or hips having interior pockets, as shown and described.

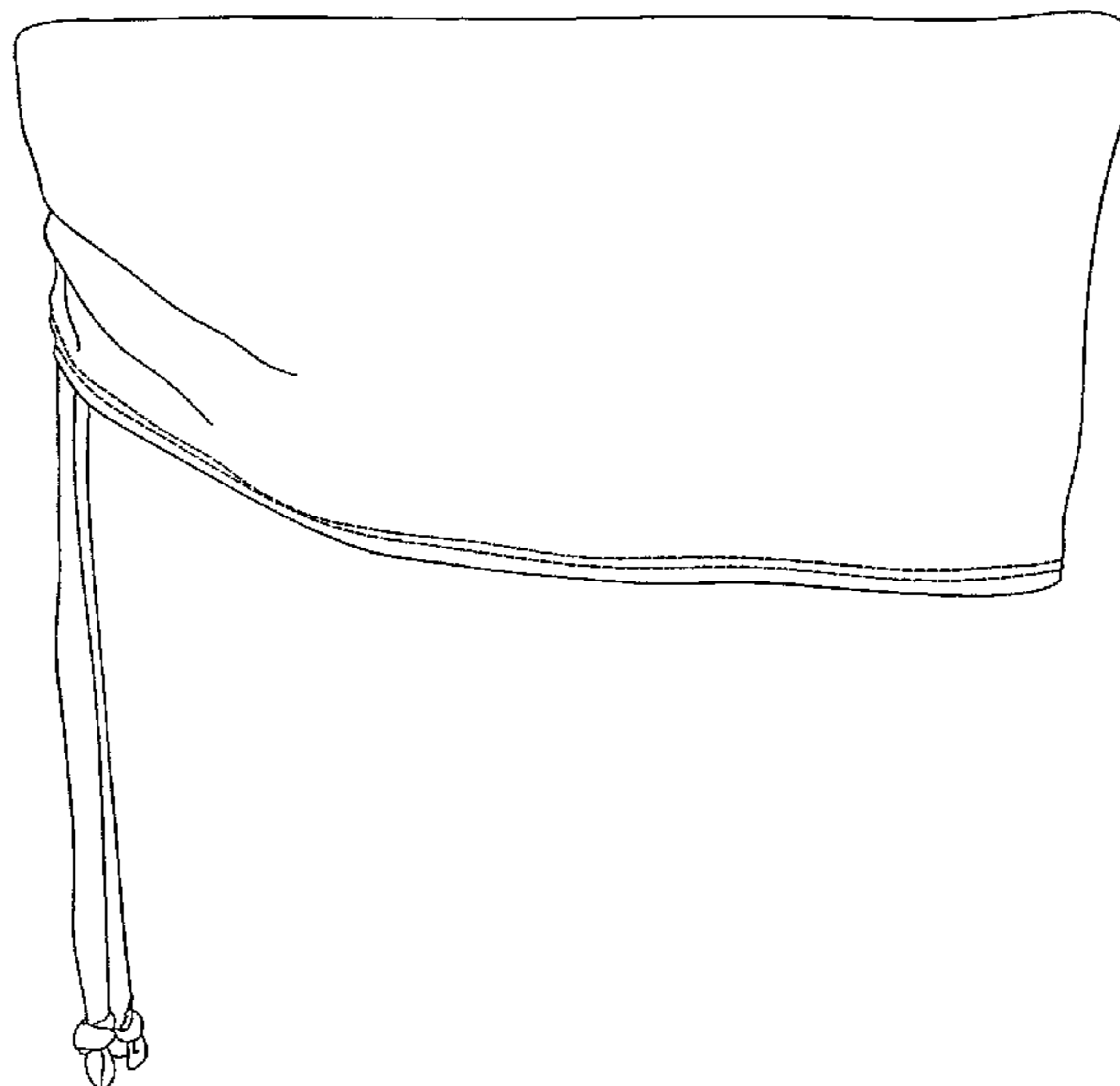
DESCRIPTION

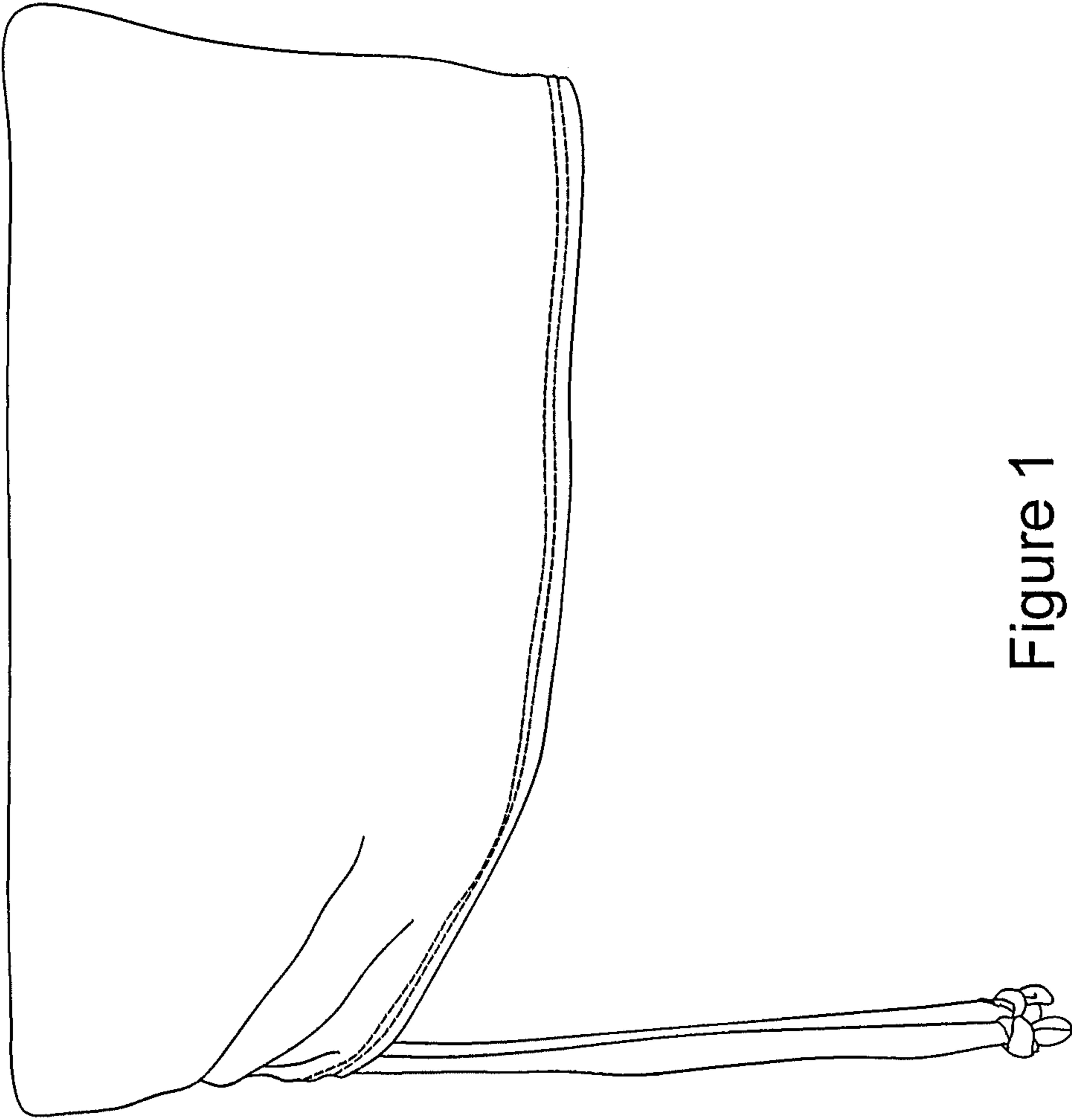

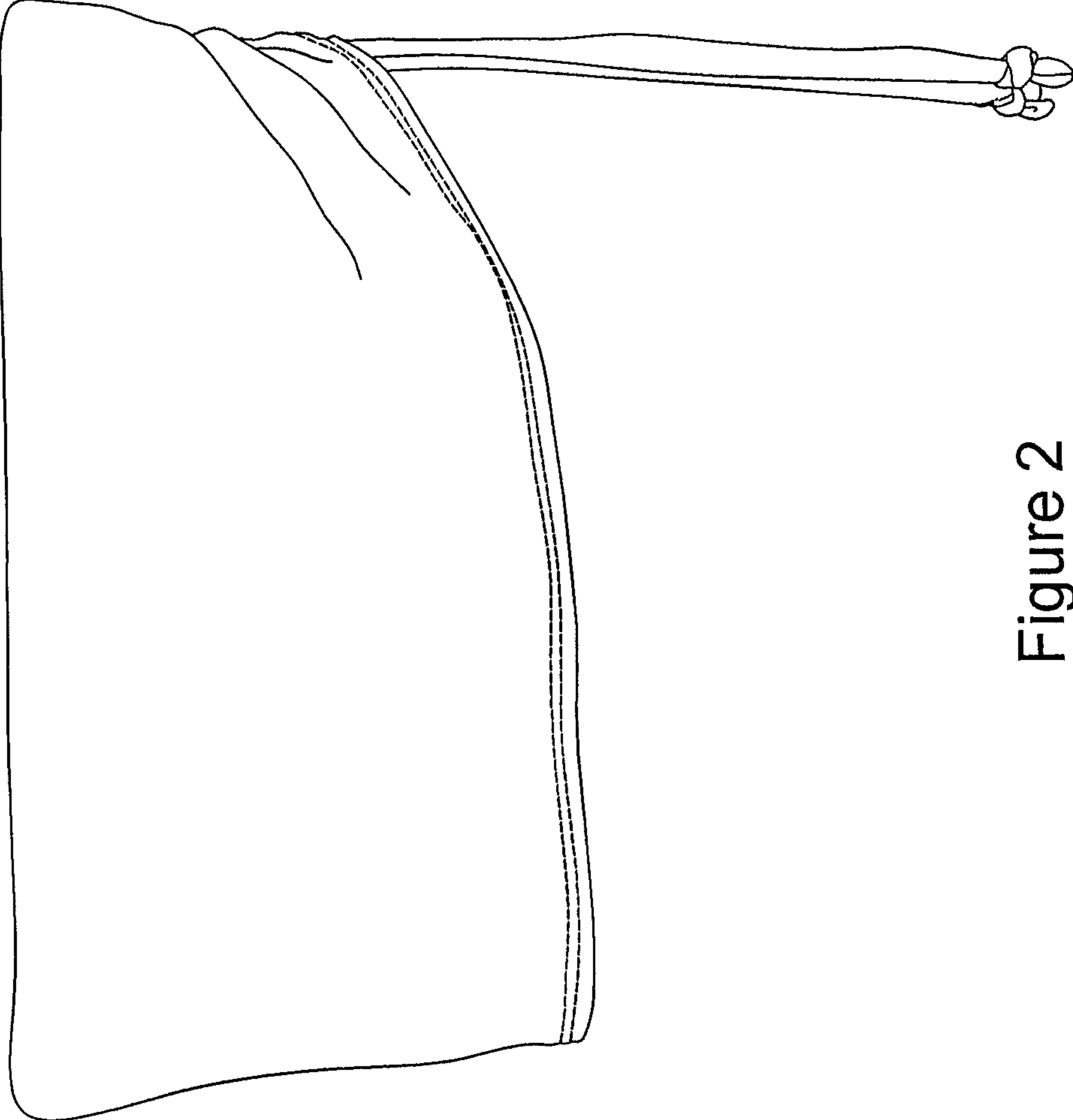

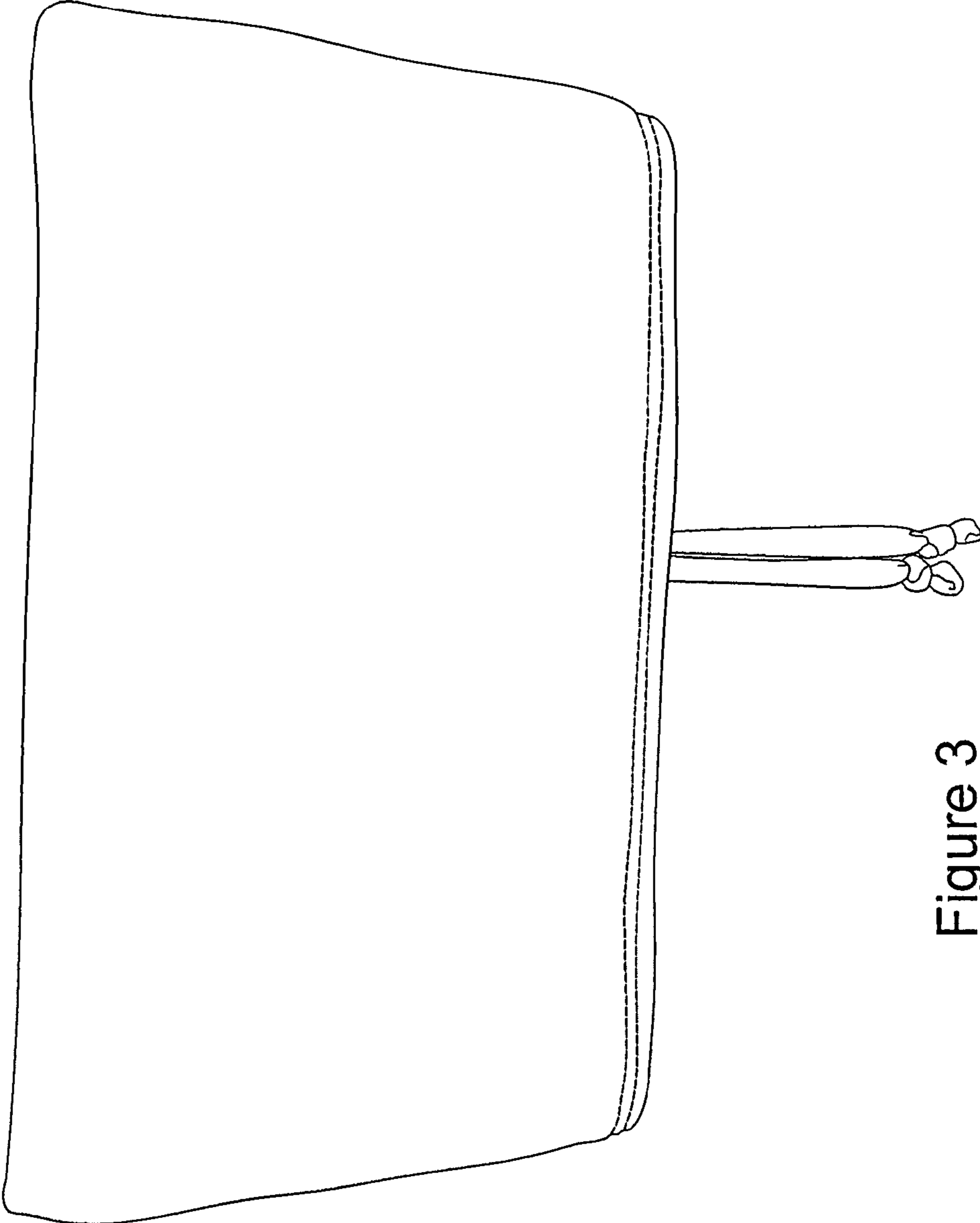

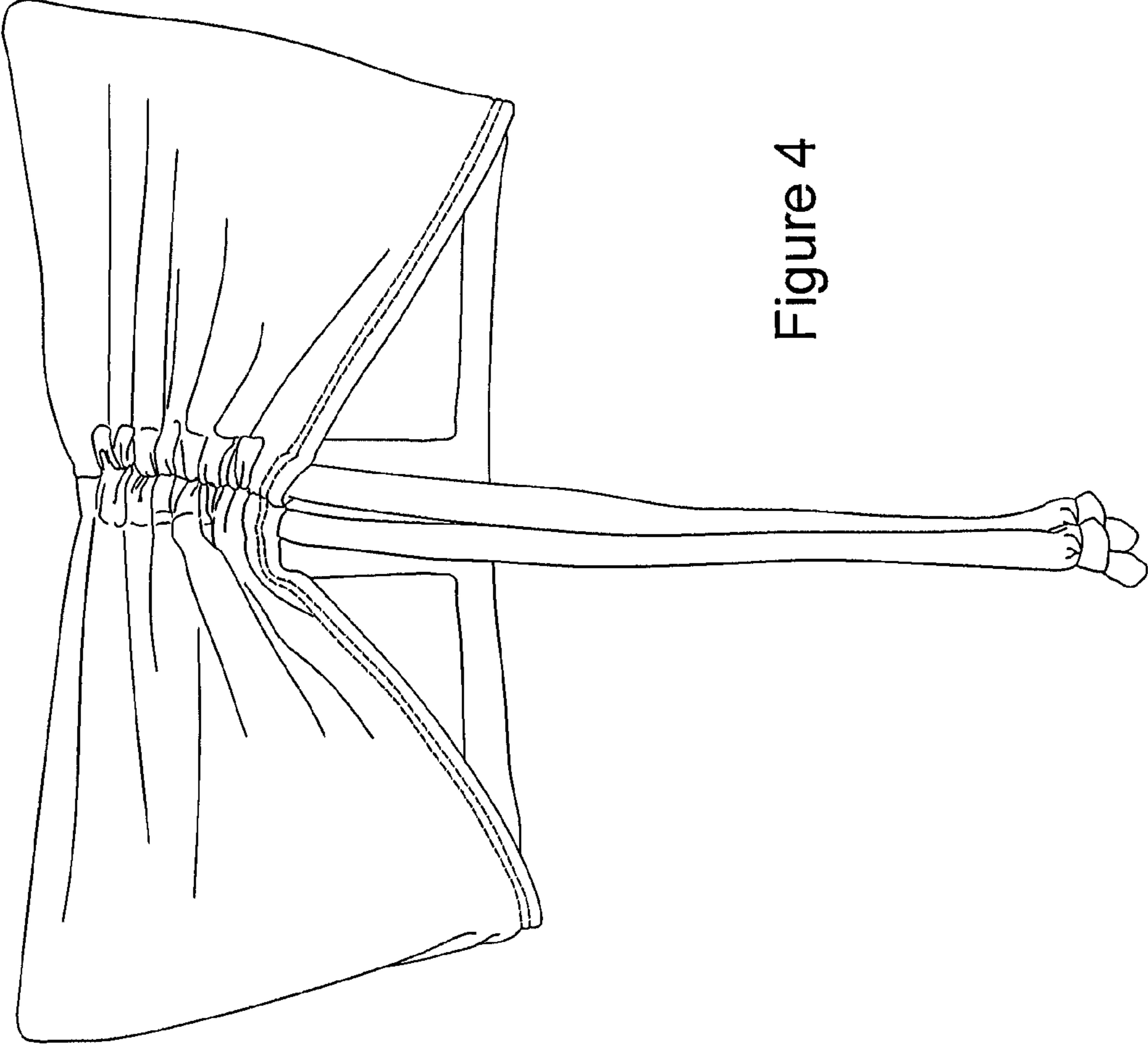

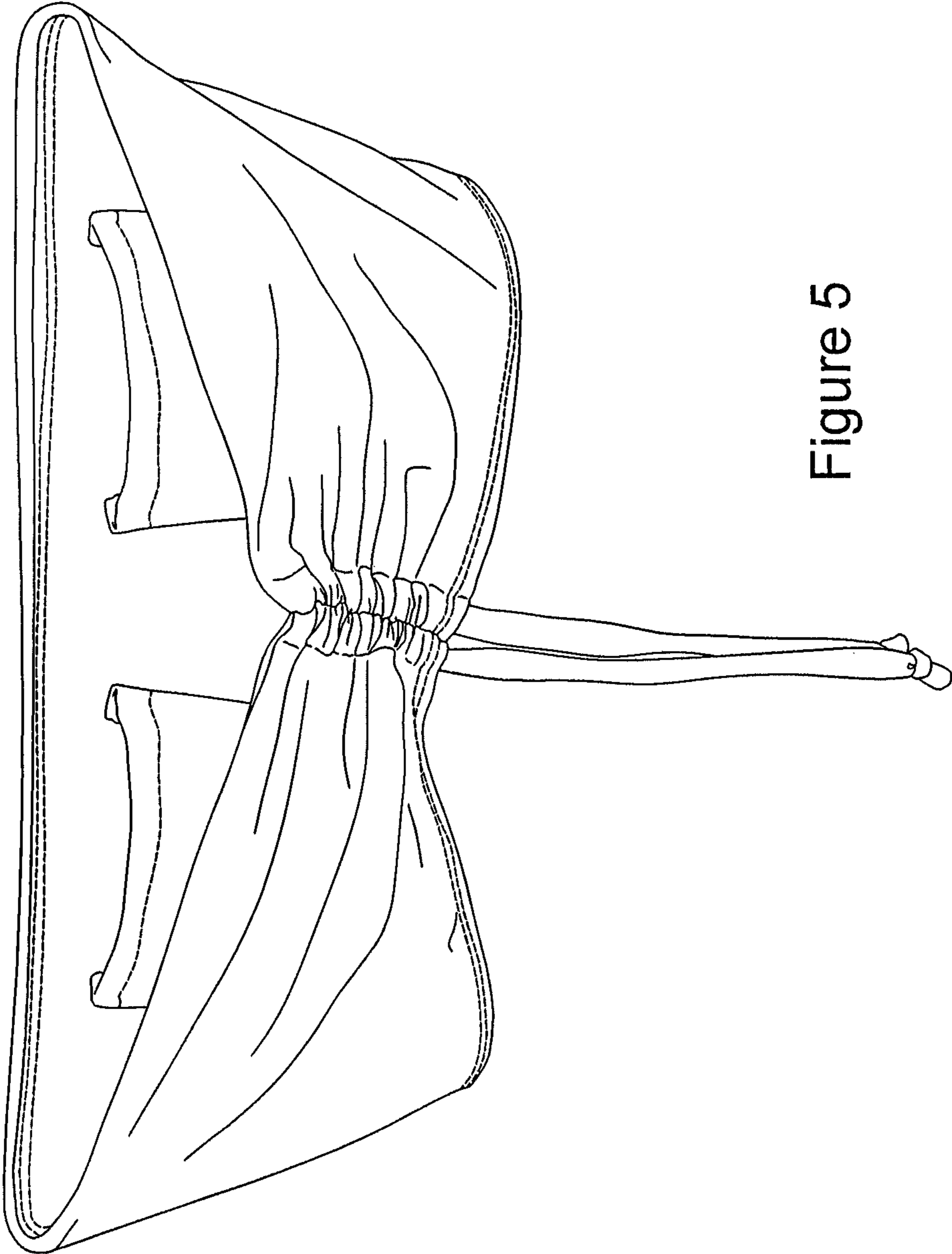

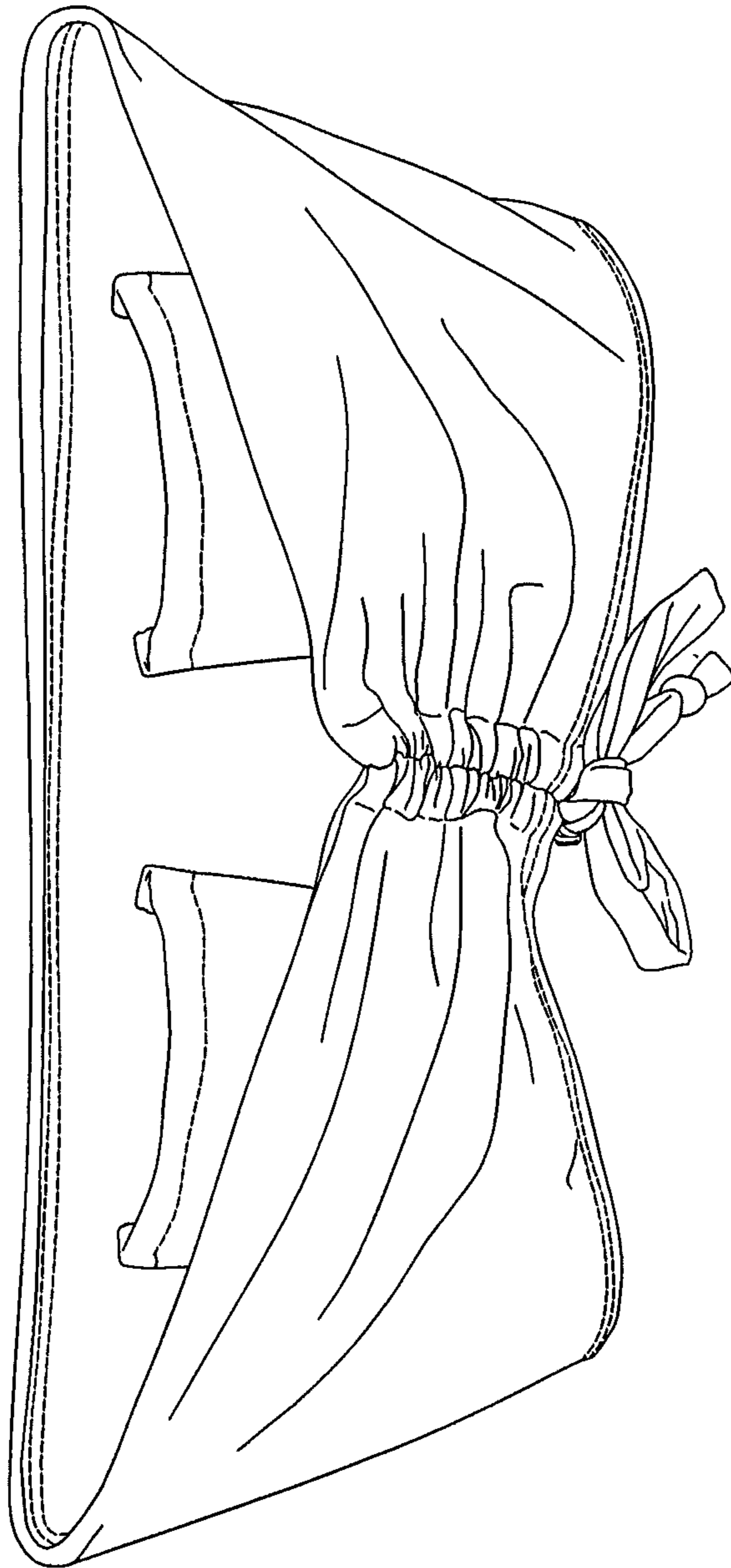
