(57) **CLAIM**

The ornamental design for a shoe midsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe midsole showing my new design, wherein greyscale shading depicts a contrast of appearance;

FIG. 2 is a side view thereof;

FIG. 3 is a rear perspective view thereof; and,

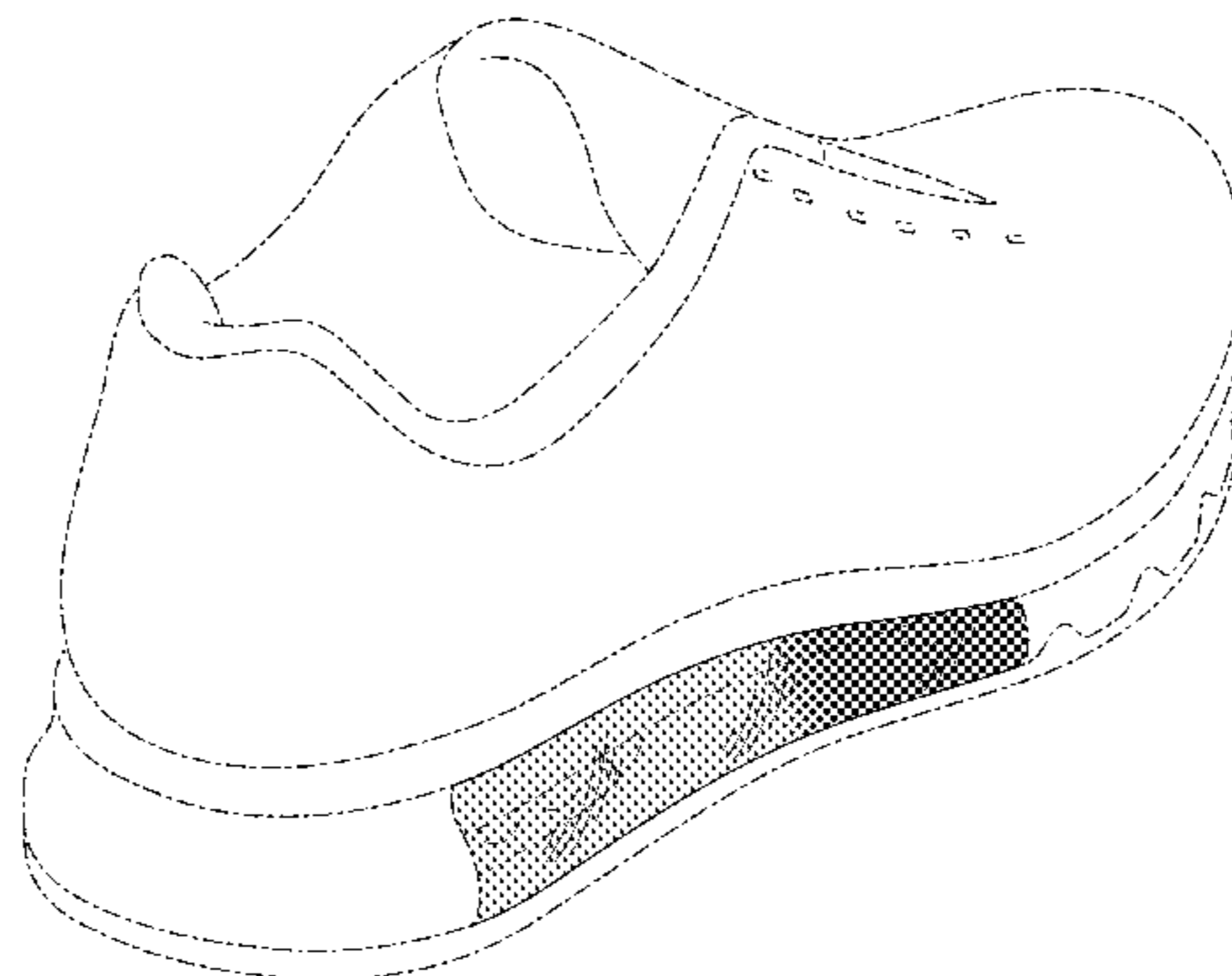
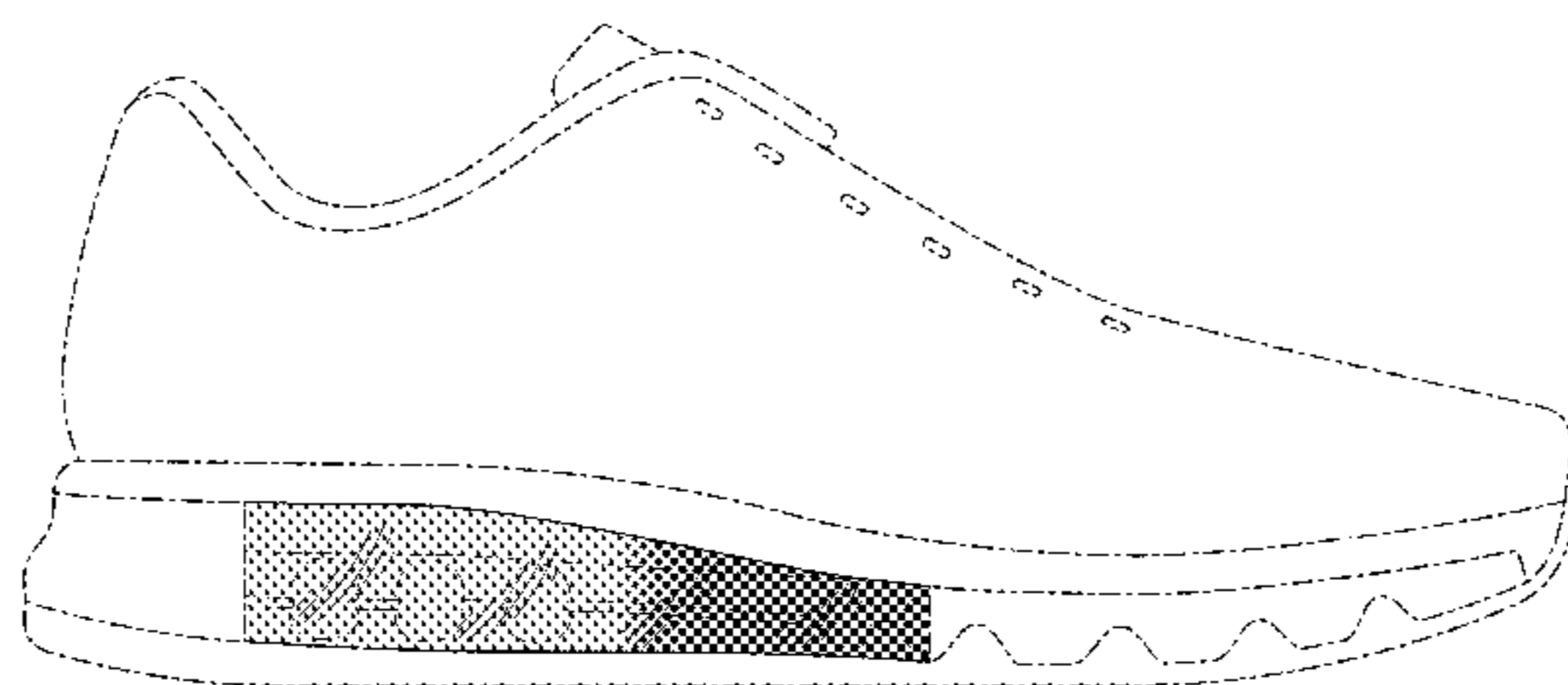
FIG. 4 is an enlarged rear perspective view thereof, wherein all unclaimed detail is omitted for clarity.

The oblique line shading in FIGS. 1-4 depicts transparency. The greyscale shading in FIGS. 1-4 represents color contrast. The broken lines immediately adjacent to the shaded areas in FIGS. 1-4 represent unclaimed boundaries of the design. The broken lines showing the remainder of the shoe in FIGS. 1-4 are for environmental purposes only and form no part of the claimed design.

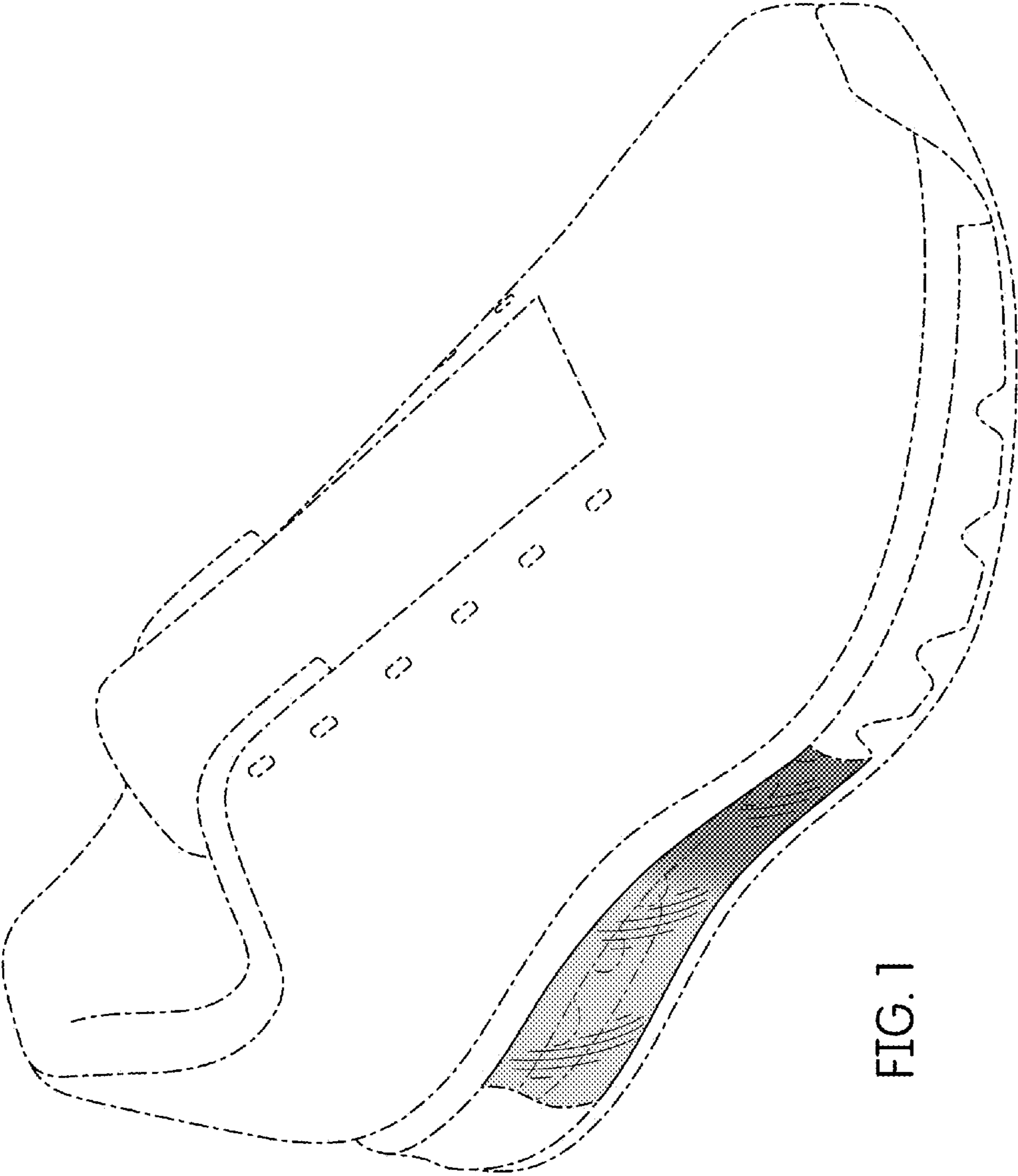

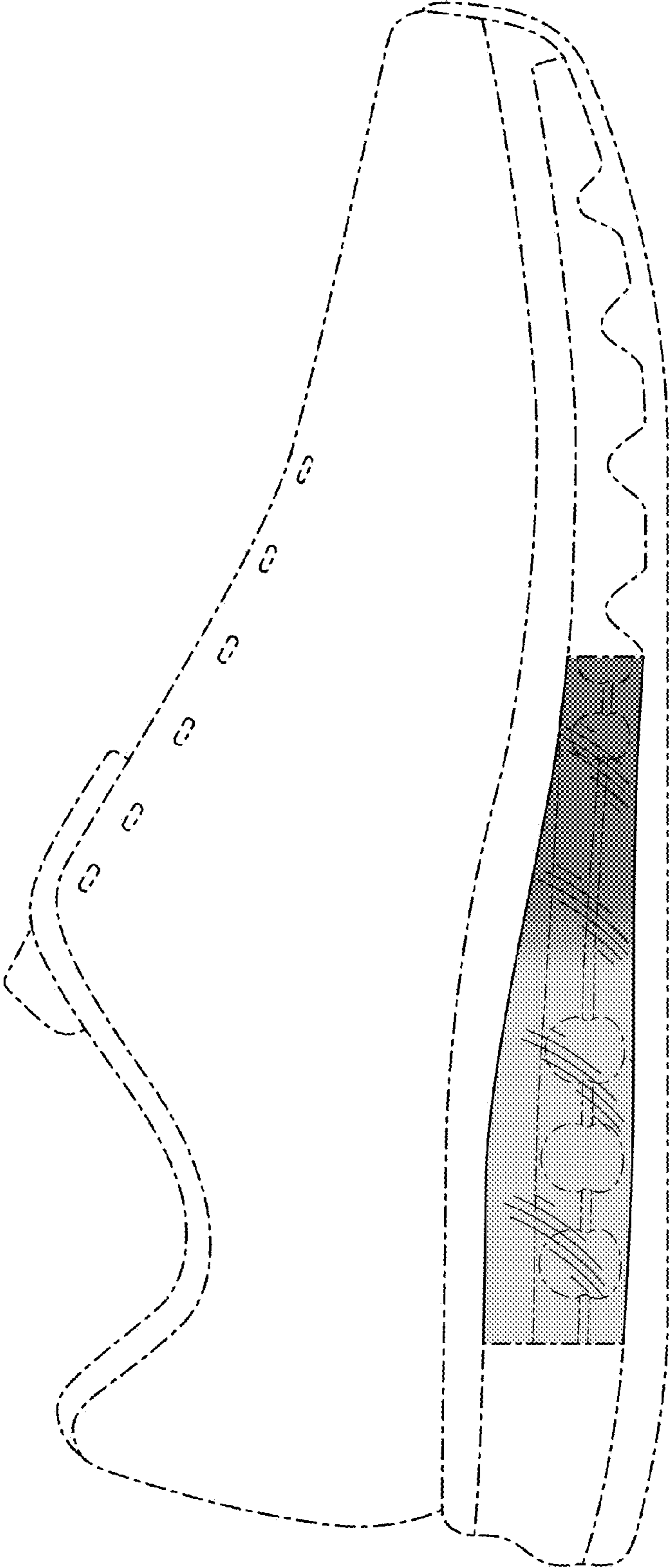

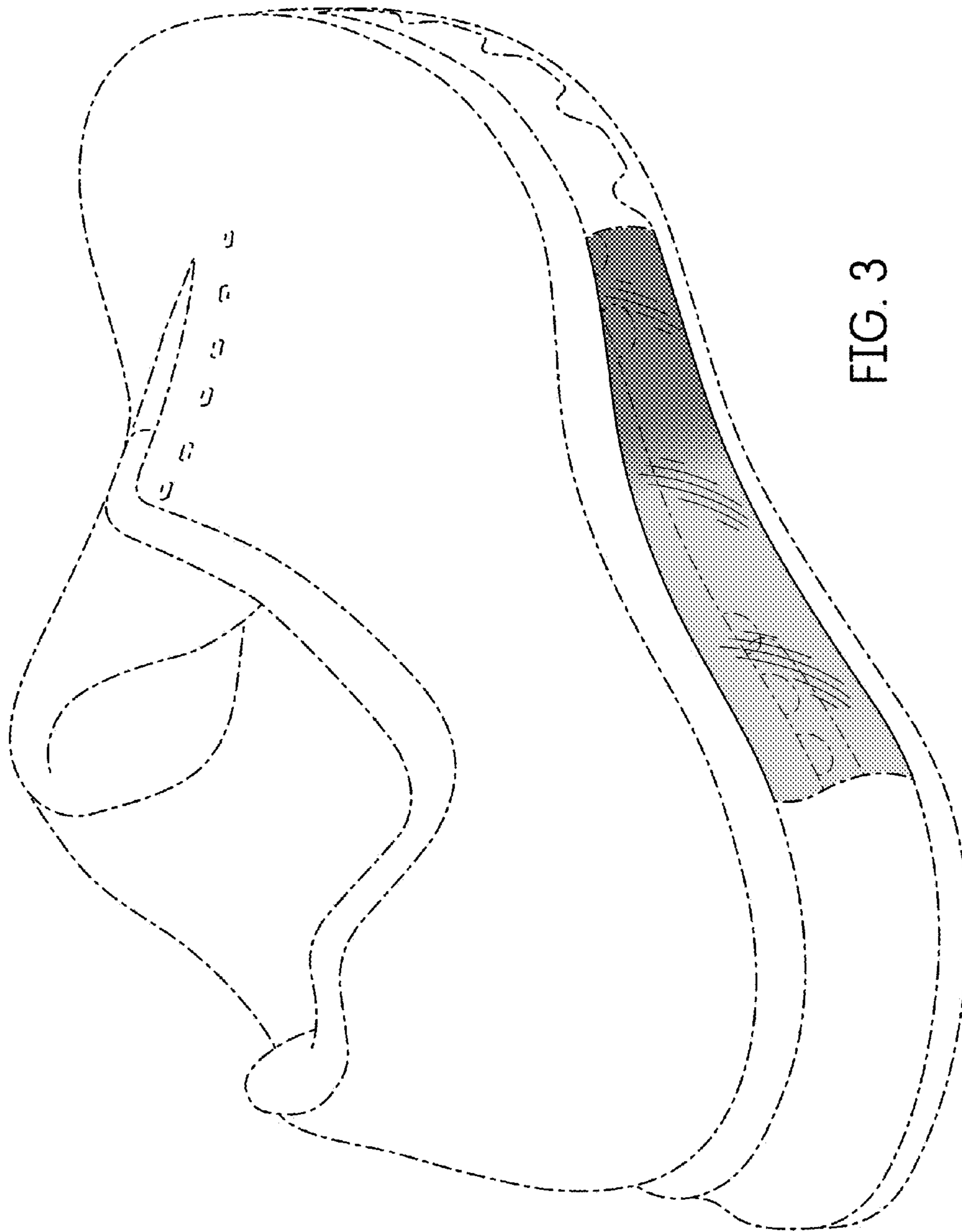

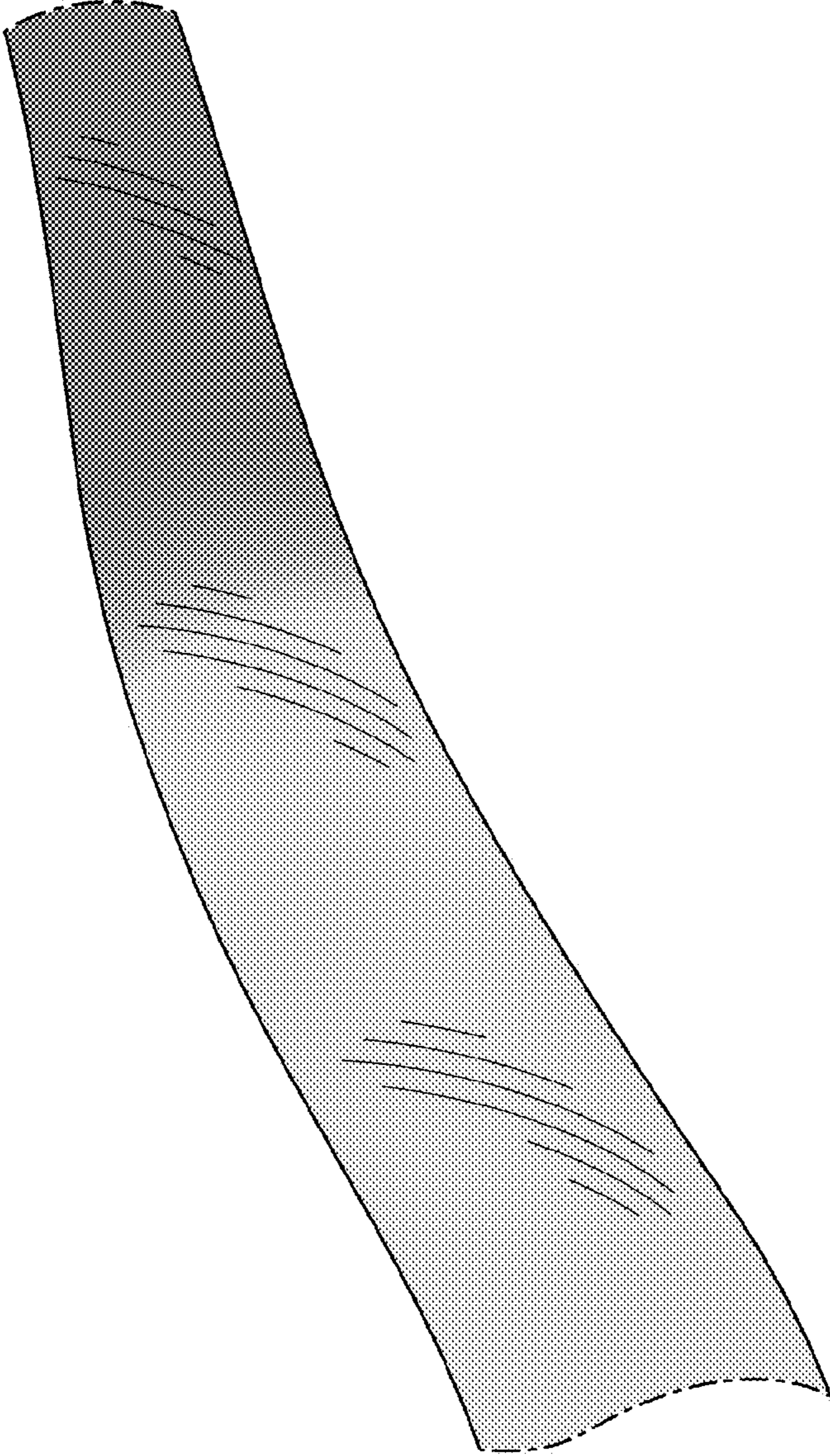
