The ornamental design for a shell backpack, as shown and described.

DESCRIPTION

FIG. 1 is a top, left rear perspective view of a shell backpack showing my new design;

FIG. 5 is a right side view of the design of FIG. 1;

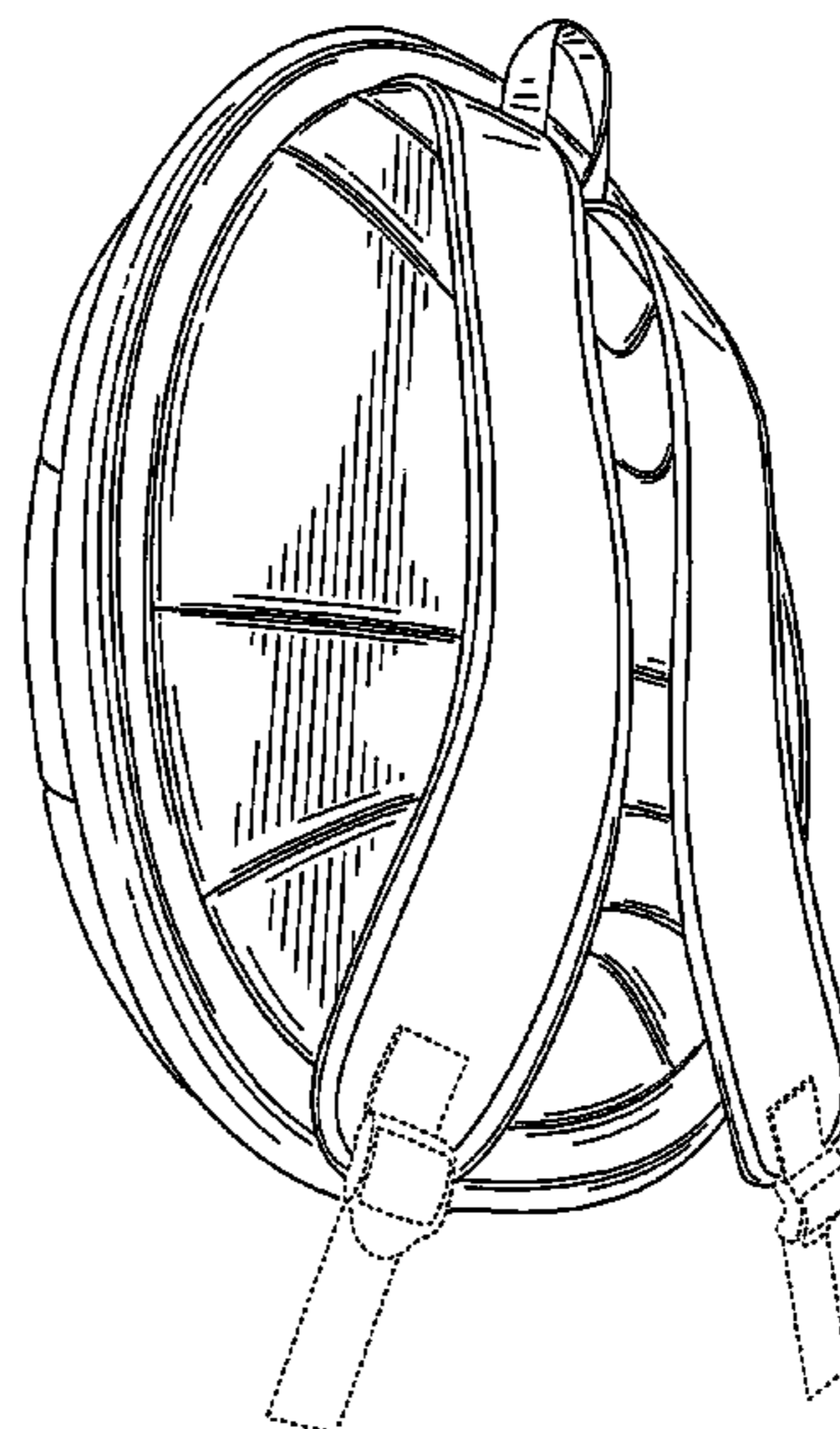
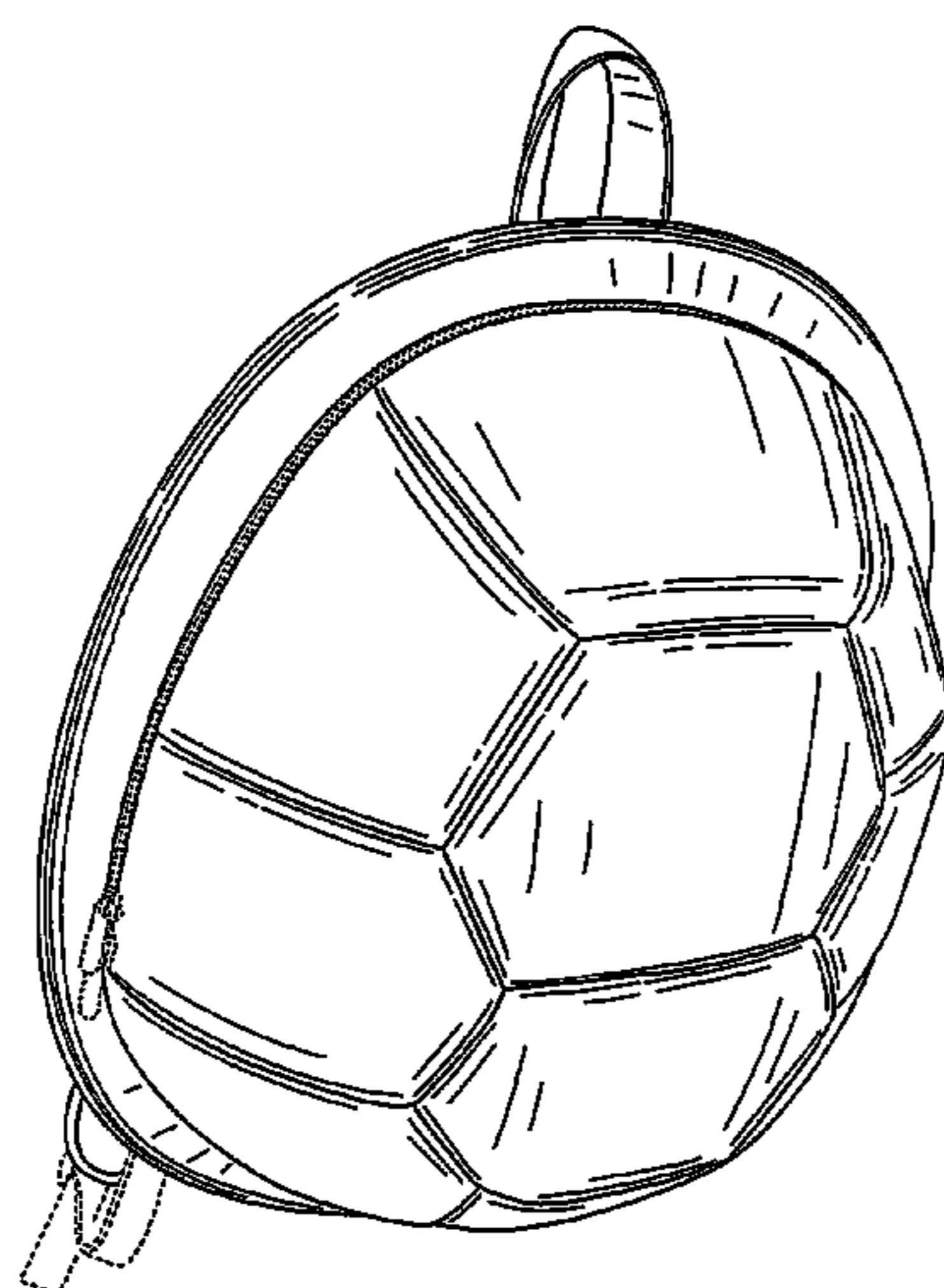
FIG. 6 is a left side view of the design of FIG. 1;

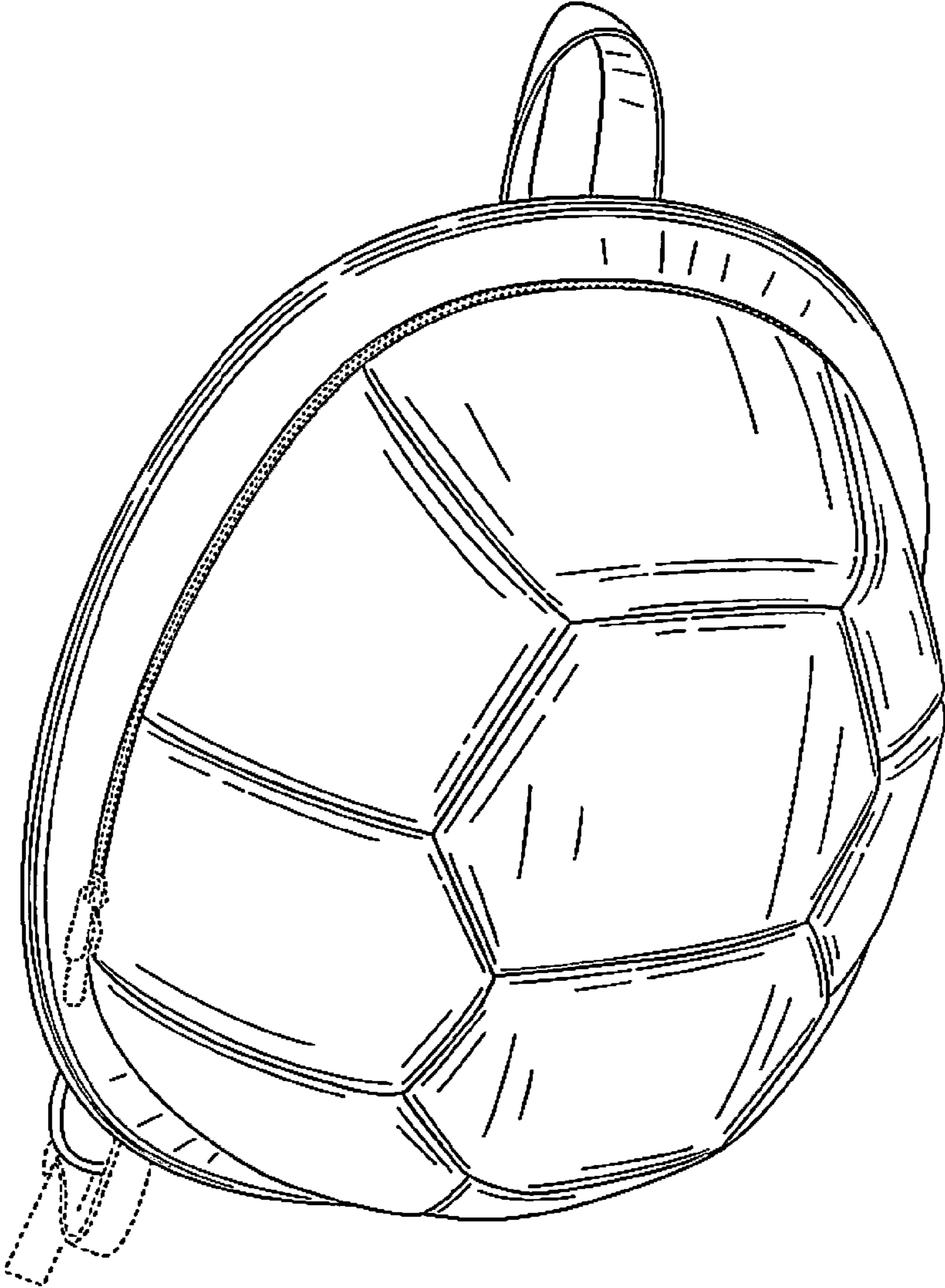

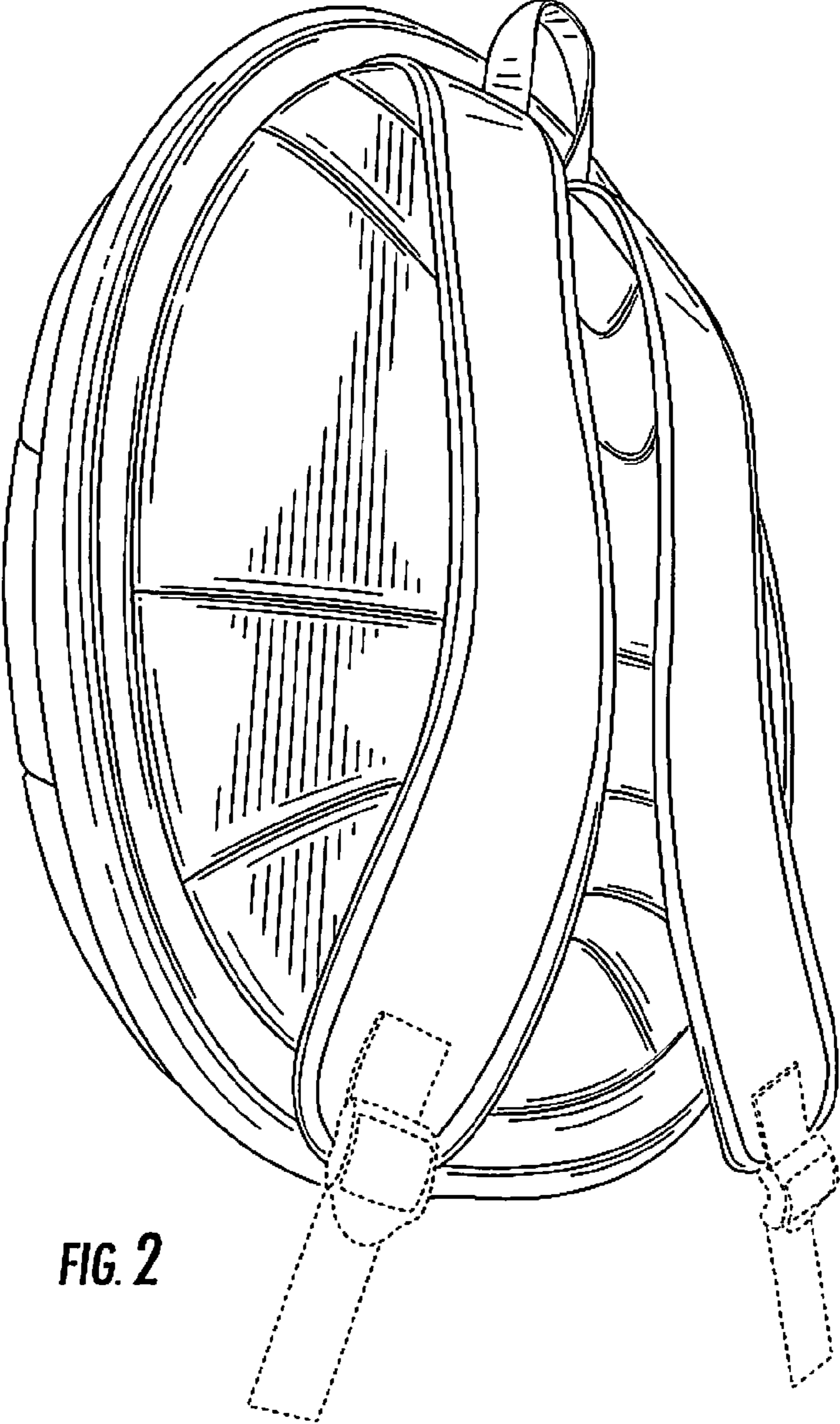

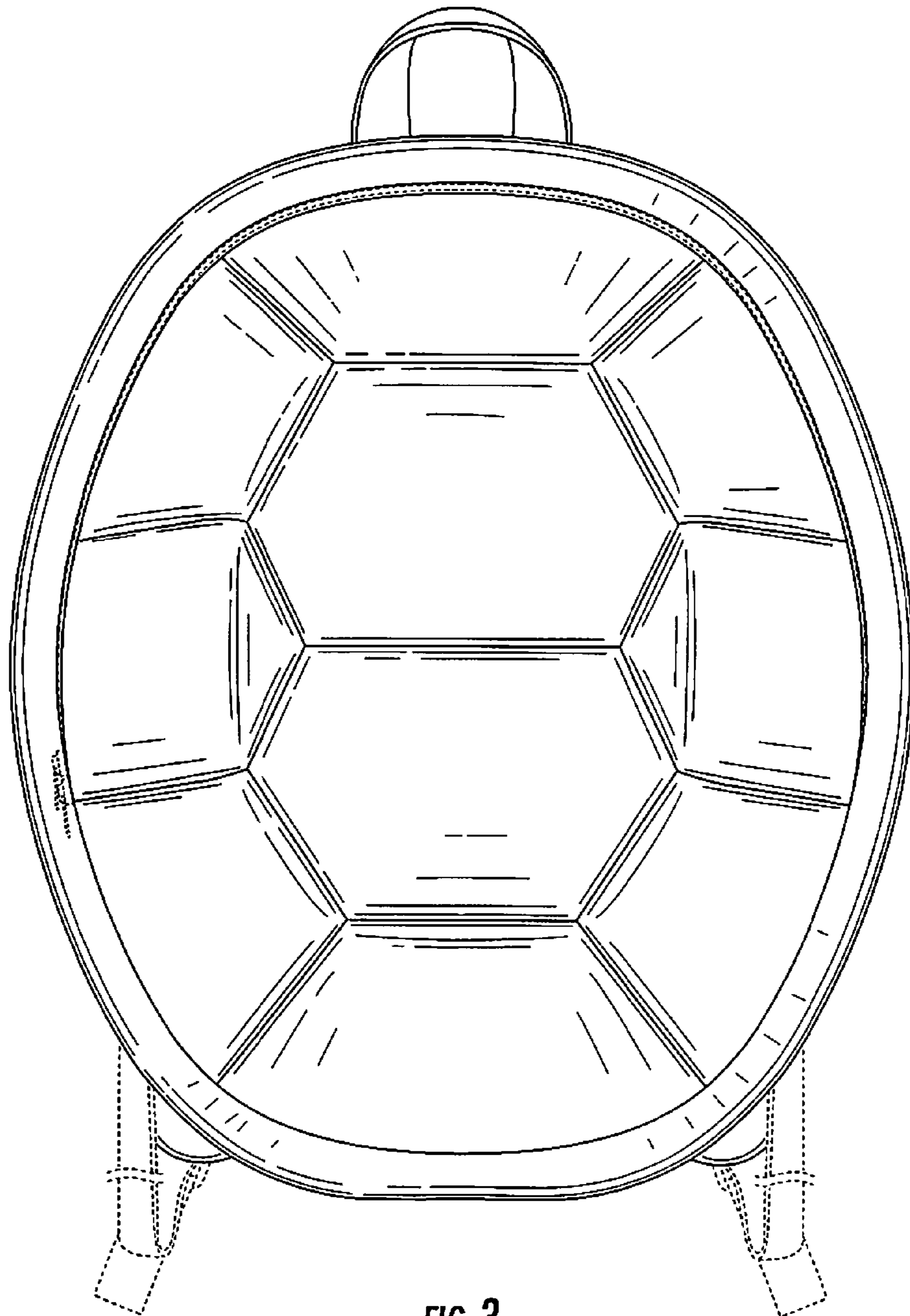

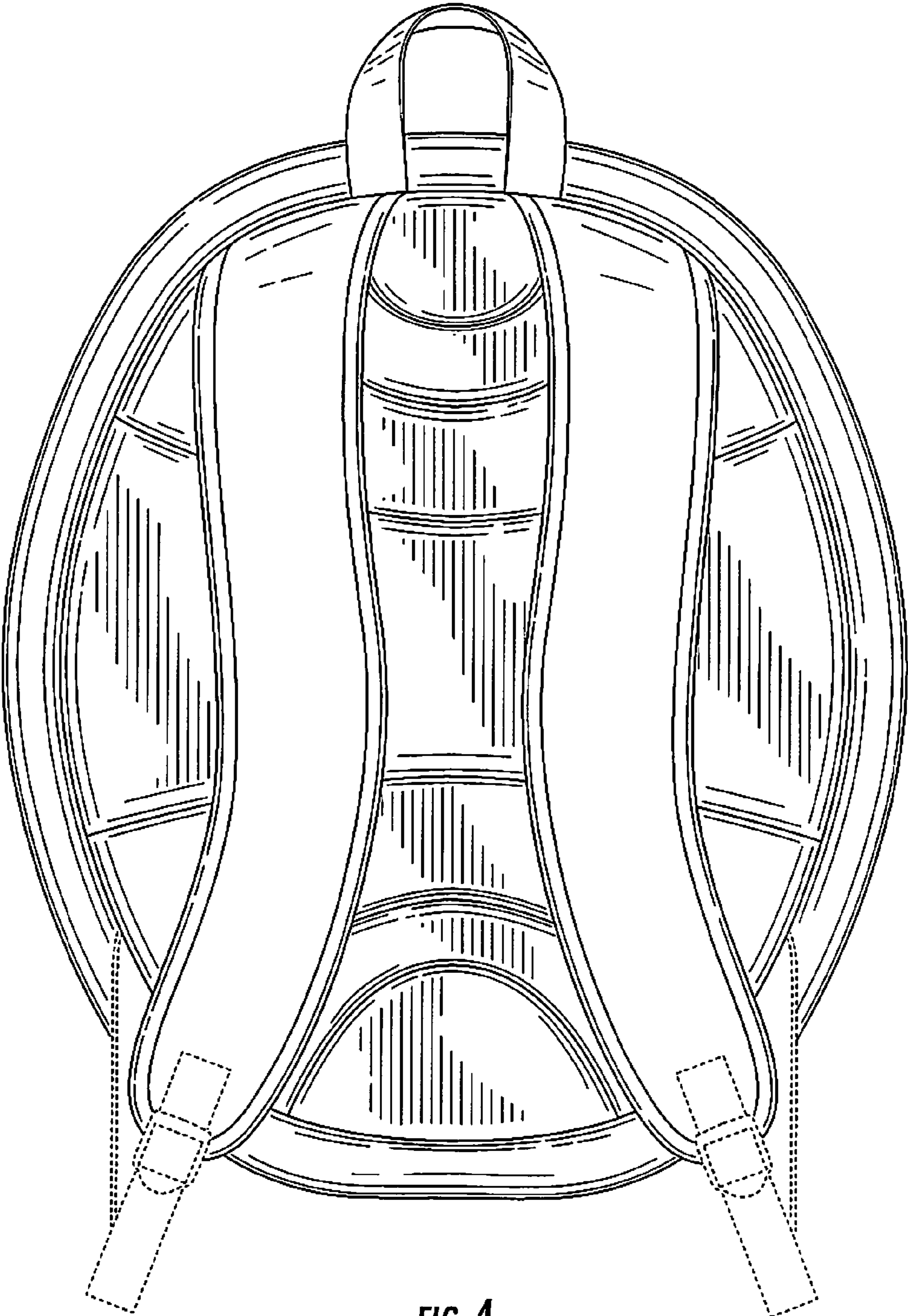

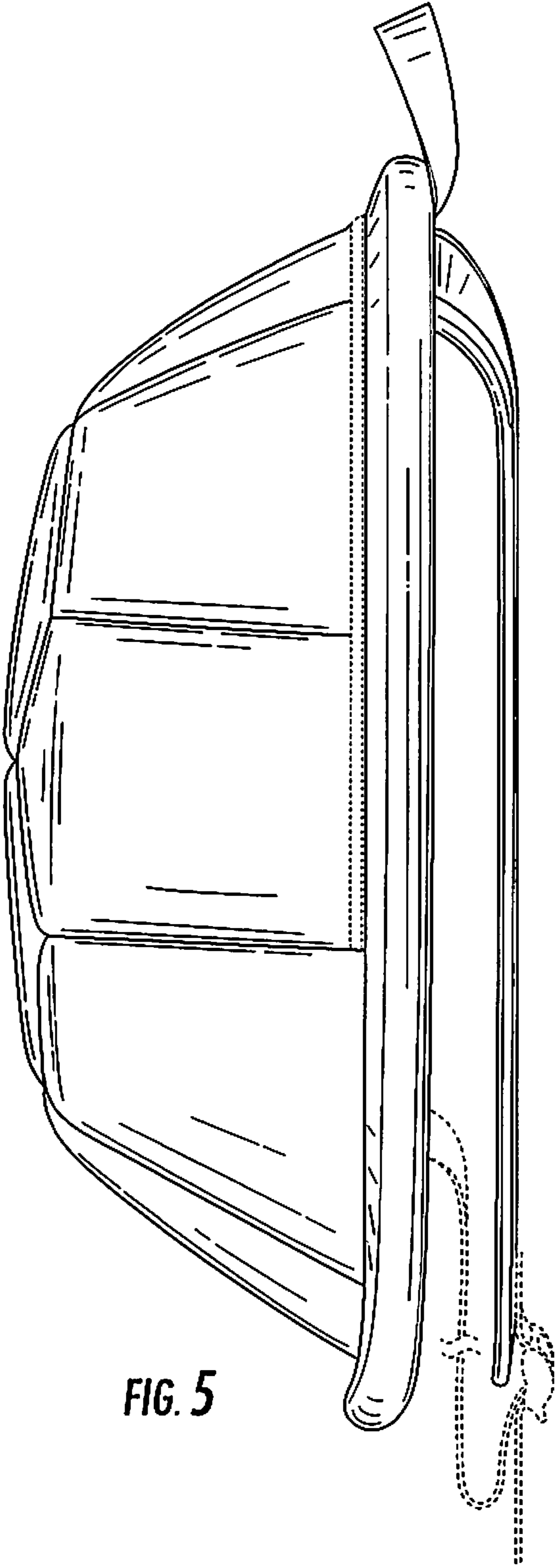

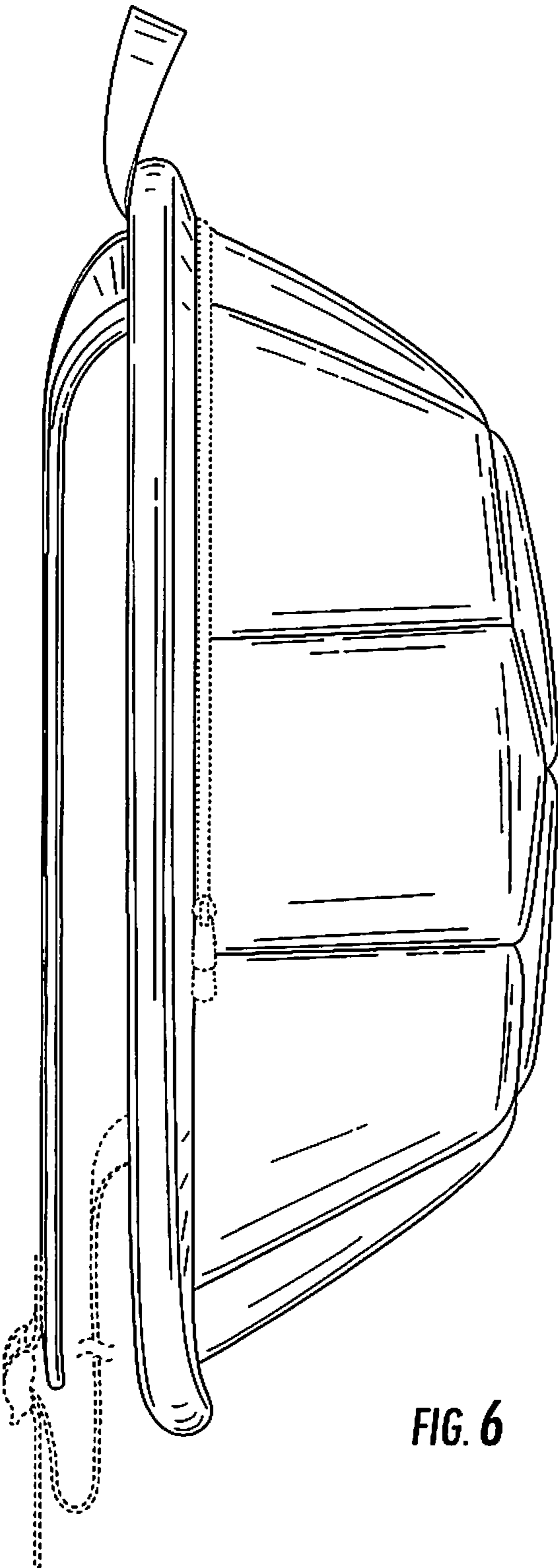

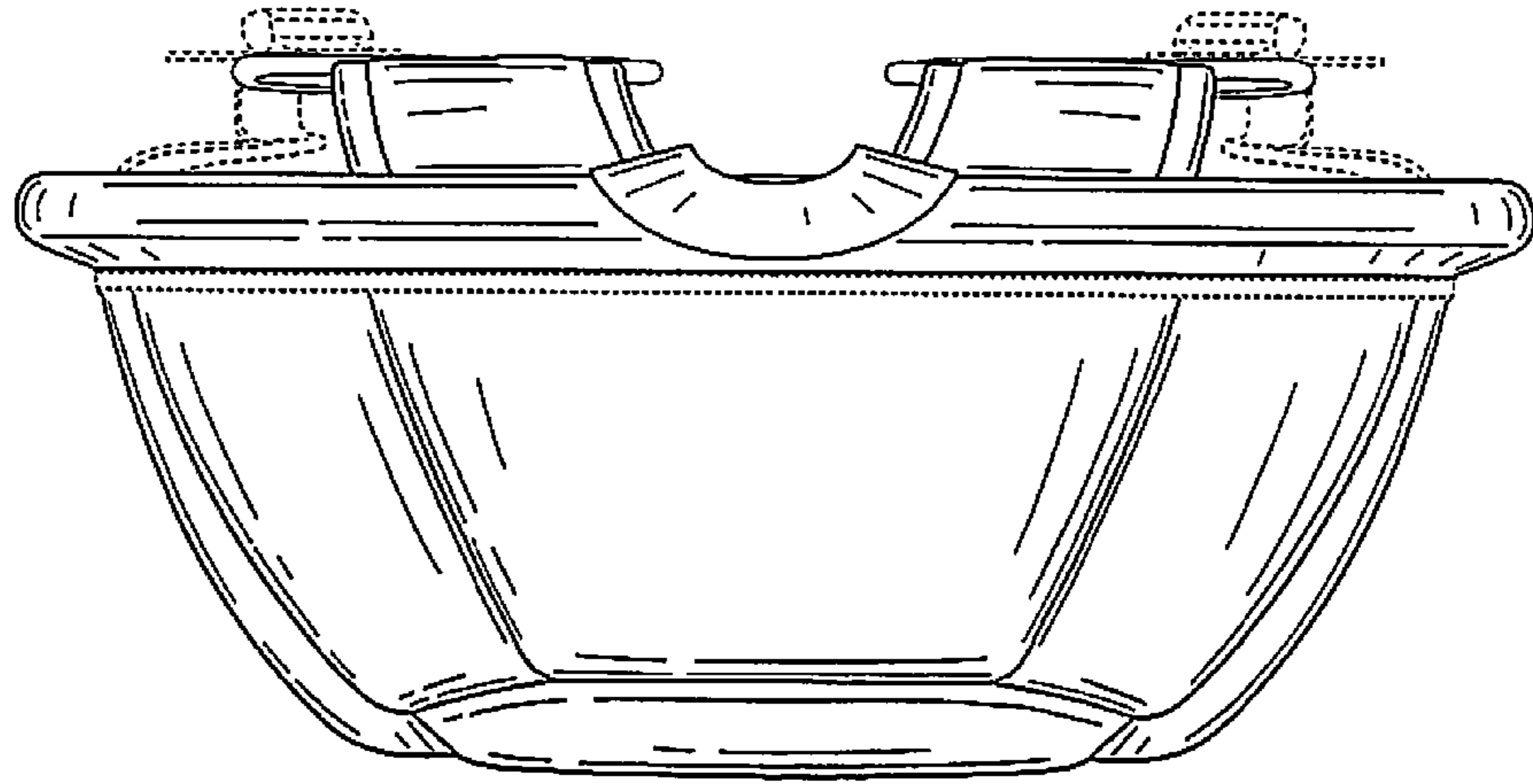

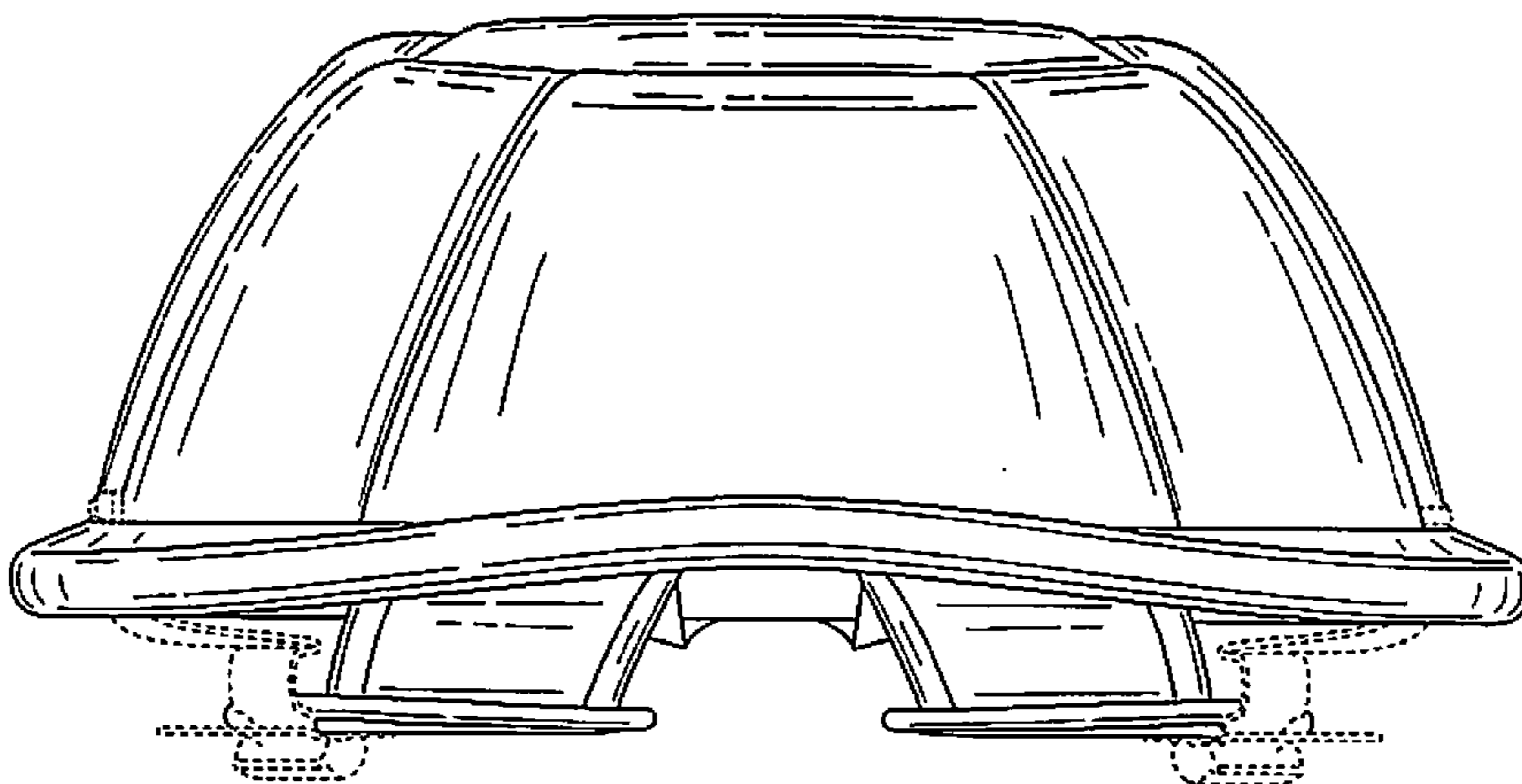
