(57) **CLAIM**

I claim the ornamental design for a tote bag, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a tote bag according to the design;
FIG. 2 is a rear view of the tote bag of FIG. 1;
FIG. 3 is a side view of the tote bag of FIG. 1;
FIG. 4 is a second side view of the tote bag of FIG. 1;
FIG. 5 is a front view of the tote bag with the strap removed;
FIG. 6 is a rear view of the tote bag of FIG. 5;
FIG. 7 is a side view of the tote bag of FIG. 5; and,
FIG. 8 is a second side view of the tote bag of FIG. 5.
The undisclosed top and bottom are not part of the claimed design.
The broken lines represent stitching and are part of the claimed design.

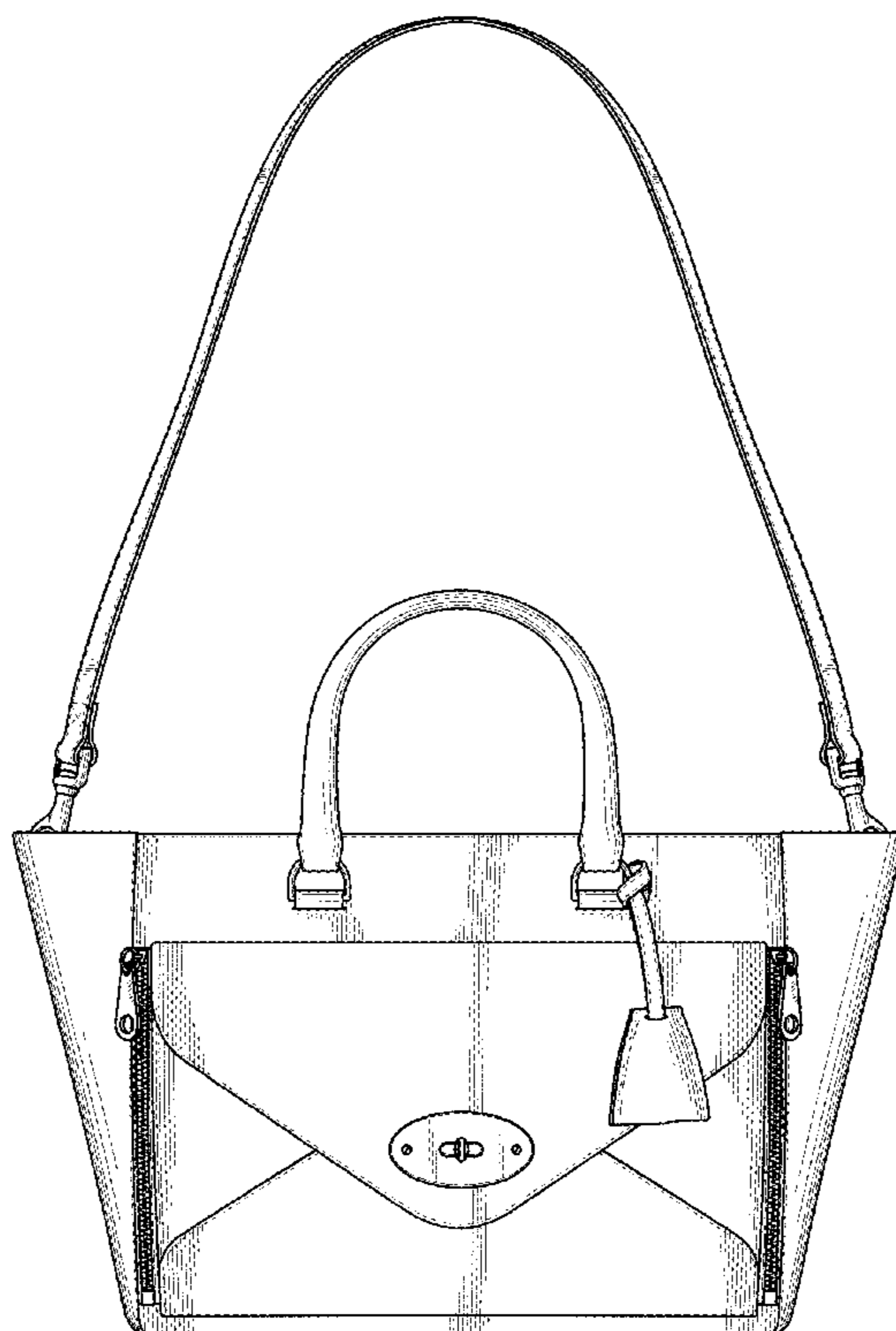

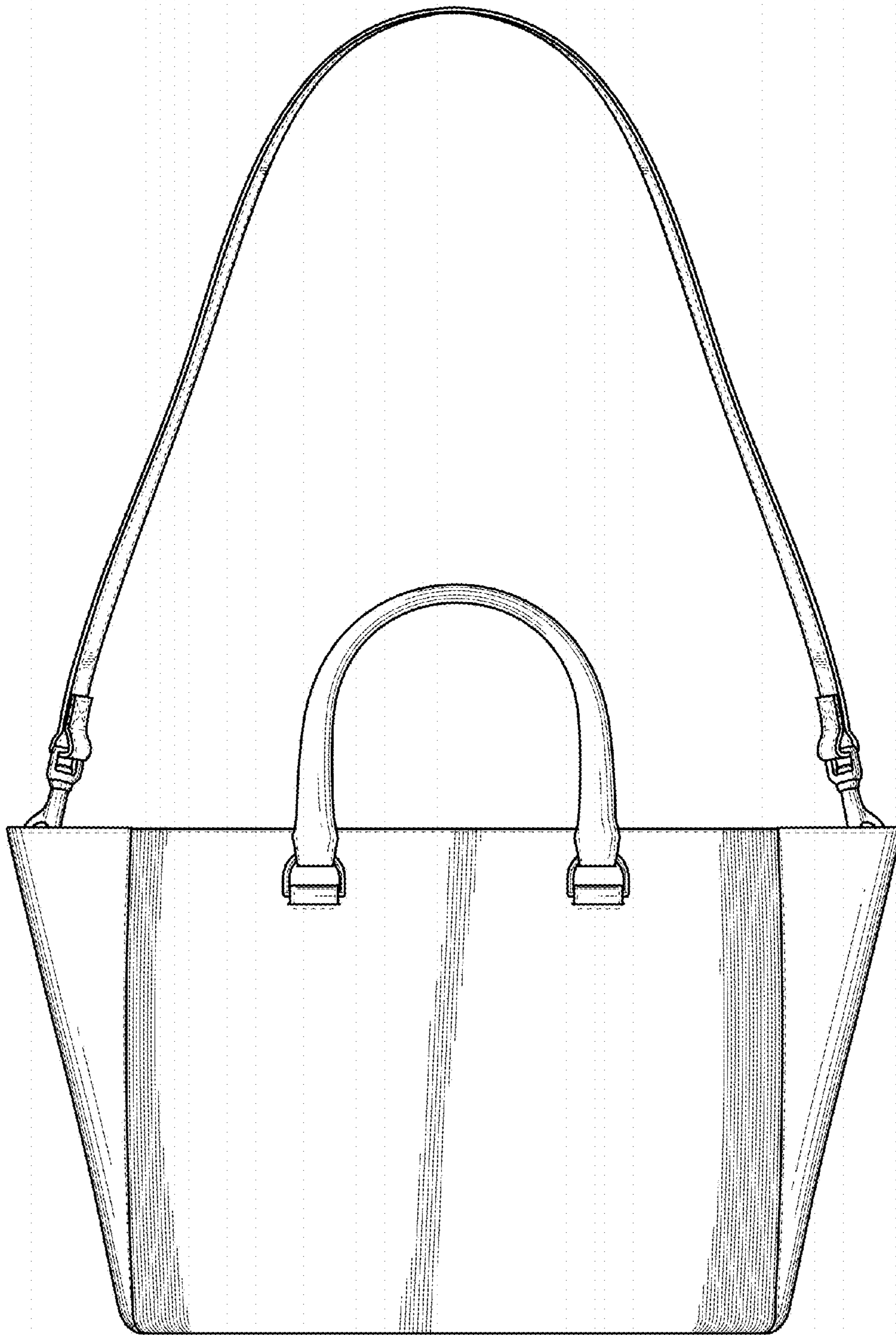

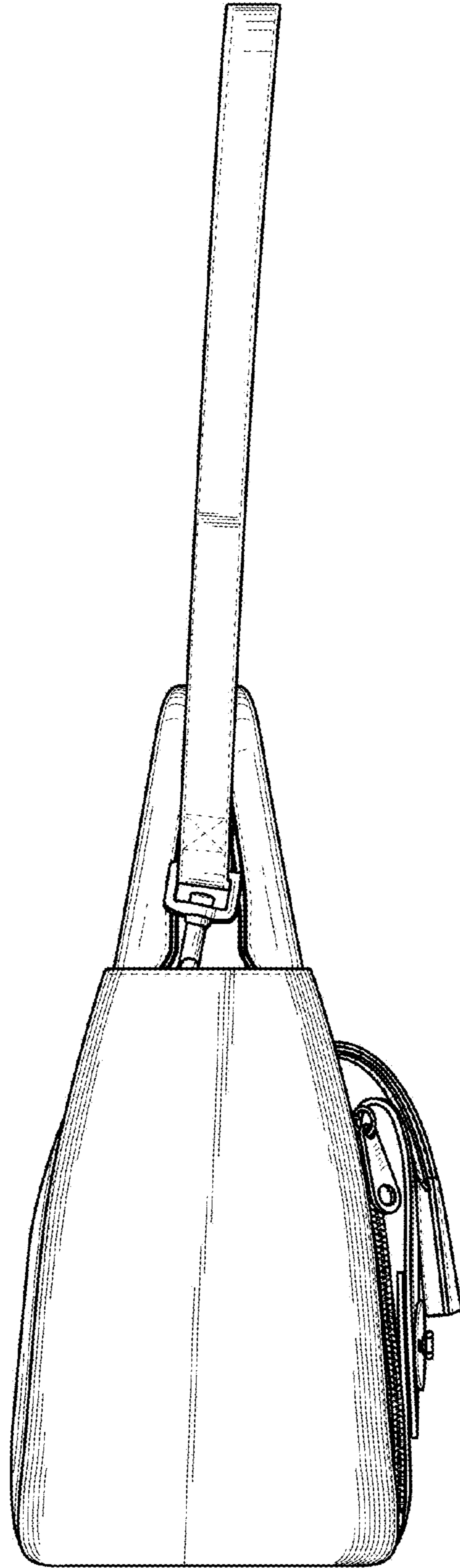

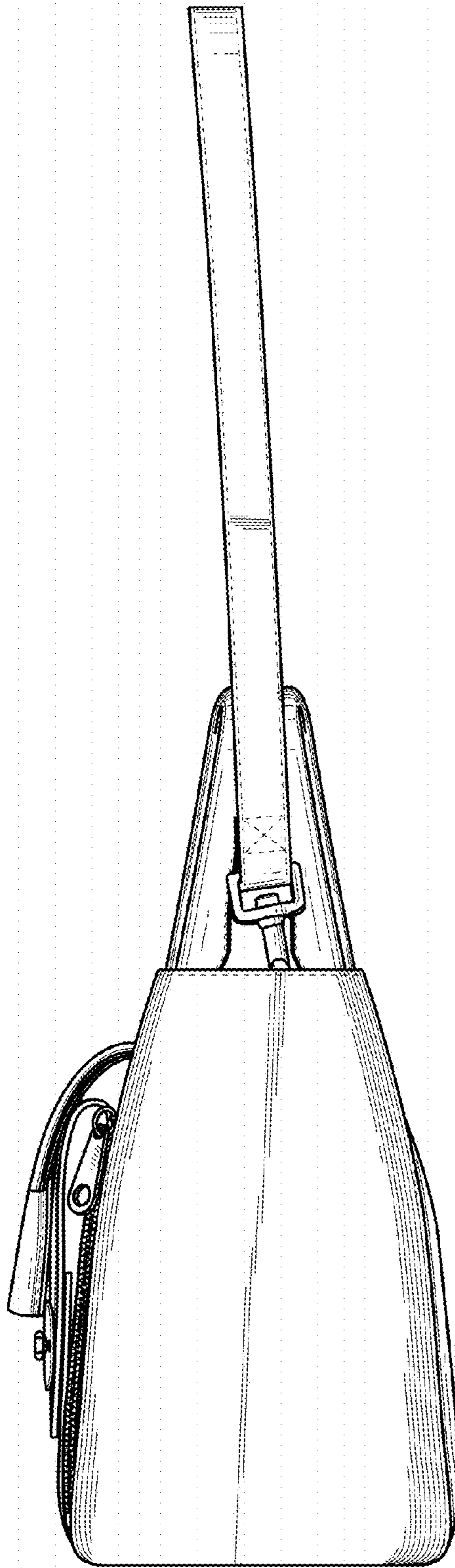

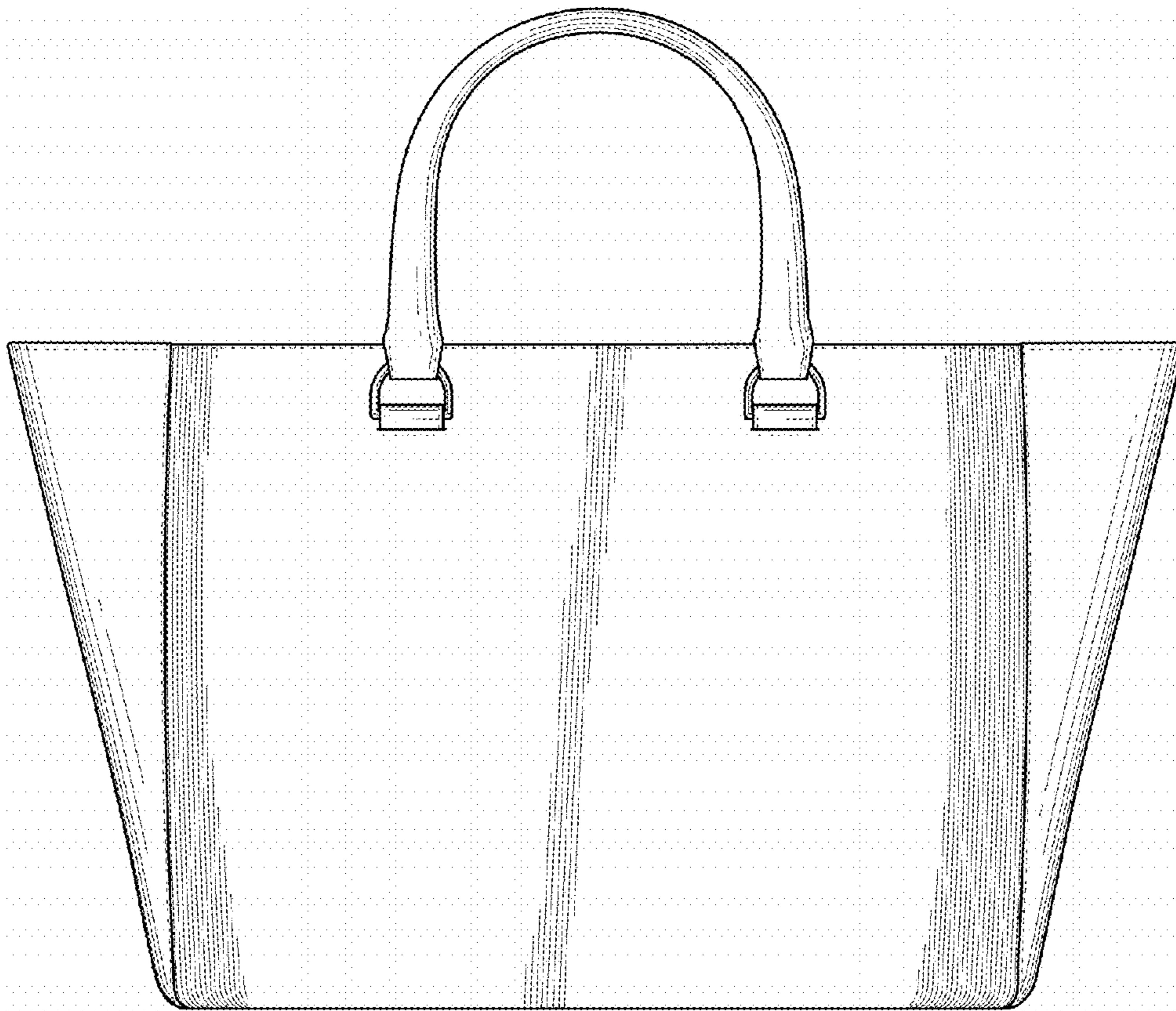

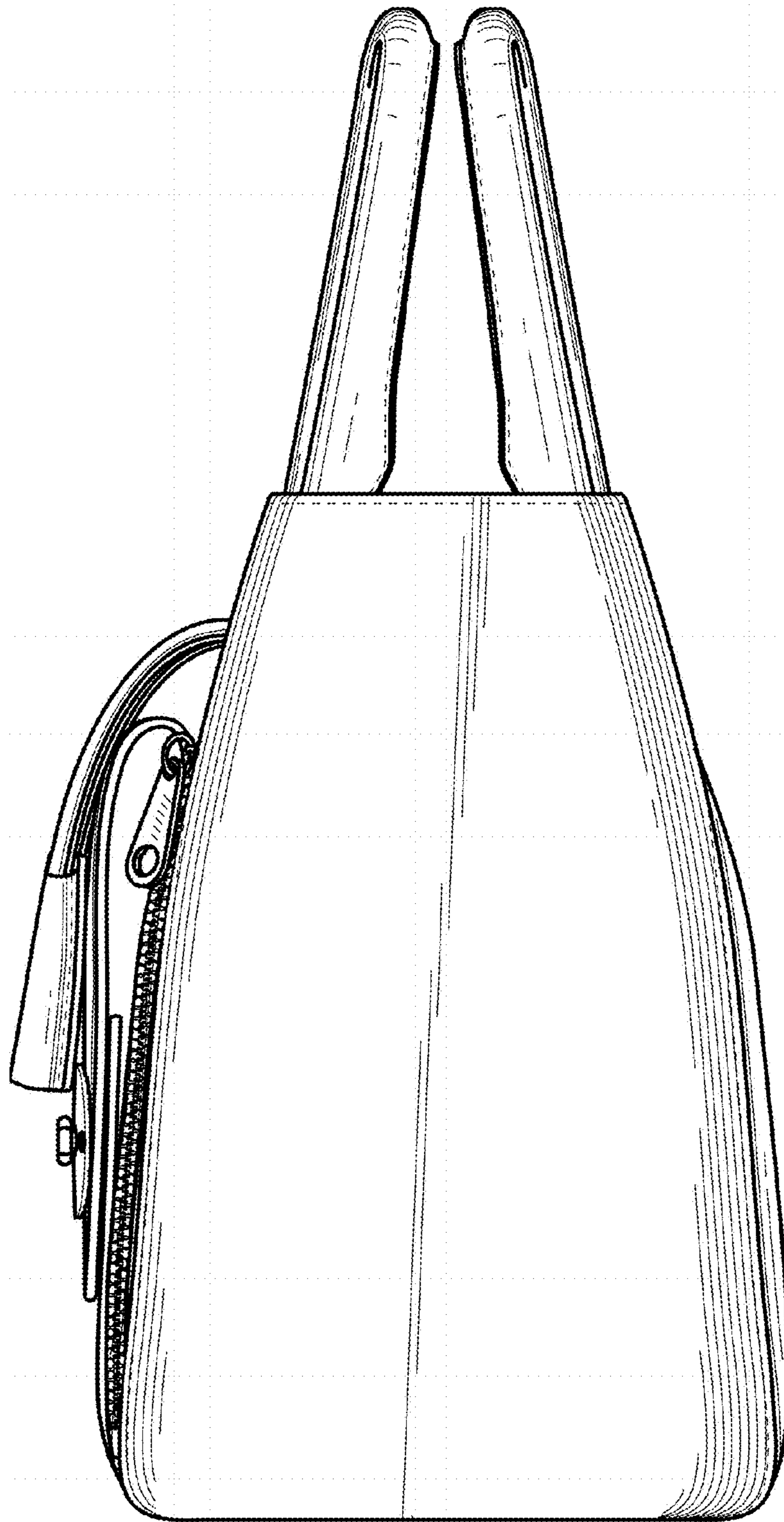

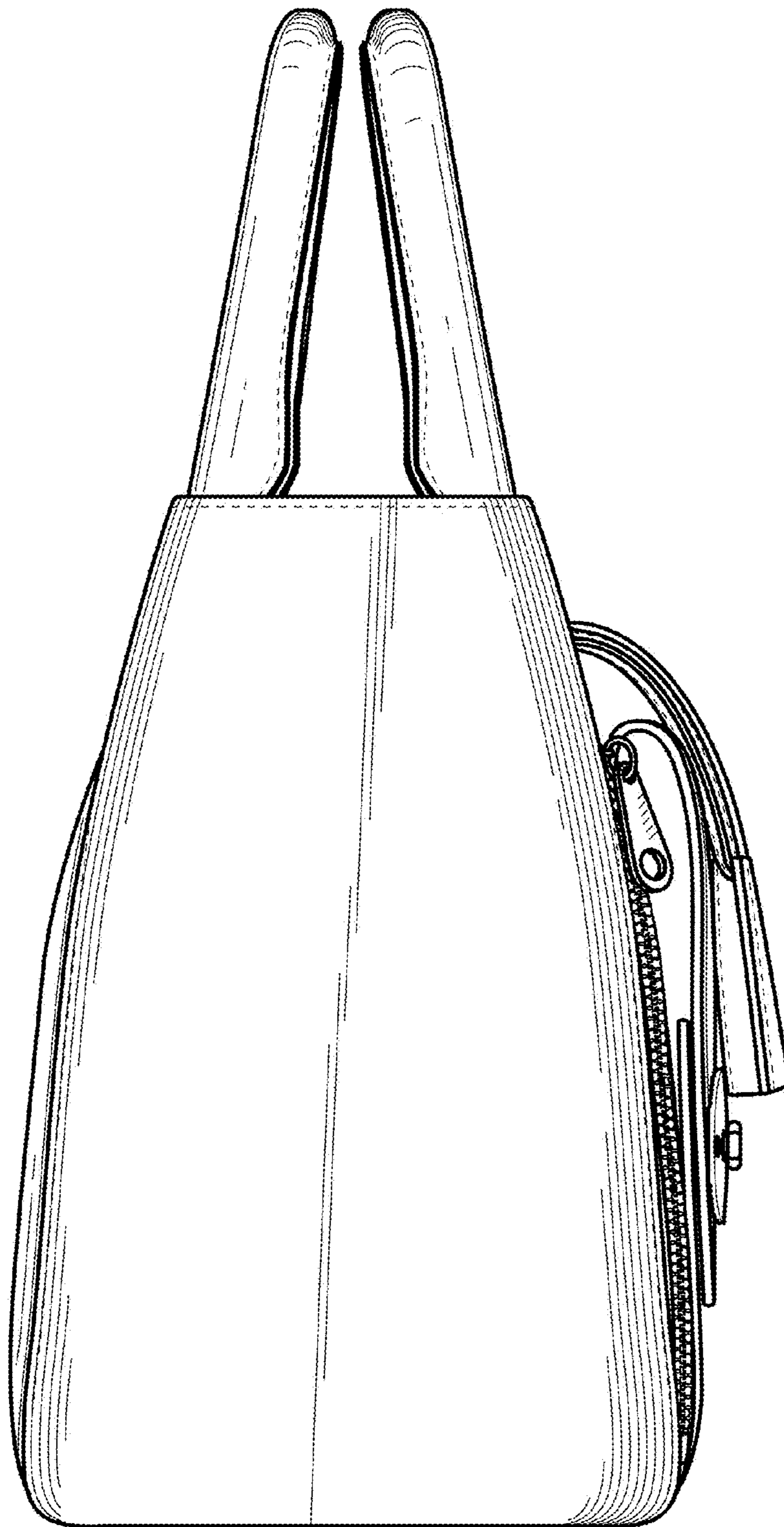
