1.

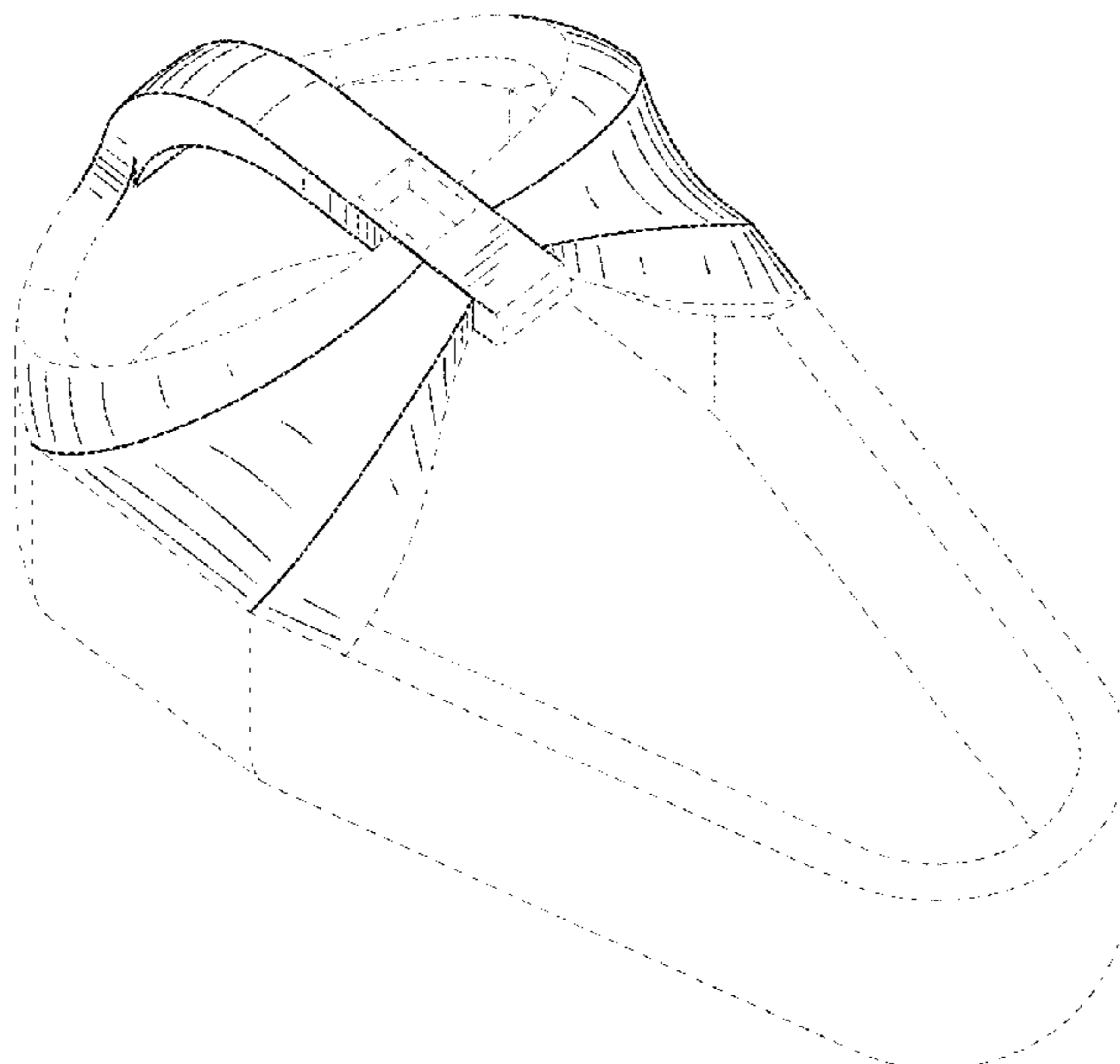

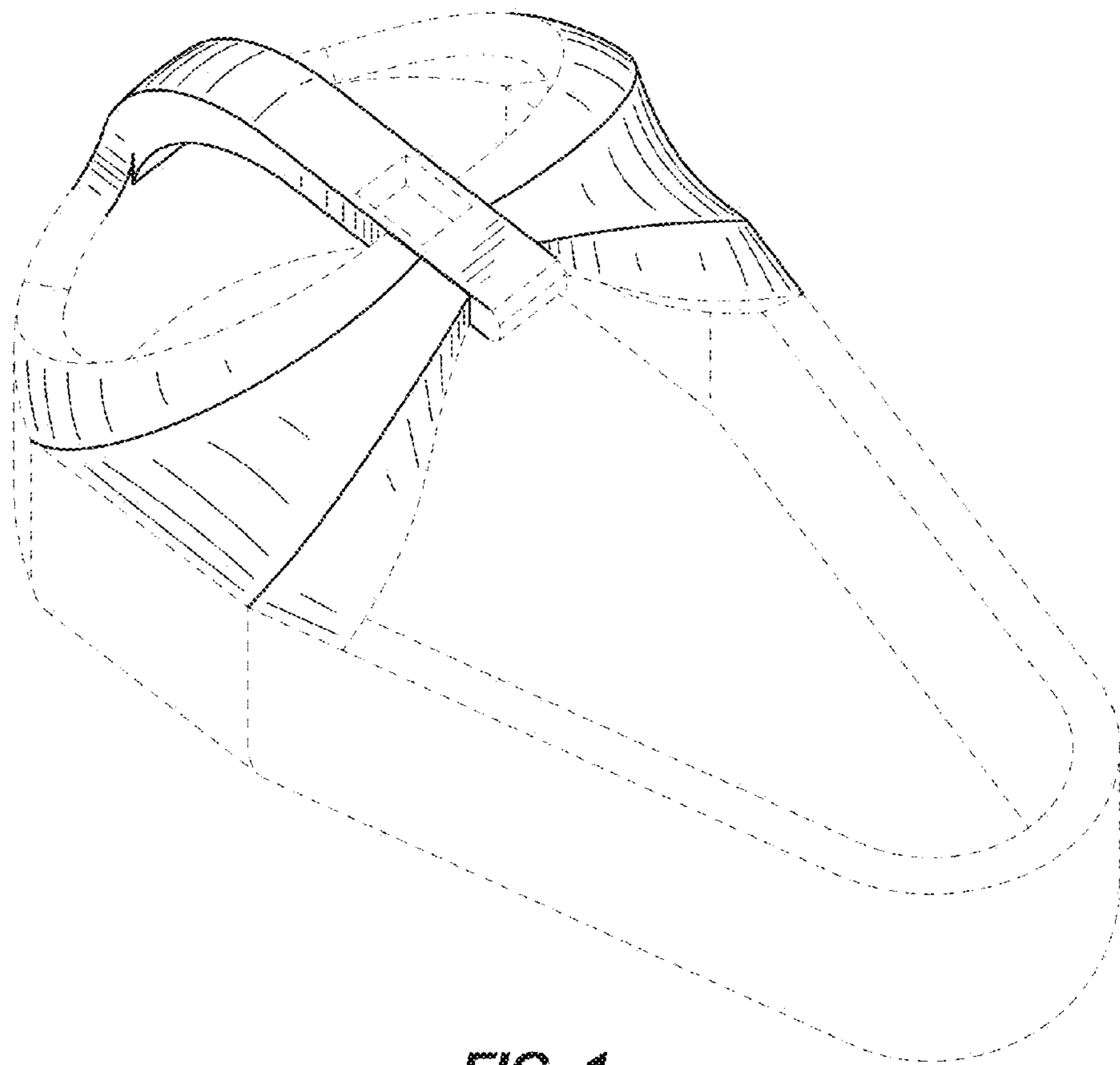

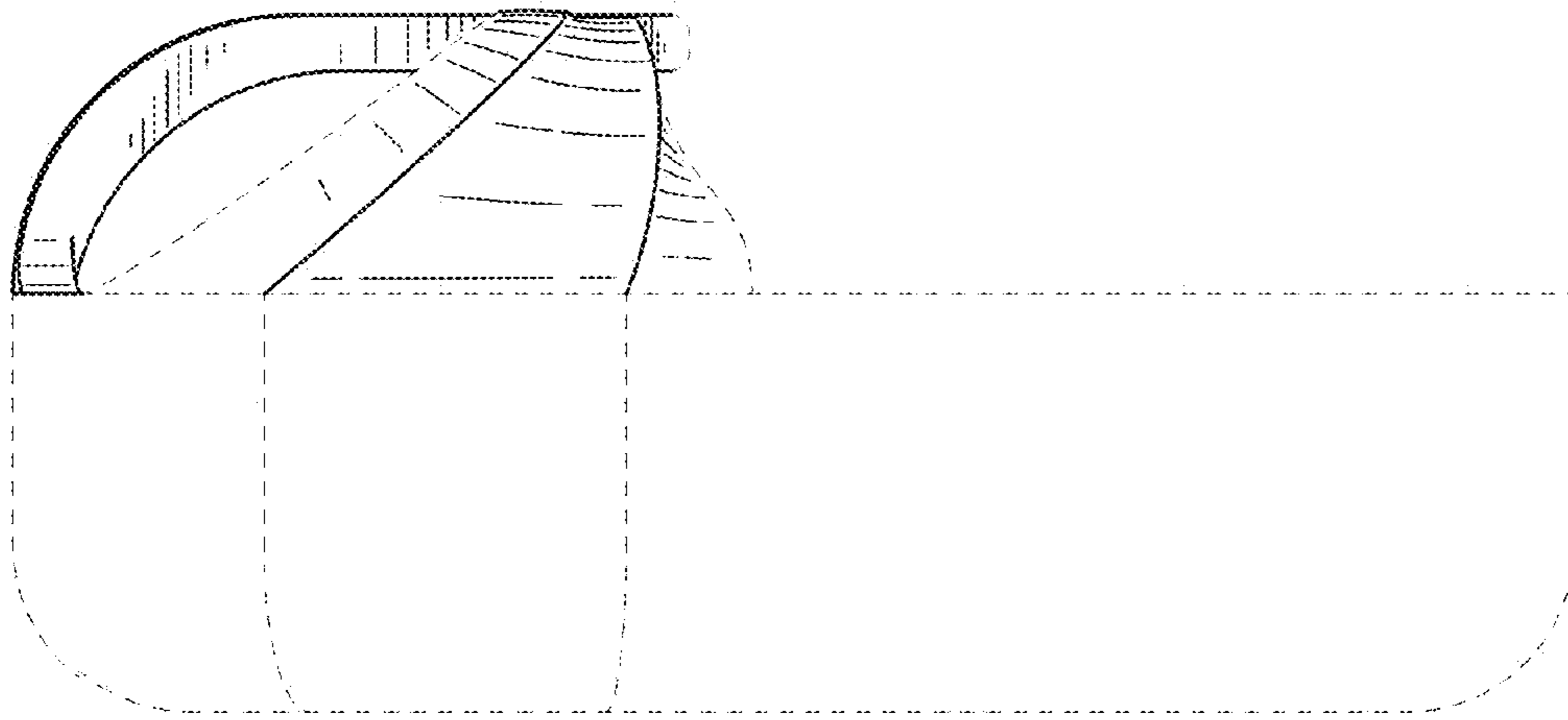

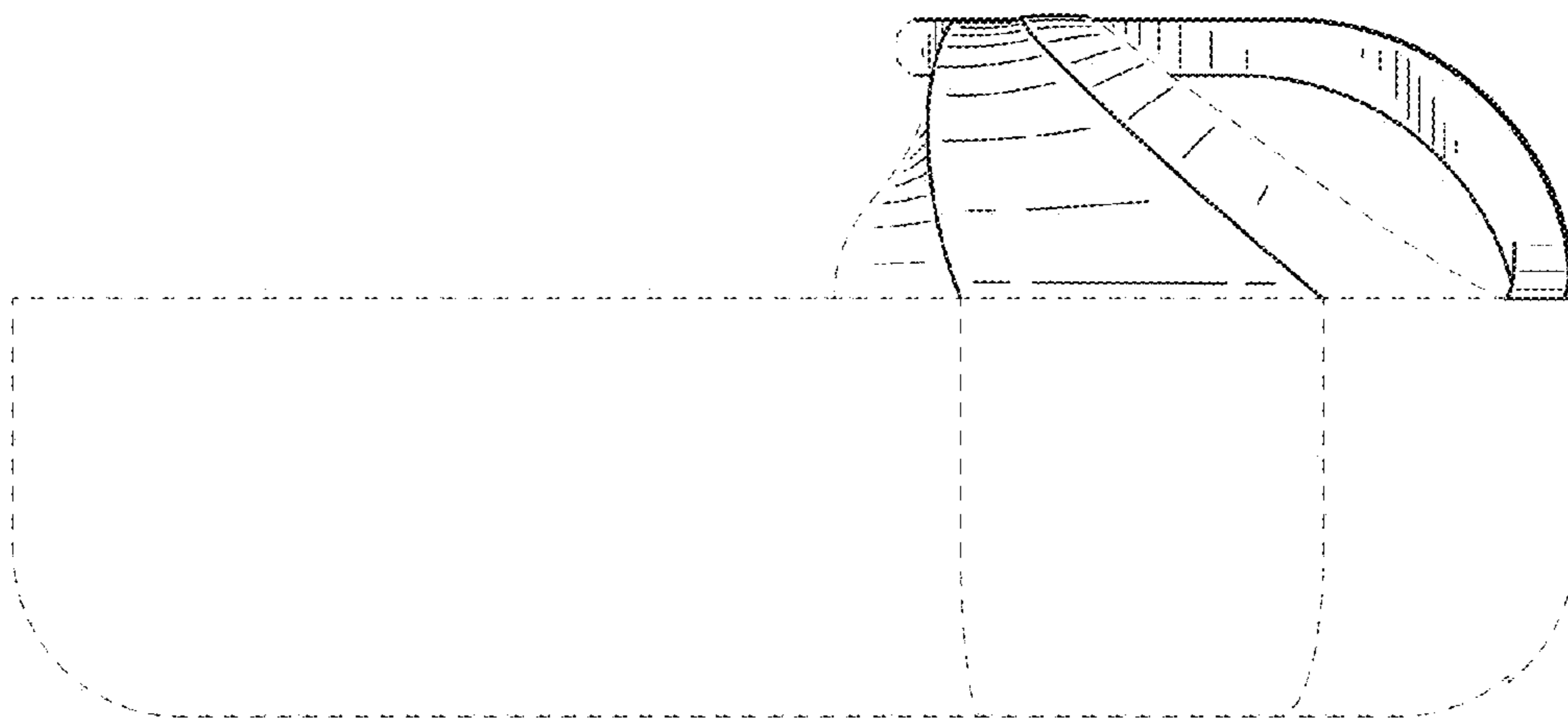

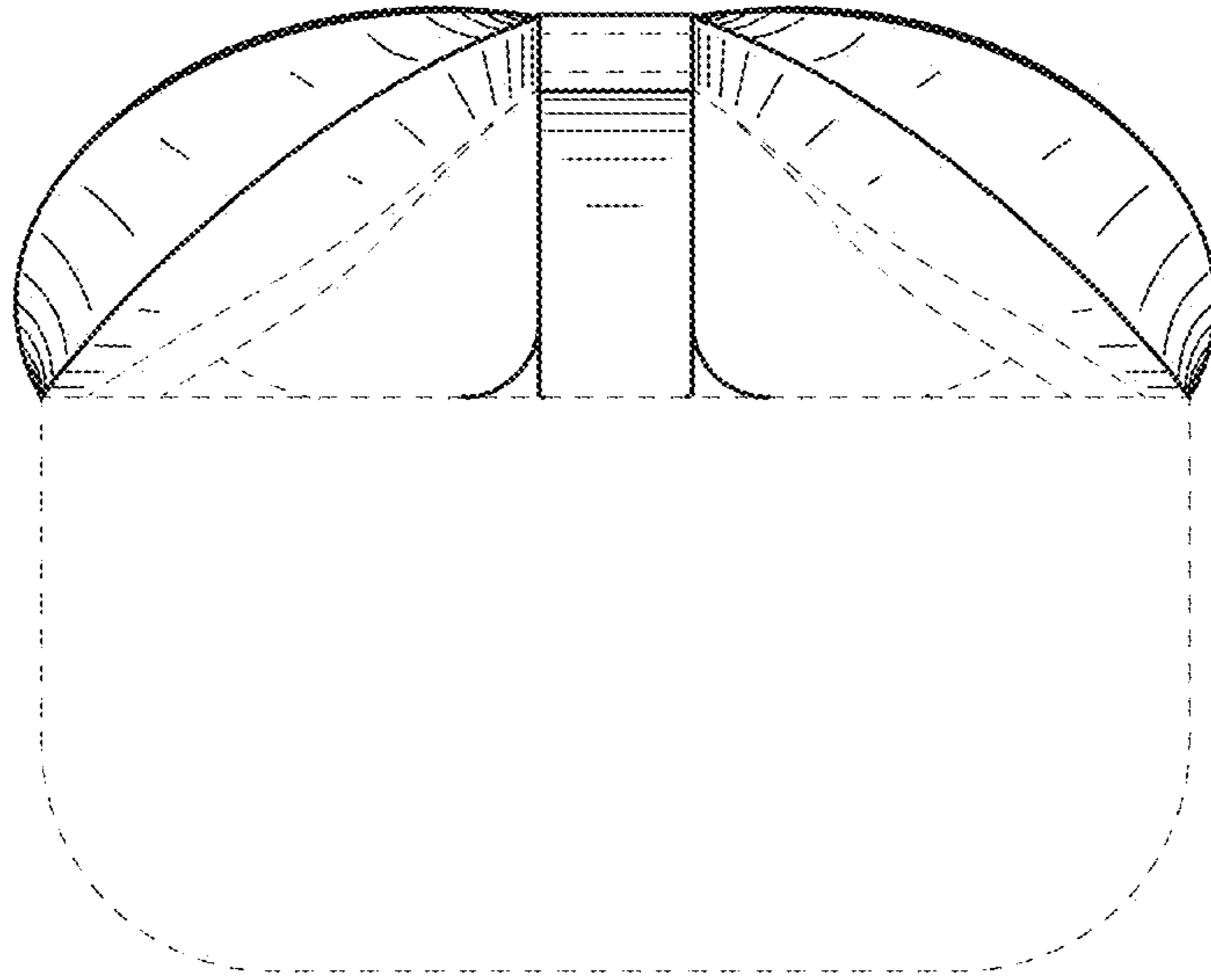

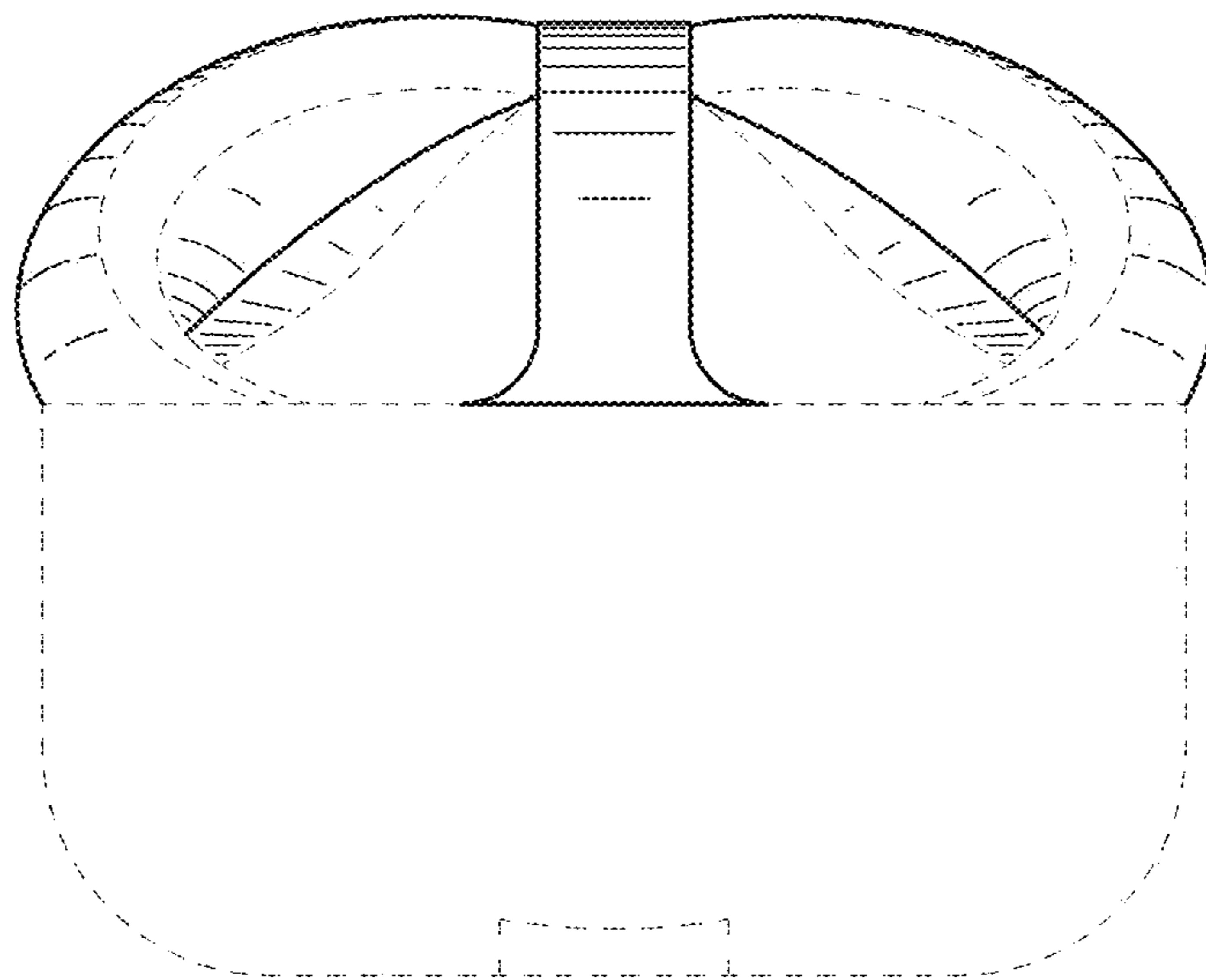

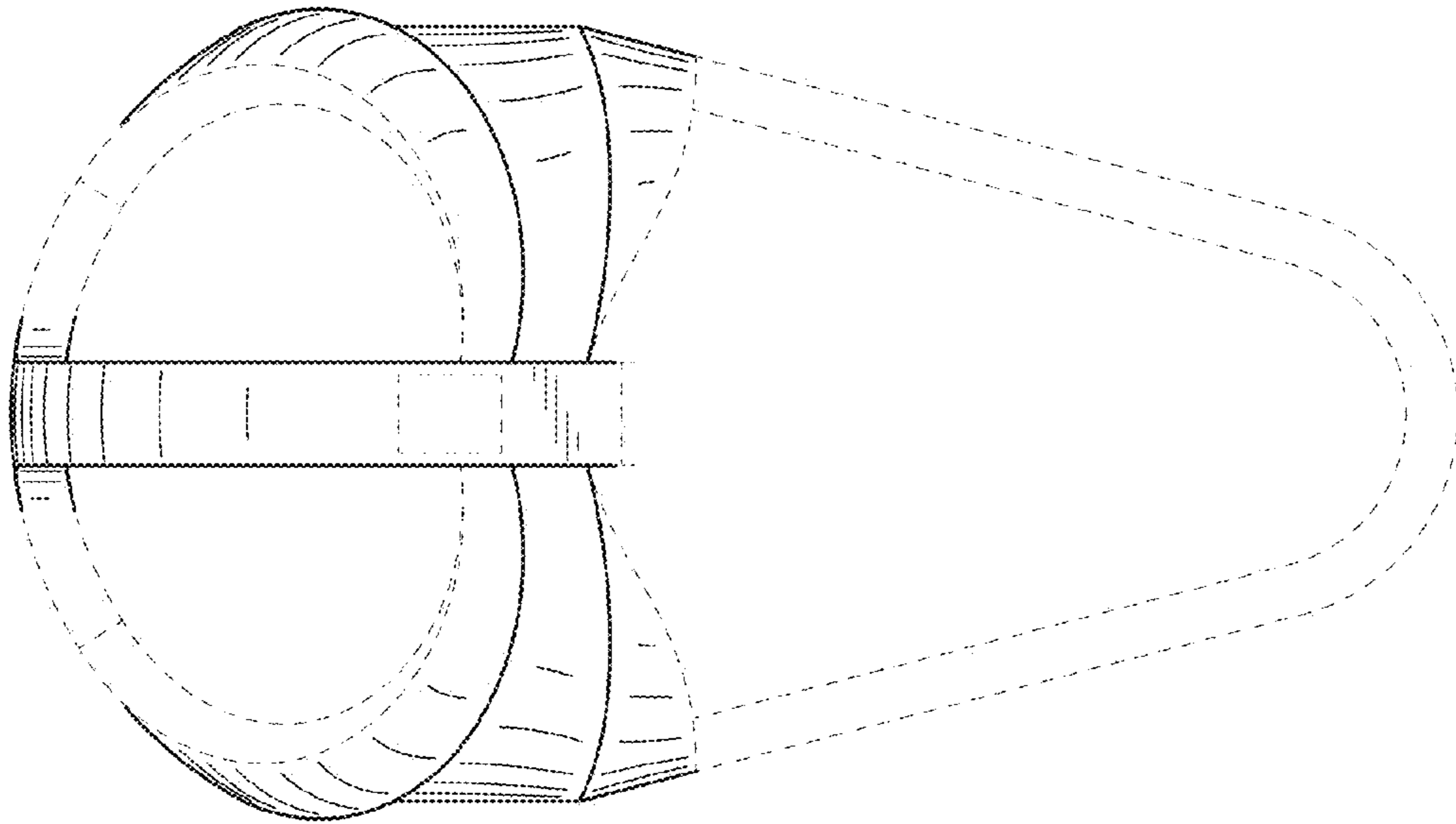

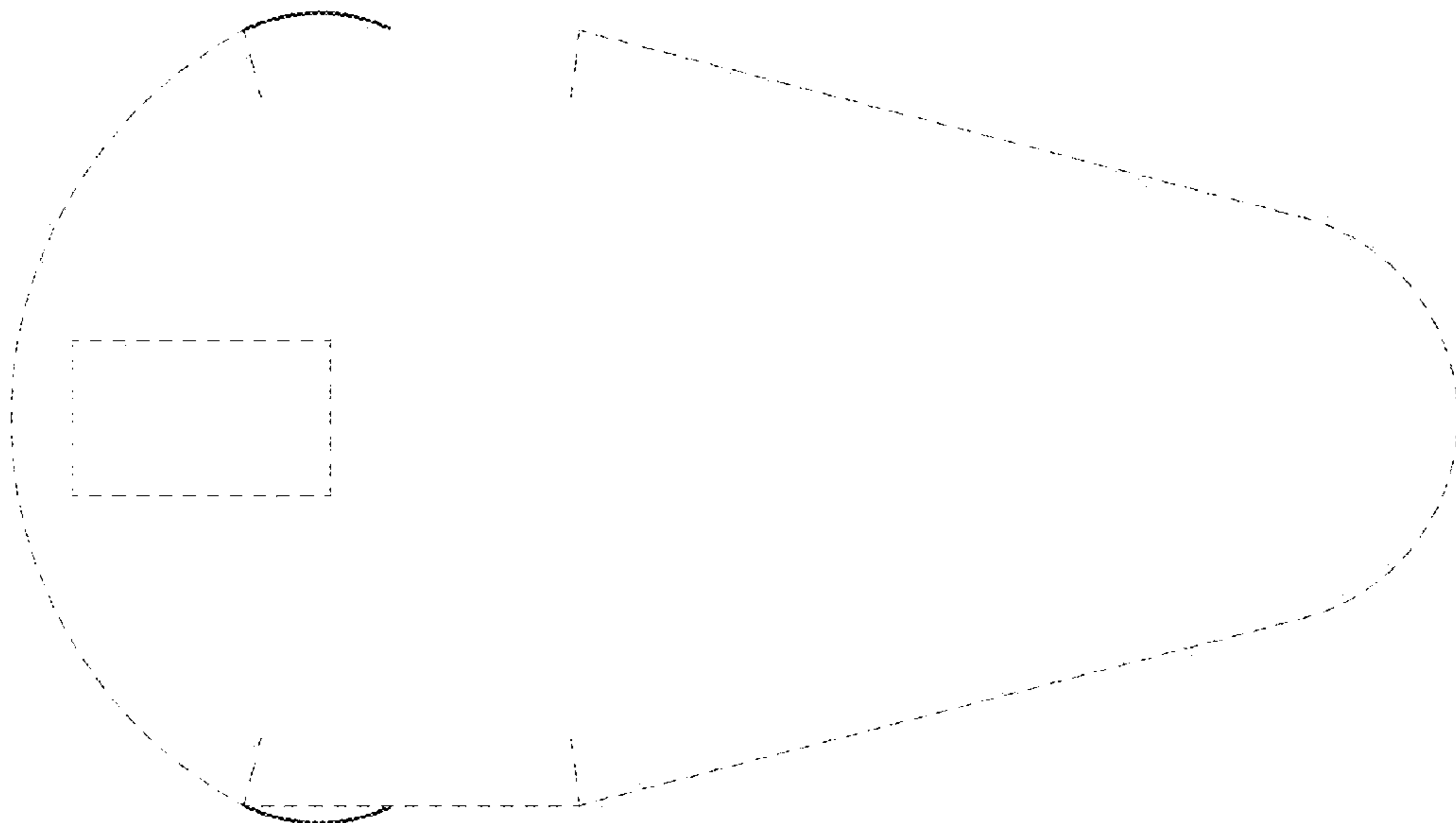
