(57) **CLAIM**

The ornamental design for an end frame for a bench, as shown
and described.

DESCRIPTION

FIG. 1 is an isometric view of an end frame for a bench
showing a first embodiment of my new design.

FIG. 2 is a right side elevational view of the end frame for a
bench of FIG. 1, the left side elevational view being a mirror
image thereof.

FIG. 3 is a front elevational view of the end frame for a bench
of FIG. 1.

FIG. 4 is a bottom plan view of the end frame for a bench of
FIG. 1.

FIG. 5 is a top plan view of the end frame for a bench of FIG.
1.

FIG. 6 is a back elevational view of the end frame for a bench
of FIG. 1.

FIG. 7 is an isometric view of an end frame for a bench
showing a second embodiment of my new design.

FIG. 8 is a right side elevational view of the end frame for a
bench of FIG. 7, the left side elevational view being a mirror
image thereof.

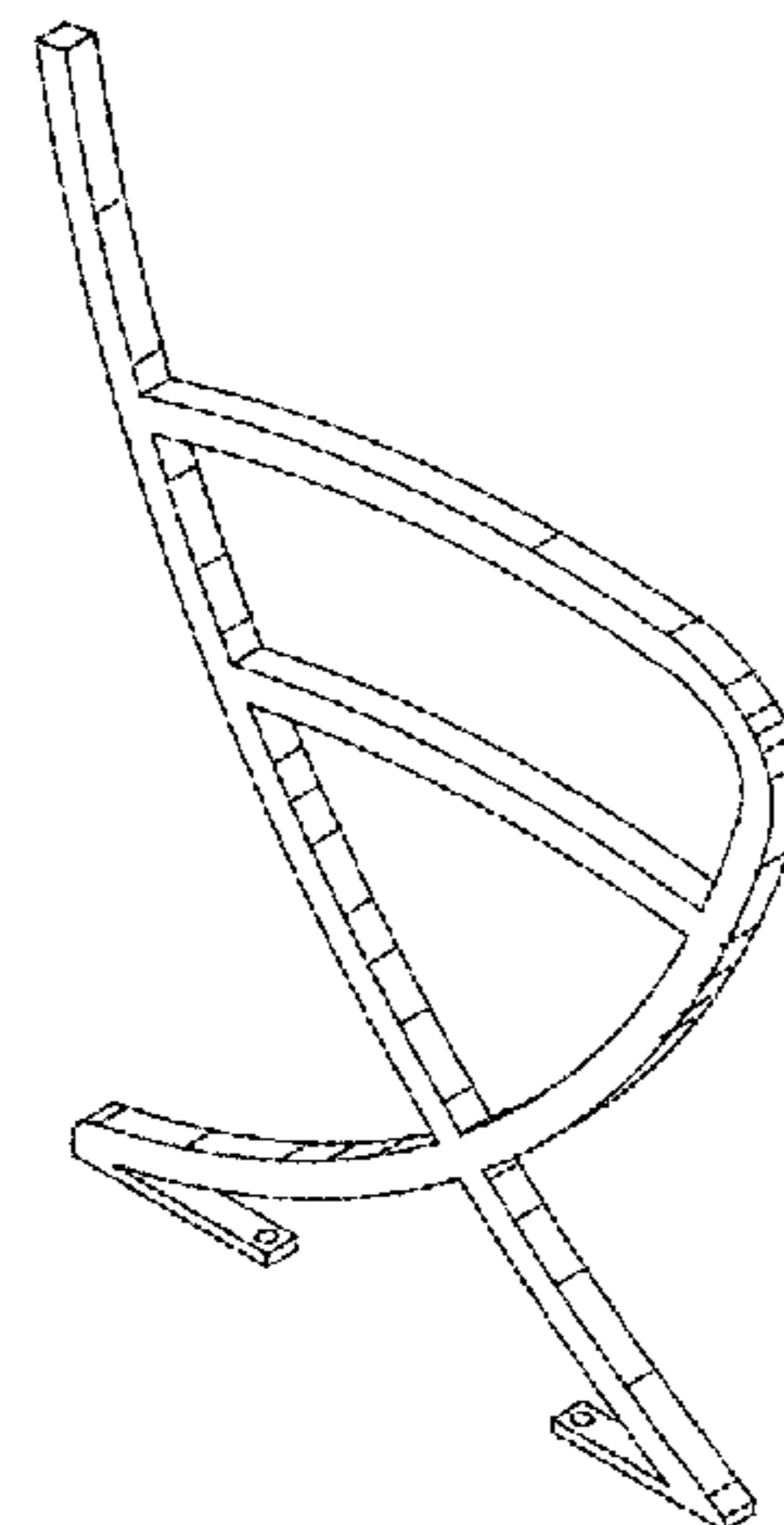
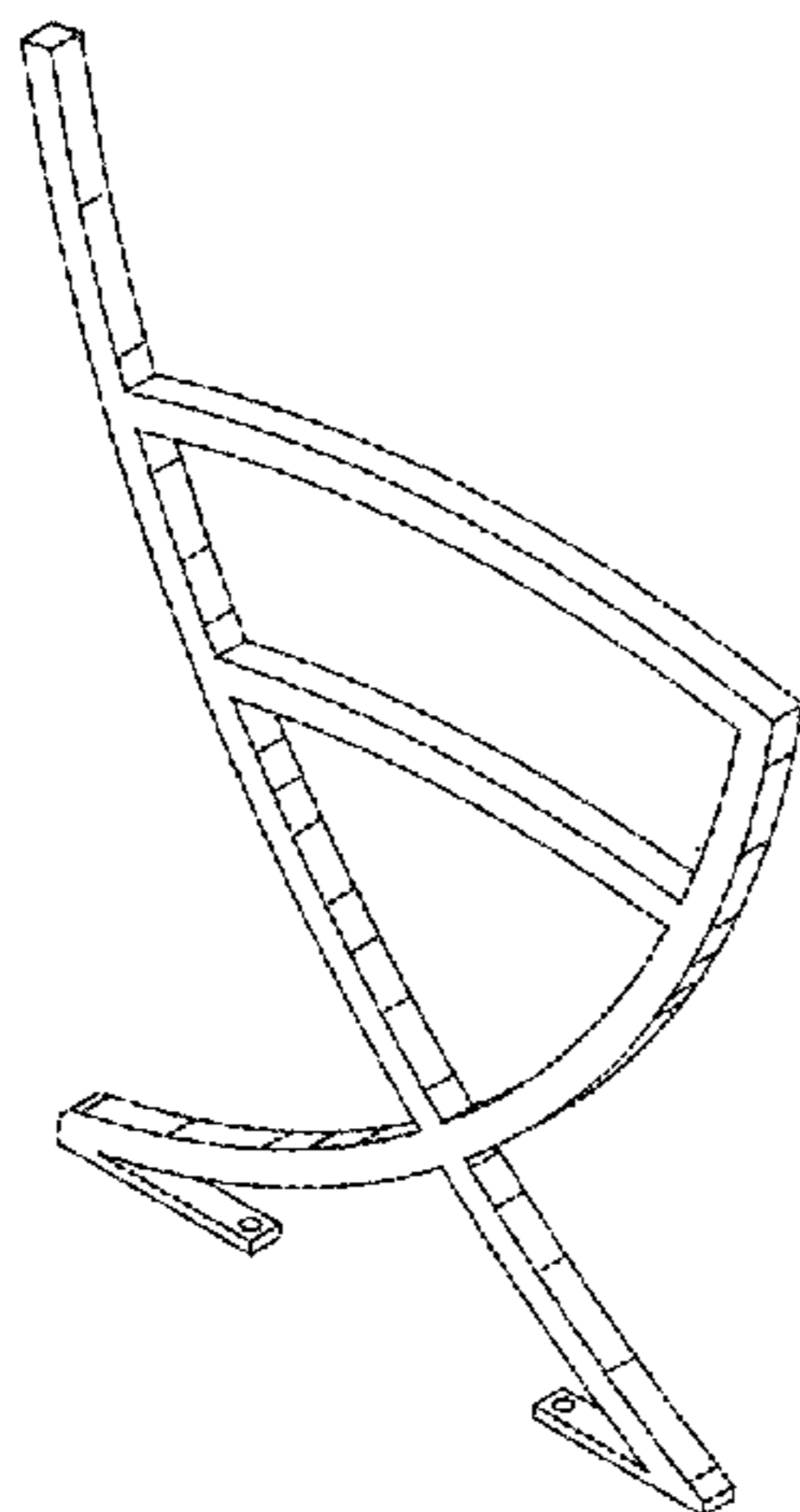
FIG. 9 is a front elevational view of the end frame for a bench
