The ornamental design of a carafe, as shown and described.

**DESCRIPTION**

FIG. 1 is a side view of the carafe of the present invention. FIG. 2 is an exploded side view thereof; FIG. 3 is another exploded side view thereof; FIG. 4 is a top, side perspective view thereof; FIG. 5 is another exploded side view thereof with the lid in alternate position; FIG. 6 is a top, side perspective view thereof where the top and bottom portions are almost removed; and, FIG. 7 is another exploded side perspective view thereof.

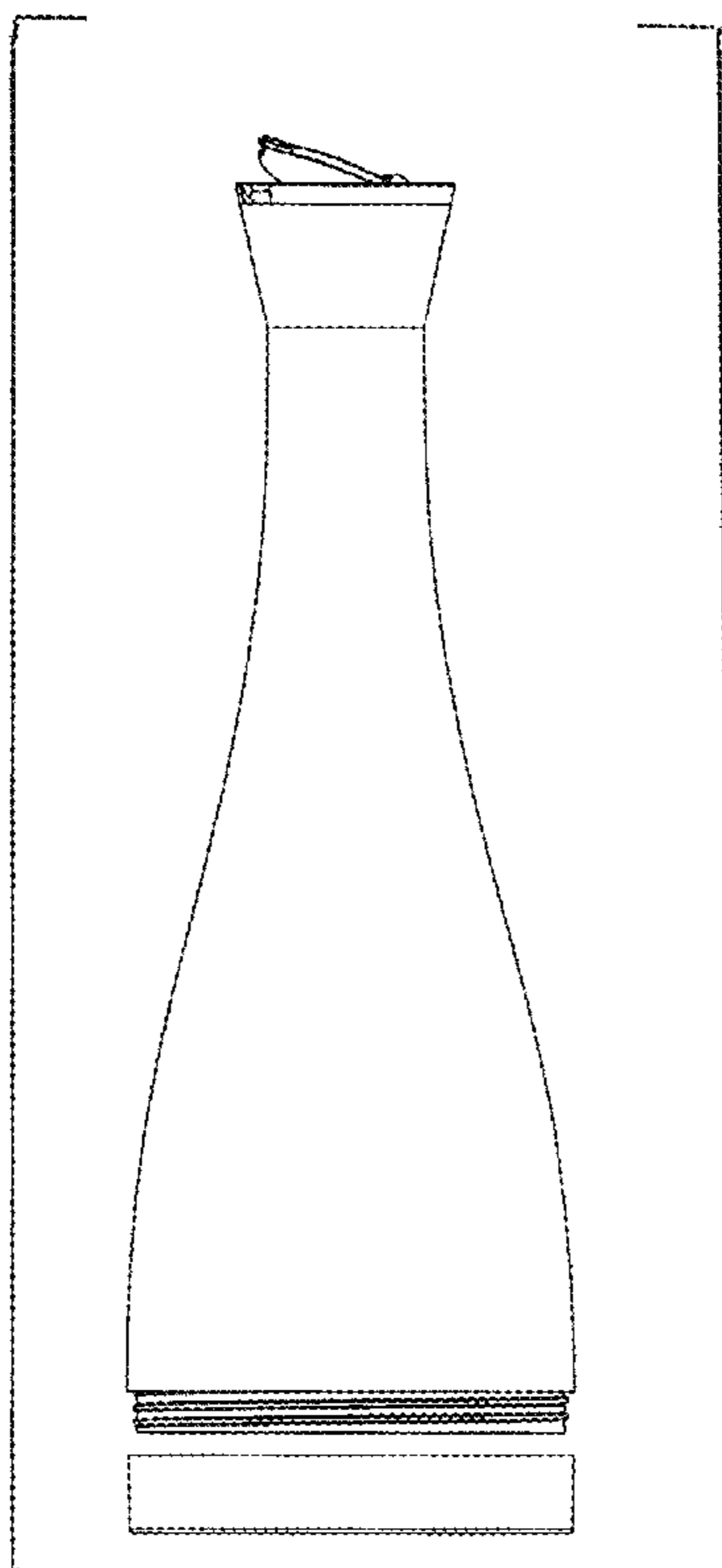
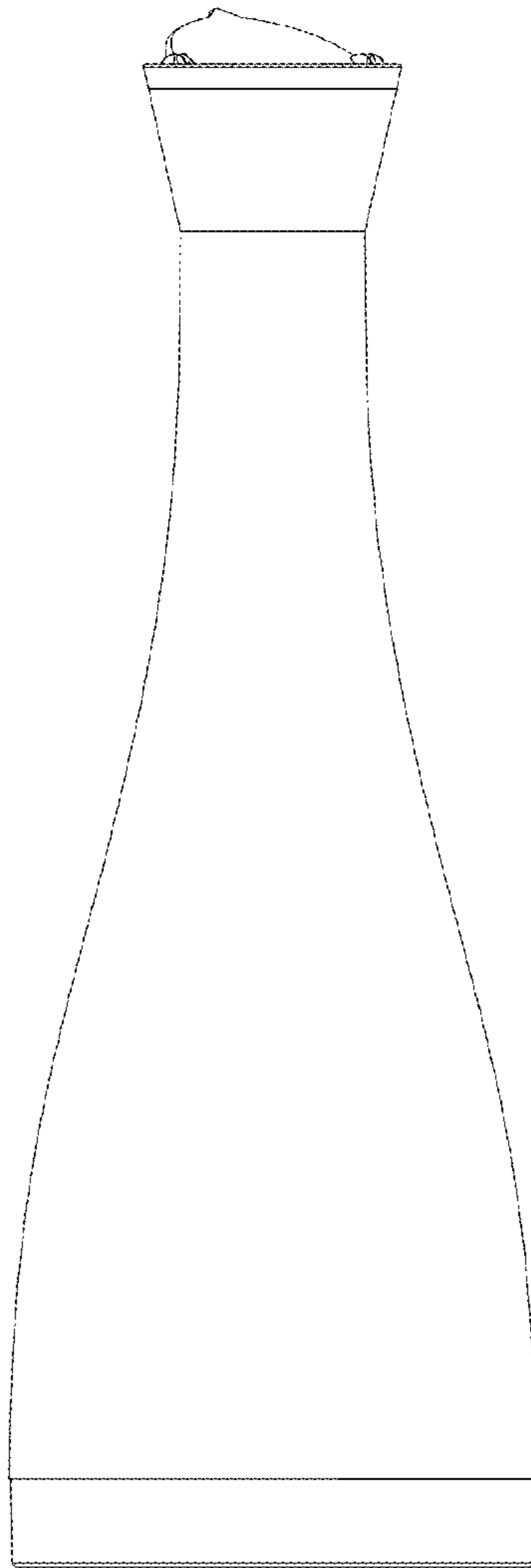

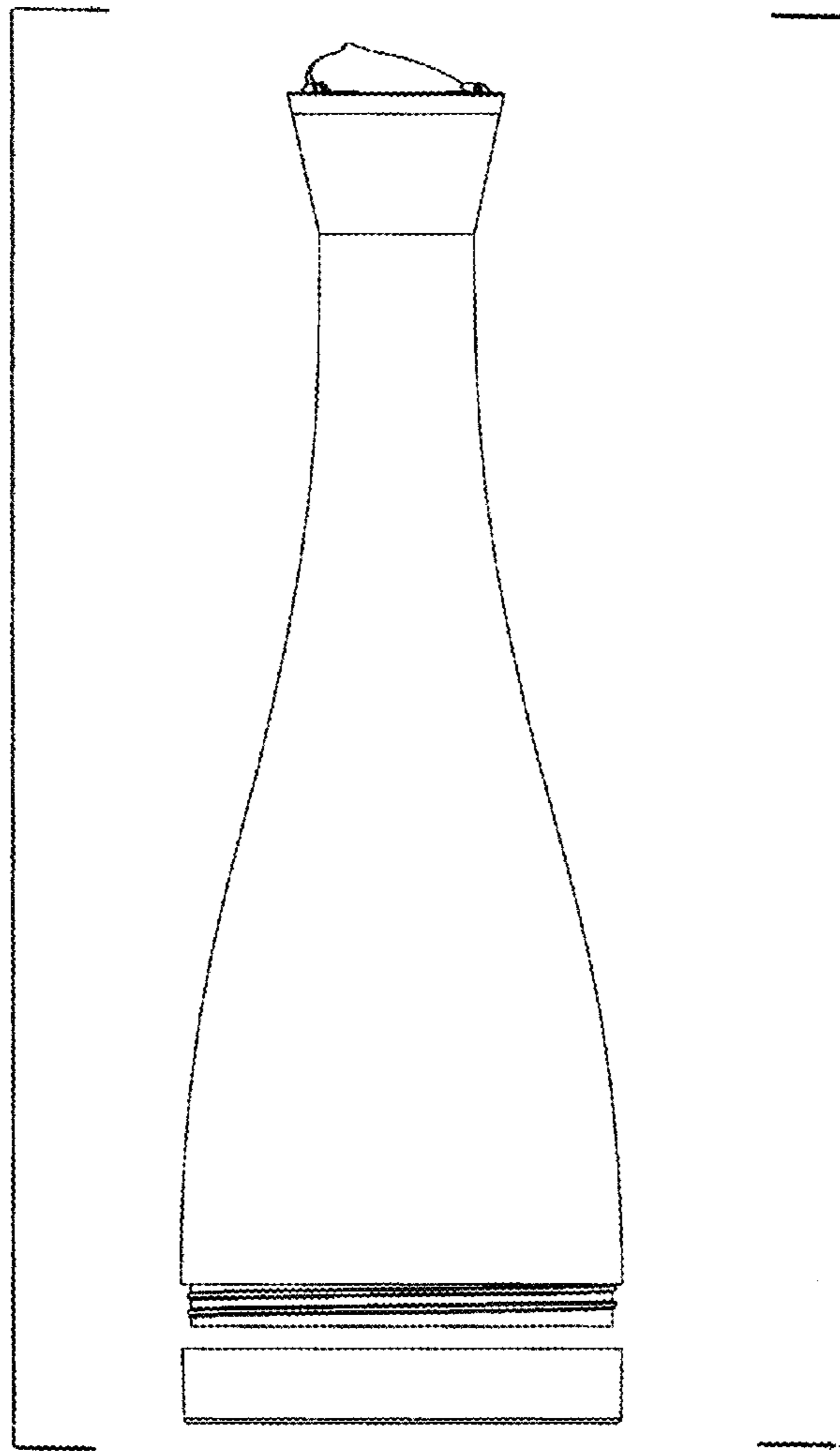
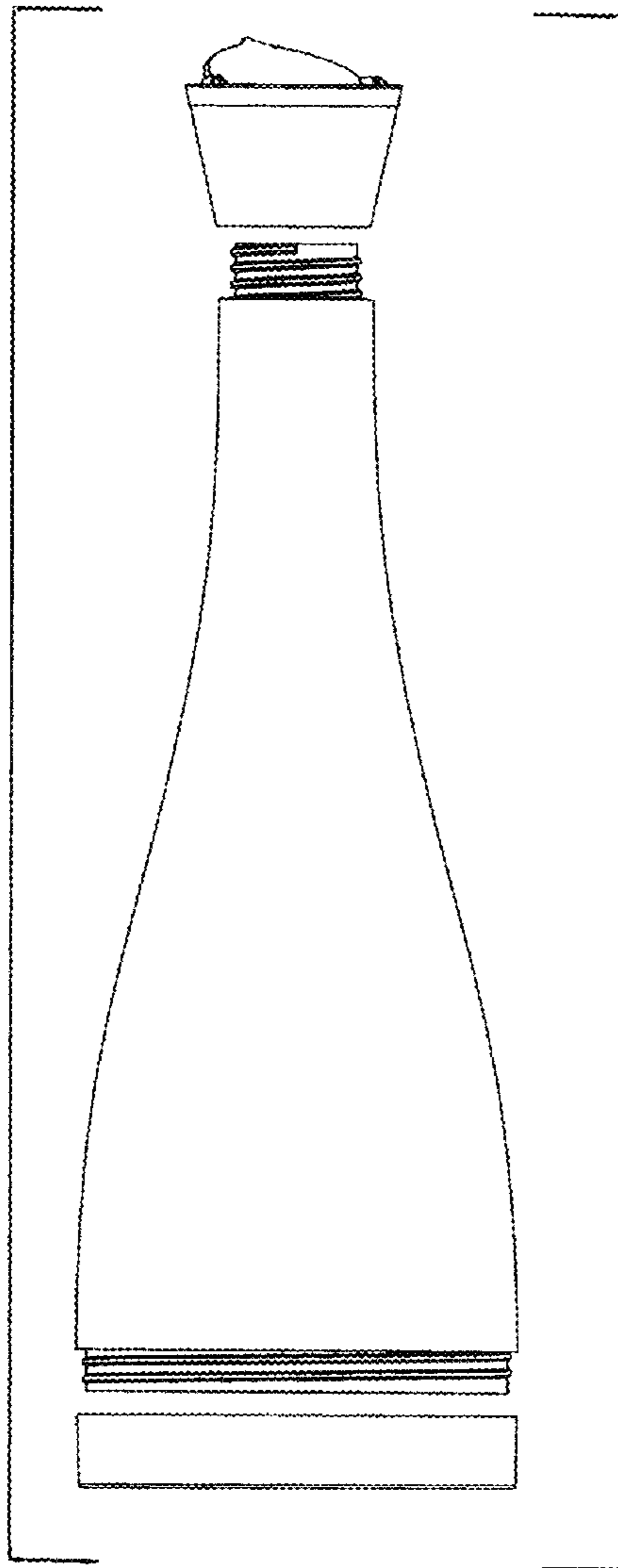

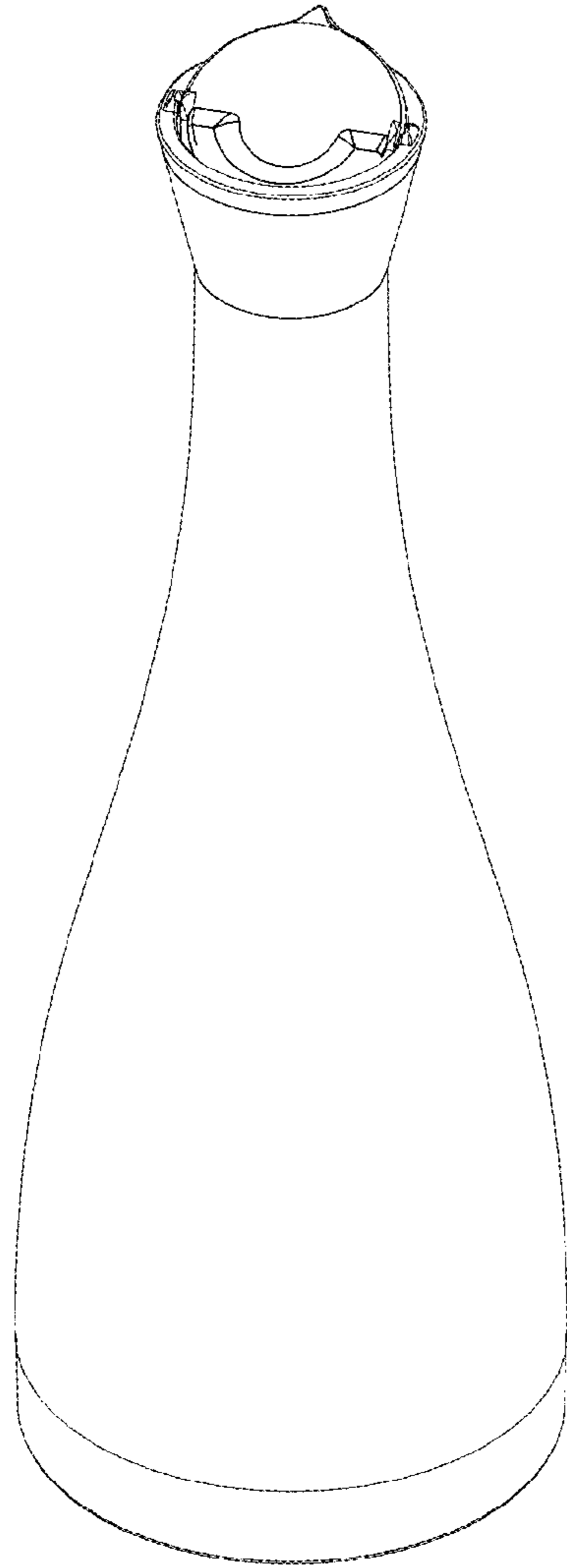

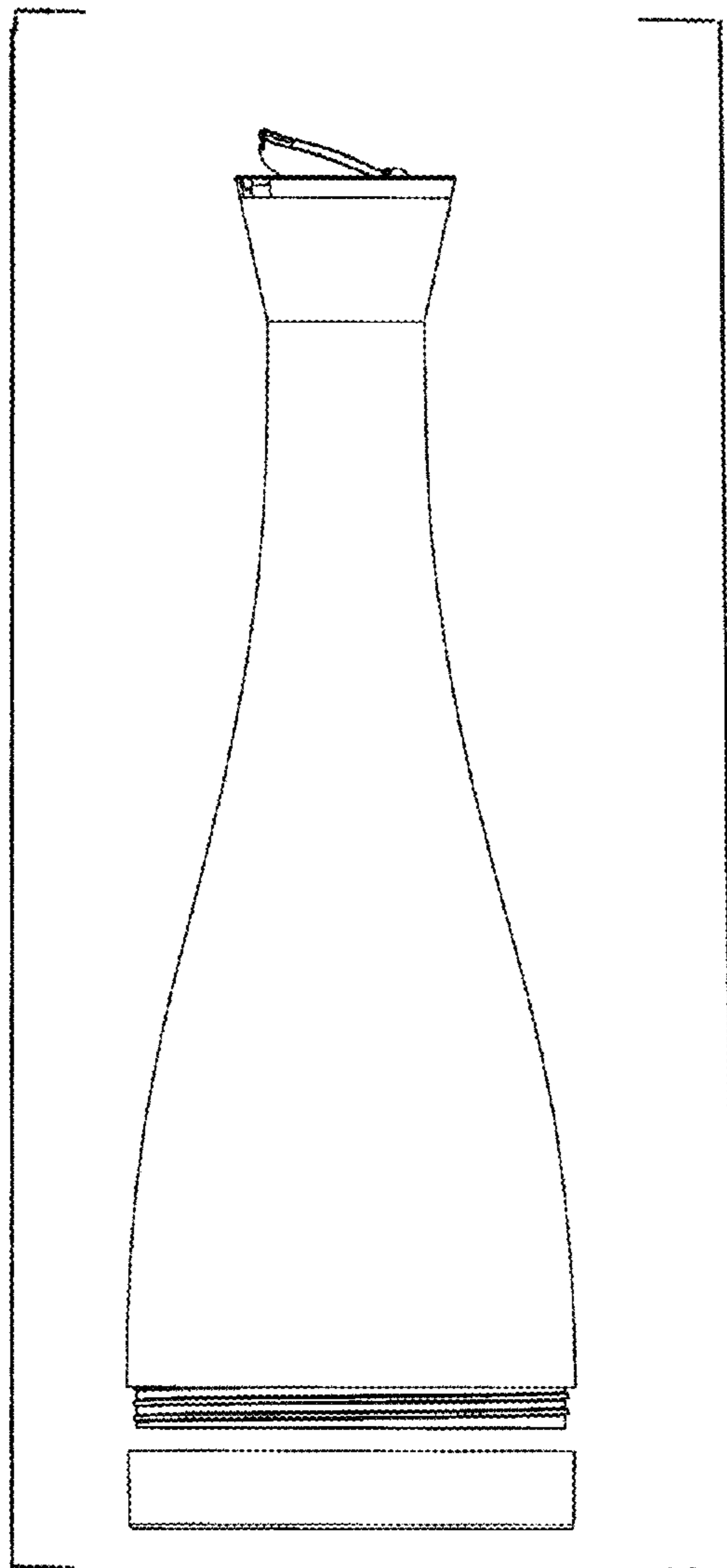

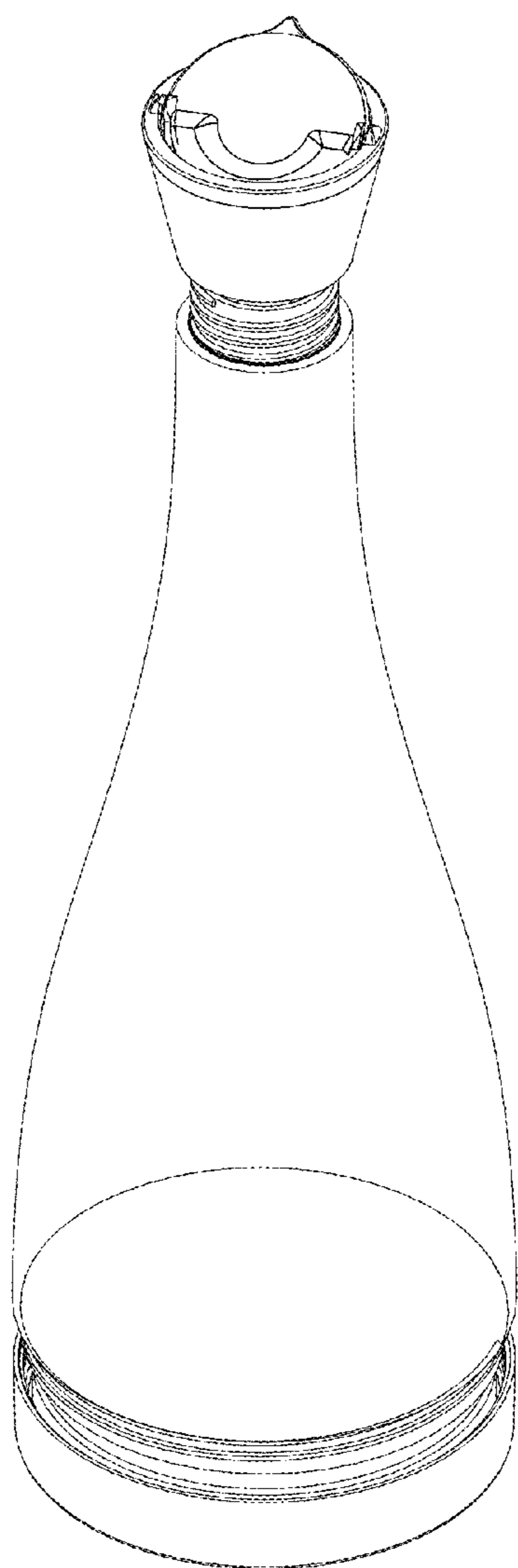

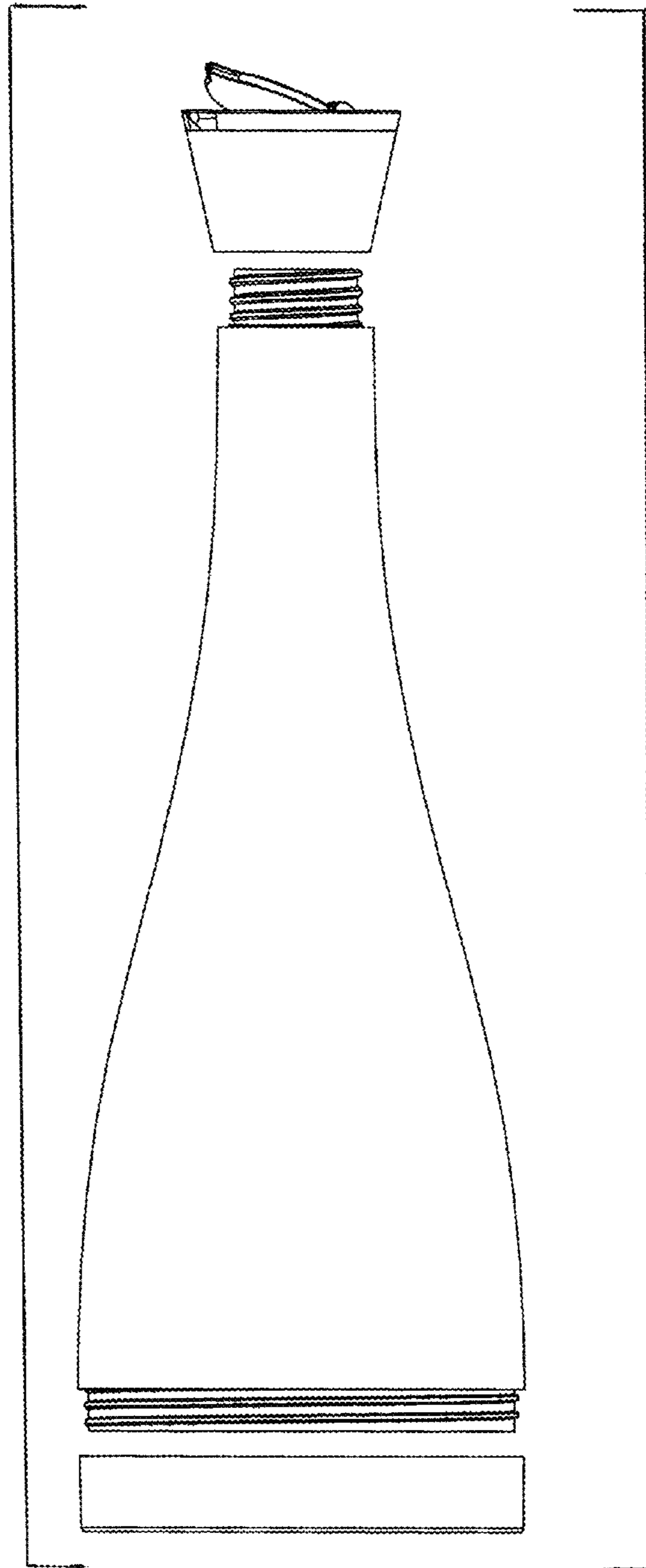
