FIG. 4 is a right side elevation view thereof, the left side elevation view being identical;

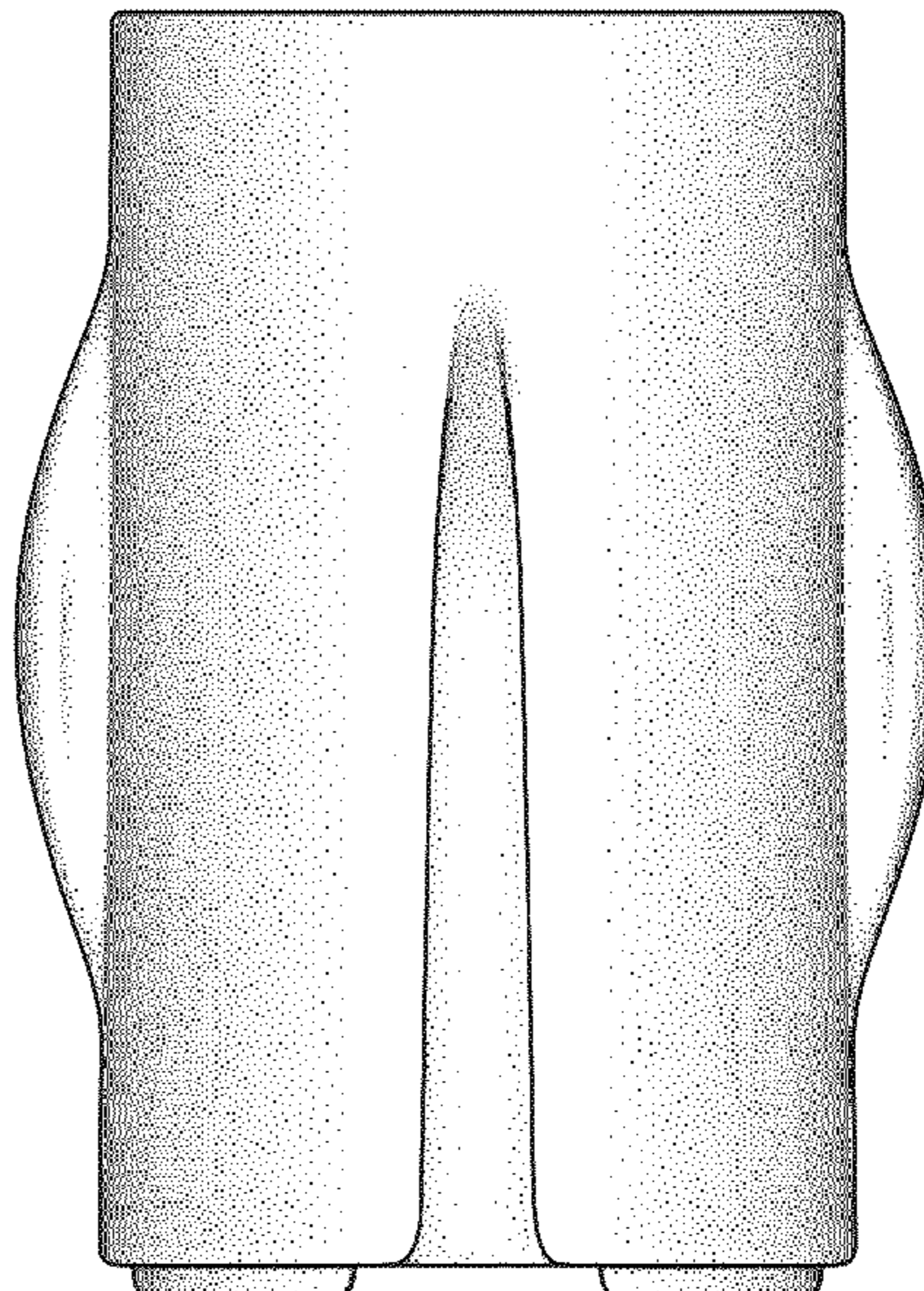
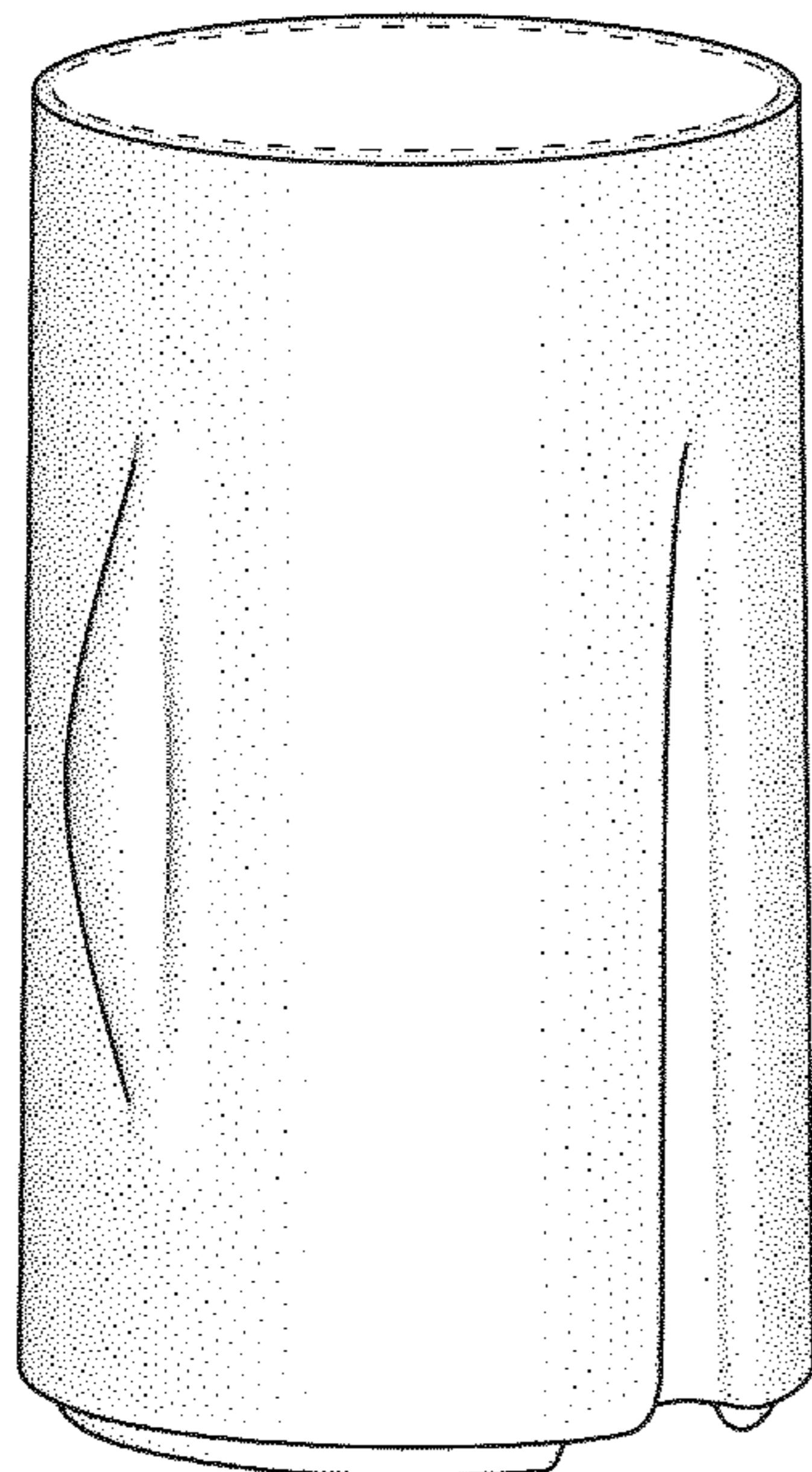
FIG. 5 is a top plan view thereof; and,

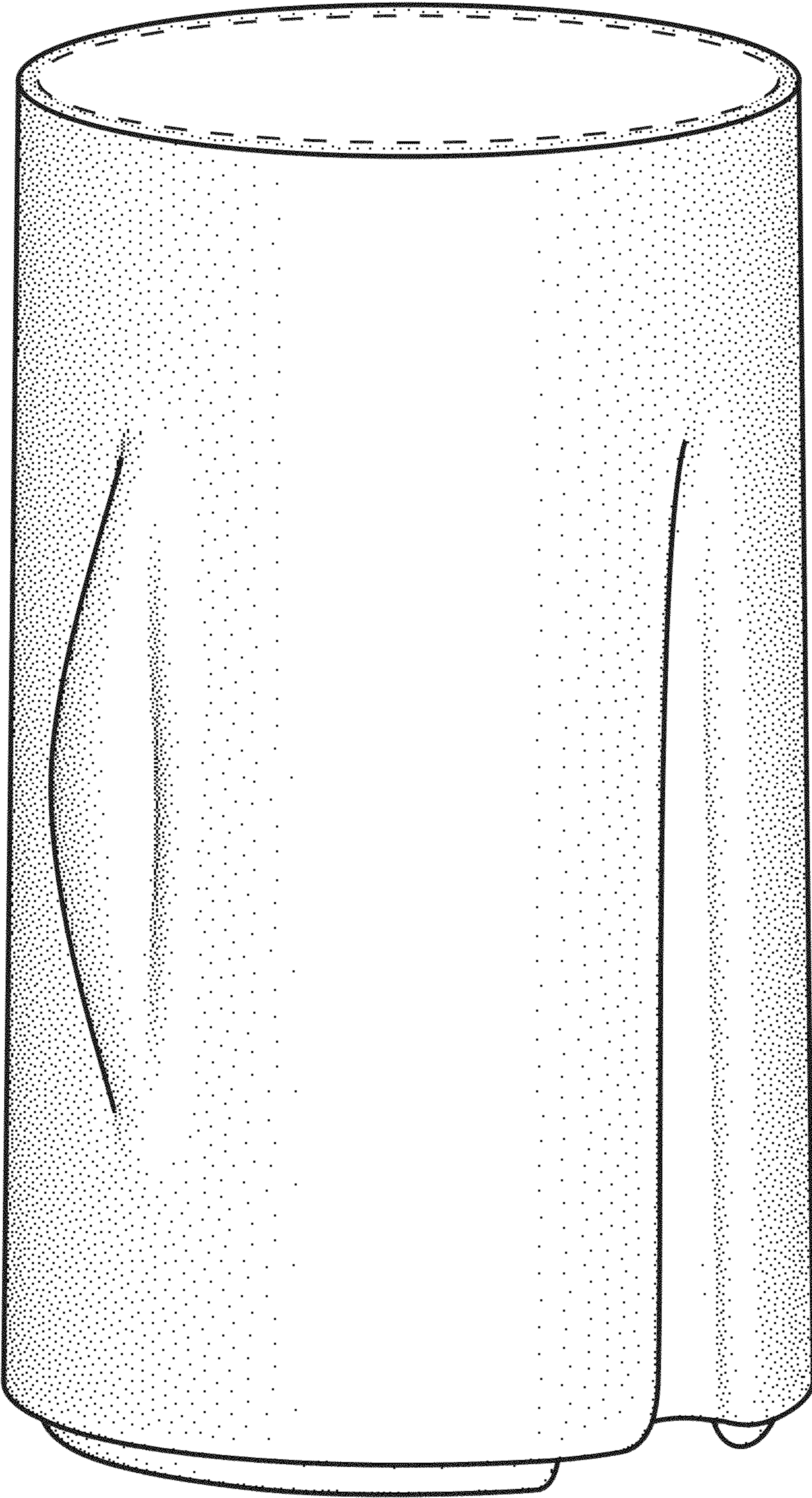

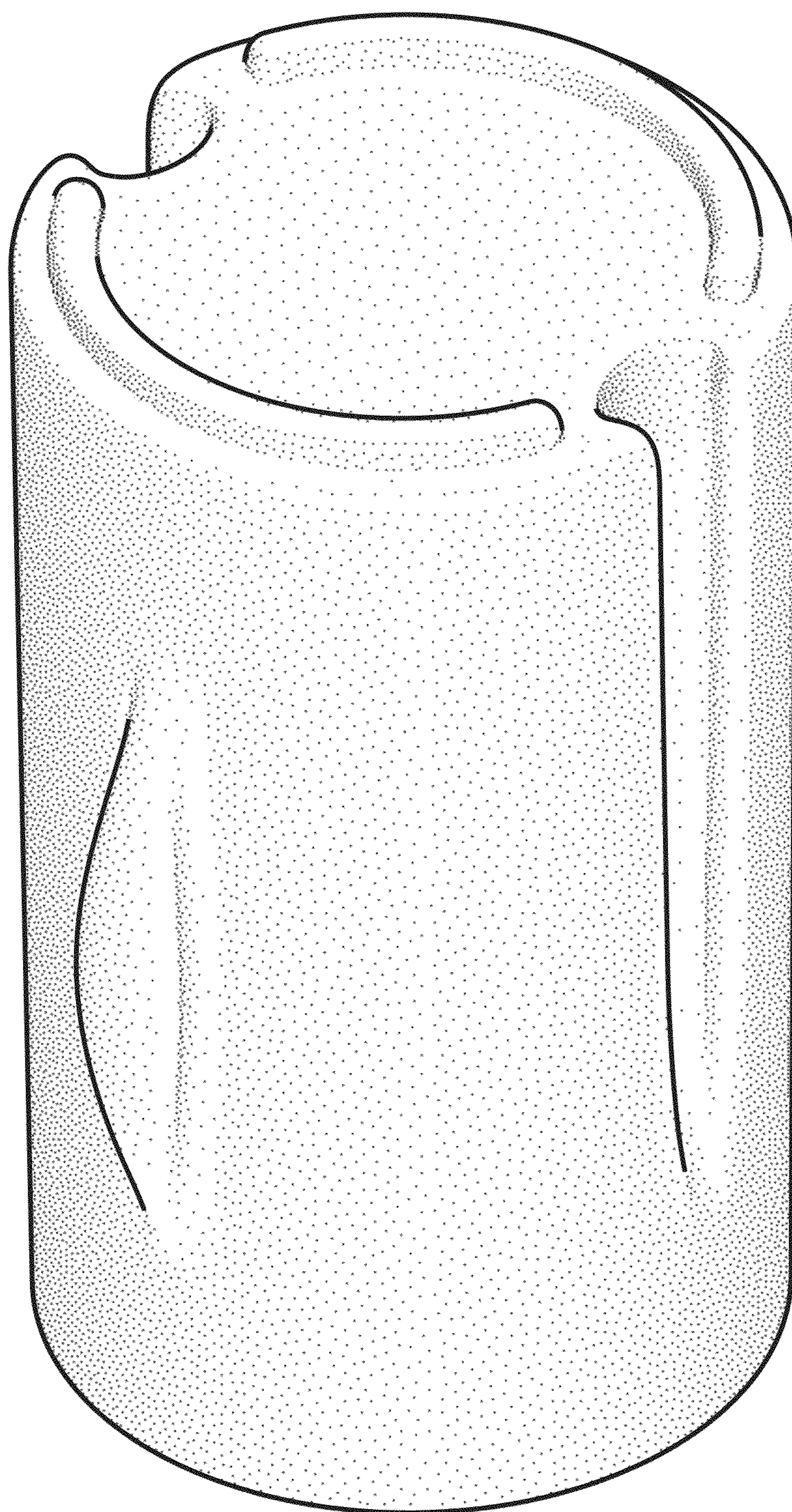

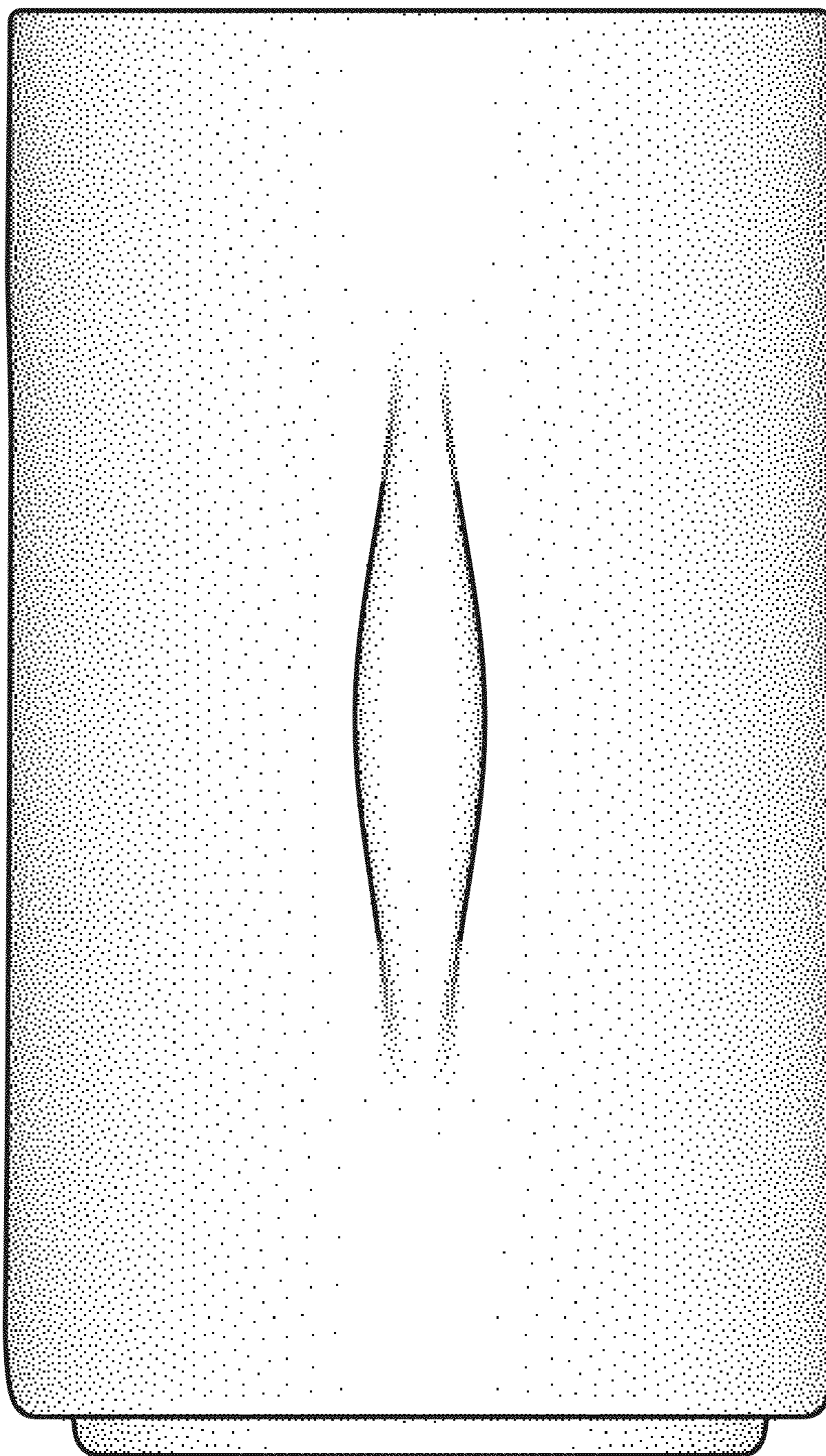

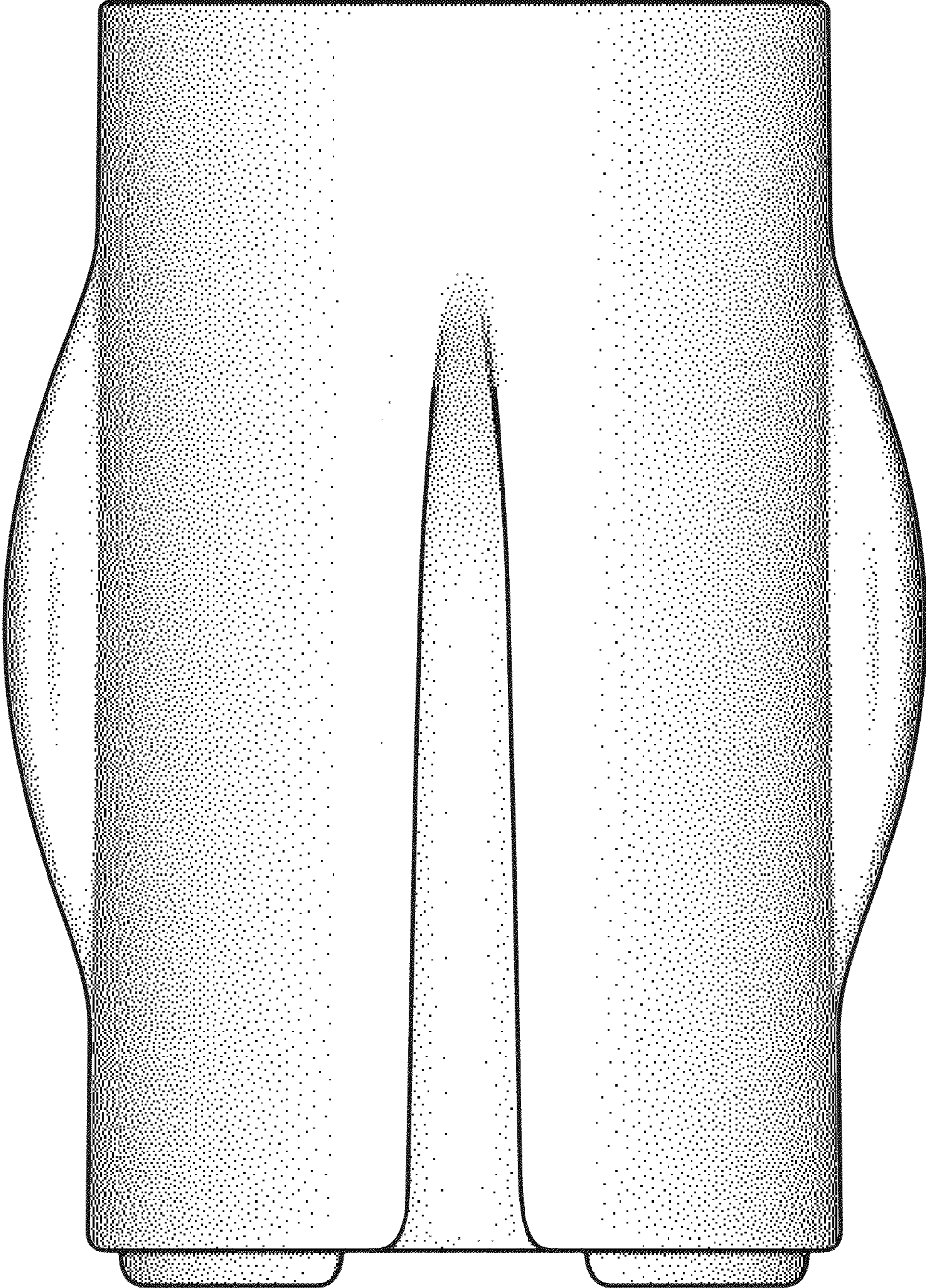

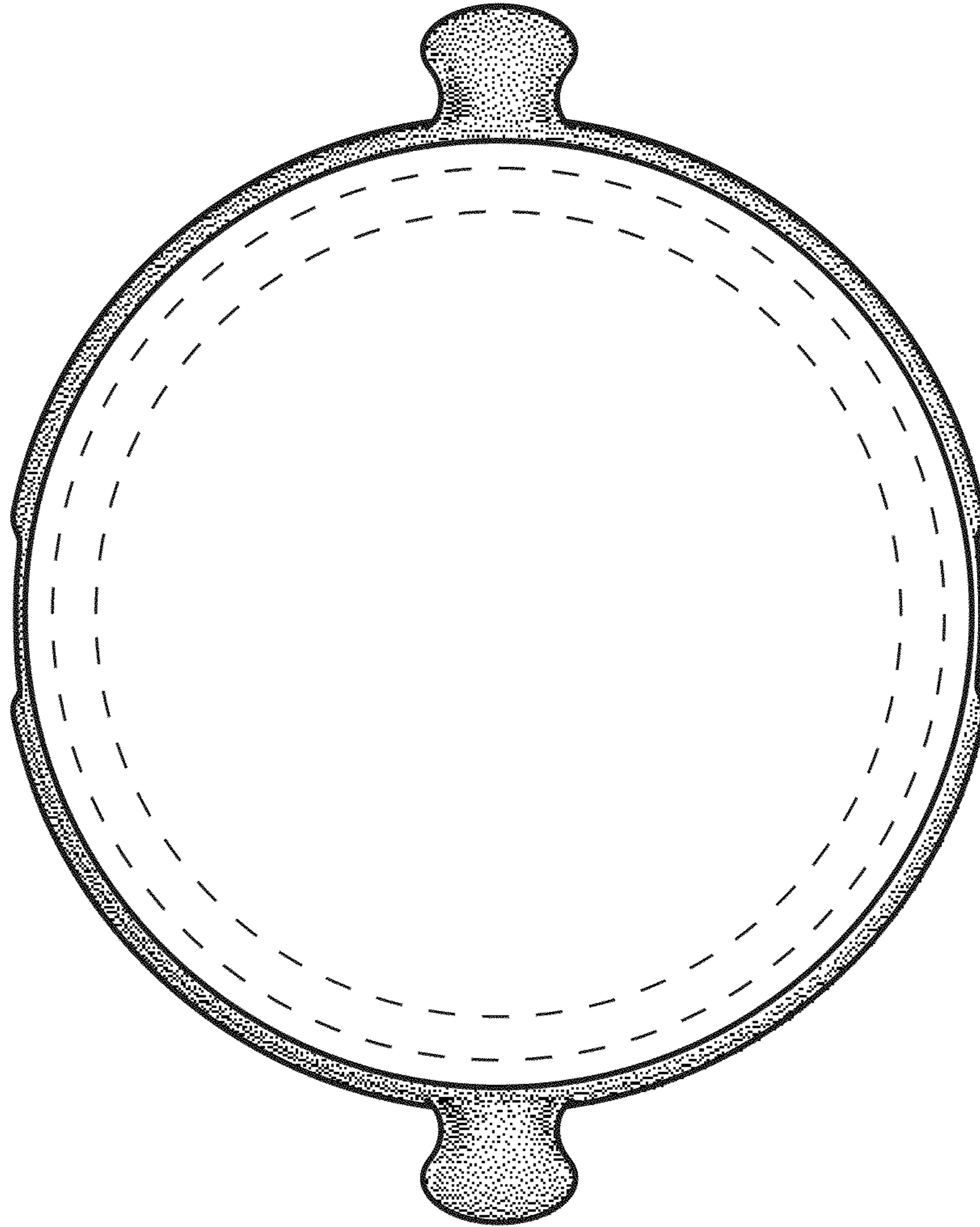

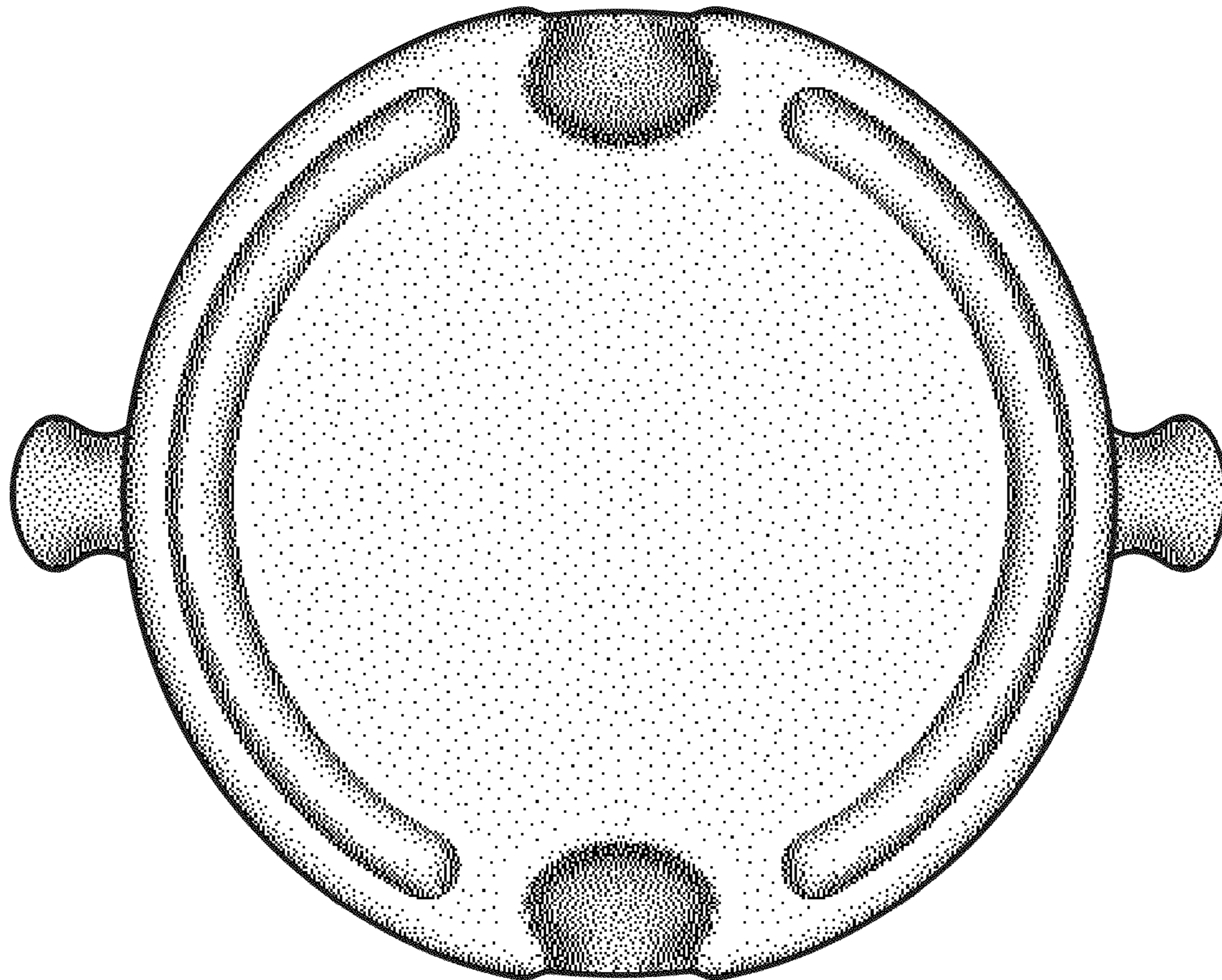
