The ornamental design for a package for retail display and sale, substantially as shown and described.

**DESCRIPTION**

FIG. 11 is a left side view of the embodiment of FIG. 8.

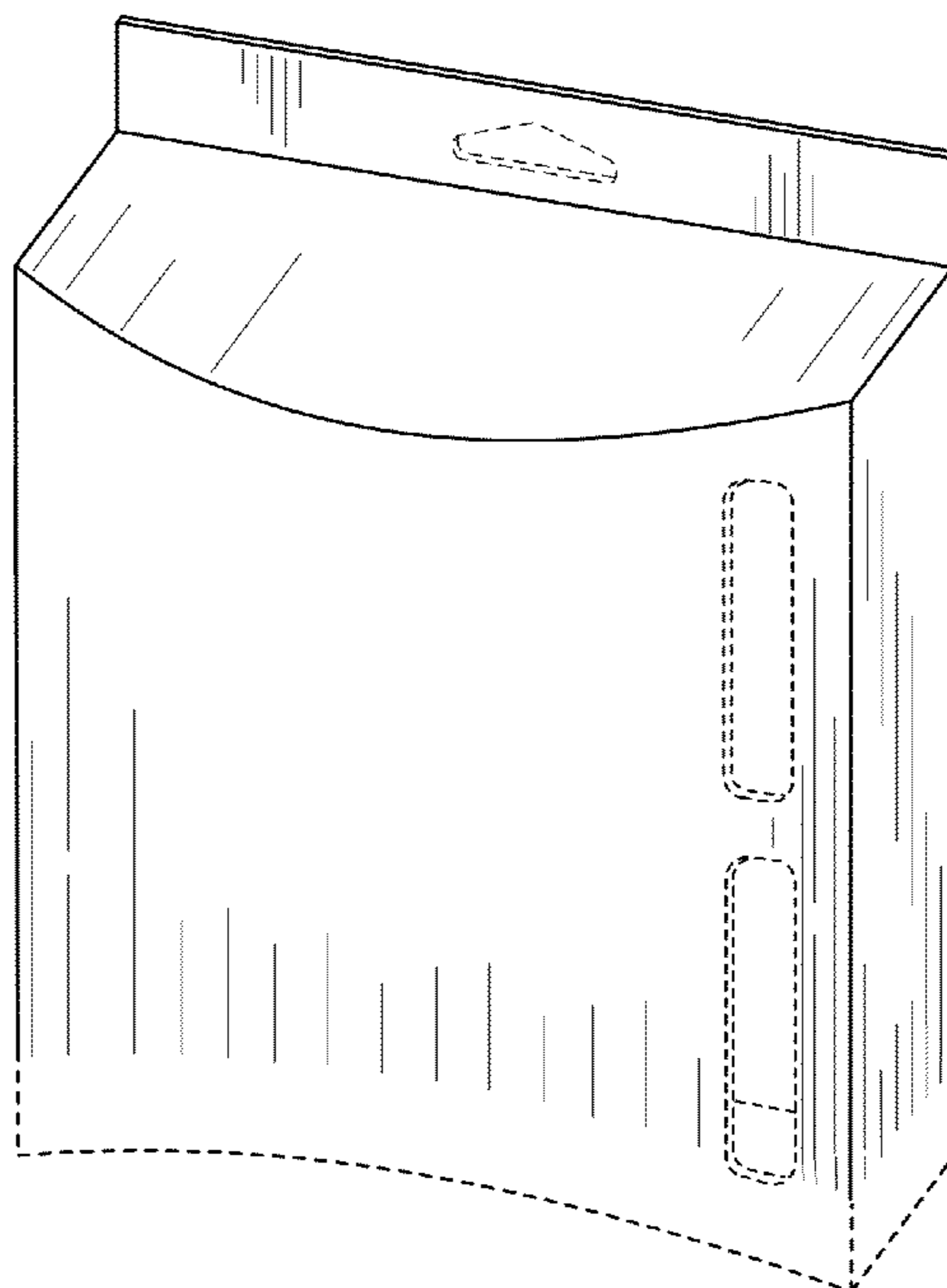
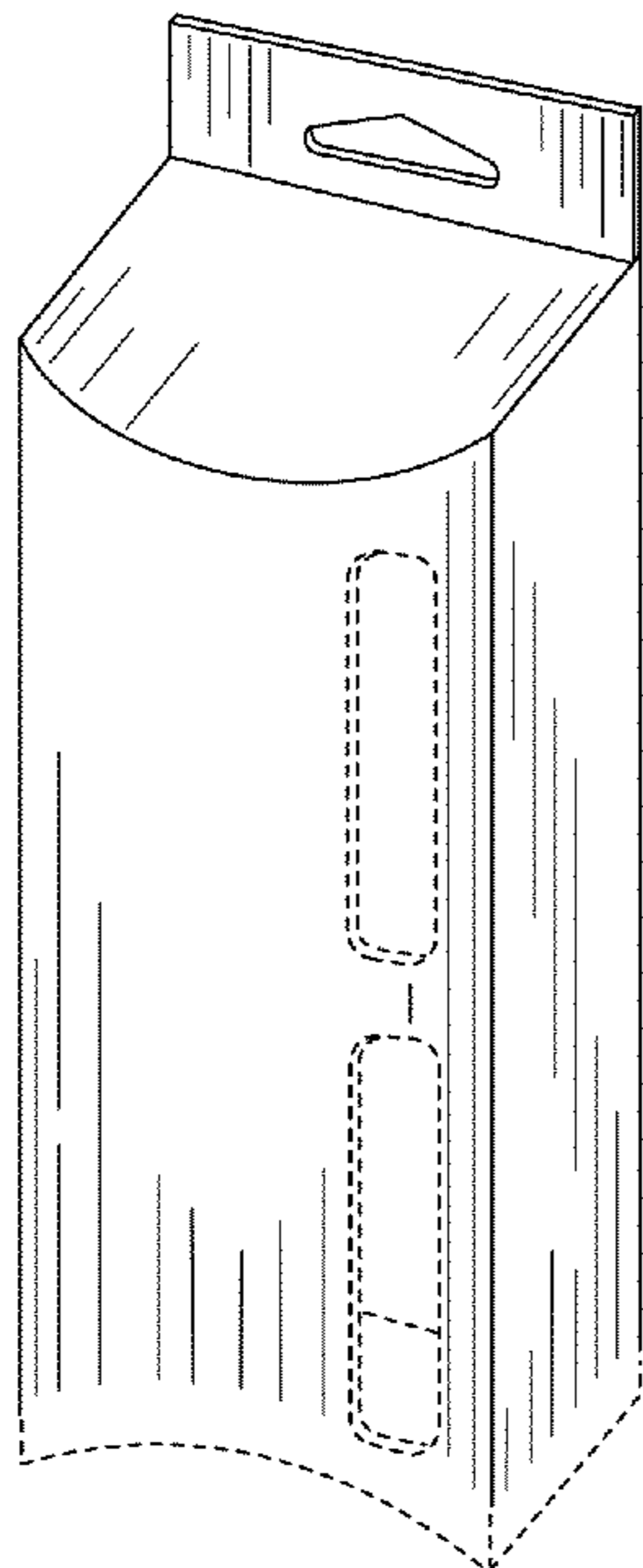
FIG. 12 is a right side view of the embodiment of FIG. 8.

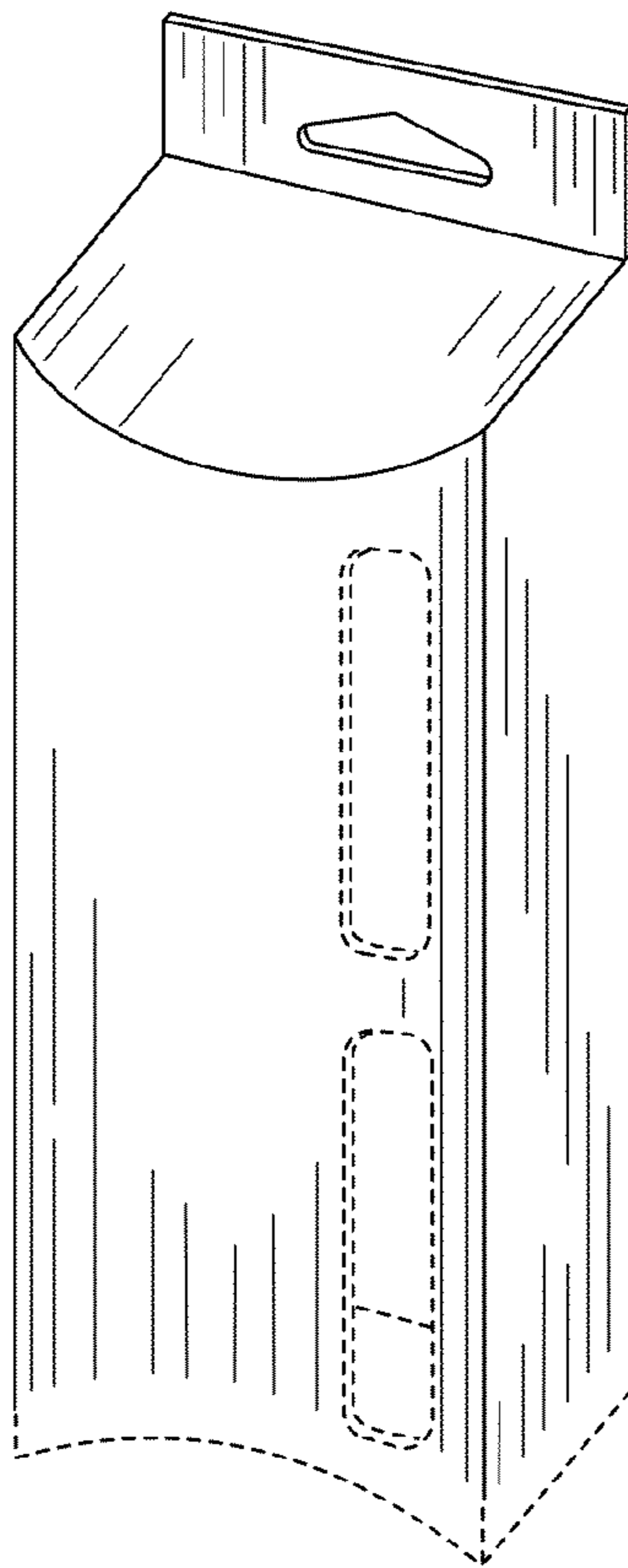

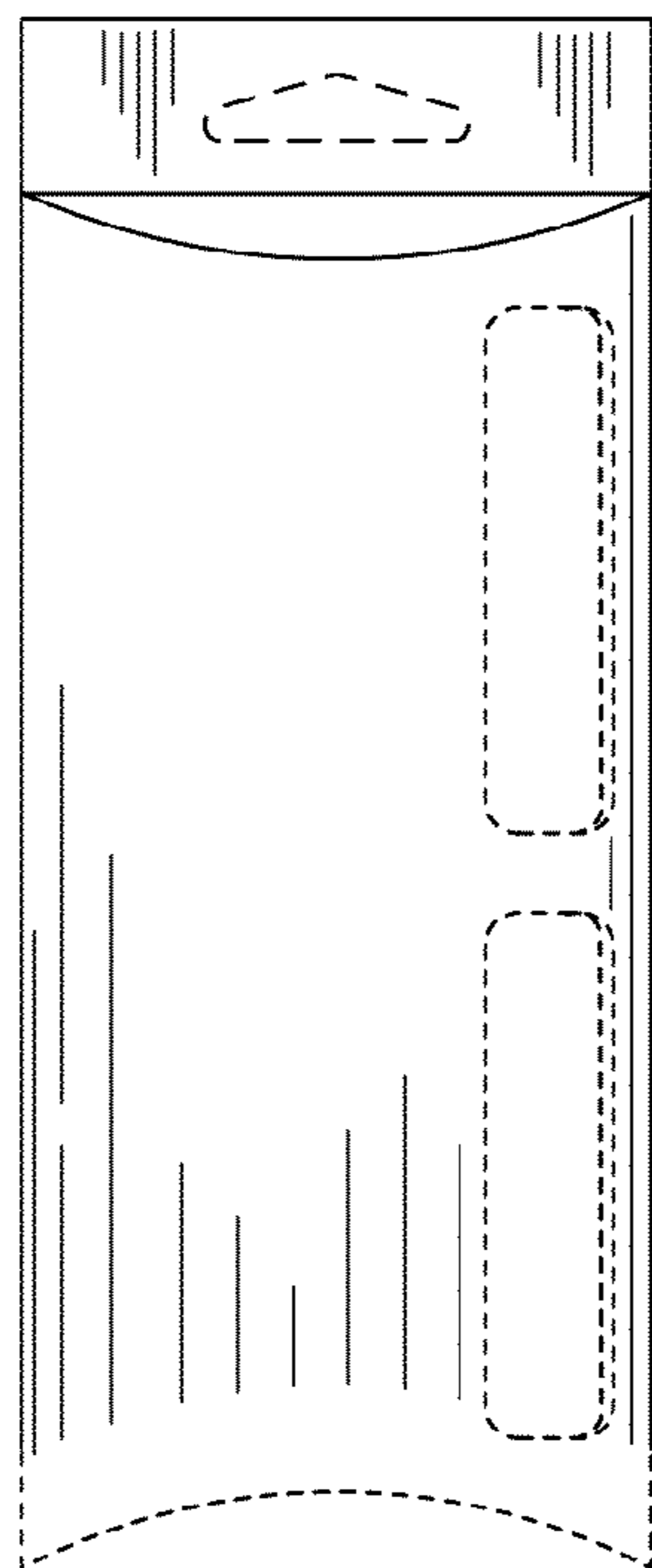

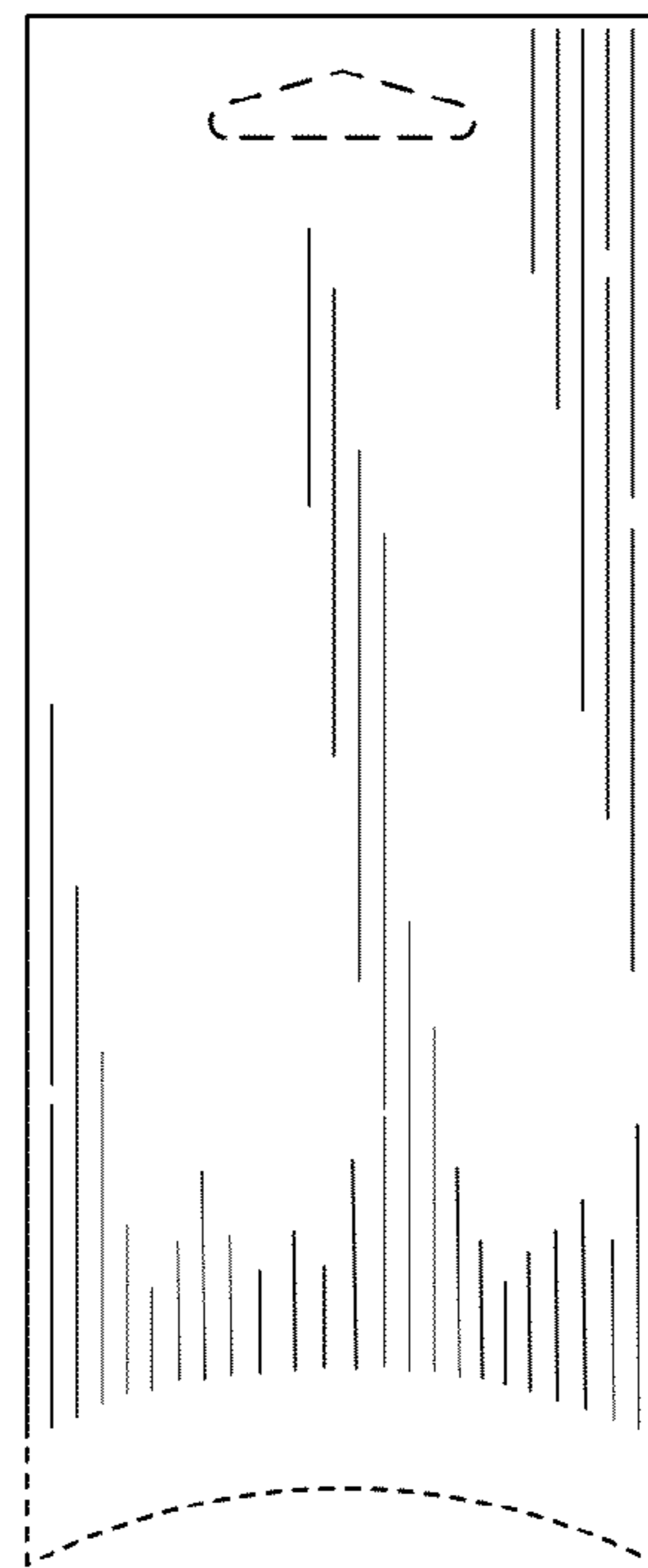

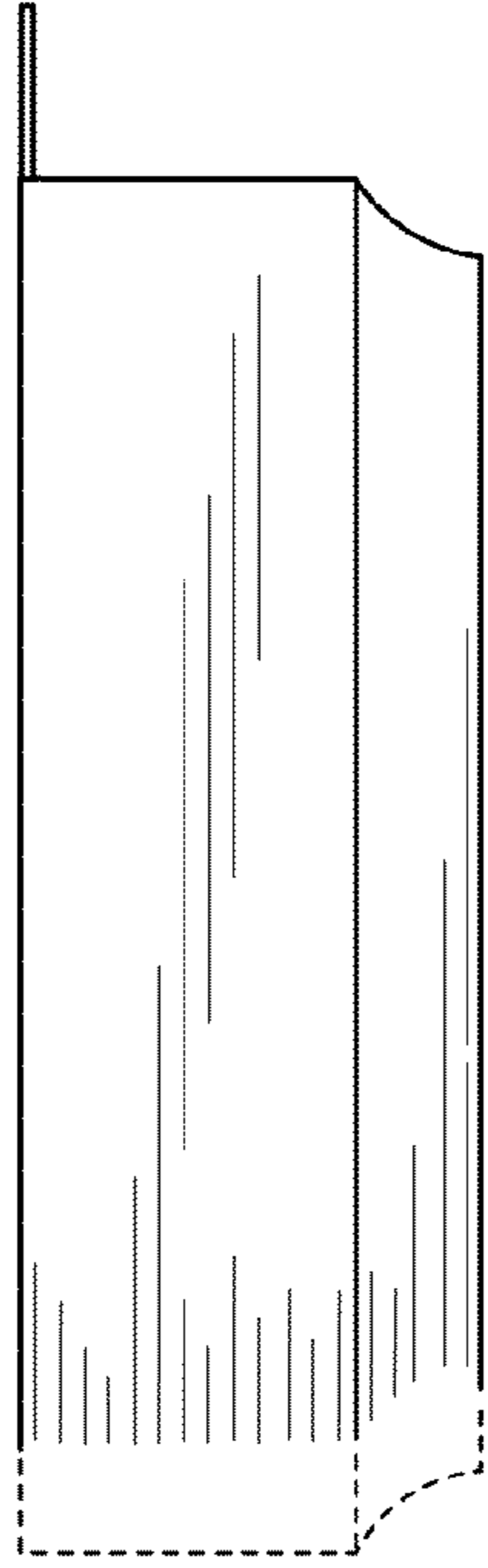

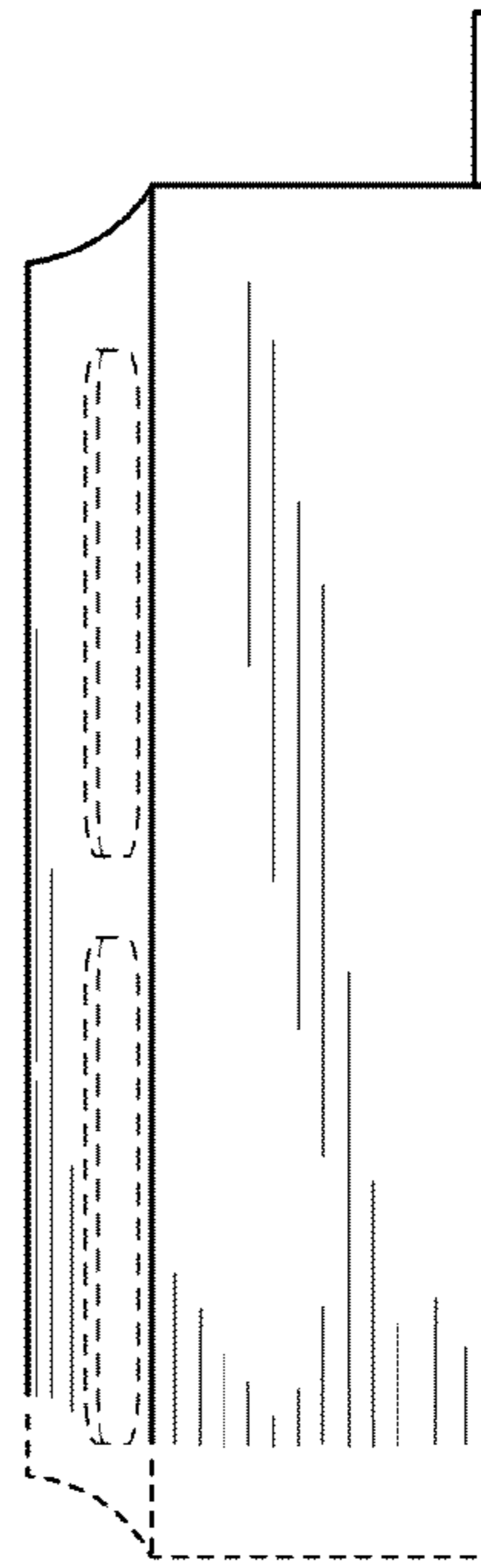

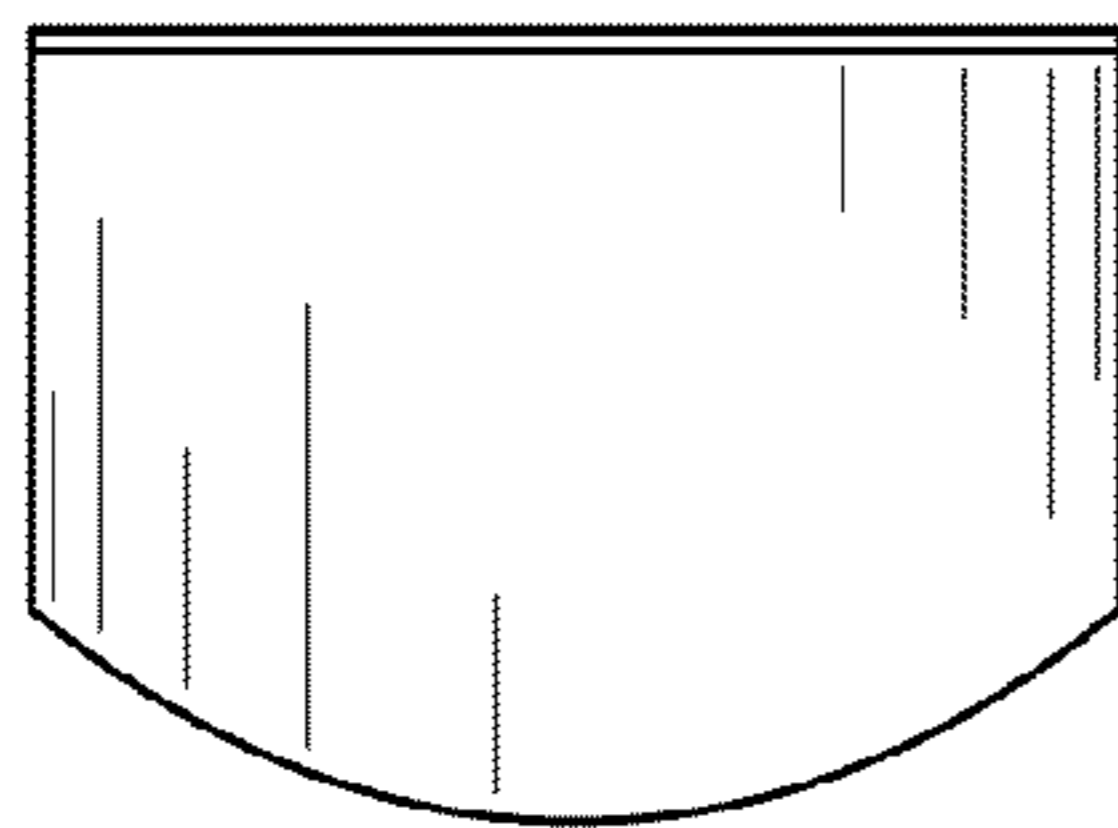

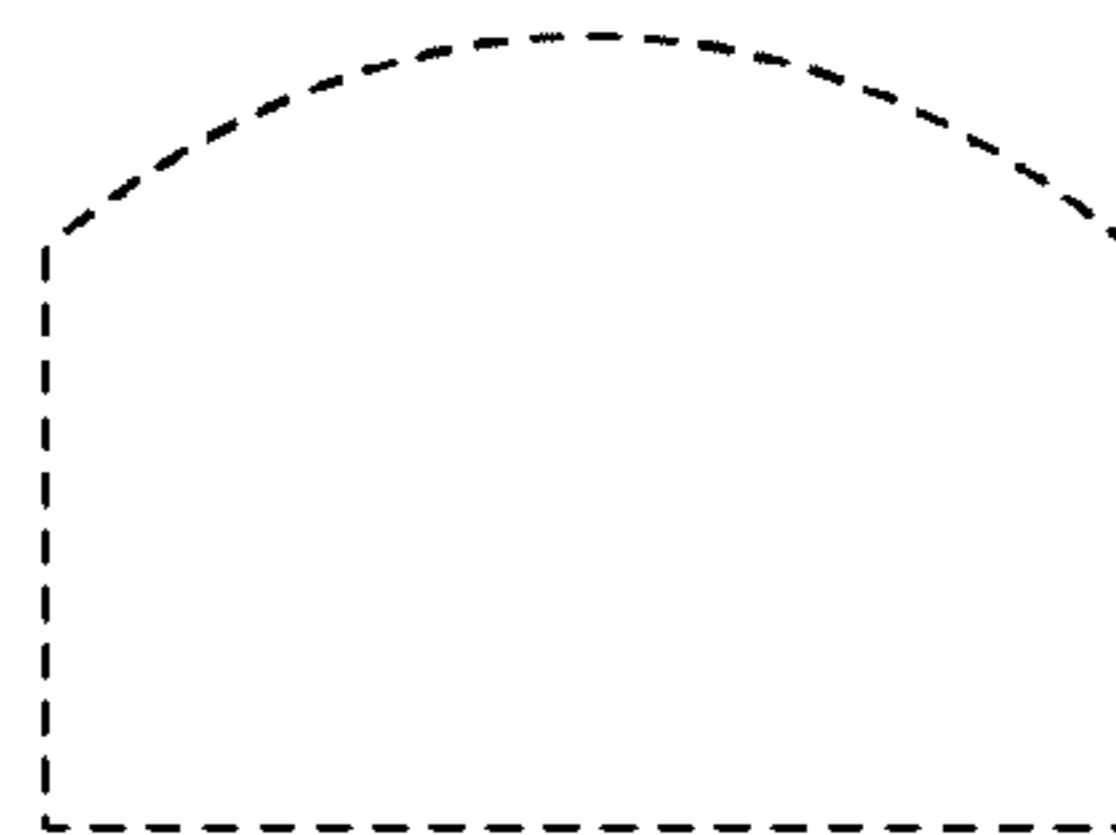

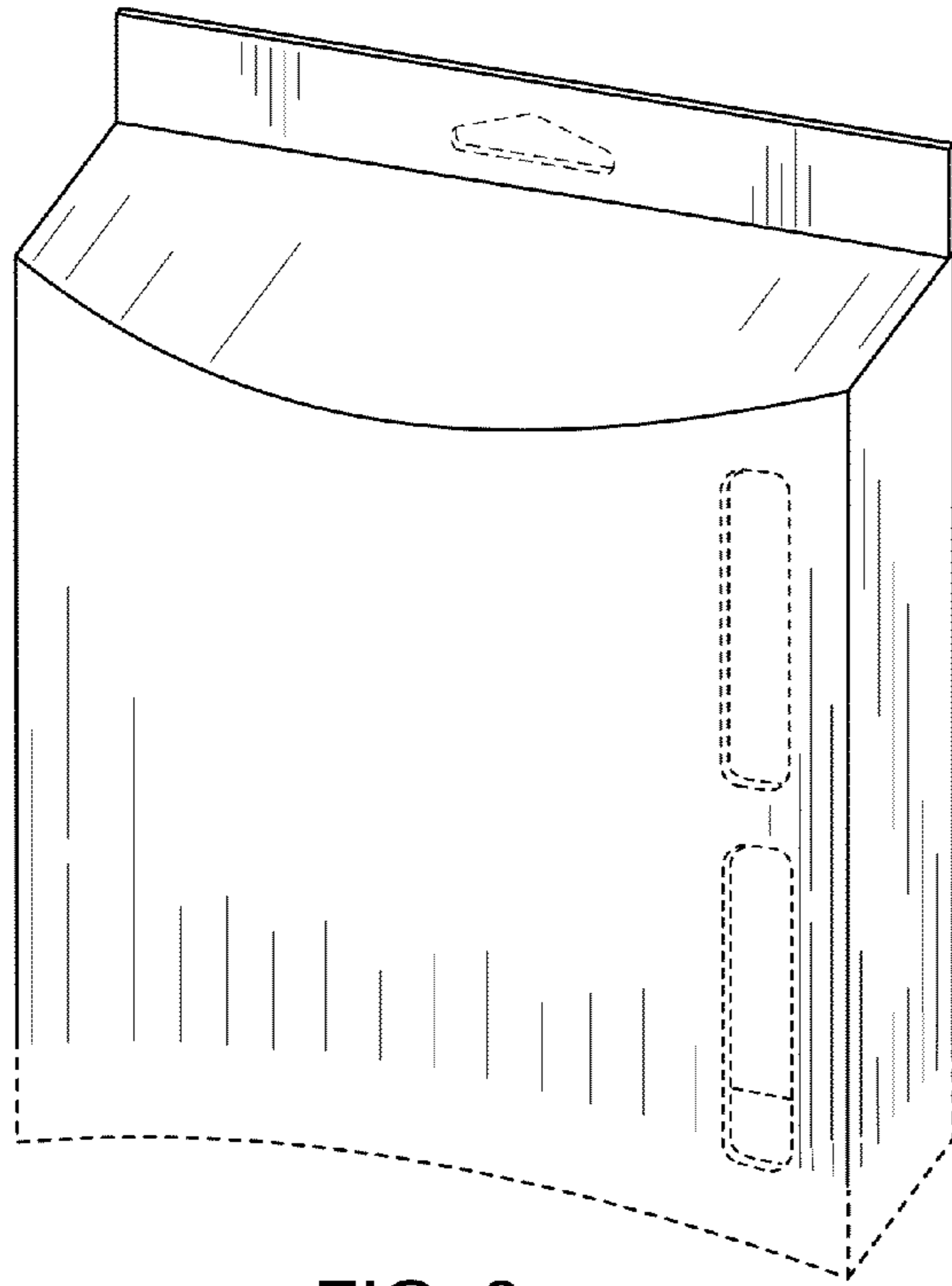

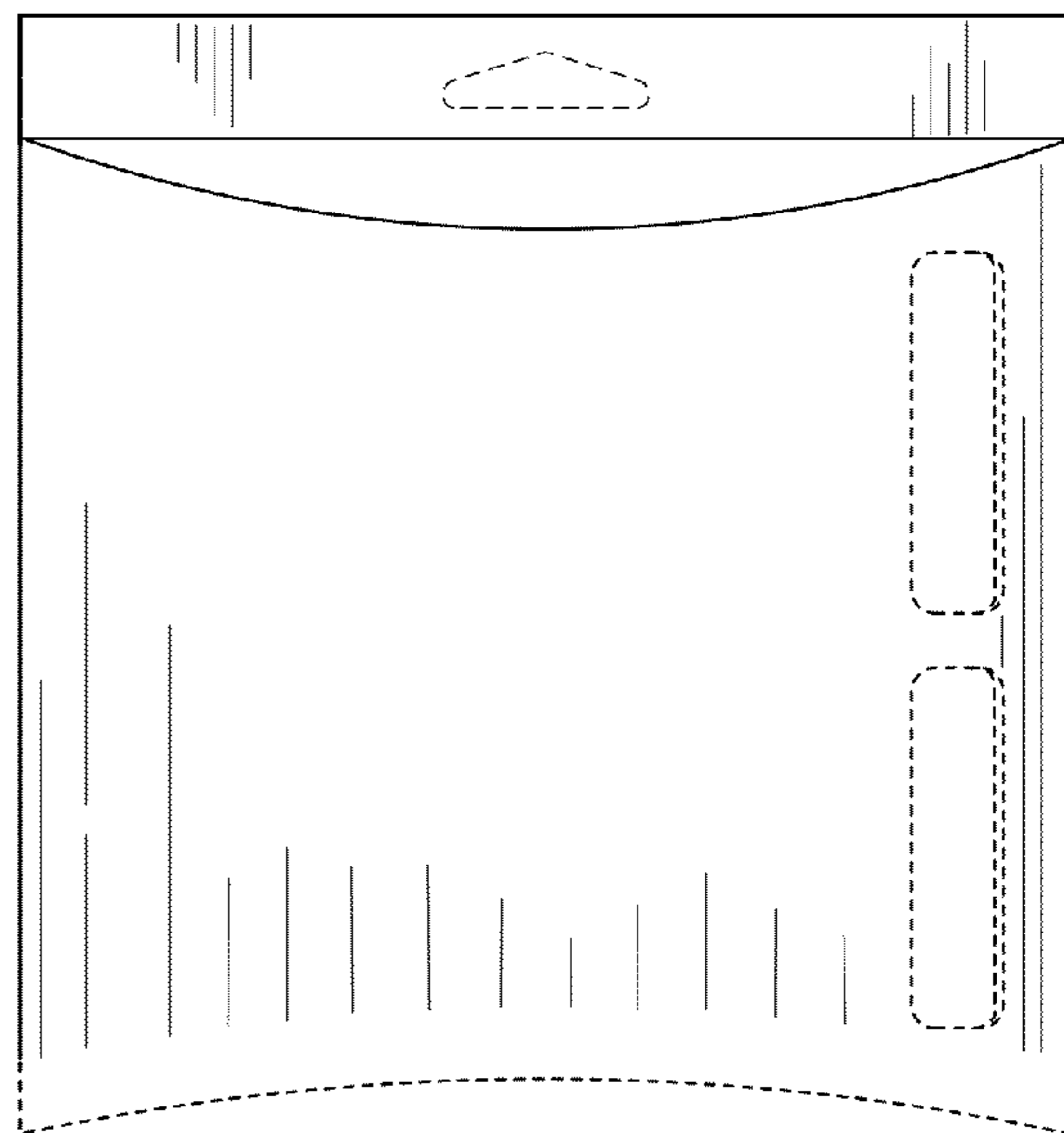

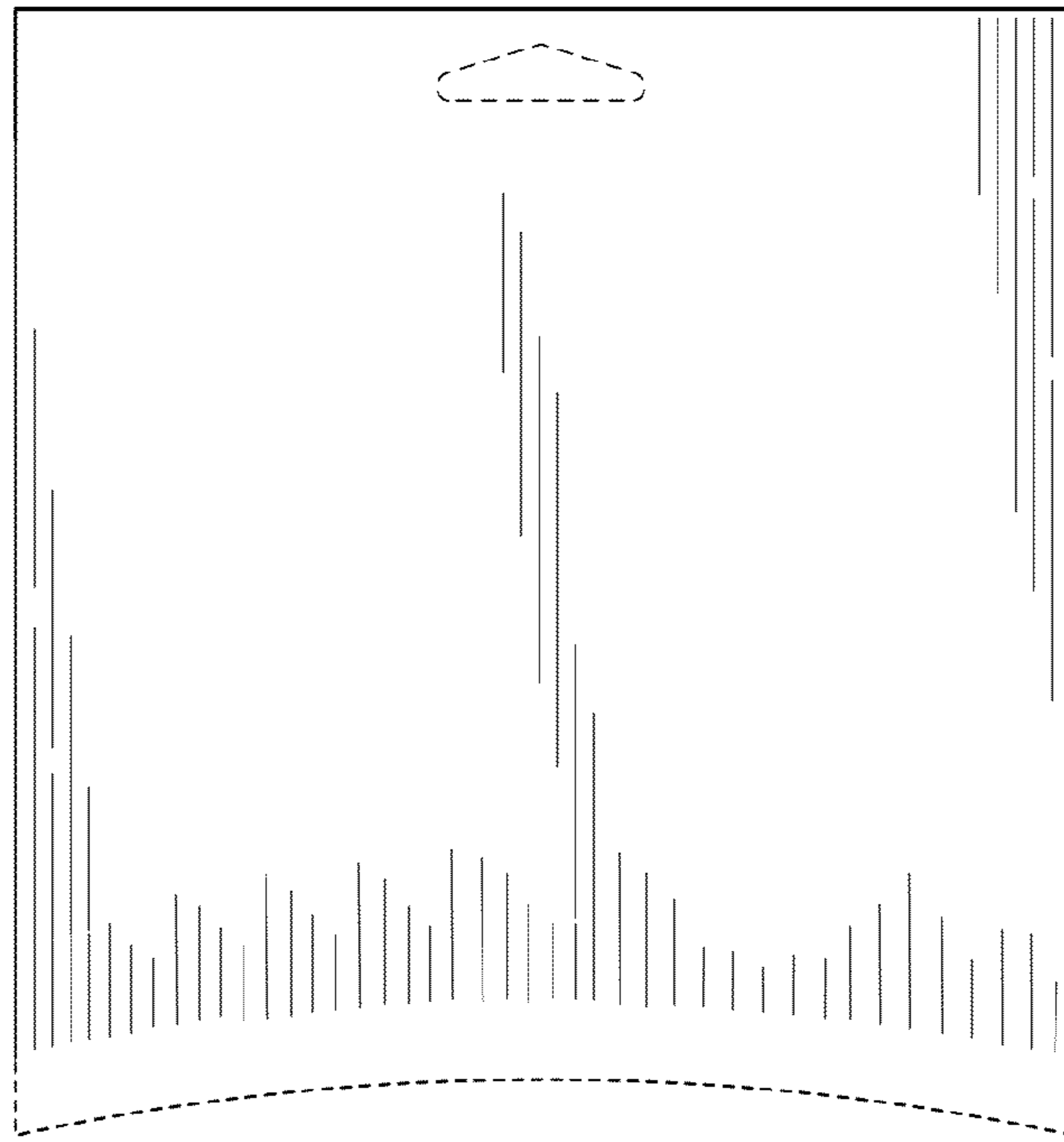

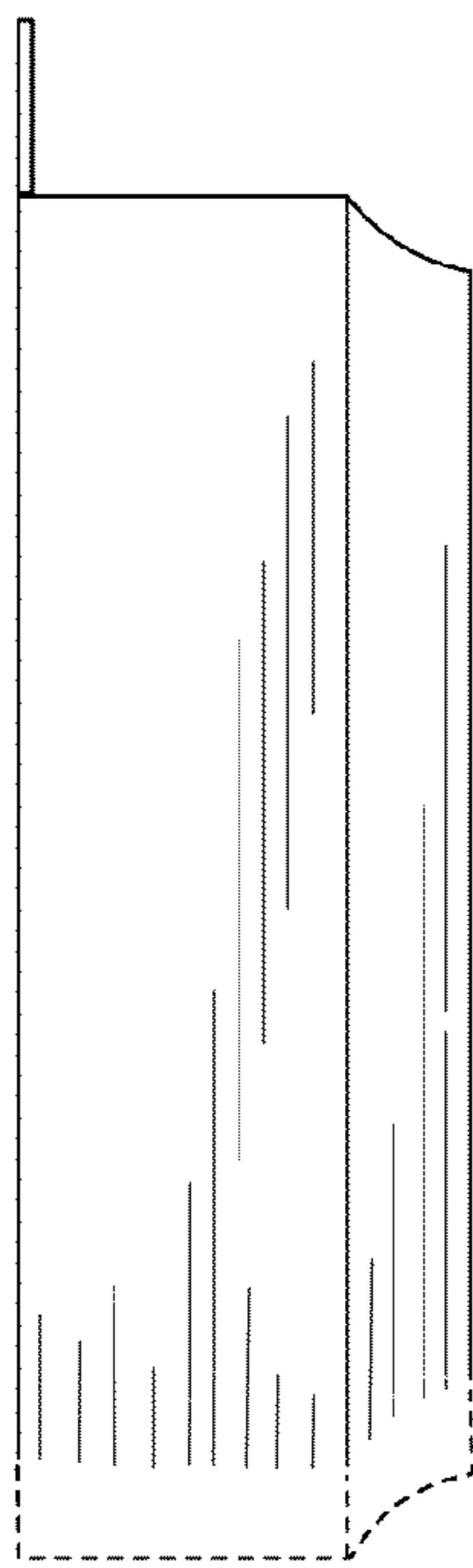

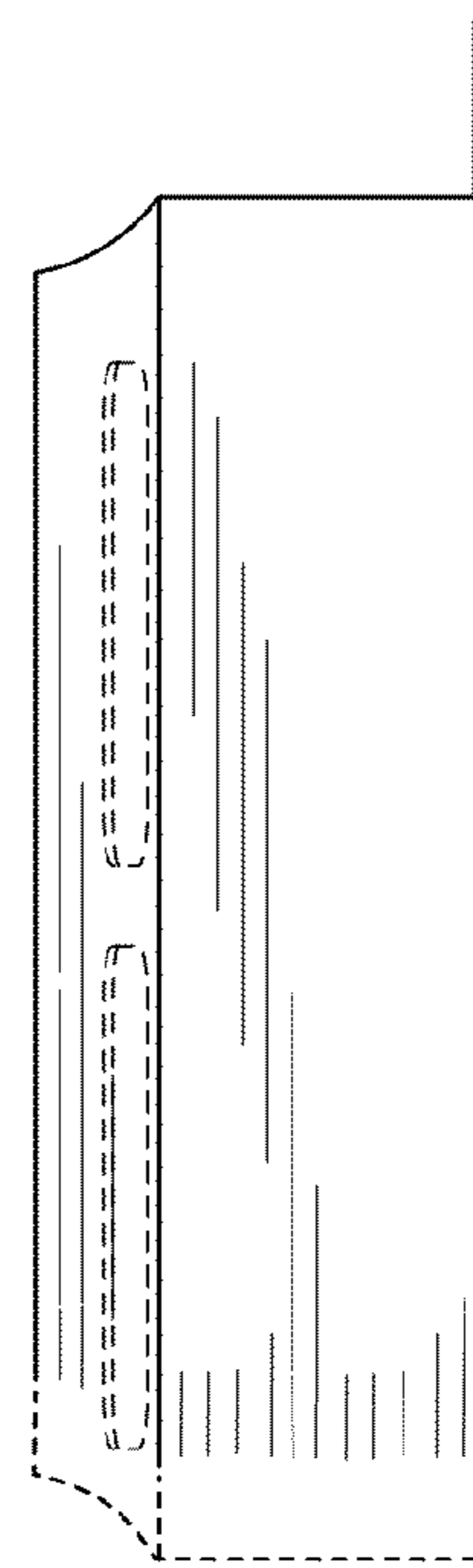

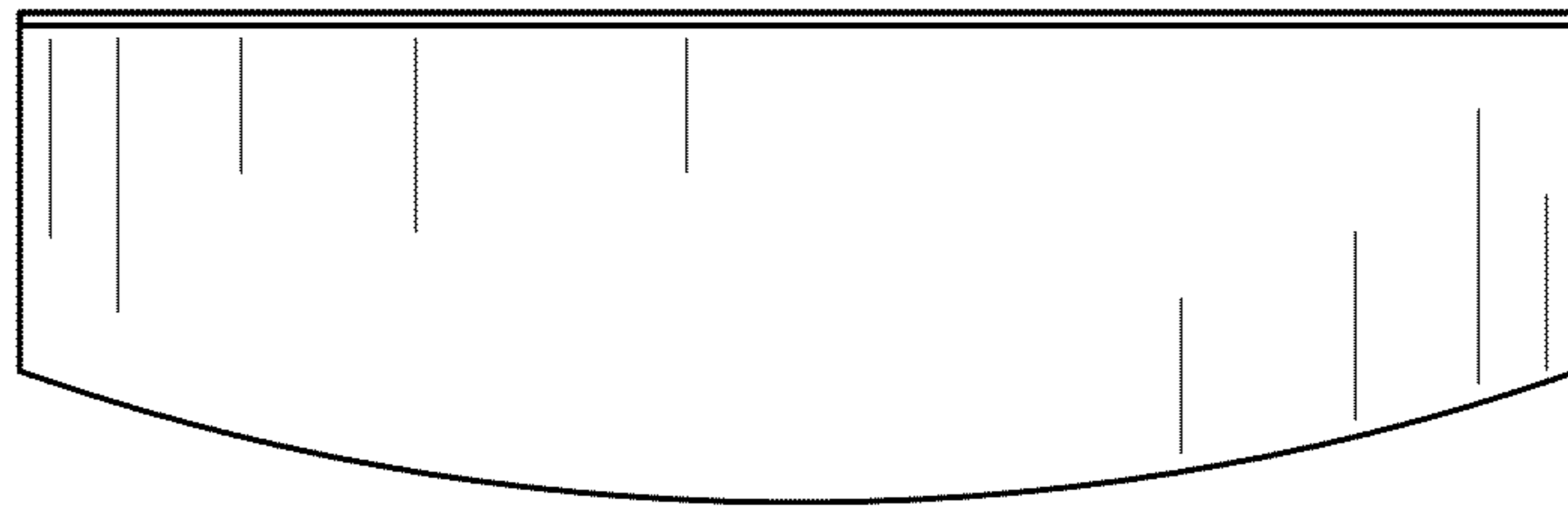
