(57) **CLAIM**

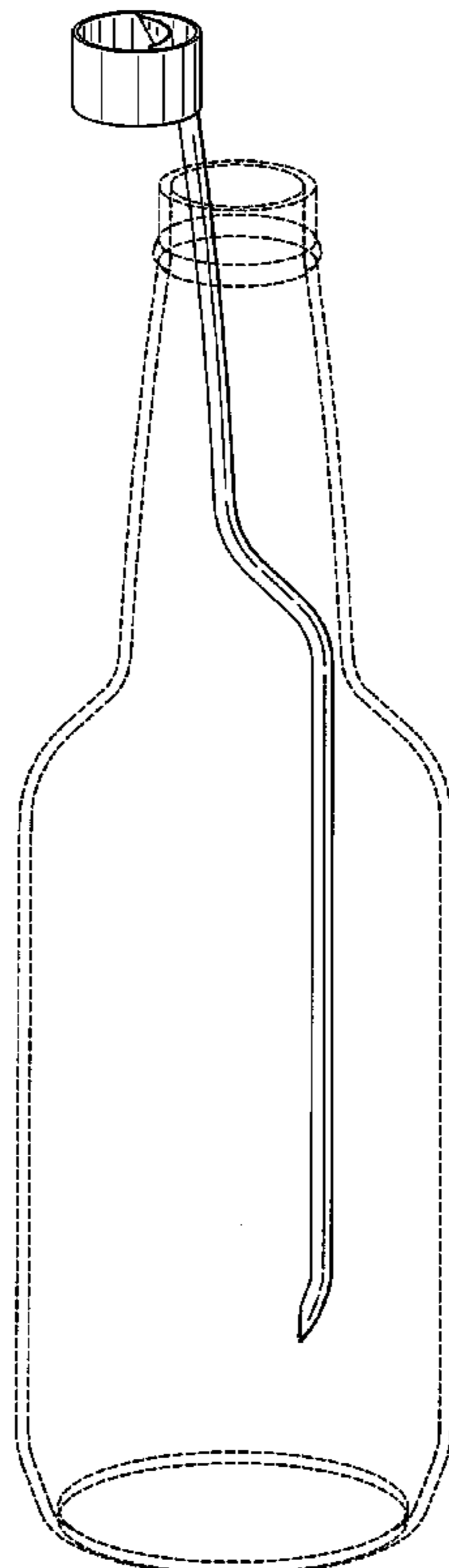
The ornamental design for a flow rate enhancement device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a flow rate enhancement device inserted in a bottle showing my new design;  
 FIG. 2 is another perspective view of a flow rate enhancement device partially removed from a bottle thereof;  
 FIG. 3 is a front view, with the back view being a mirror image thereof;  
 FIG. 4 is a back view thereof;  
 FIG. 5 is a top view thereof;  
 FIG. 6 is a bottom view thereof;  
 FIG. 7 is a left side view thereof; and,  
 FIG. 8 is a right side view thereof.

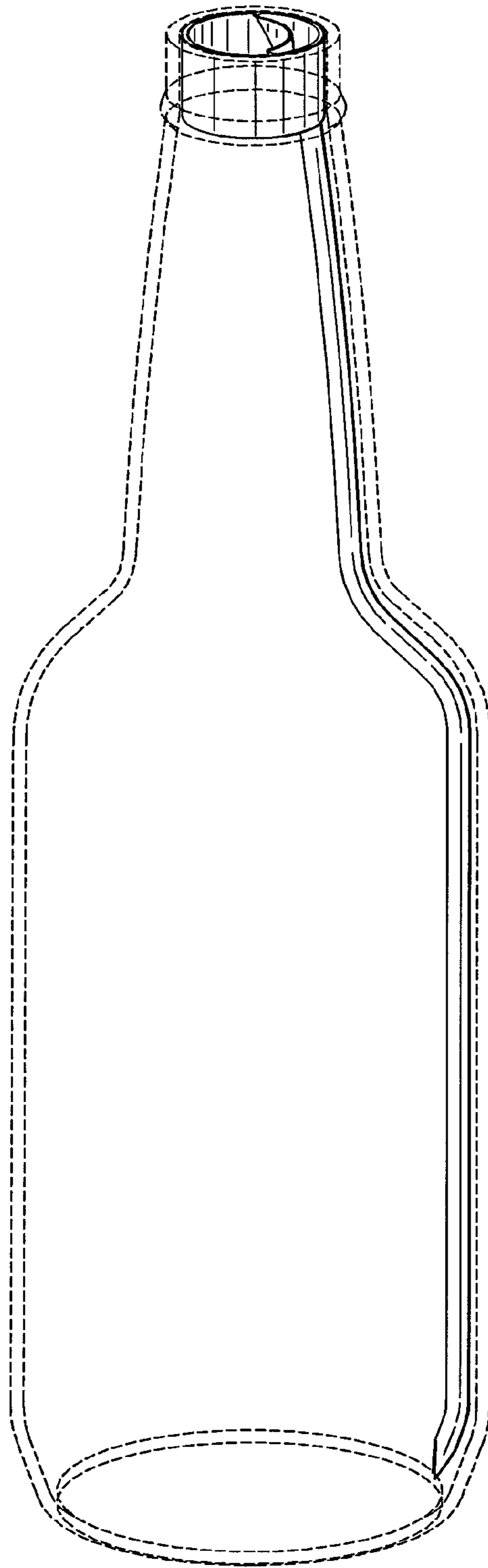
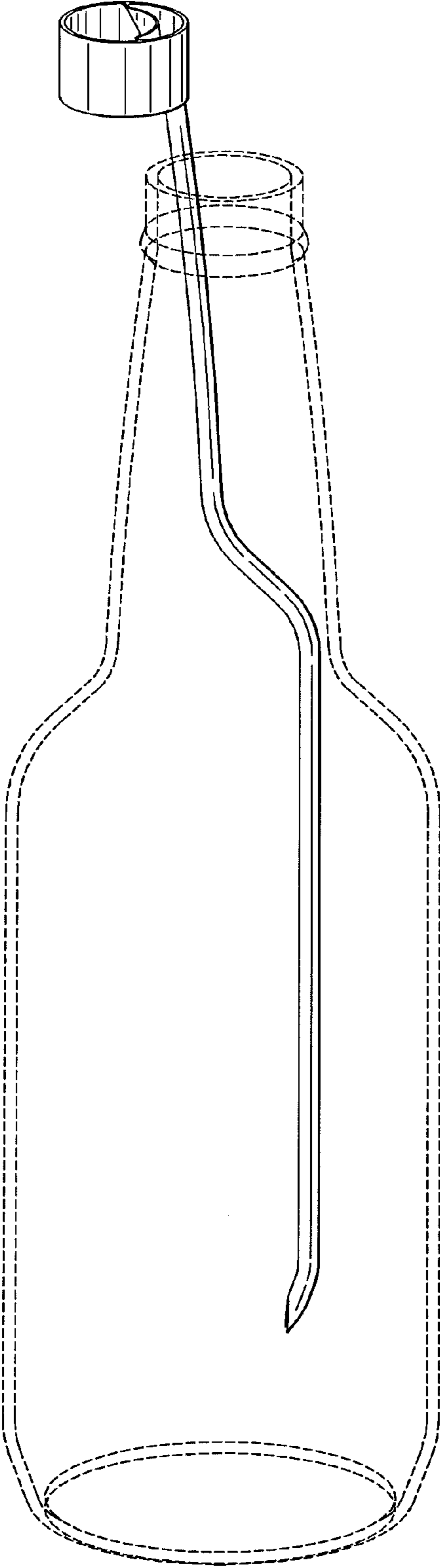

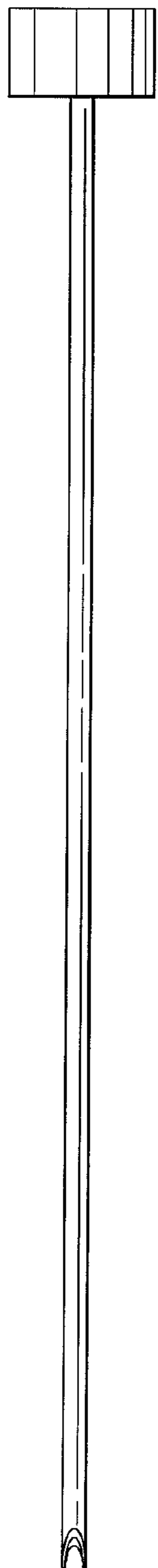

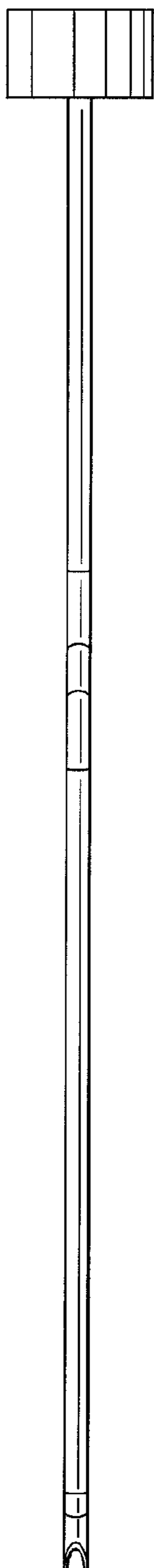

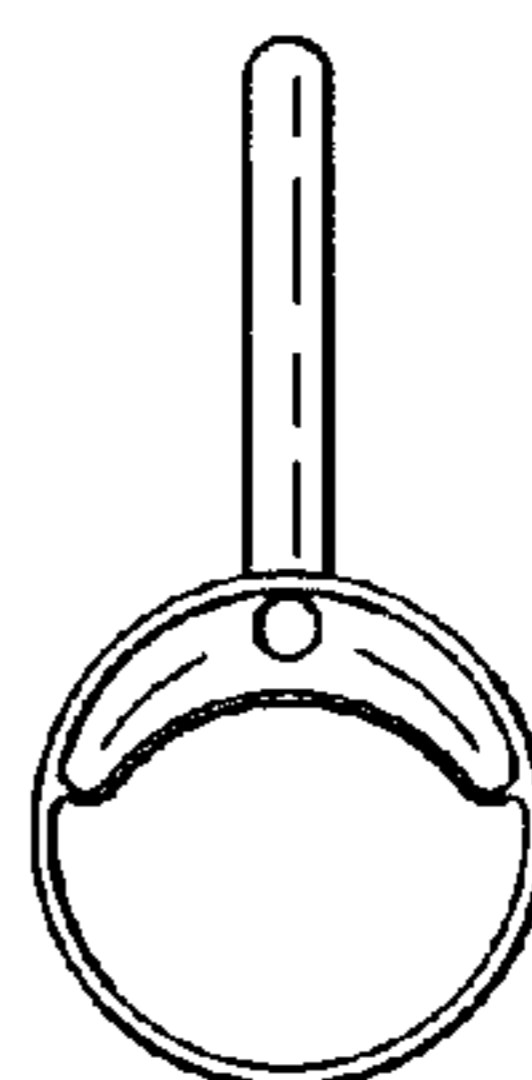

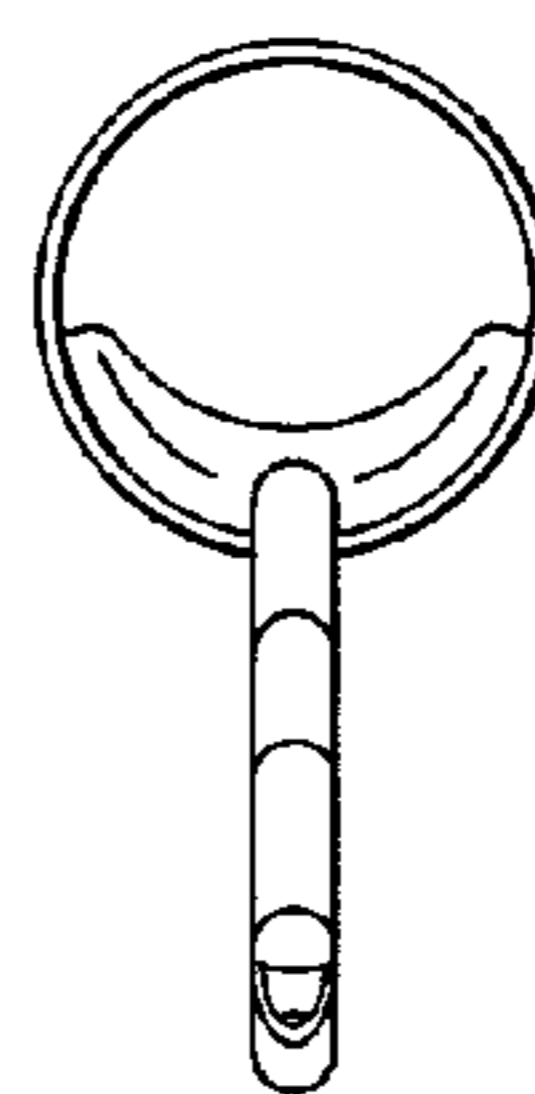

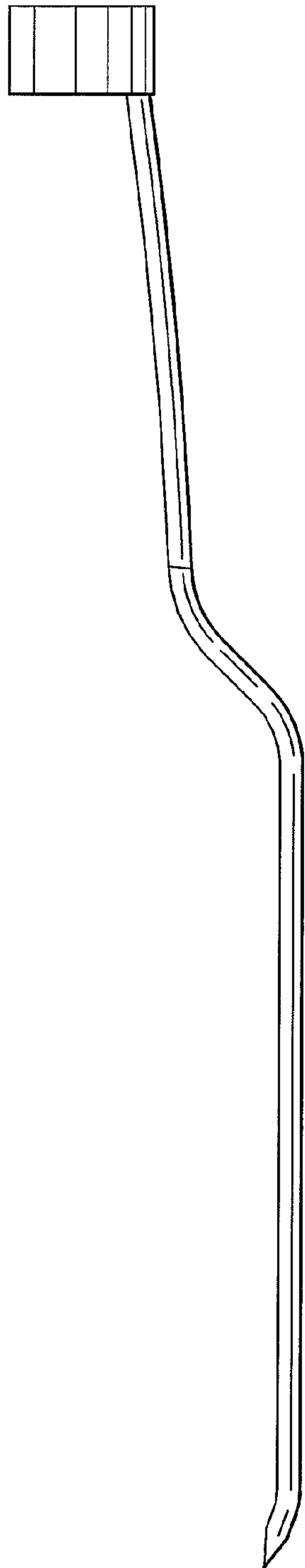

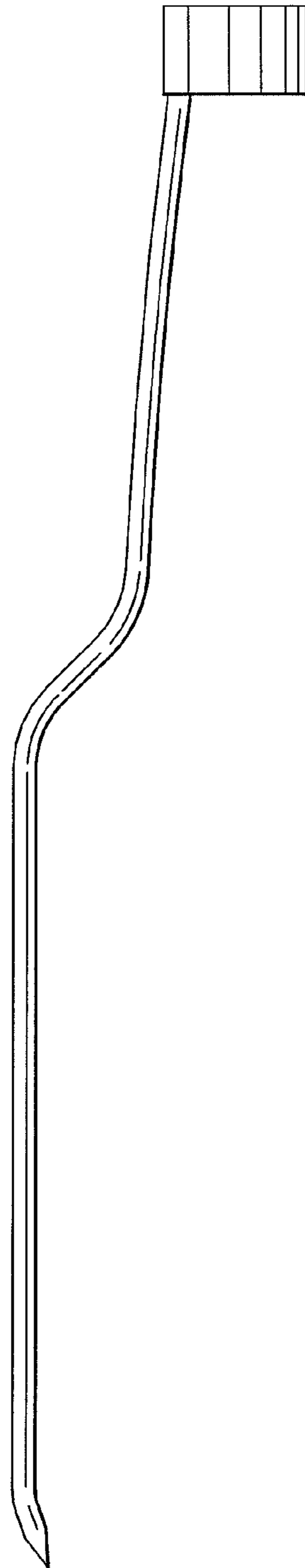
