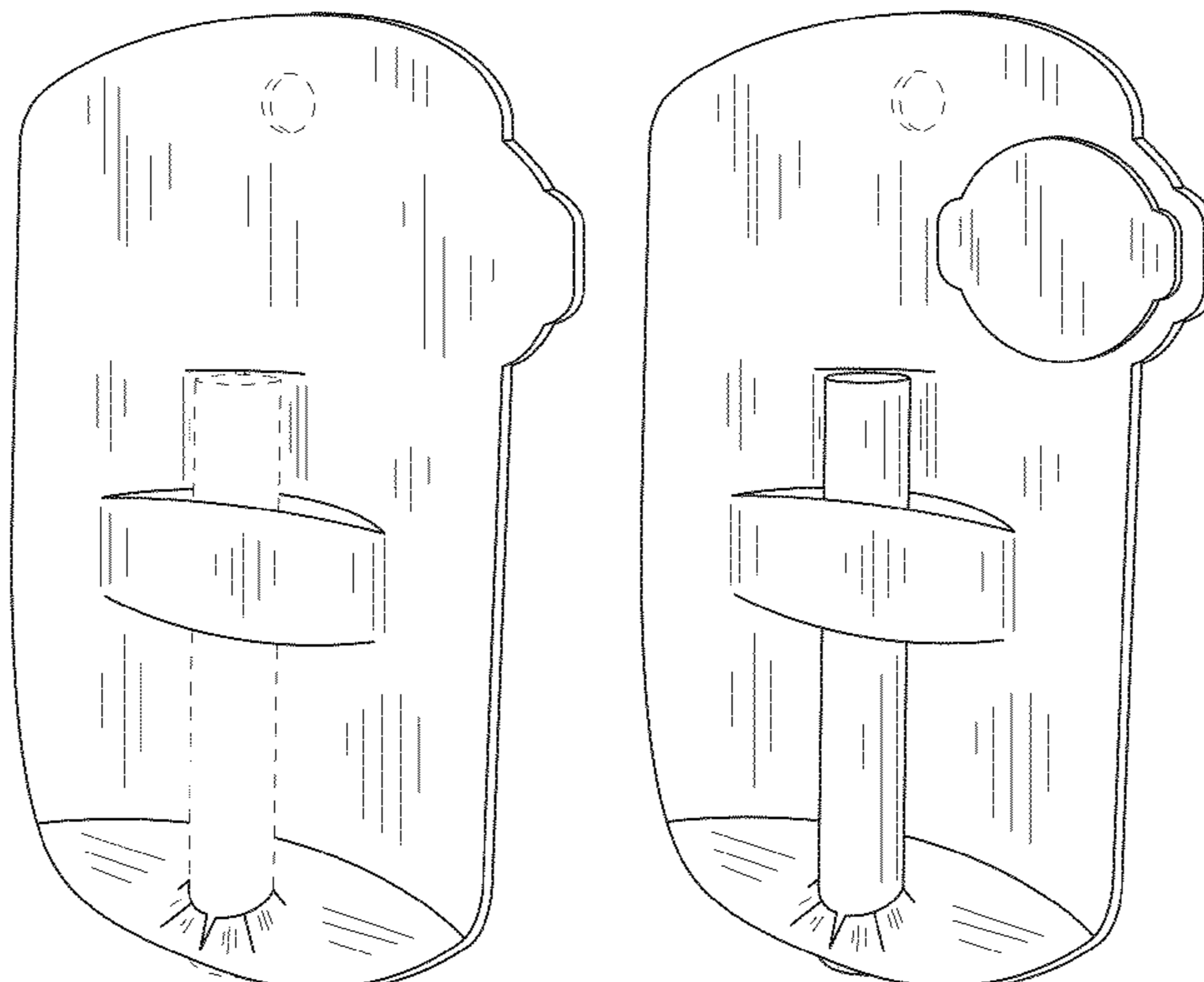
The ornamental design for product packaging, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the product packaging; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a right elevation view thereof; FIG. 5 is a left elevation view thereof; FIG. 6 is a rear elevation view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a front perspective view of the product packaging according to an alternative embodiment; FIG. 9 is a top plan view of the product packaging of FIG. 8; FIG. 10 is a front elevation view of the product packaging of FIG. 8; FIG. 11 is a right elevation view of the product packaging of FIG. 8; FIG. 12 is a left elevation view of the product packaging of FIG. 8; FIG. 13 is a rear elevation view of the product packaging of FIG. 8; FIG. 14 is a bottom plan view of the product packaging of FIG. 8; FIG. 15 is a front perspective view of the product packaging according to a second alternative embodiment; FIG. 16 is a top plan view of the product packaging of FIG. 15; FIG. 17 is a front elevation view of the product packaging of FIG. 15; FIG. 18 is a right elevation view of the product packaging of FIG. 15; FIG. 19 is a left elevation view of the product packaging of FIG. 15; FIG. 20 is a rear elevation view of the product packaging of FIG. 15; and, FIG. 21 is a bottom plan view of the product packaging of FIG. 15.

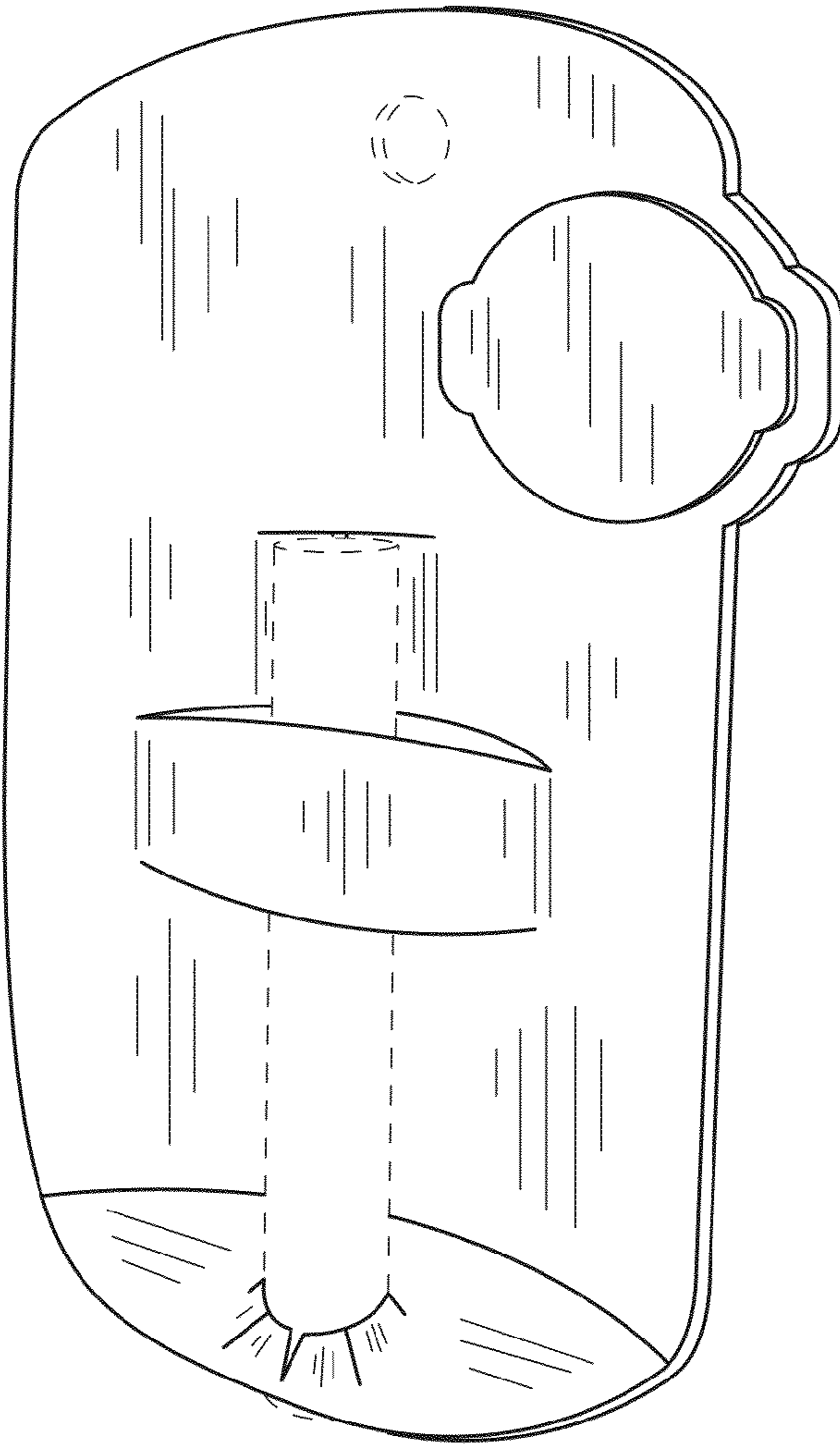

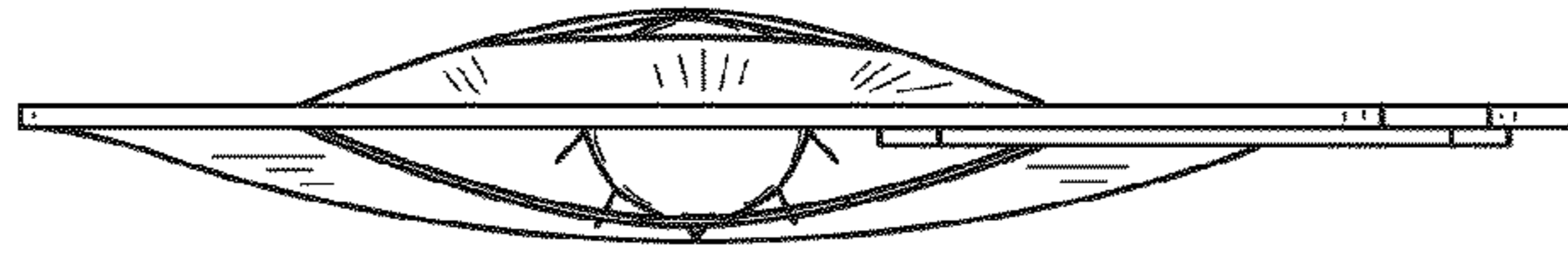

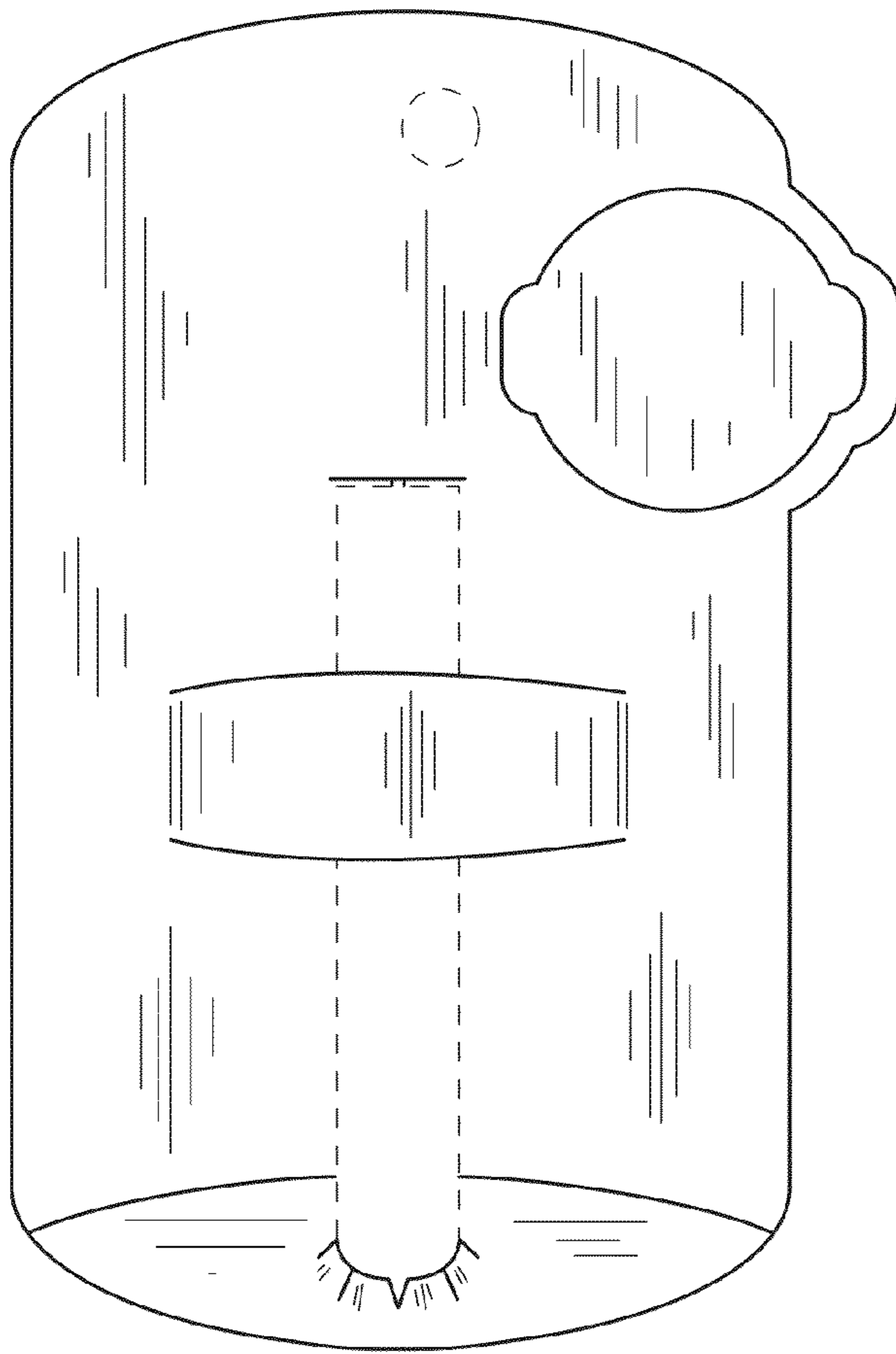

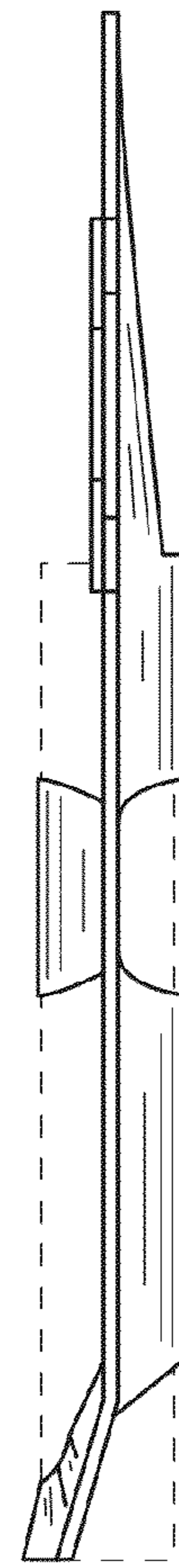

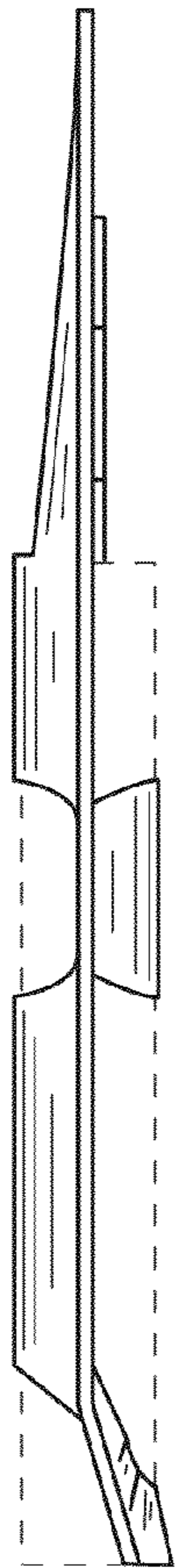

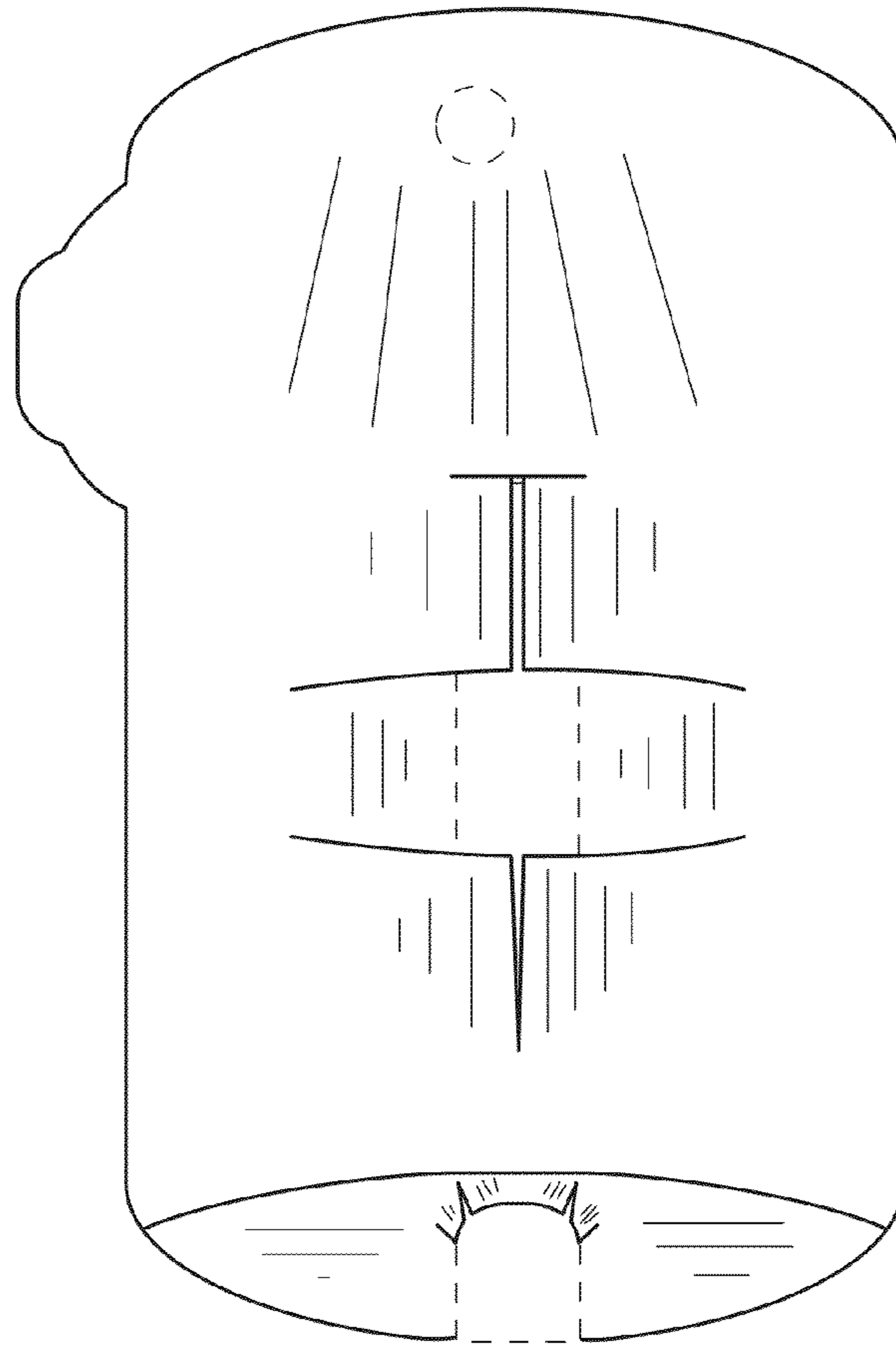

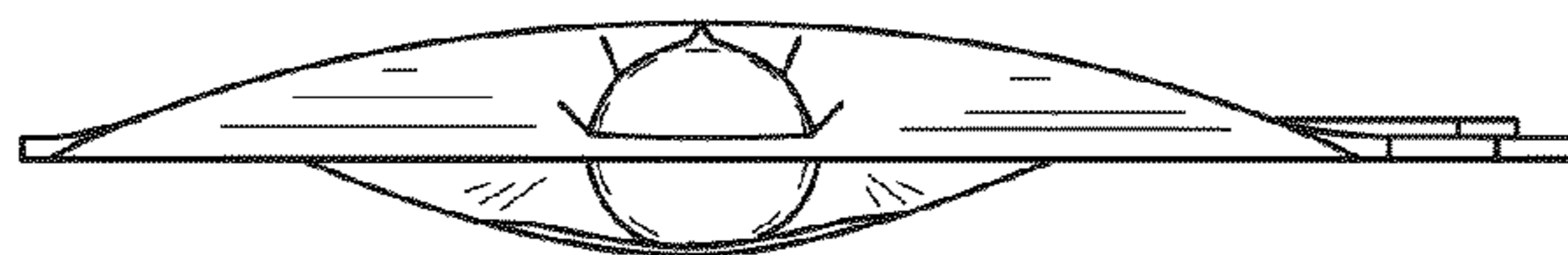

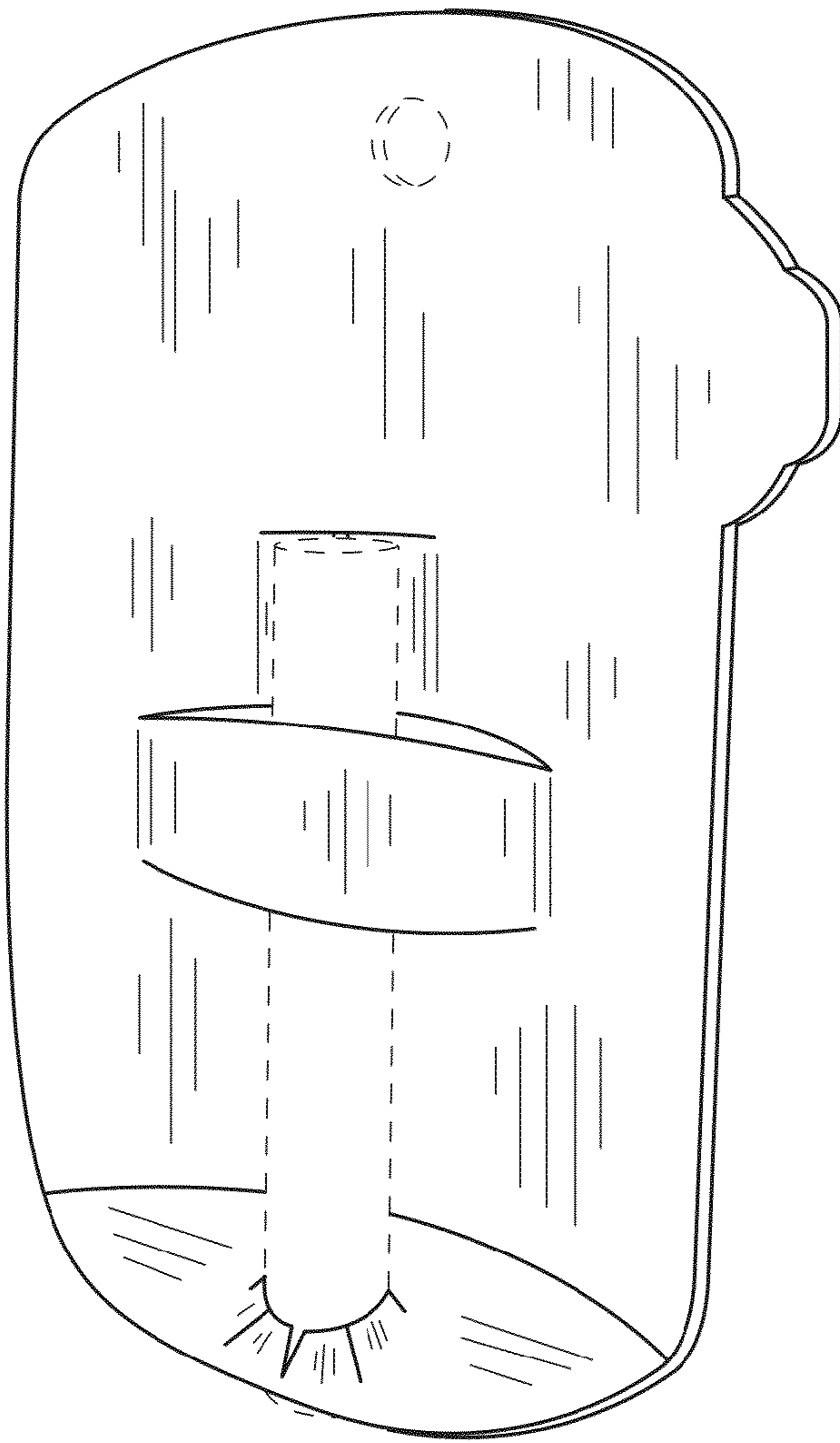

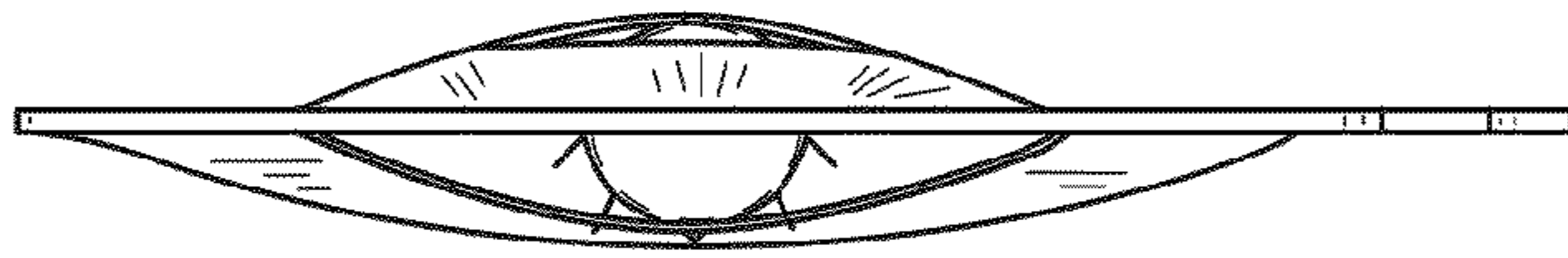

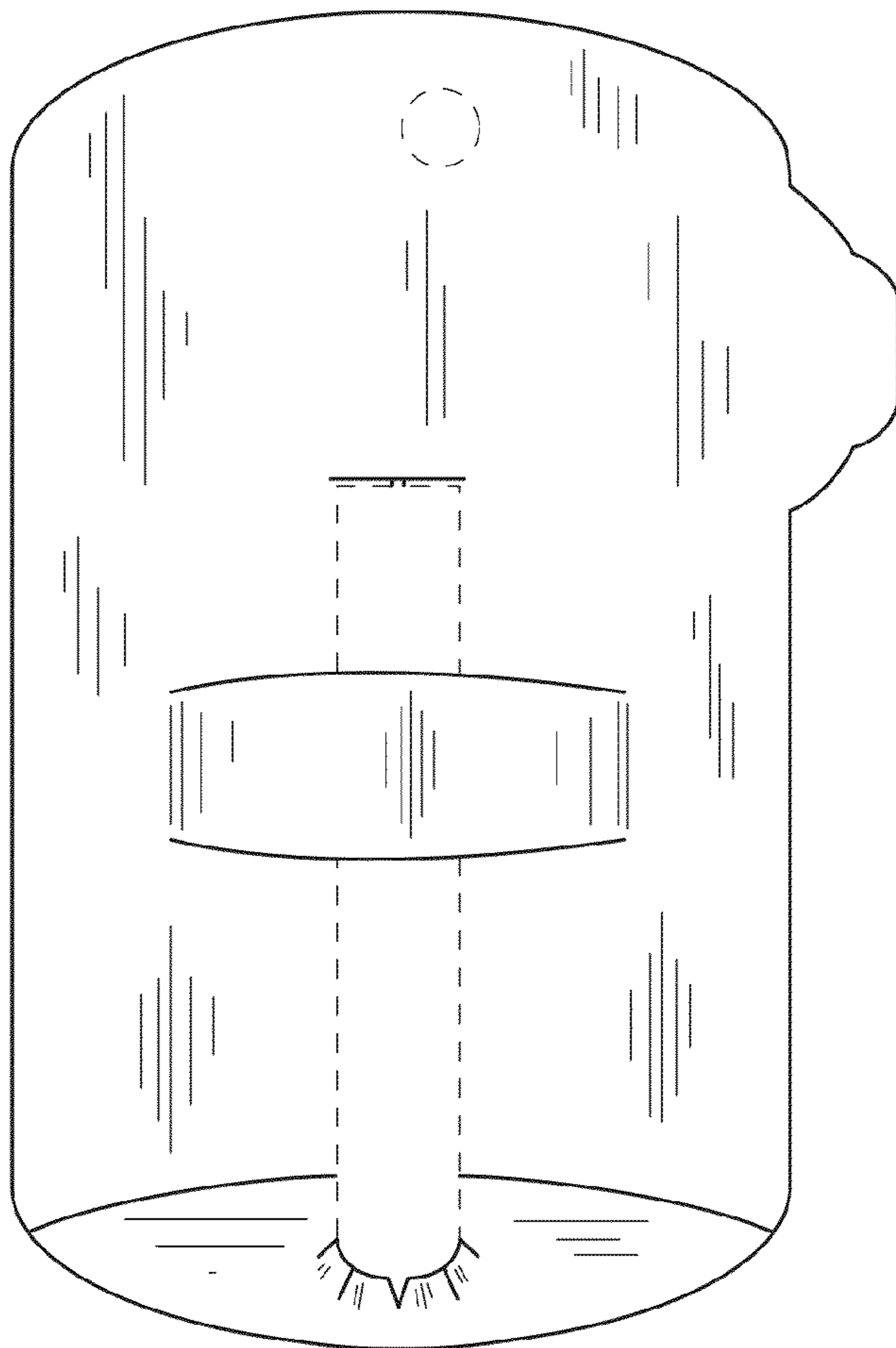

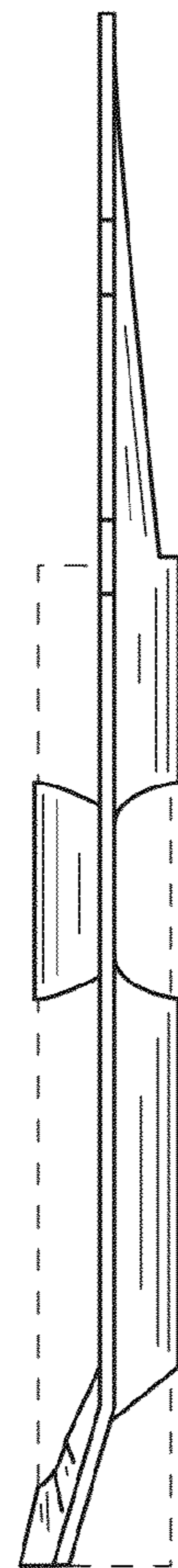

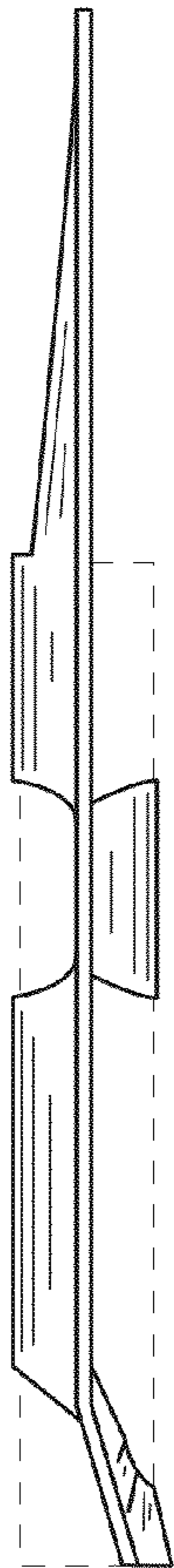

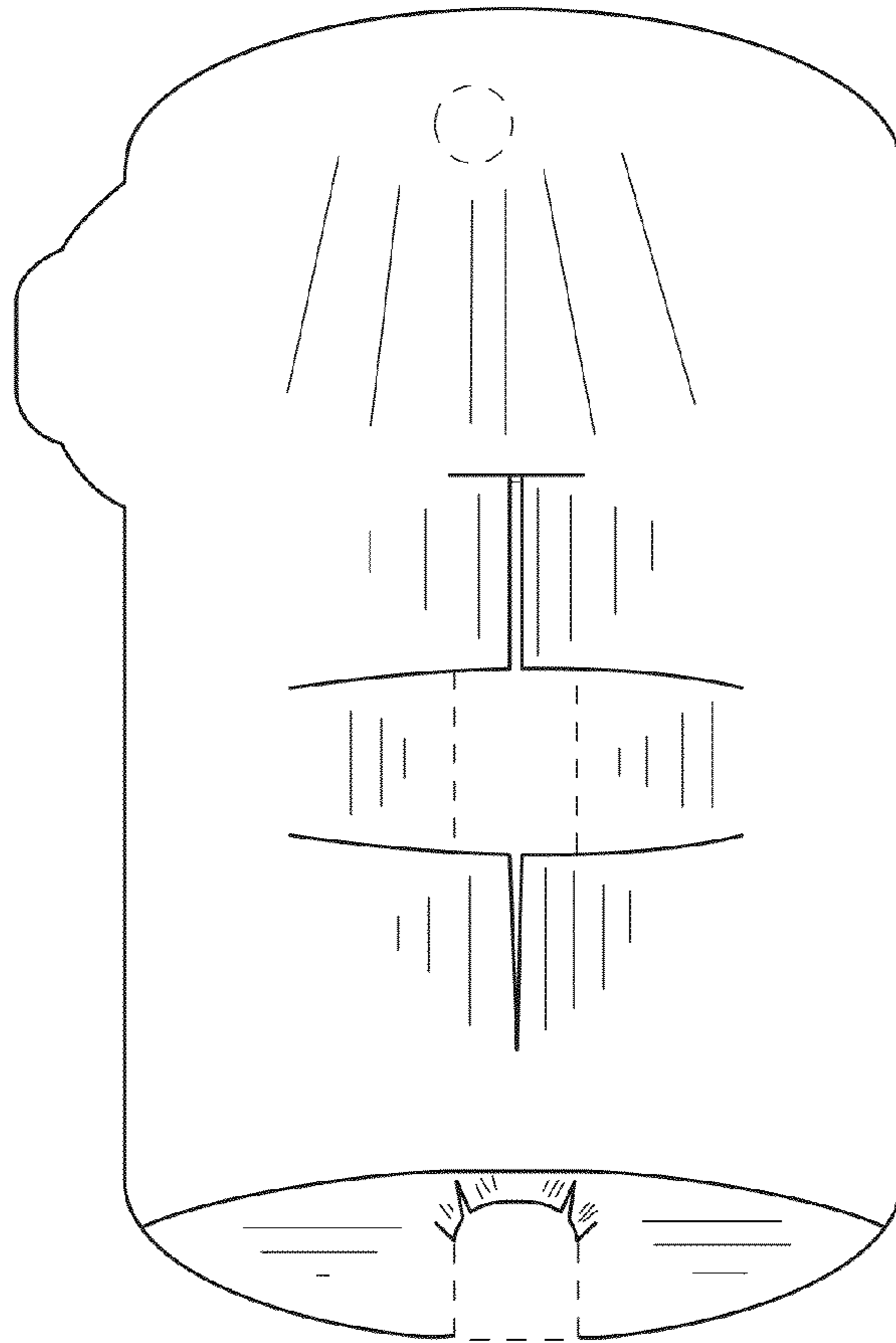

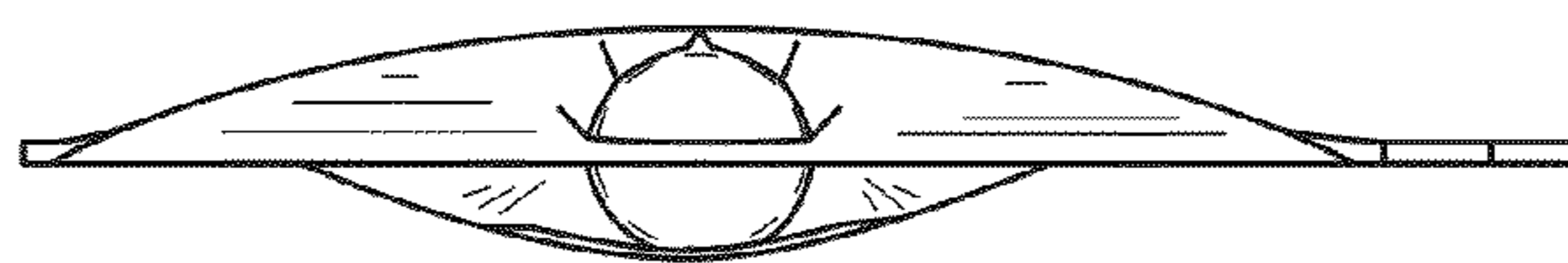

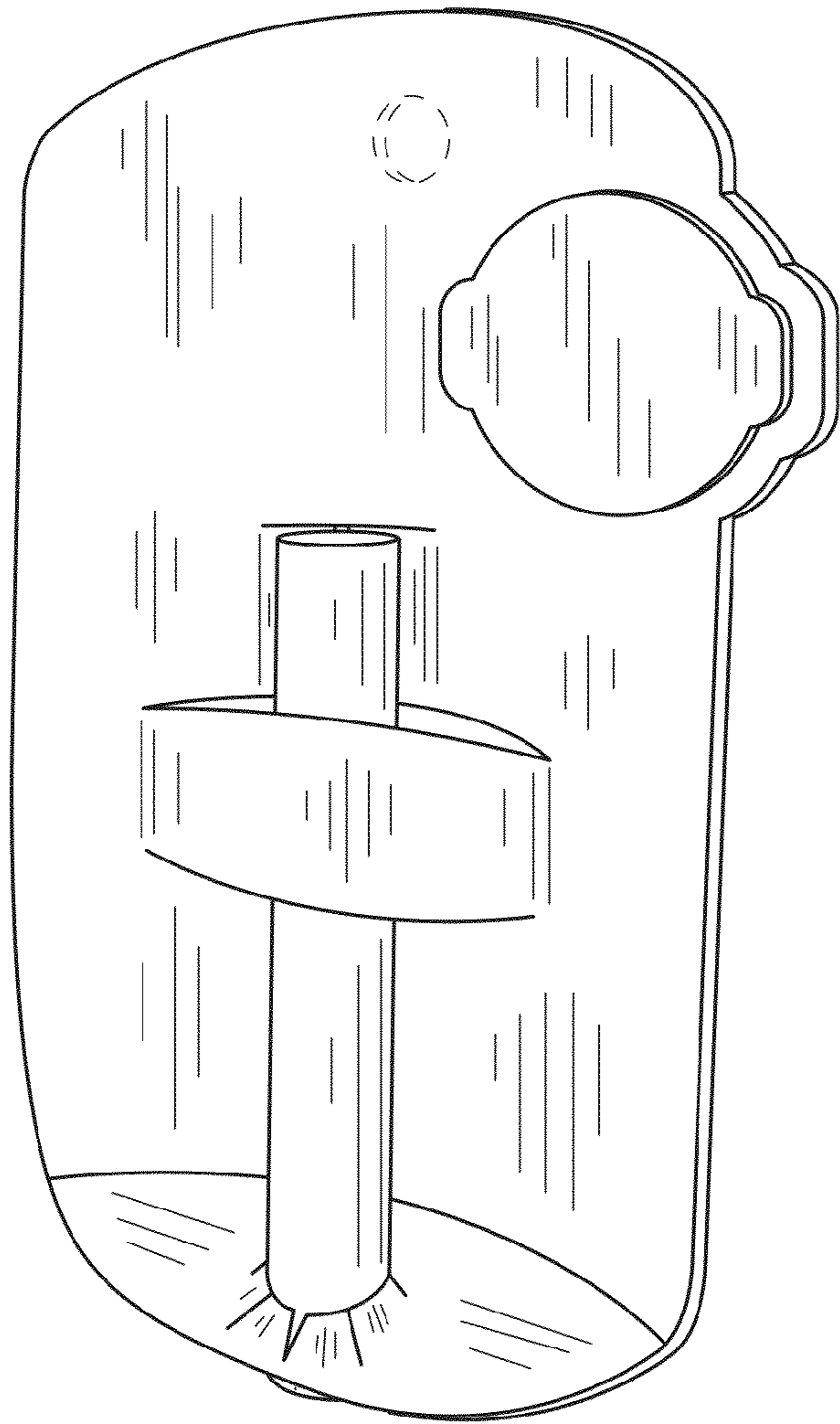

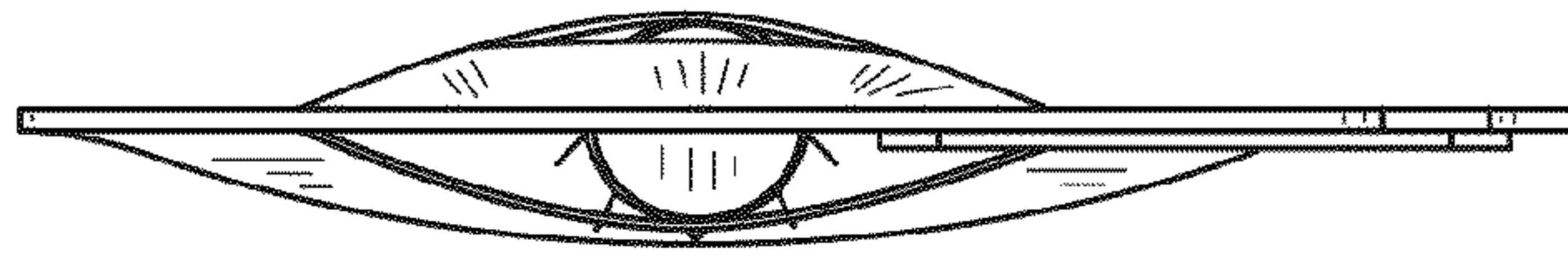

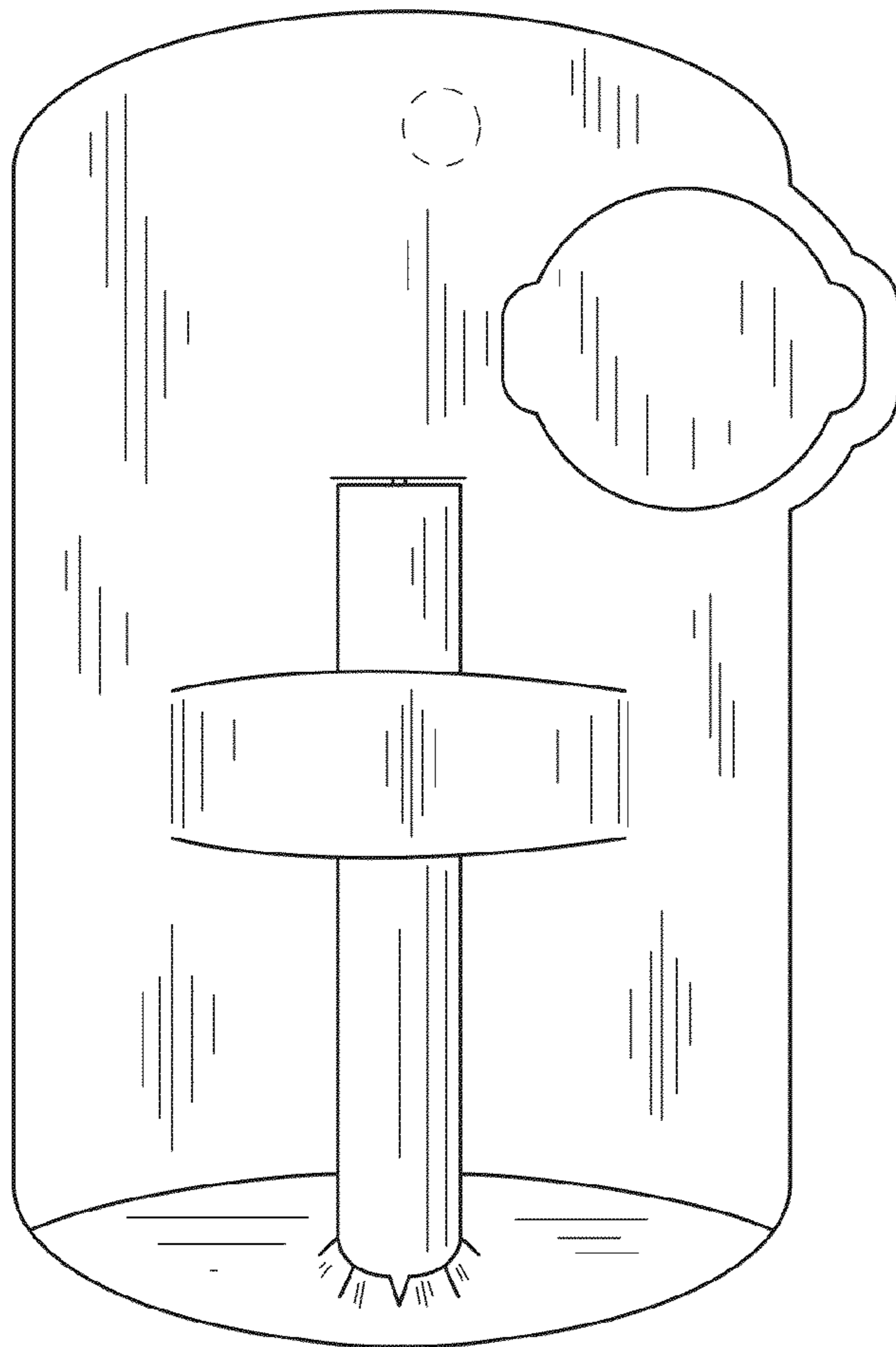

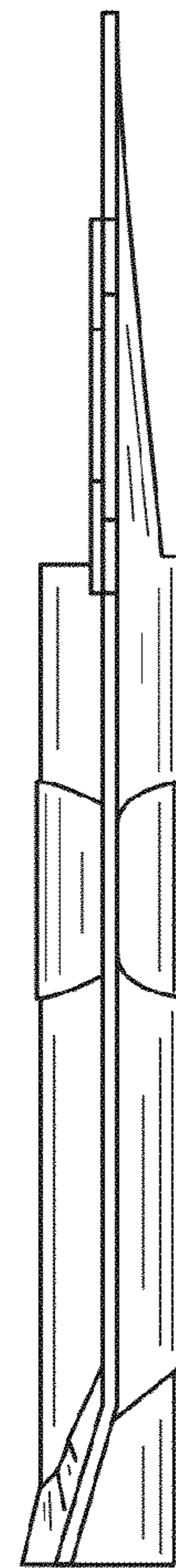

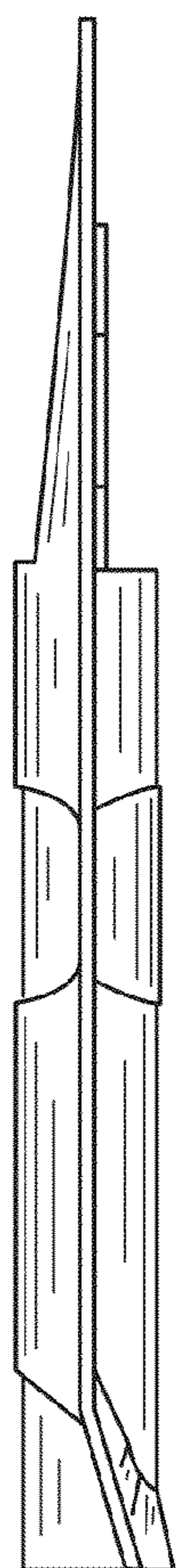

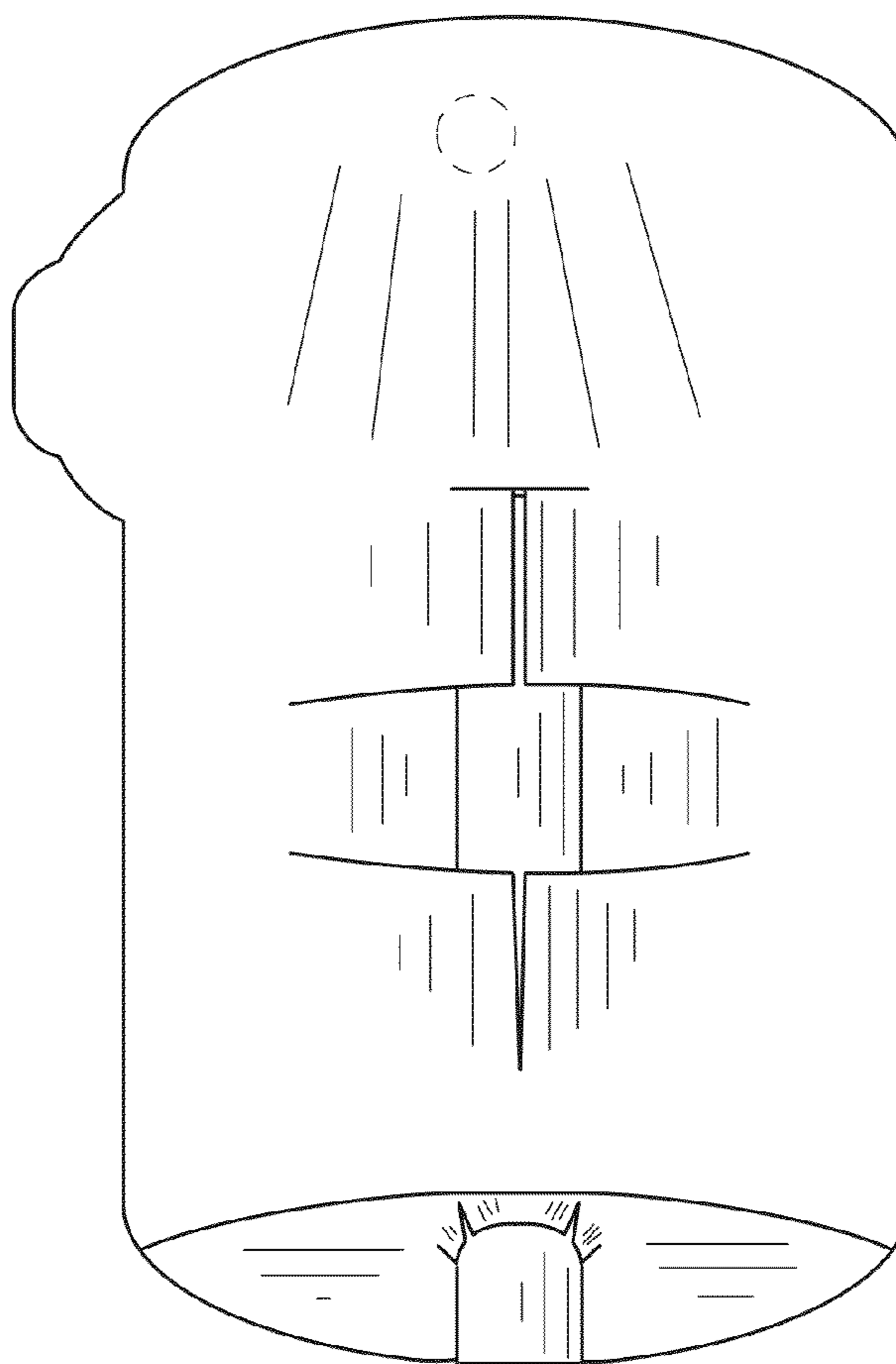

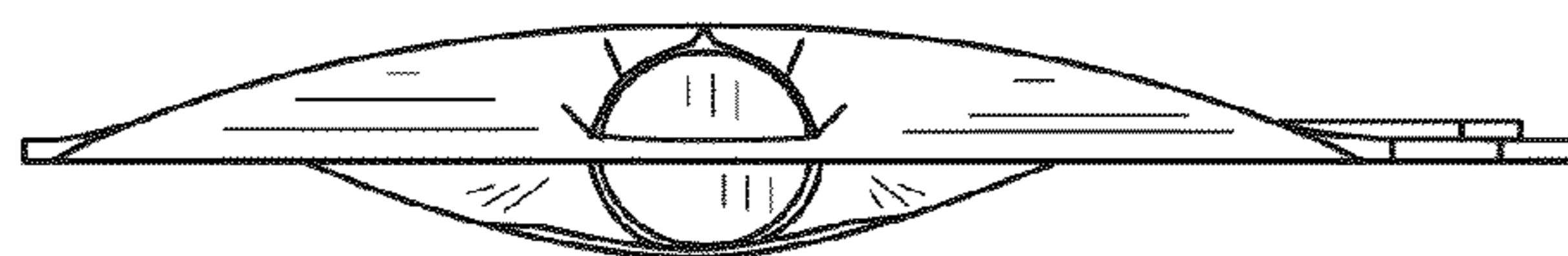
