(57) **CLAIM**
The ornamental design for a beverage bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the beverage bottle of the present invention.
FIG. 2 is a front elevation view of the bottle of FIG. 1.
FIG. 3 is a side elevation view of the bottle of FIG. 1, the bottle being otherwise symmetrical about its longitudinal axis.
FIG. 4 is a top plan view of the bottle of FIG. 1; and,
FIG. 5 is a bottom plan view of the bottle of FIG. 1.
The broken line showing is for illustrative purposes only, and forms no part of the claimed design.

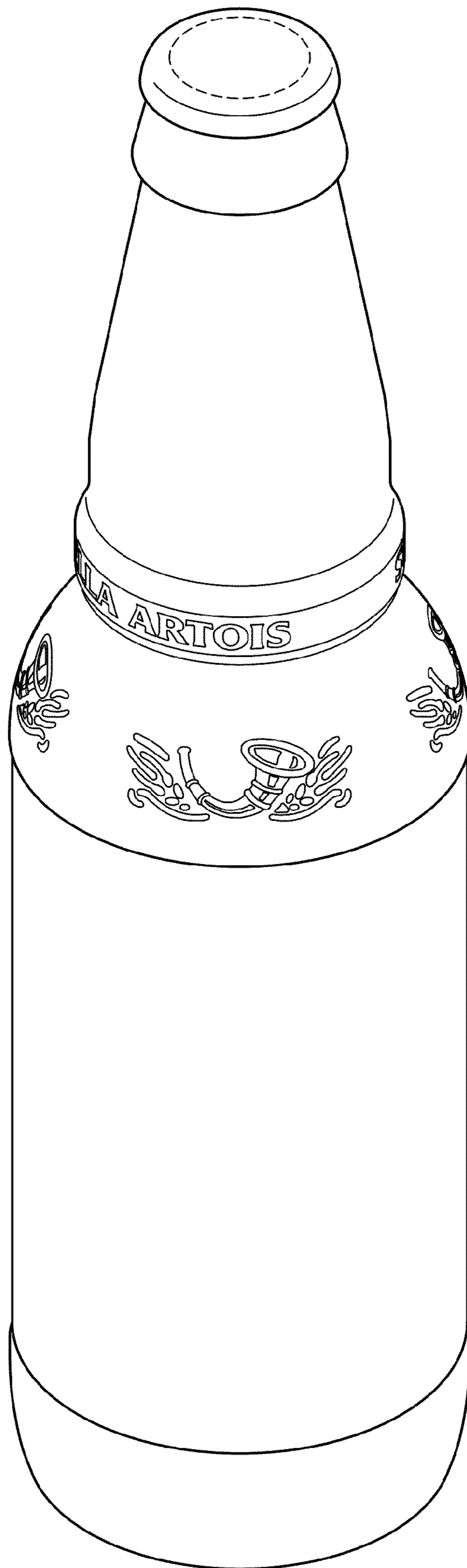

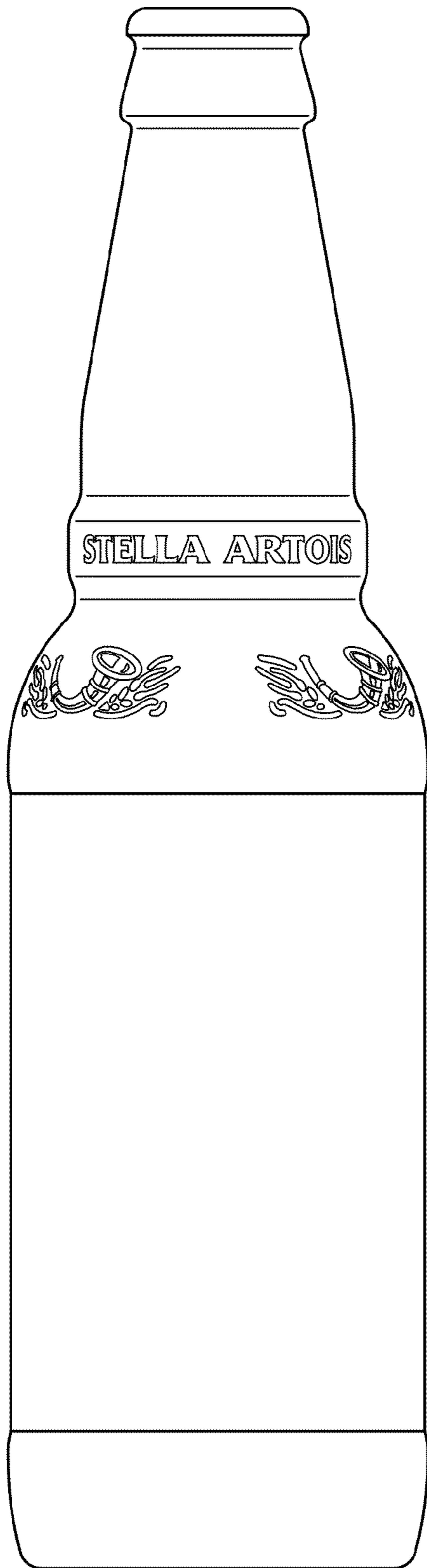

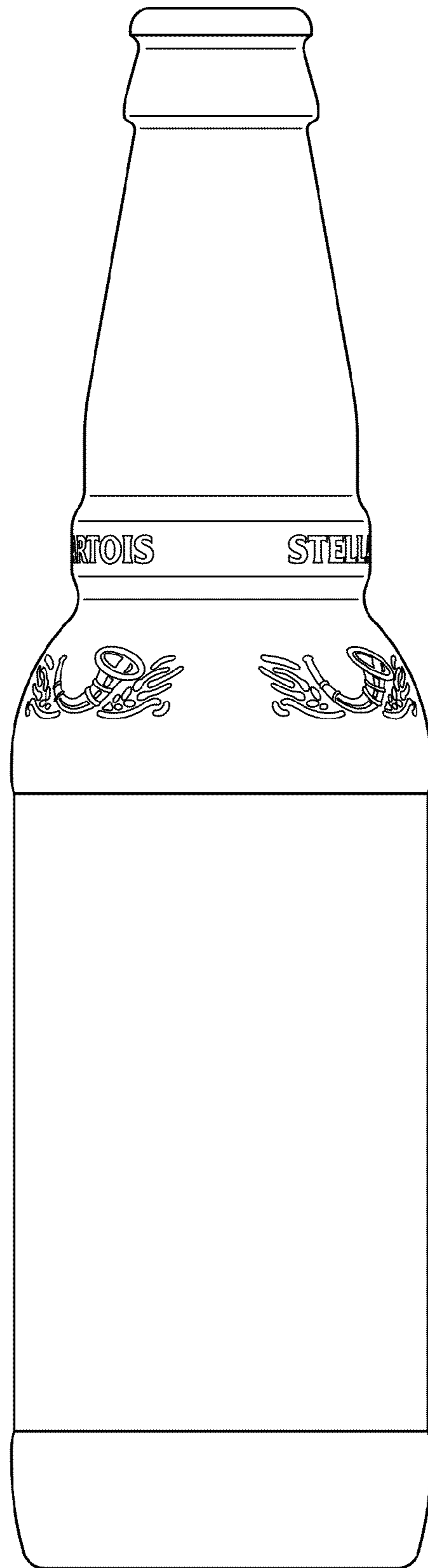

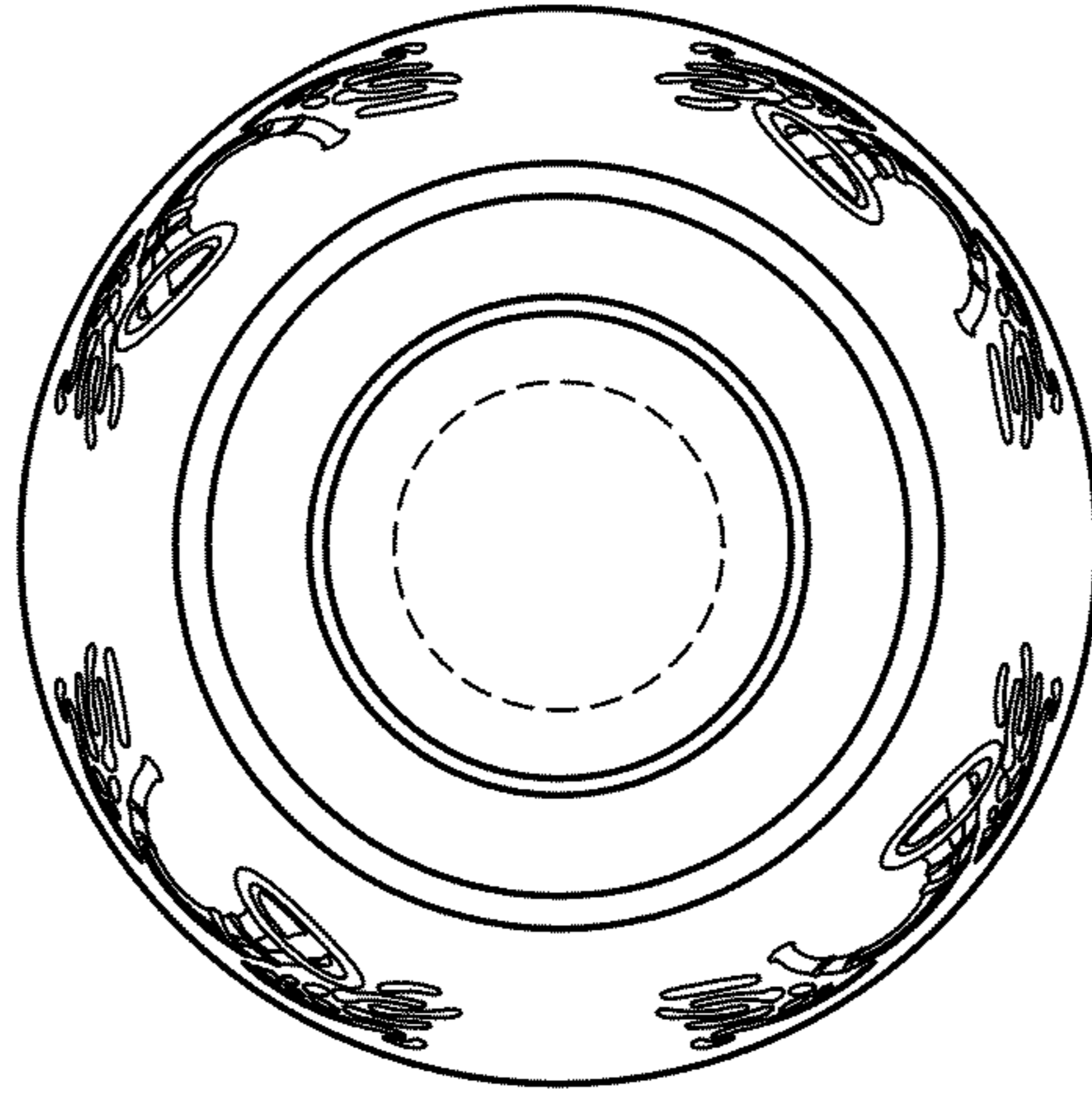

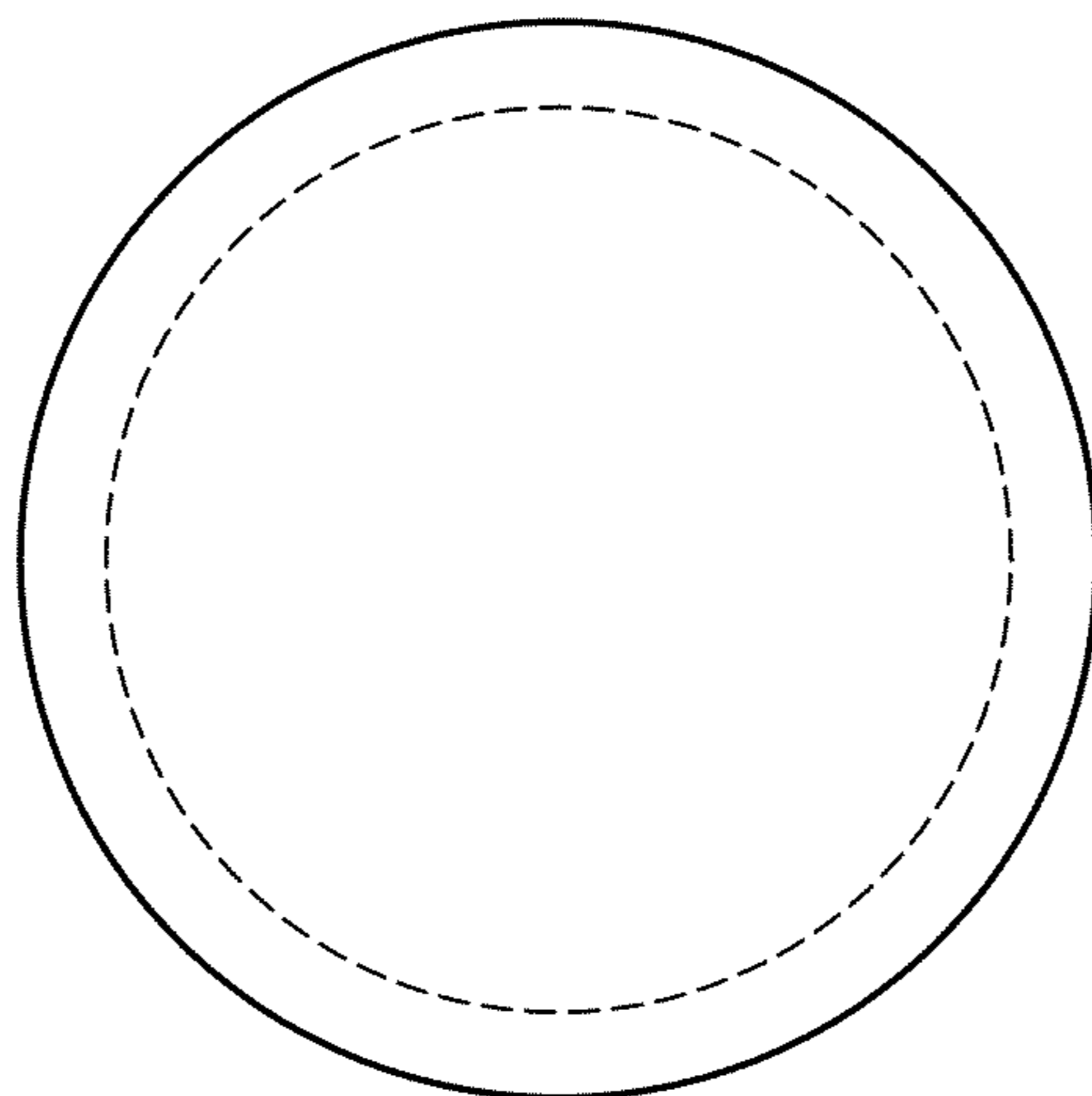
