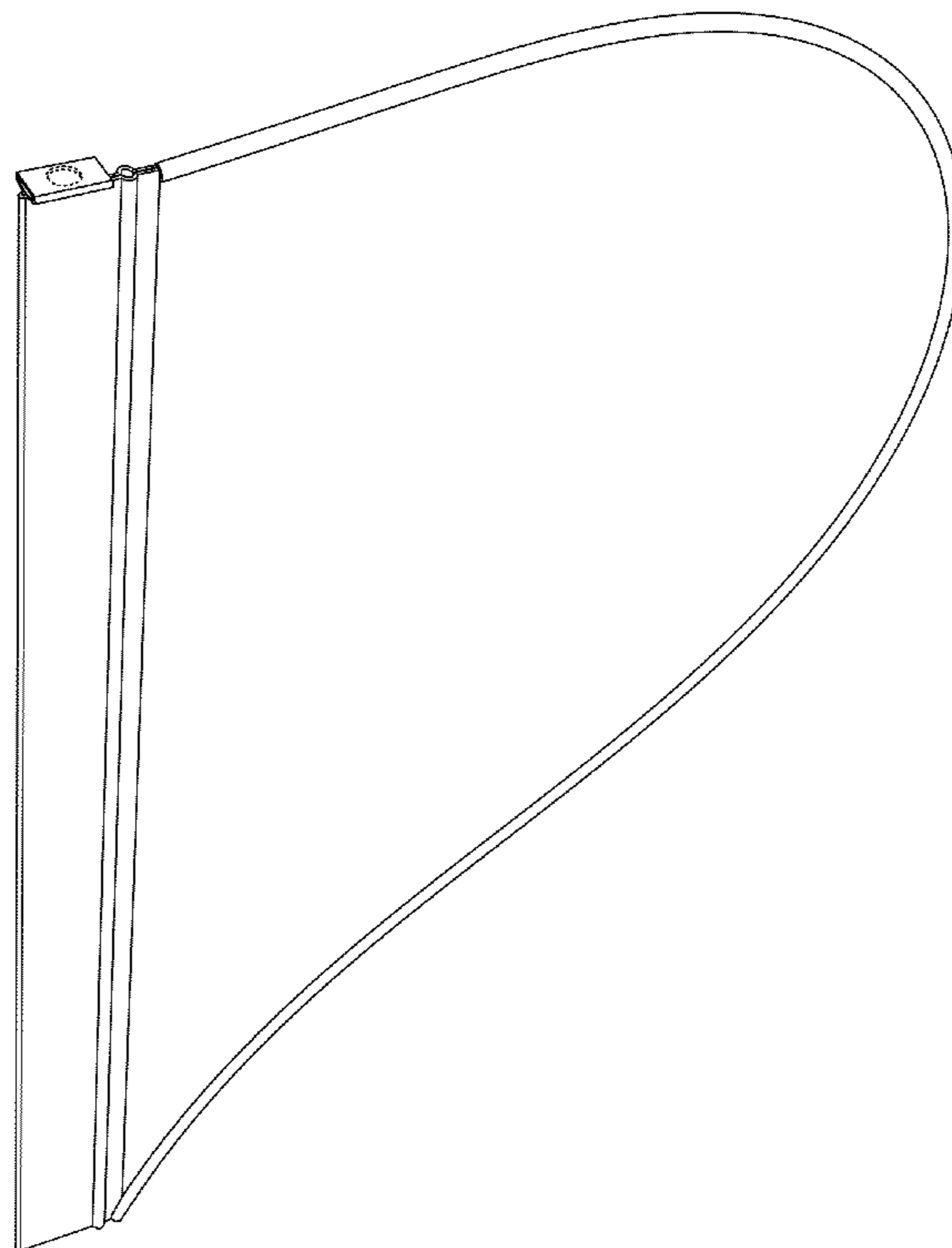
(57) **CLAIM**

The ornamental design for a flag, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a flag showing our new design;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a right side elevational view thereof; the left side elevational view is a mirror image of the right side view;
FIG. 6 is a rear elevational view thereof; and,
FIG. 7 is a top plan view thereof.
The broken lines represent unclaimed portions of the flag and form no part of the claimed design.

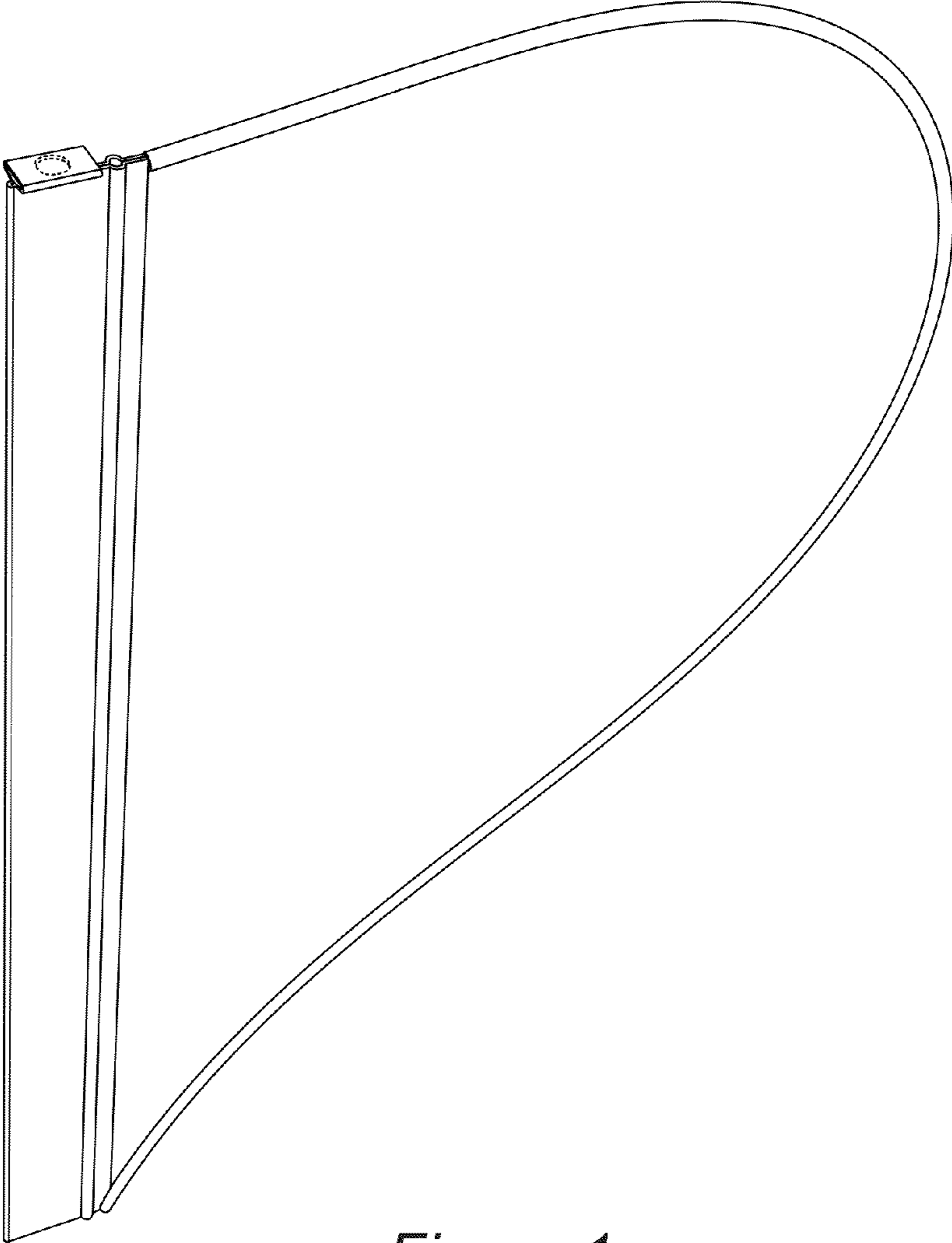

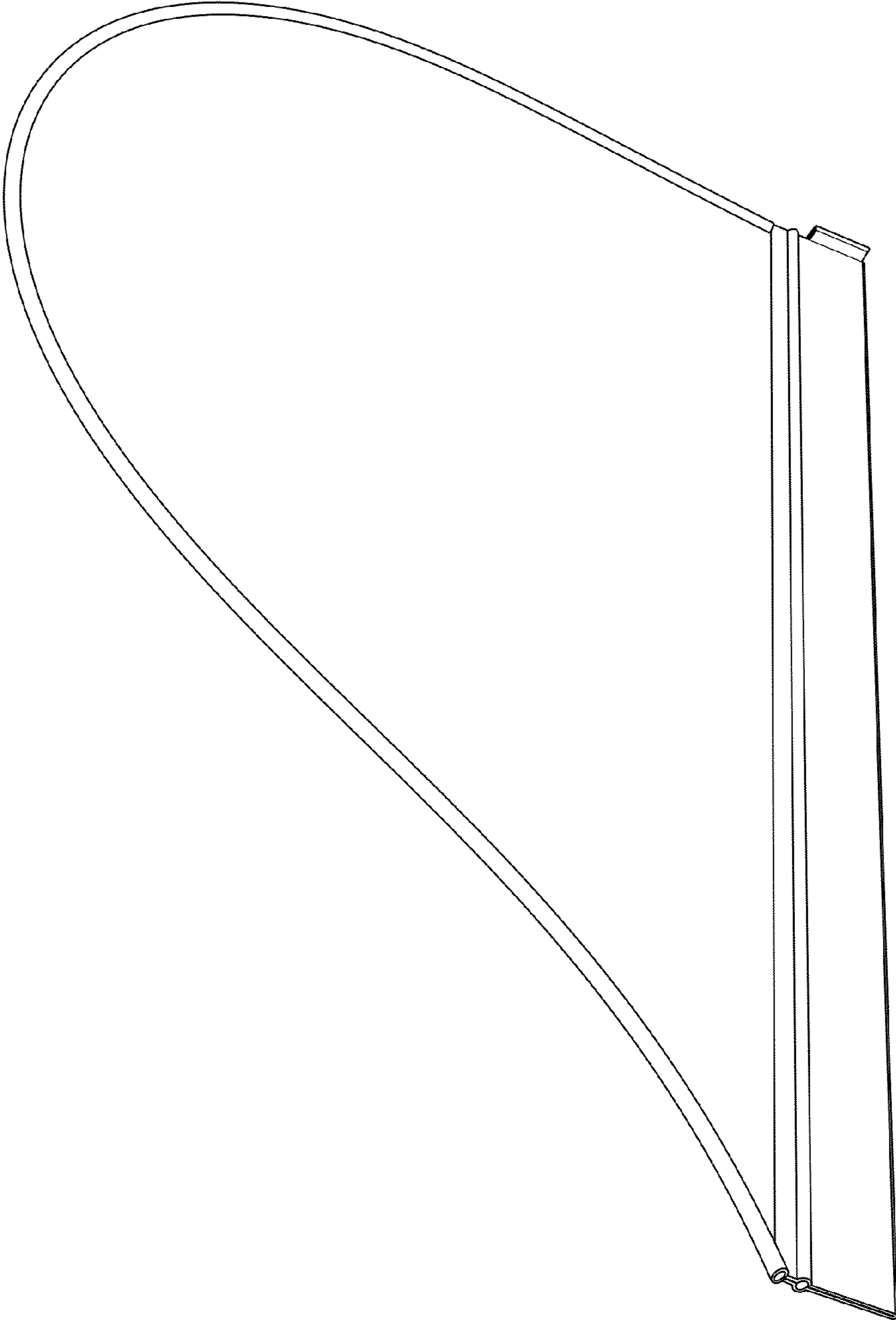

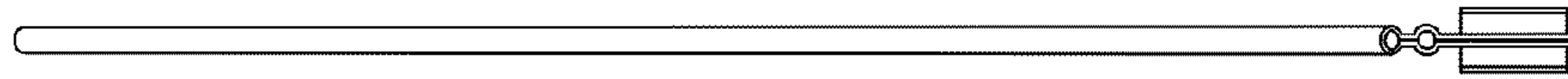

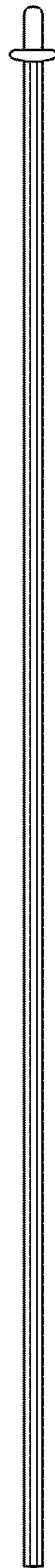

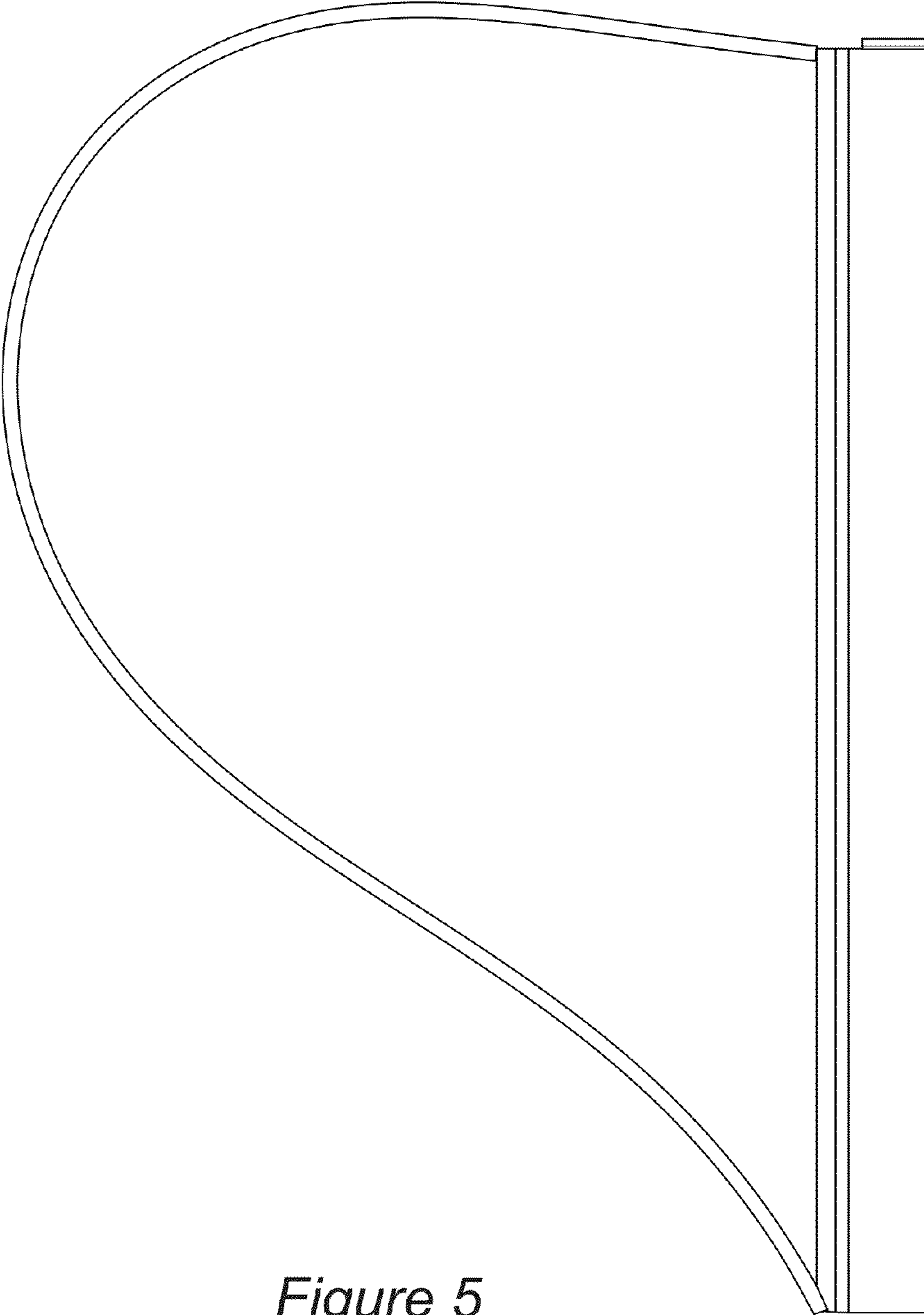

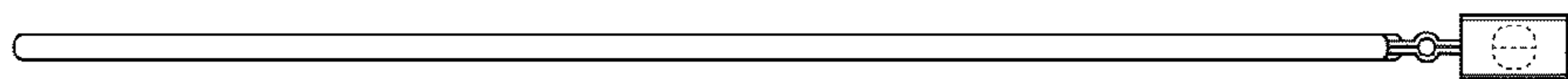
