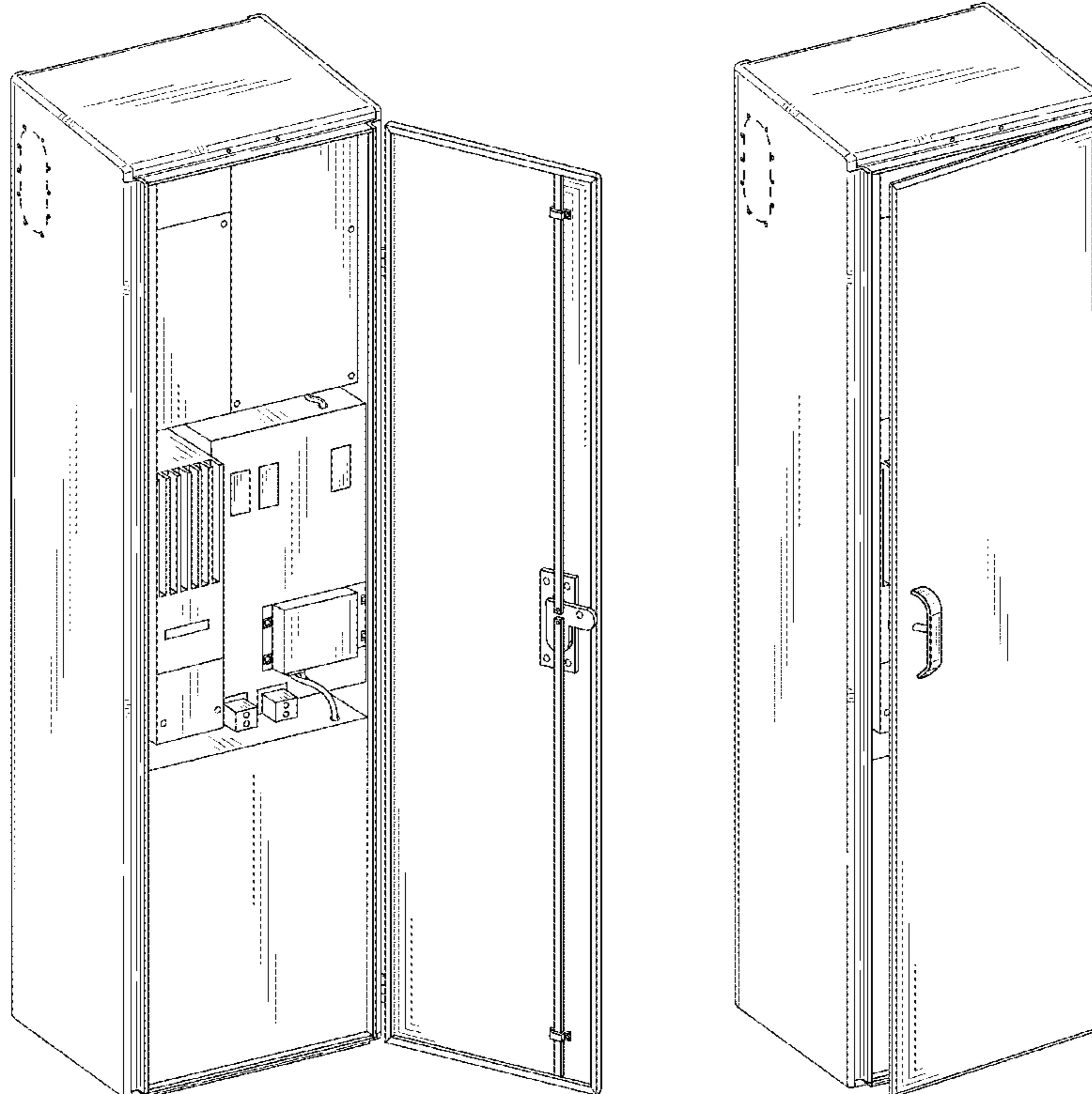
(57) **CLAIM**

The ornamental design for a solar integrated system enclosure, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a solar integrated system enclosure showing my new design;  
 FIG. 2 is a back elevation view thereof;  
 FIG. 3 is a right side exploded view thereof;  
 FIG. 4 is a left side exploded view thereof;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a perspective view thereof, with the door in an open condition;  
 FIG. 7 is another perspective view thereof, with the door in a slightly open condition;  
 FIG. 8 is a front elevation view with the door removed for ease of illustration;  
 FIG. 9 is a rear elevation view of the door shown removed from the solar integrated system enclosure for ease of illustration;  
 FIG. 10 is a side view of the door thereof; and,  
 FIG. 11 is a top plan view of the door thereof.  
 The broken lines are included for the purpose of illustrating environmental structure and form no part of the claimed design.

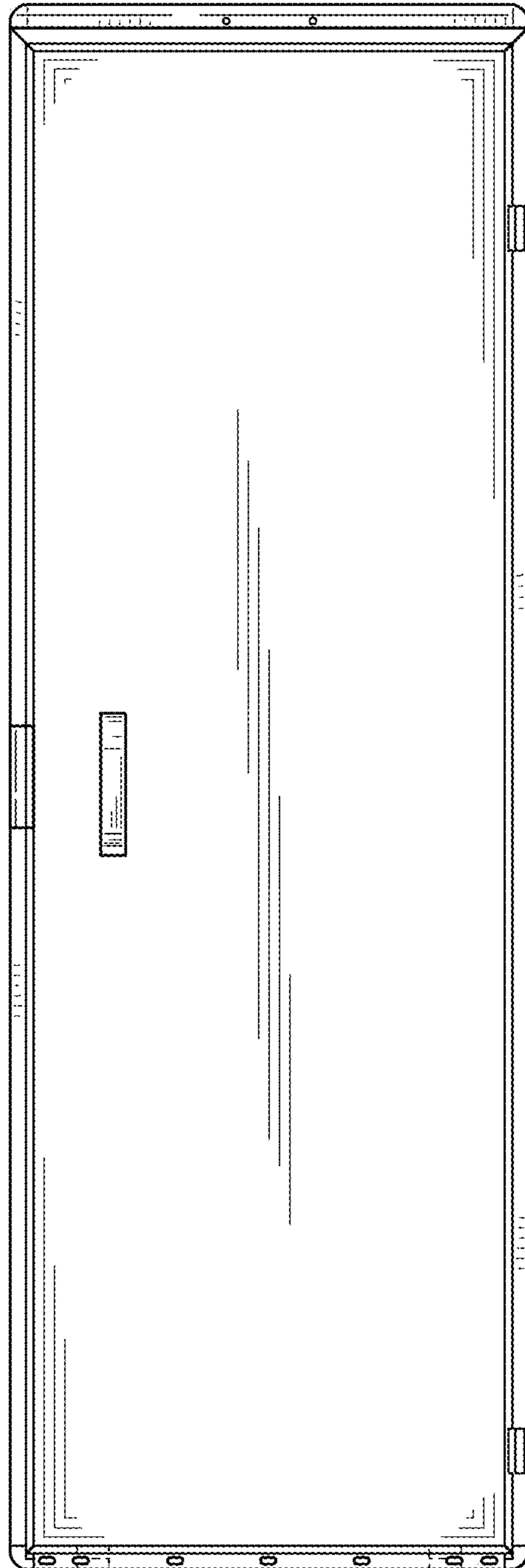

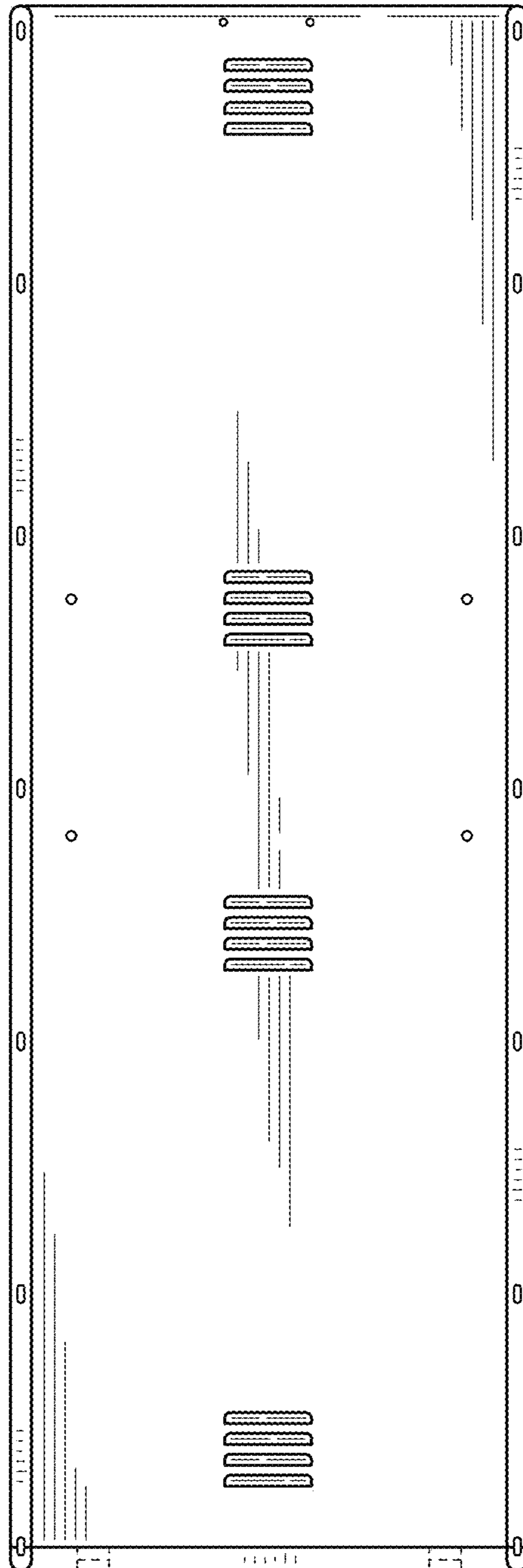

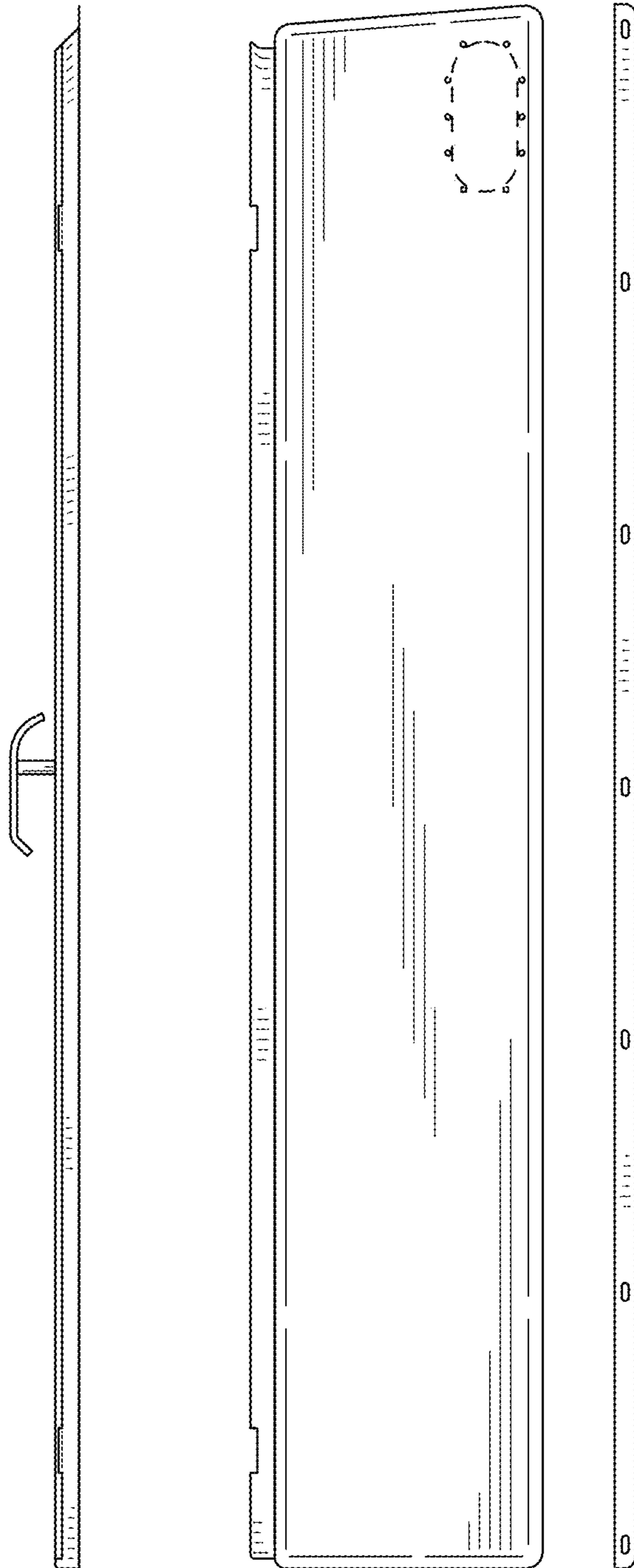

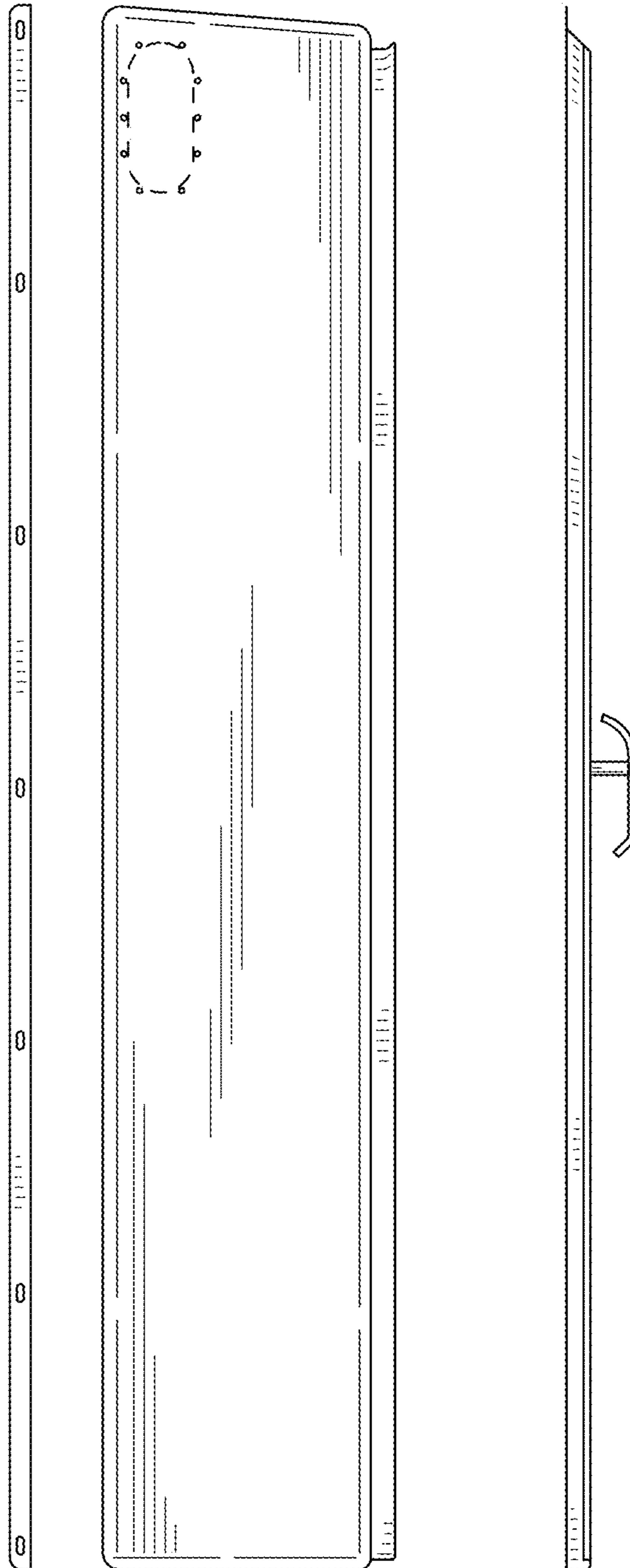

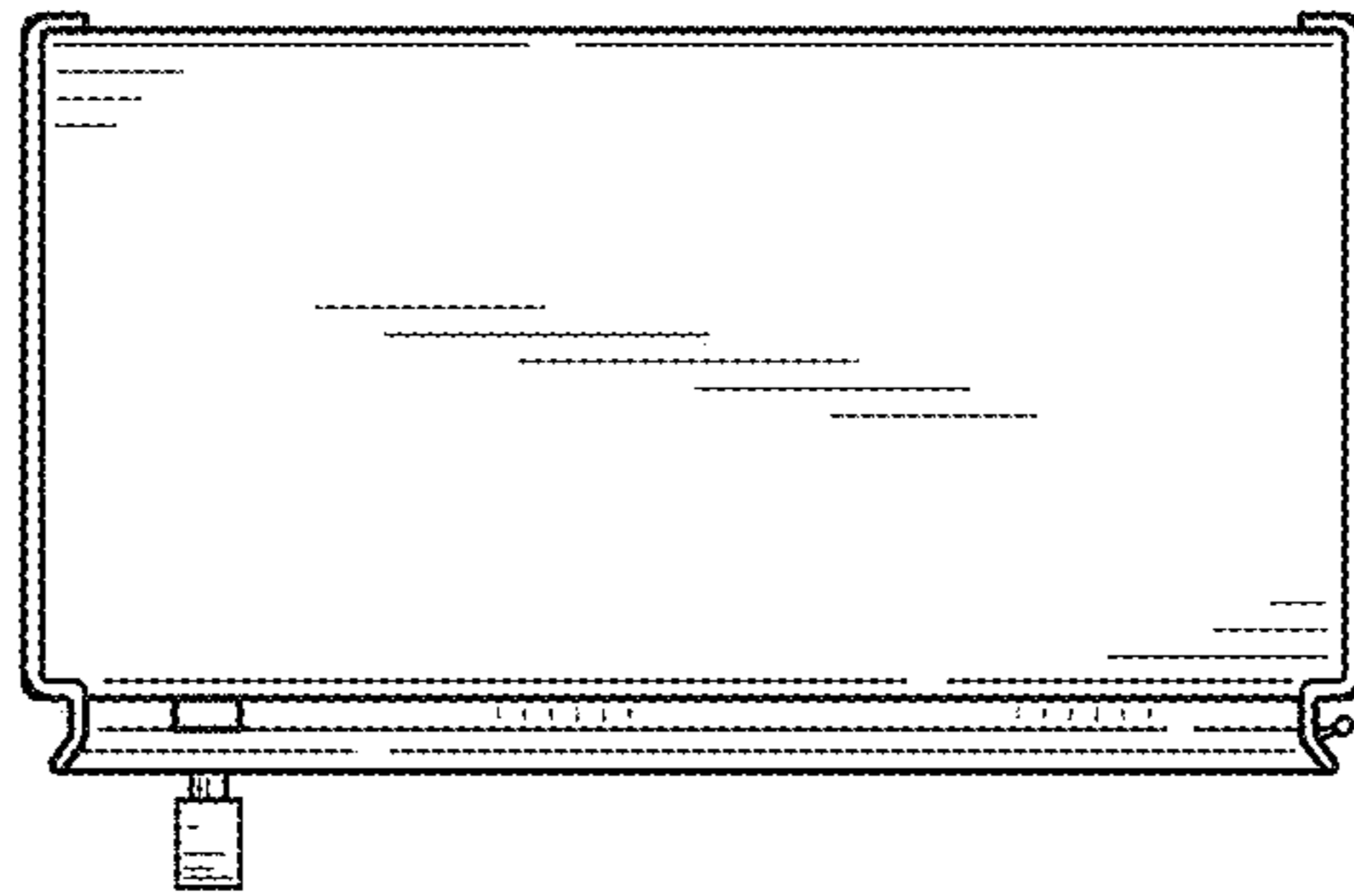

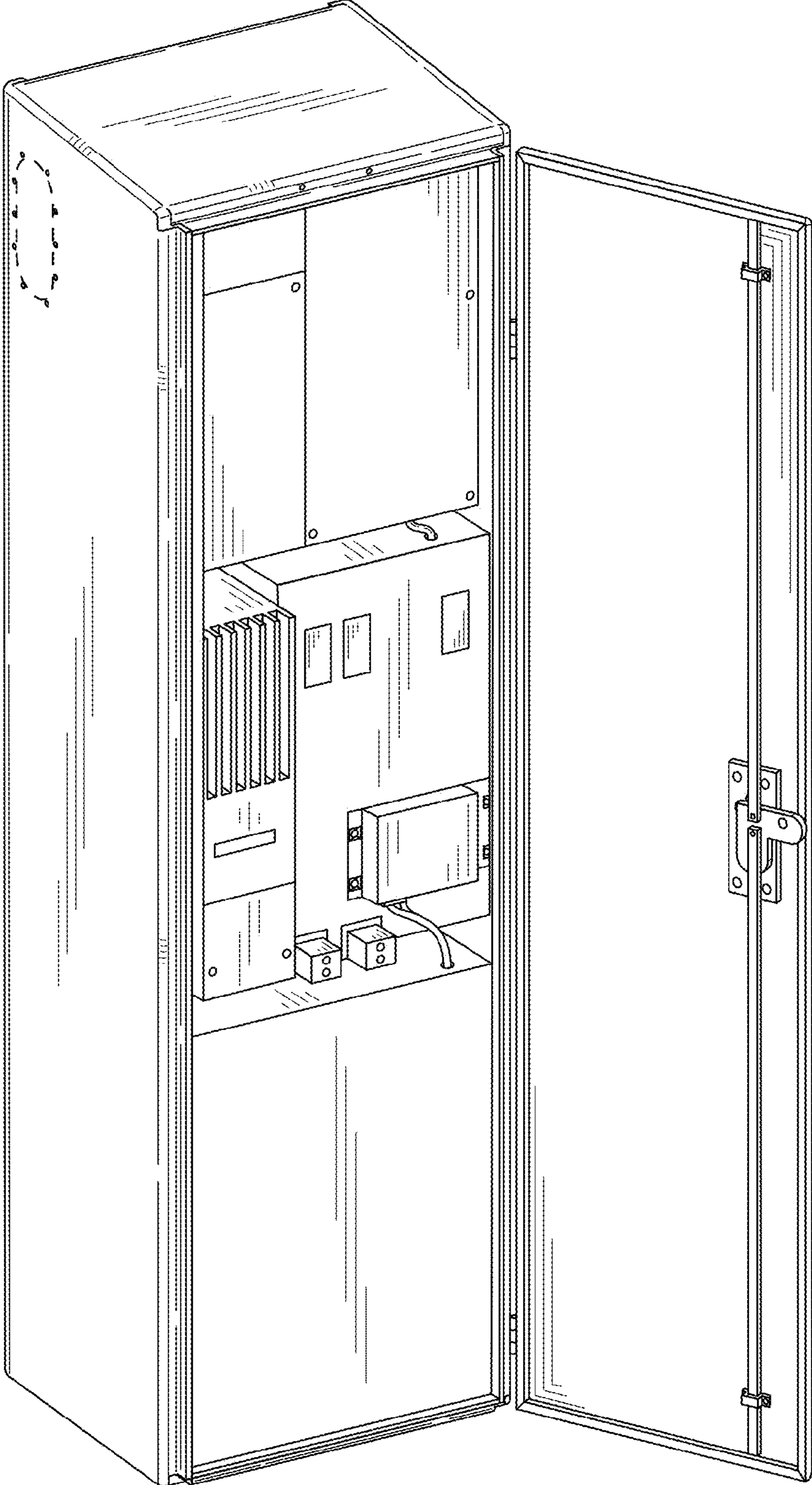

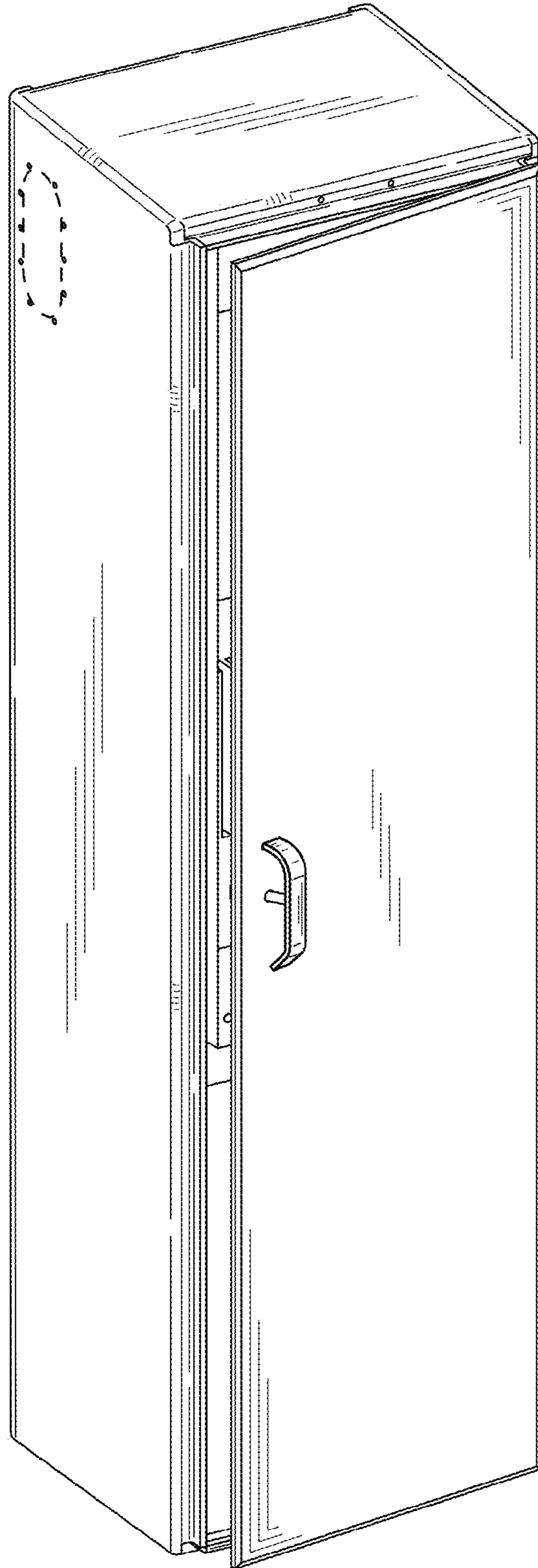

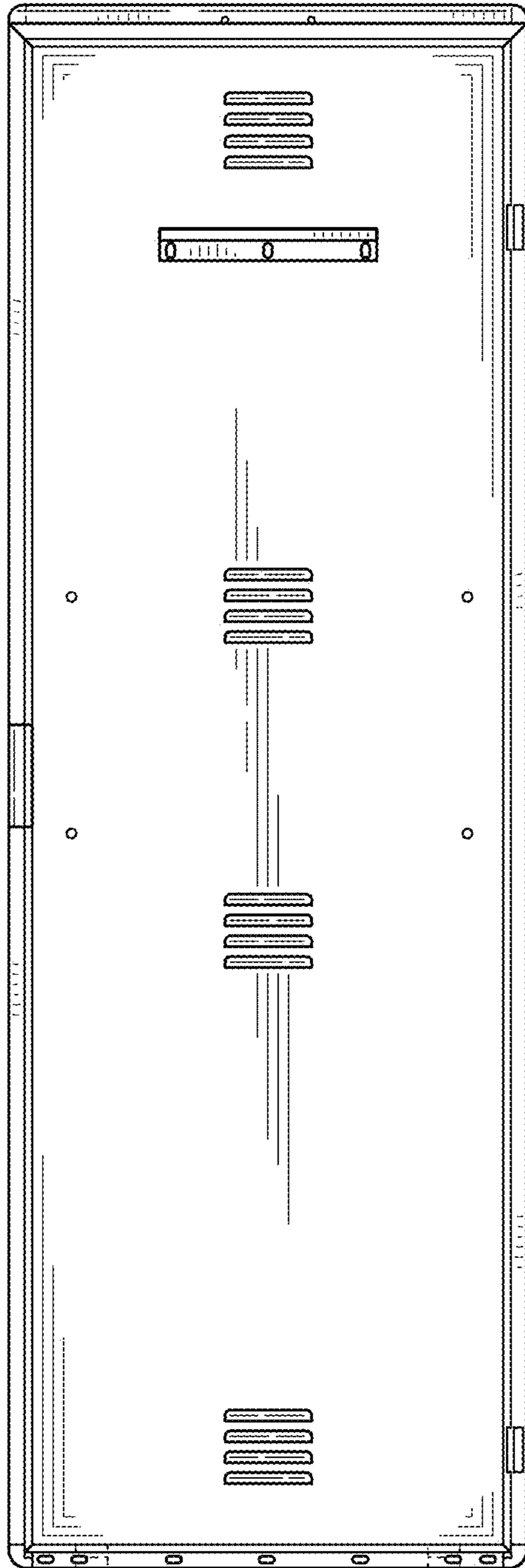

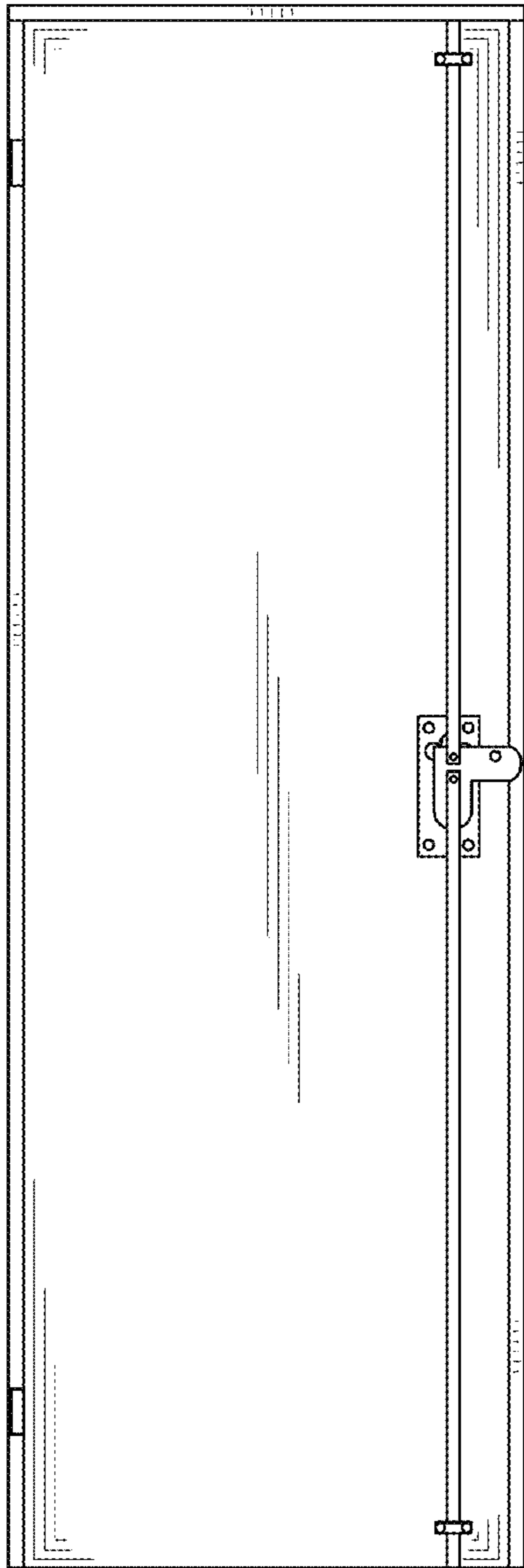

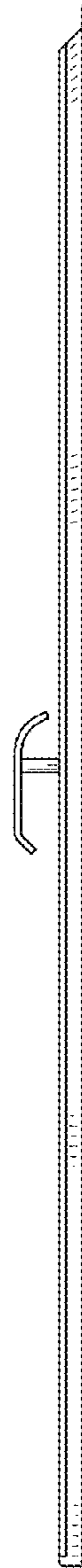
