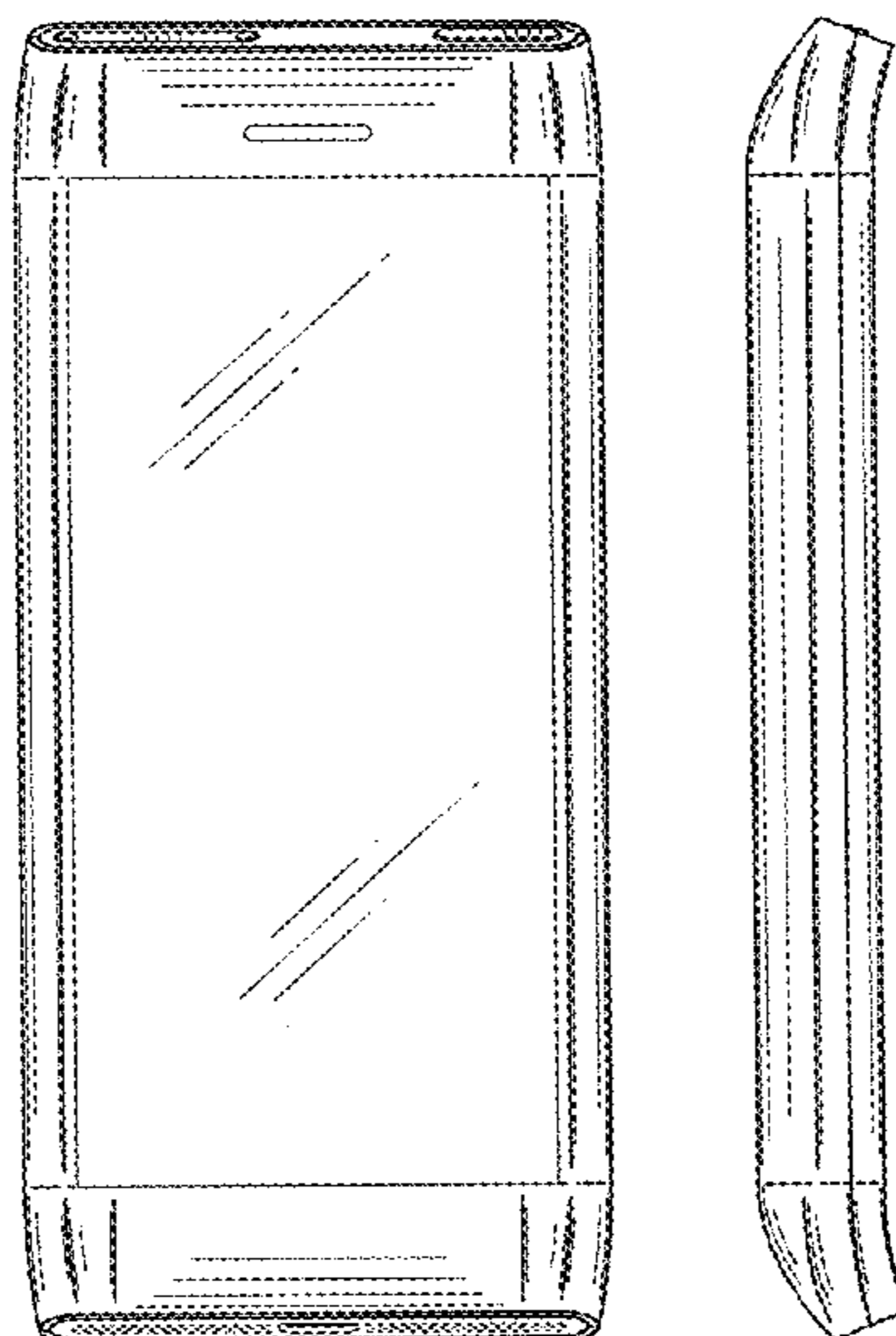
(57) **CLAIM**

The ornamental design for a mobile phone, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the front of a mobile phone, showing our new design;
FIG. 2 is a perspective view from the back thereof;
FIG. 3 is a perspective view from the side thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a back view thereof;
FIG. 6 is a left side view thereof, the mirror image of which is a right side view thereof;
FIG. 7 is a top view thereof; and,
FIG. 8 is a bottom view thereof.

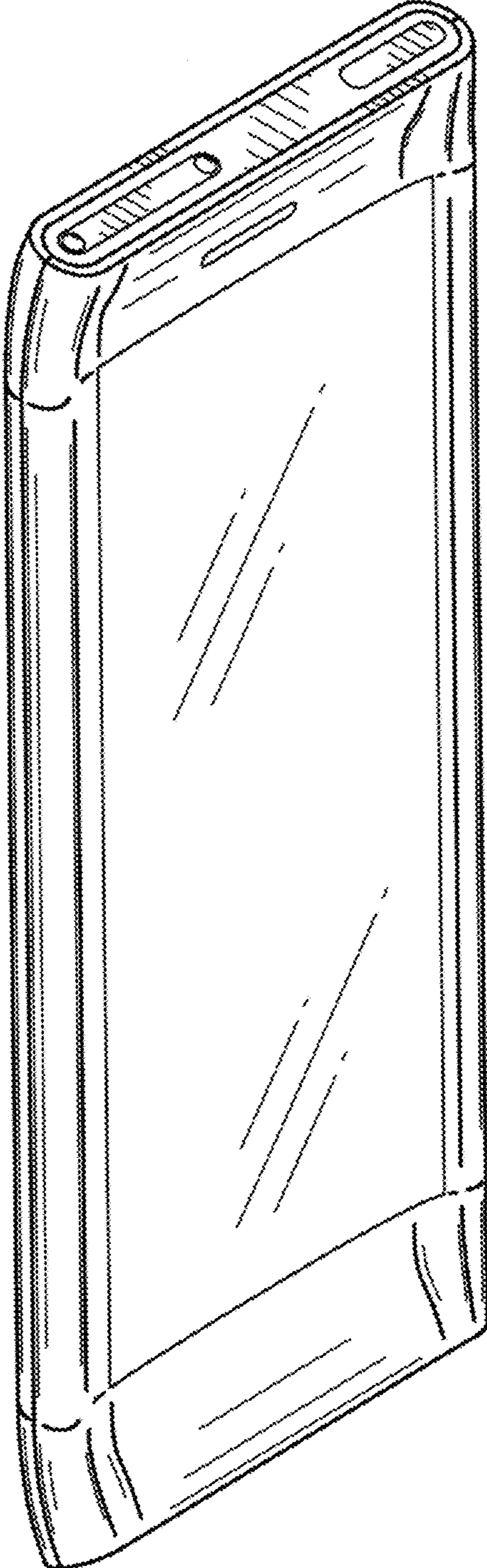

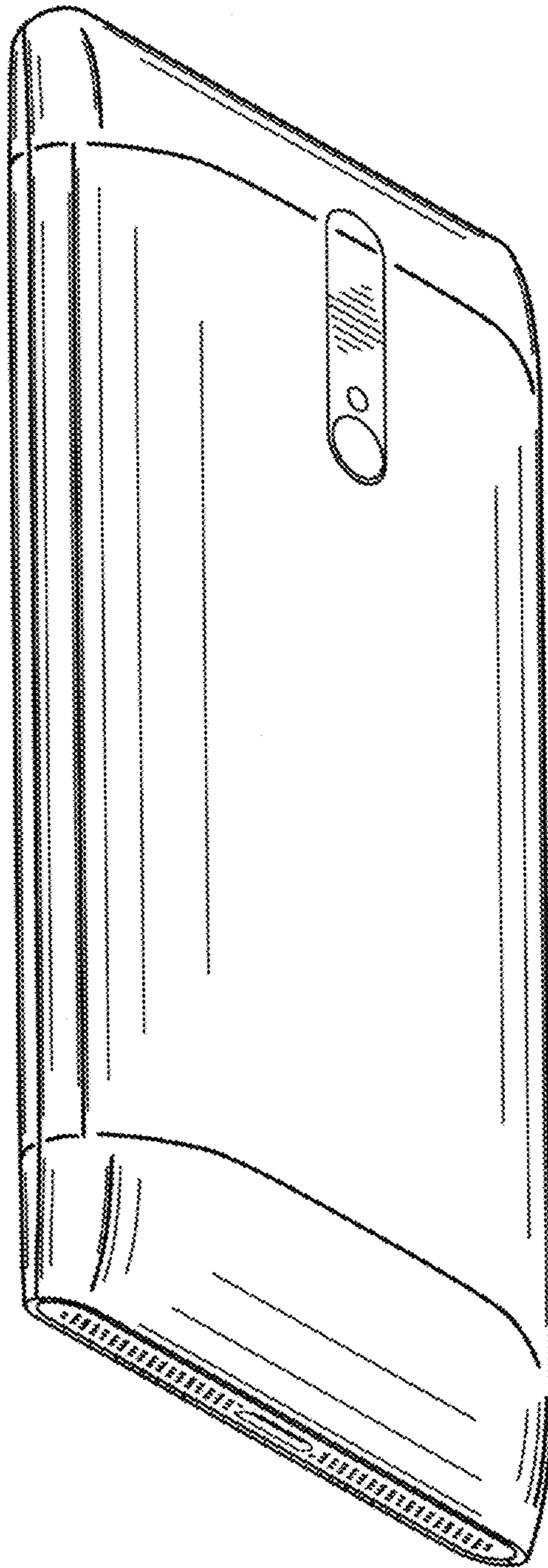

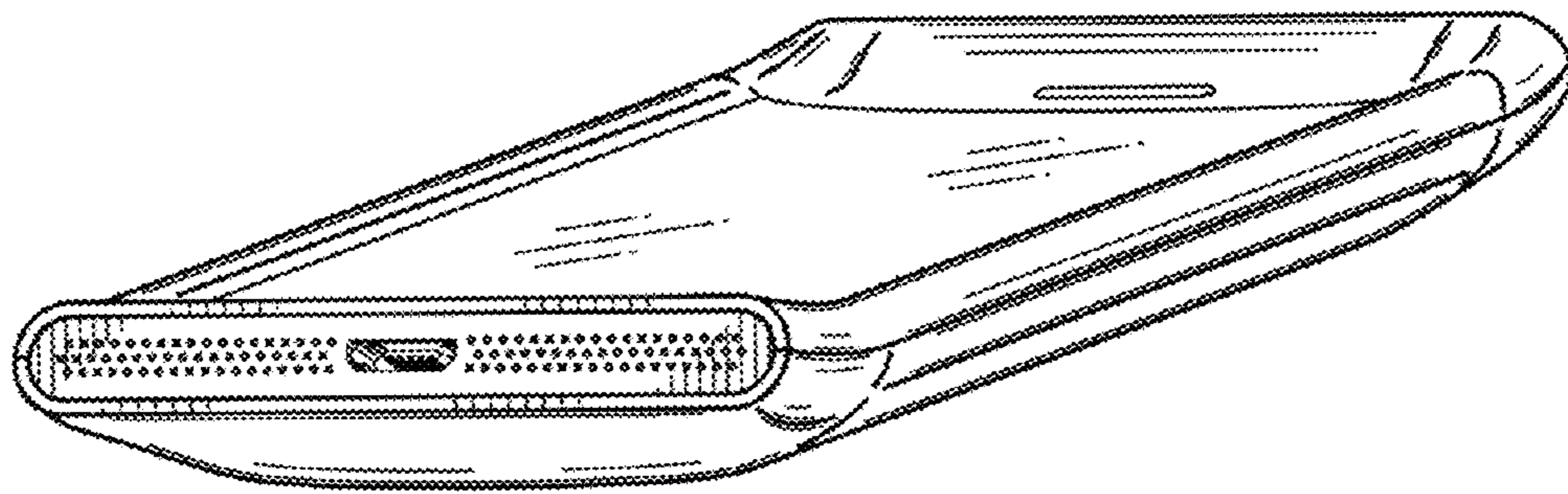

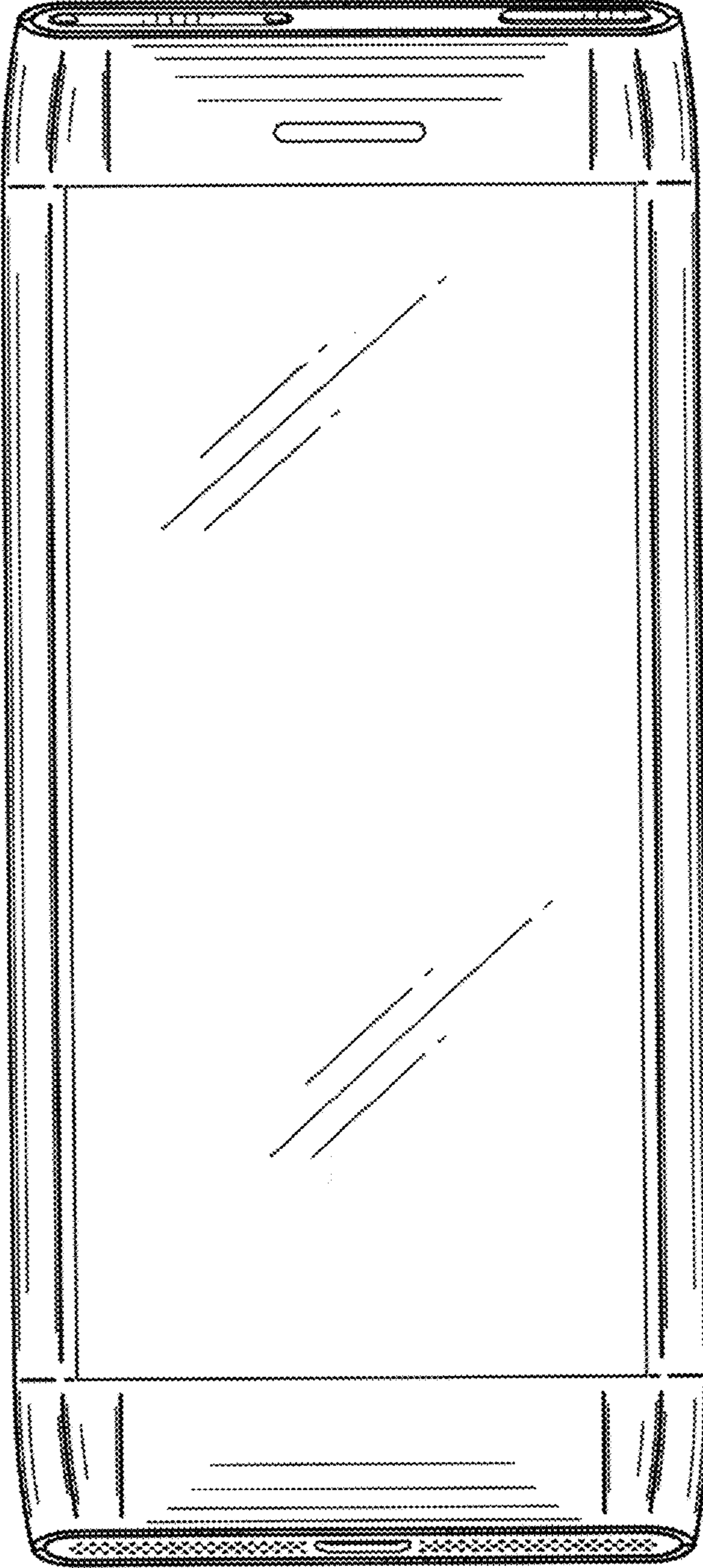

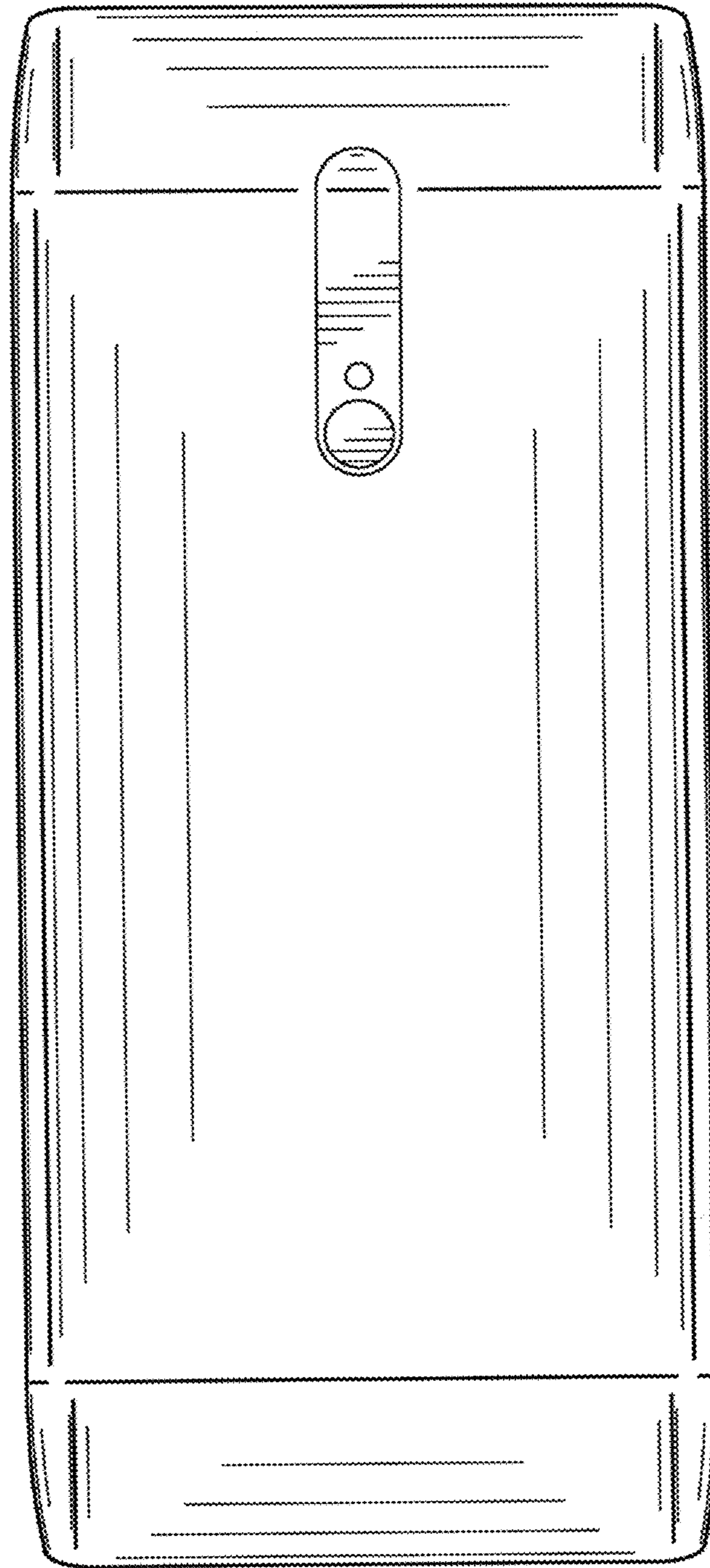

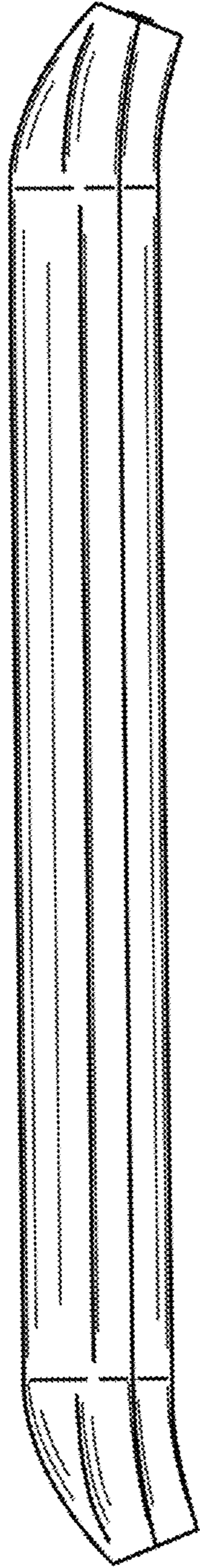

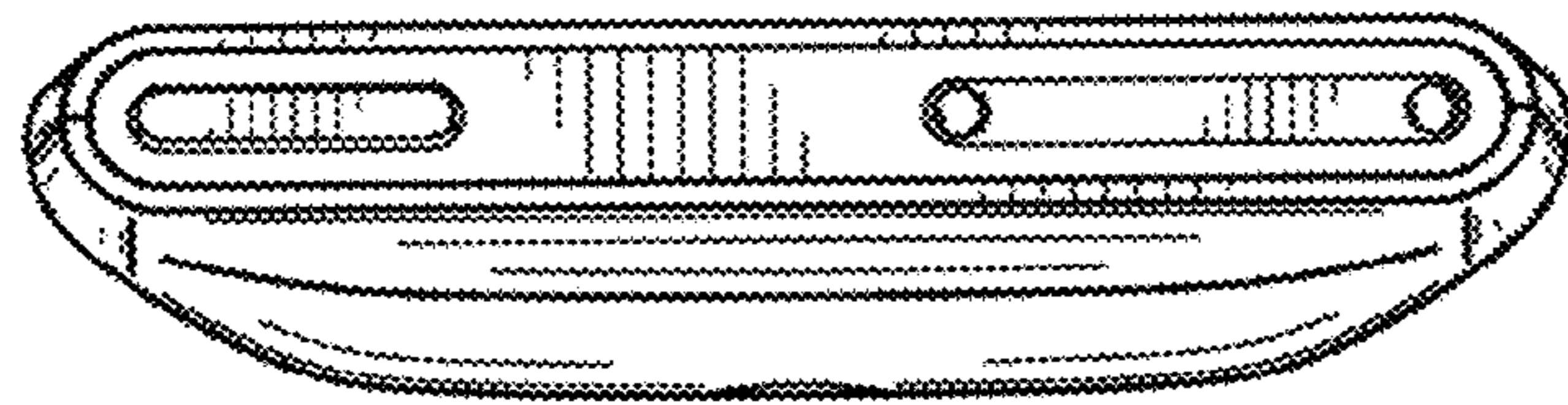

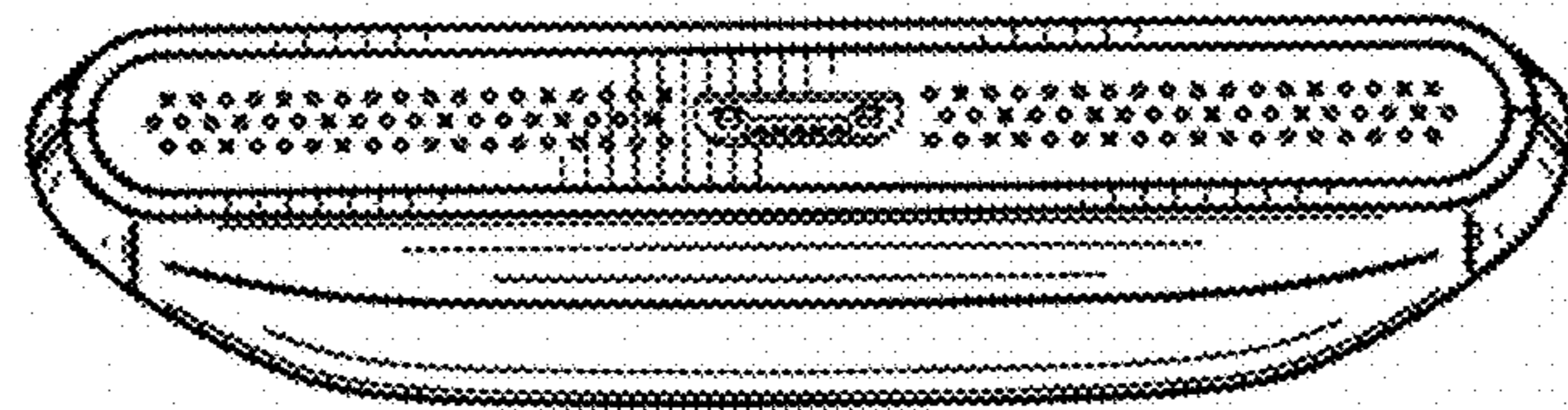
