FIG. 3 is a front view of the first state in a sequence of an alternate embodiment for a display with graphical user interface showing our new design;

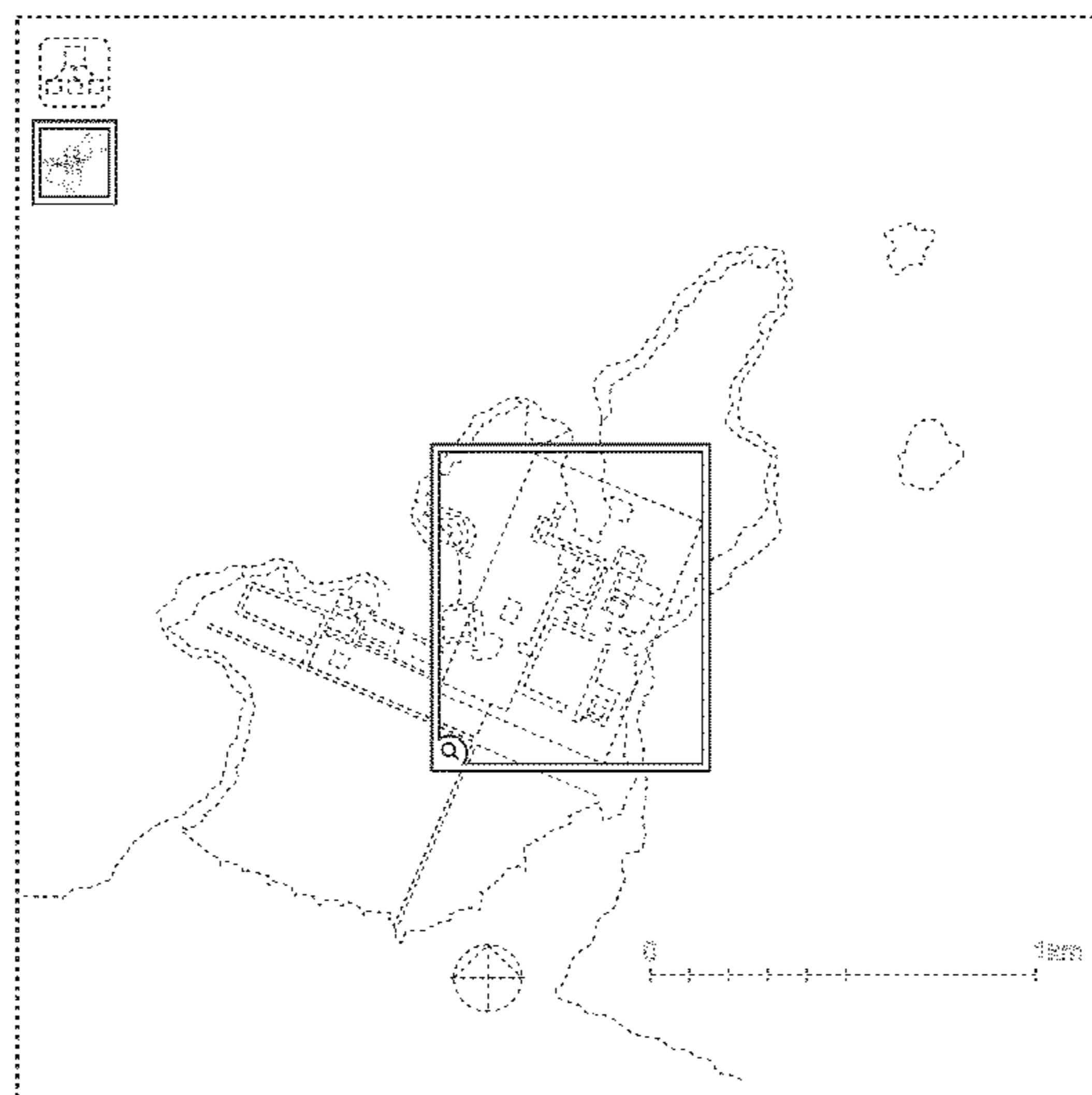
FIG. 4 is a front view second state thereof; and,

FIG. 5 is a front view third state thereof.

The appearance of the transitional user interface sequentially transitions between the images shown in FIGS. 1-2 and between the images shown in FIGS. 3-5 in an alternate embodiment. The process or period in which one image transitions to another image forms no part of the claimed design.

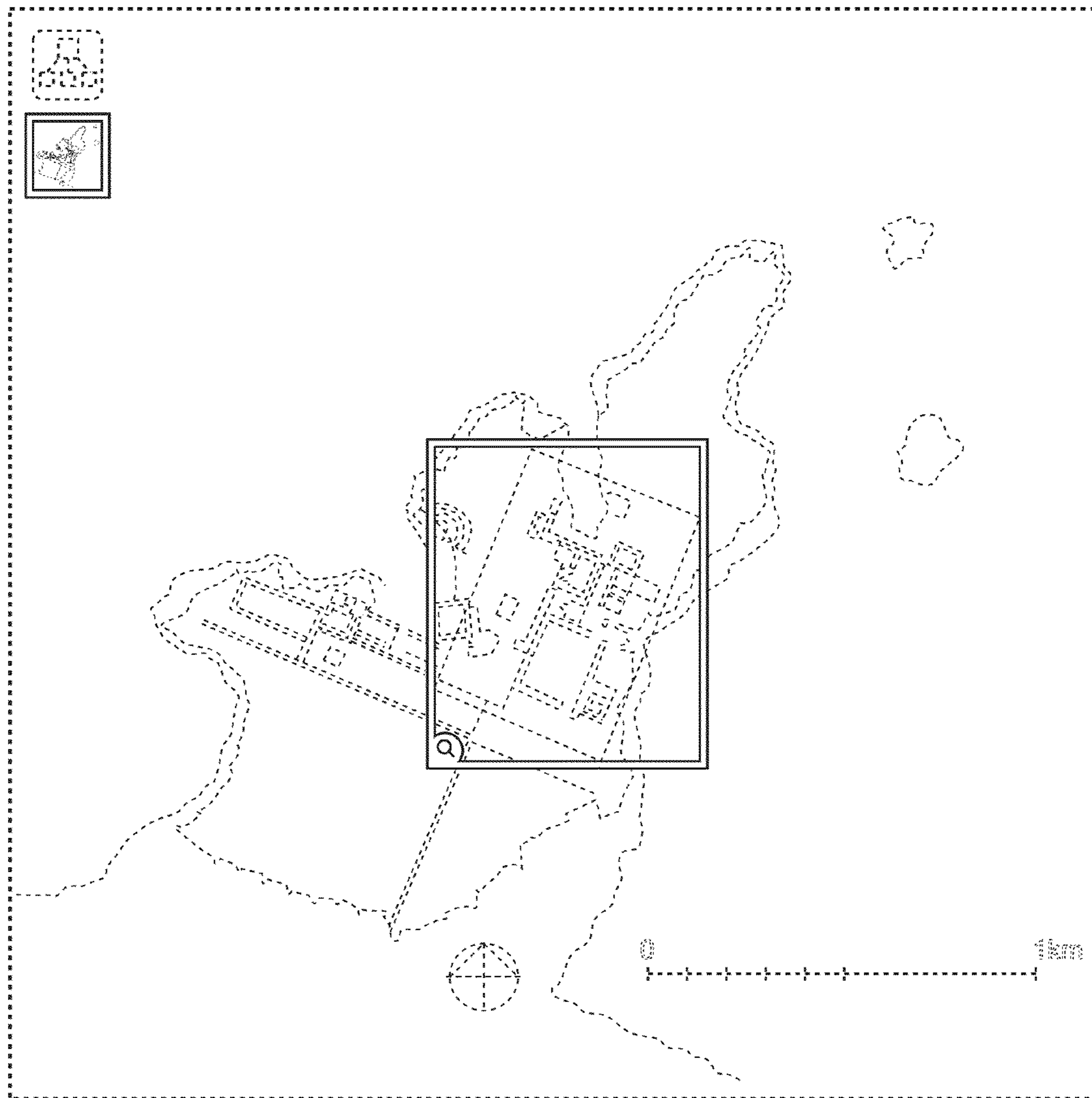

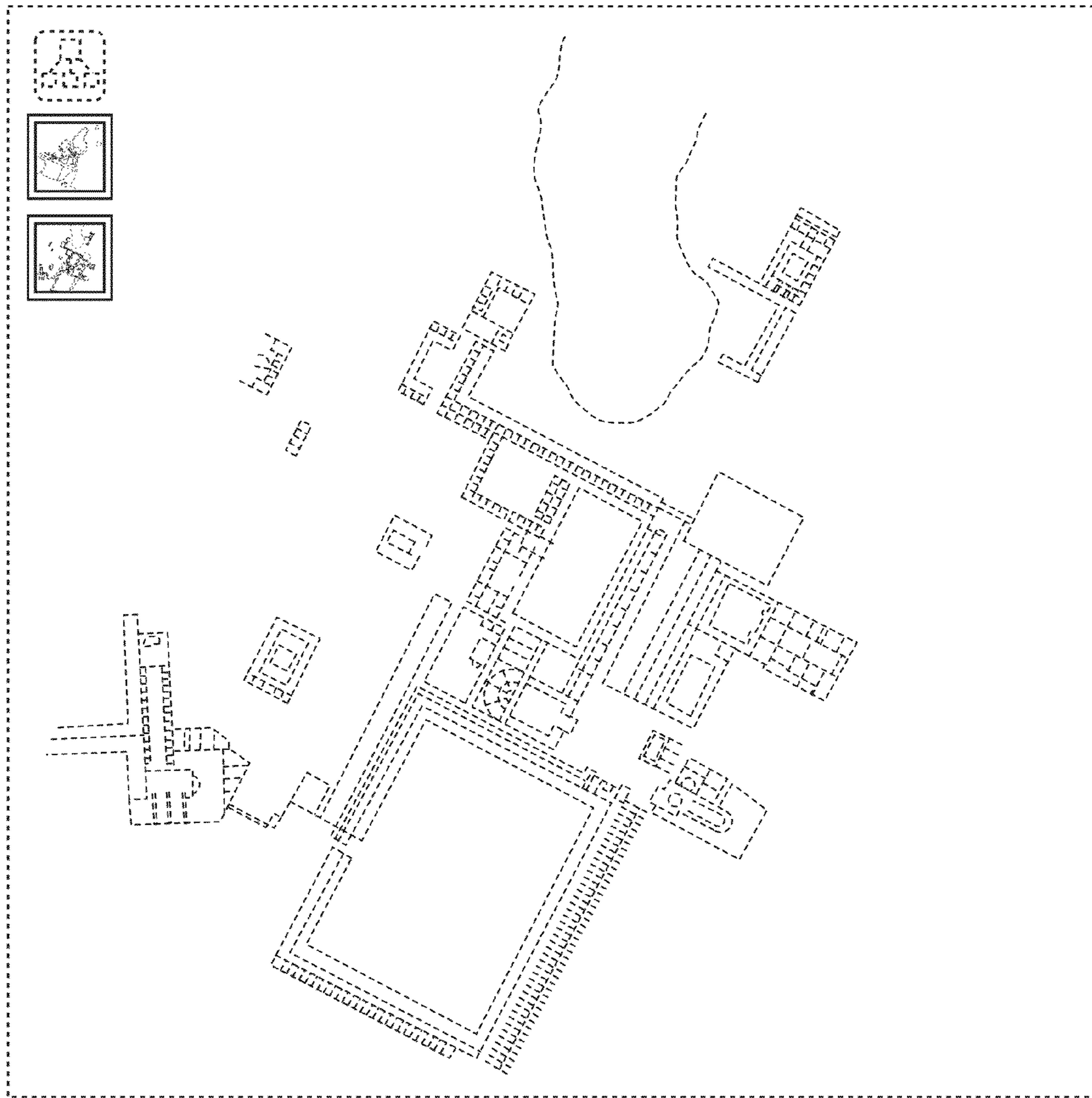

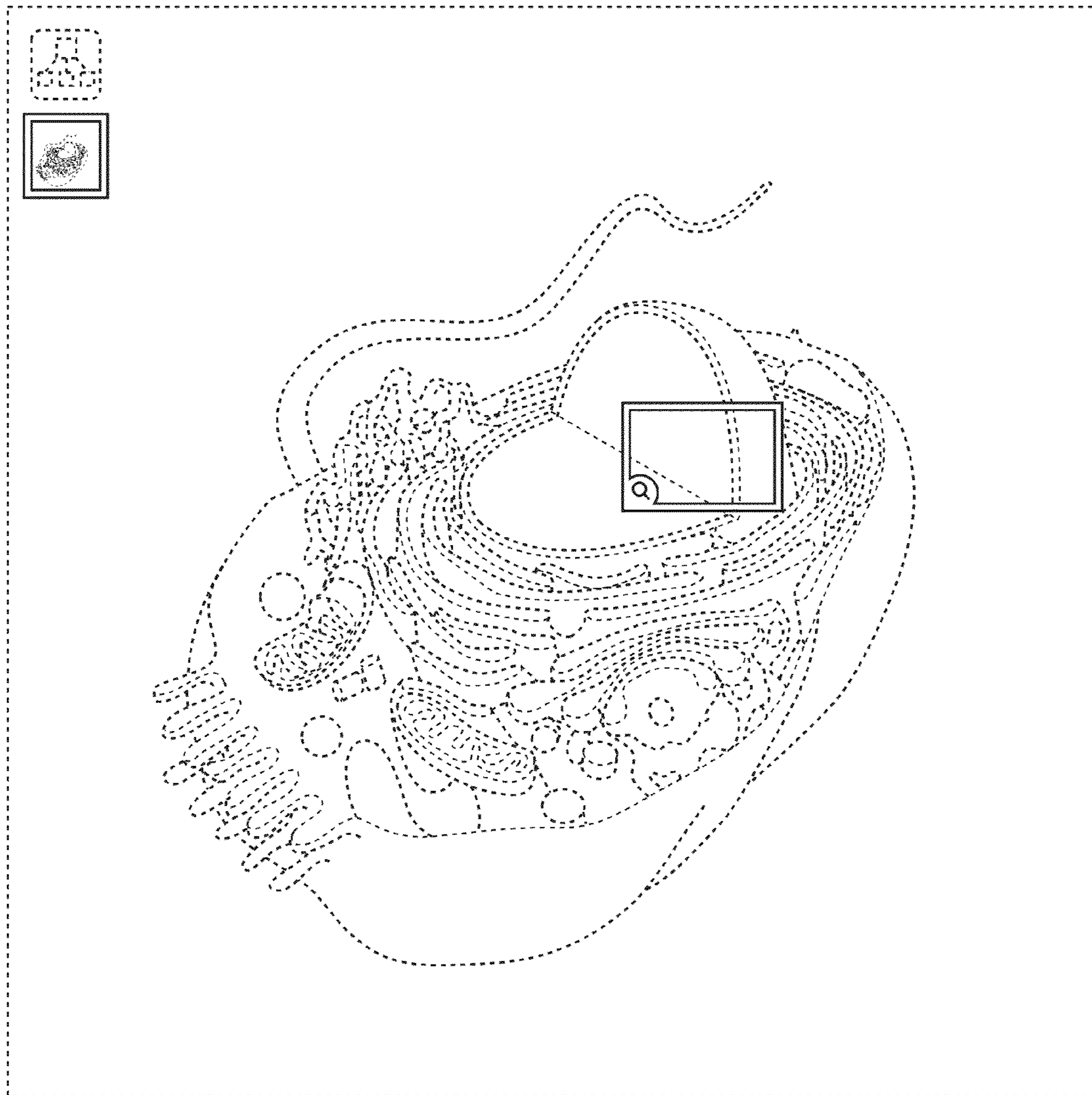

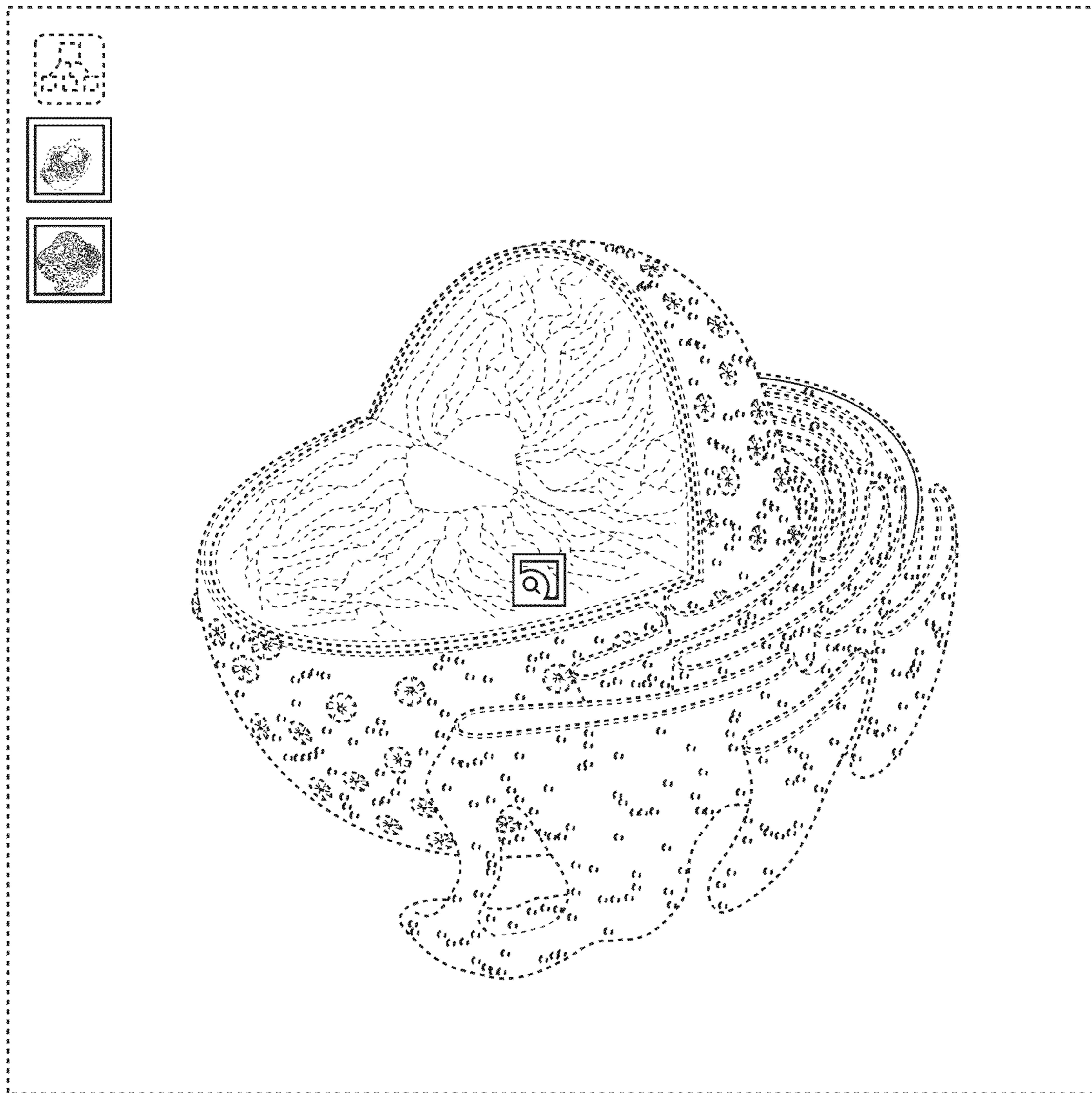

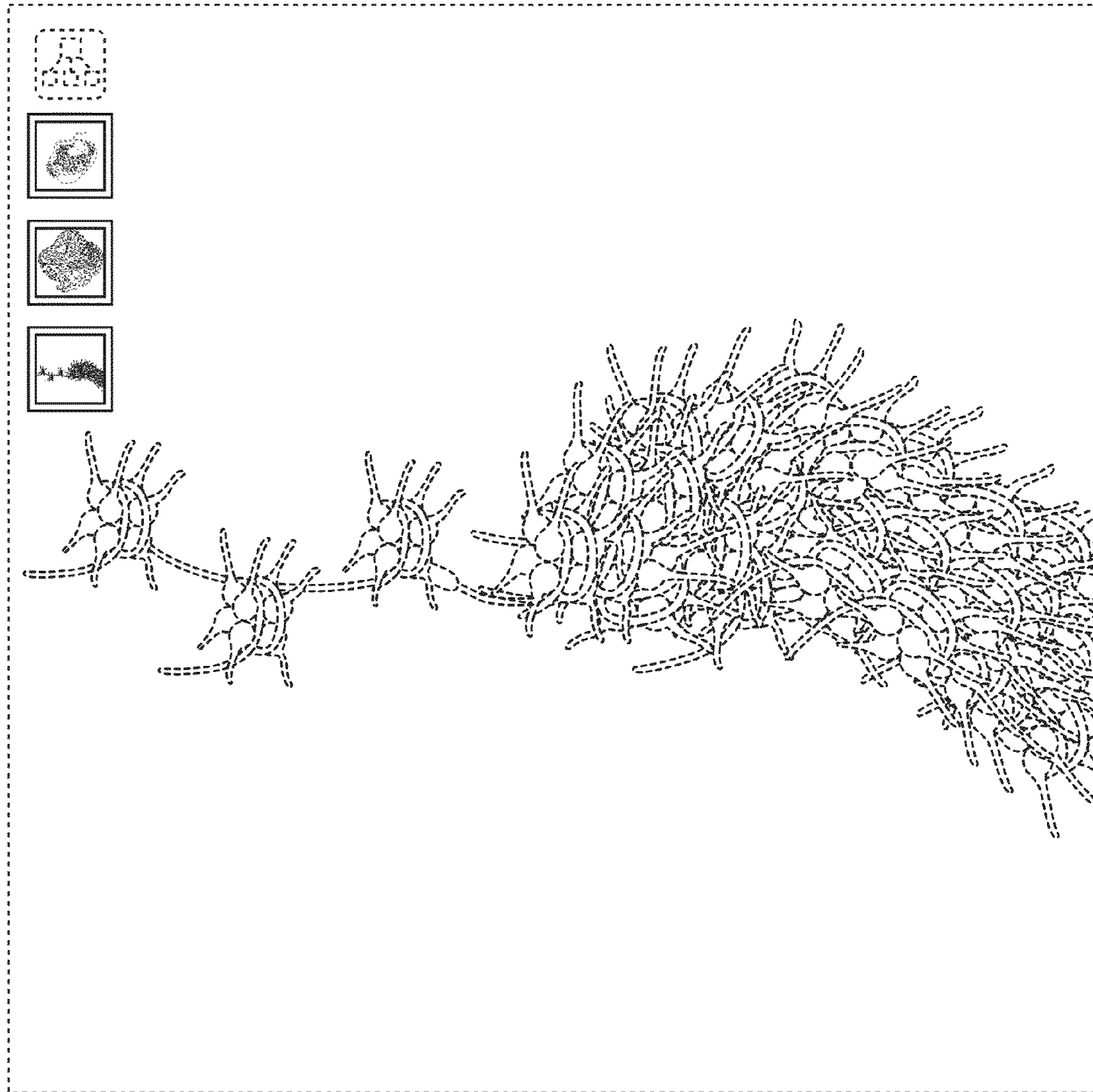
