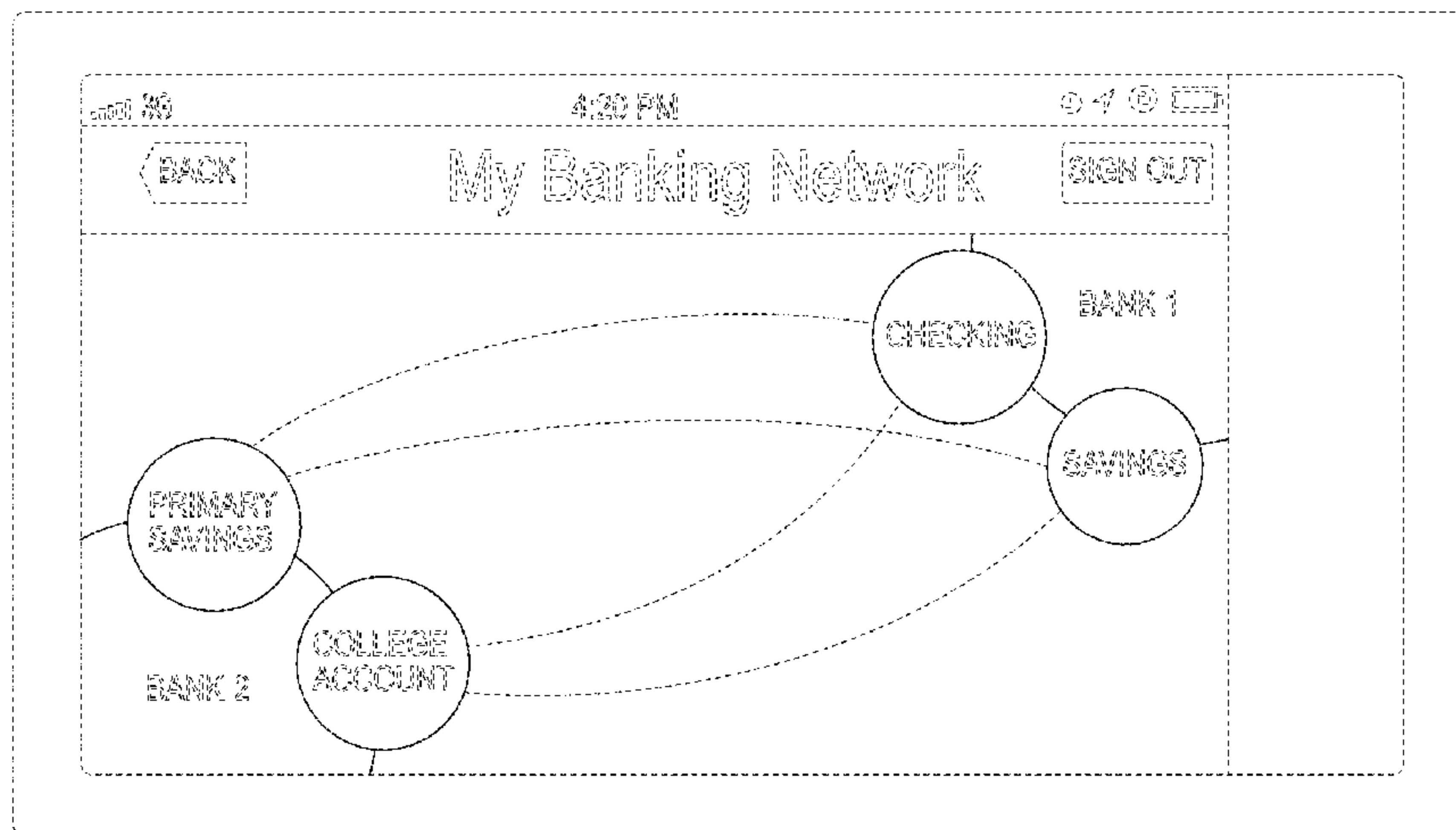
The ornamental design for a display screen for a communication device, as shown and described.
