The ornamental design for a display screen with graphical user interface for athletic achievements, as shown and described.

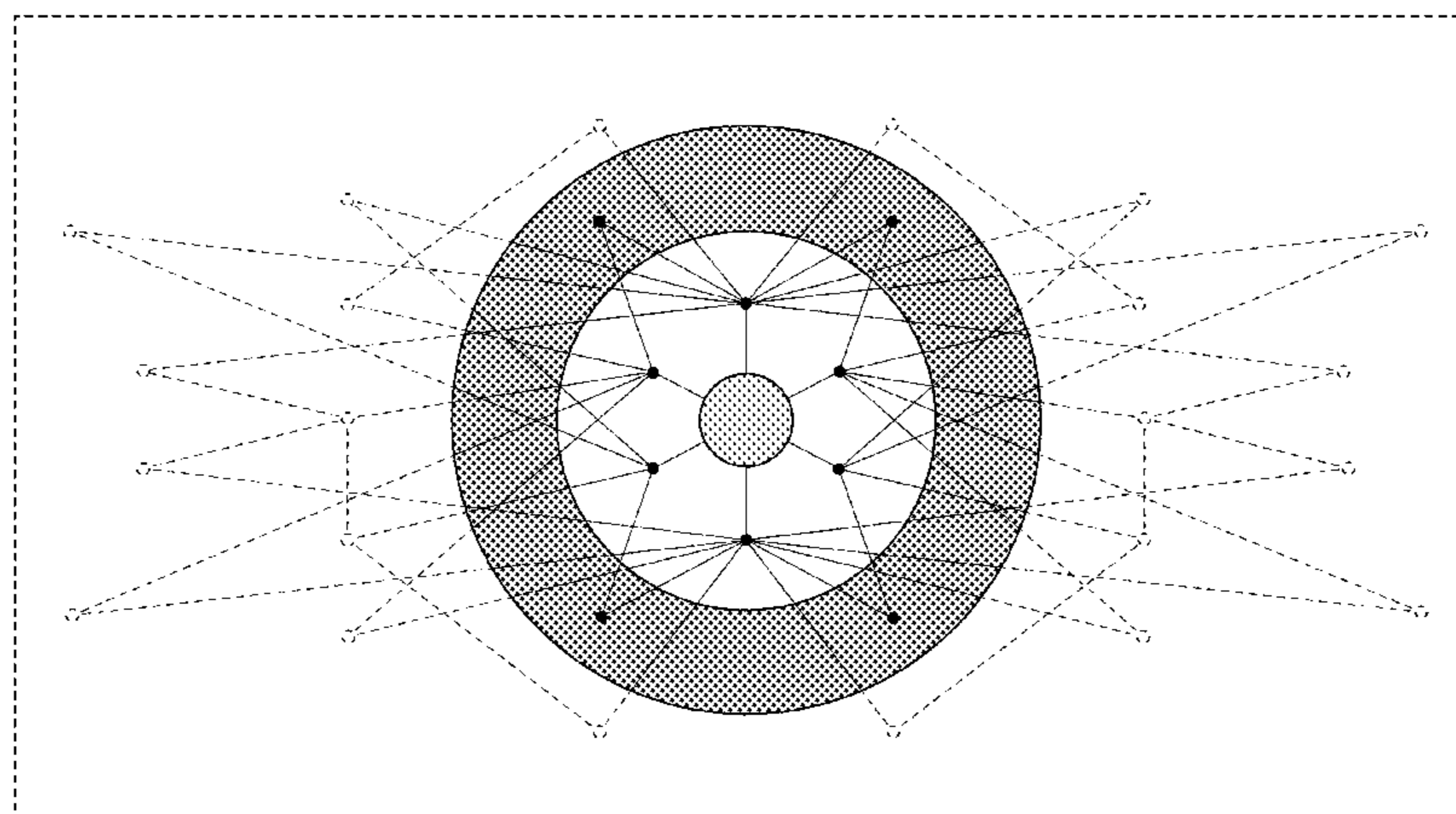
DESCRIPTION

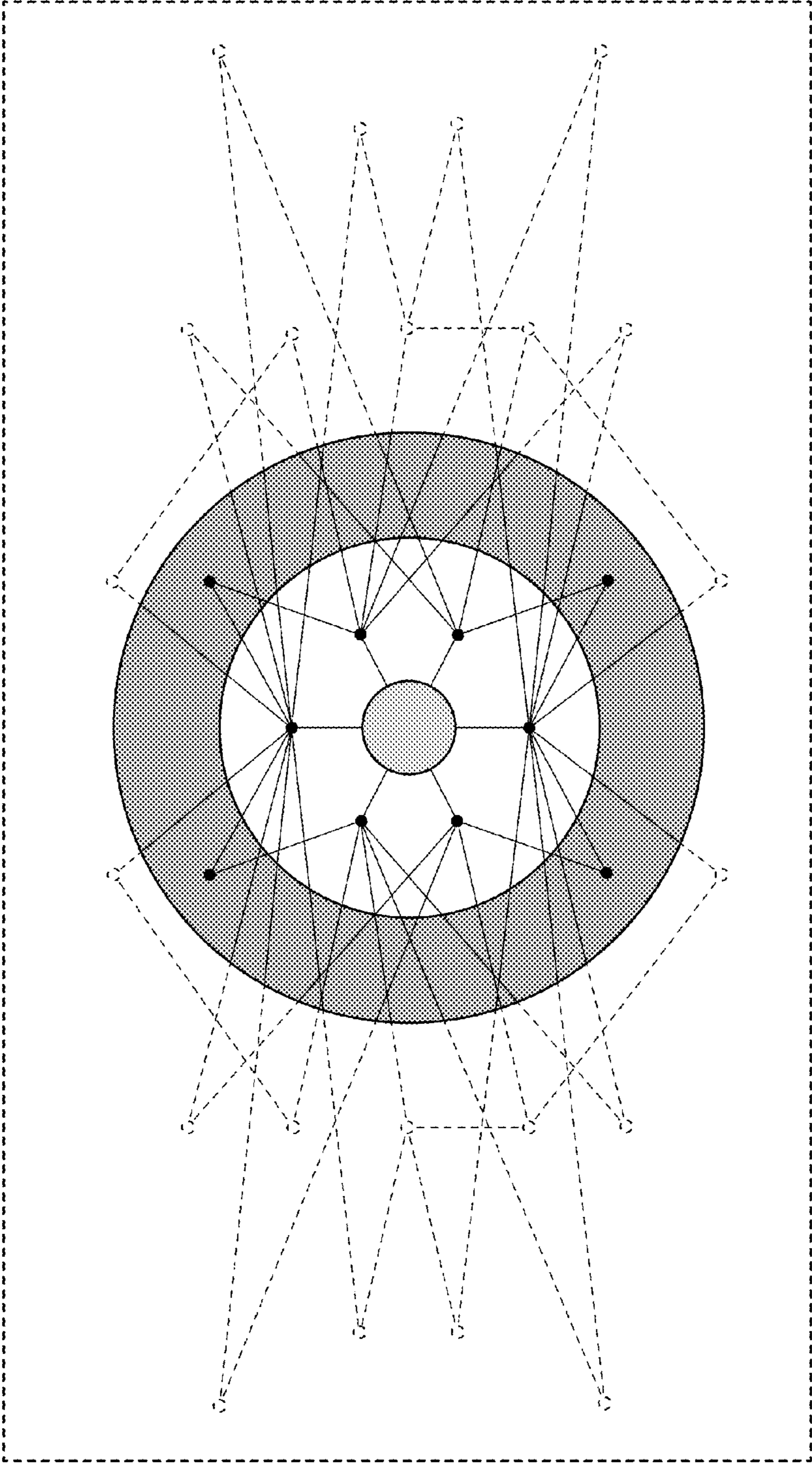

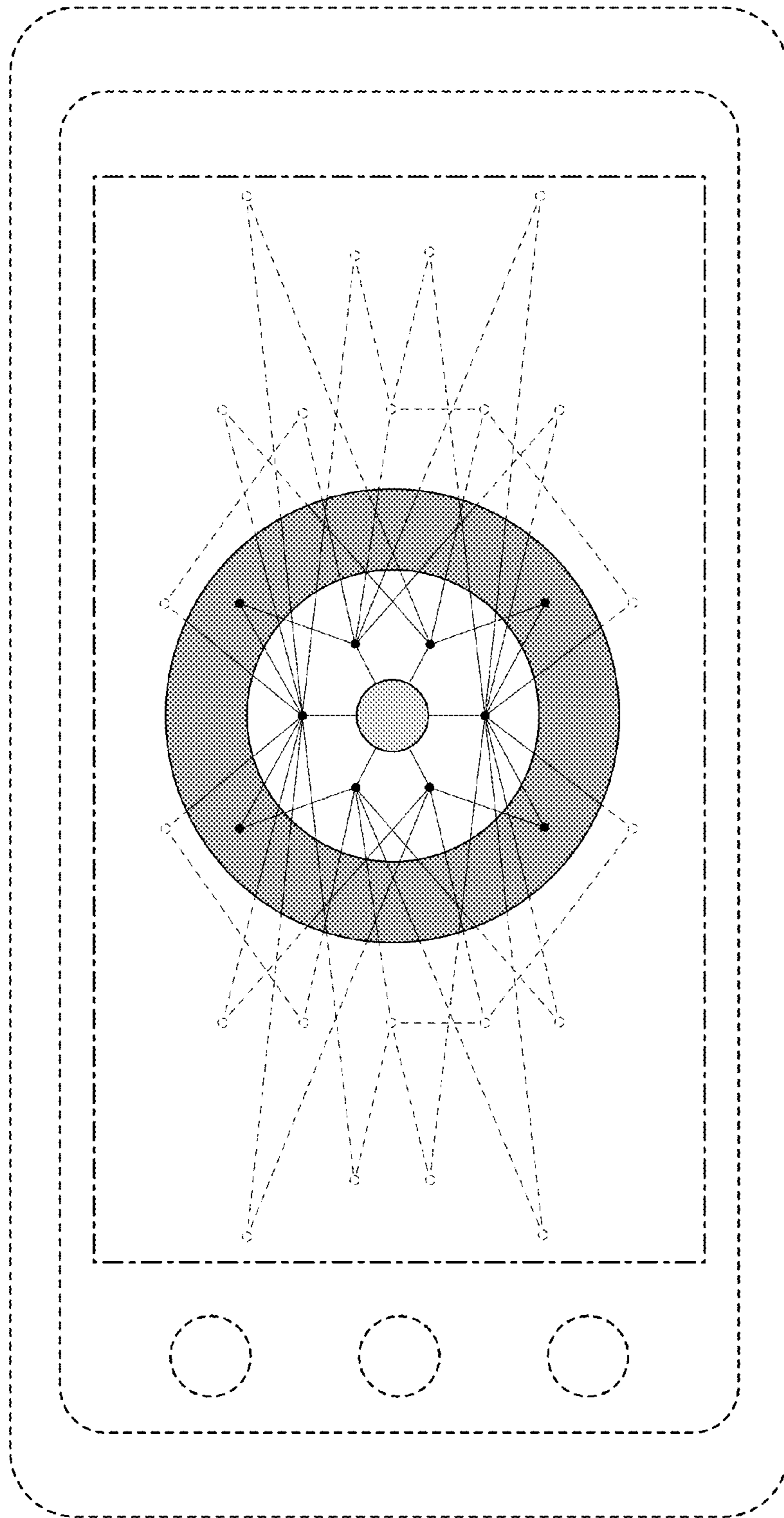
