**DESCRIPTION**

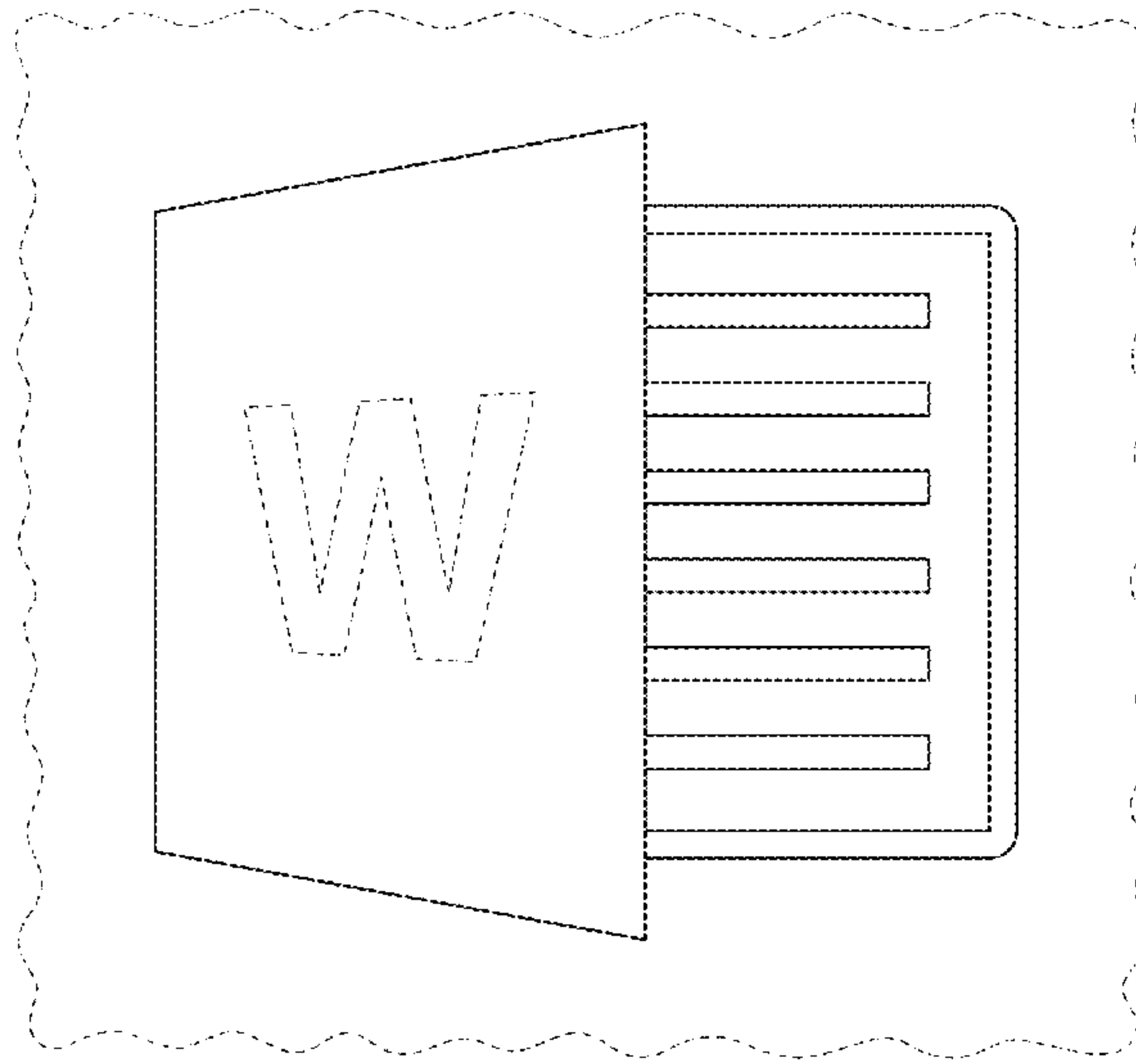
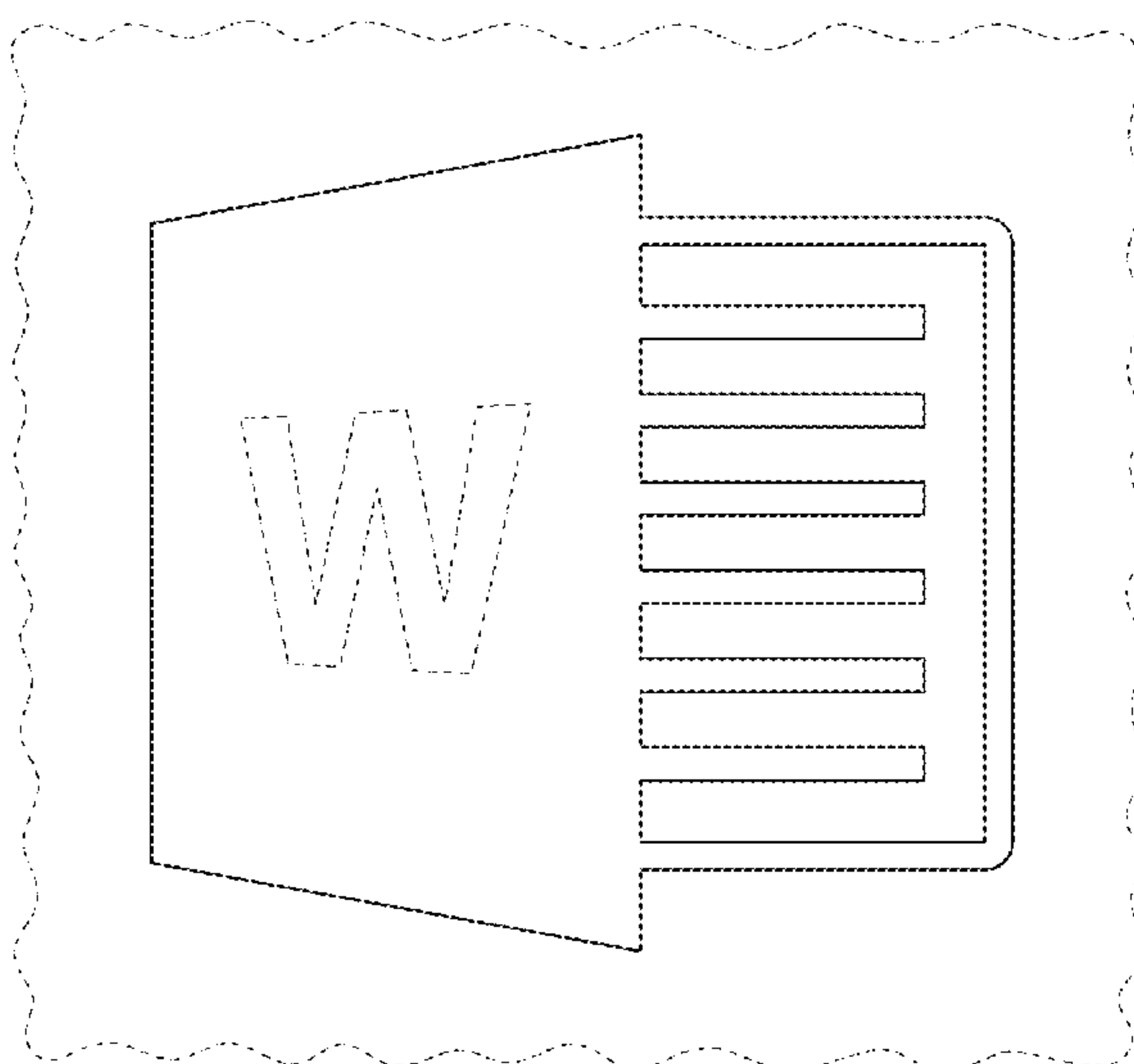

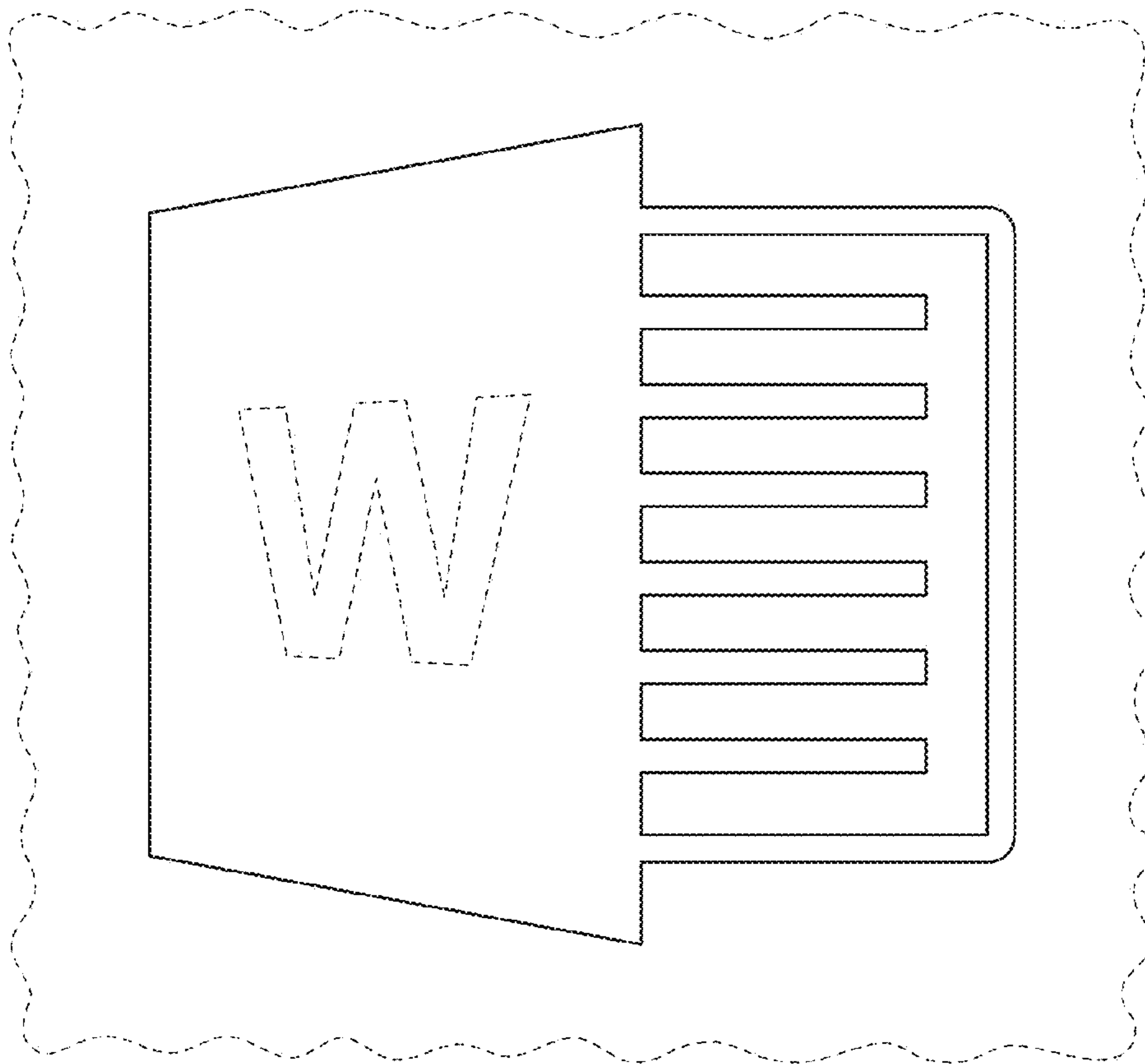

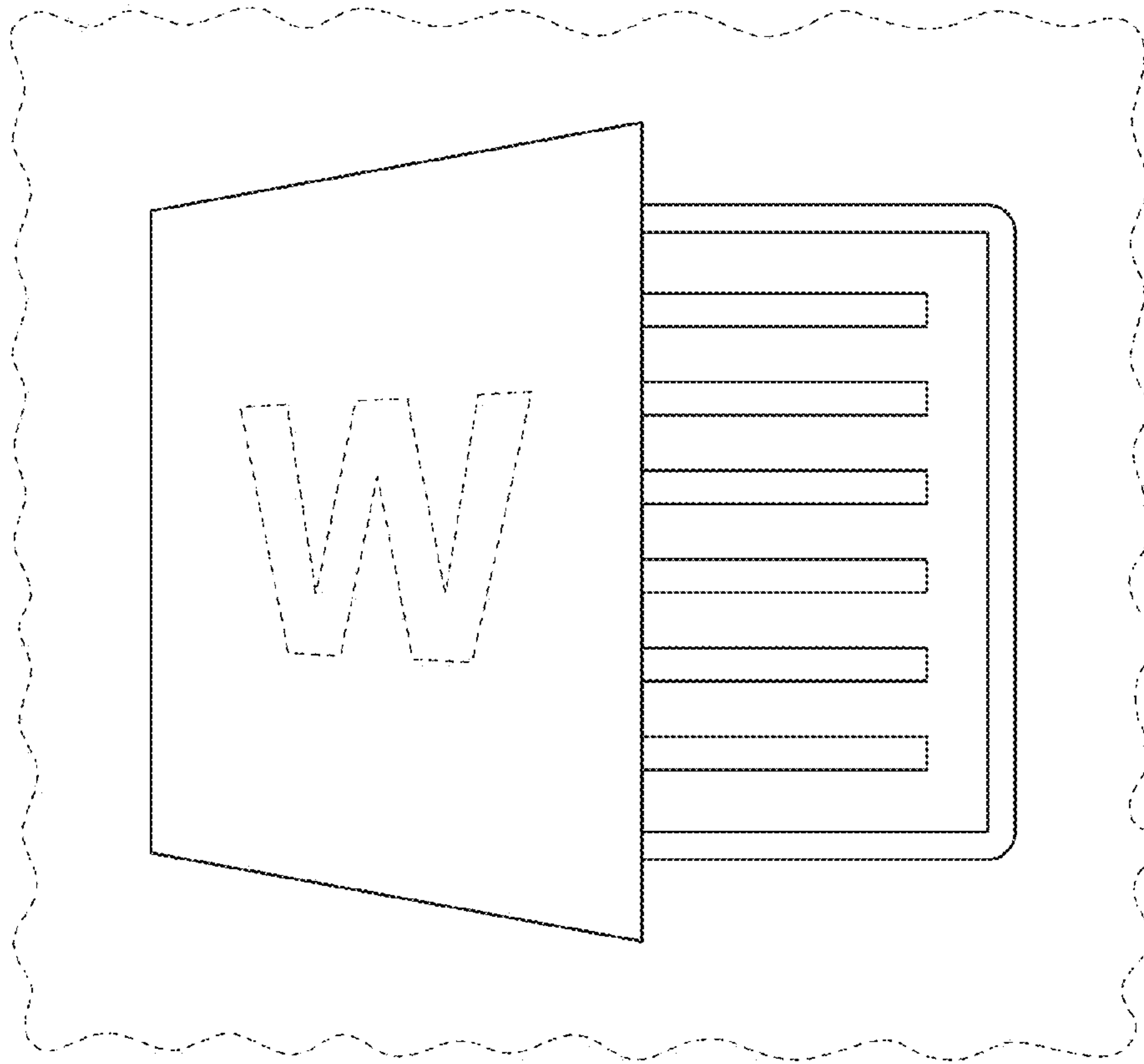
