(57) **CLAIM**

The ornamental design for a ripper cleat for a compactor wheel, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a ripper cleat for a compactor wheel showing my new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a right side elevational view thereof, the left side being a mirror image of this view; FIG. 6 is a rear elevational view thereof; and, FIG. 7 is a bottom plan view thereof.

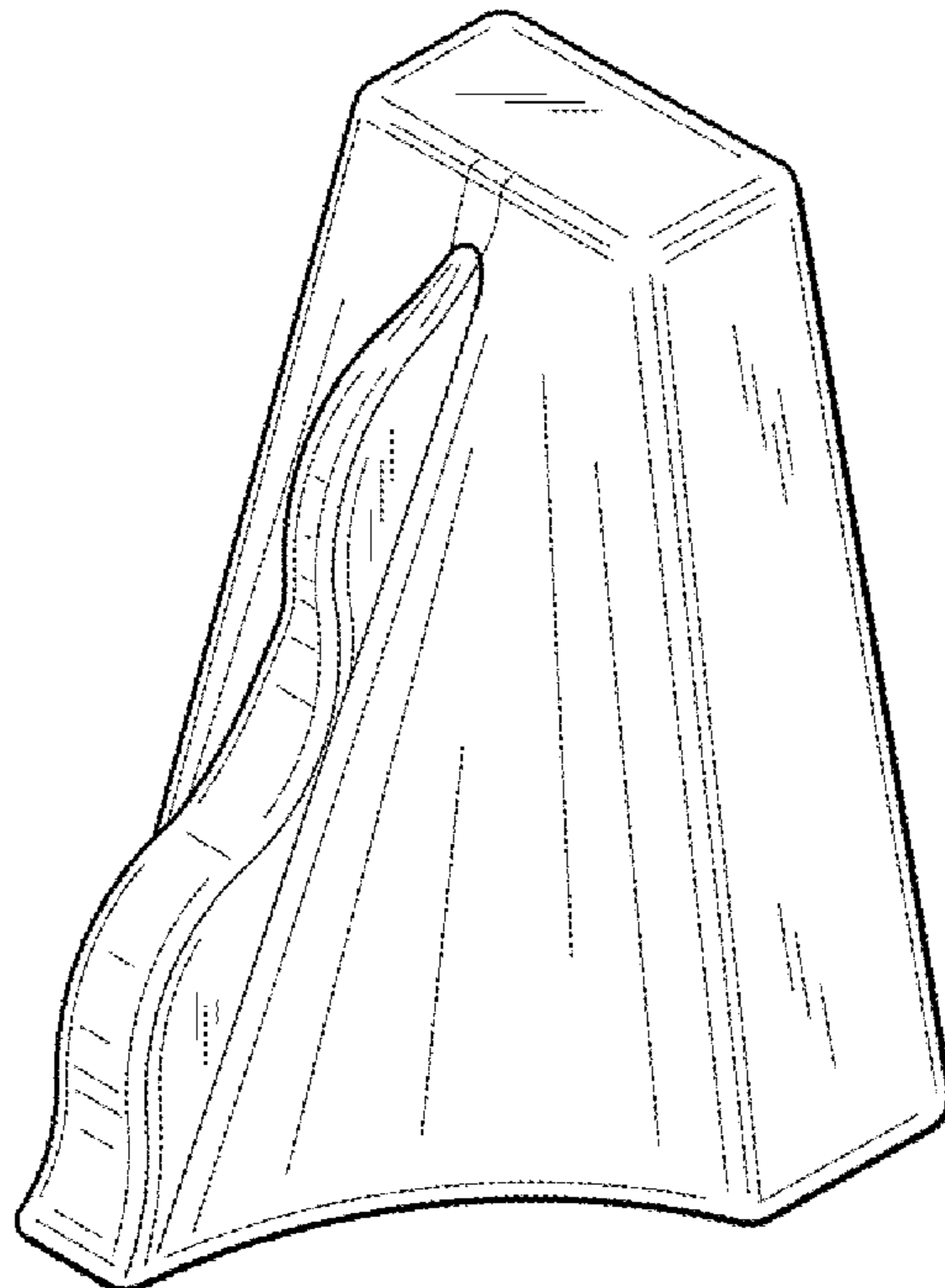

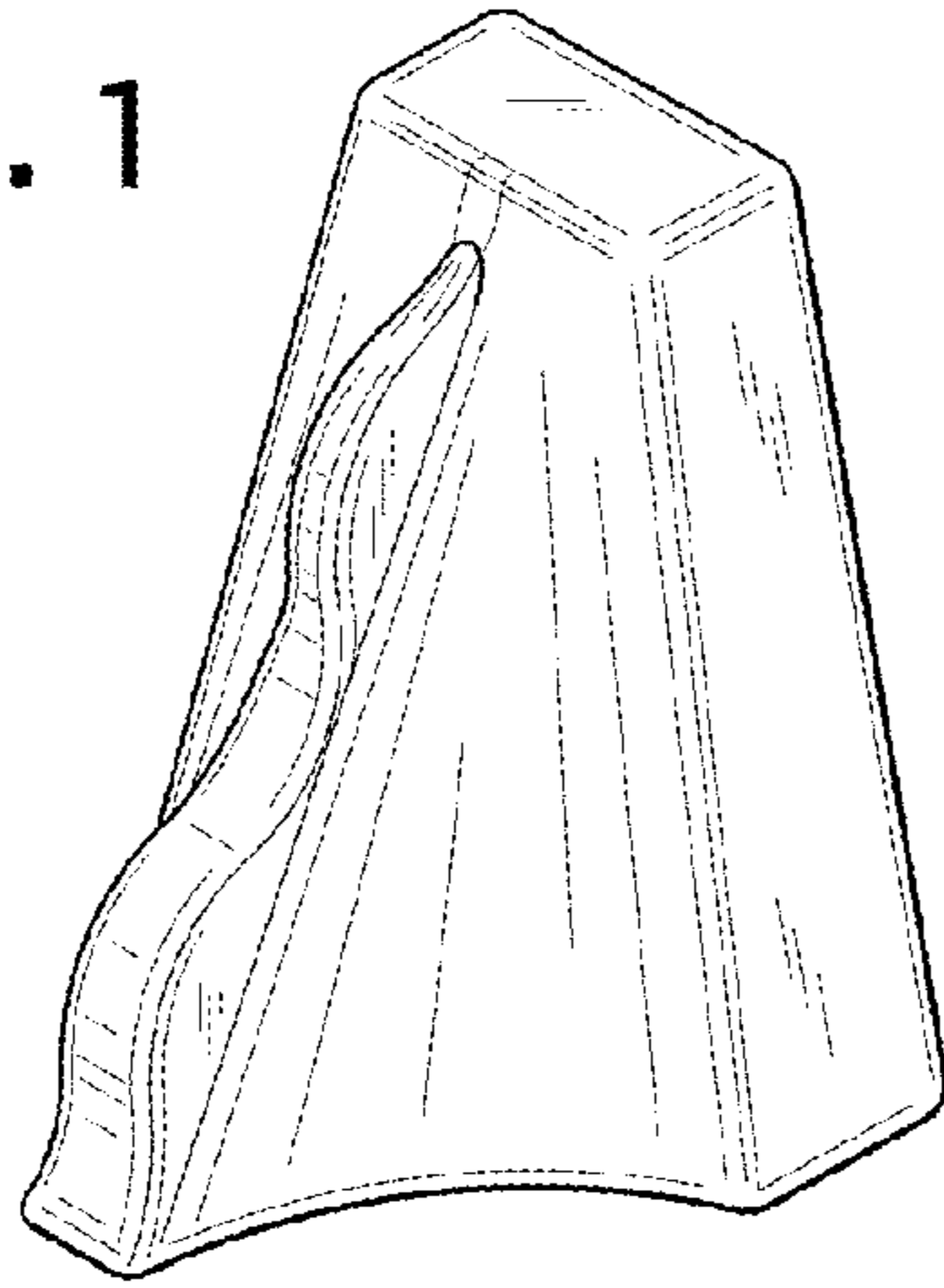

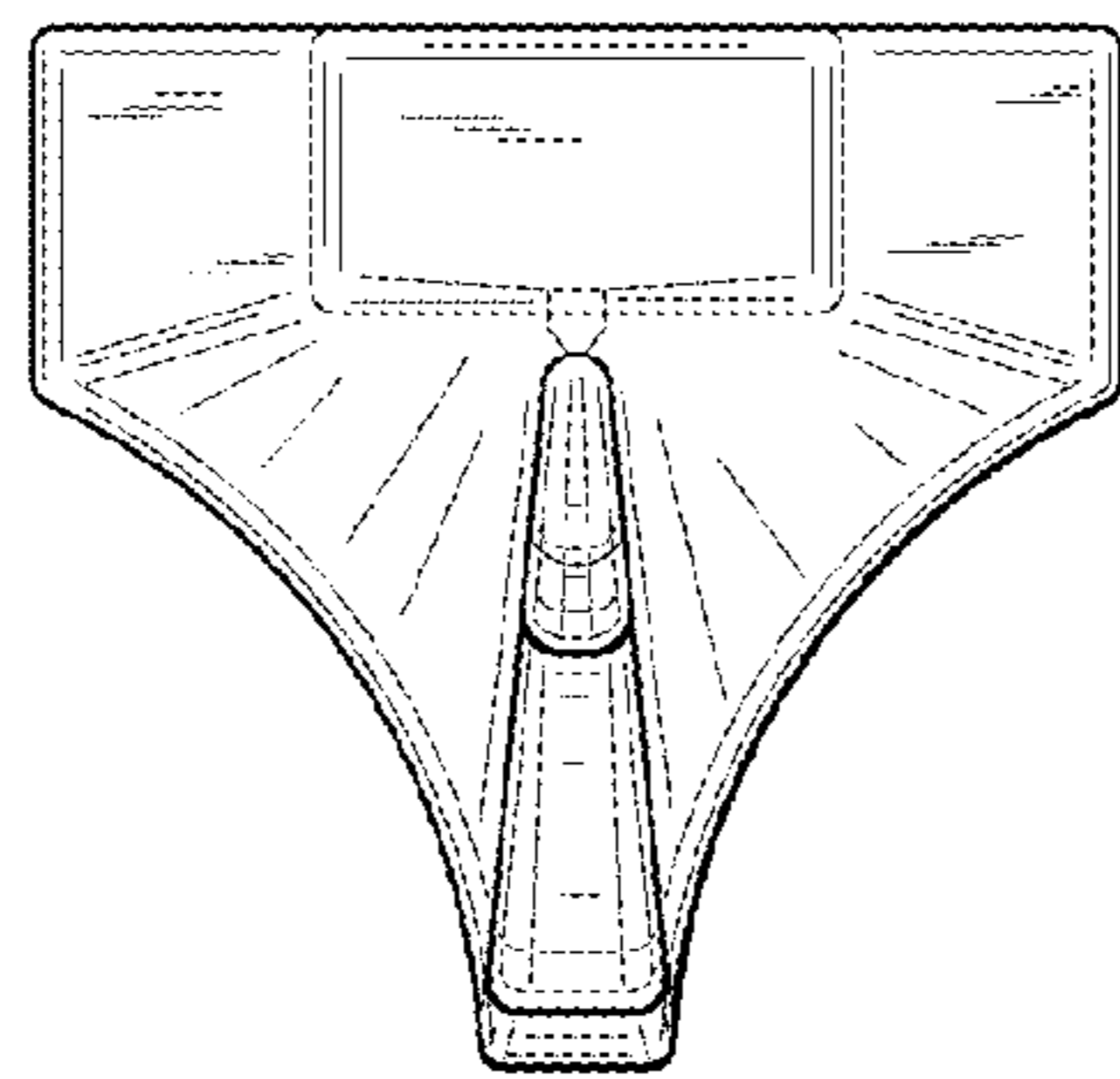
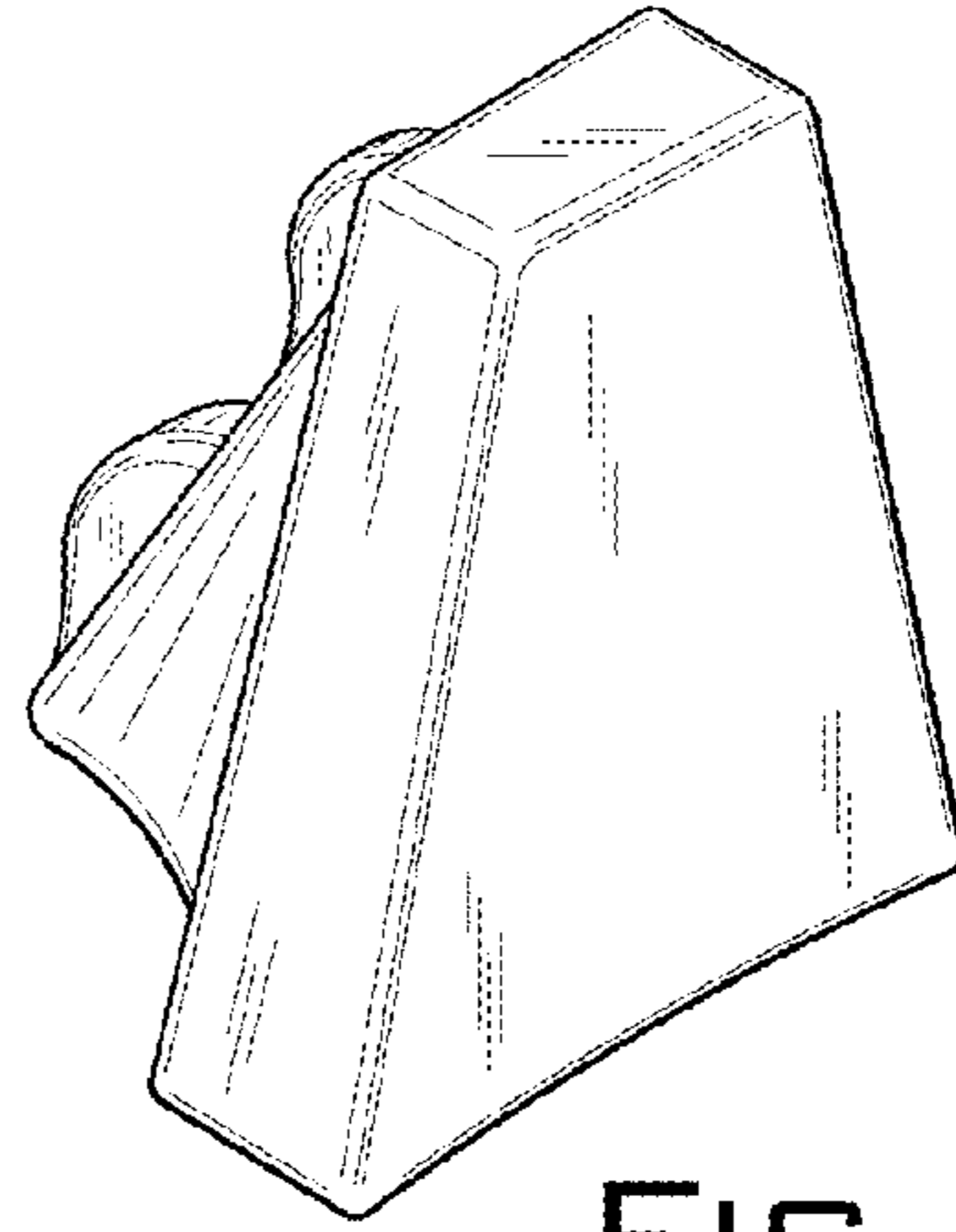

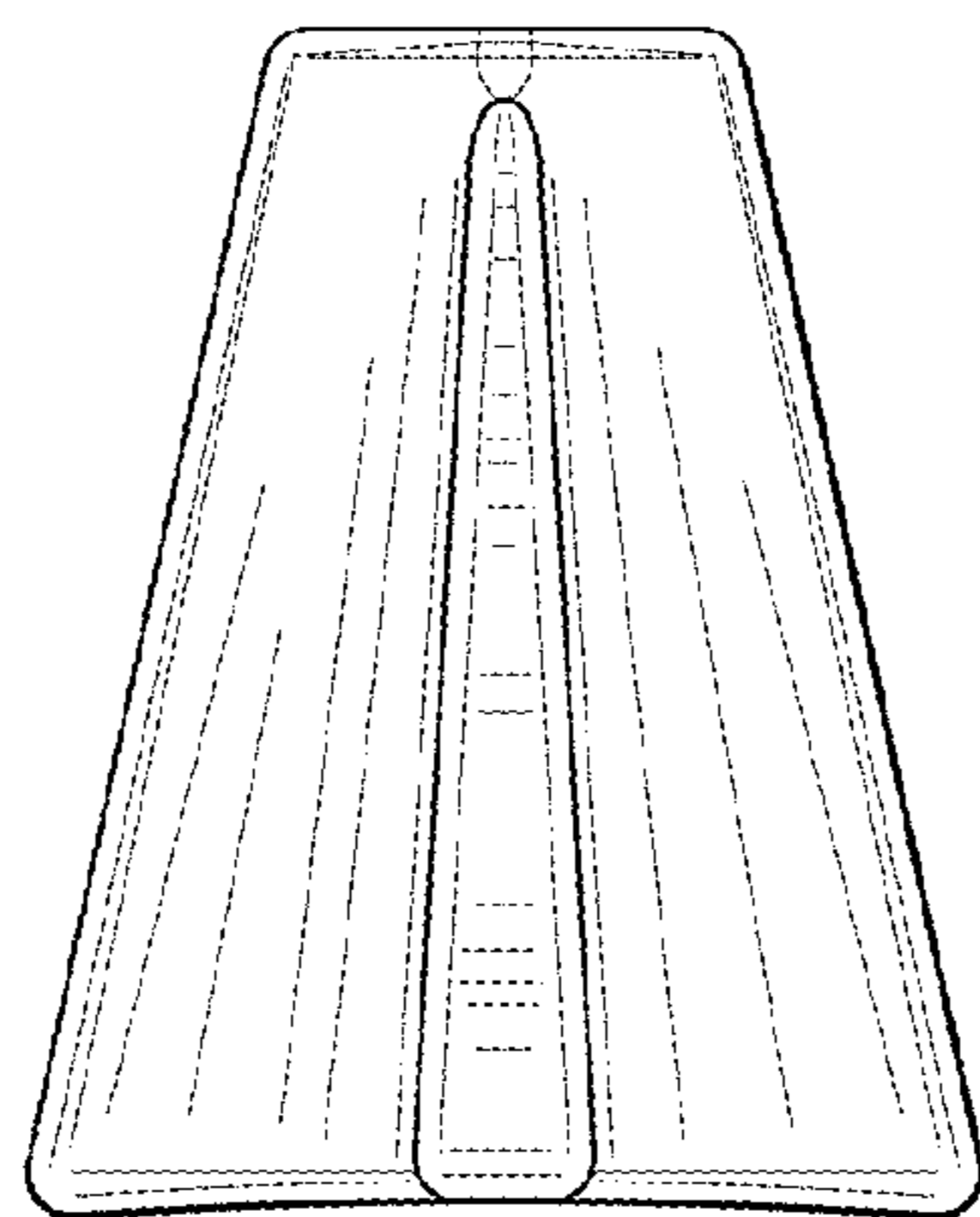

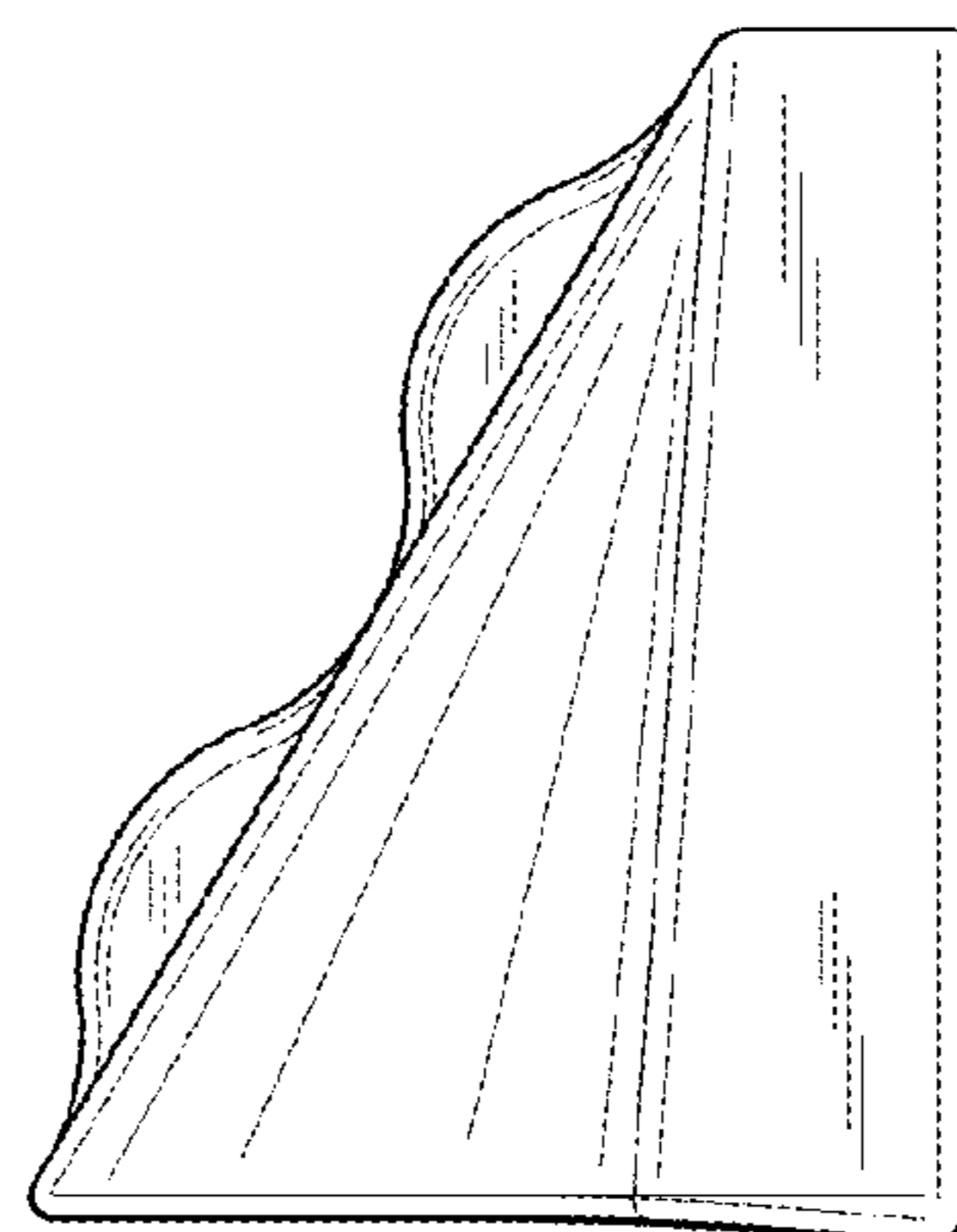

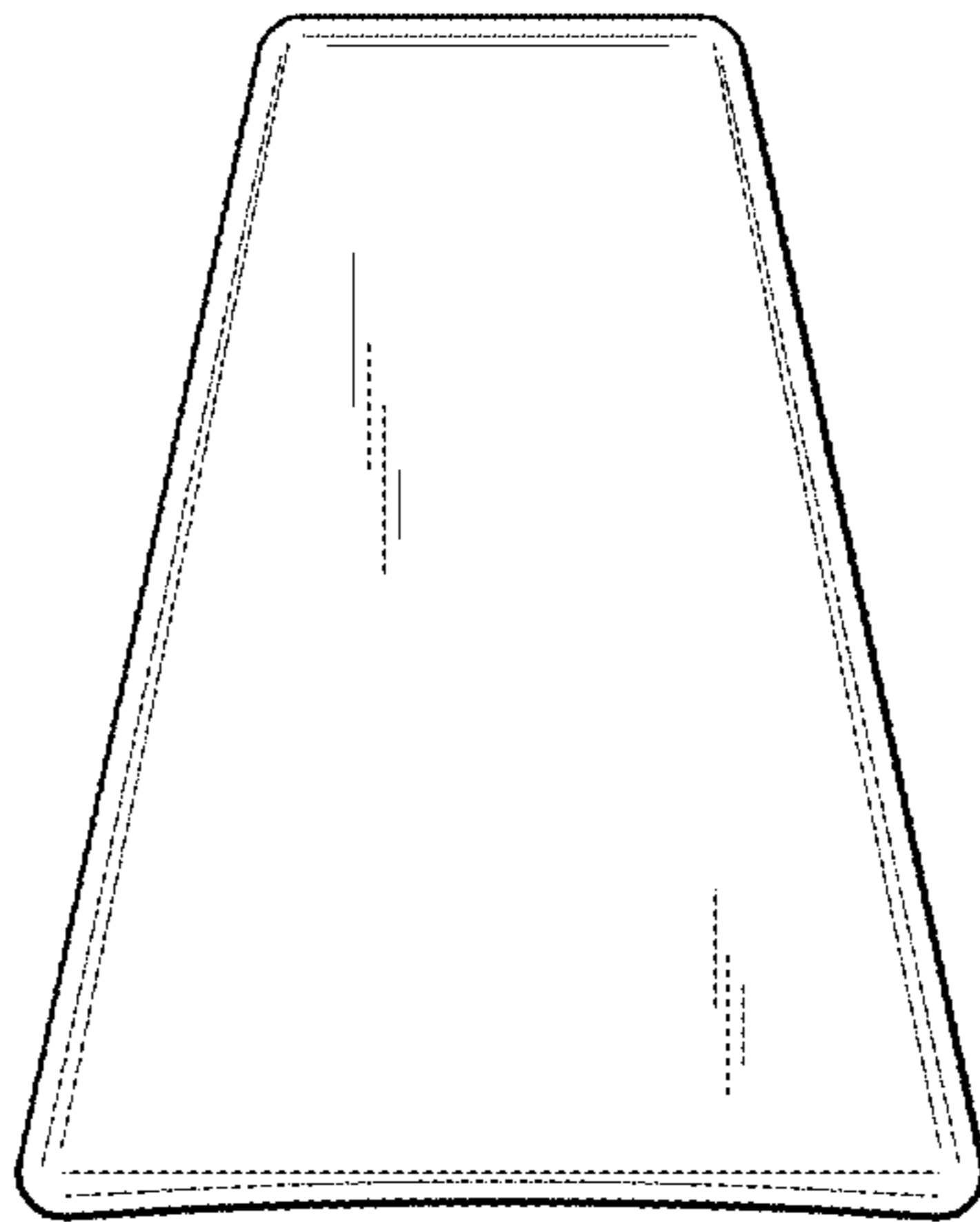

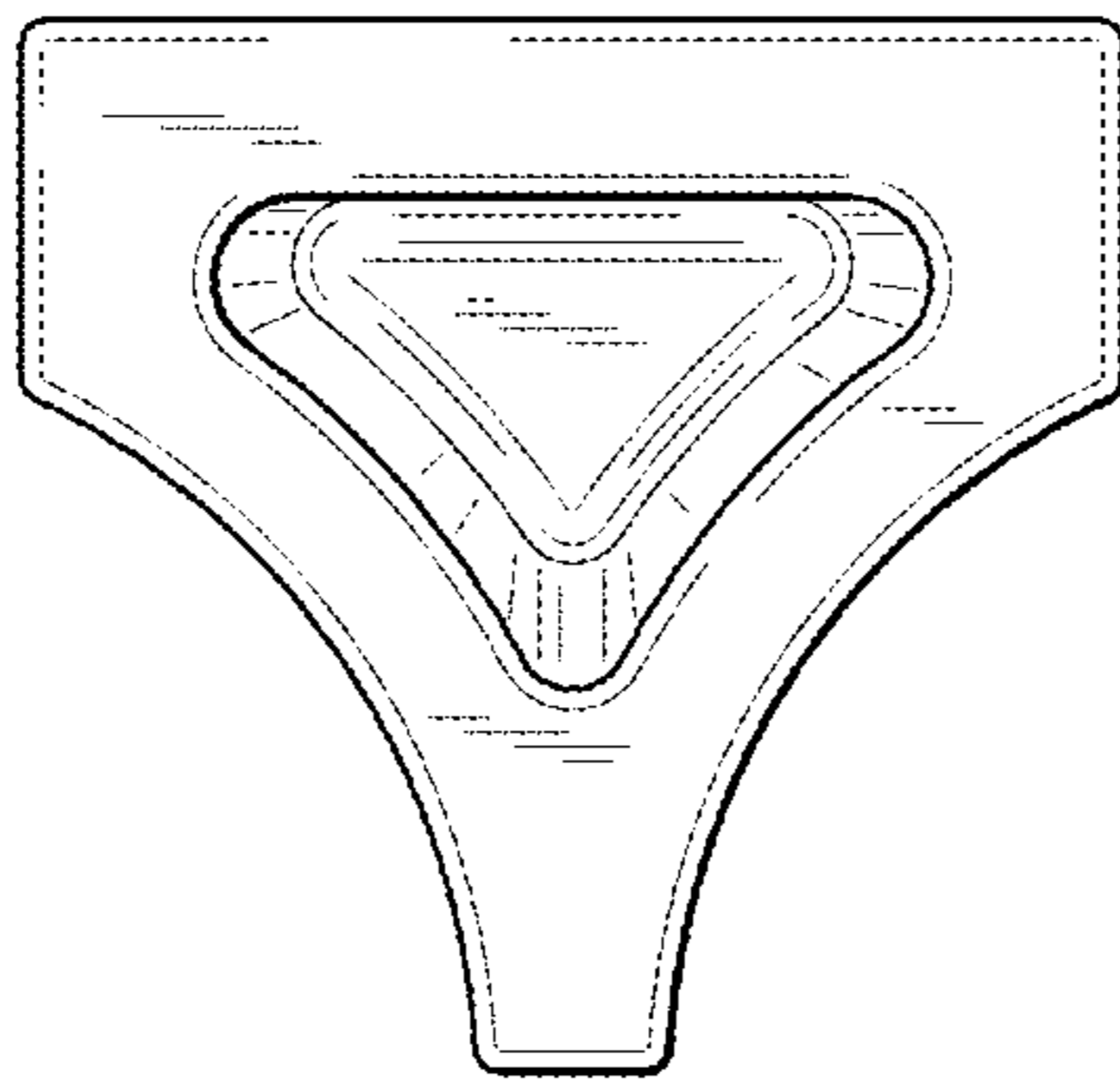
