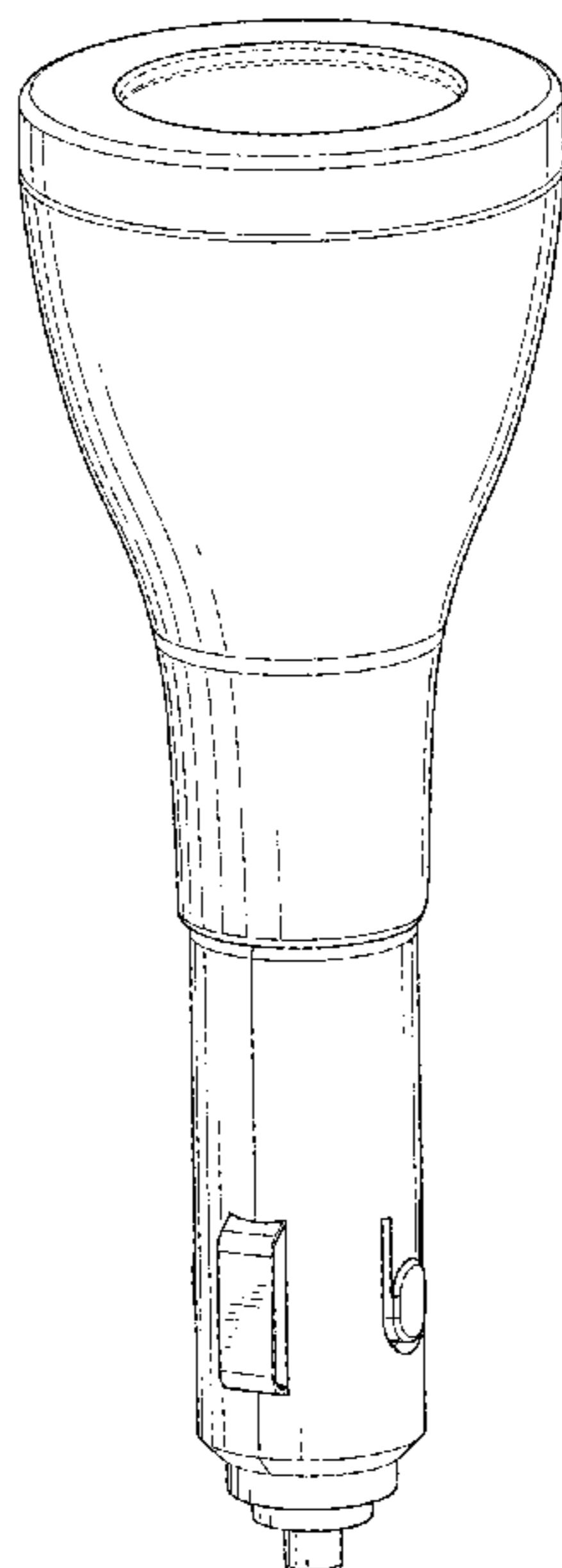
The ornamental design for an angle-adjustable aroma diffusing apparatus, as shown and described.

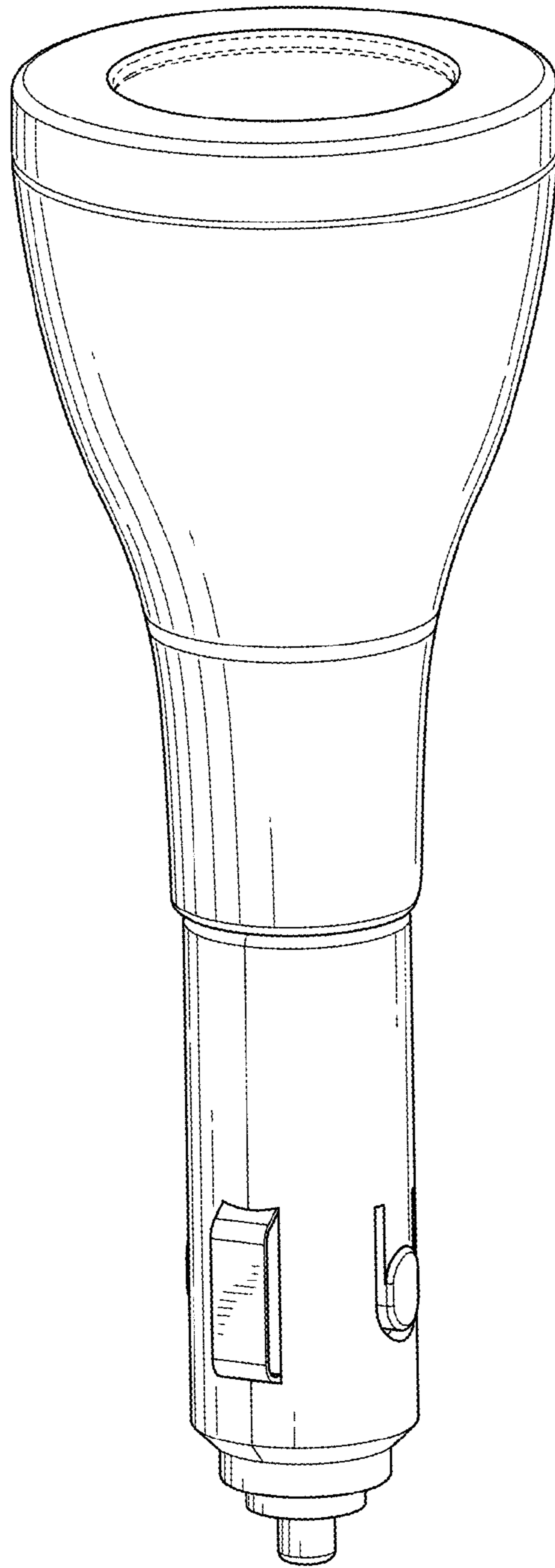

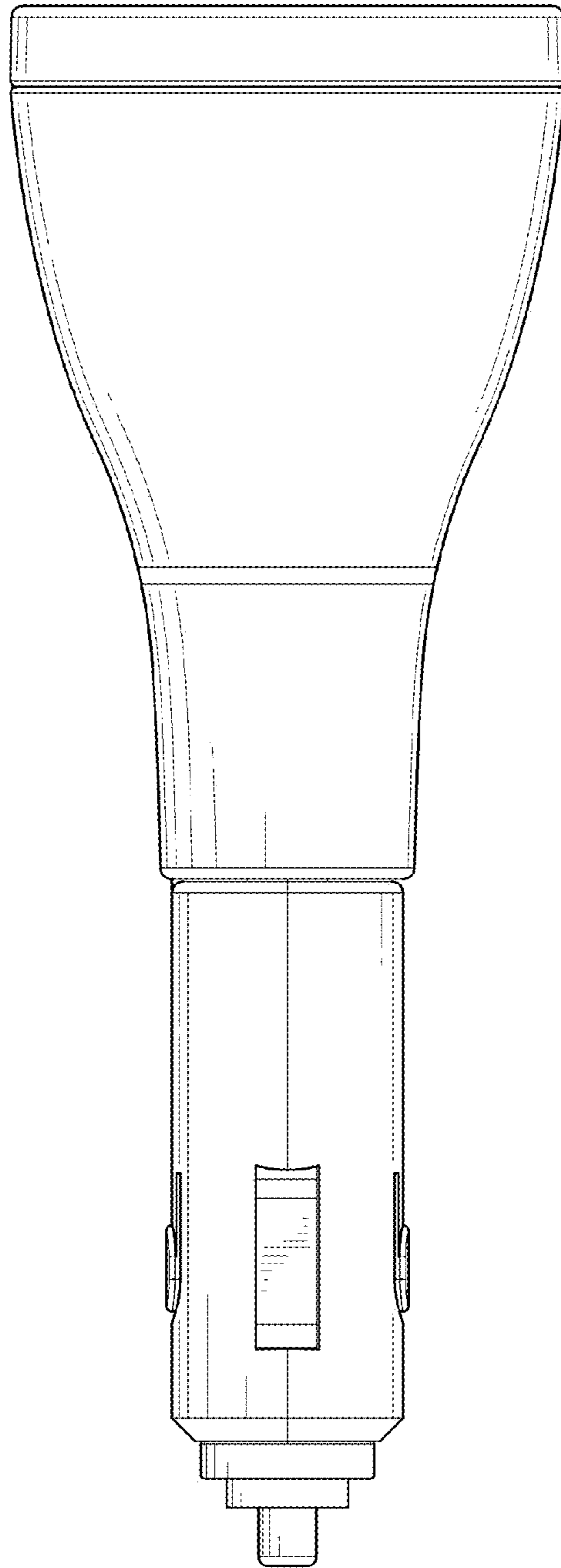

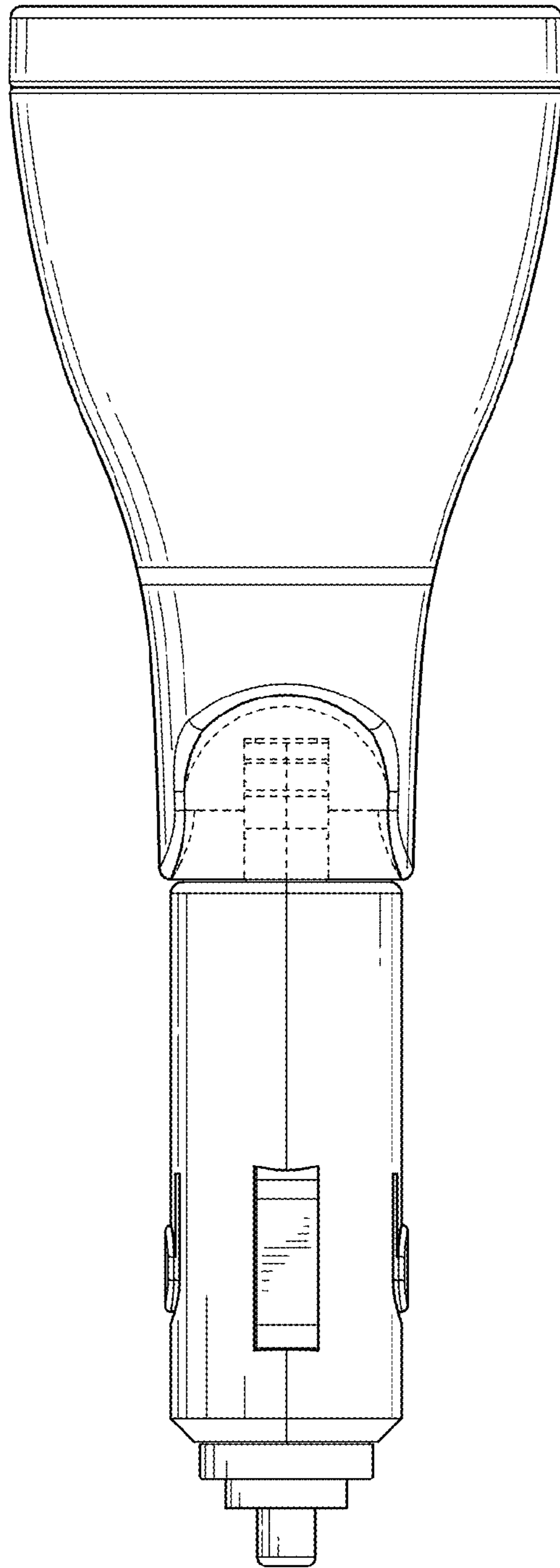

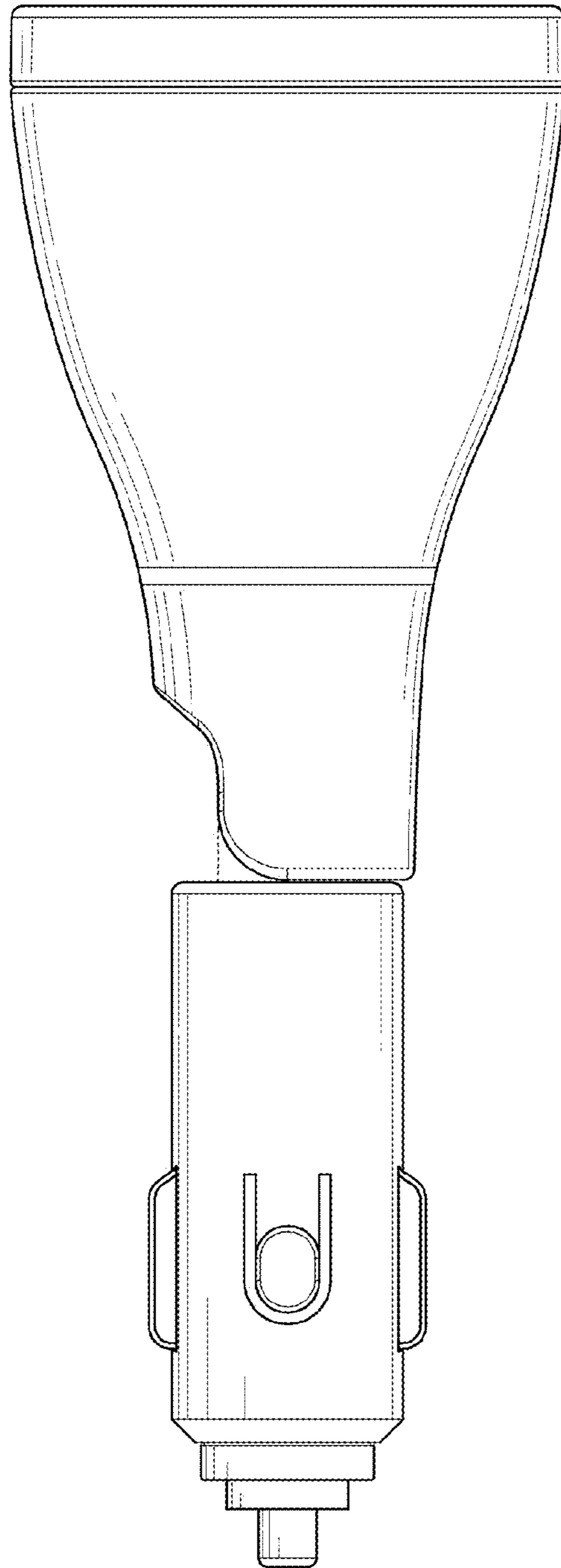

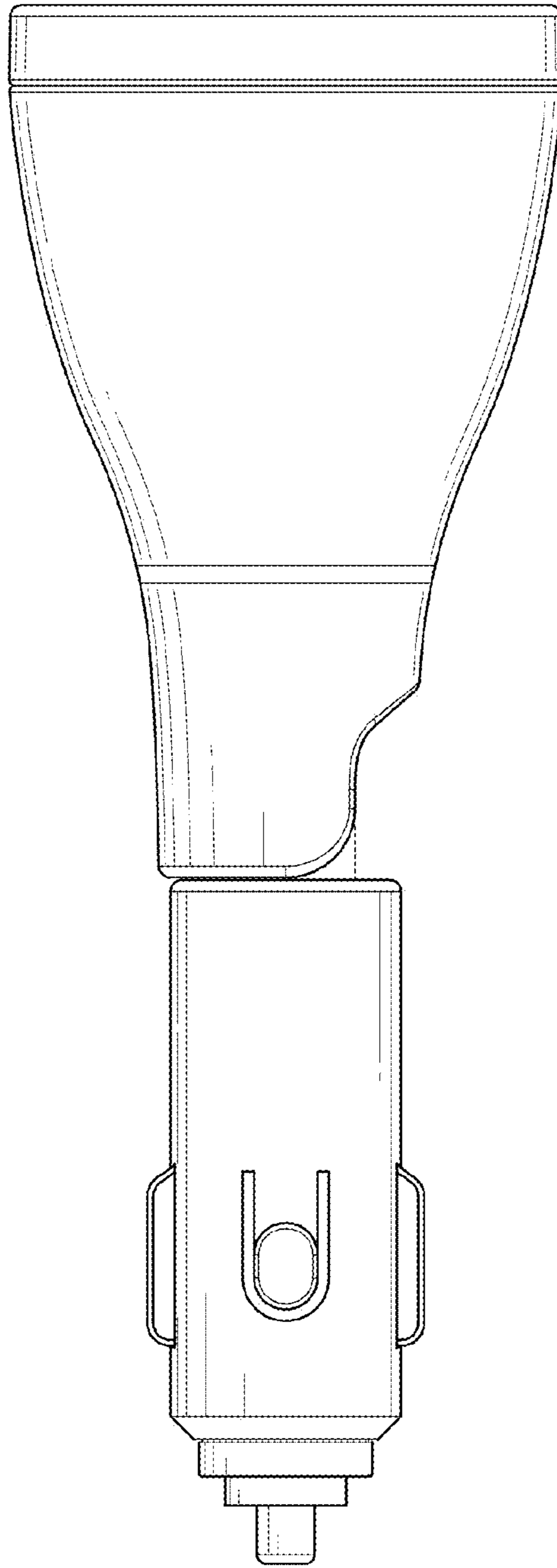

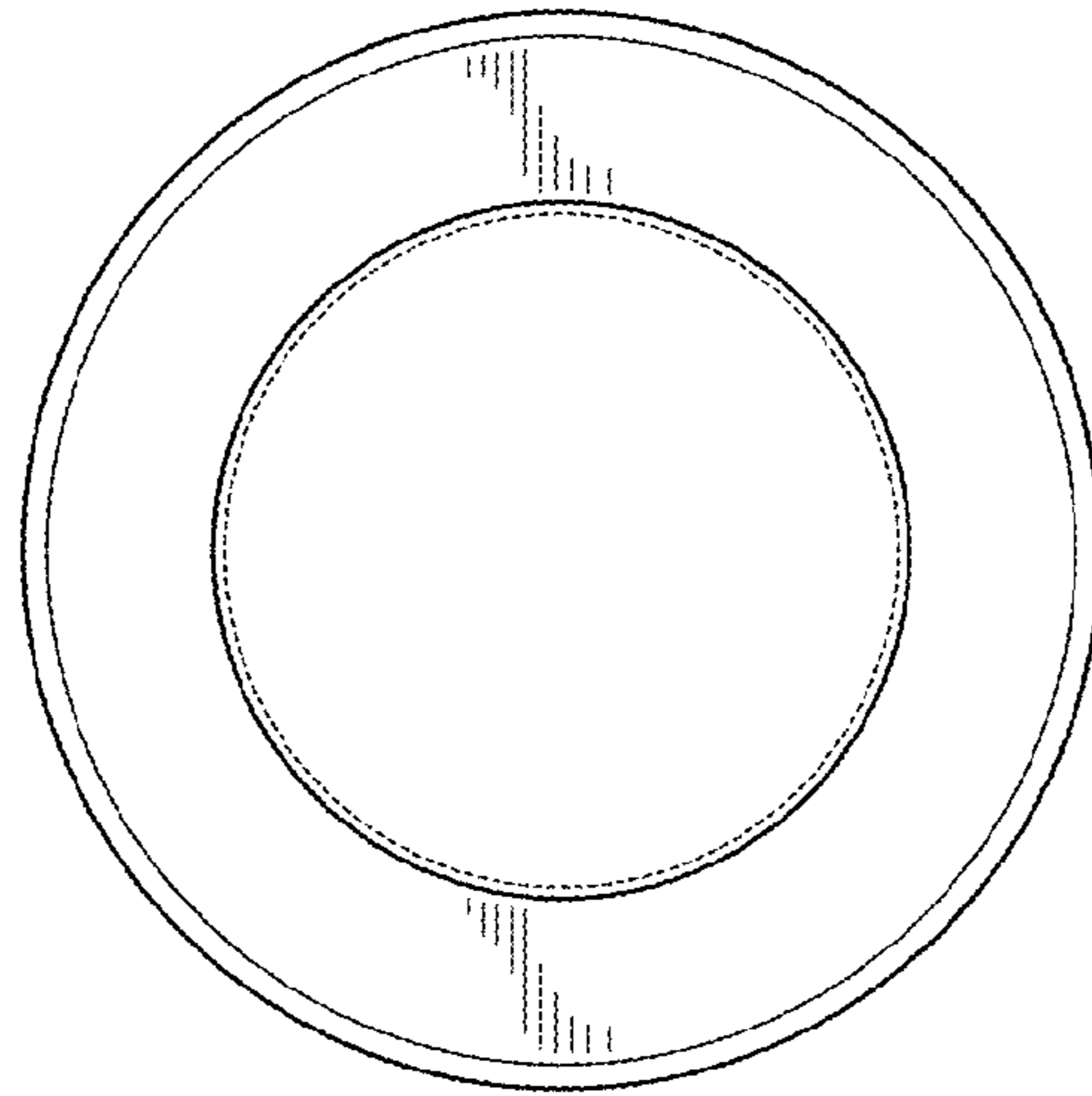

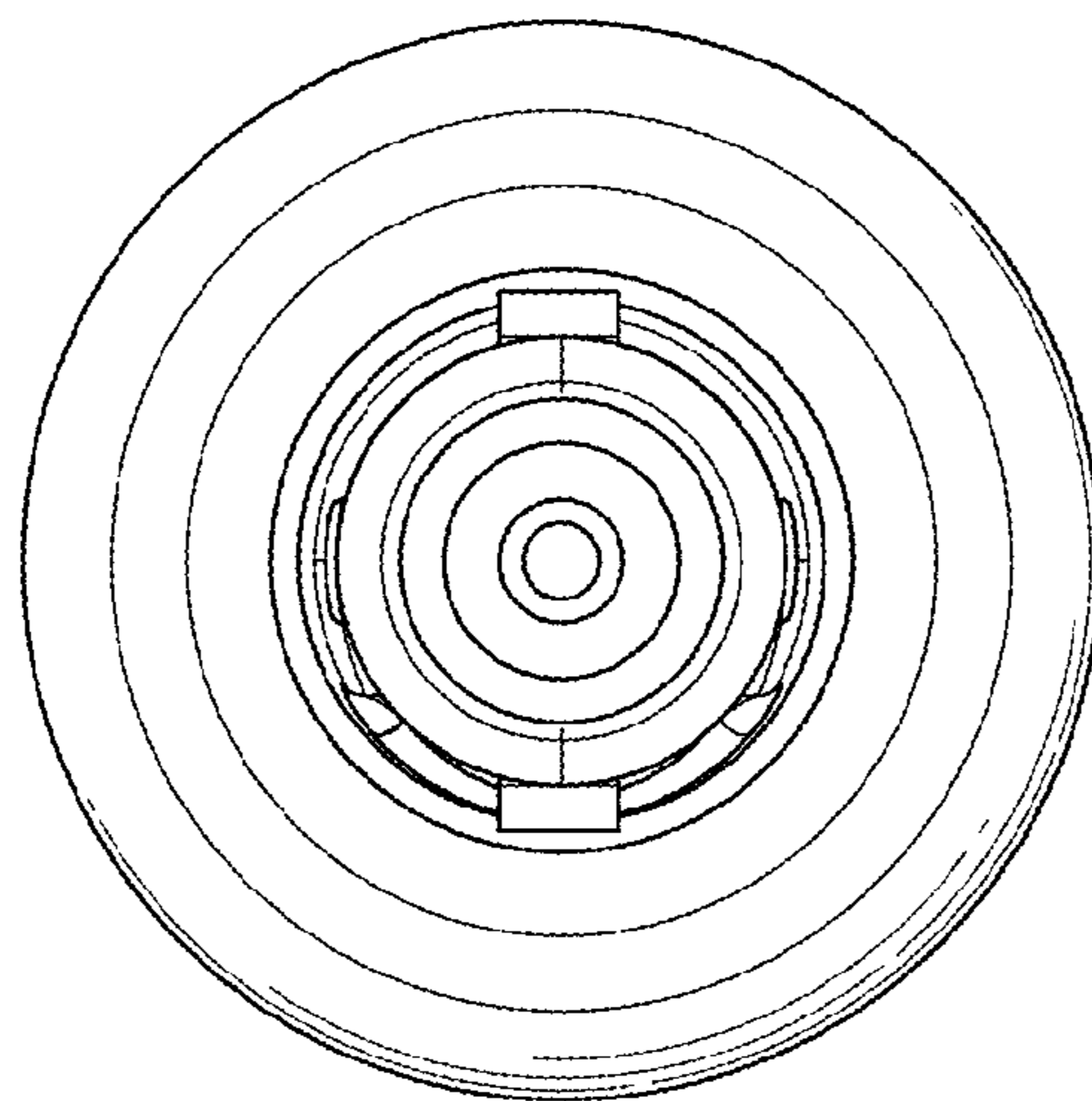
