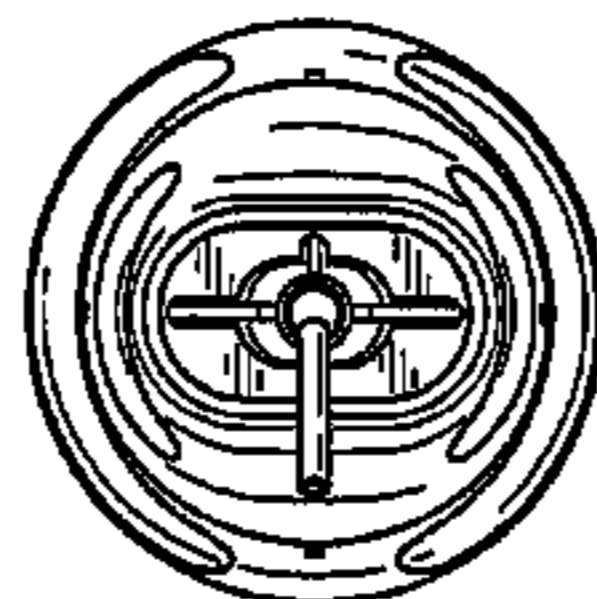
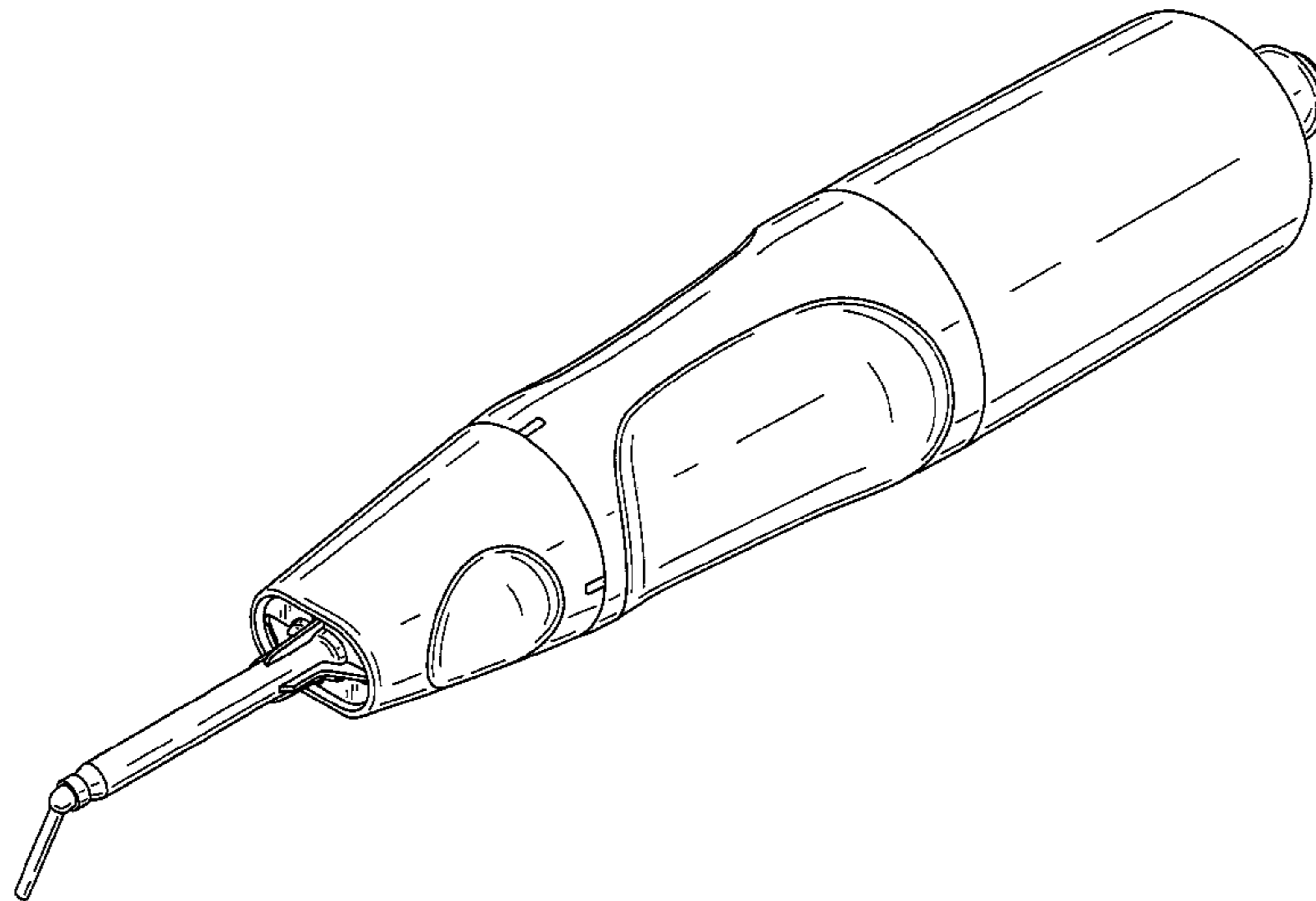
FIG. 1 is an isometric view of a dental material dispenser showing our new design;

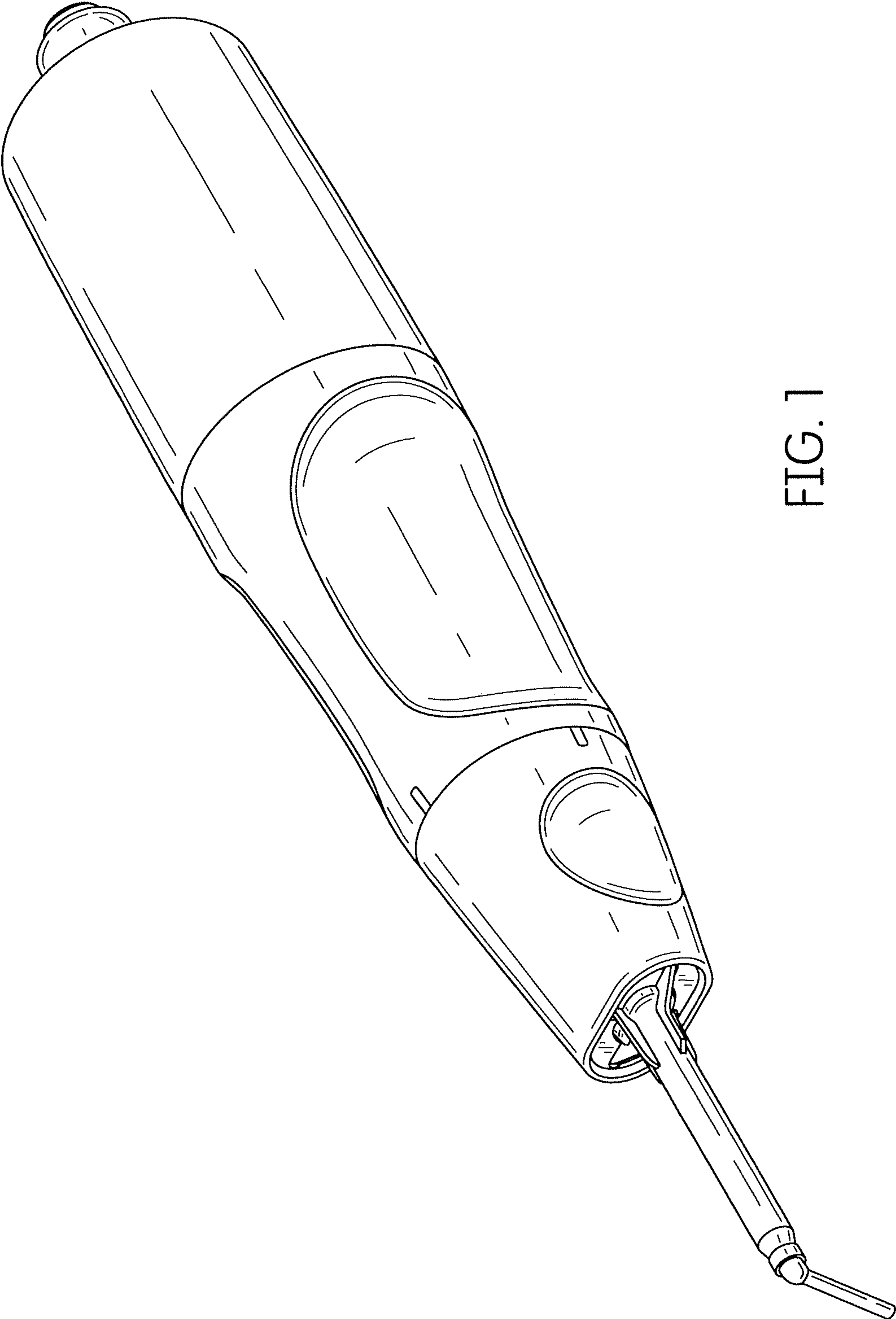

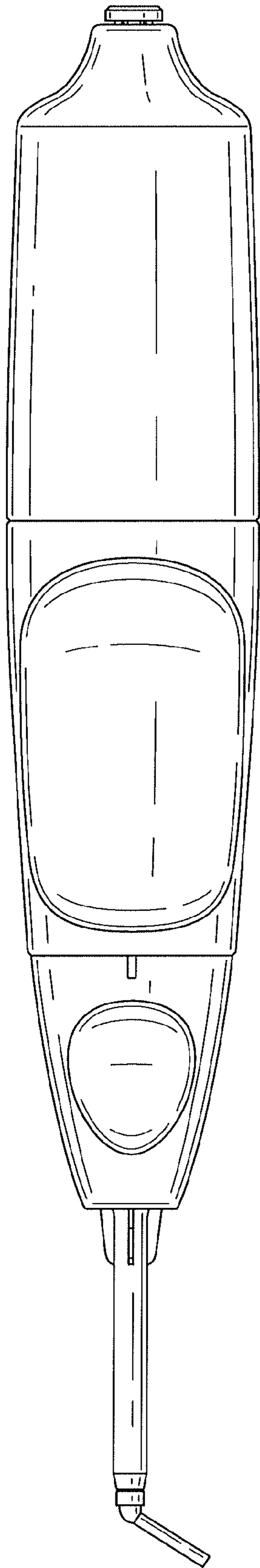

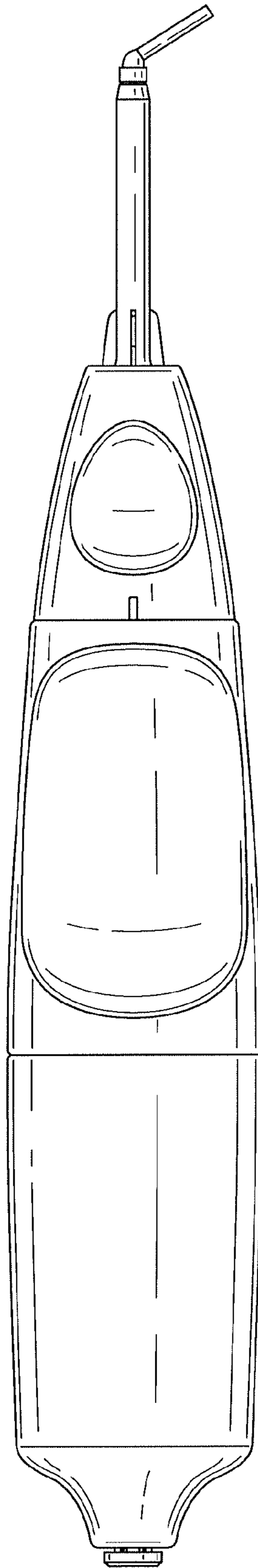

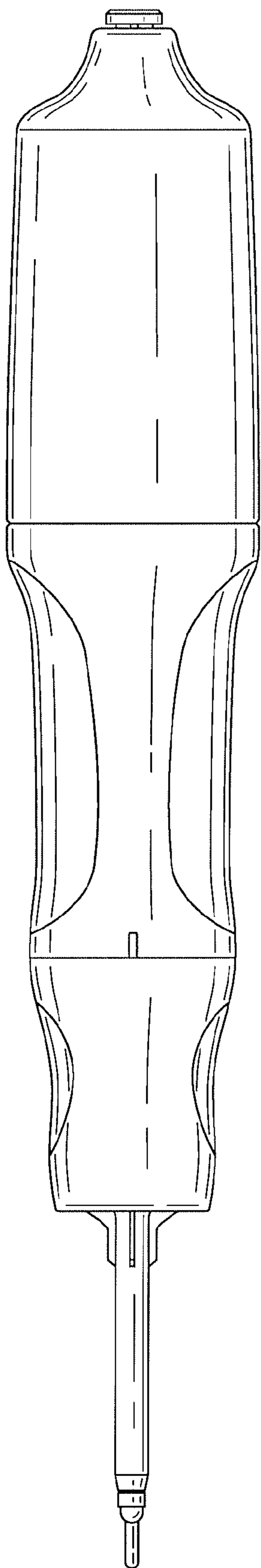

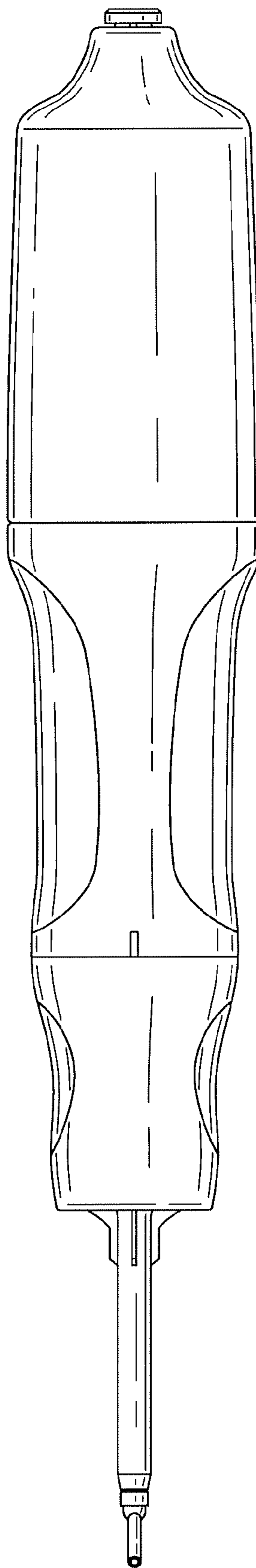

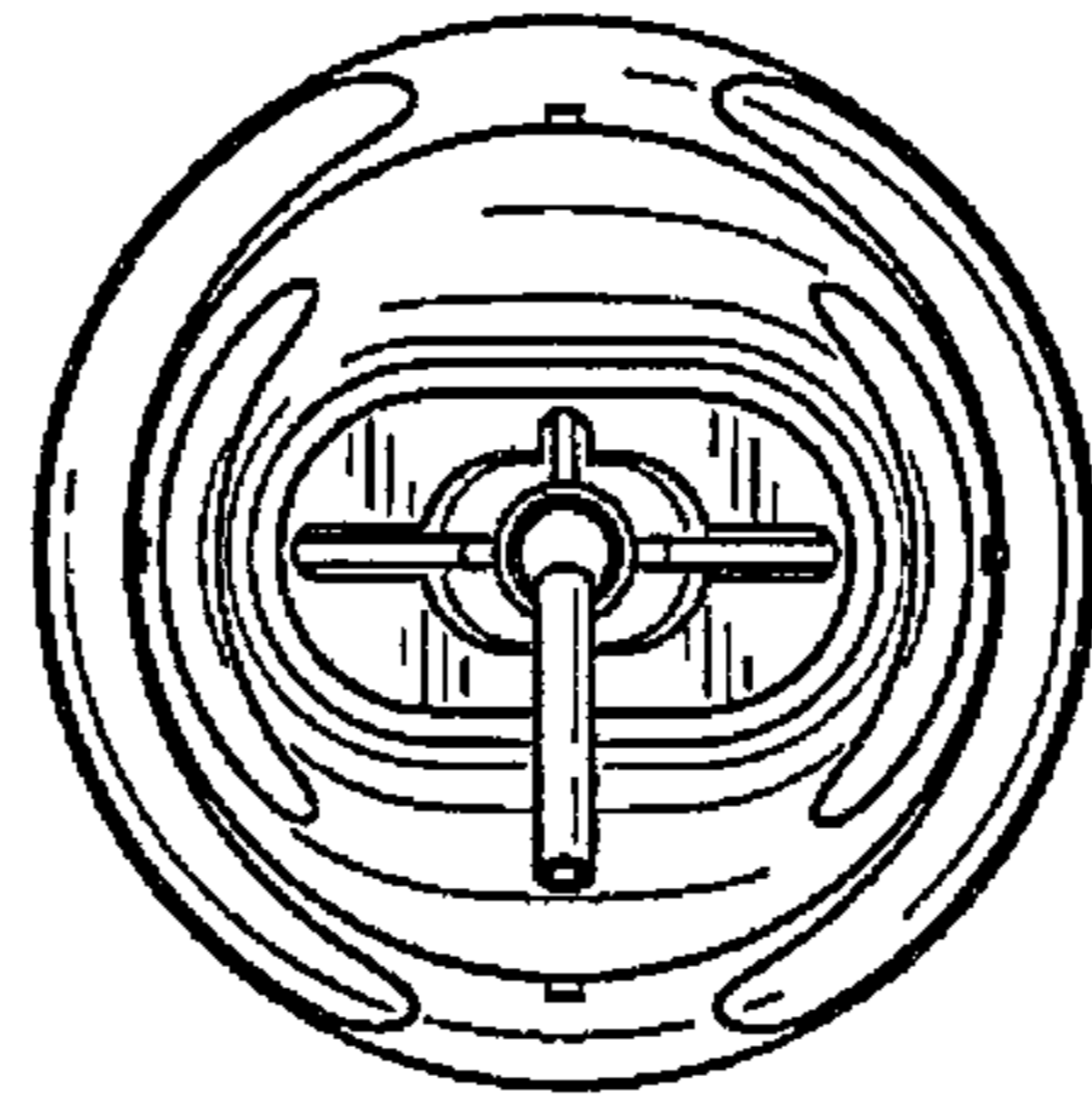

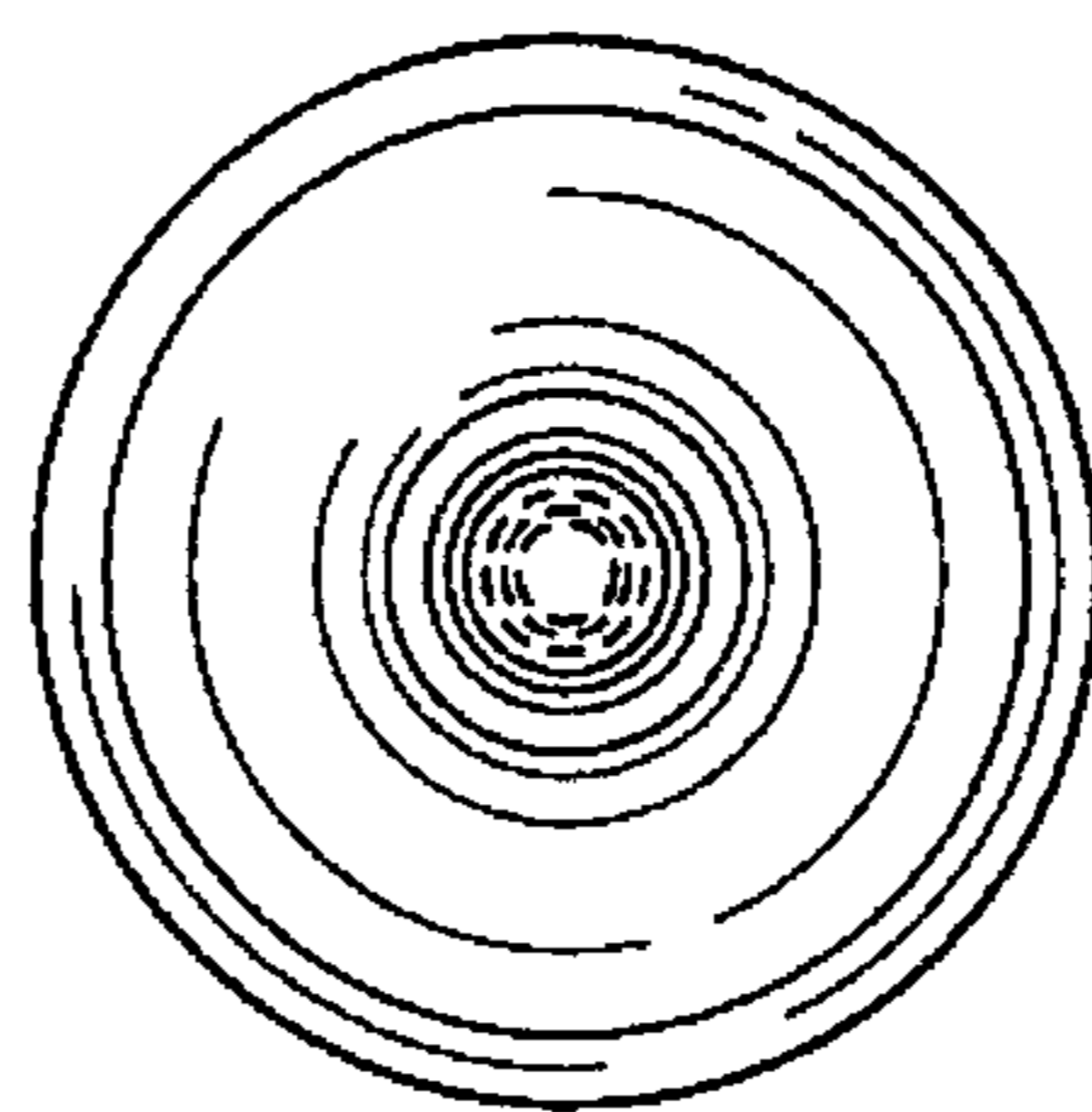
