We claim the ornamental design for a roof tile, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a roof tile according to the present design;

FIG. 2 is a front elevation view of the roof tile shown in FIG. 1;

FIG. 3 is a rear elevation view of the roof tile shown in FIG. 1;

FIG. 4 is a bottom plan view of the roof tile shown in FIG. 1;

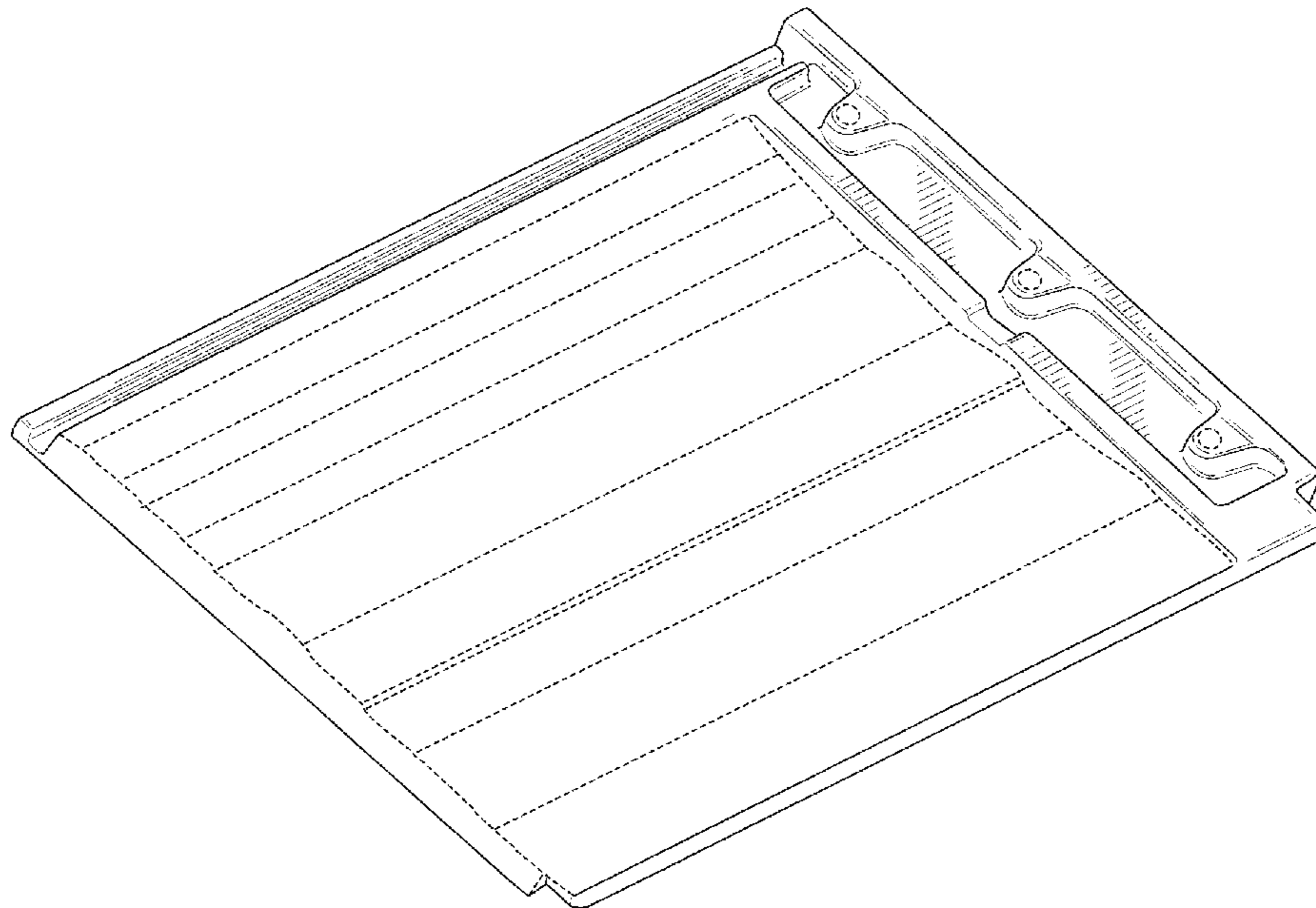
FIG. 5 is a top plan view of the roof tile shown in FIG. 1;

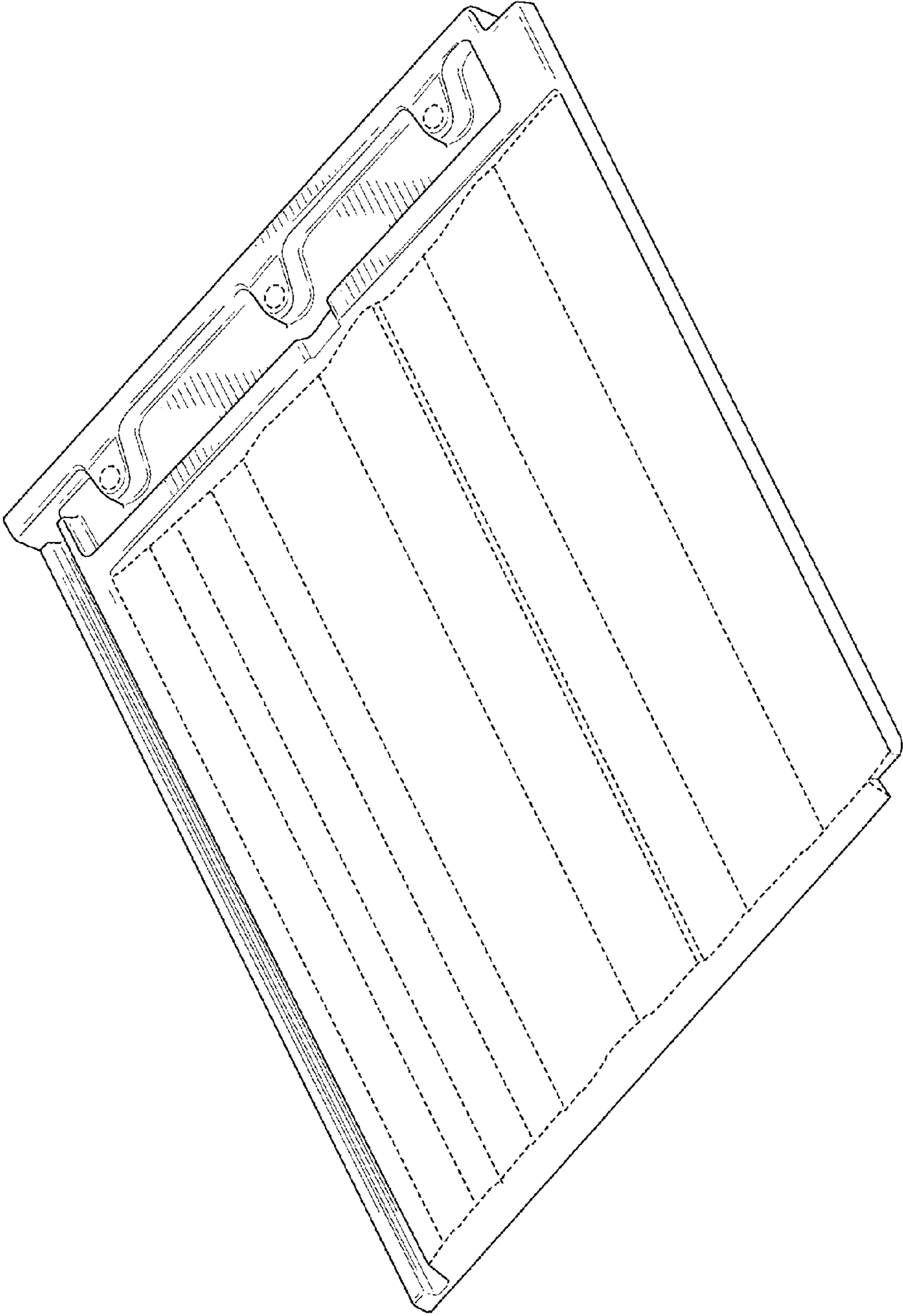

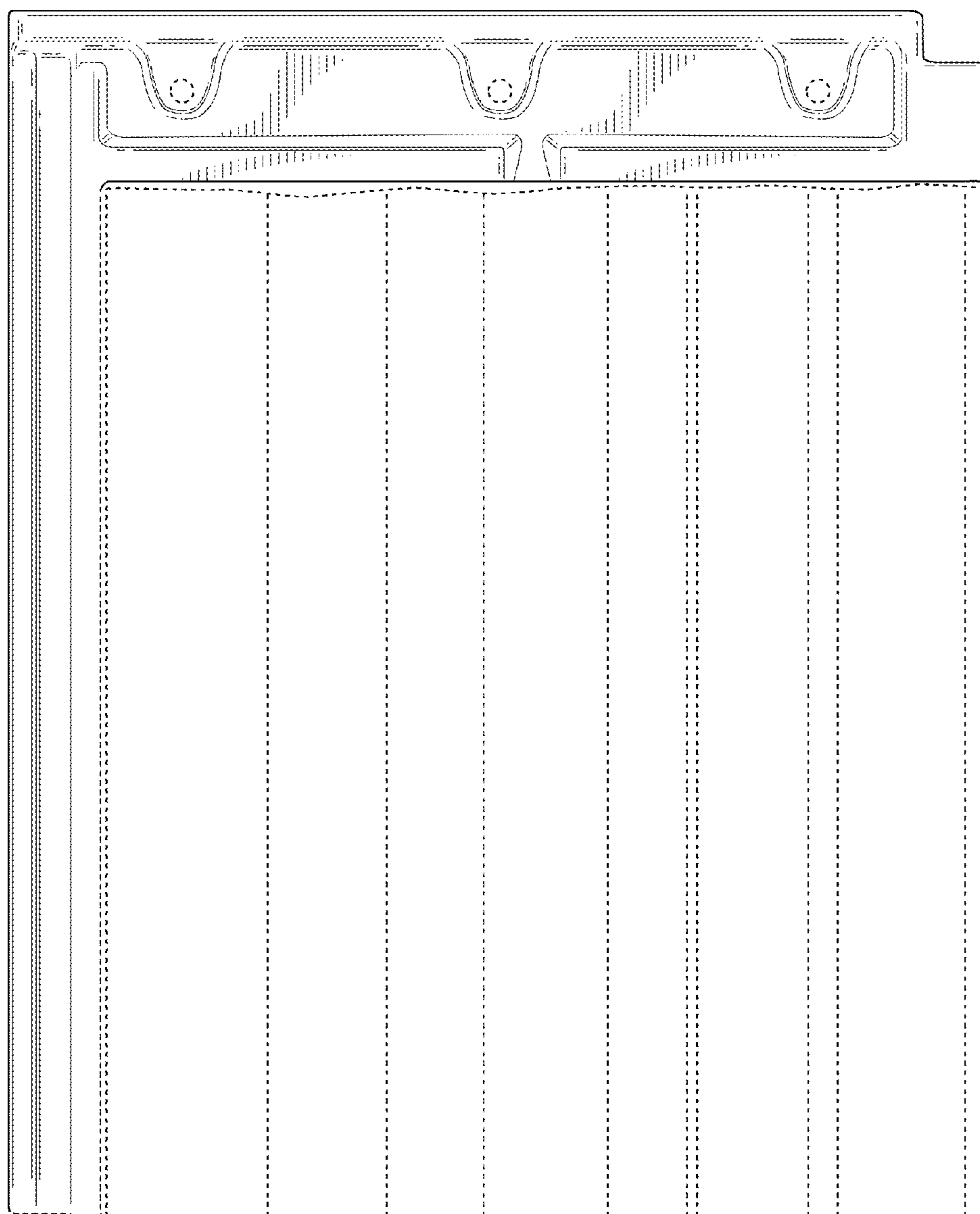

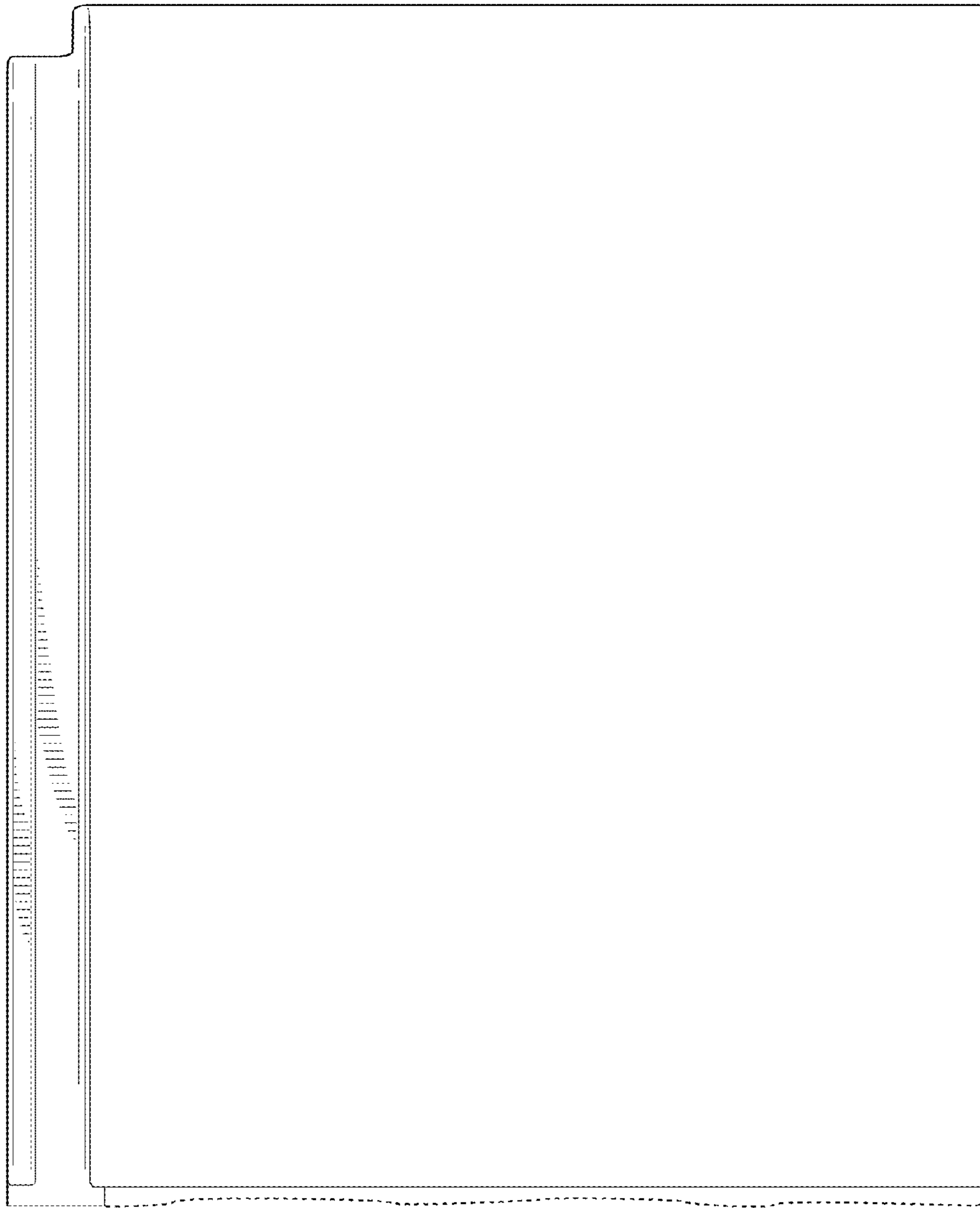

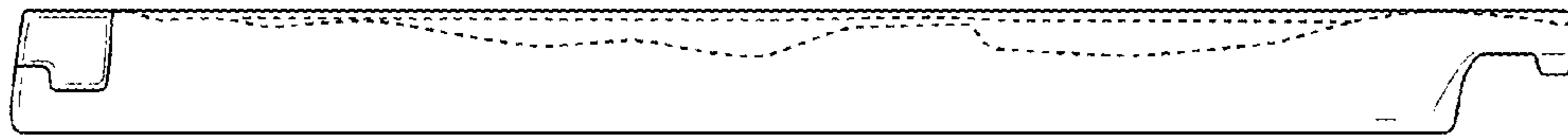

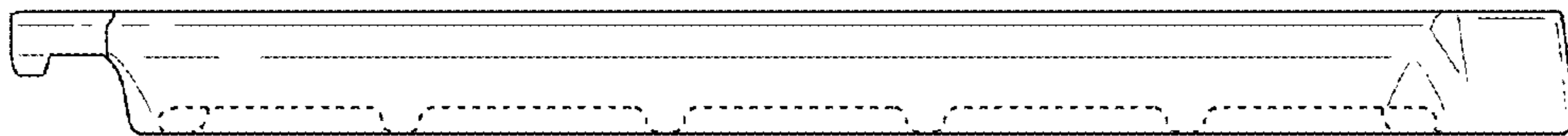

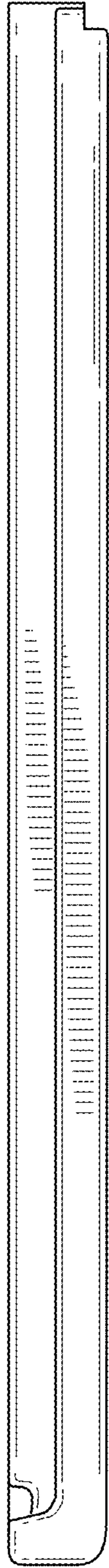

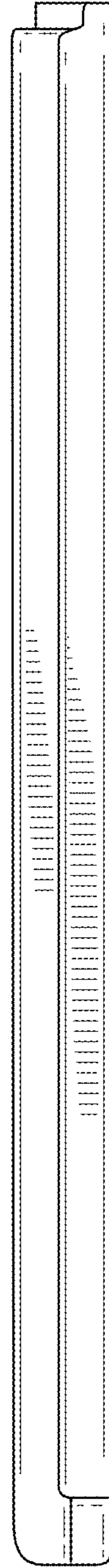
