DESCRIPTION

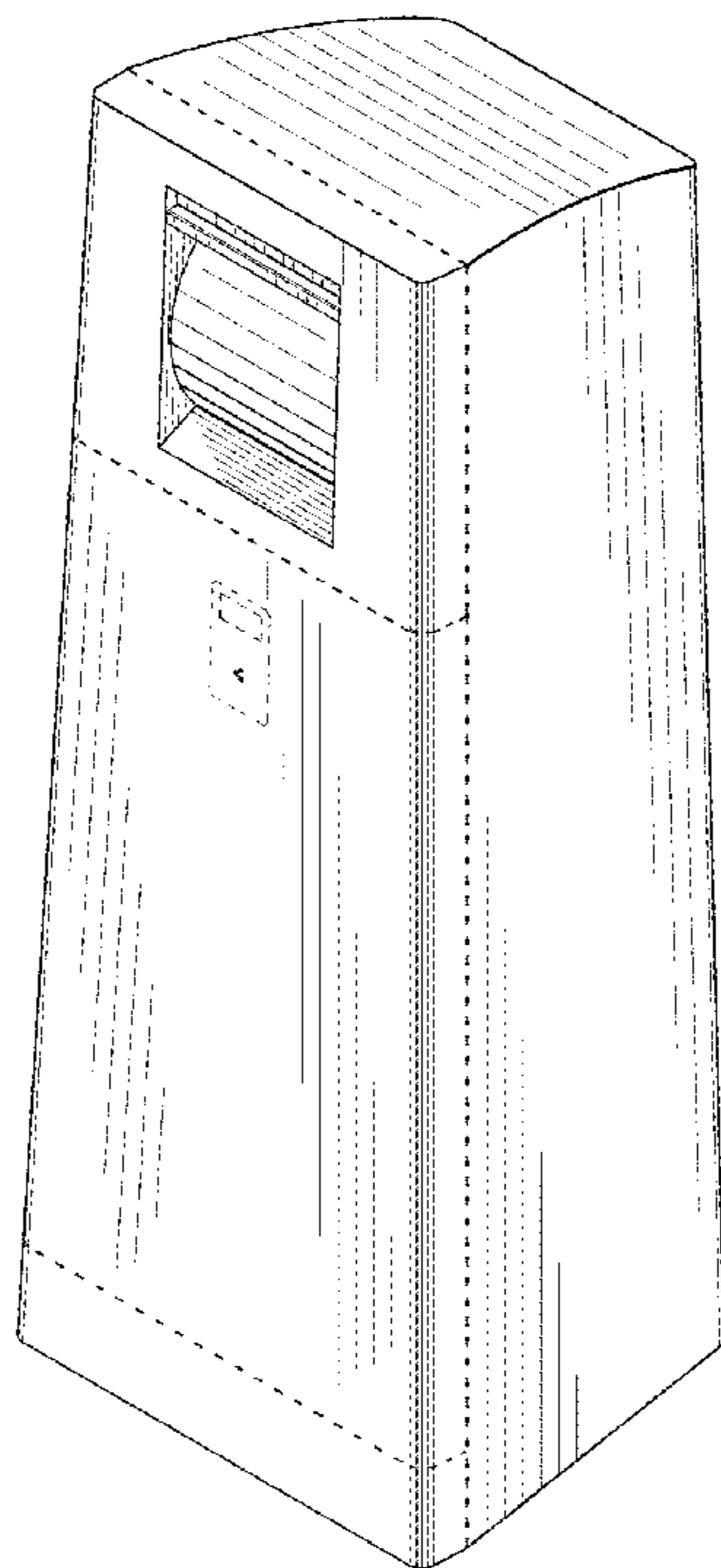
FIG. 1 is a front, right, perspective view of a helmet returning bin showing my new design invention;

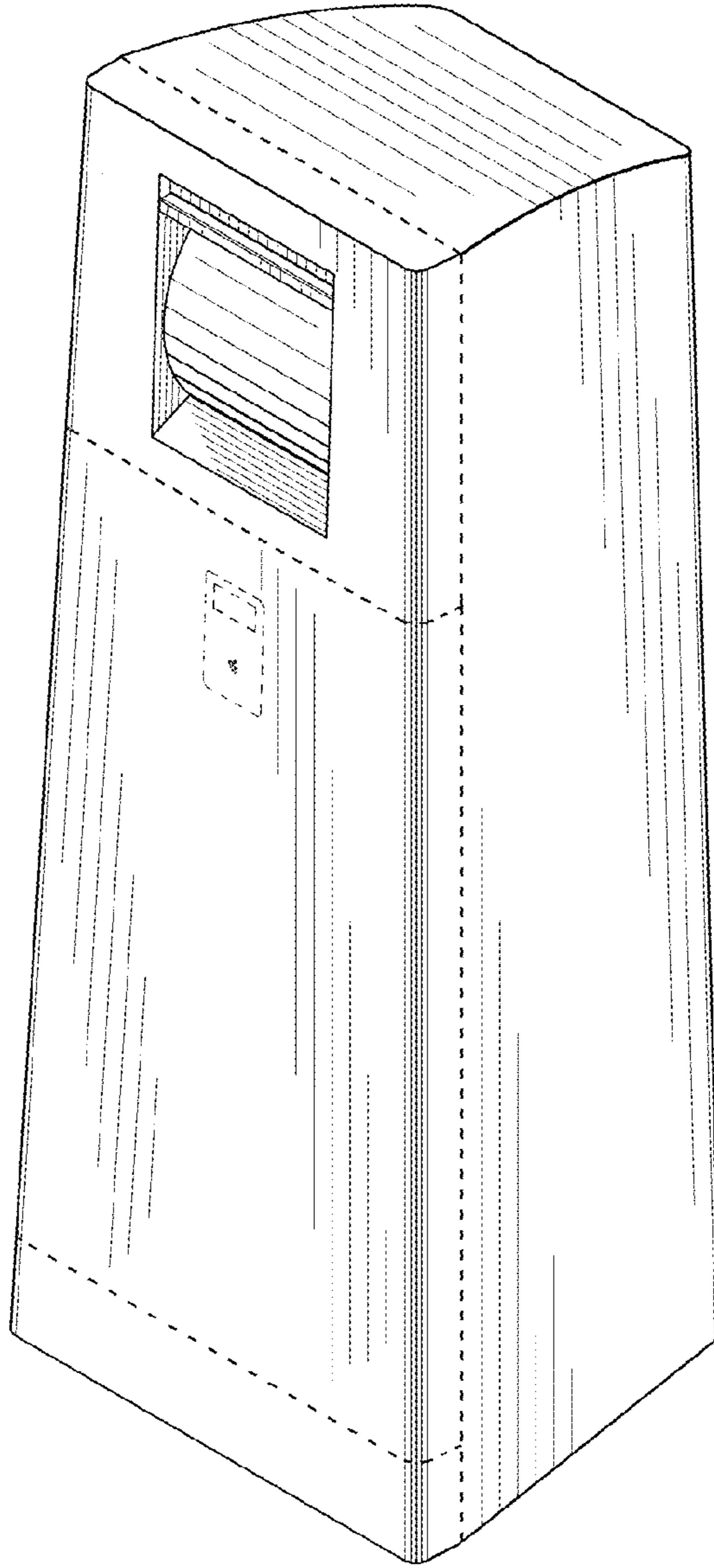

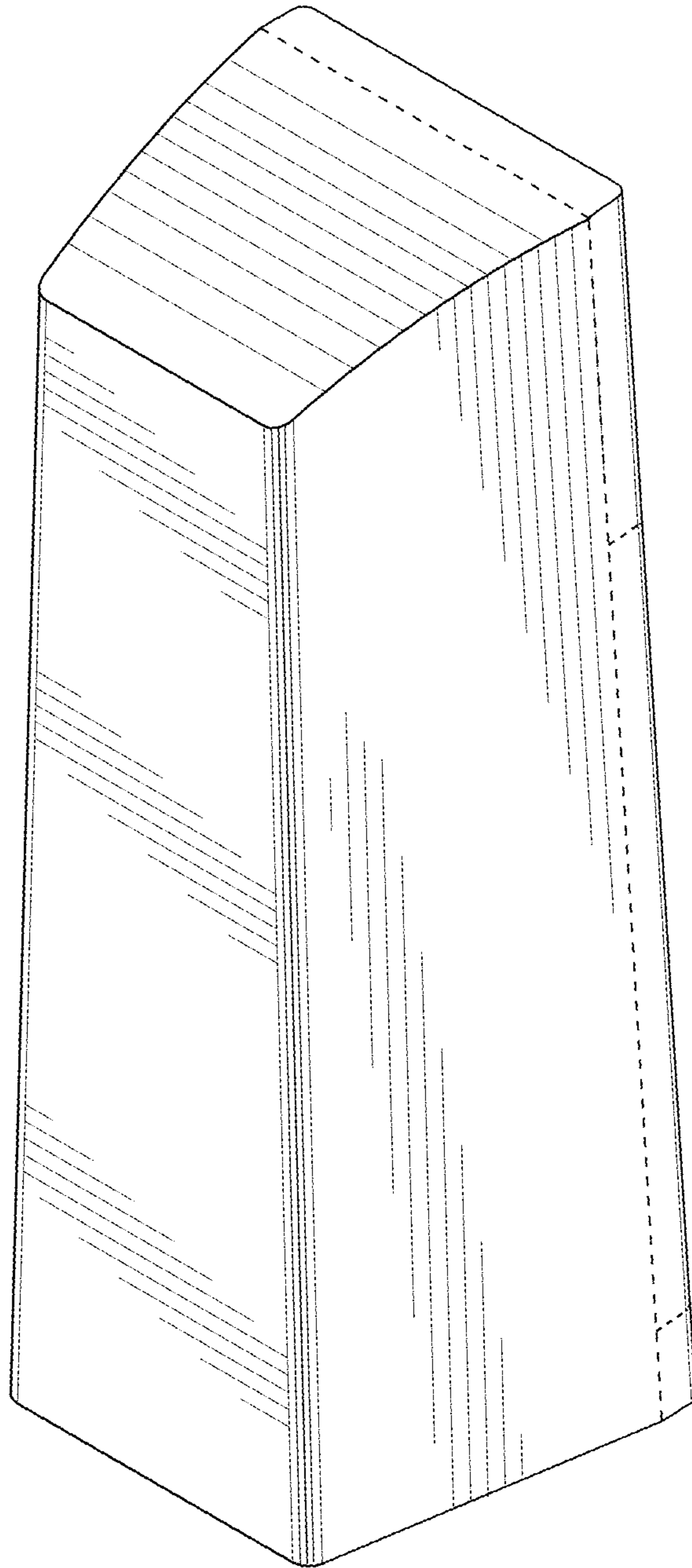

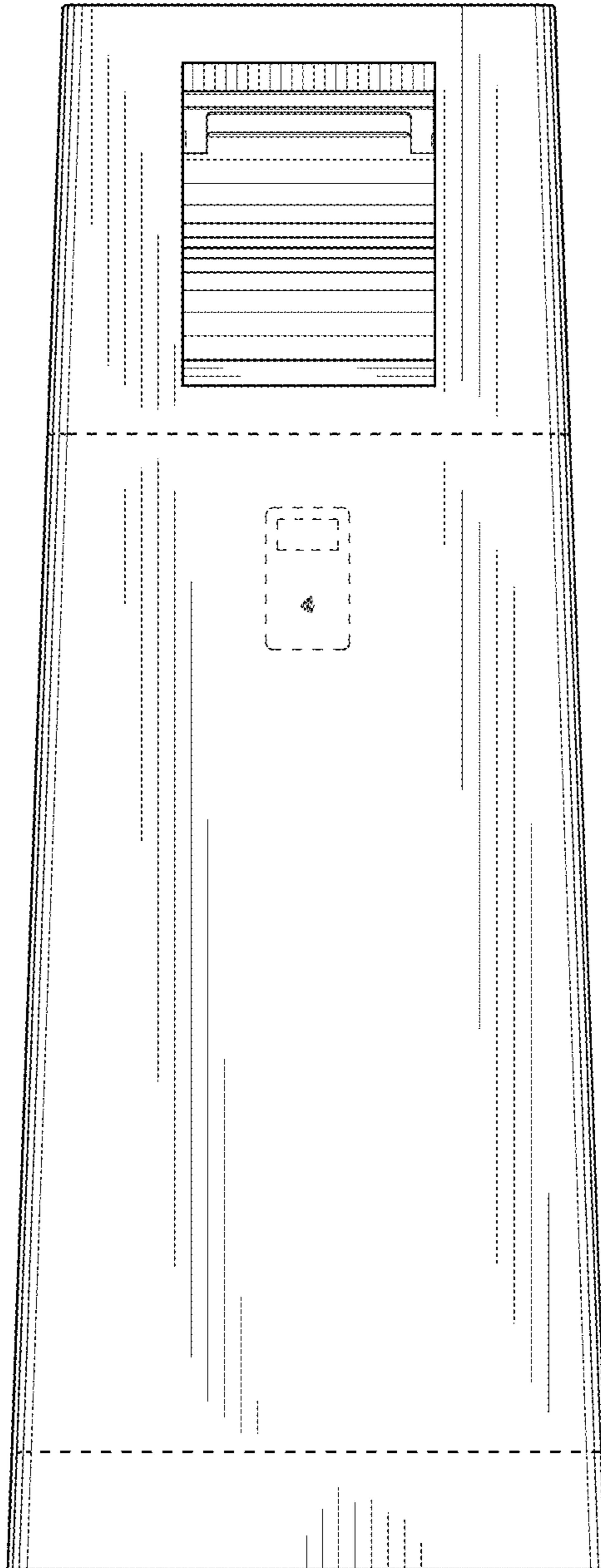

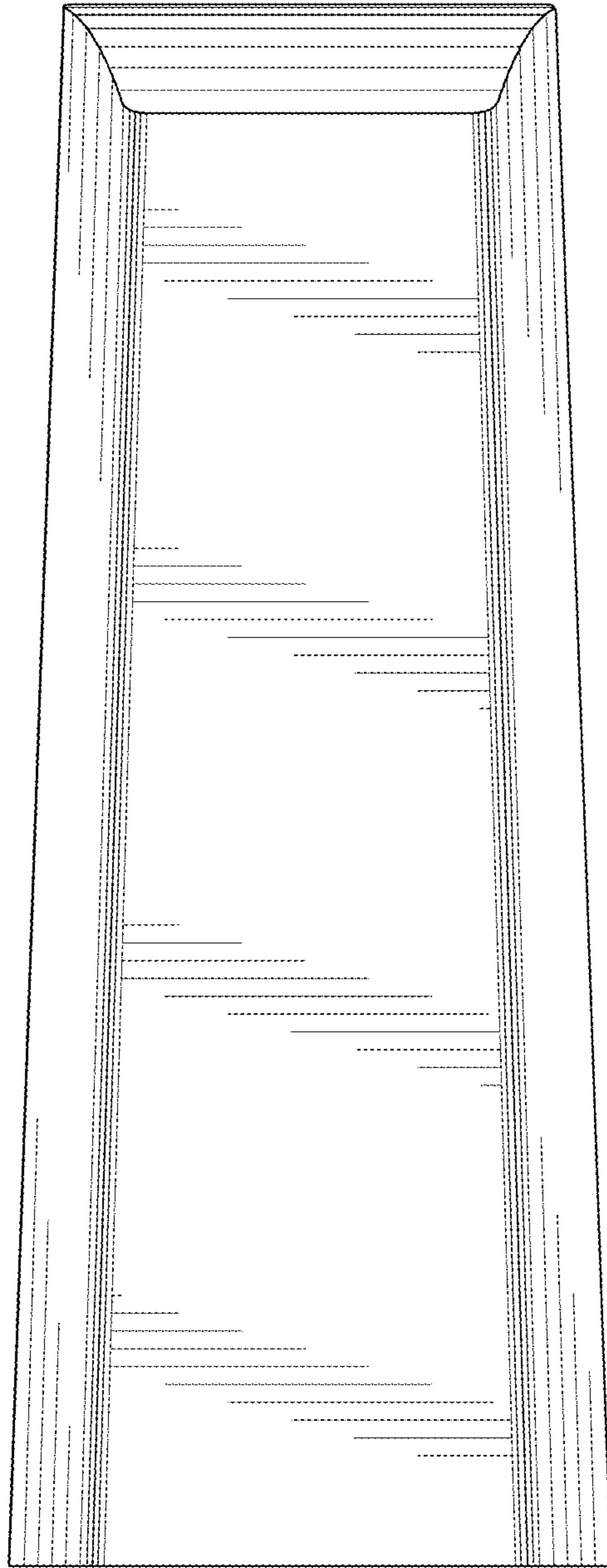

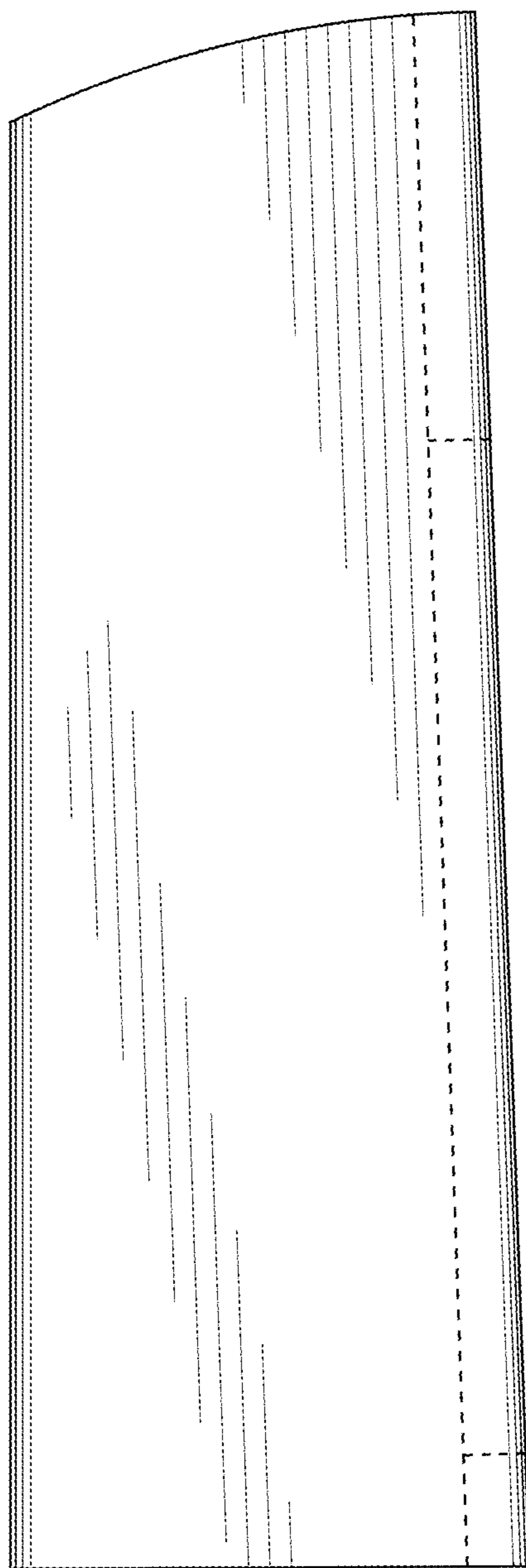

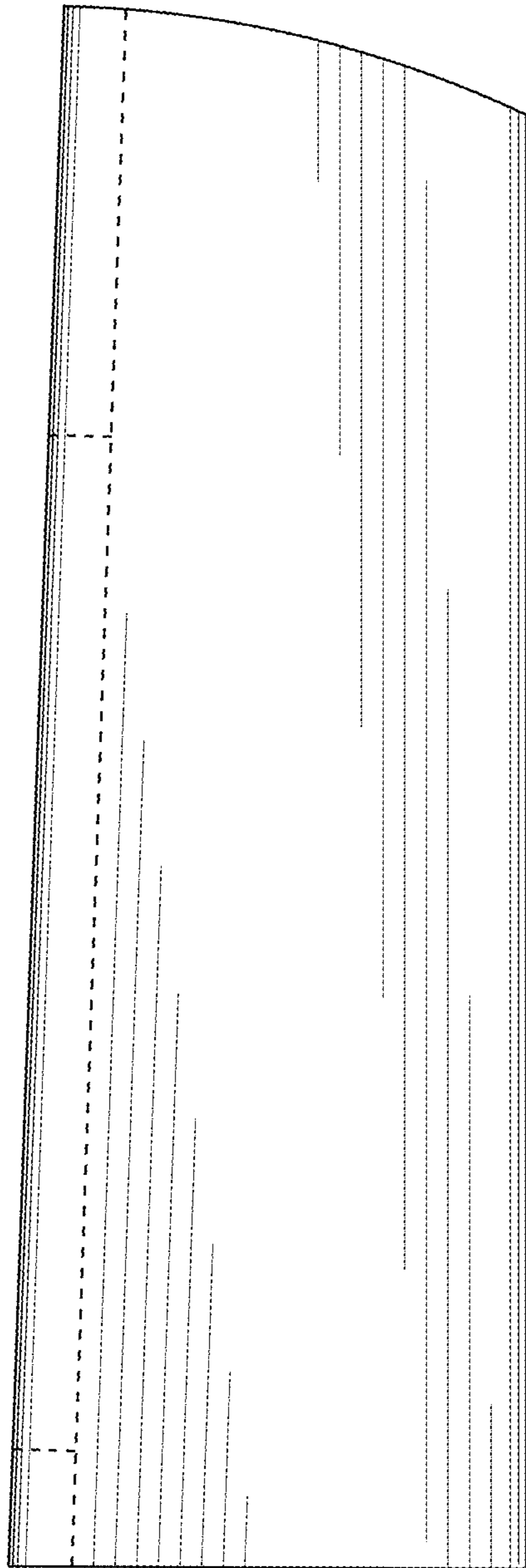

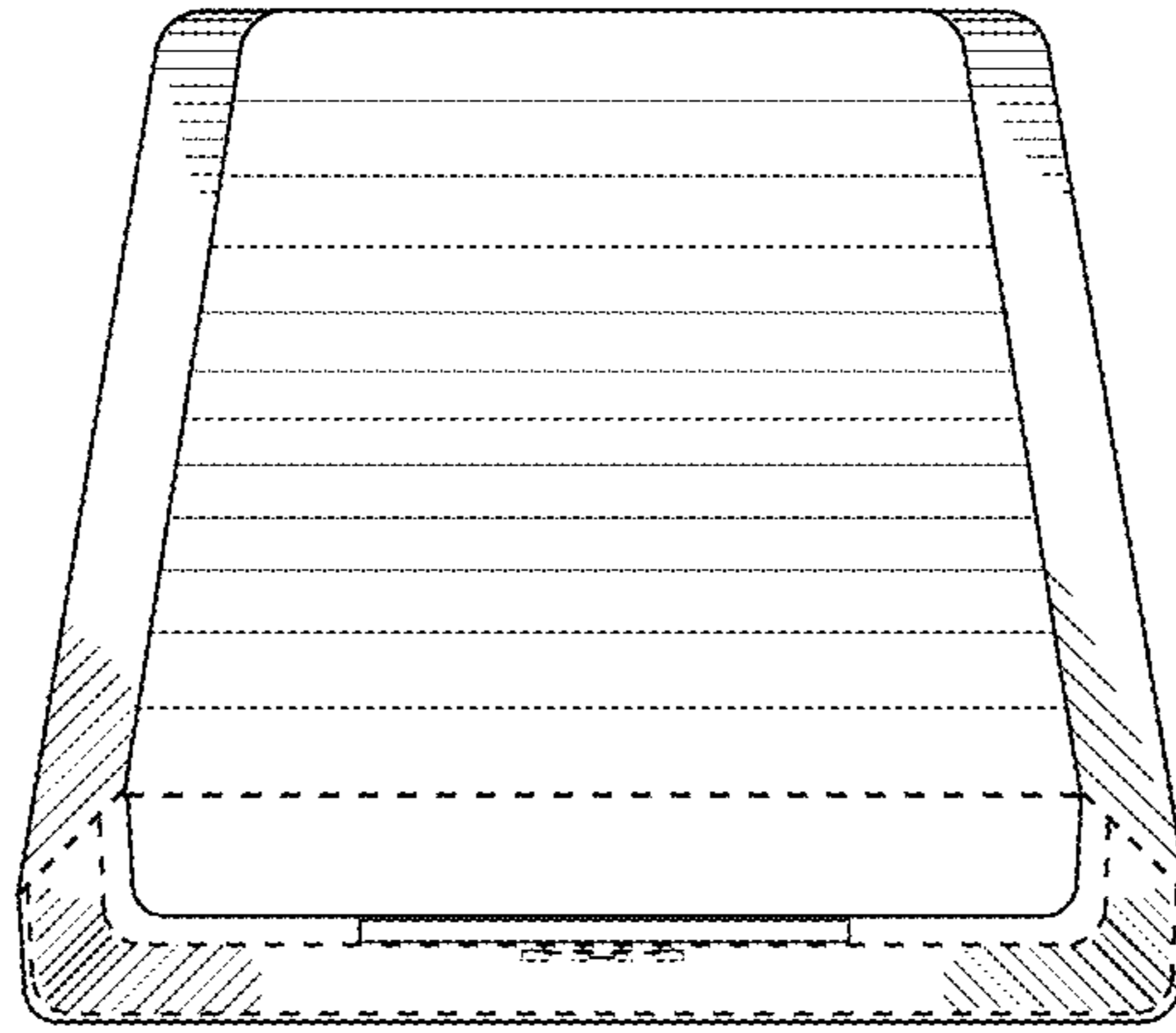

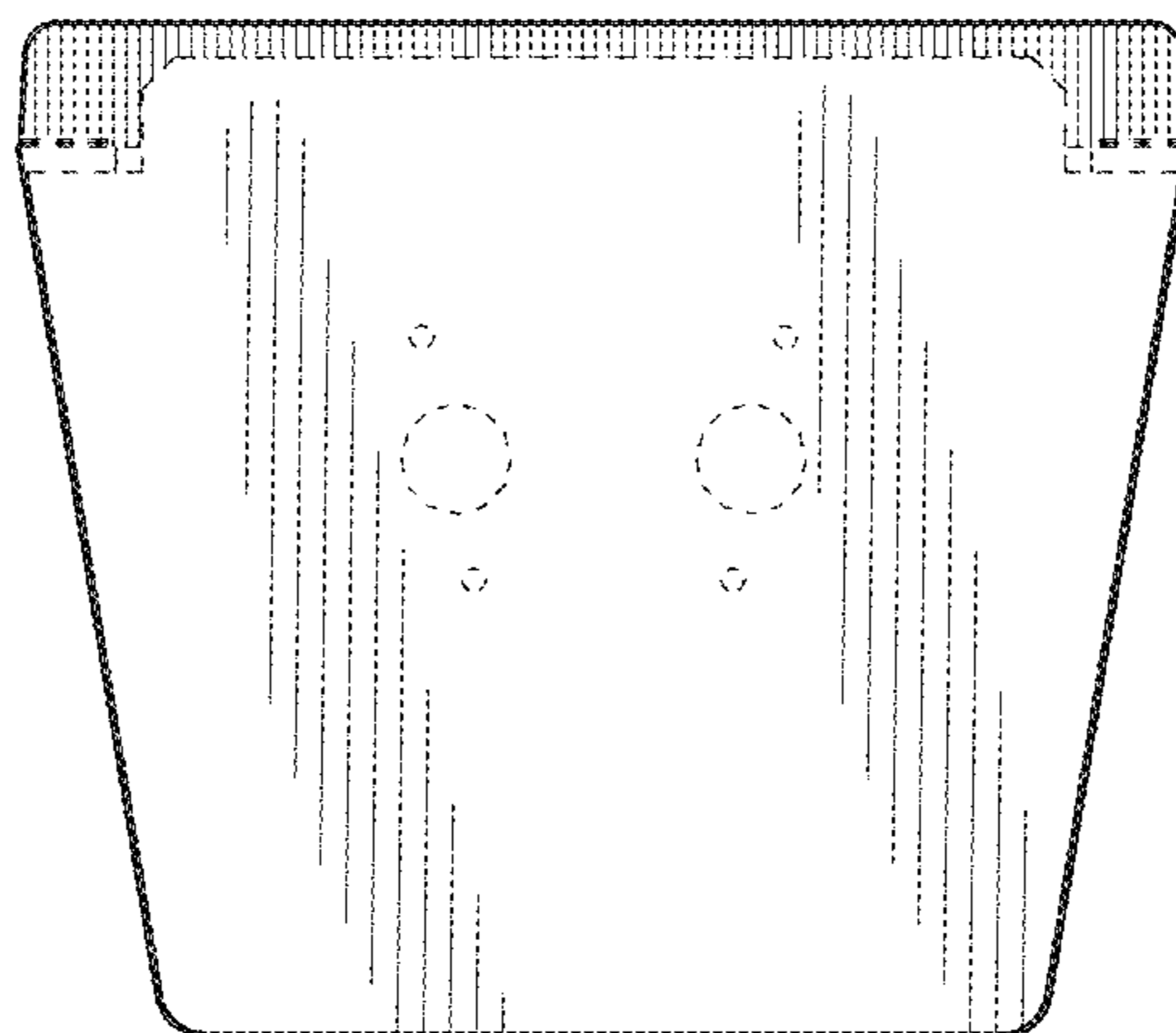

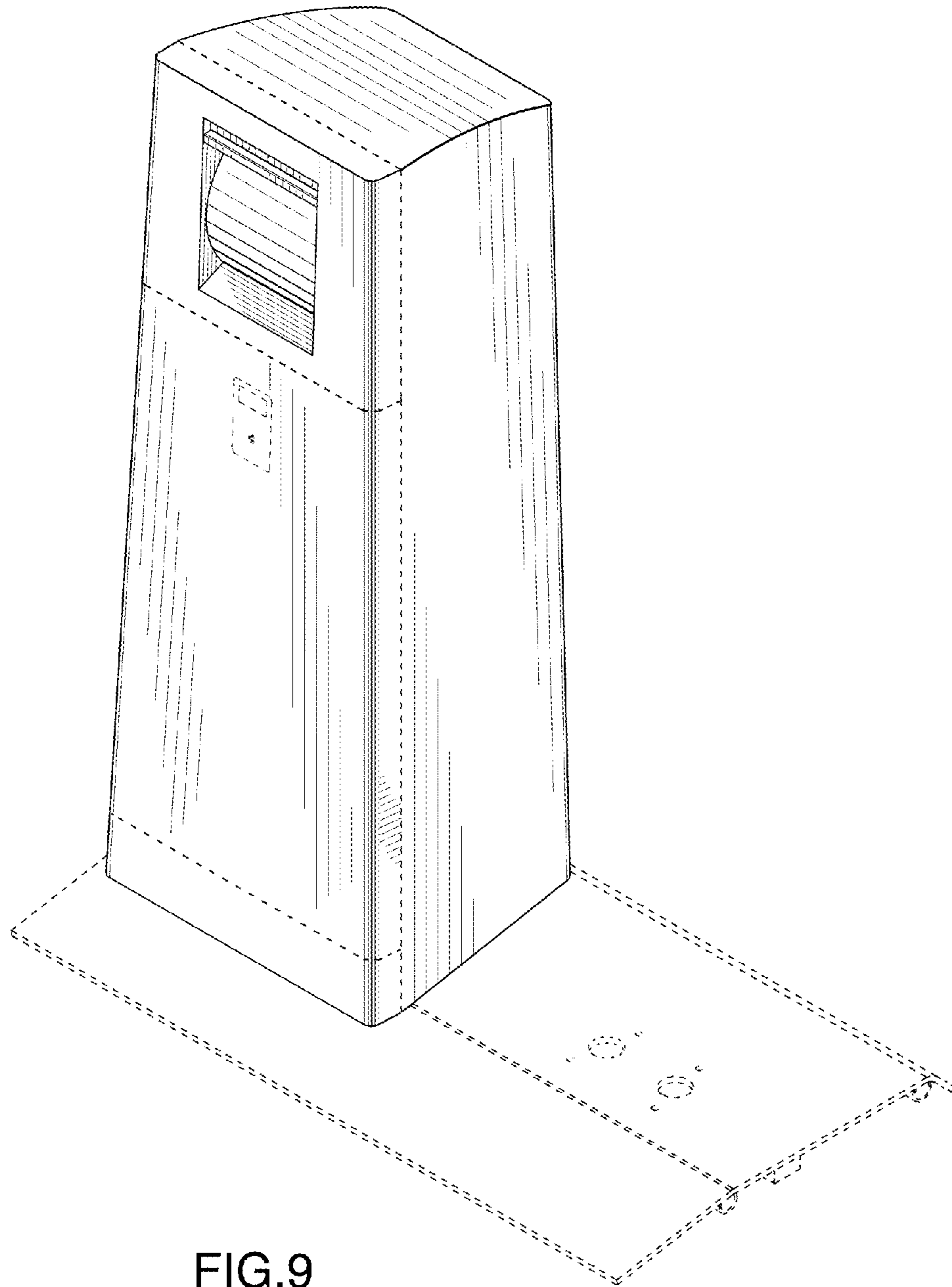
