(57) **CLAIM**

The ornamental design for a set of yoga pose chocolates, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a yoga pose chocolate of the set of yoga pose chocolates, showing a yoga pose known to yoga practitioners as the Equal Standing pose (Samasthiti);

FIG. 2 is a front view thereof;

FIG. 3 is a front view of another yoga pose chocolate of the set of yoga pose chocolates, showing a yoga pose known to yoga practitioners as the Raised Hands pose (Urdhva Hastasana);

FIG. 4 is a front view of another yoga pose chocolate of the set of yoga pose chocolates, showing a yoga pose known to yoga practitioners as the Flat Back pose (Ardha Uttanasana);

FIG. 5 is a front view of another yoga pose chocolate of the set of yoga pose chocolates, showing a yoga pose known to yoga practitioners as the Four Legged Staff pose (Chaturanga Dandasana);

FIG. 6 is a front view of another yoga pose chocolate of the set of yoga pose chocolates, showing a yoga pose known to yoga practitioners as the Upward Facing Dog pose (Urdhva Mukha Svanasana);

FIG. 7 is a front view of another yoga pose chocolate of the set of yoga pose chocolates, showing a yoga pose known to yoga practitioners as the Downward Facing Dog pose (Adho Mukha Svanasana);

FIG. 8 is a front view of another yoga pose chocolate of the set of yoga pose chocolates, showing a yoga pose known to yoga practitioners as the Tree pose (Vrksasana);

FIG. 9 is a front view of another yoga pose chocolate of the set of yoga pose chocolates, showing a yoga pose known to yoga practitioners as the Triangle pose (Trikonasana);

FIG. 10 is a front view of another yoga pose chocolate of the set of yoga pose chocolates, showing a yoga pose known to yoga practitioners as the Side Angle pose (Parsvakonasana);

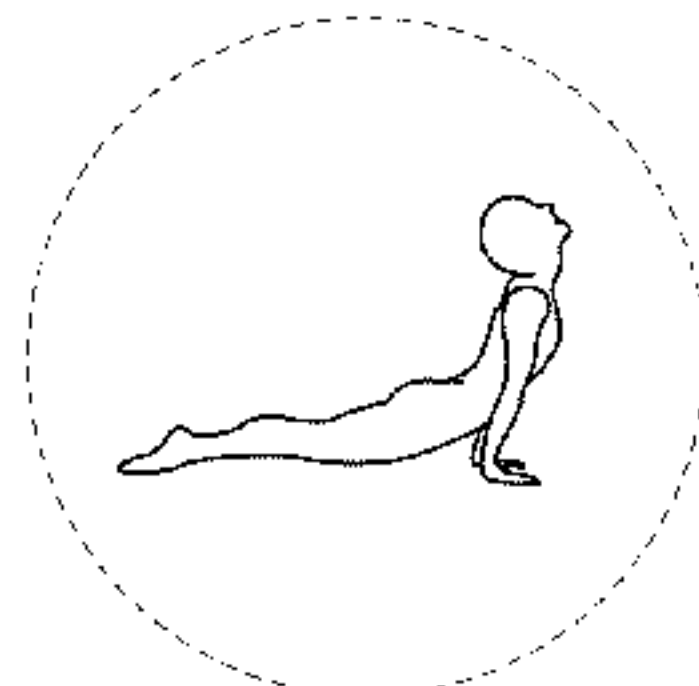
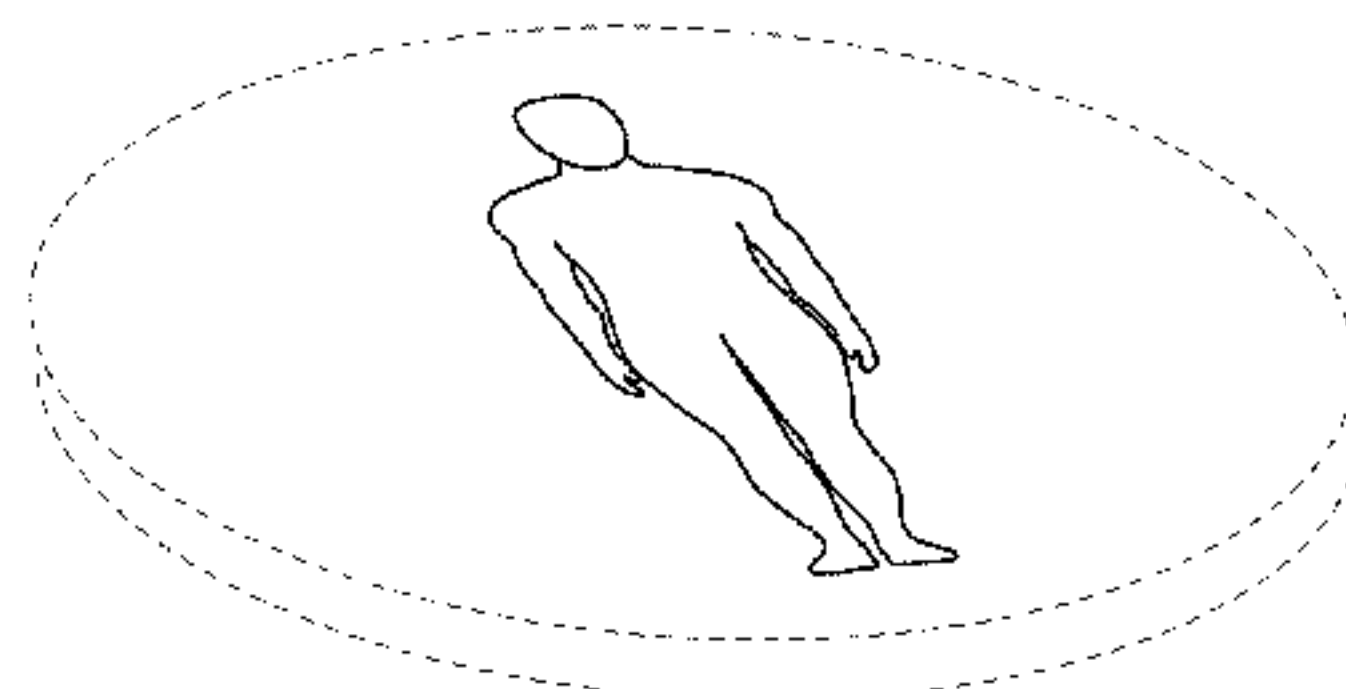

FIG. 14 is a front view of another yoga pose chocolate of the set of yoga pose chocolates, showing a yoga pose known to yoga practitioners as the Standing Forward Bend pose (Uttanasana);

FIG. 15 is a front view of another yoga pose chocolate of the set of yoga pose chocolates, showing a yoga pose known to yoga practitioners as the Warrior I pose (Virabhadrasana I);

FIG. 16 is a front view of another yoga pose chocolate of the set of yoga pose chocolates, showing a yoga pose known to yoga practitioners as the Warrior III pose (Virabhadrasana III); and,

FIG. 17 is a front view of another yoga pose chocolate of the set of yoga pose chocolates, showing a yoga pose known to yoga practitioners as the Chair pose (Utkatasana).

The broken lines in the drawings illustrate portions of the set of yoga pose chocolates which form no part of the claimed design.

The claimed design is directed to the collective appearance of the set of yoga pose chocolates.

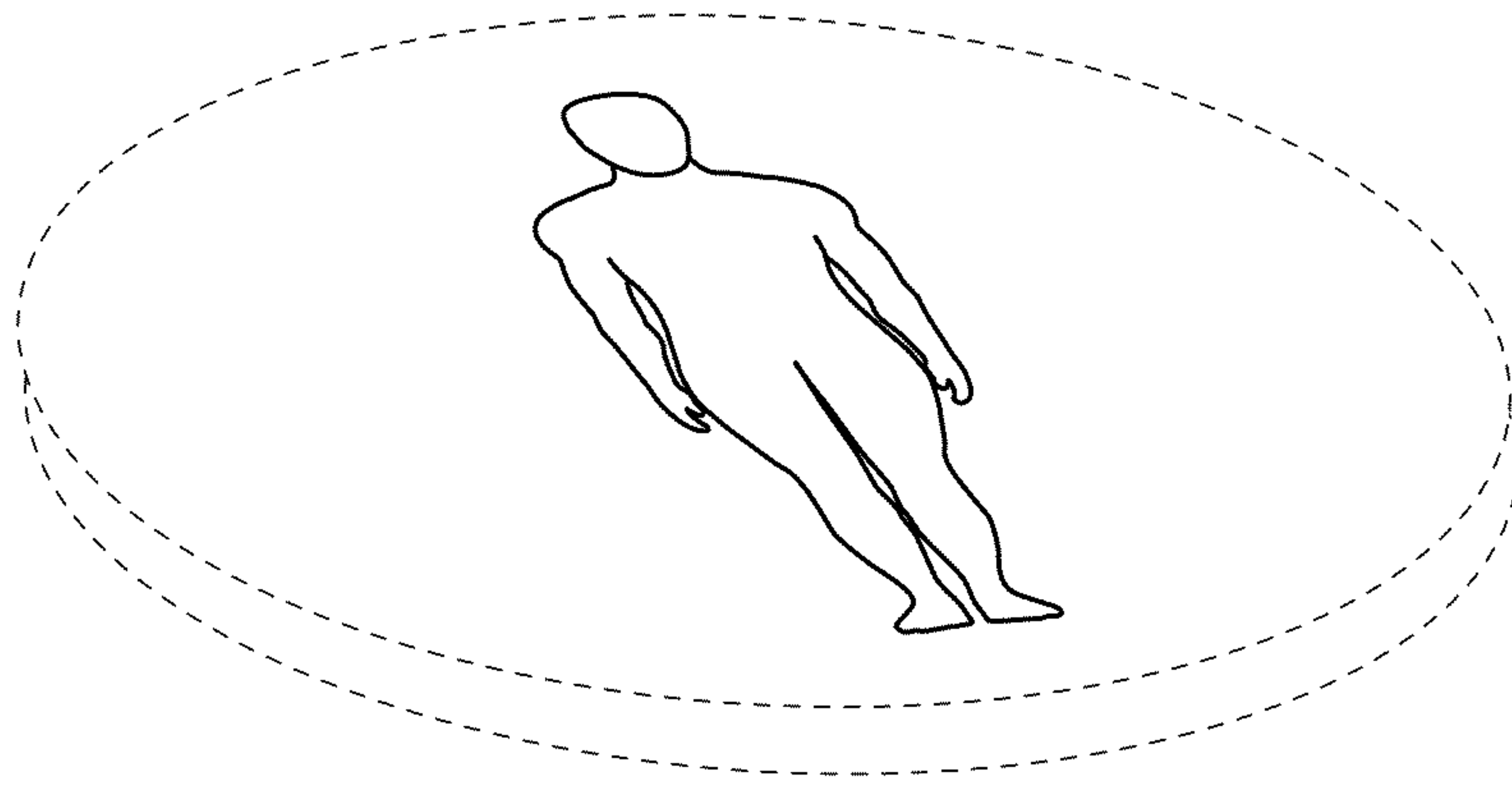

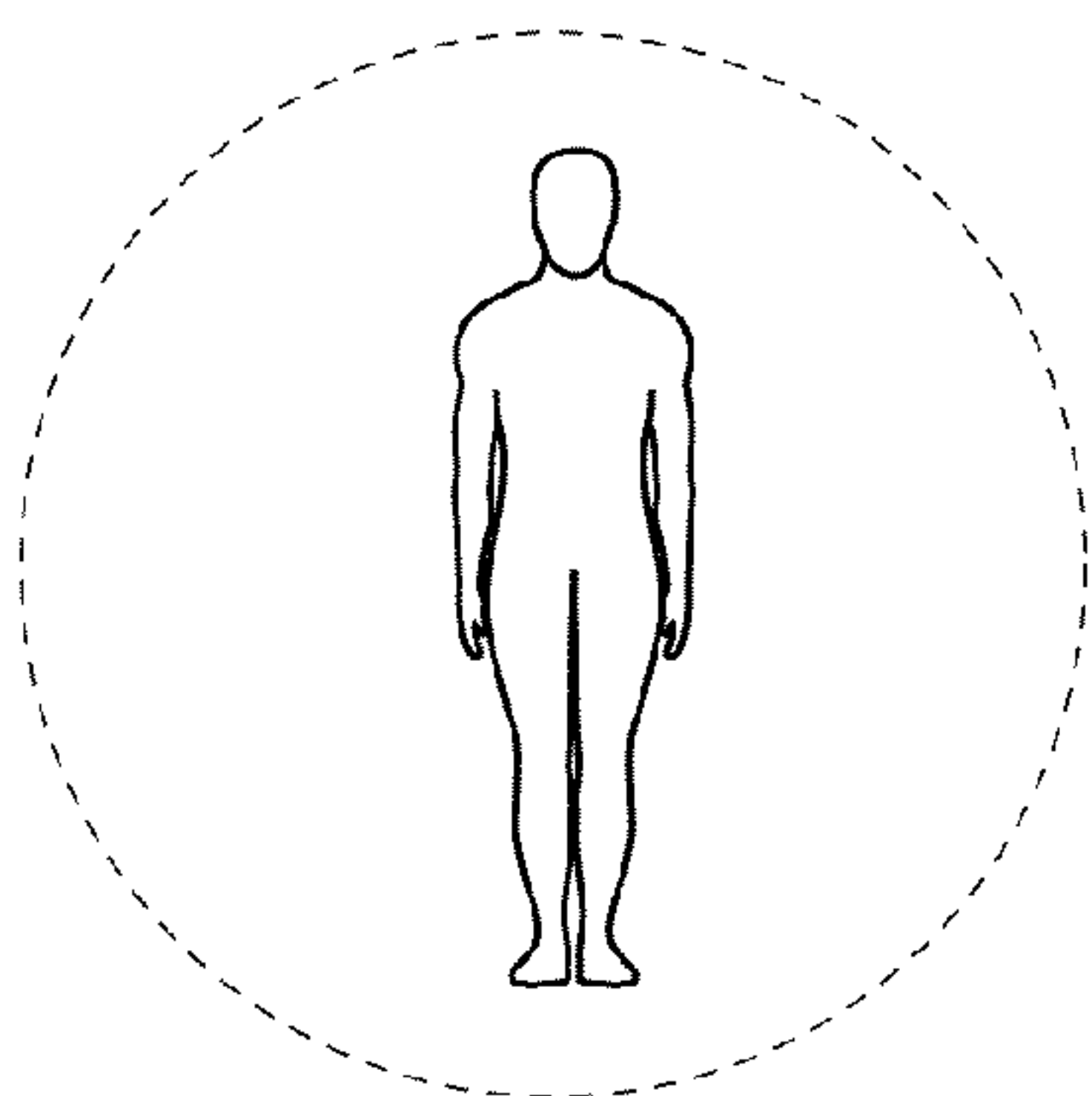

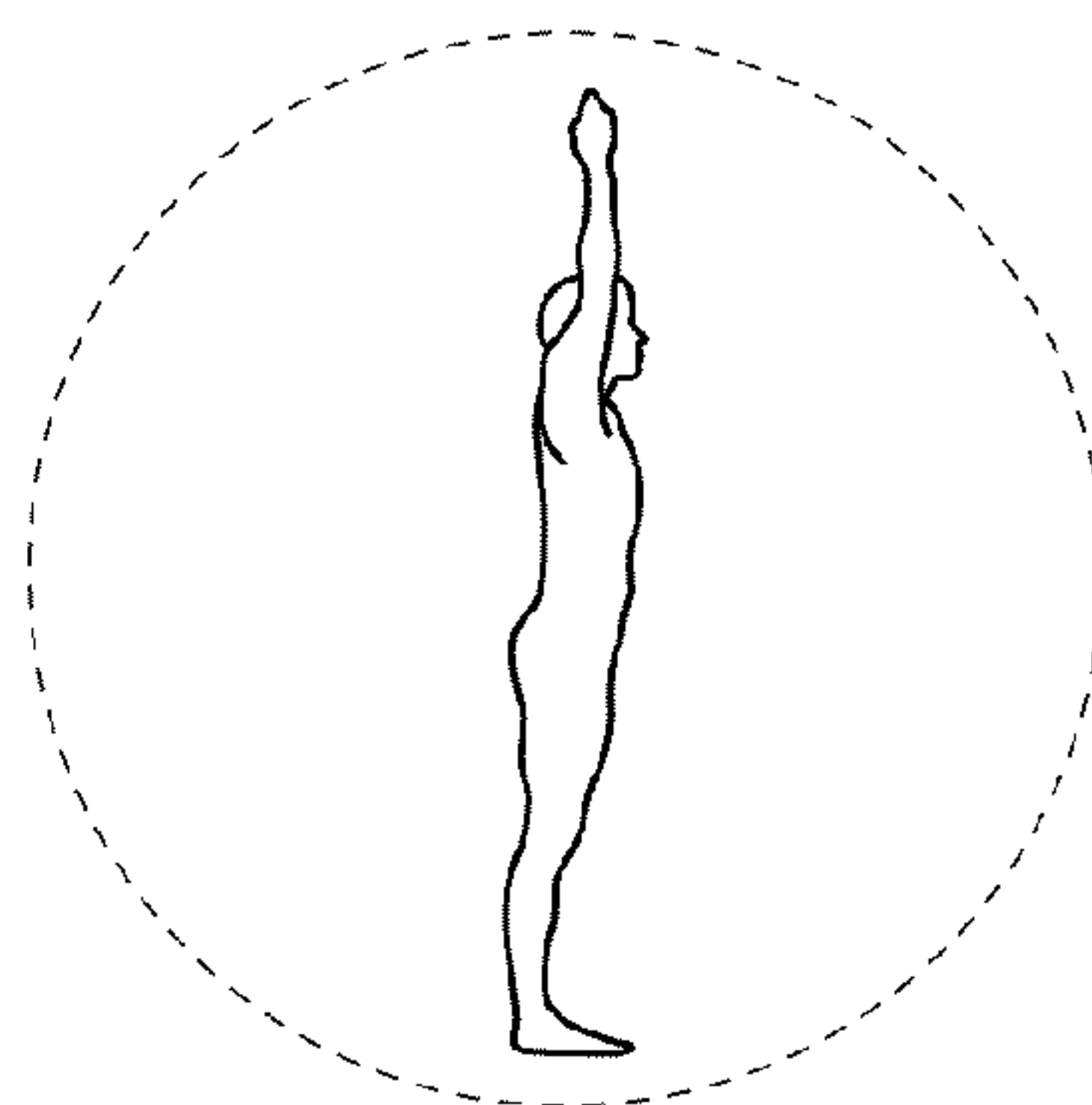

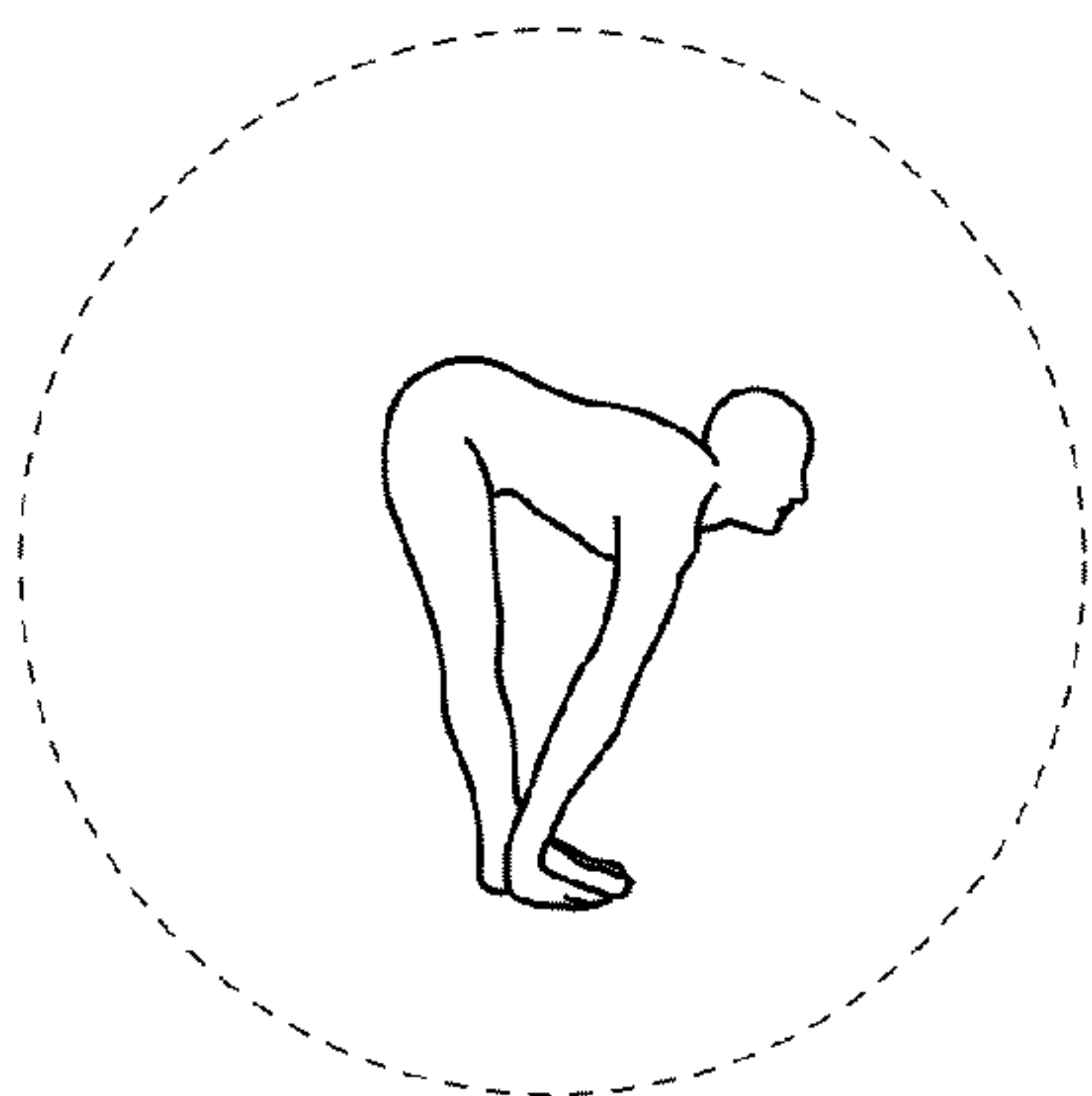

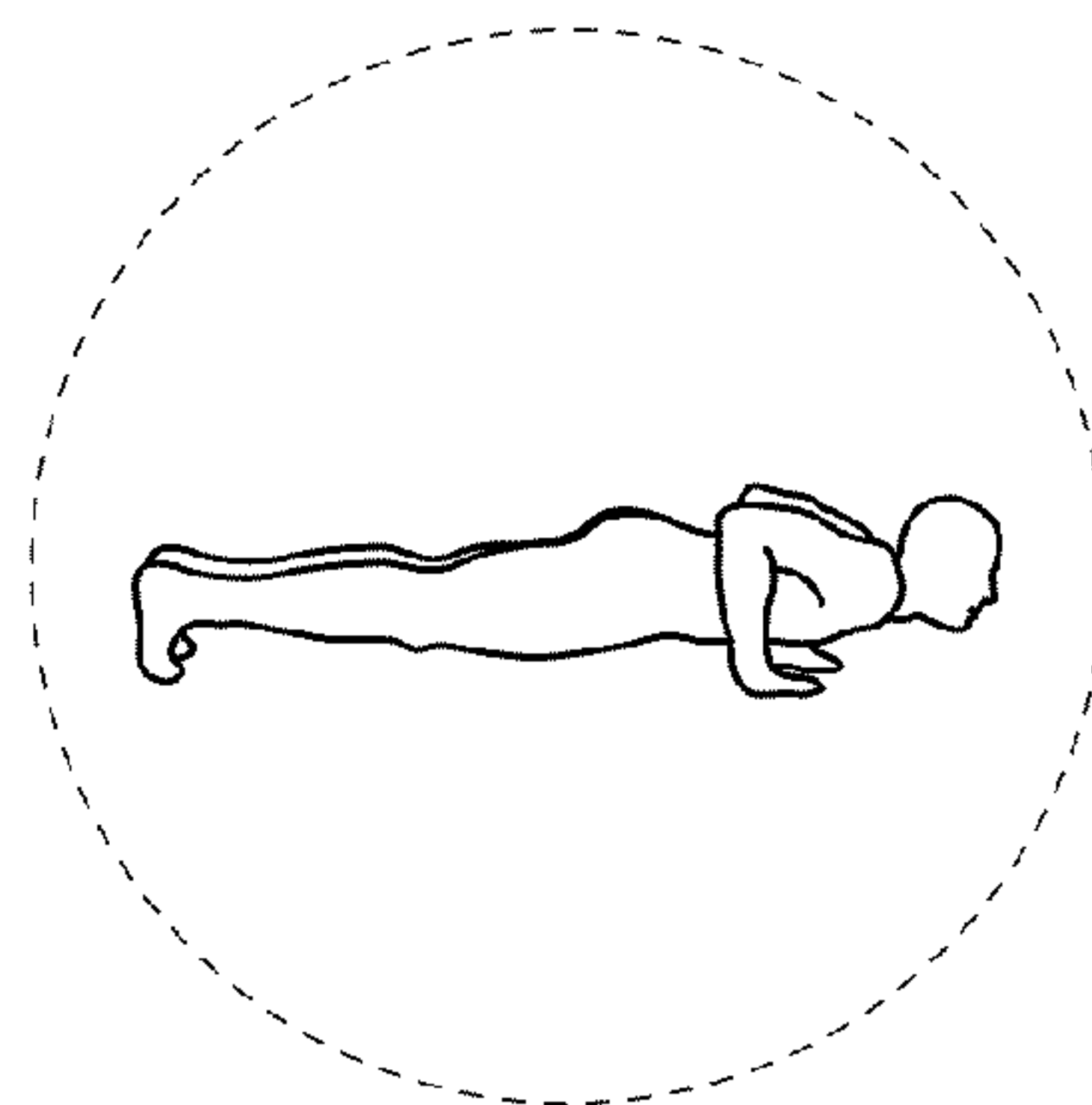

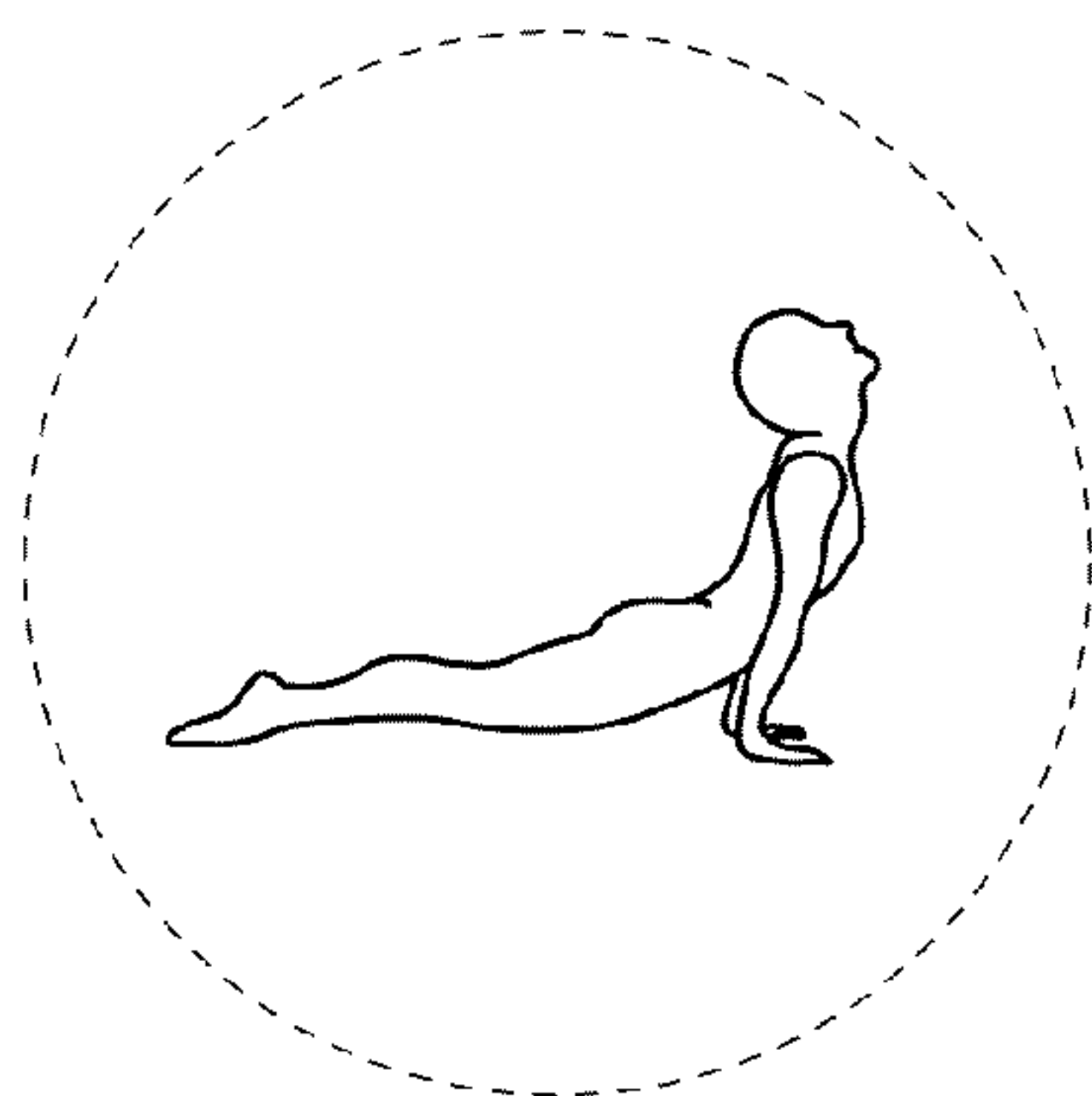

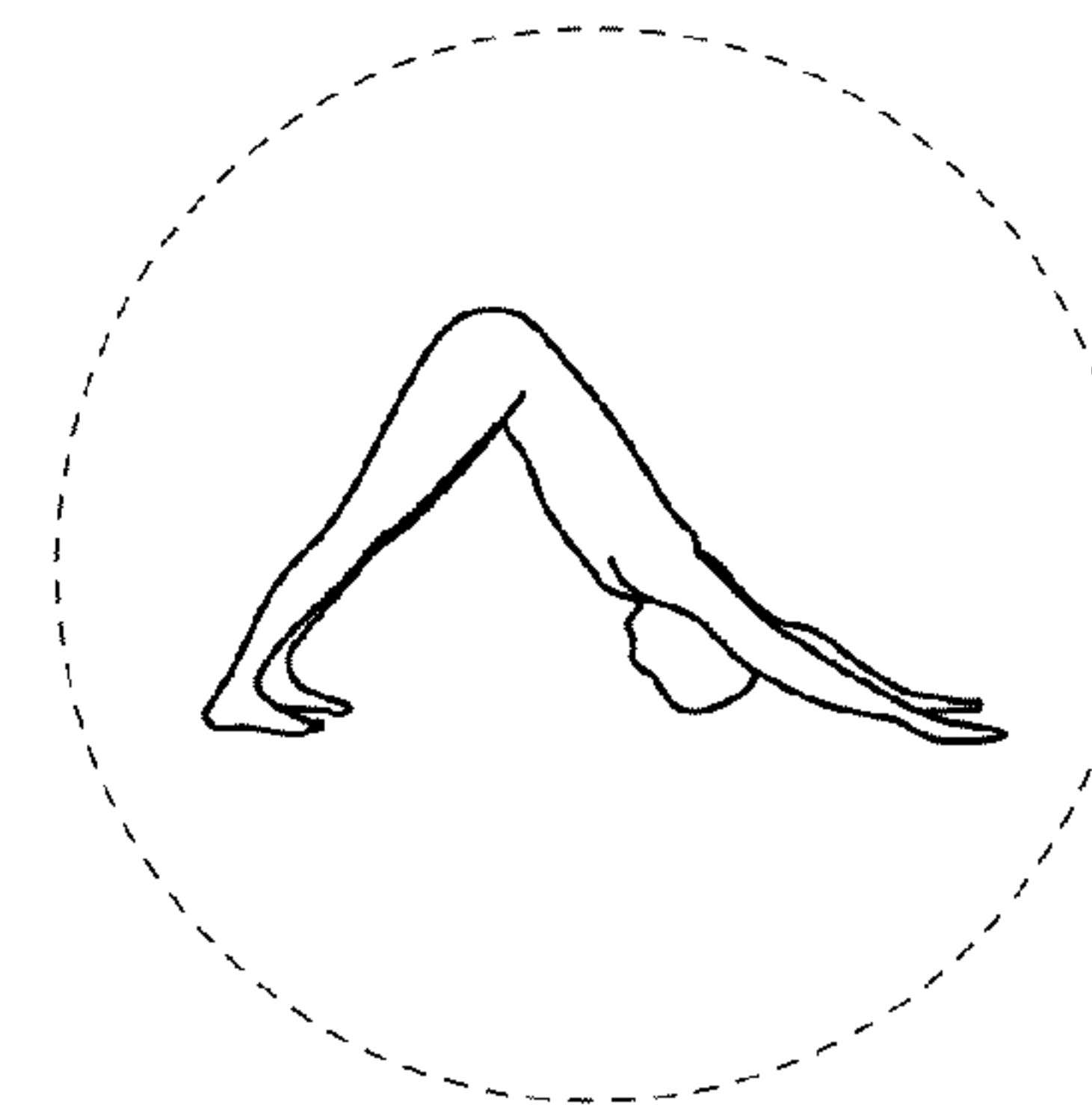

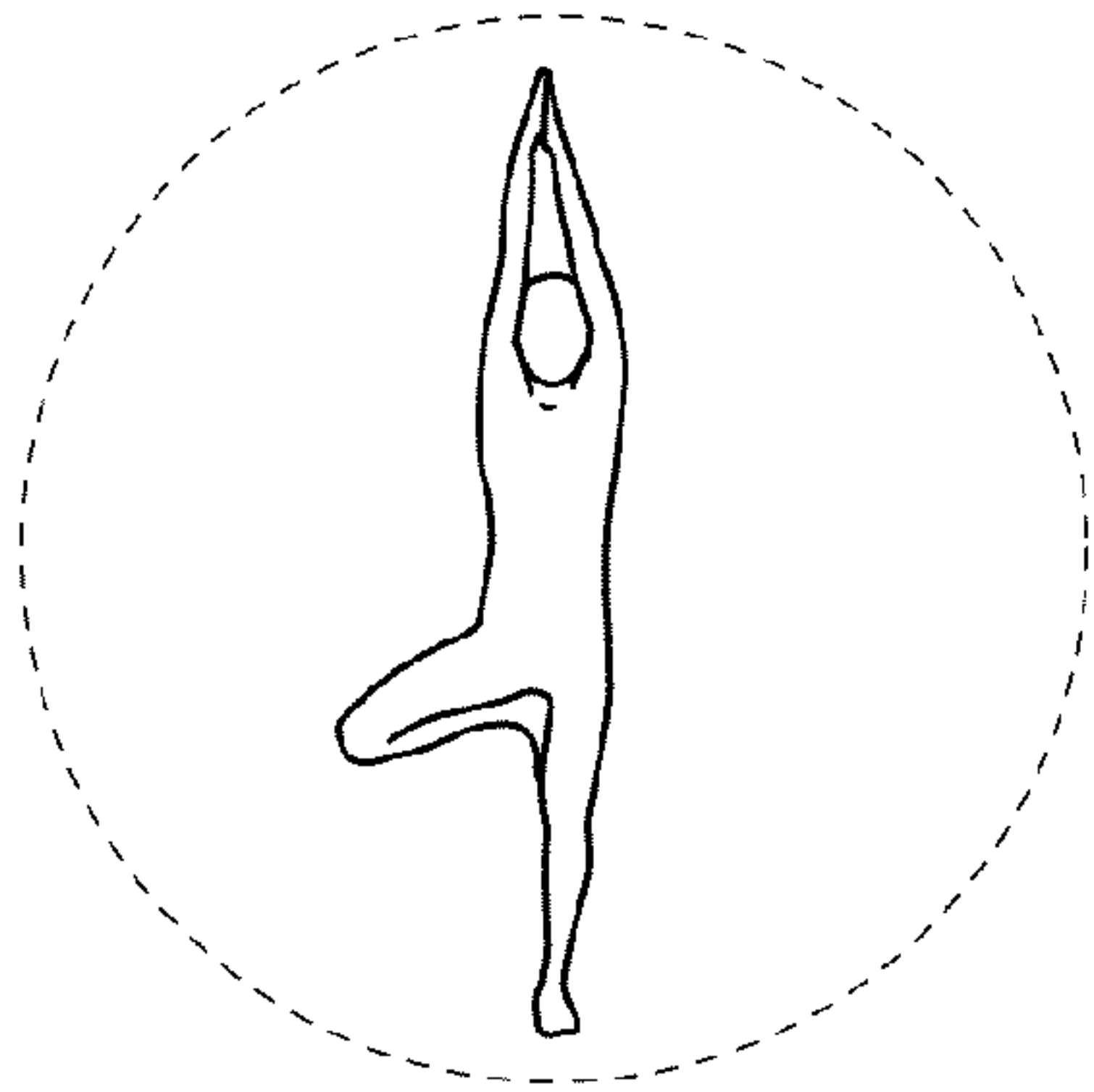

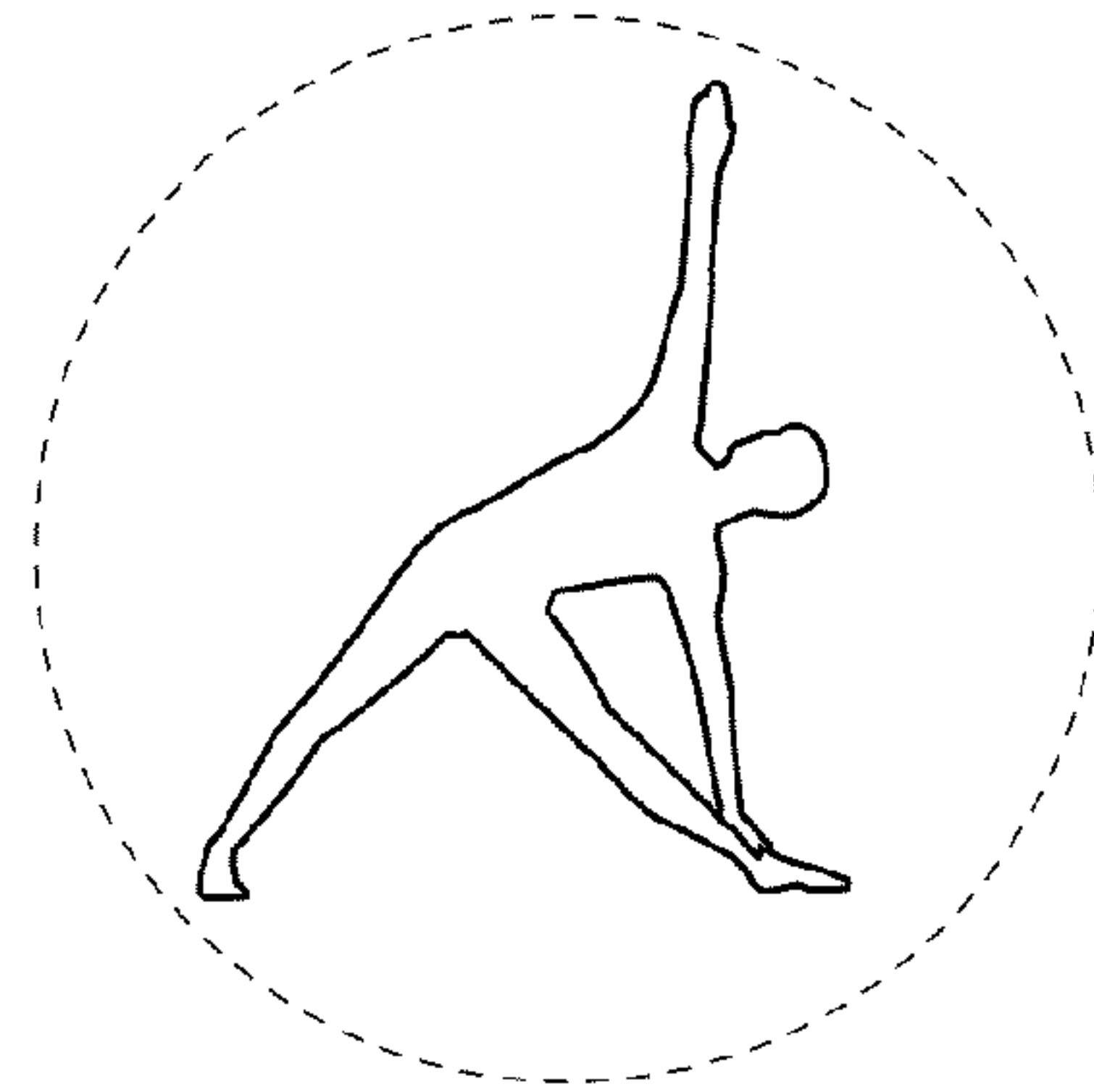

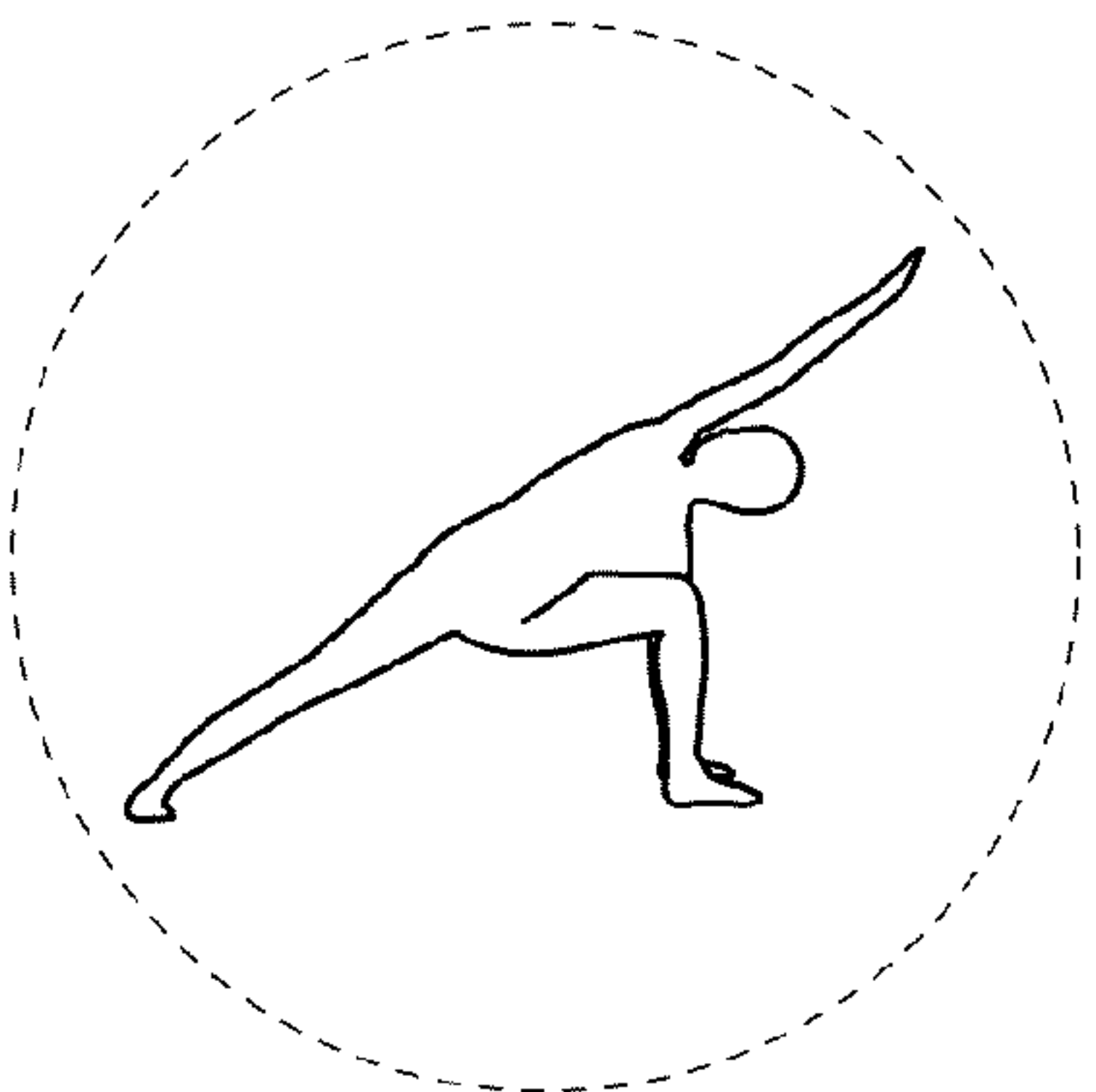

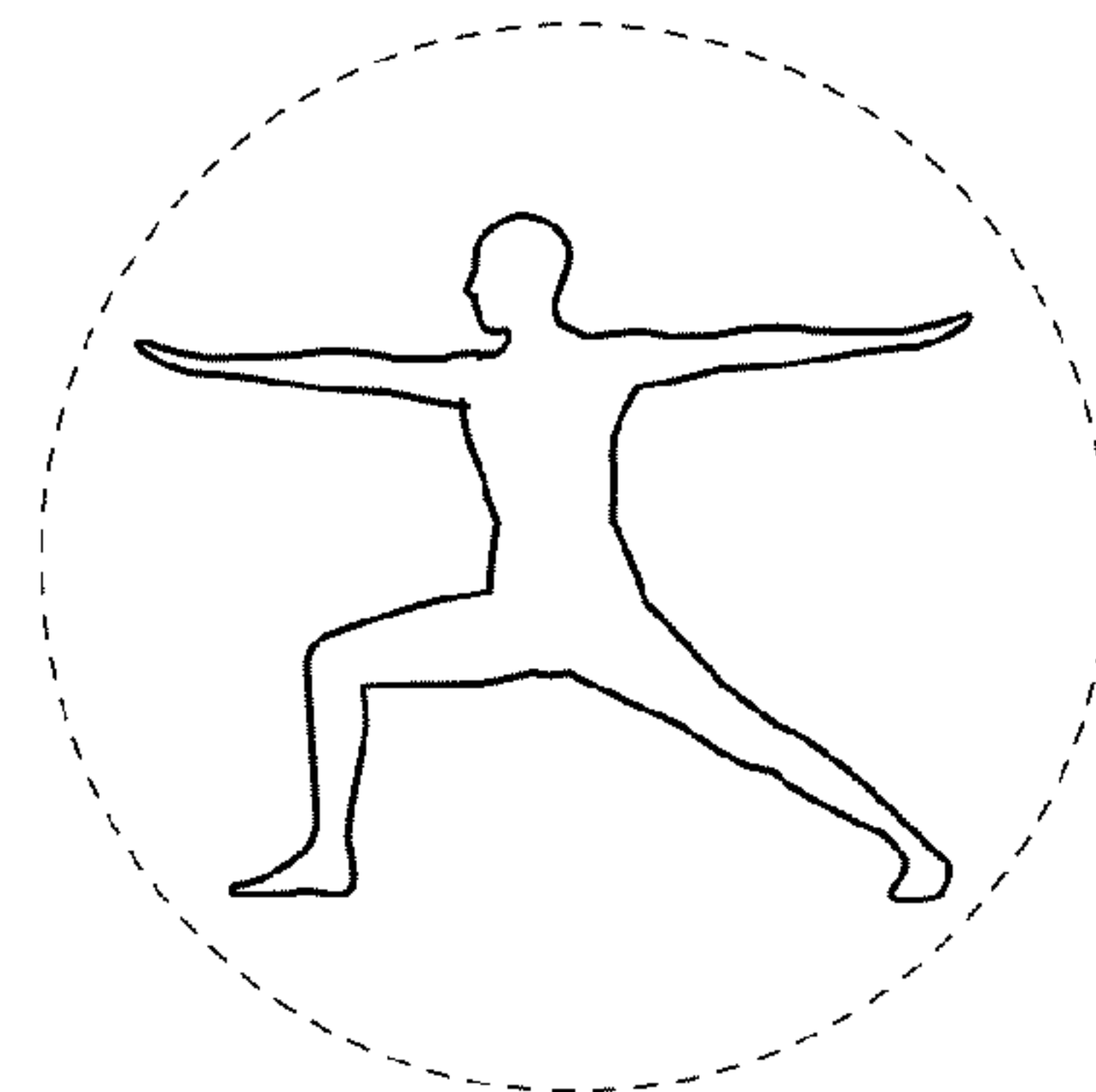

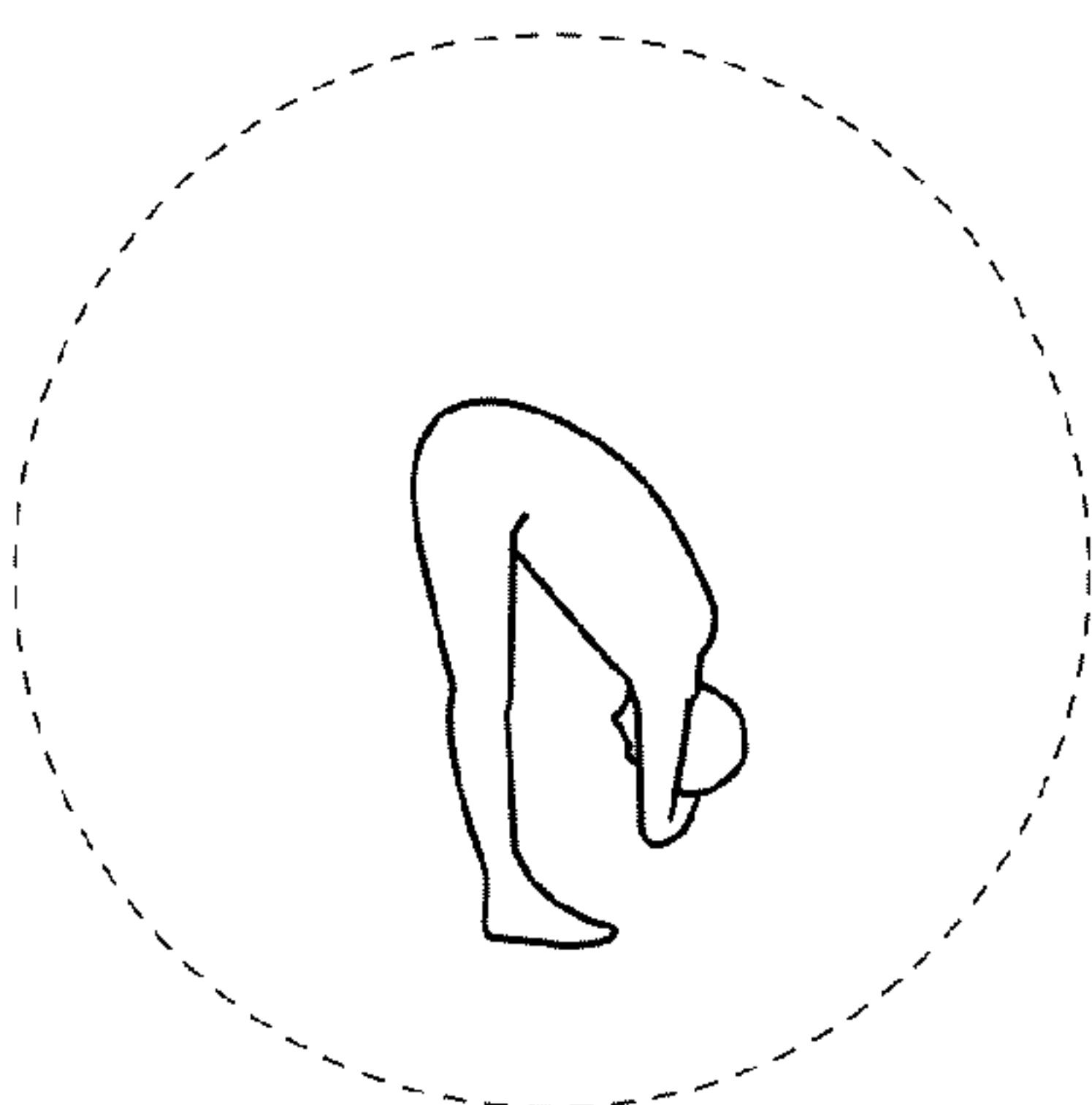

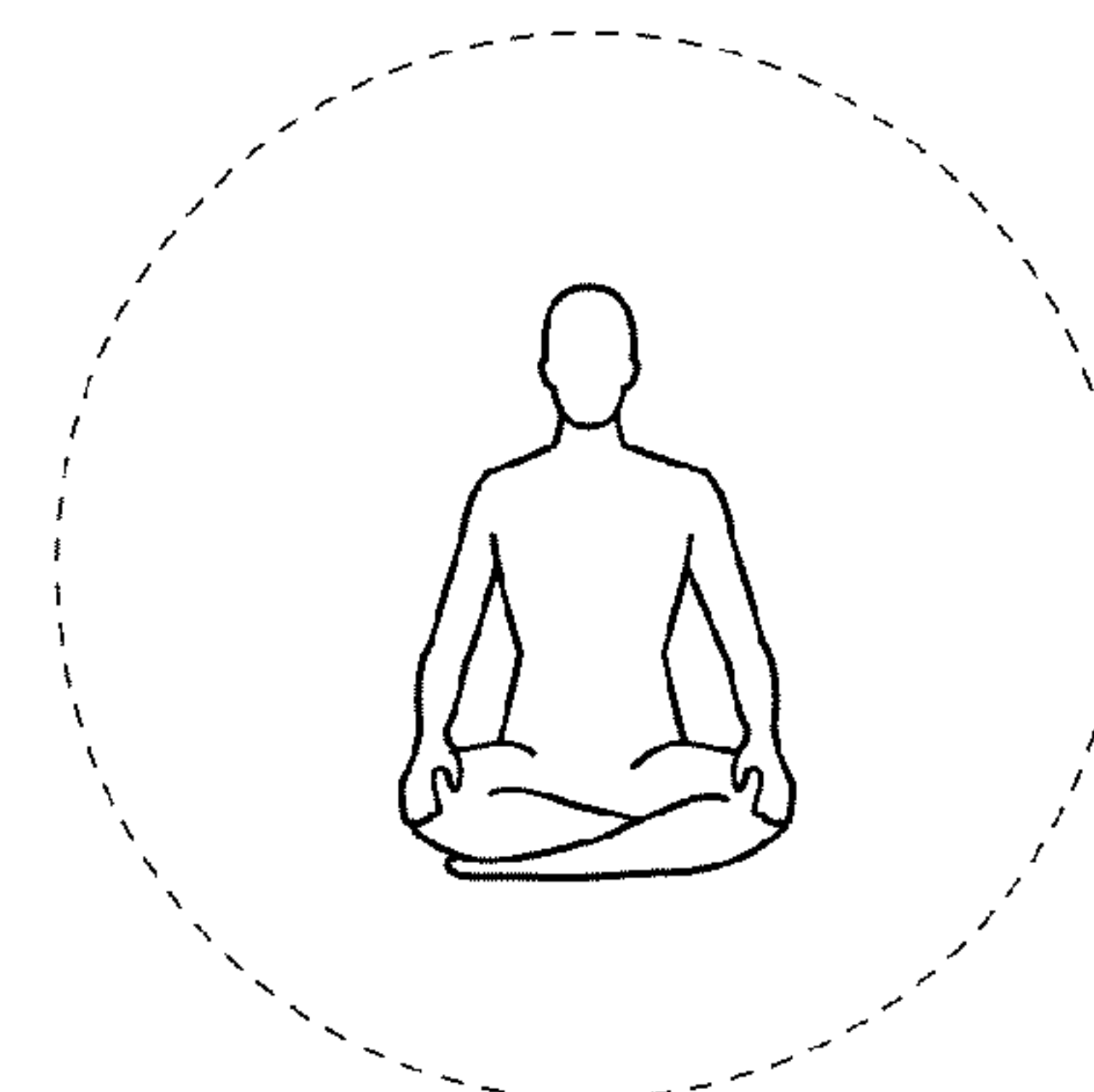

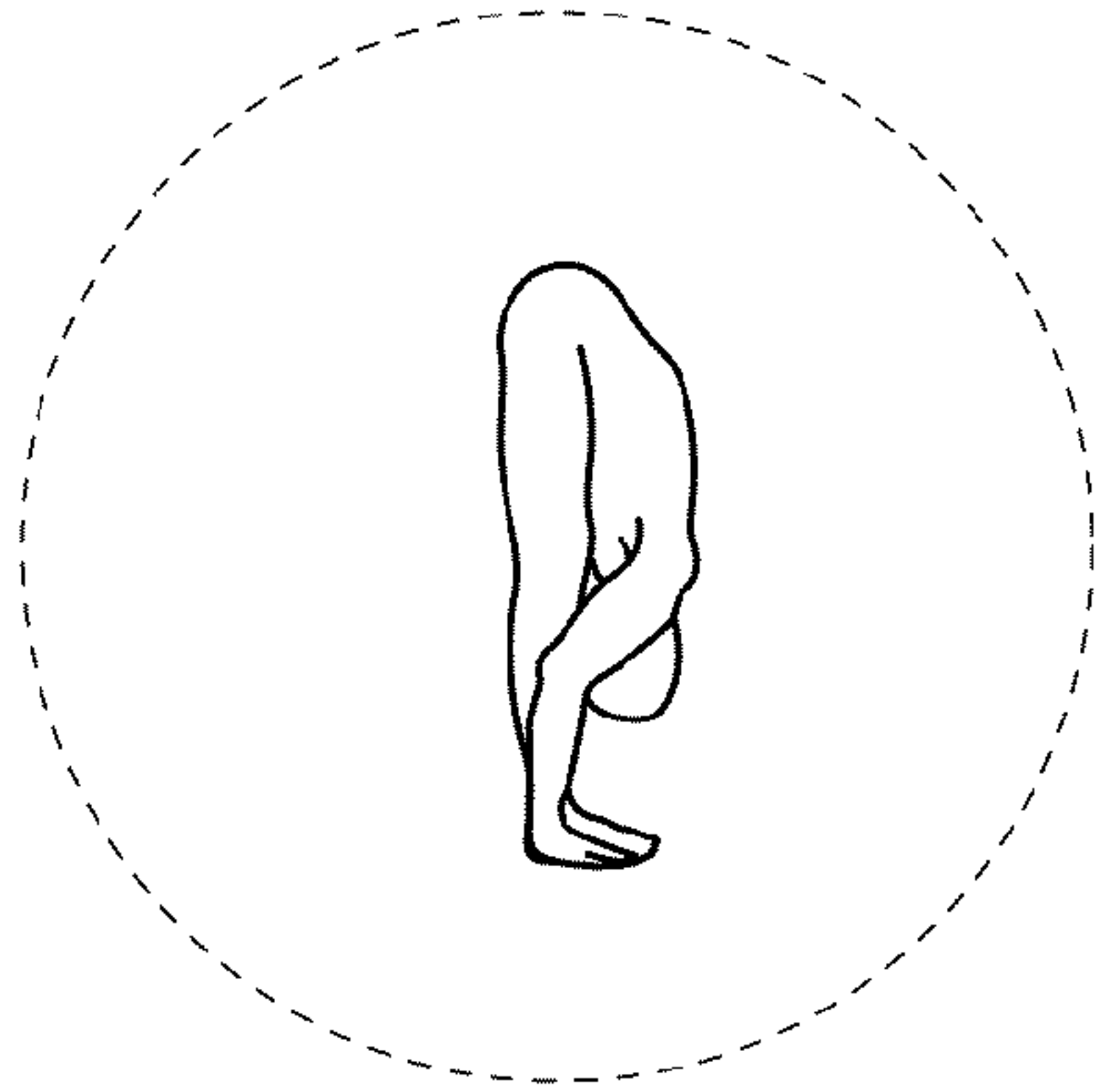

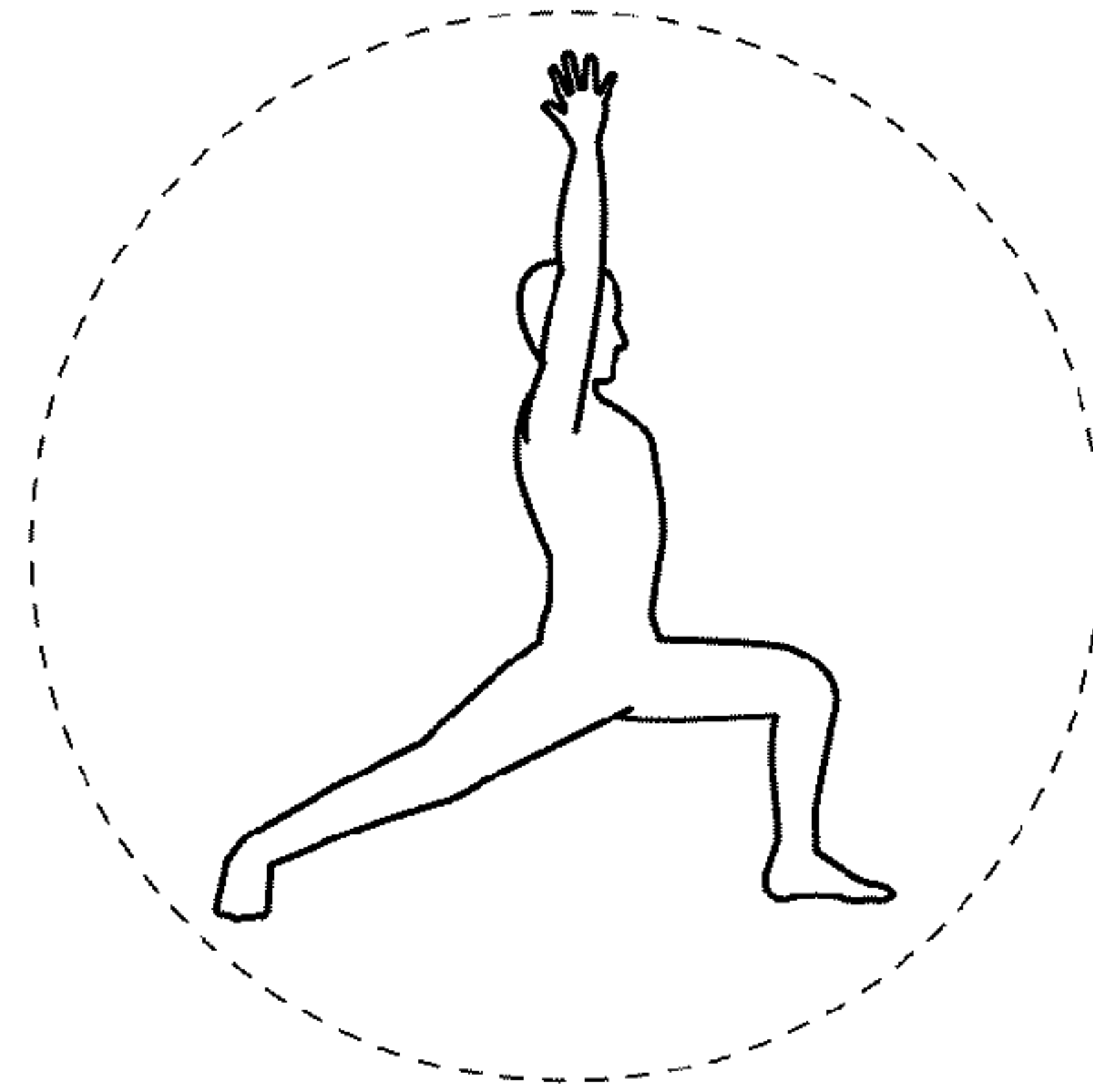

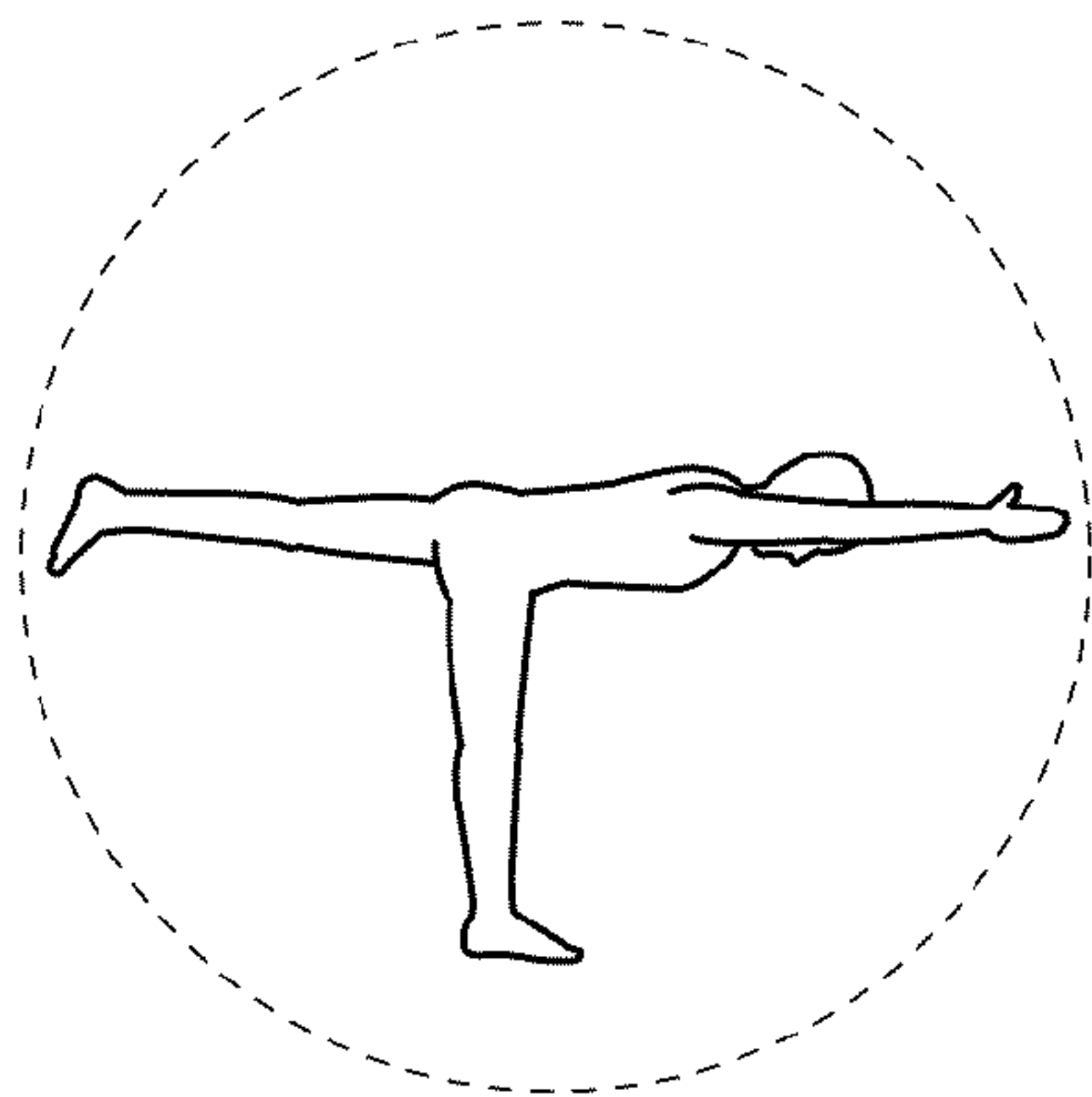

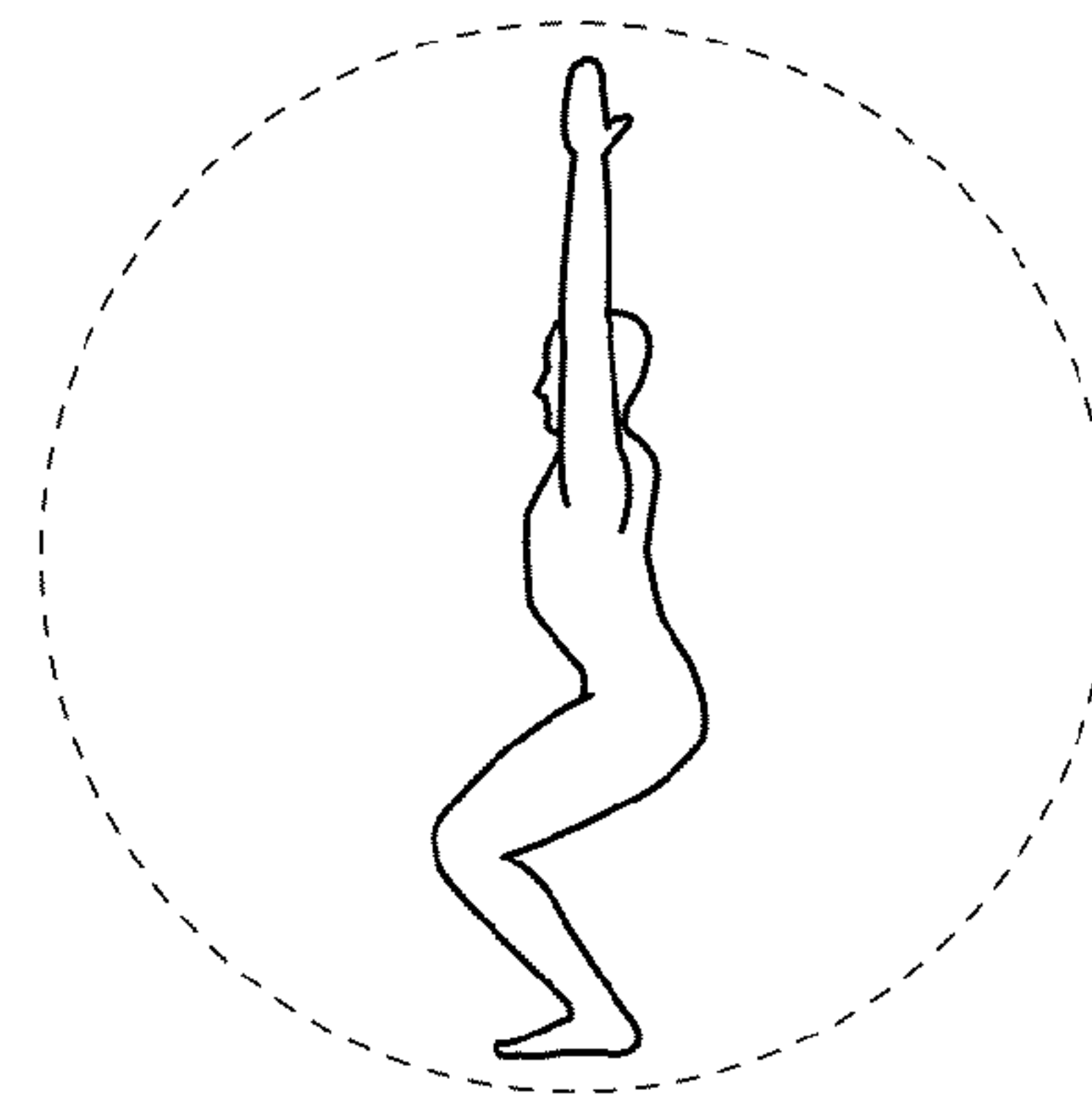
