FIG. 11 is a left side view of the embodiment of the claimed design of FIG. 8;

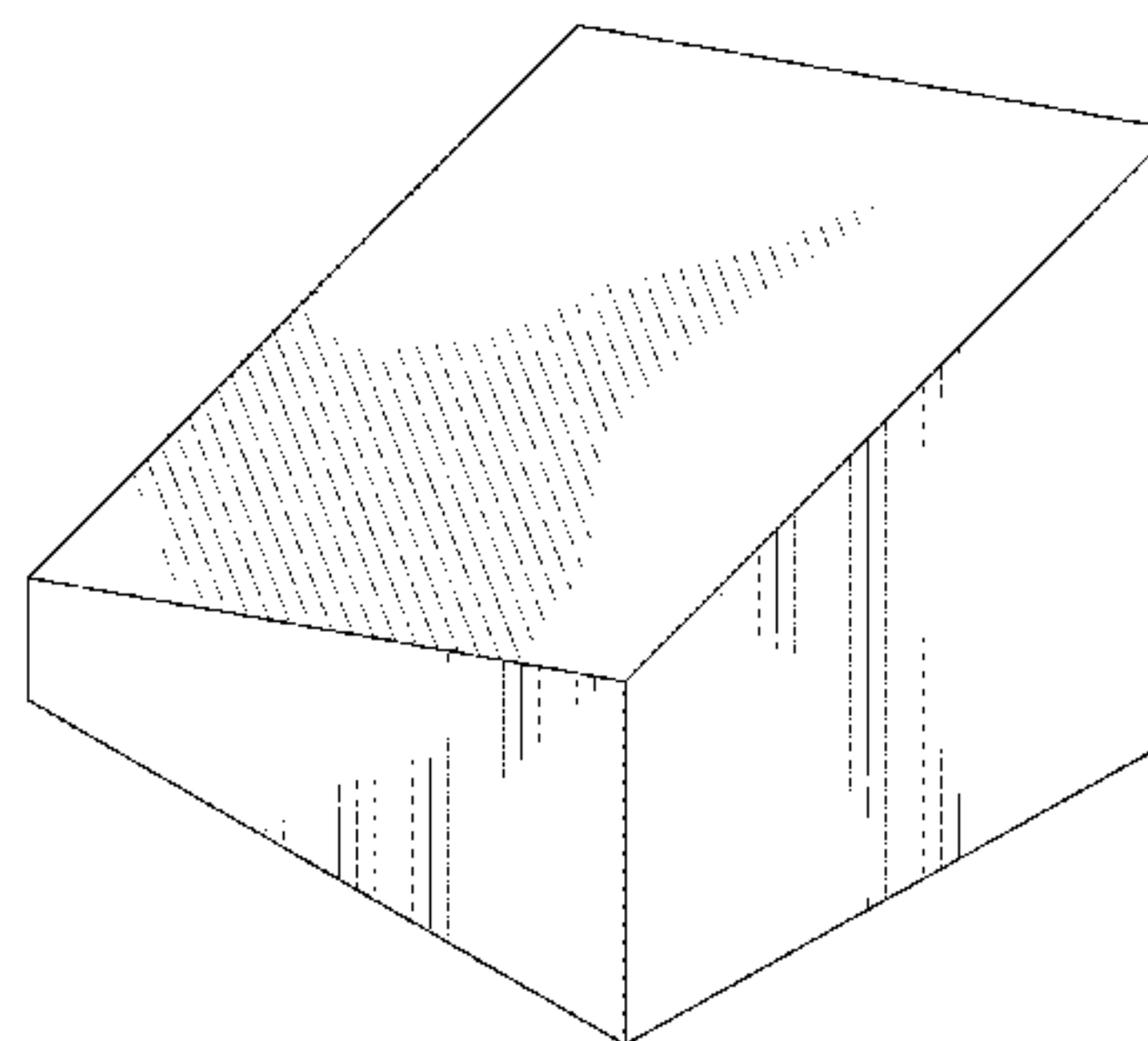
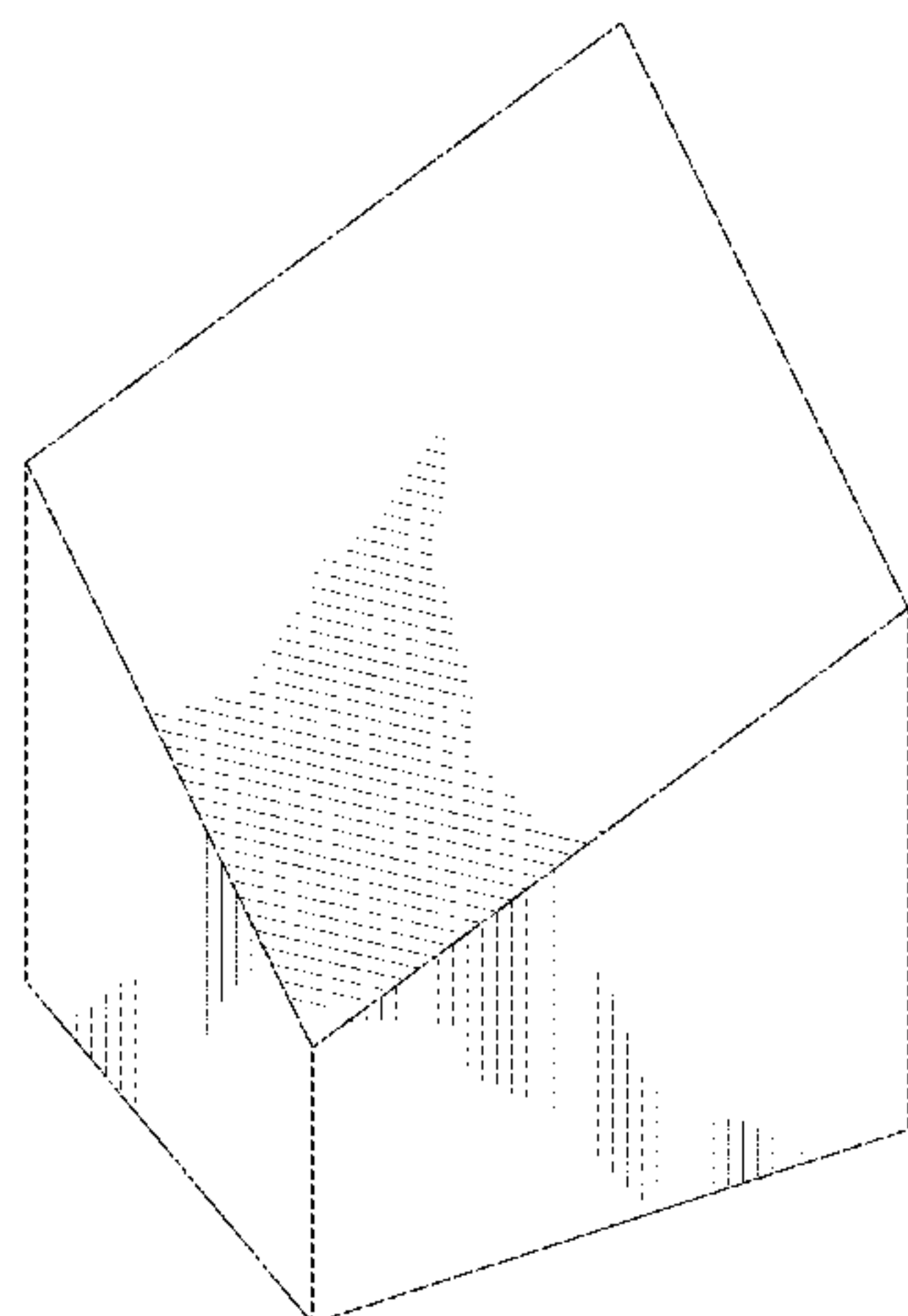
FIG. 12 is a right side view of the embodiment of the claimed design of FIG. 8;

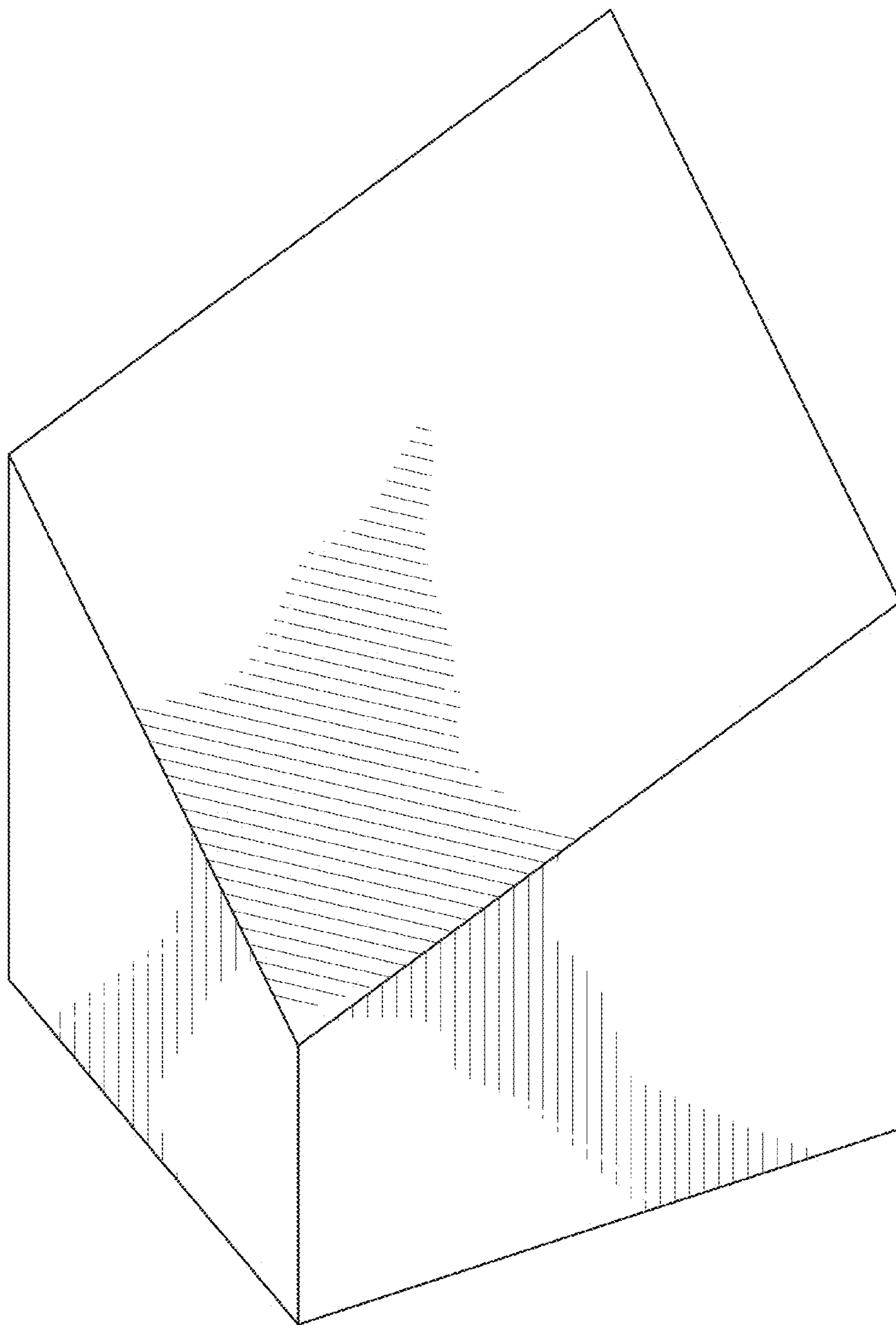

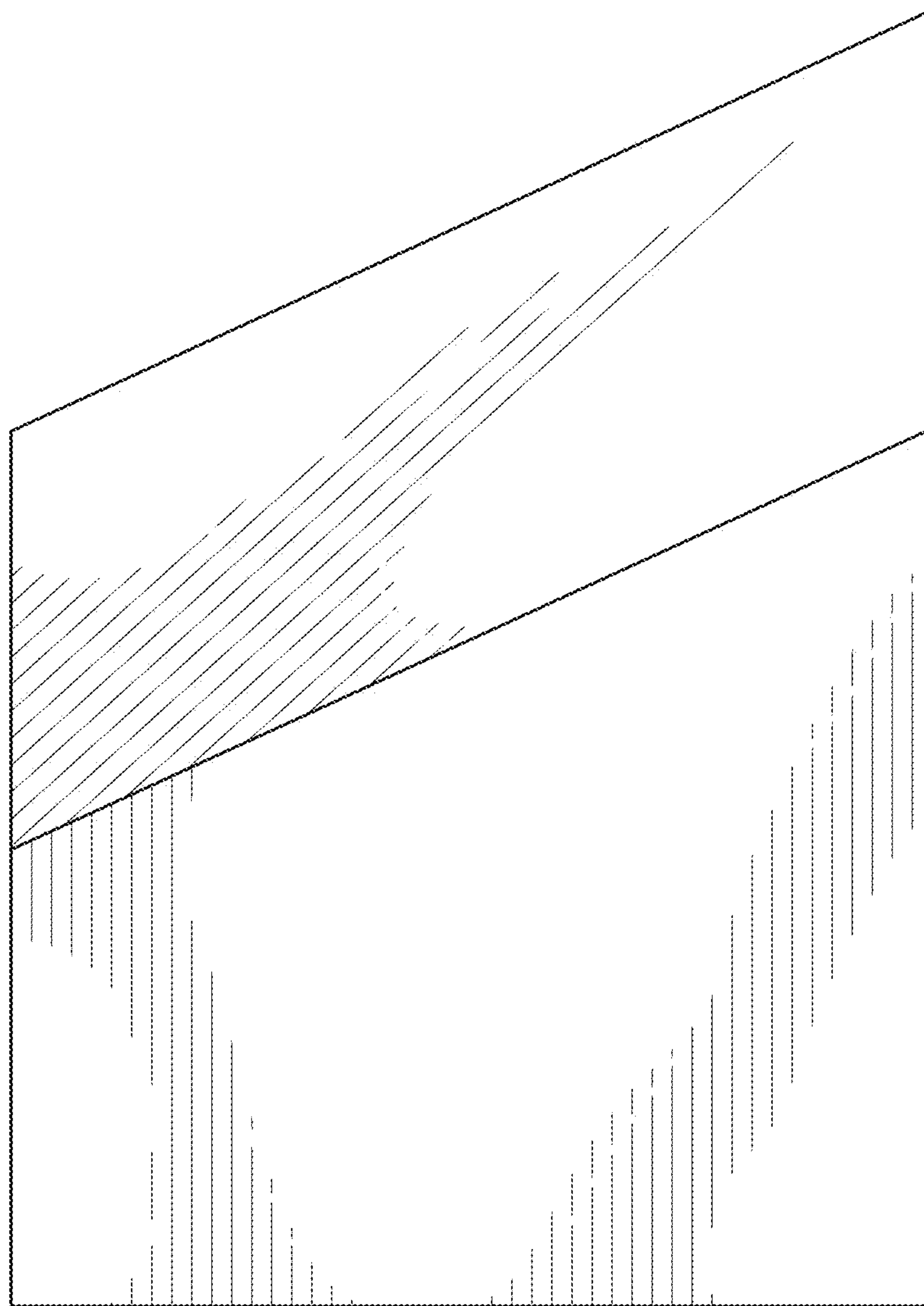

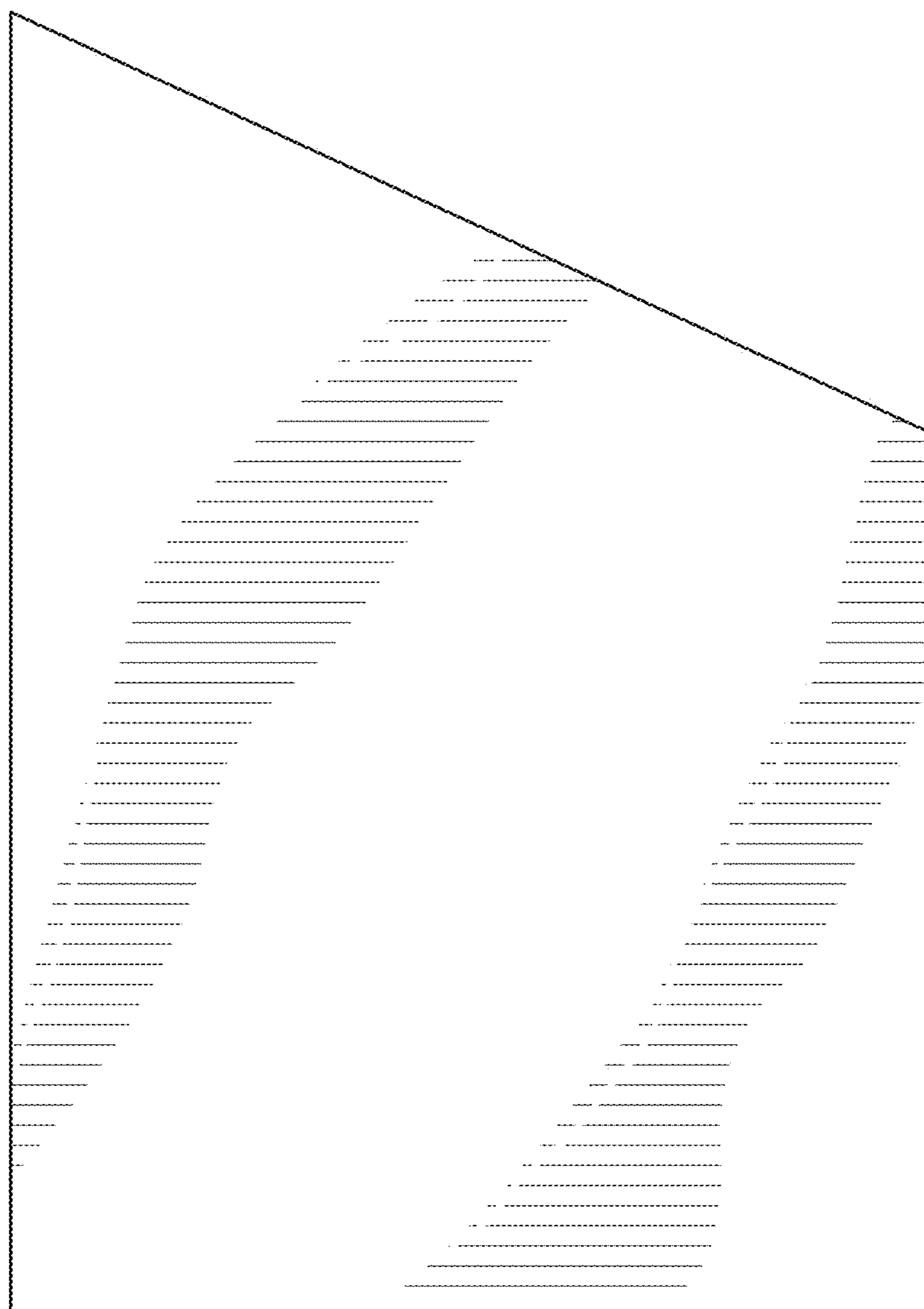

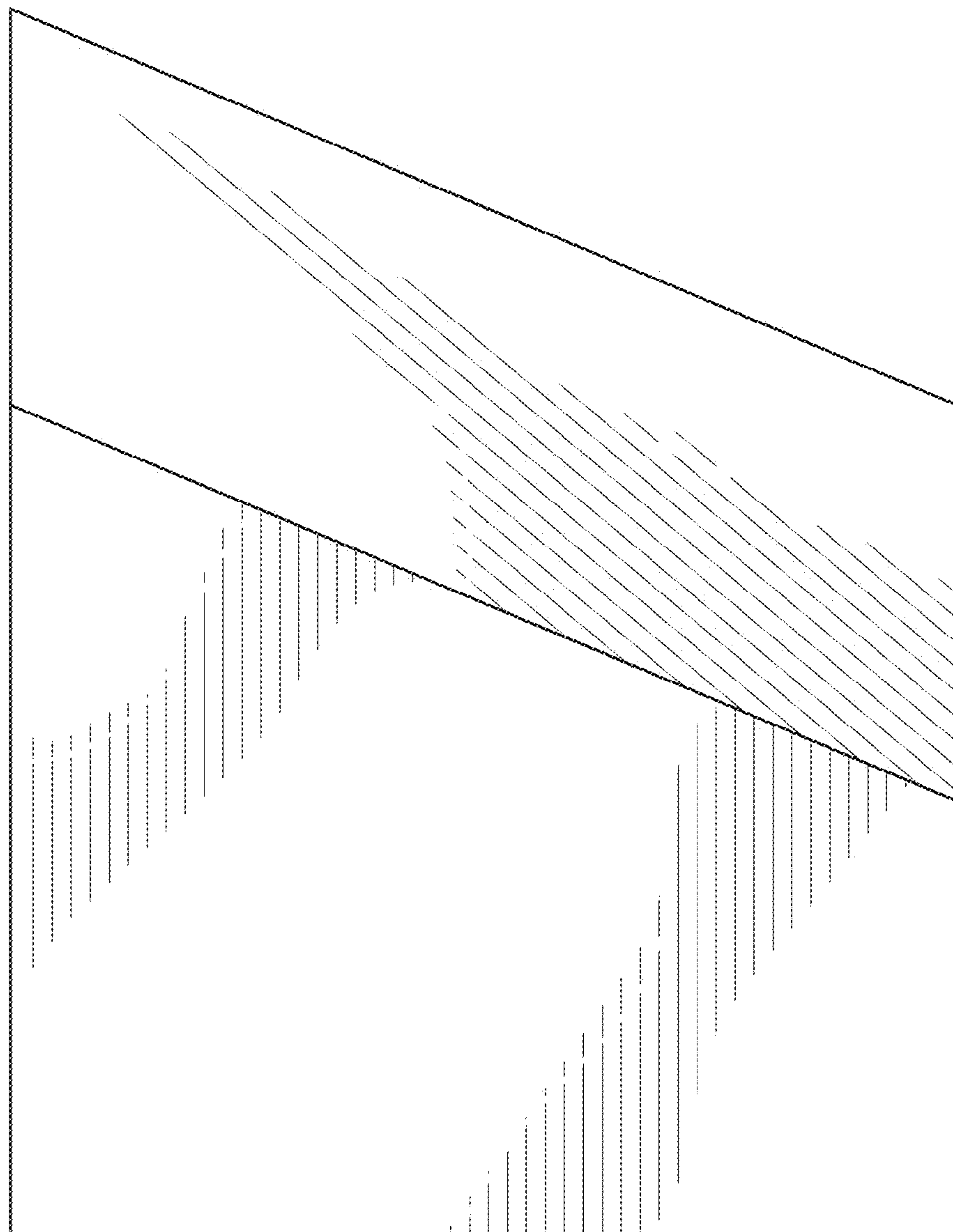

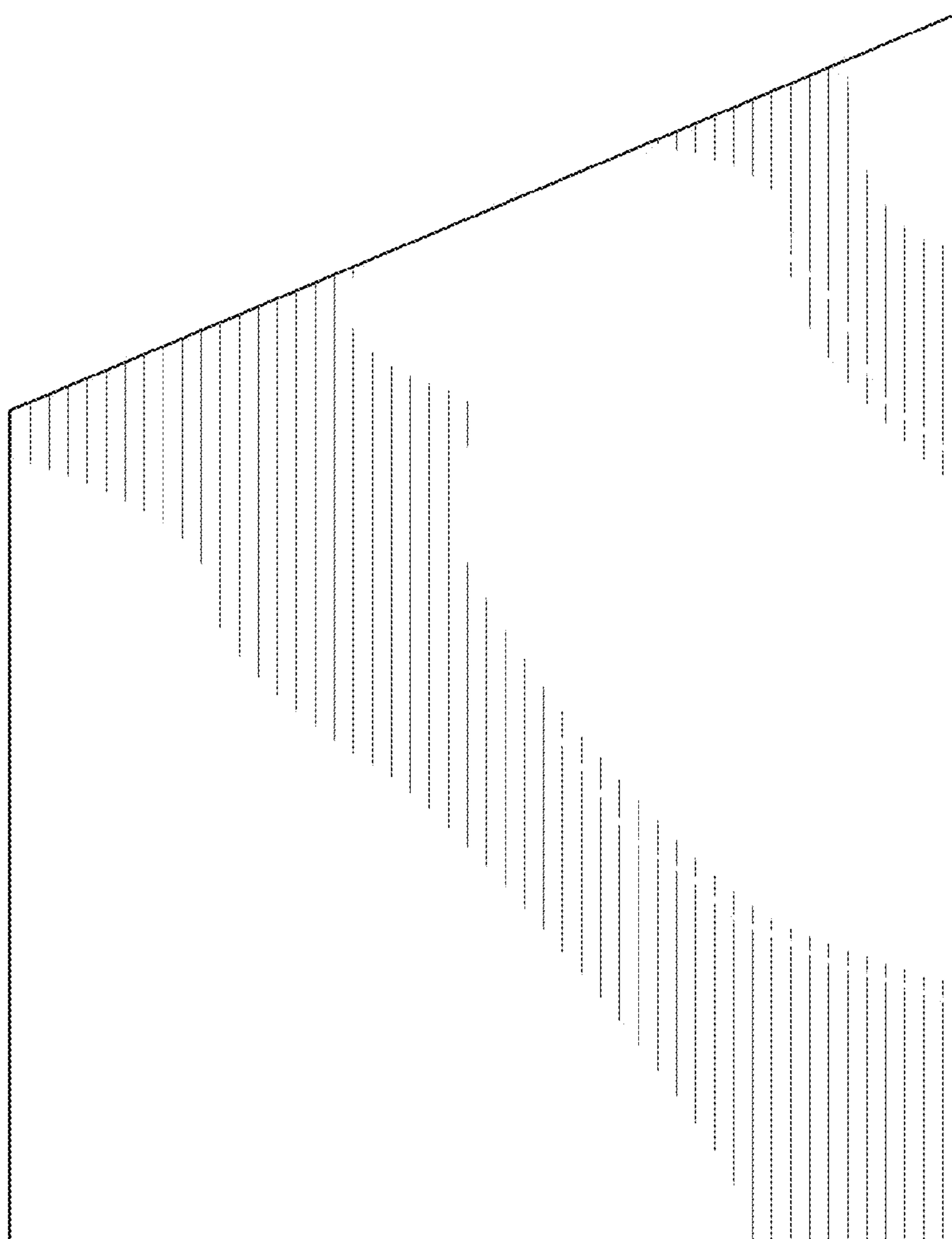

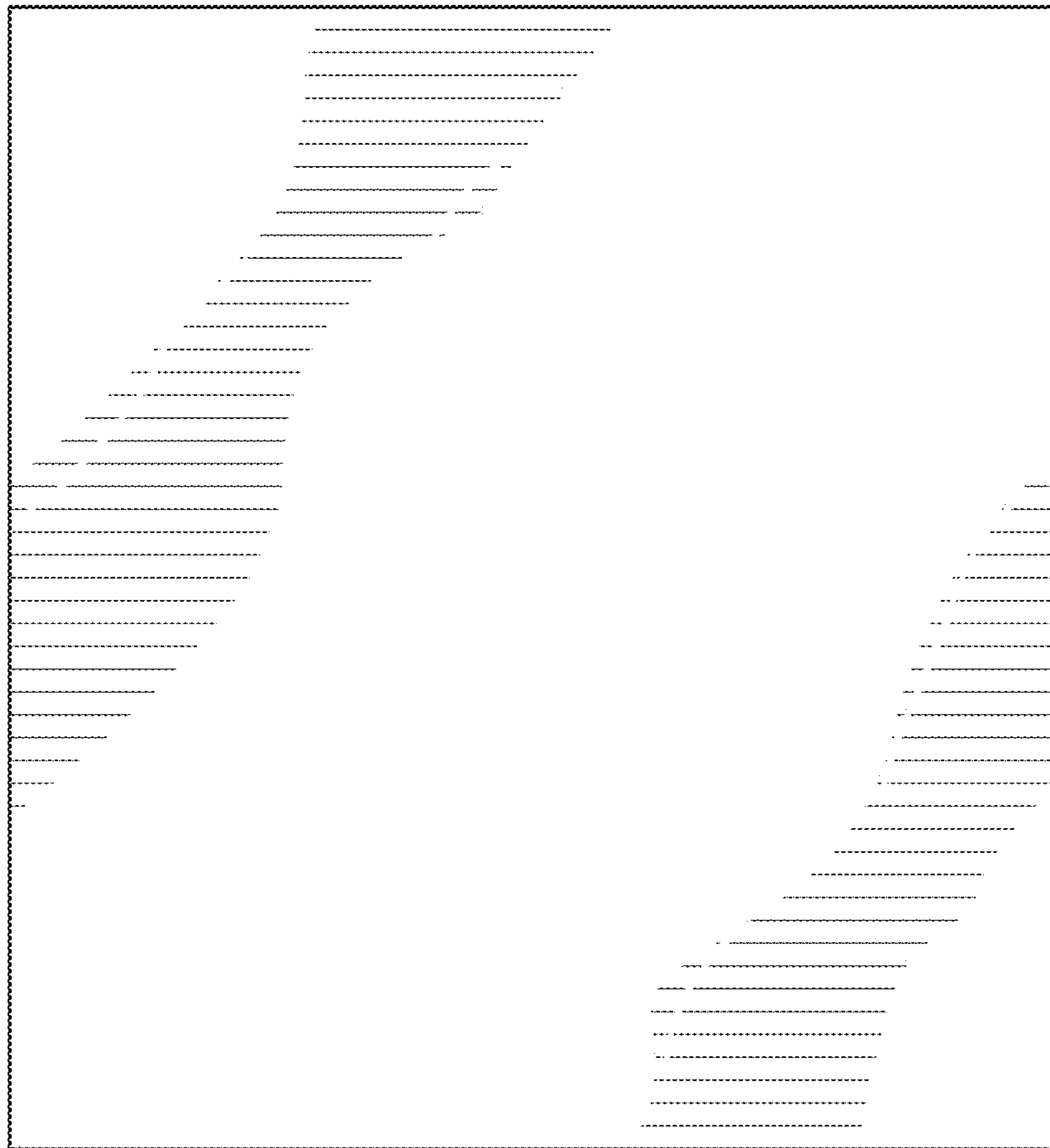

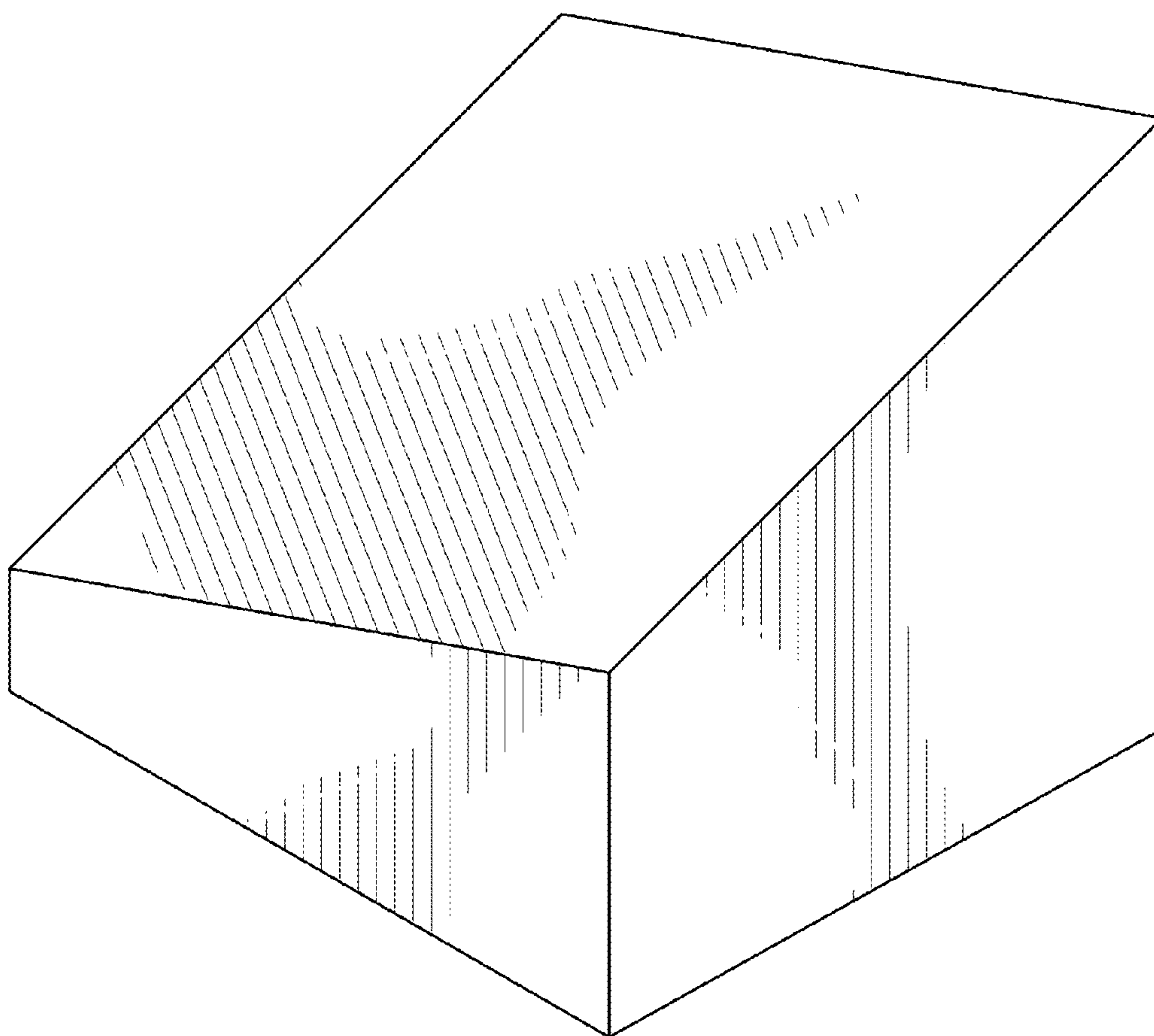

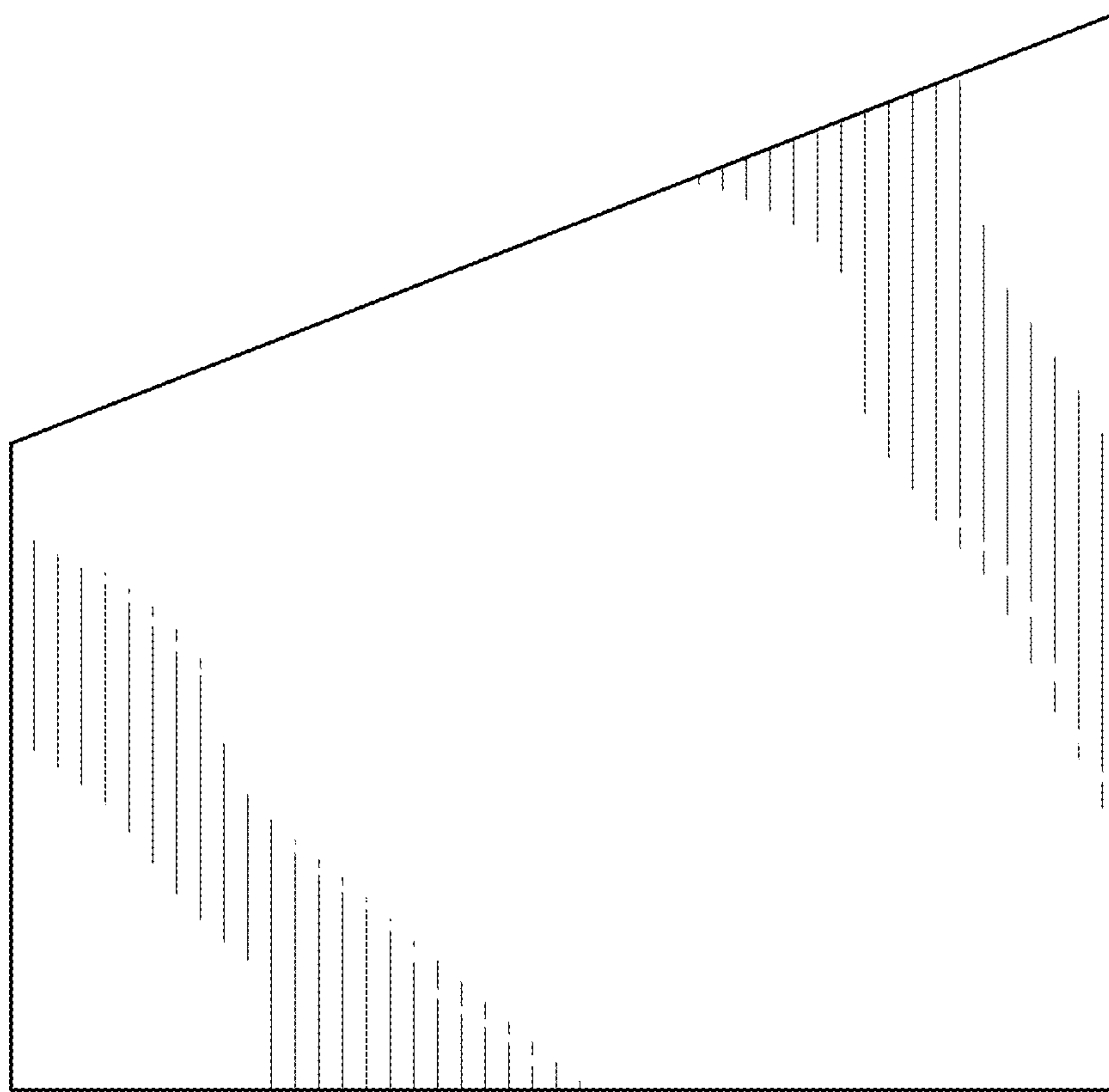

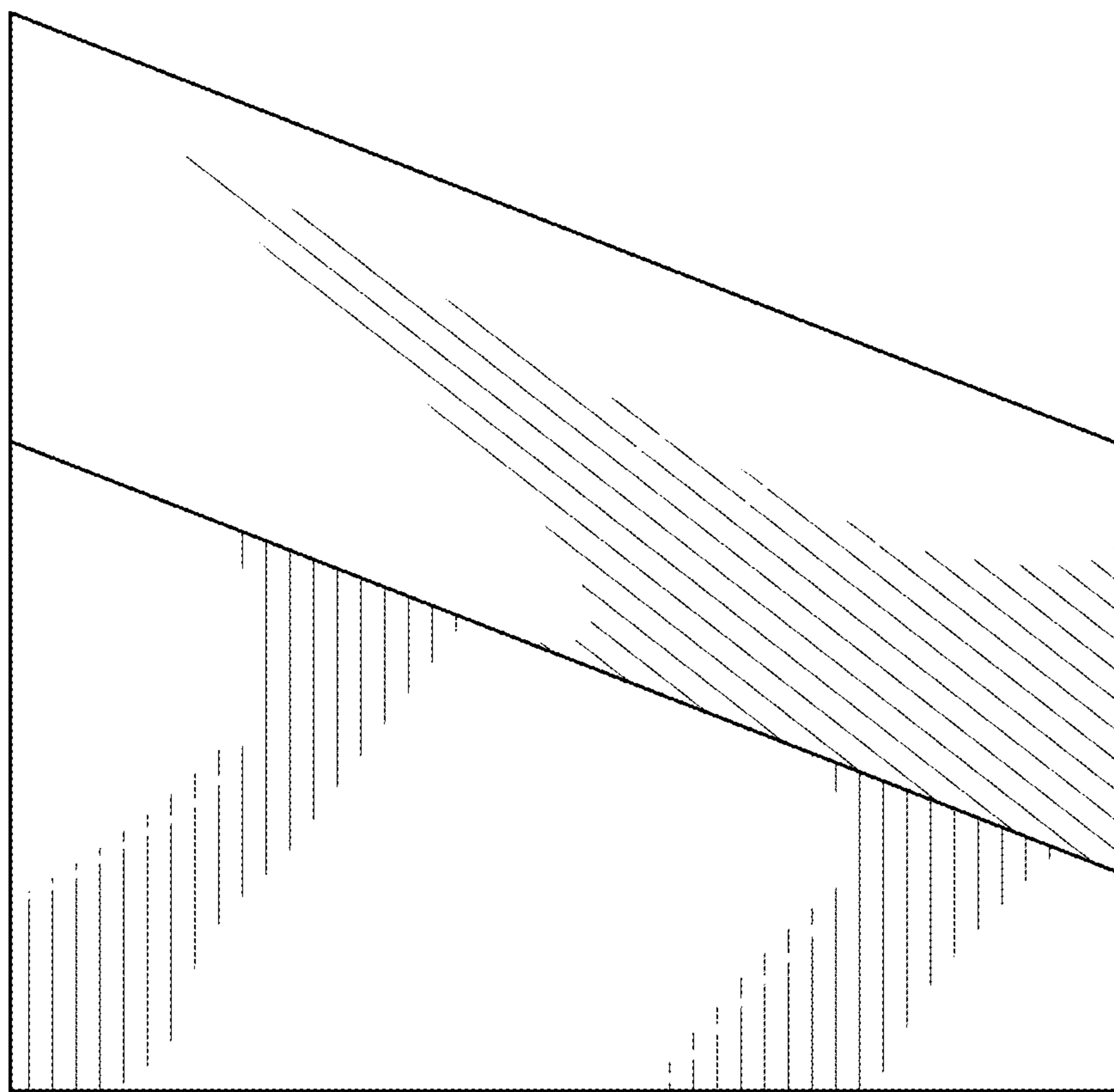

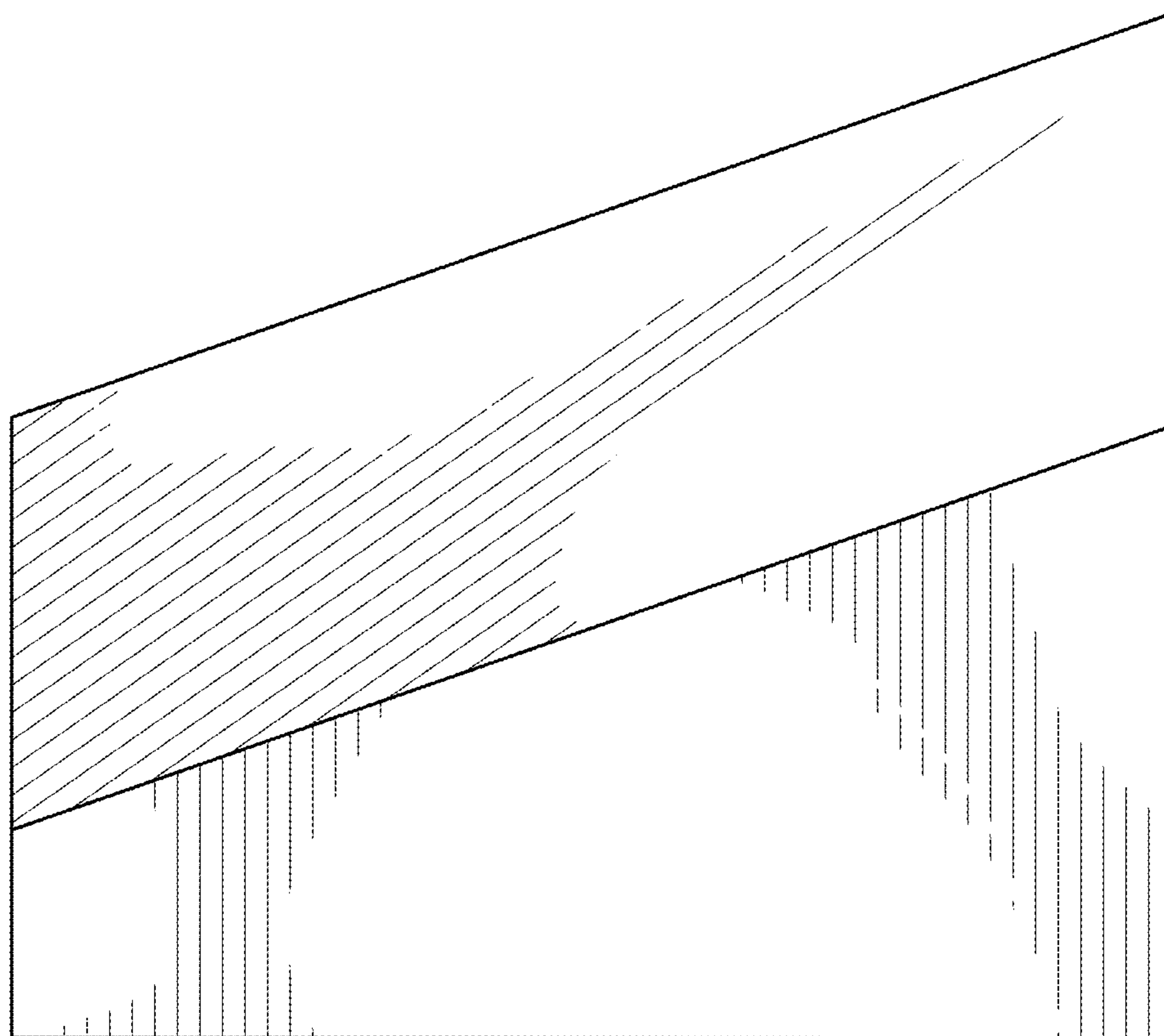

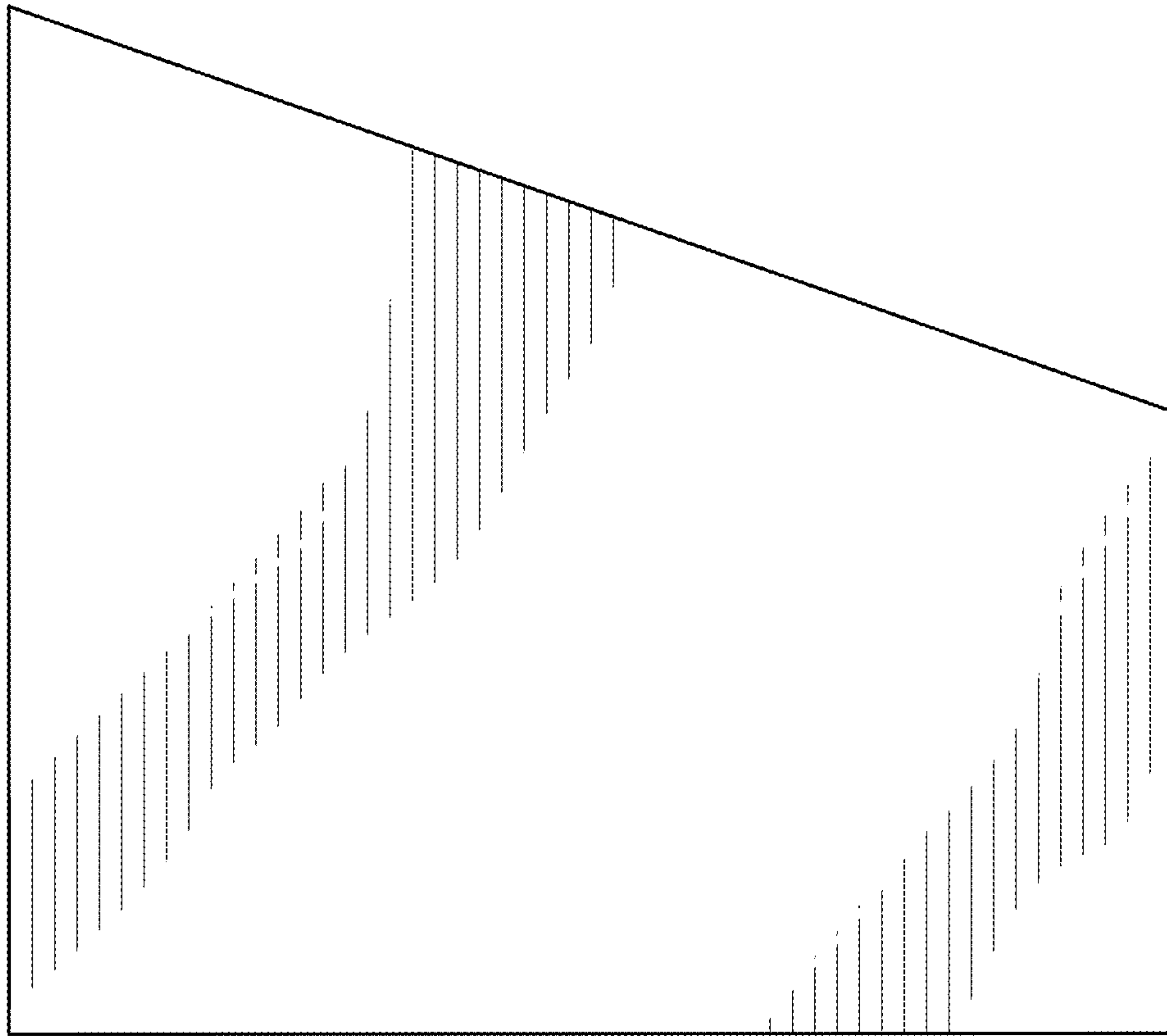

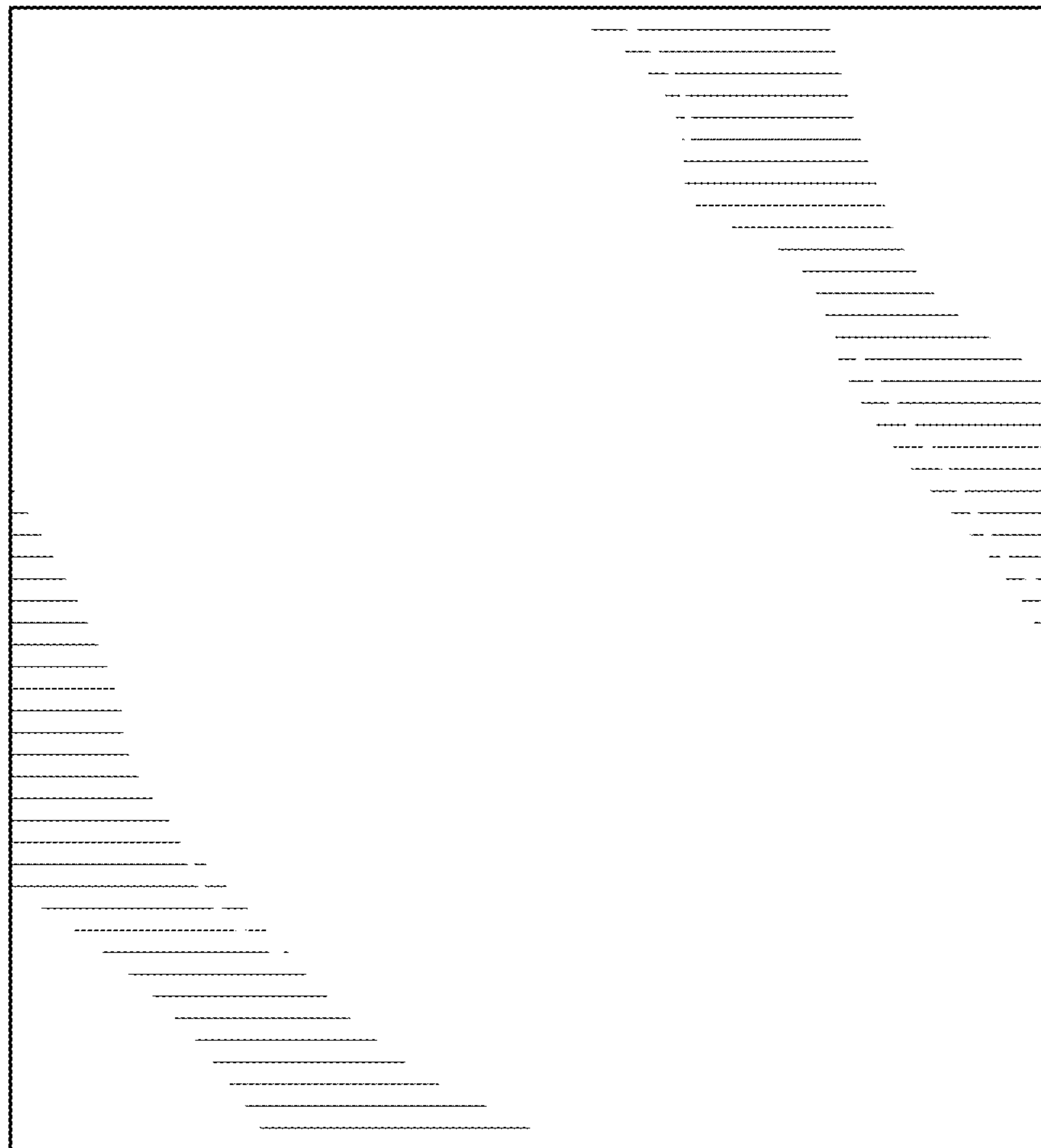
