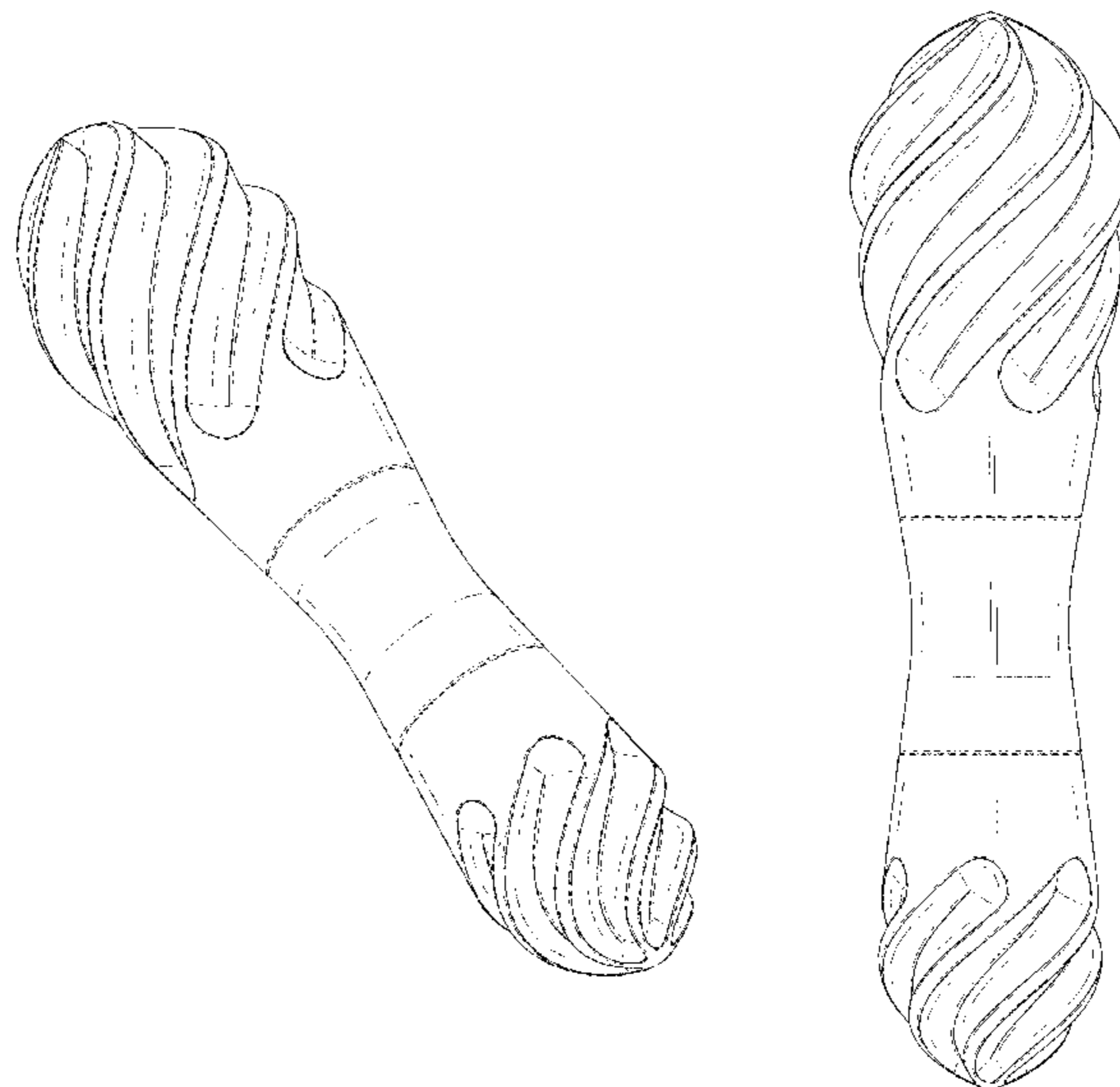
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a dual citrus reamer showing my new design;

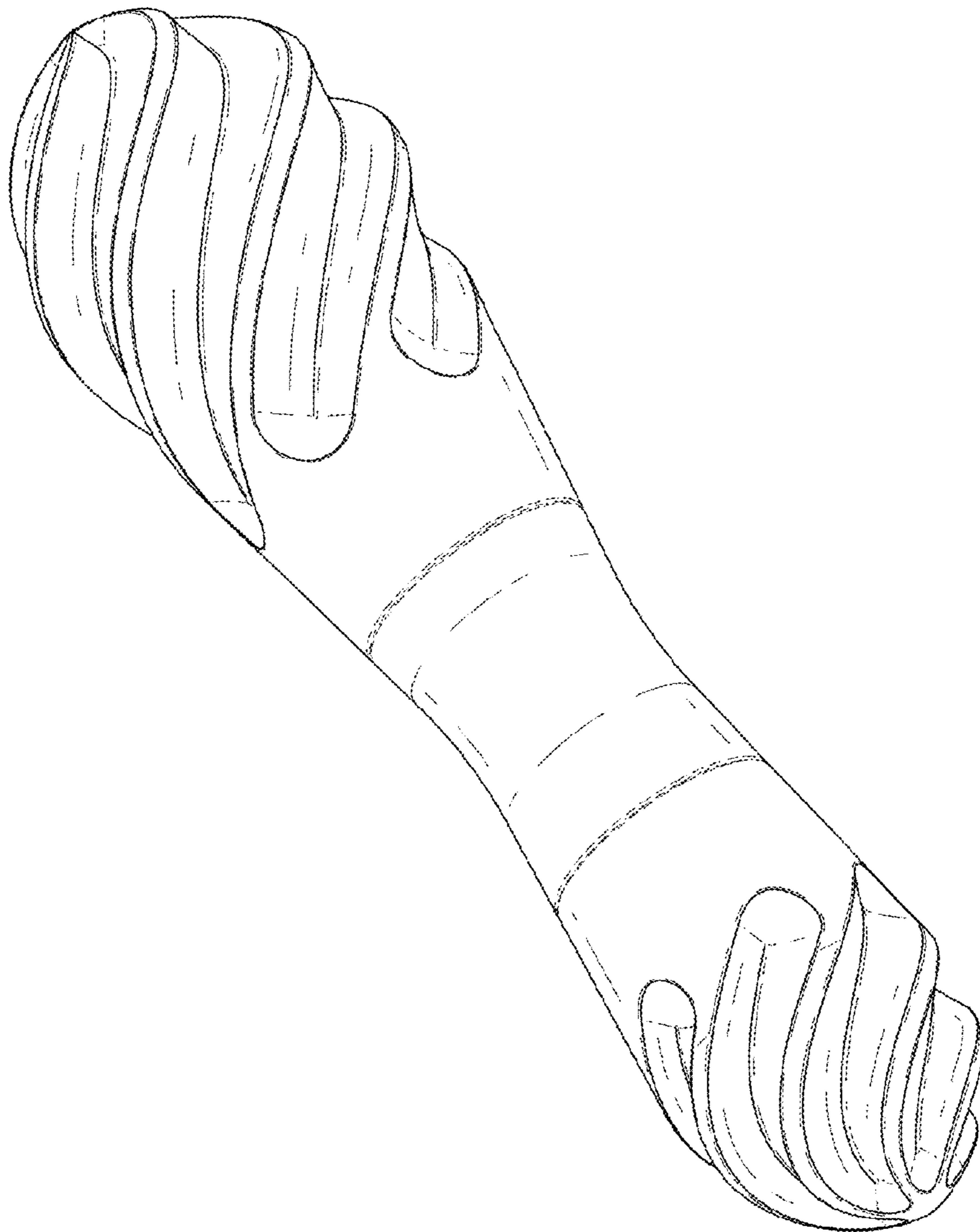

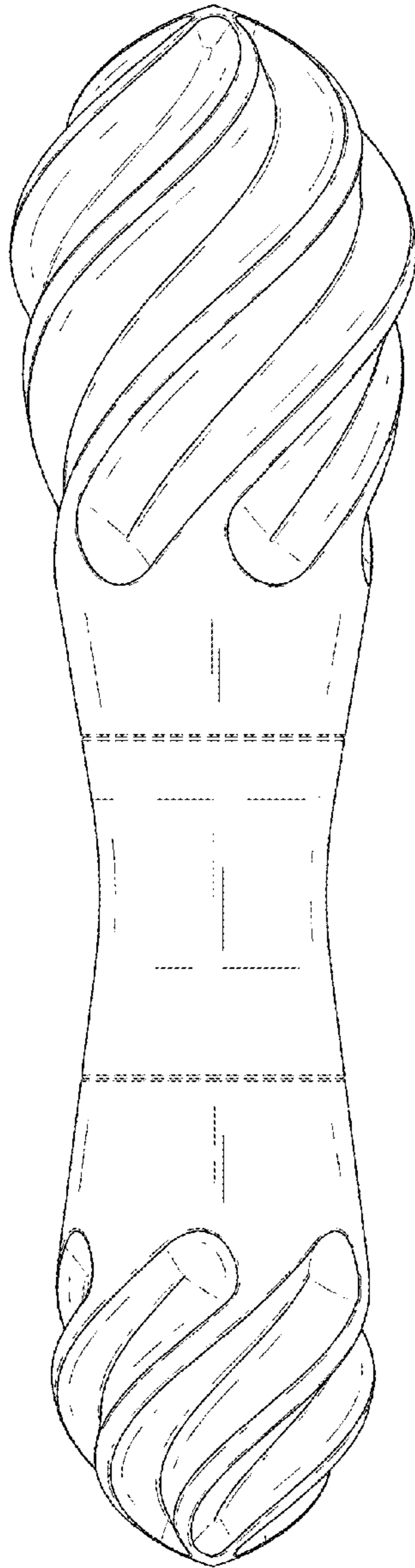

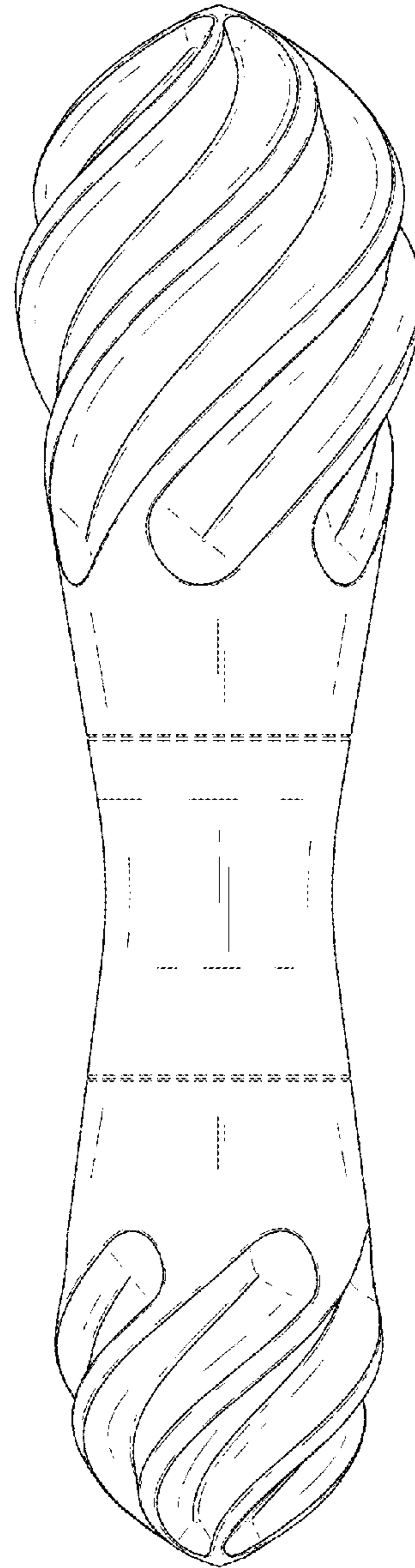

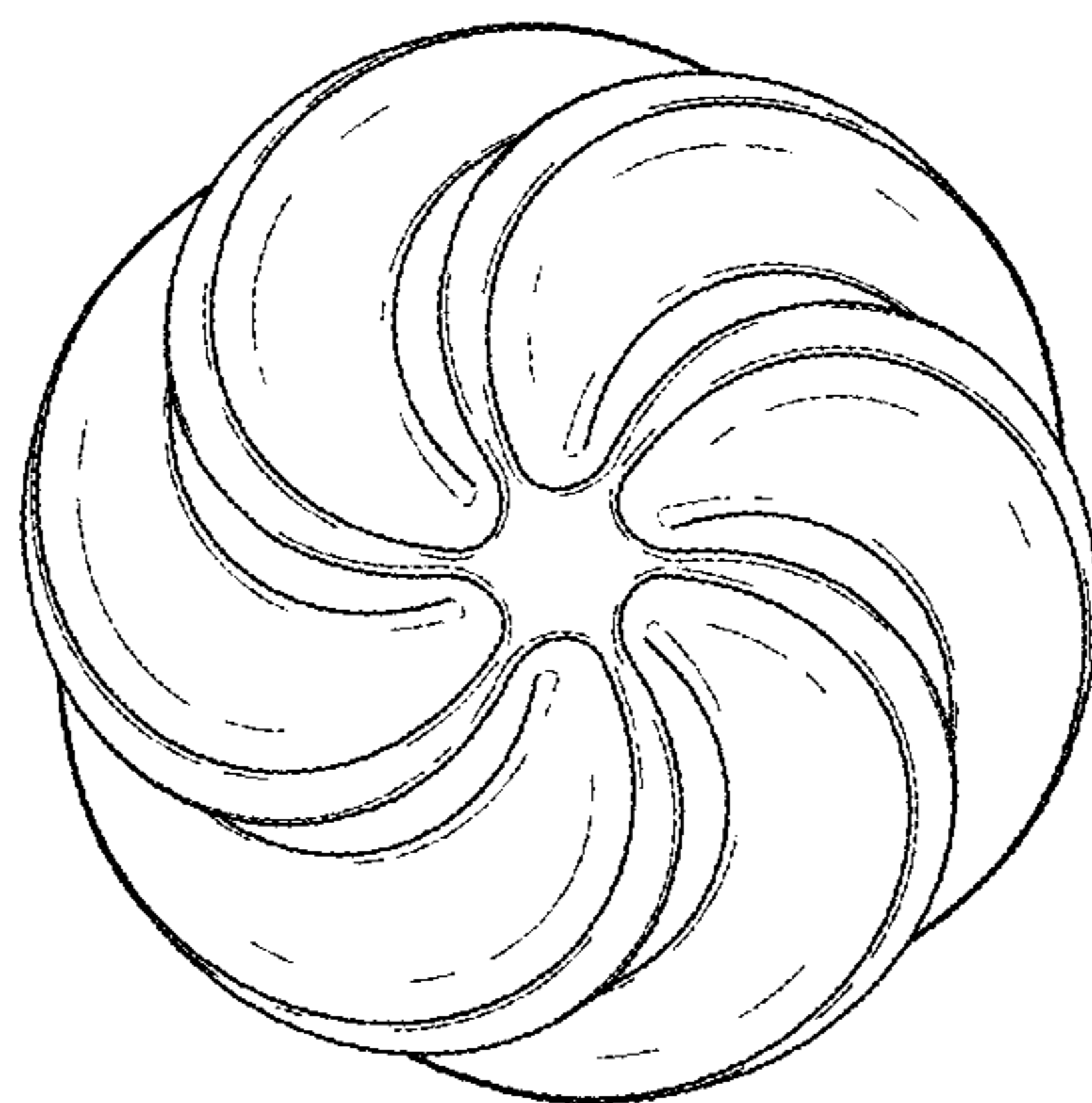

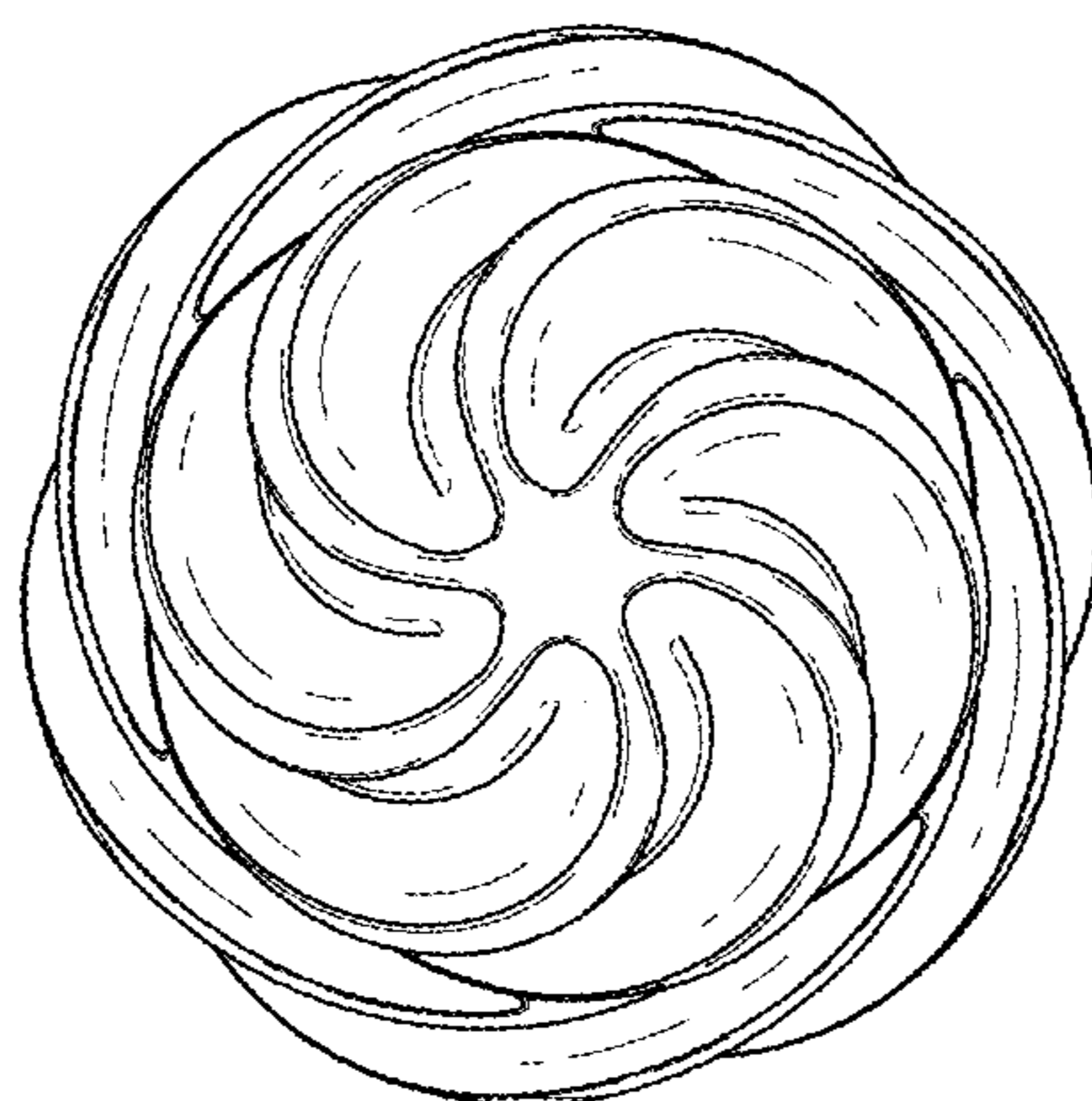
