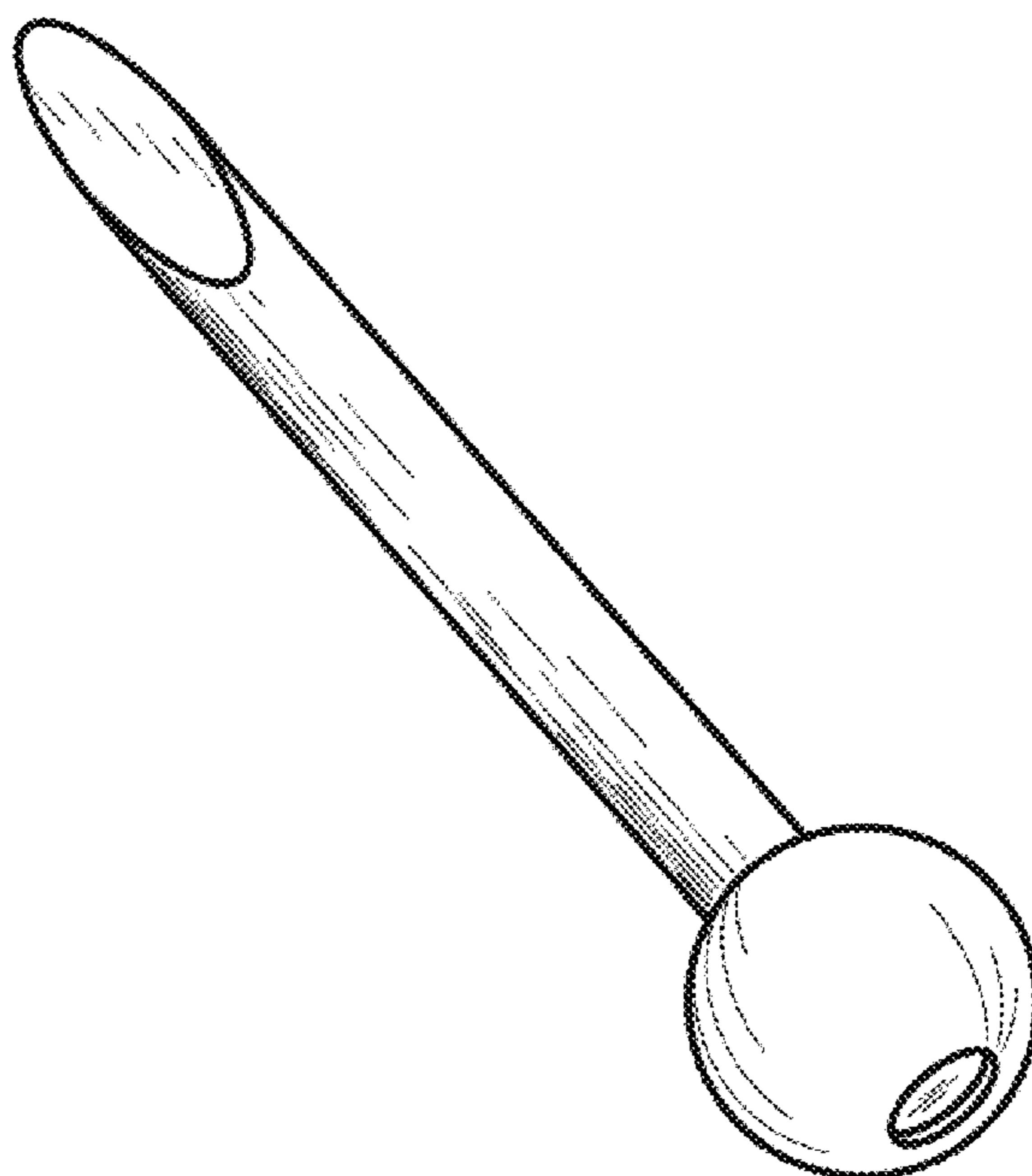
(57) **CLAIM**

I claim the ornamental design for a wood pinching wedge, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wood pinching wedge, showing a first embodiment of my new design;
 FIG. 2 is a bottom plan view of FIG. 1;
 FIG. 3 is a top plan view of FIG. 1;
 FIG. 4 is a left-side elevational view of FIG. 1, the right-side elevational view being a mirror image thereof;
 FIG. 5 is a front elevational view of FIG. 1;
 FIG. 6 is a rear elevational view of FIG. 1;
 FIG. 7 is a perspective view of a second embodiment thereof;
 FIG. 8 is a bottom plan view of FIG. 7;
 FIG. 9 is a top plan view of FIG. 7;
 FIG. 10 is a left-side elevational view of FIG. 7, the right-side elevational view being a mirror image thereof;
 FIG. 11 is a front elevational view of FIG. 7; and
 FIG. 12 is a rear elevational view of FIG. 7.
 FIG. 13 is a perspective view of a third embodiment thereof;
 FIG. 14 is a bottom plan view of FIG. 13;
 FIG. 15 is a top plan view of FIG. 13;
 FIG. 16 is a left-side elevational view of FIG. 13, the right-side elevational view being a mirror image thereof;

 FIG. 18 is a rear elevational view of FIG. 13.

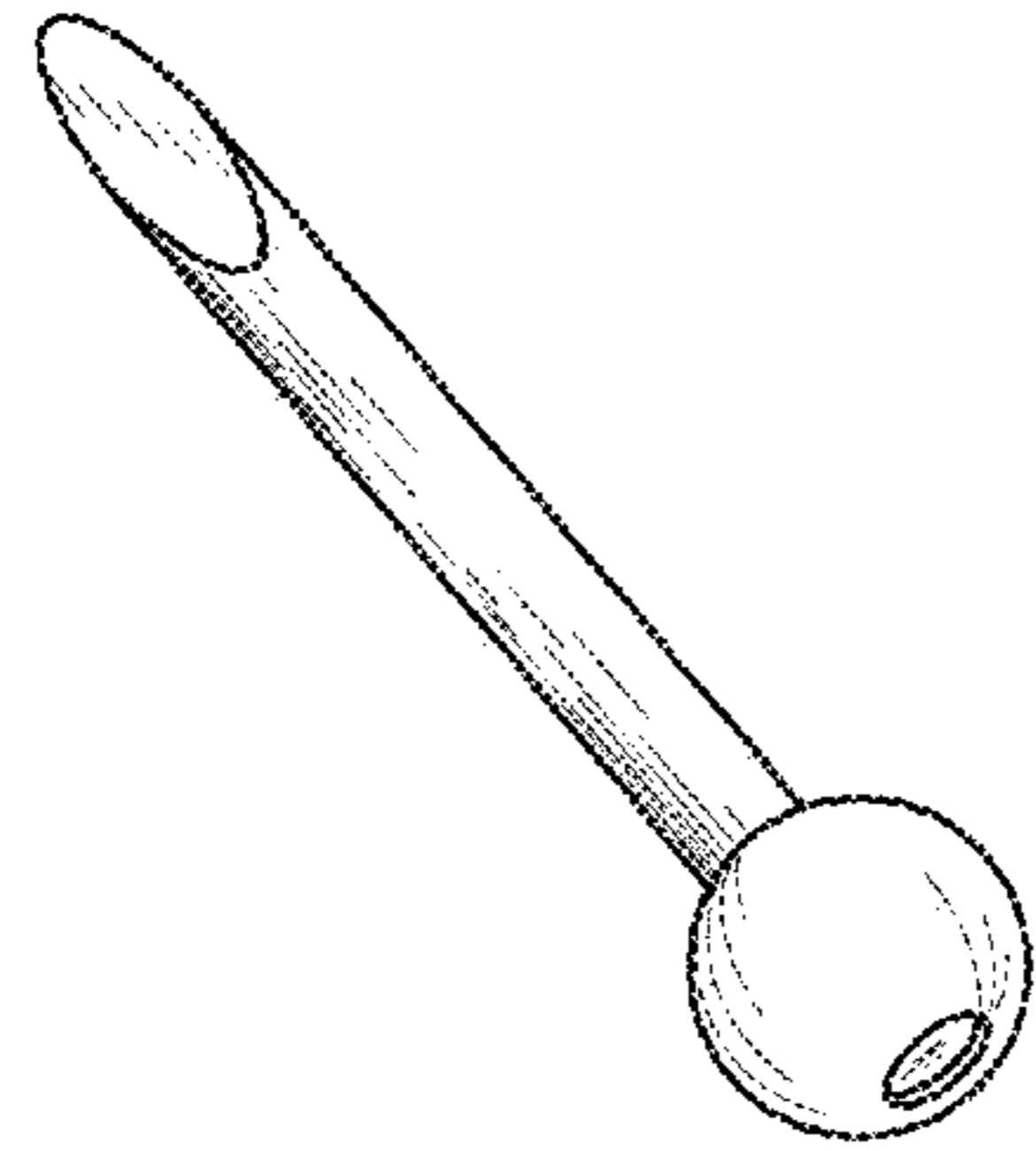

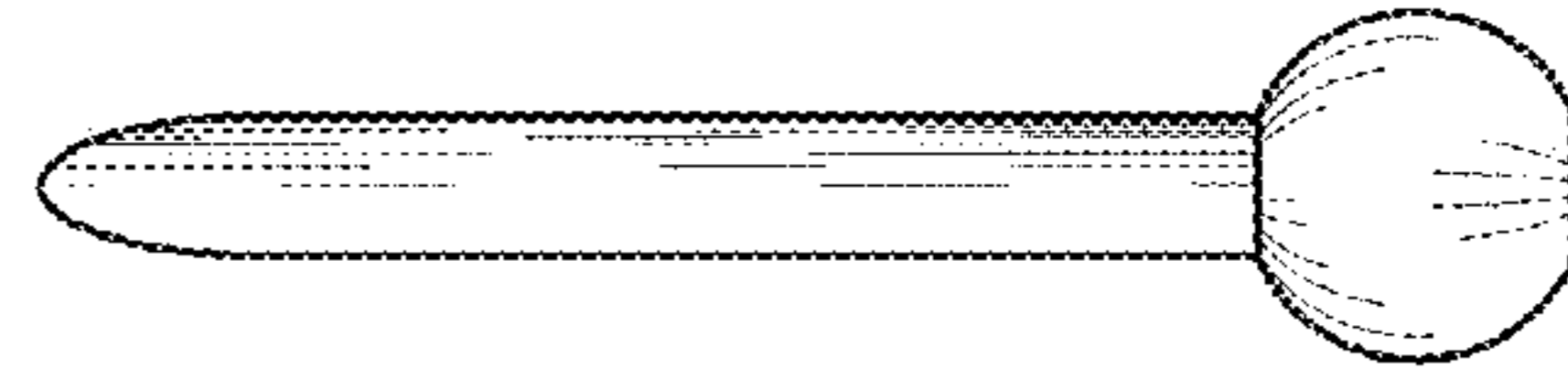

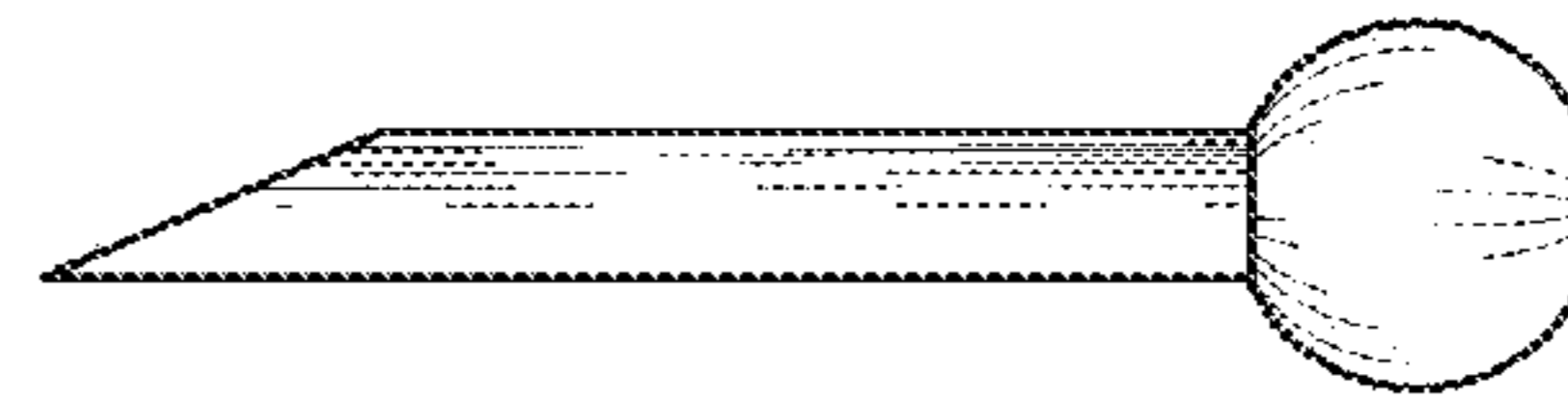

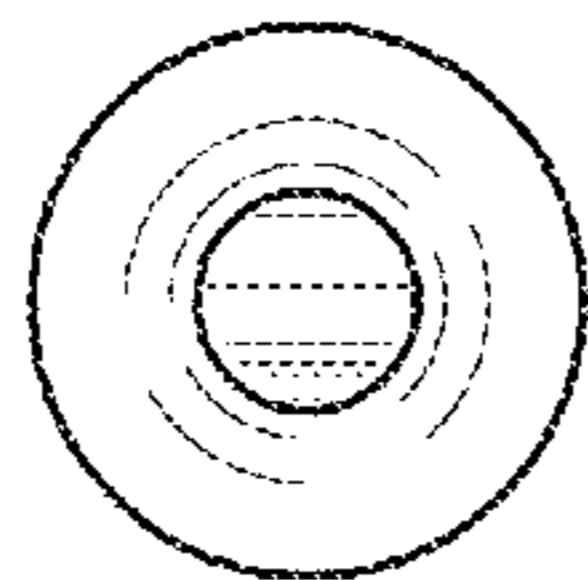

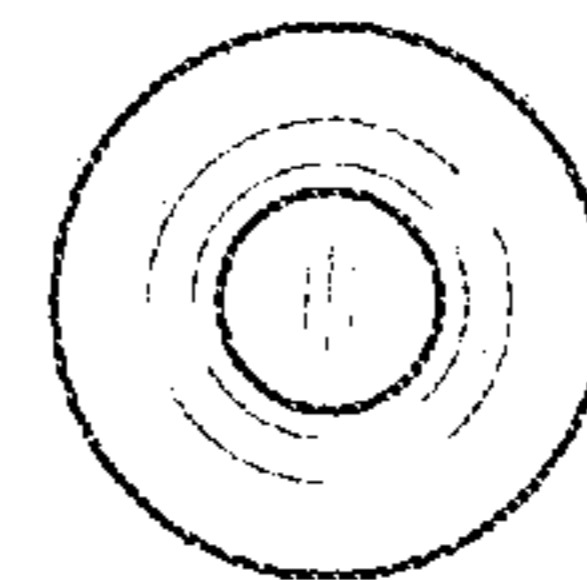

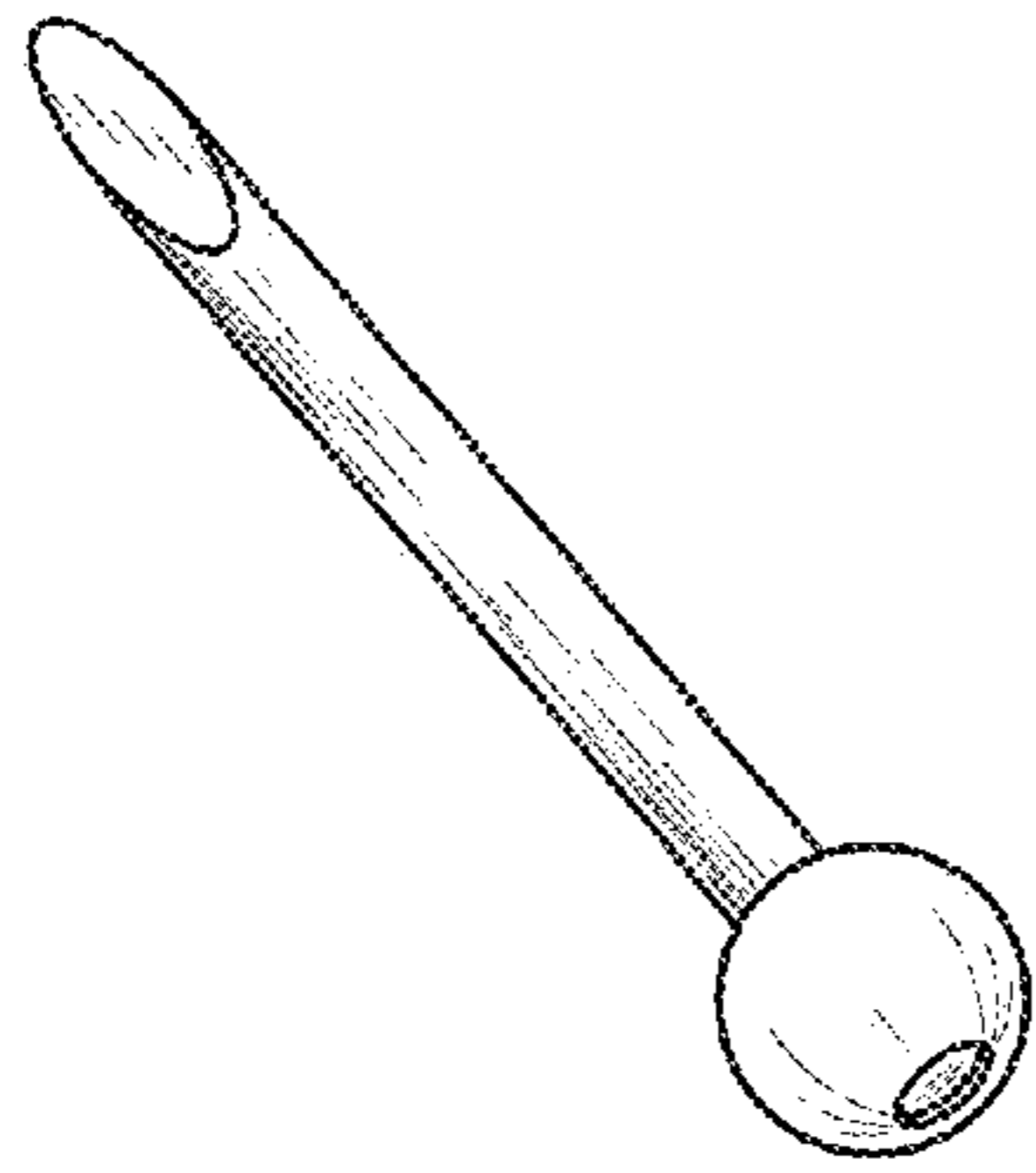

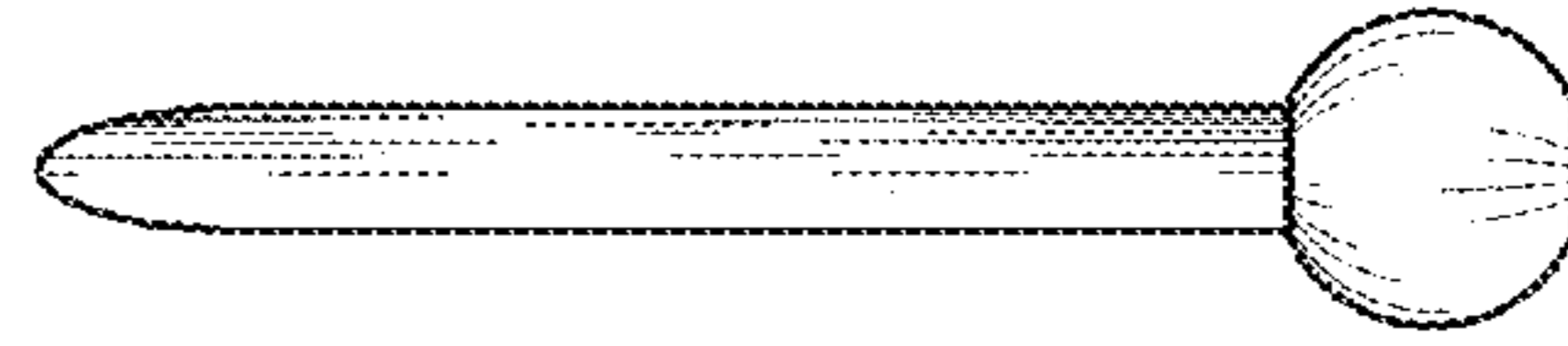

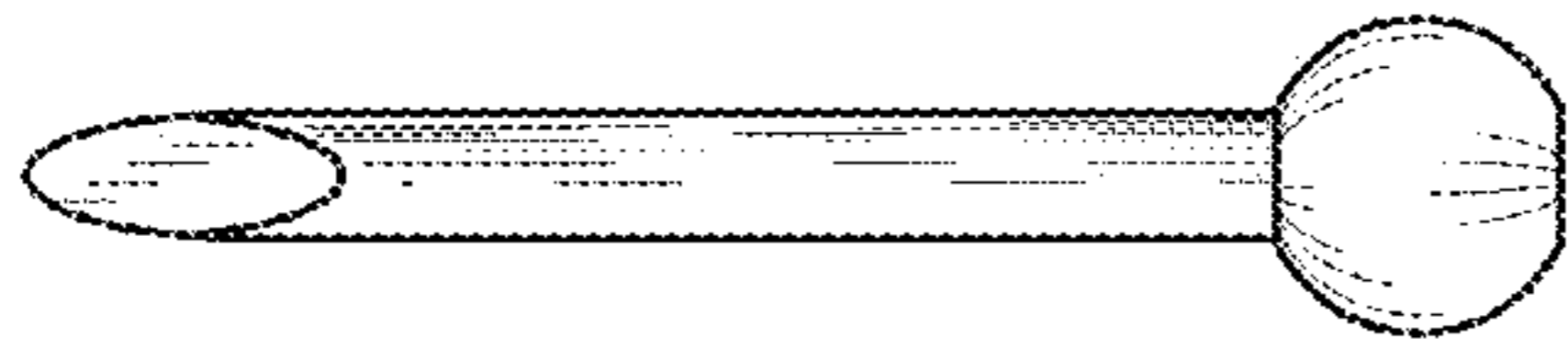

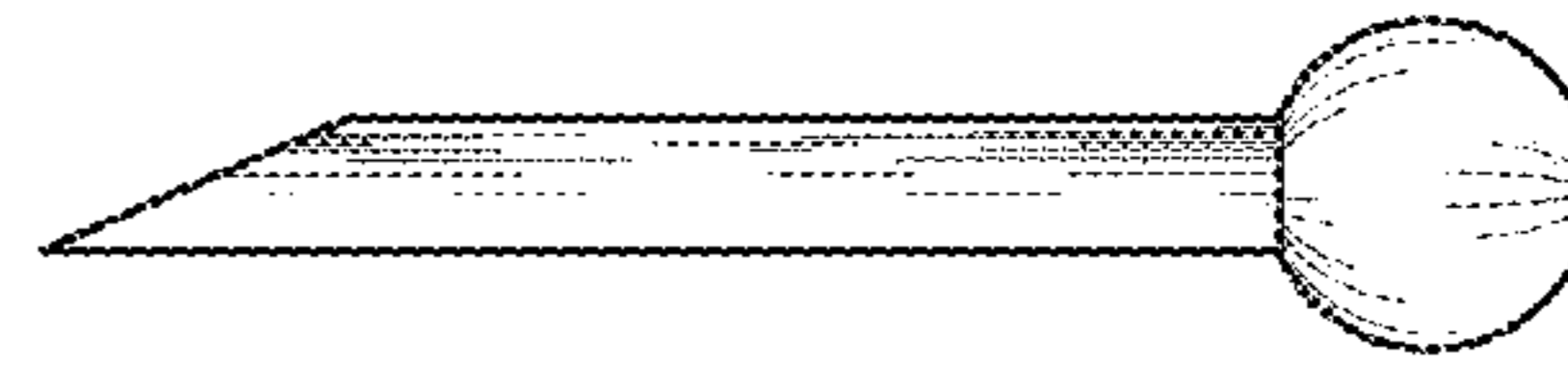

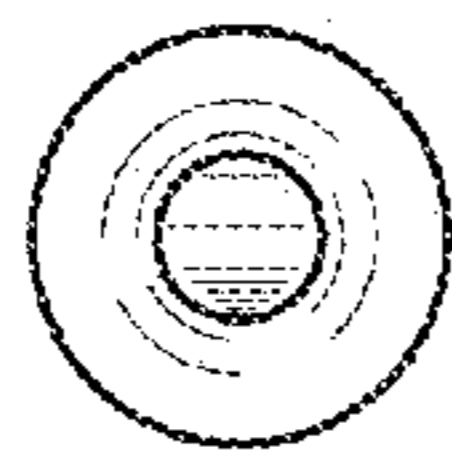

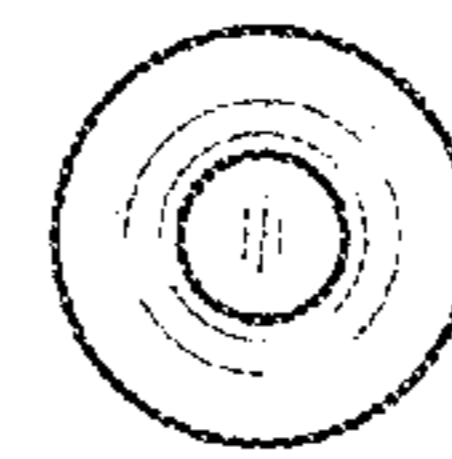

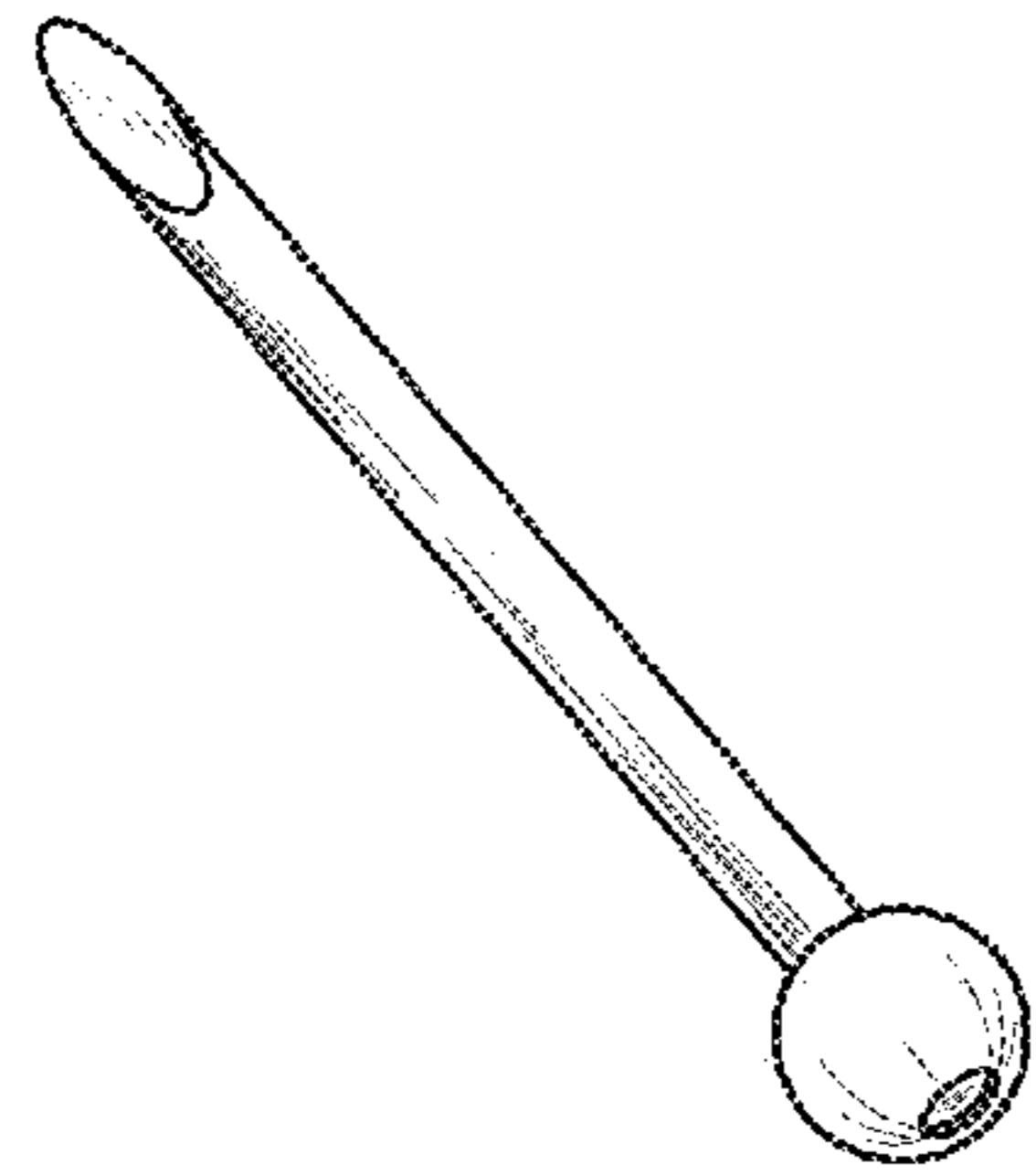

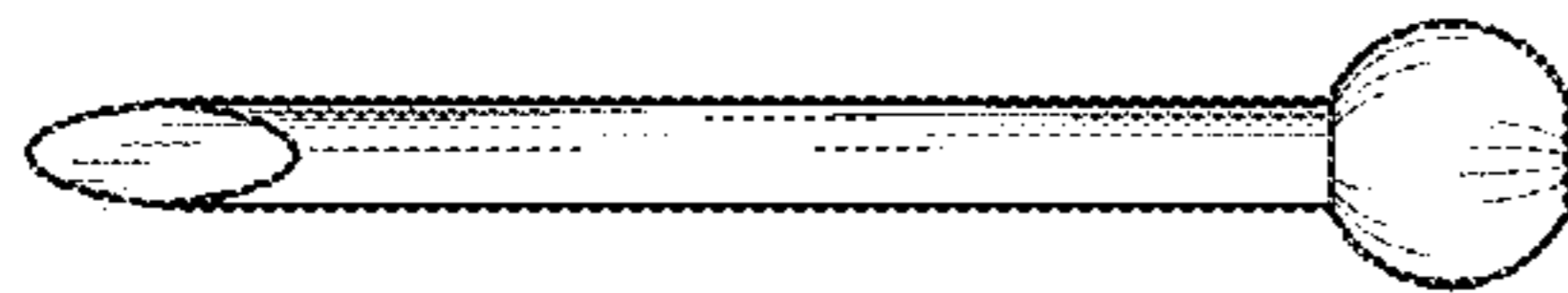

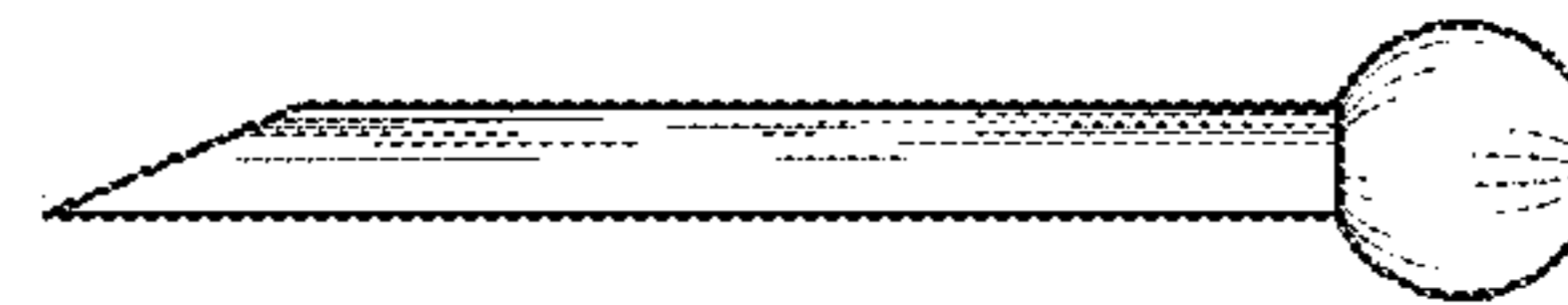

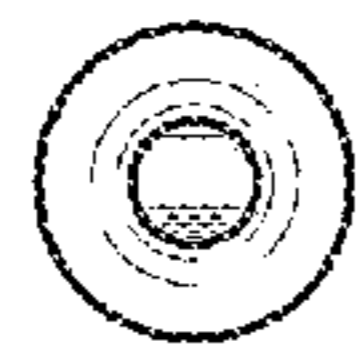

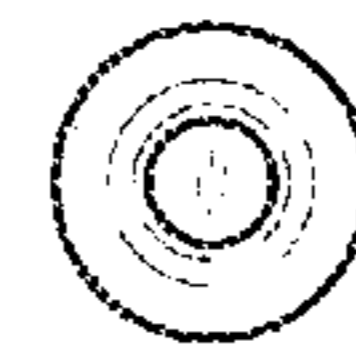
