DESCRIPTION

FIG. 1 is a perspective view of a cyclometer showing my new design;

FIG. 2 is left side elevational view showing the design for the cyclometer of FIG. 1;

FIG. 4 is a front elevational view showing the design for the cyclometer of FIG. 1;

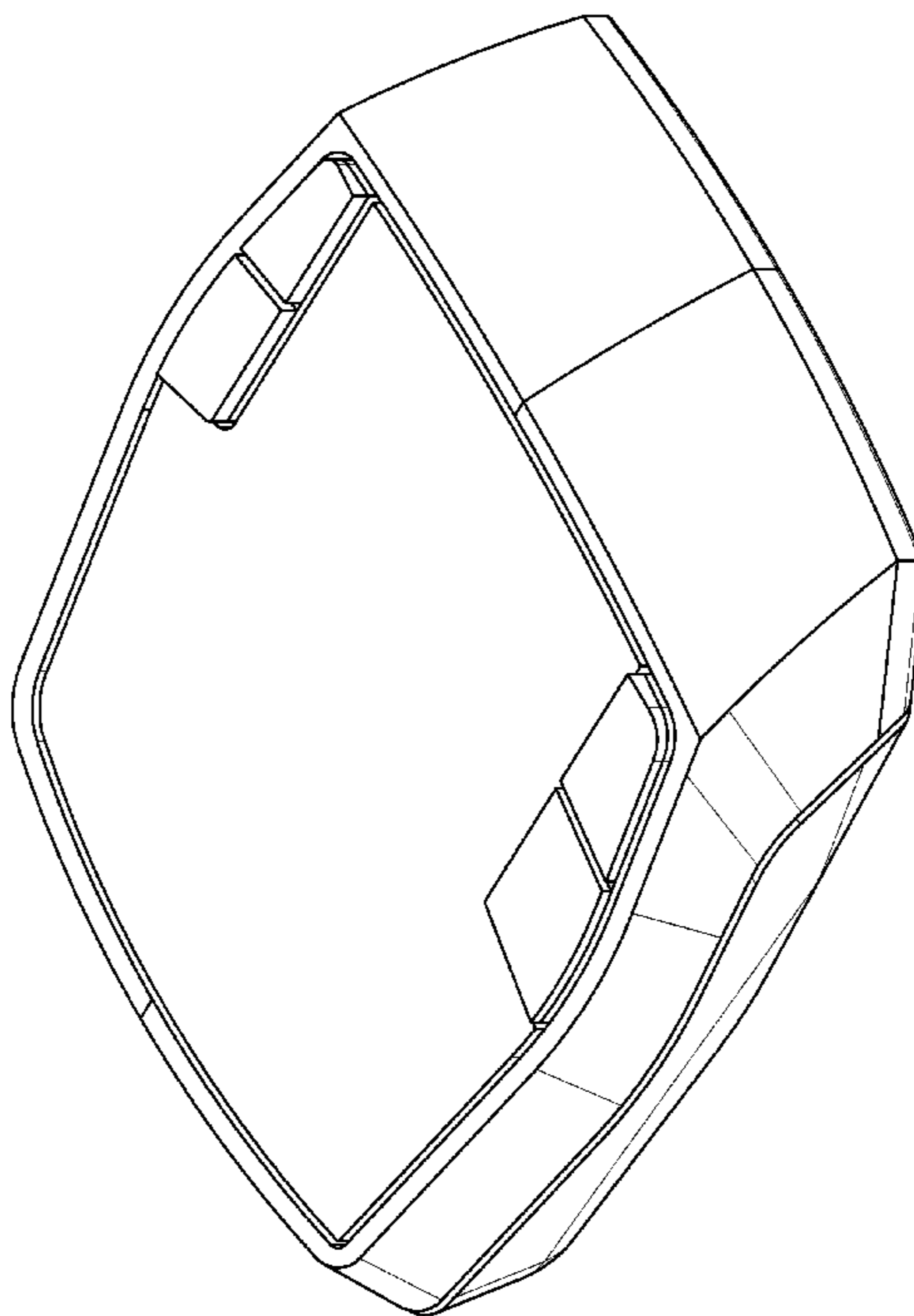
FIG. 5 is a rear elevational view showing the design for the cyclometer of FIG. 1;

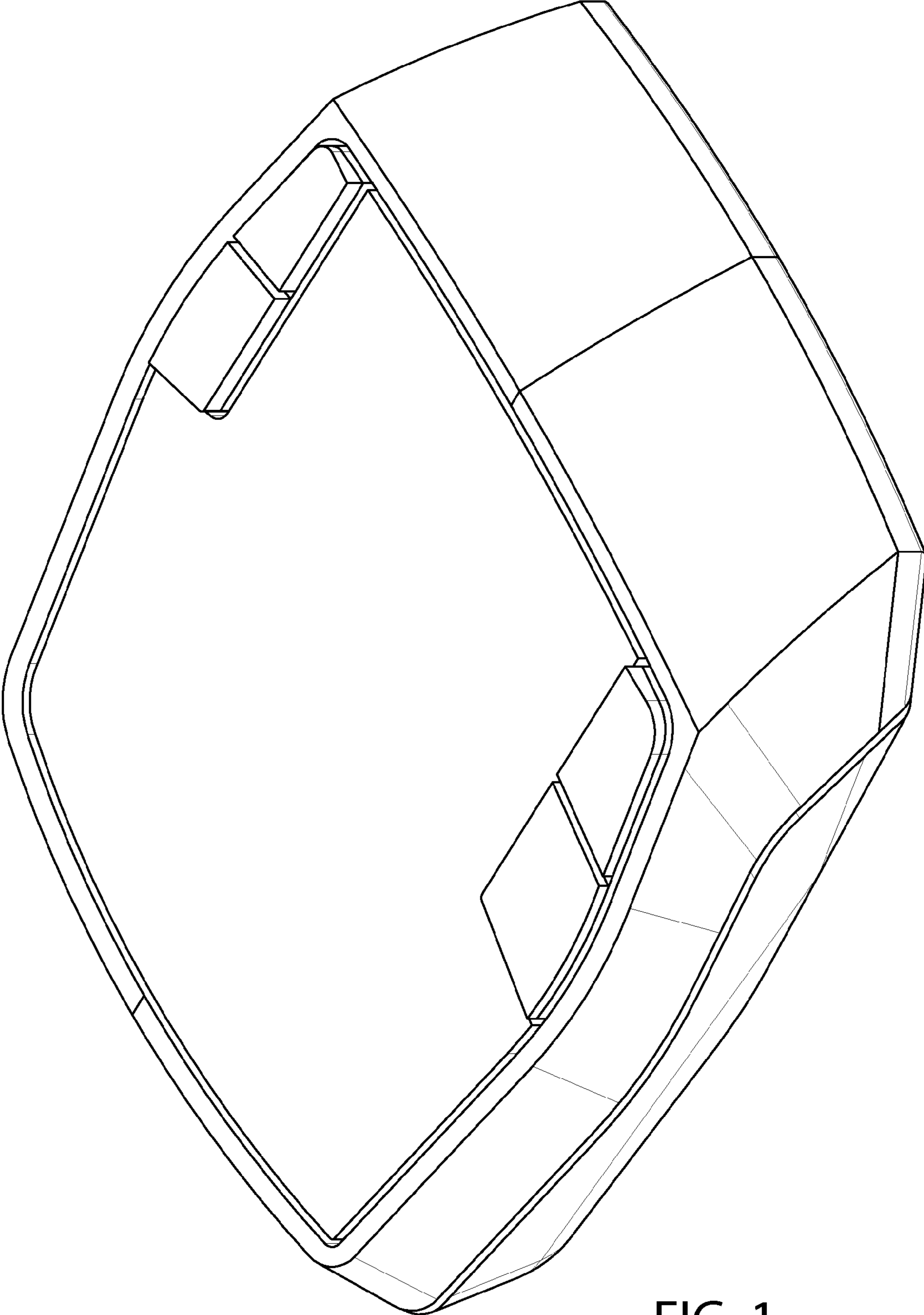

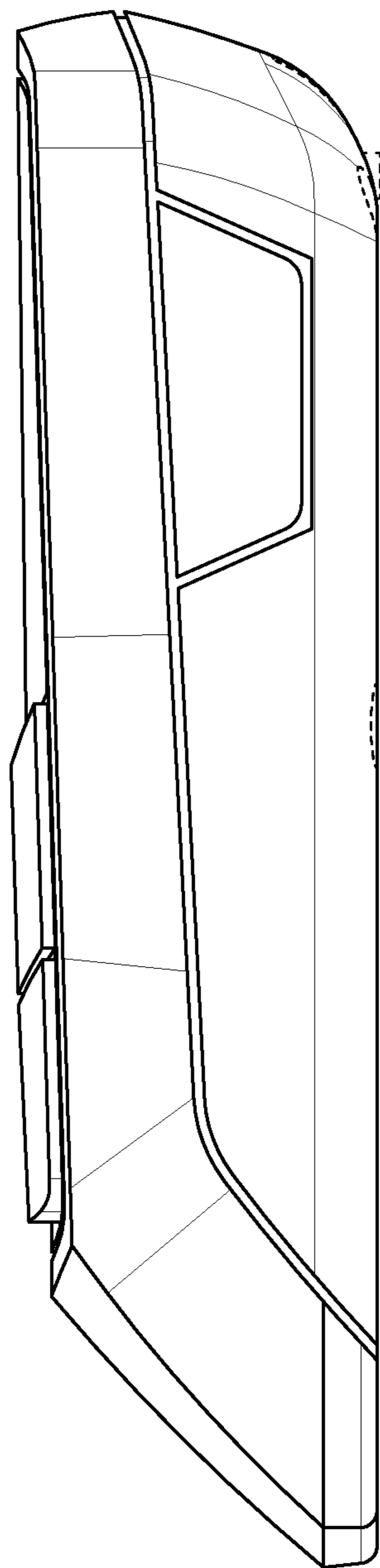

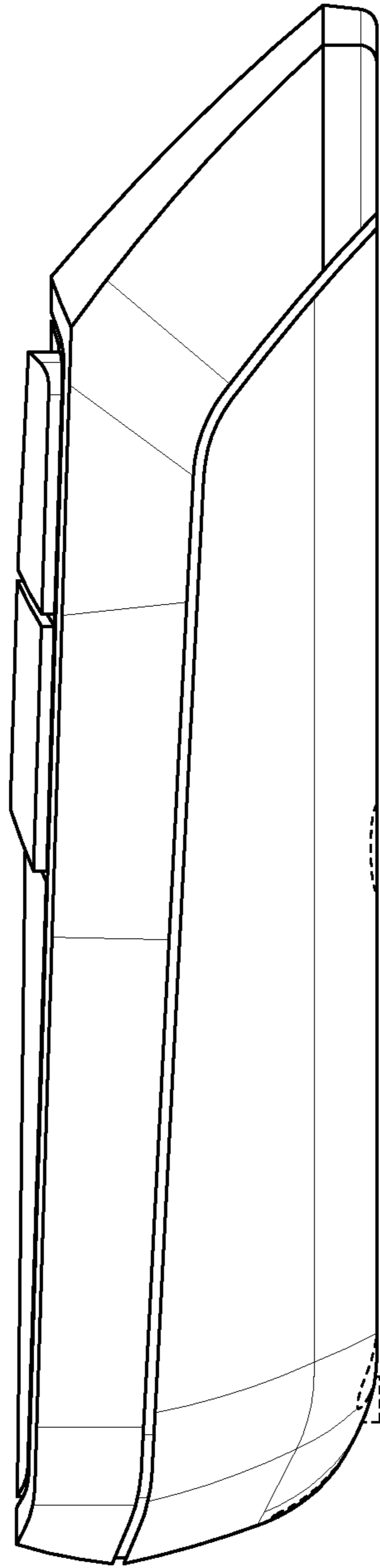

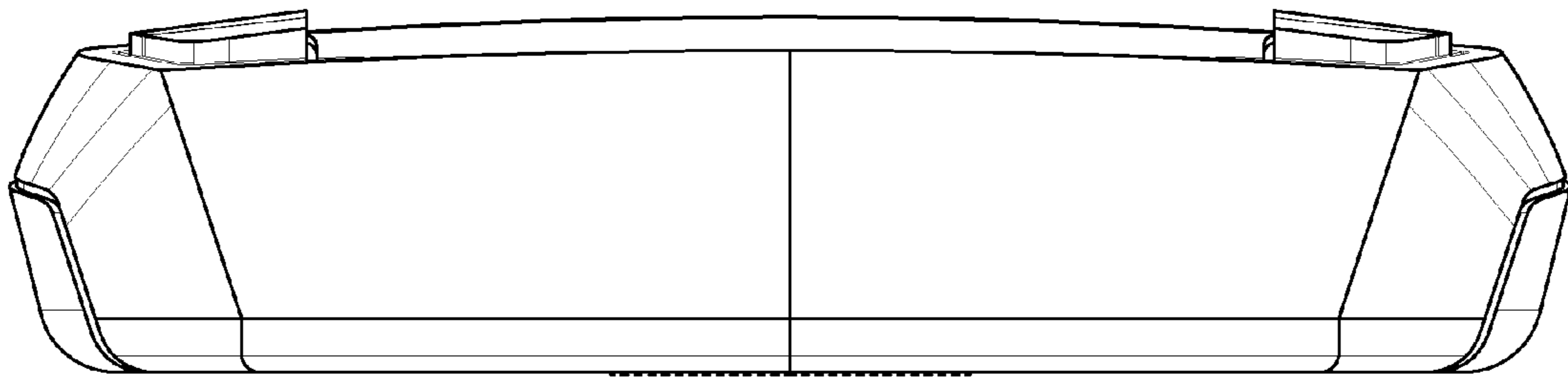

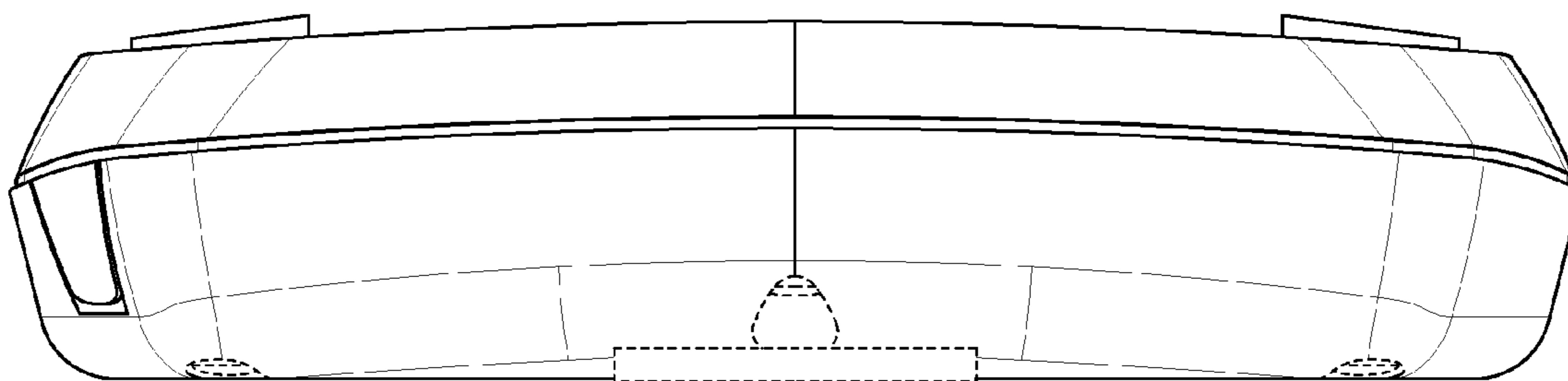

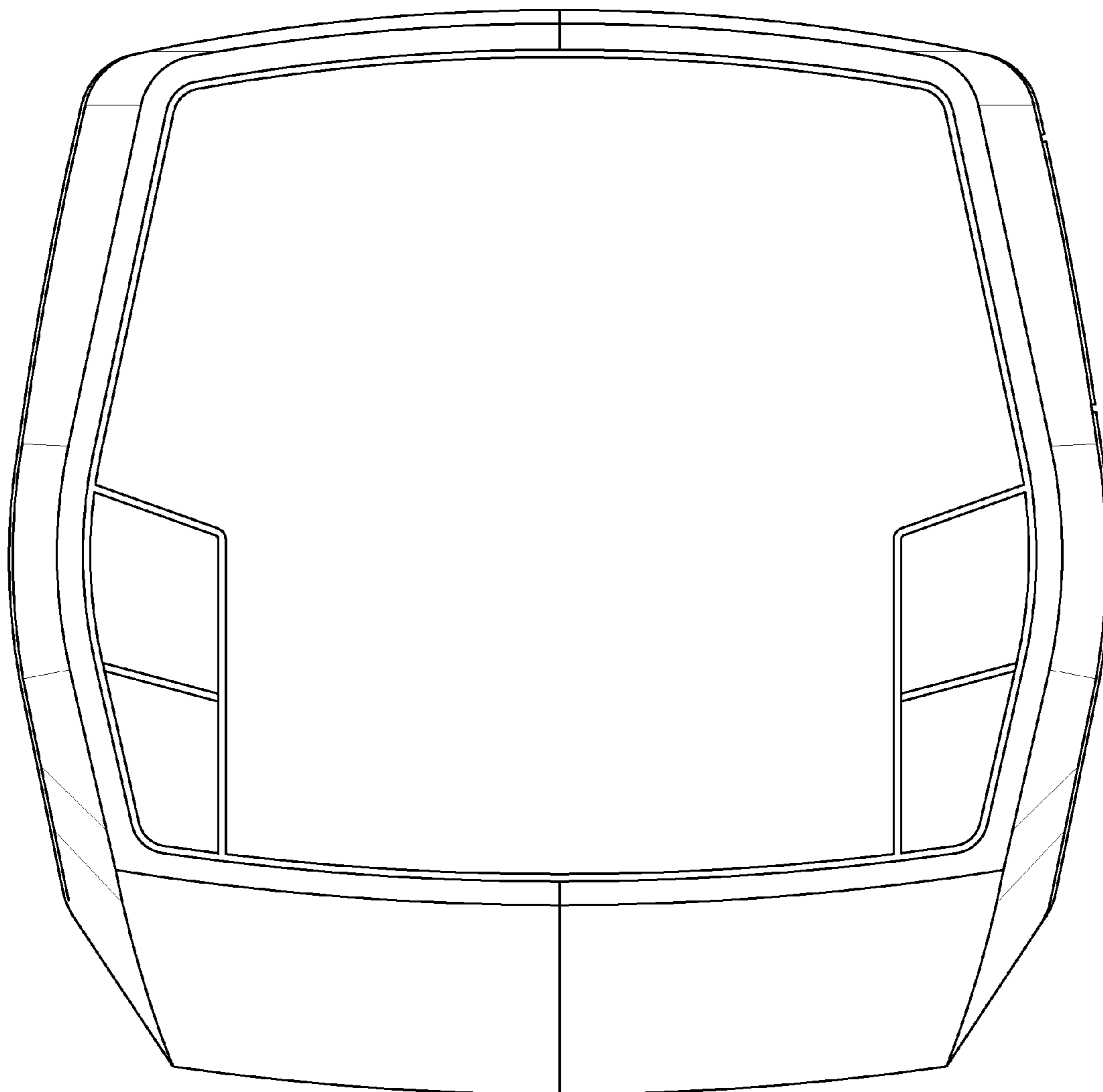

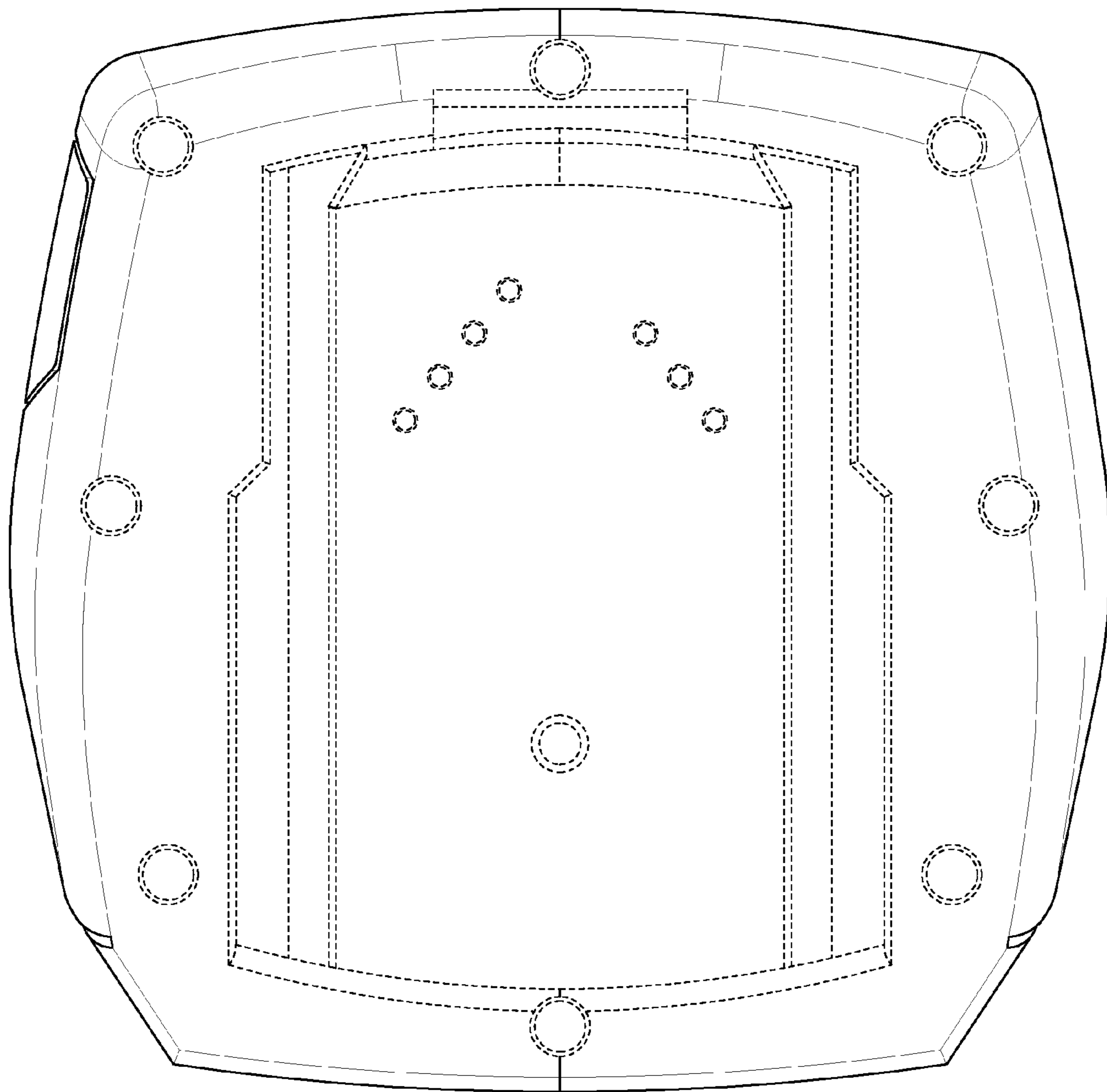
