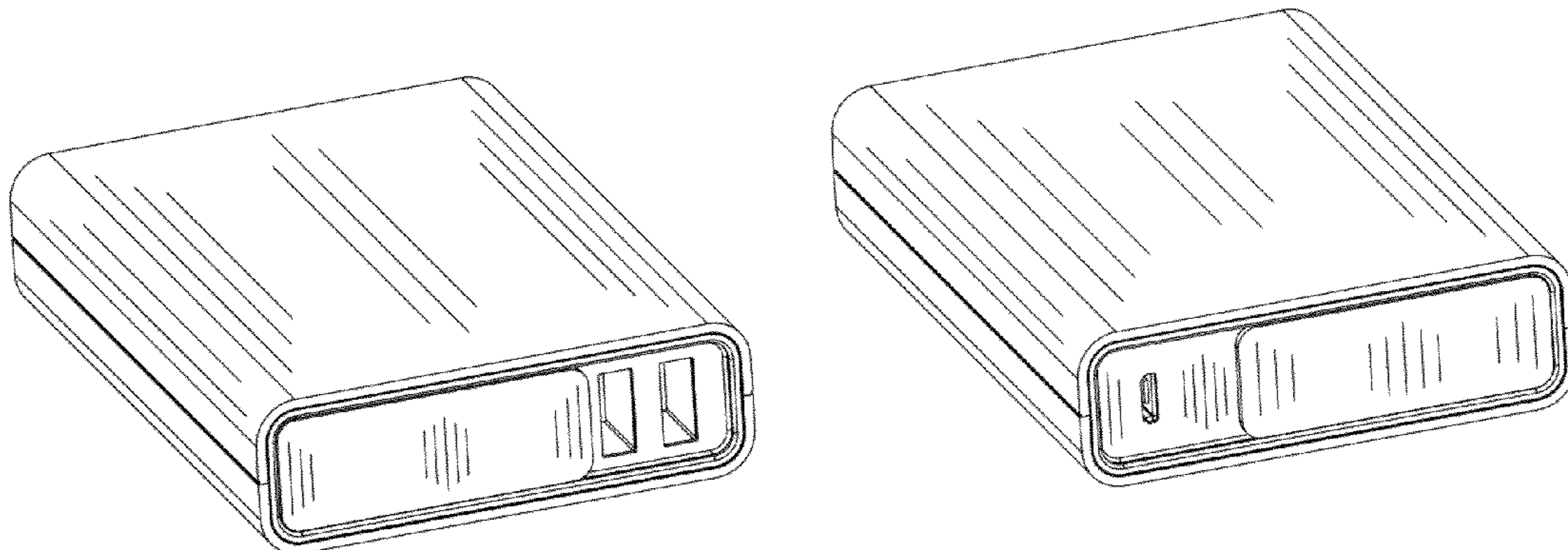
(57) **CLAIM**

The ornamental design for a mobile power source, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a mobile power source; FIG. 2 is a rear elevational view of the mobile power source; FIG. 3 is a left side elevational view of the mobile power source; FIG. 4 is a right side elevational view of the mobile power source; FIG. 5 is a top plan view of the mobile power source; FIG. 6 is a bottom plan view of the mobile power source; FIG. 7 is a first perspective view of the mobile power source; FIG. 8 is a second perspective view of the mobile power source; and, FIG. 9 is a third perspective view of the mobile power source, shown in an alternate position.

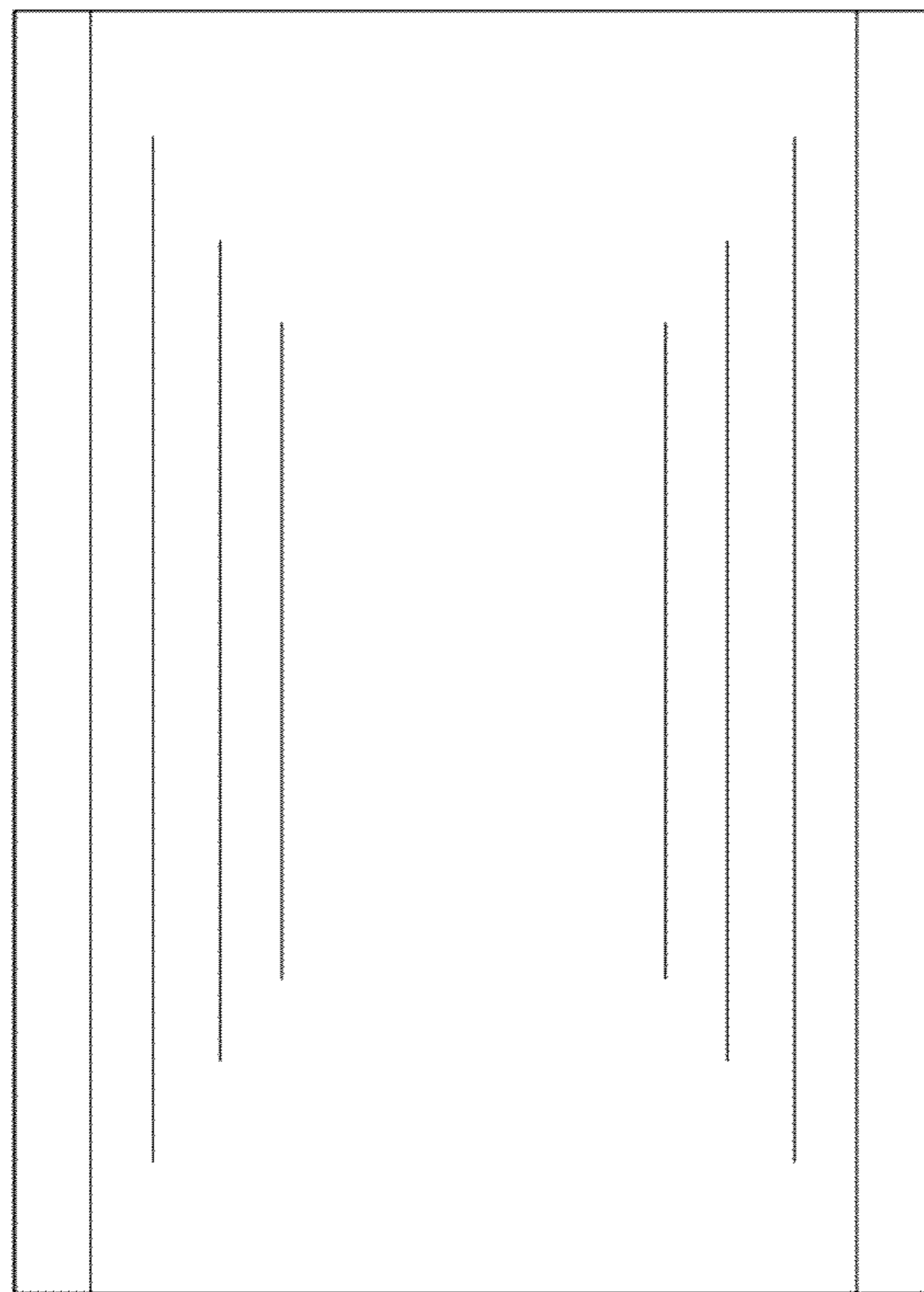

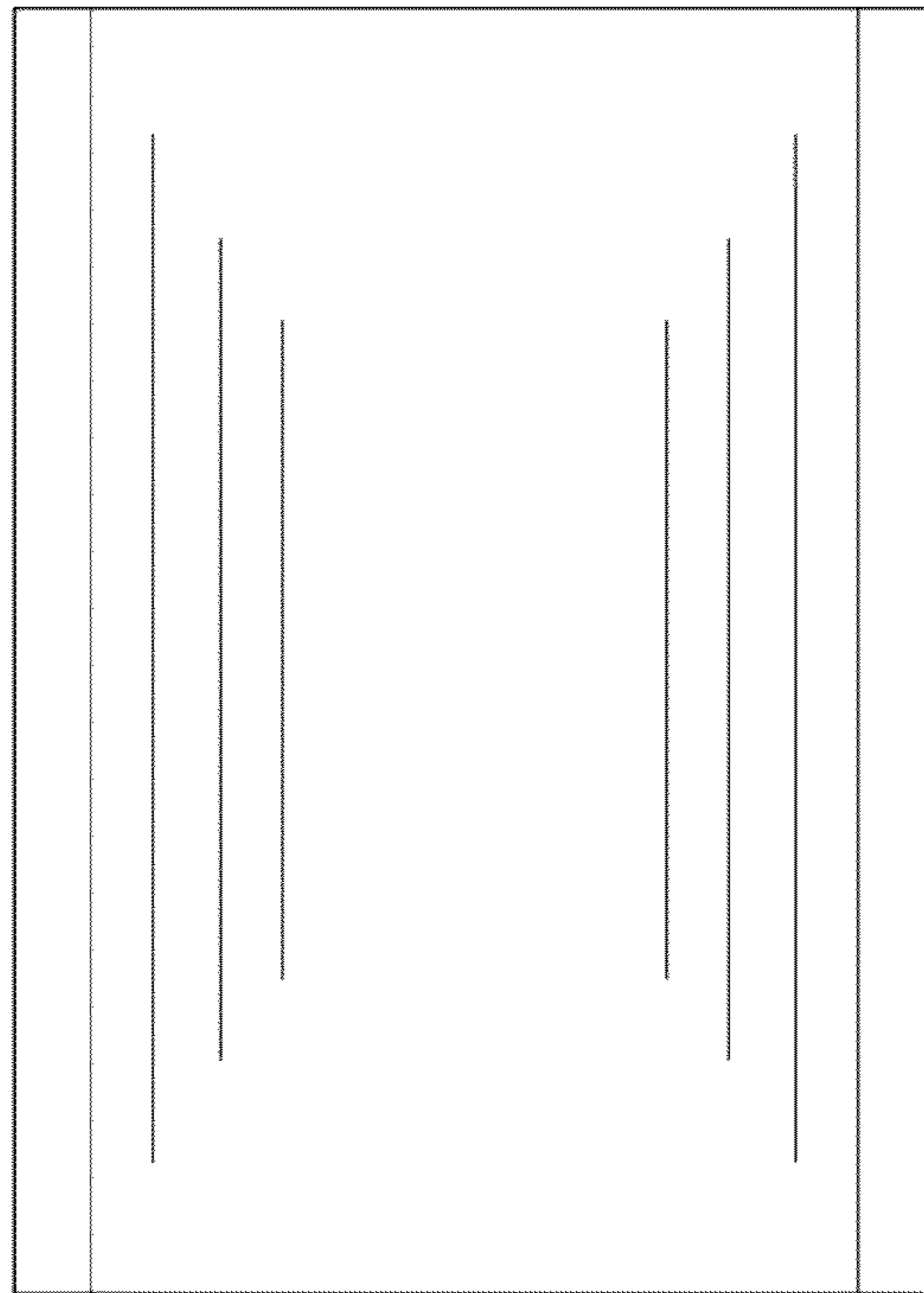

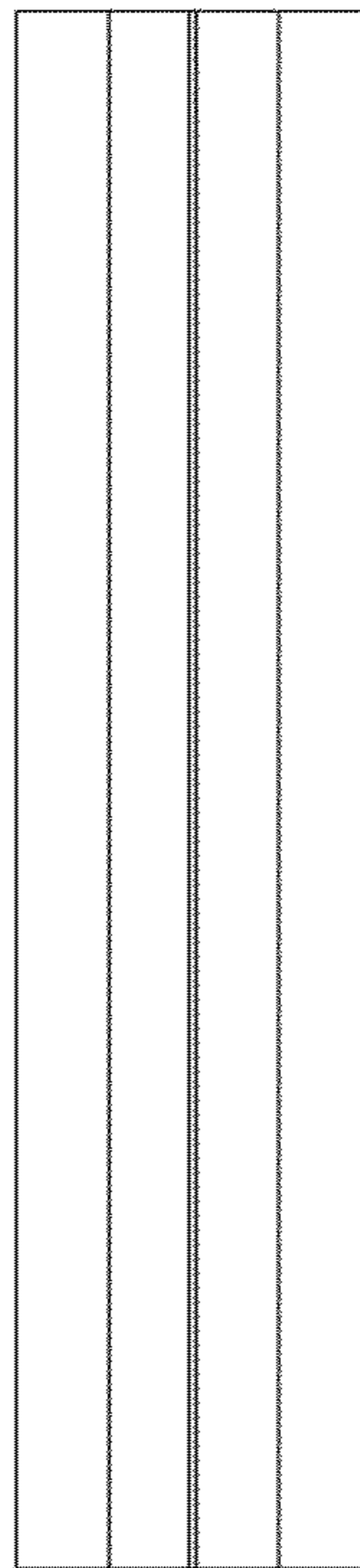

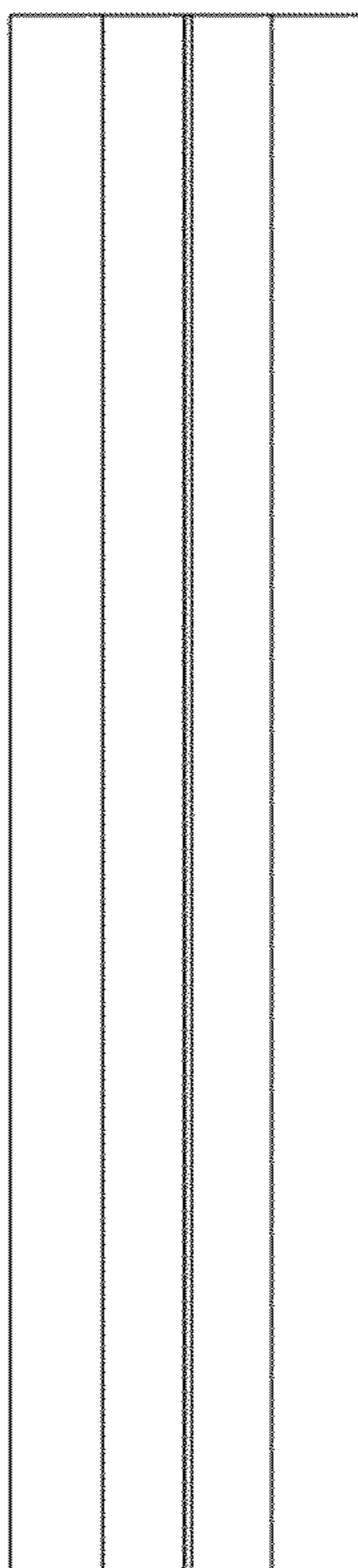

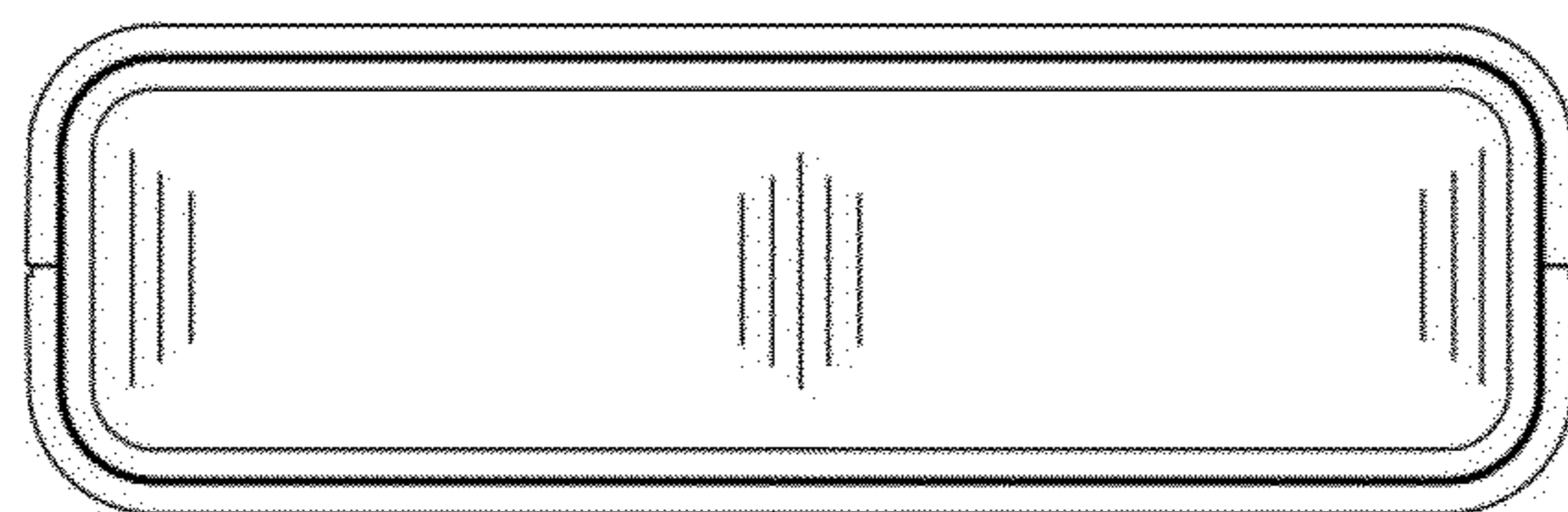

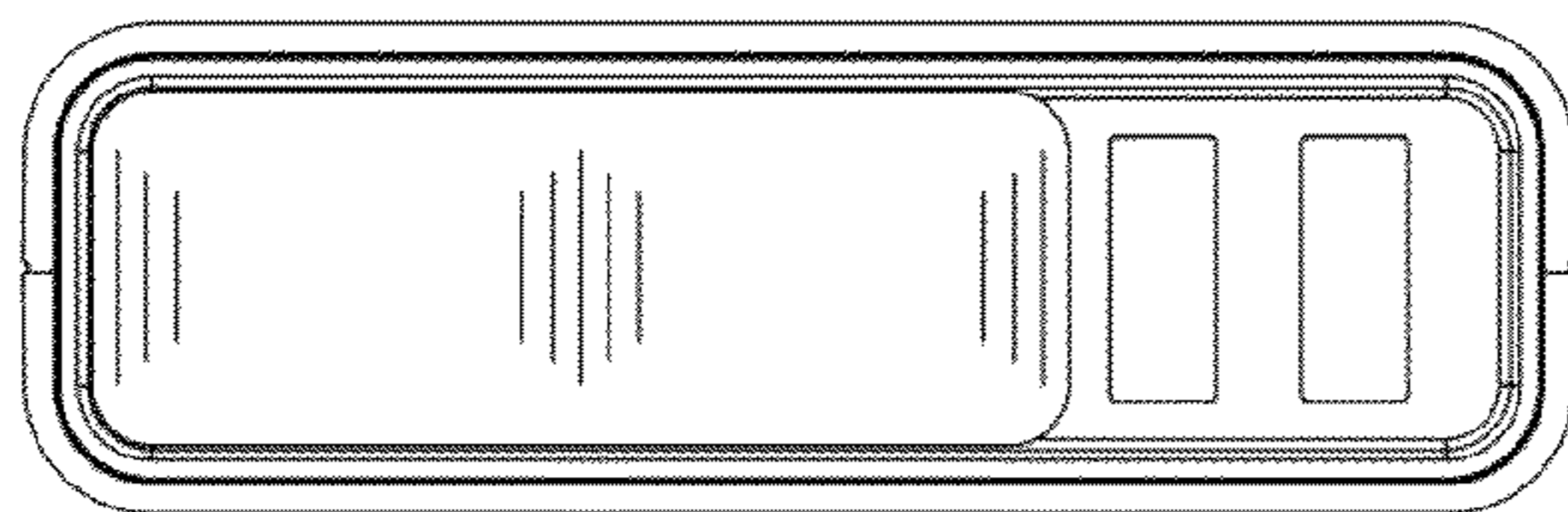

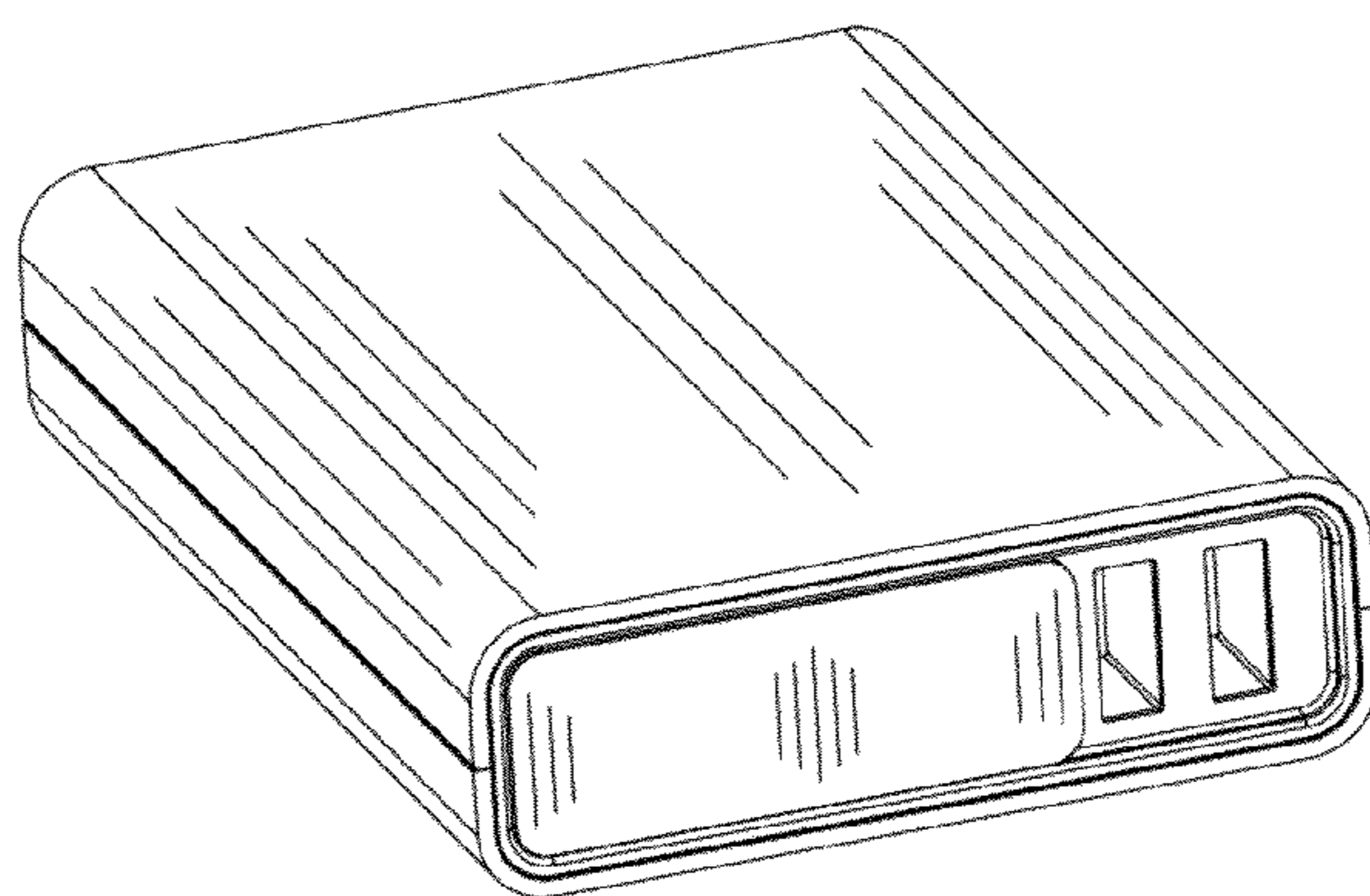

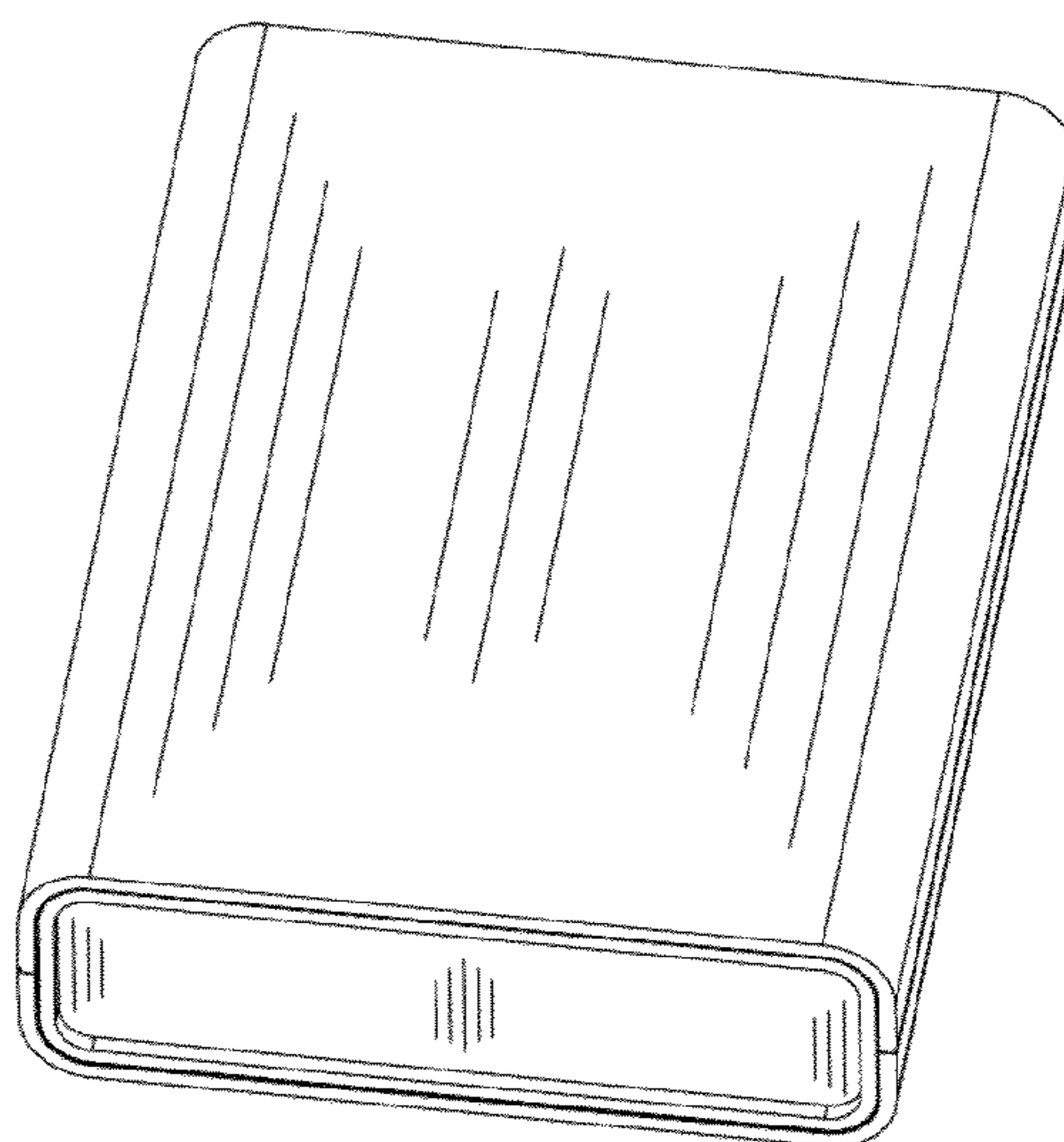

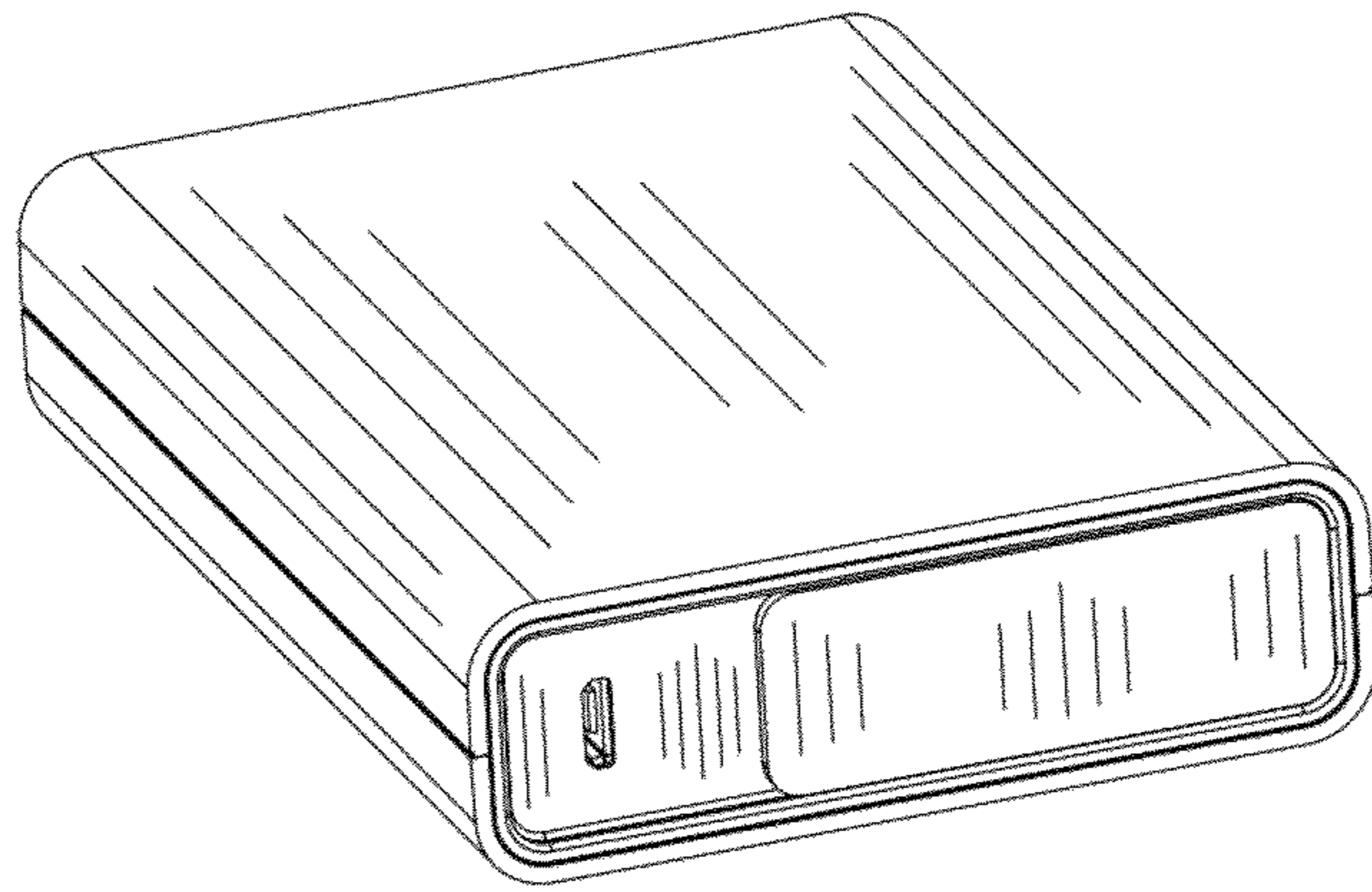
