(57) **CLAIM**

We claim the ornamental design for a display screen with animated-graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image in a sequence for a display screen with an animated graphical user interface showing our new design;

FIG. 2 is a front view of the second image thereof, shown enlarged and separately for clarity of illustration;

FIG. 3 is a front view of the third image thereof, shown enlarged and separately for clarity of illustration;

FIG. 4 is a front view of the fourth image thereof, shown enlarged and separately for clarity of illustration;

FIG. 5 is a front view of the fifth image thereof, shown enlarged and separately for clarity of illustration;

FIG. 6 is a front view of the sixth image thereof, shown enlarged and separately for clarity of illustration;

FIG. 7 is a front view of the seventh image thereof, shown enlarged and separately for clarity of illustration; and,

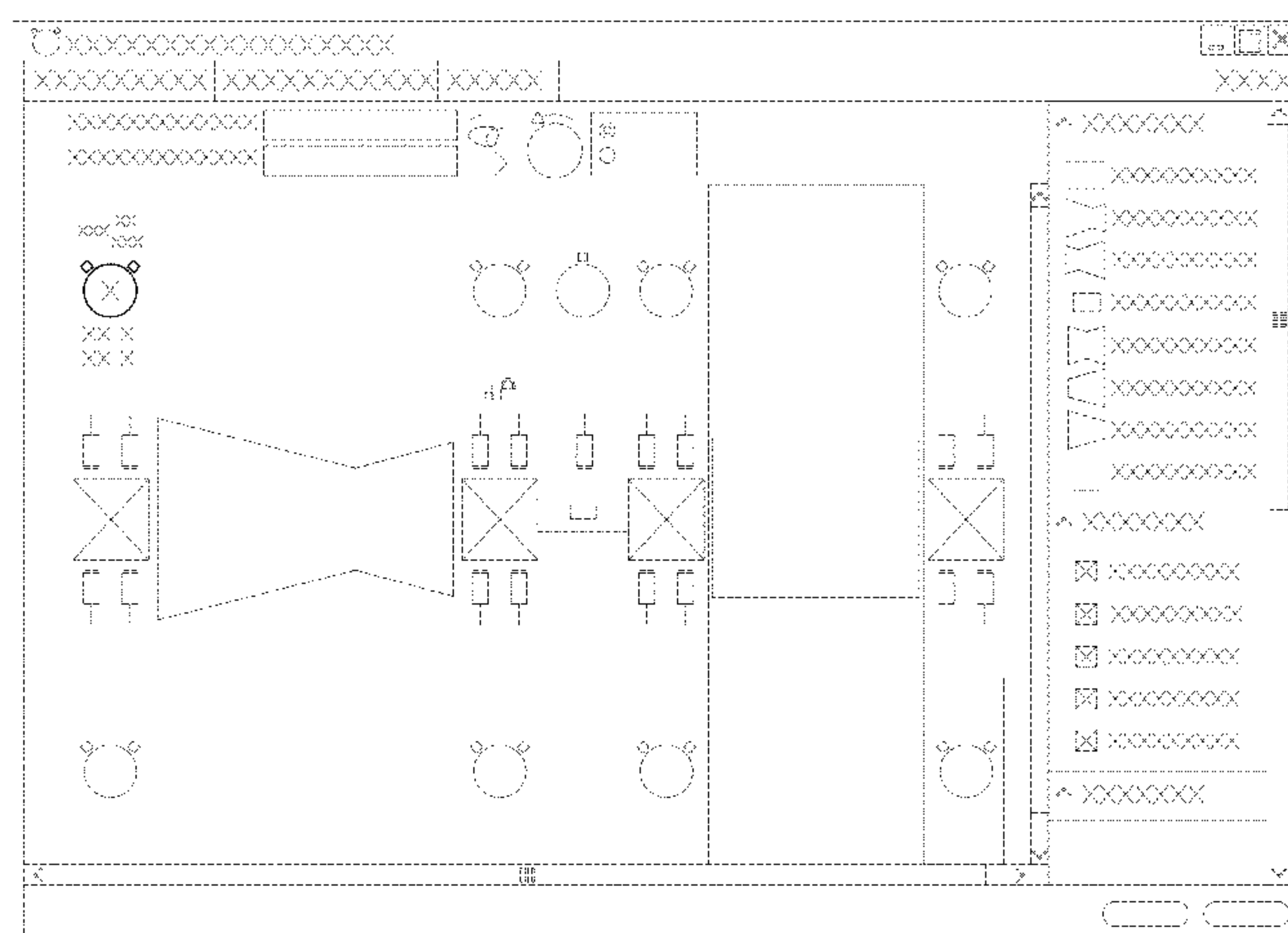
FIG. 8 is a front view of the eighth image thereof, shown enlarged and separately for clarity of illustration.

The claimed design is an integral and active component in the operation of a computer-programmed device displaying the design. The appearance of the animated image sequentially transitions between the images shown in FIGS. 1-8.

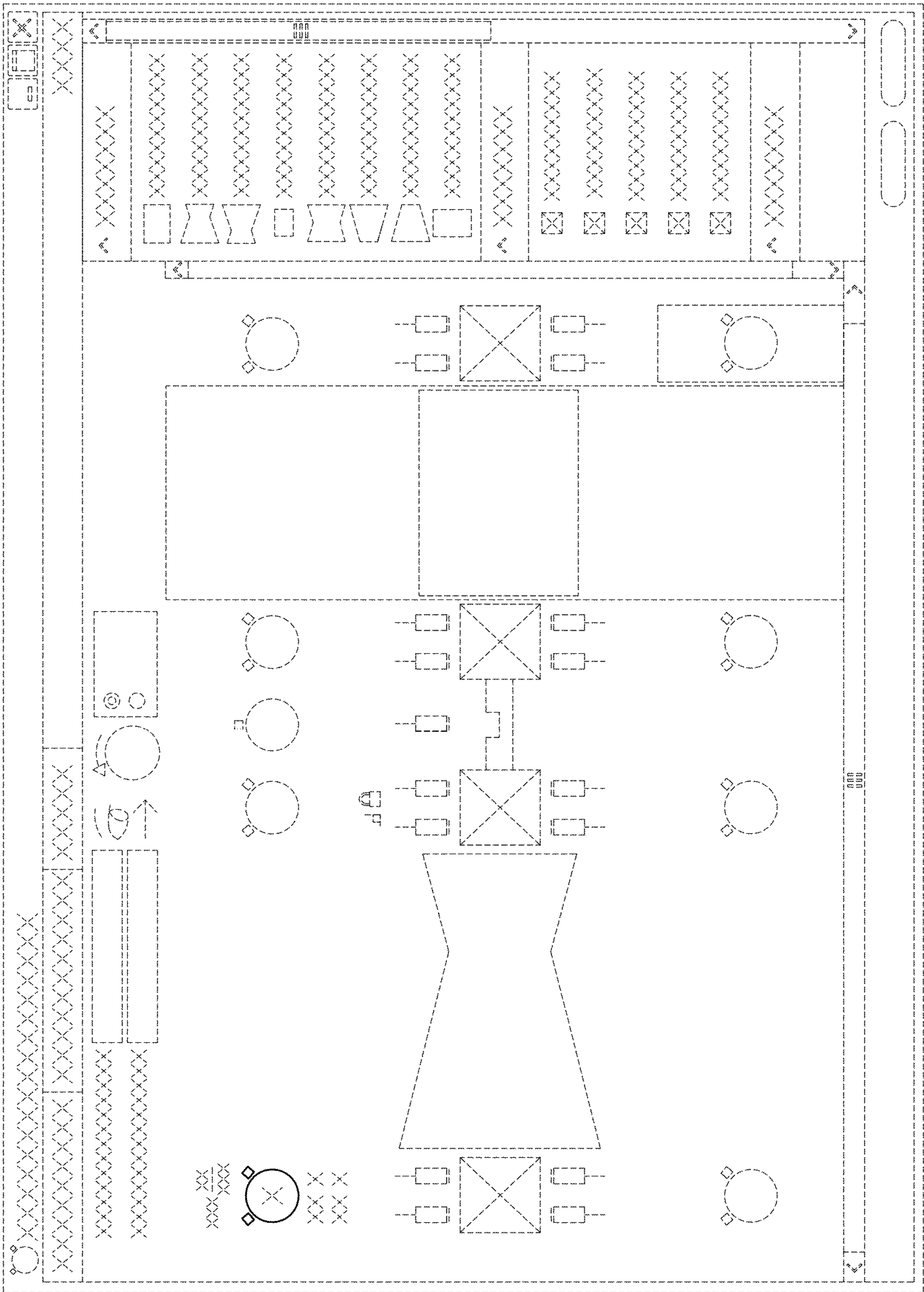

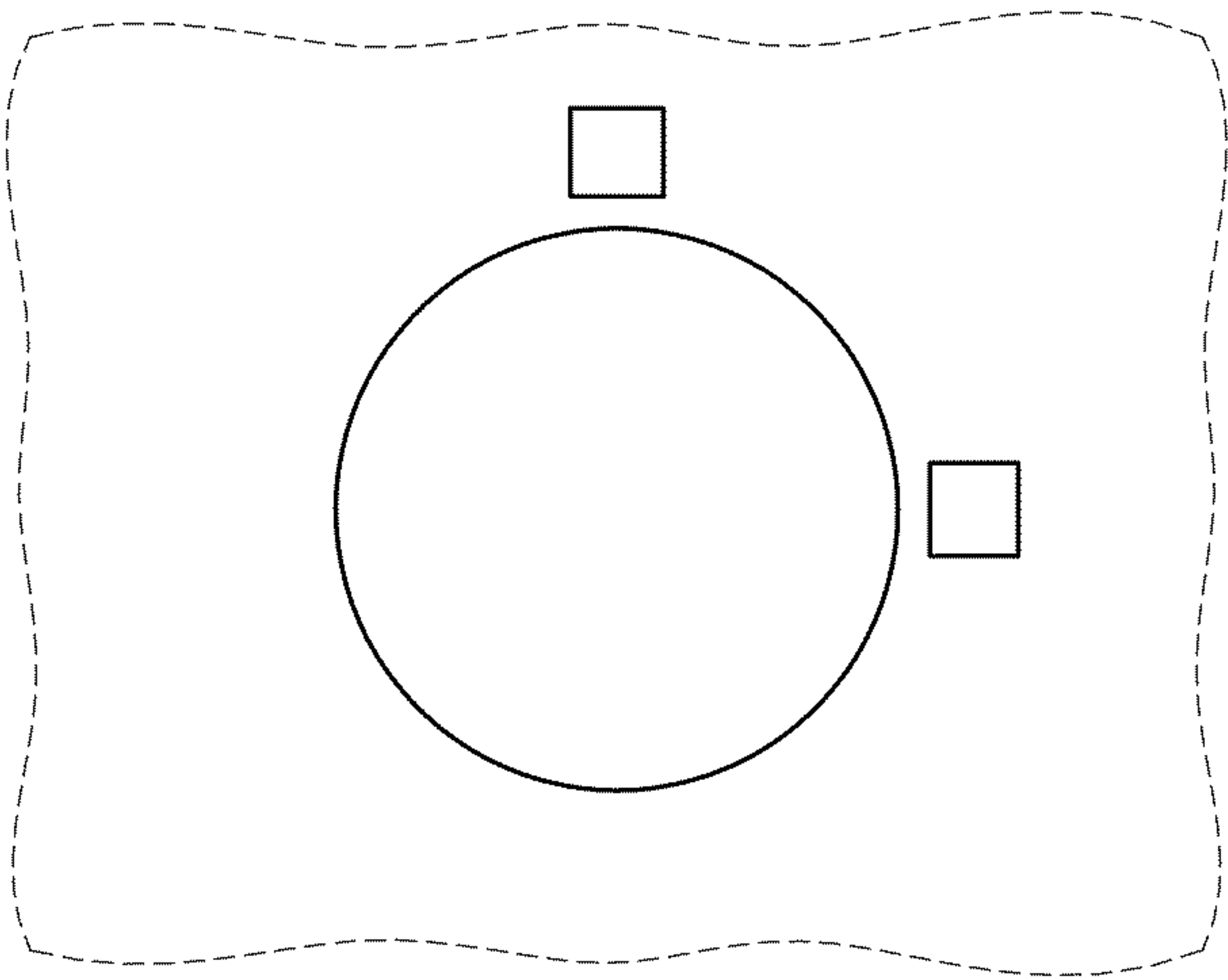

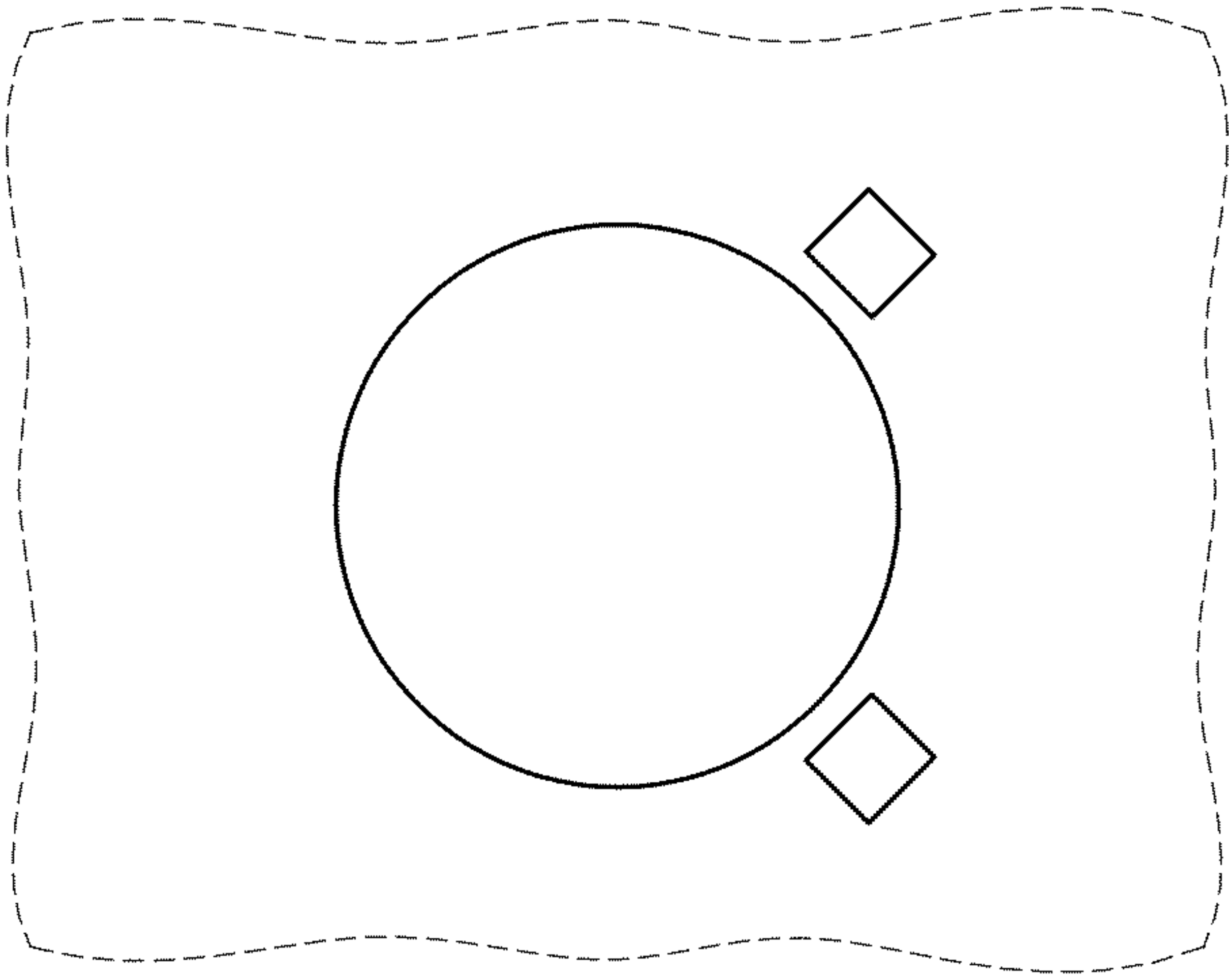

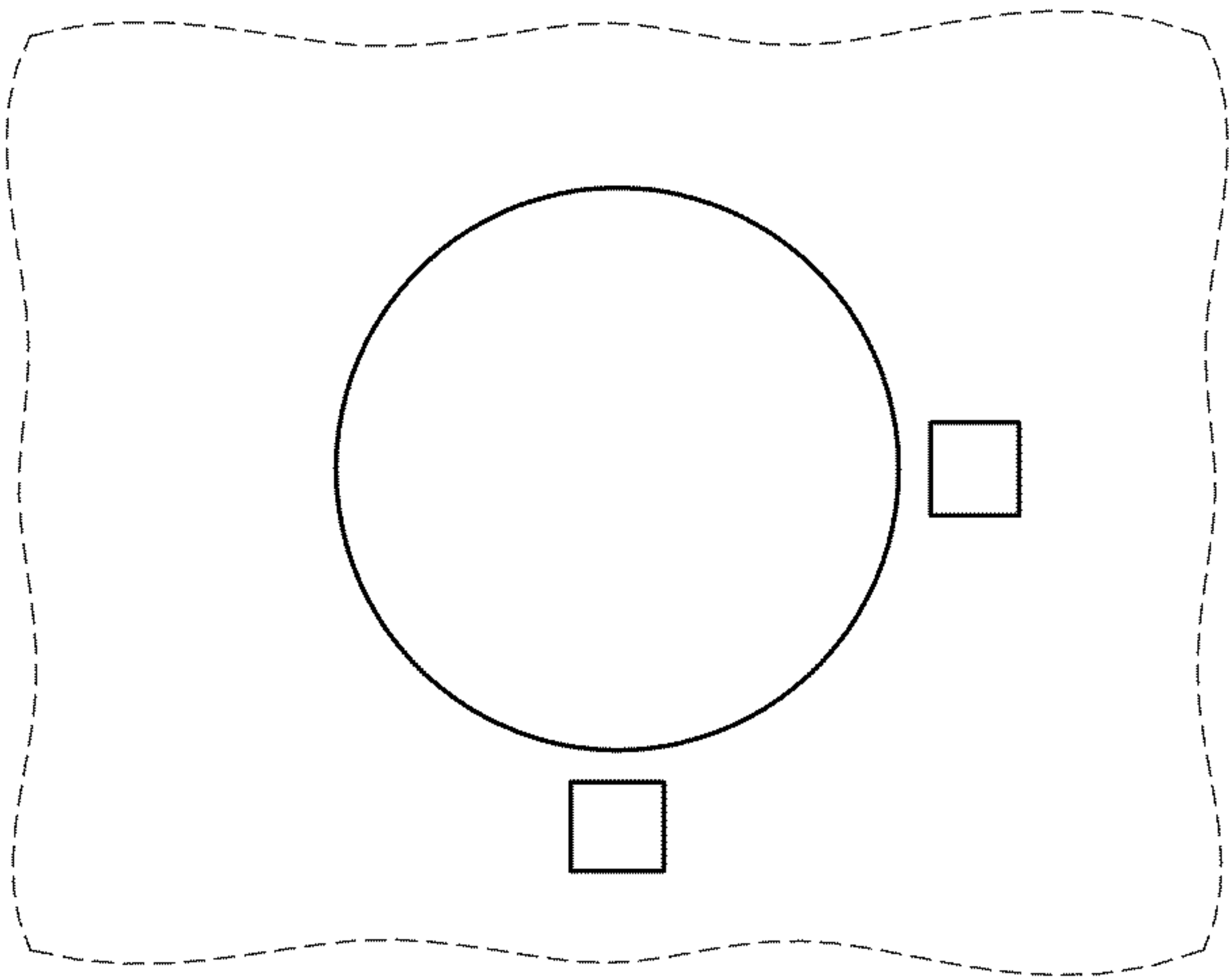

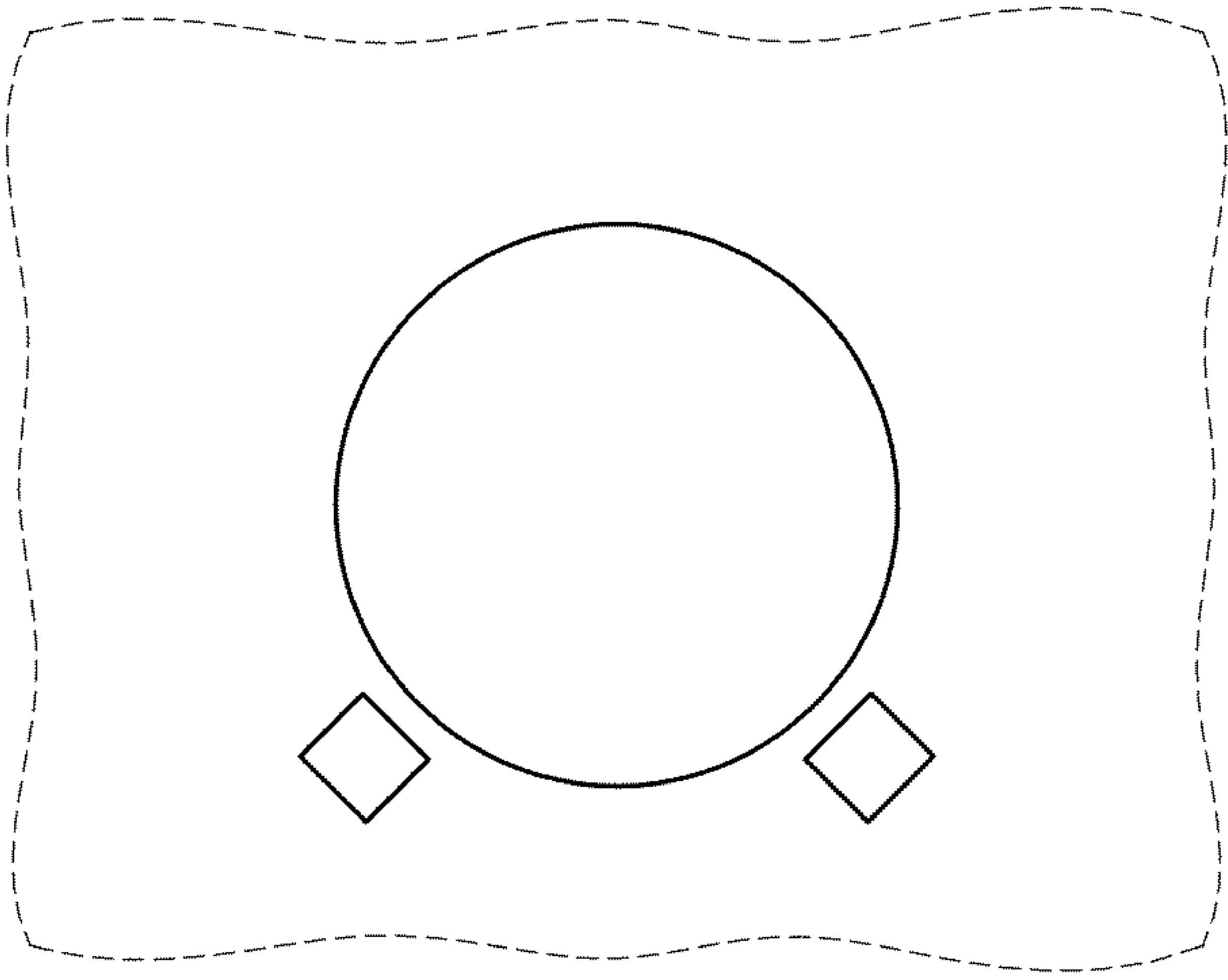

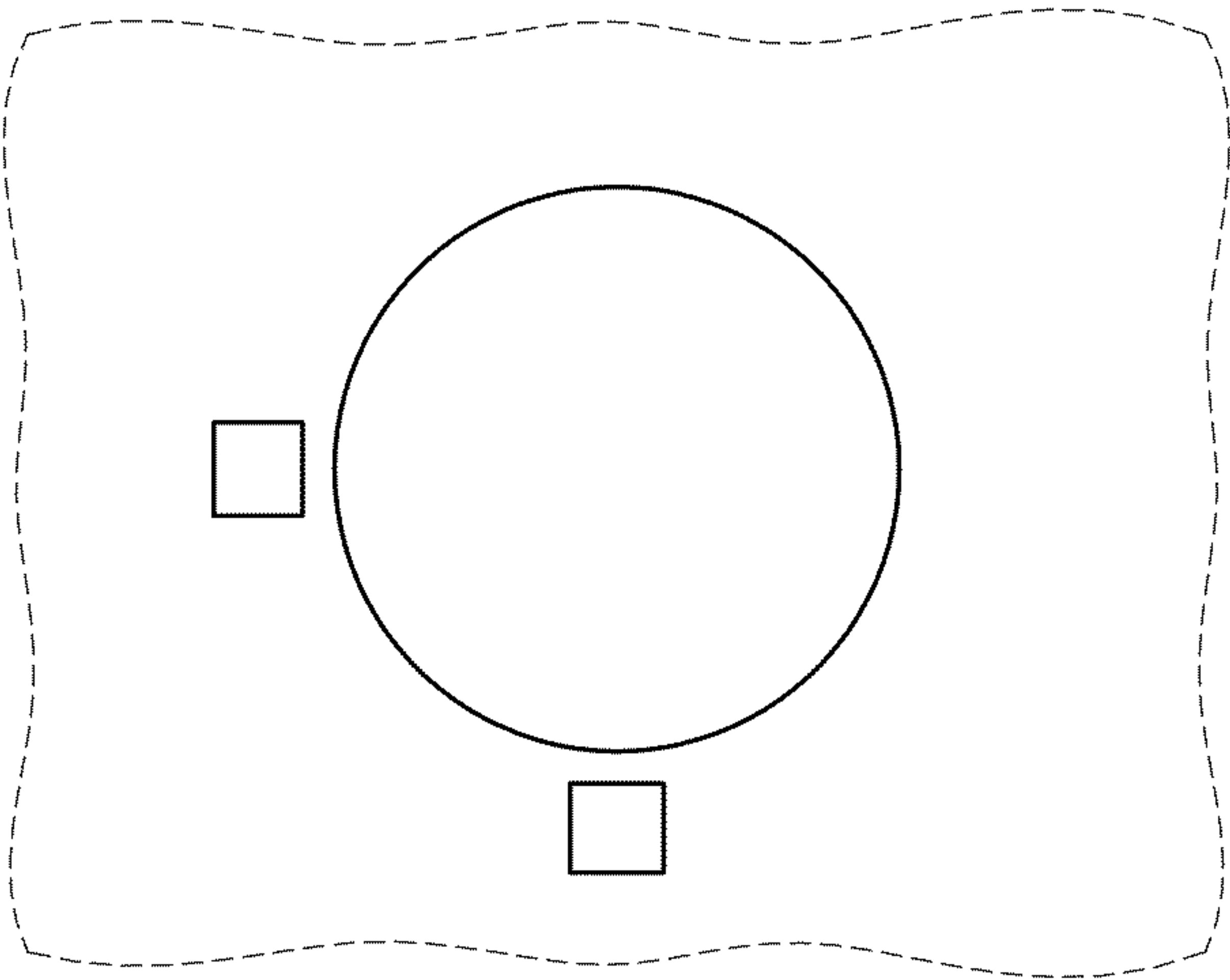

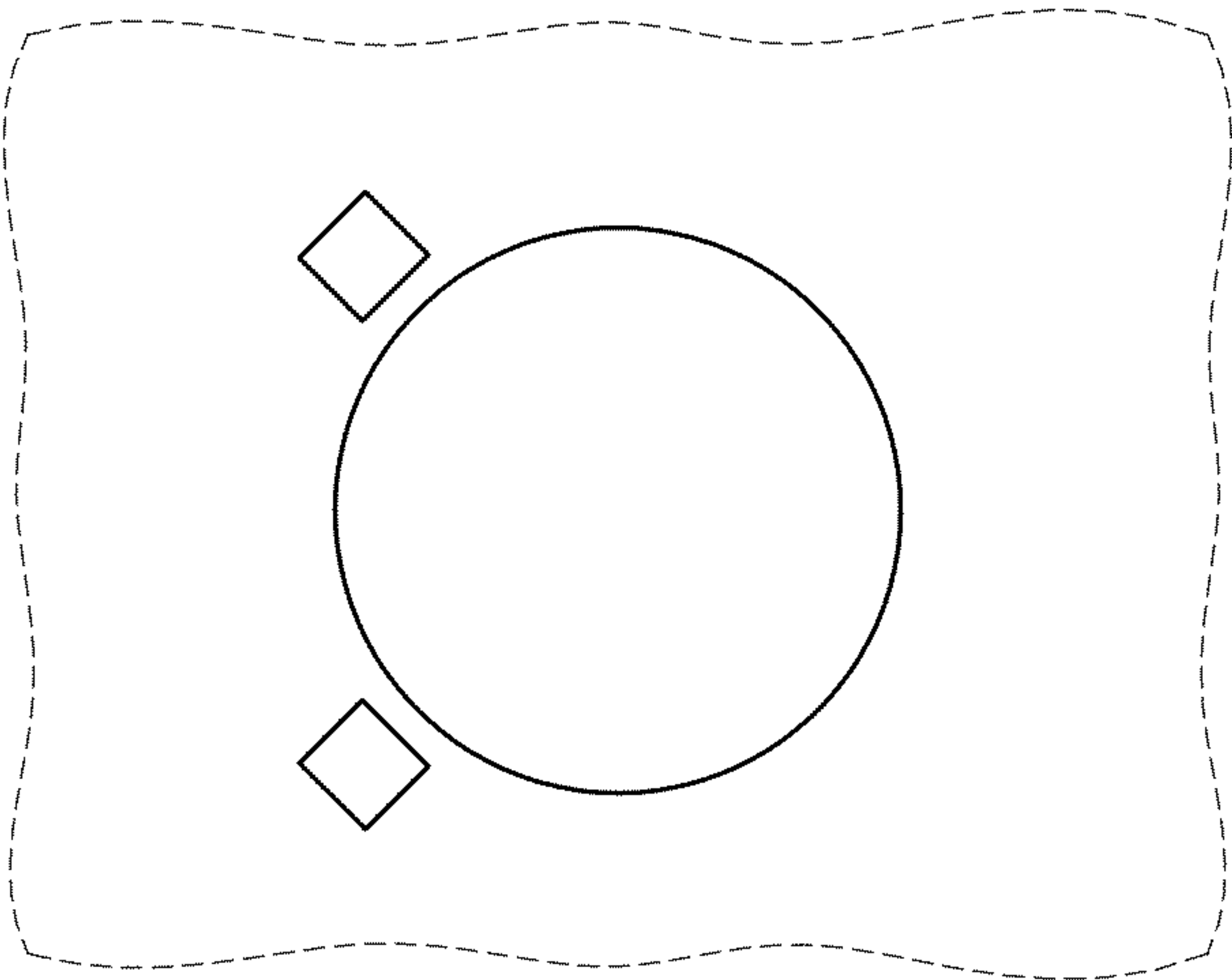

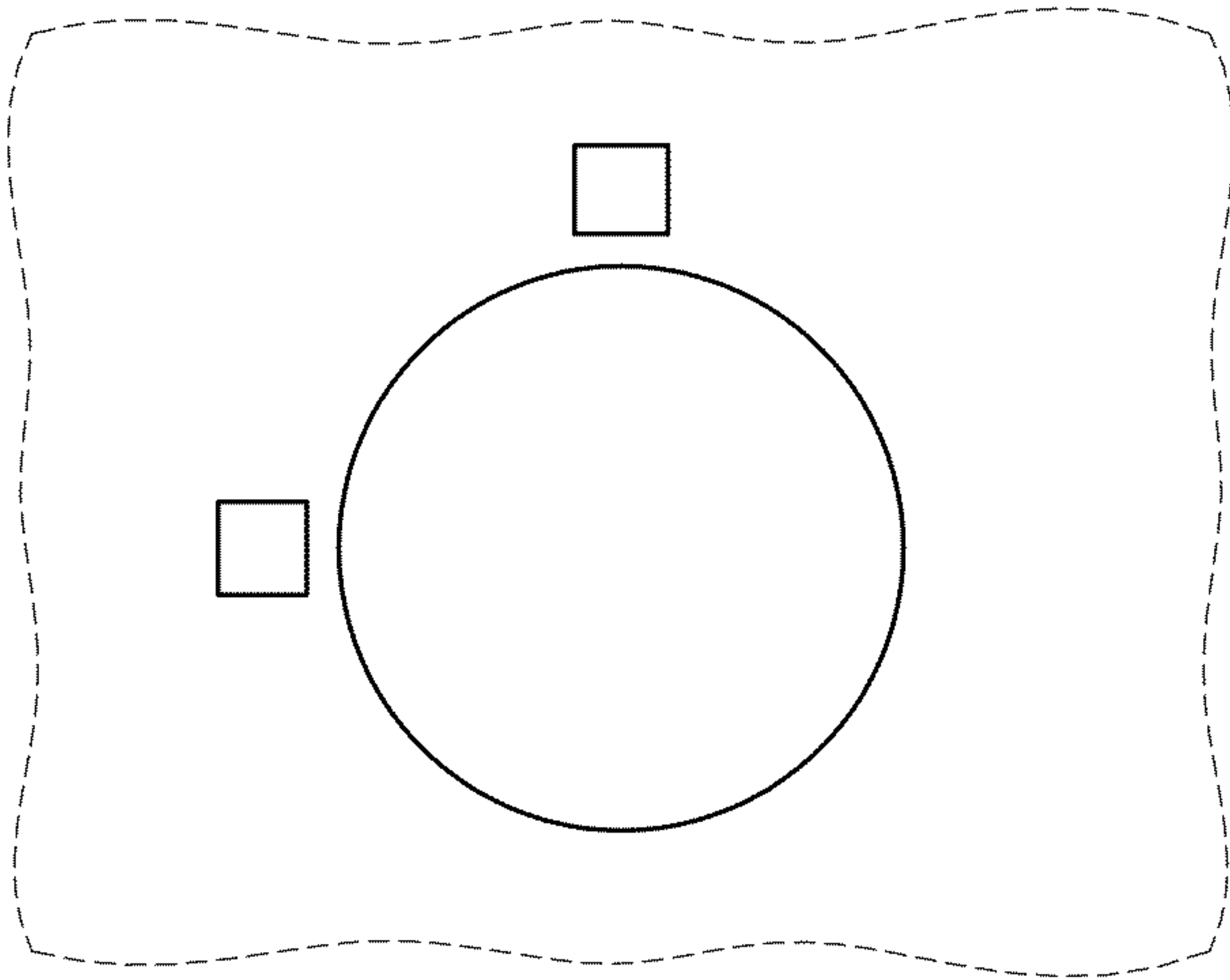
