DESCRIPTION

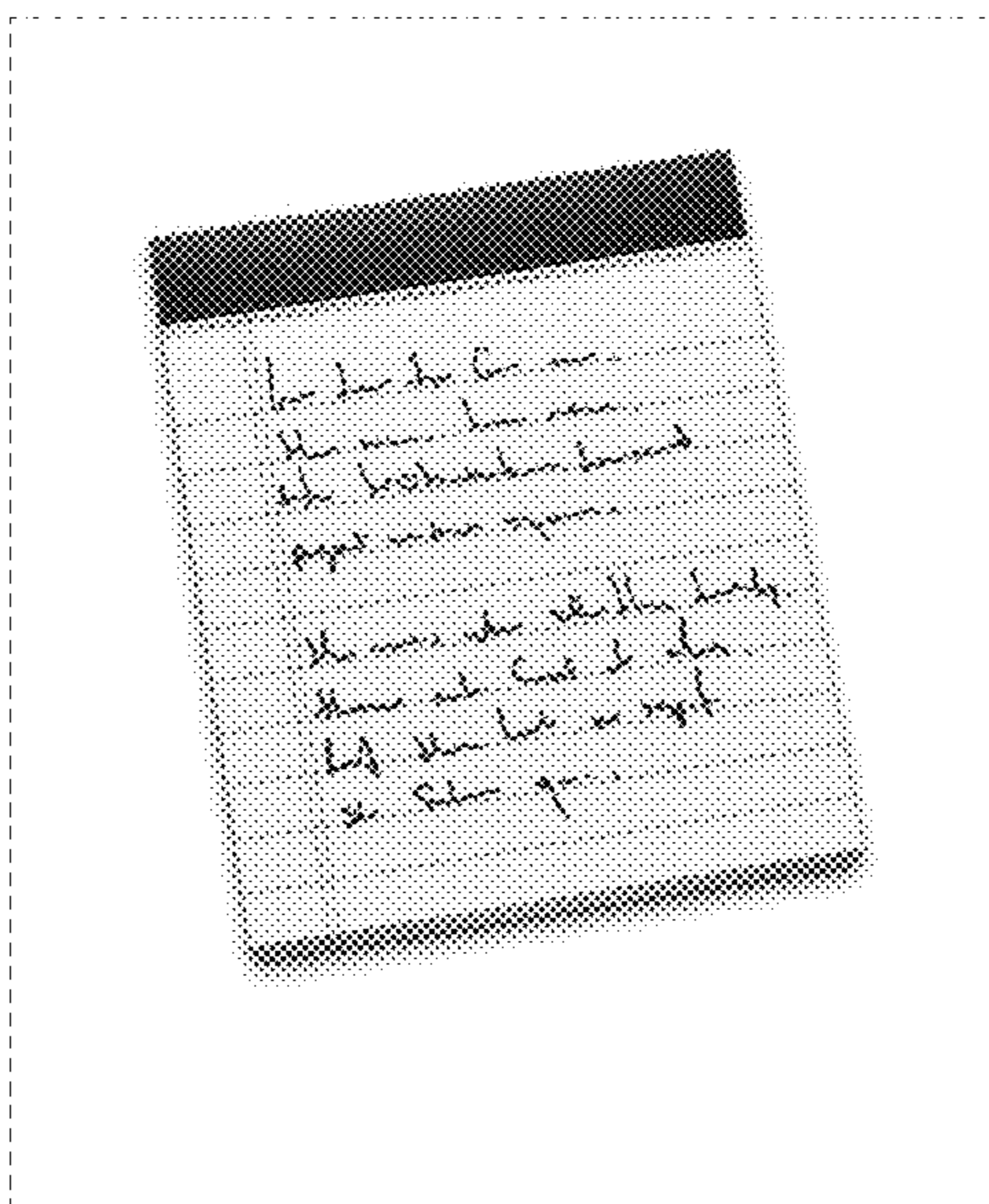

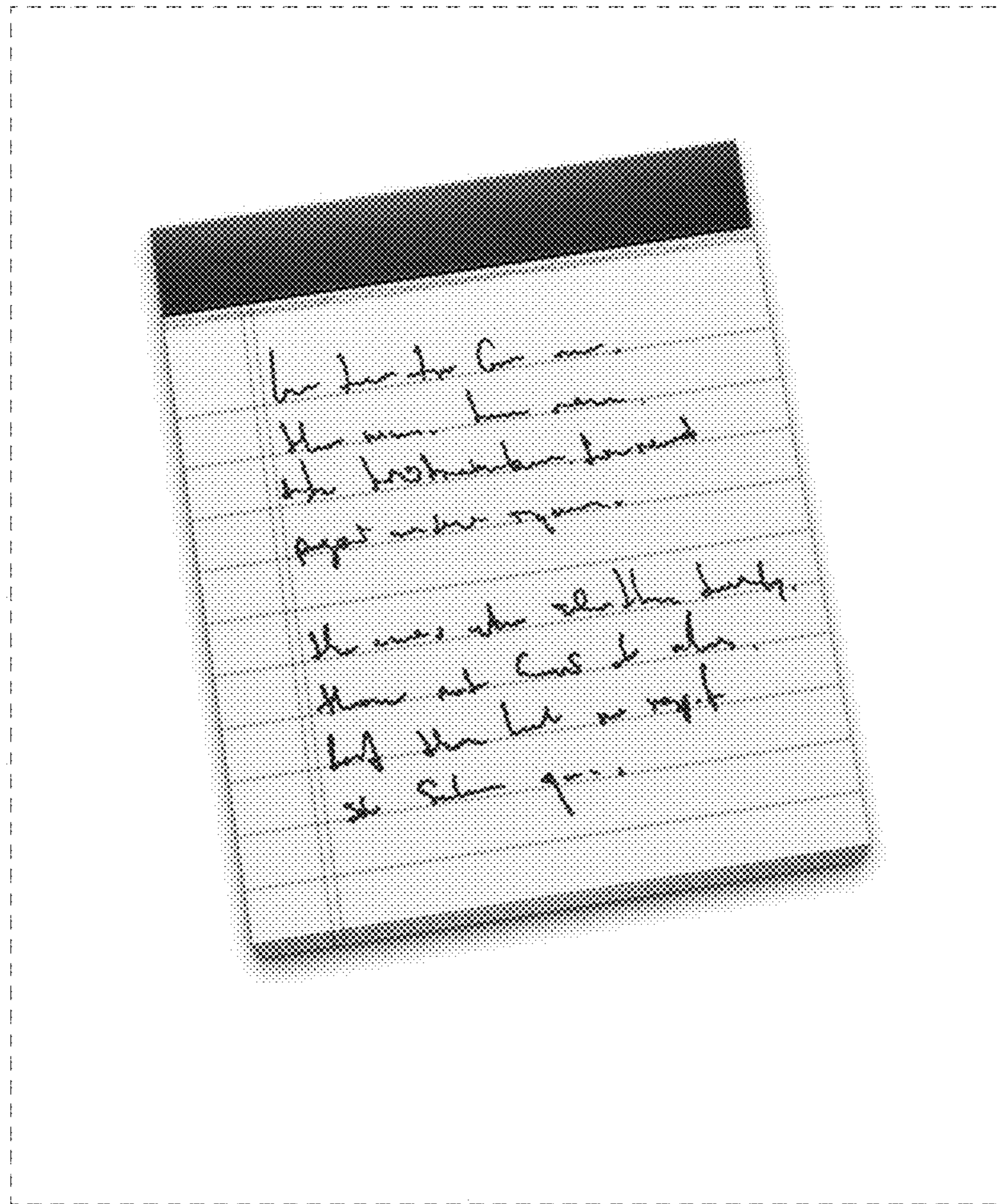
