(57) **CLAIM**

The ornamental design for a refrigerator handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a refrigerator handle, showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left-side view thereof;

FIG. 5 is a right-side view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a rear perspective view thereof;

FIG. 9 is another perspective view of the refrigerator handle of FIG. 1, in which an unclaimed element is provided to illustrate an example unclaimed environment; and,

FIG. 10 is a partially enlarged rear view of FIG. 3.

The broken lines in the drawings show unclaimed subject matter only and form no part of the claimed design.

The dot-dot-dash style broken lines in FIG. 3 and FIG. 10 illustrate the boundary of the isolated detail view which is enlarged in FIG. 10.

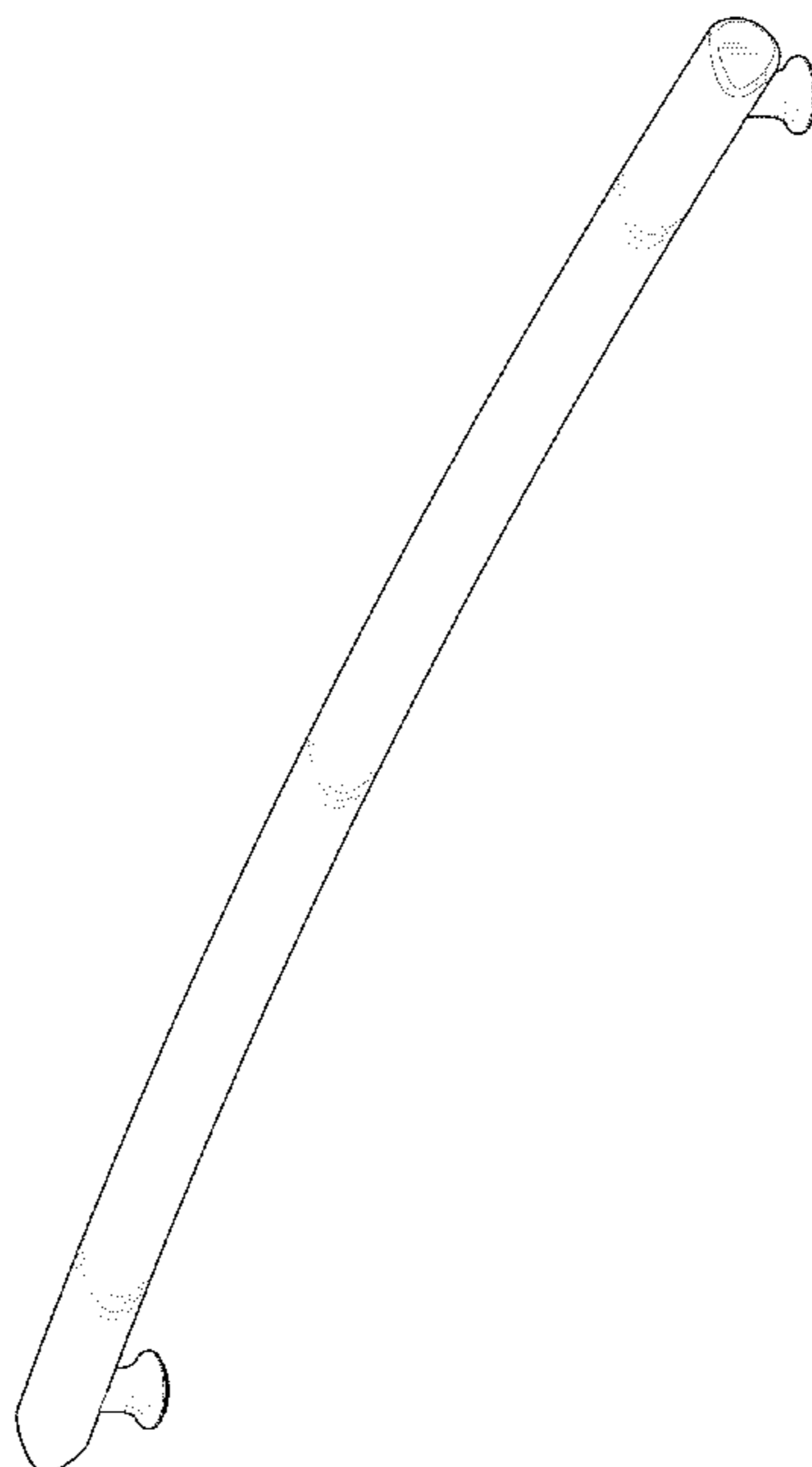

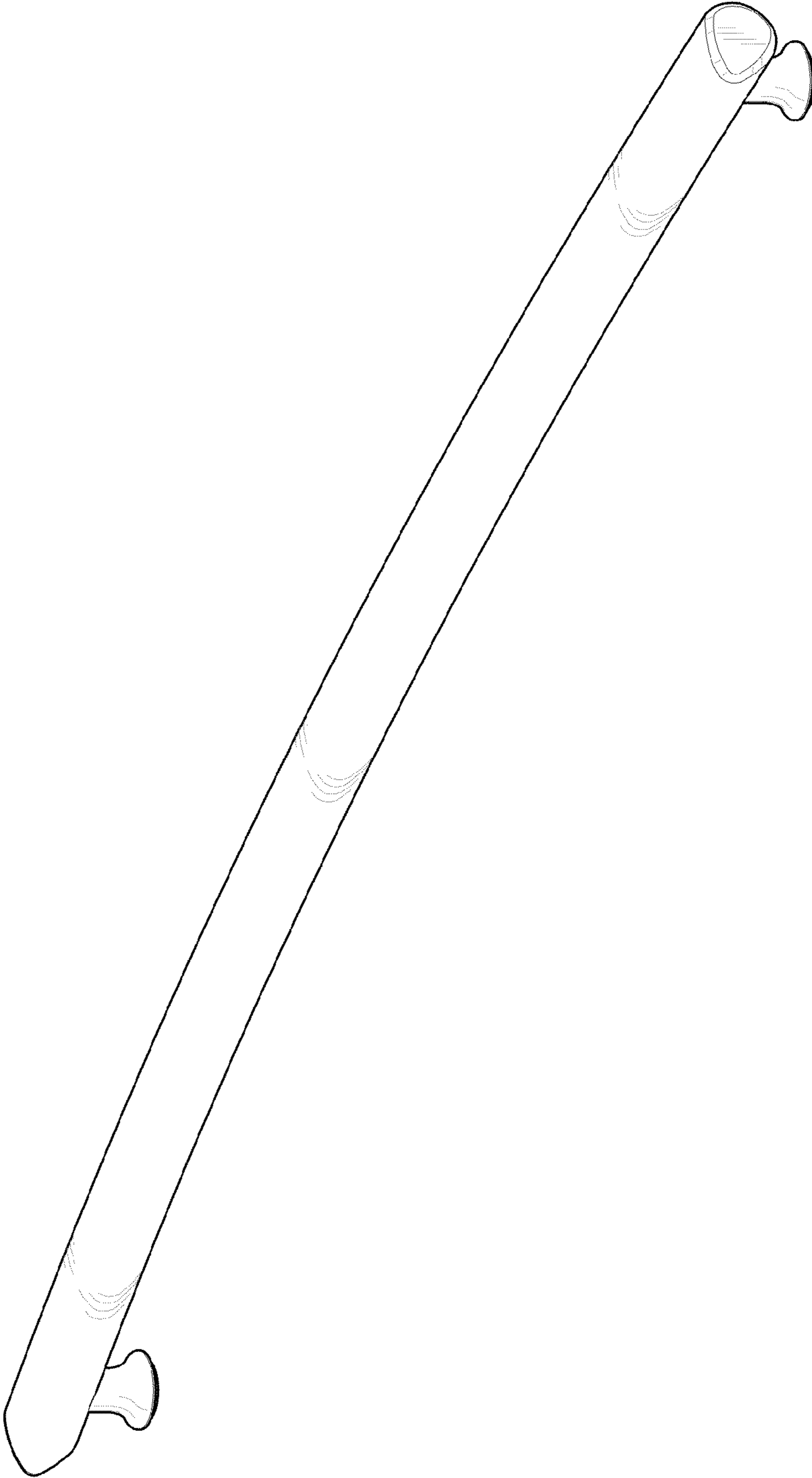

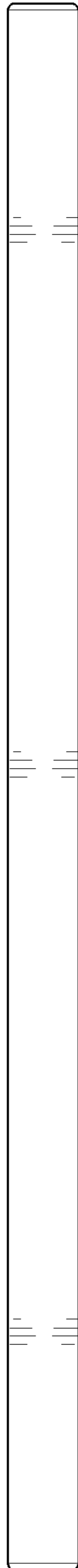

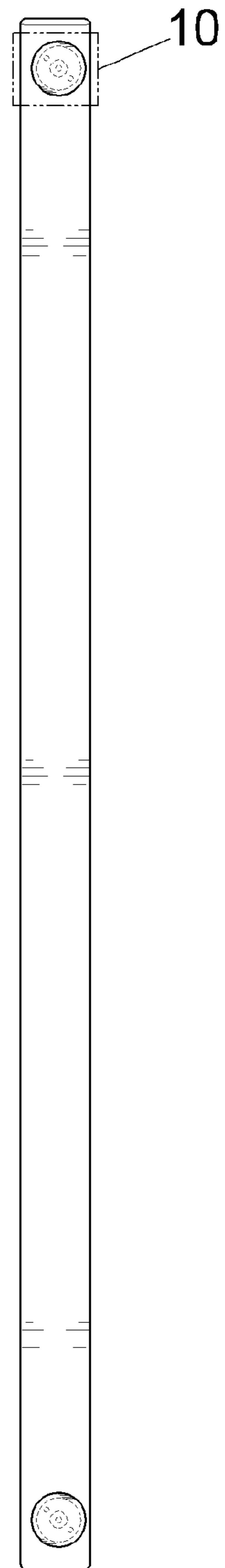

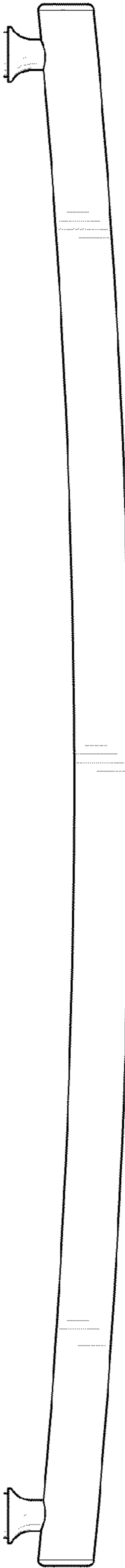

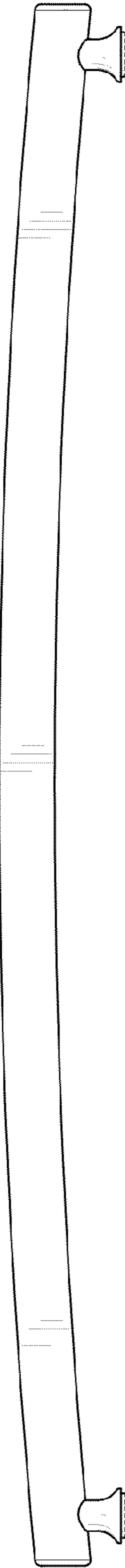

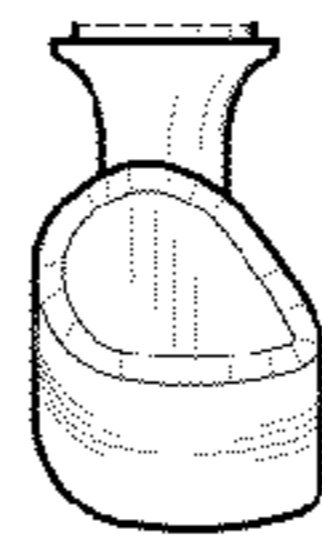

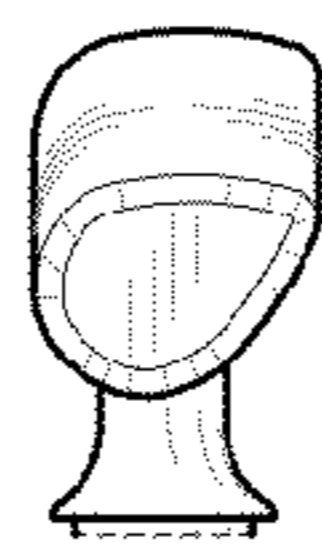

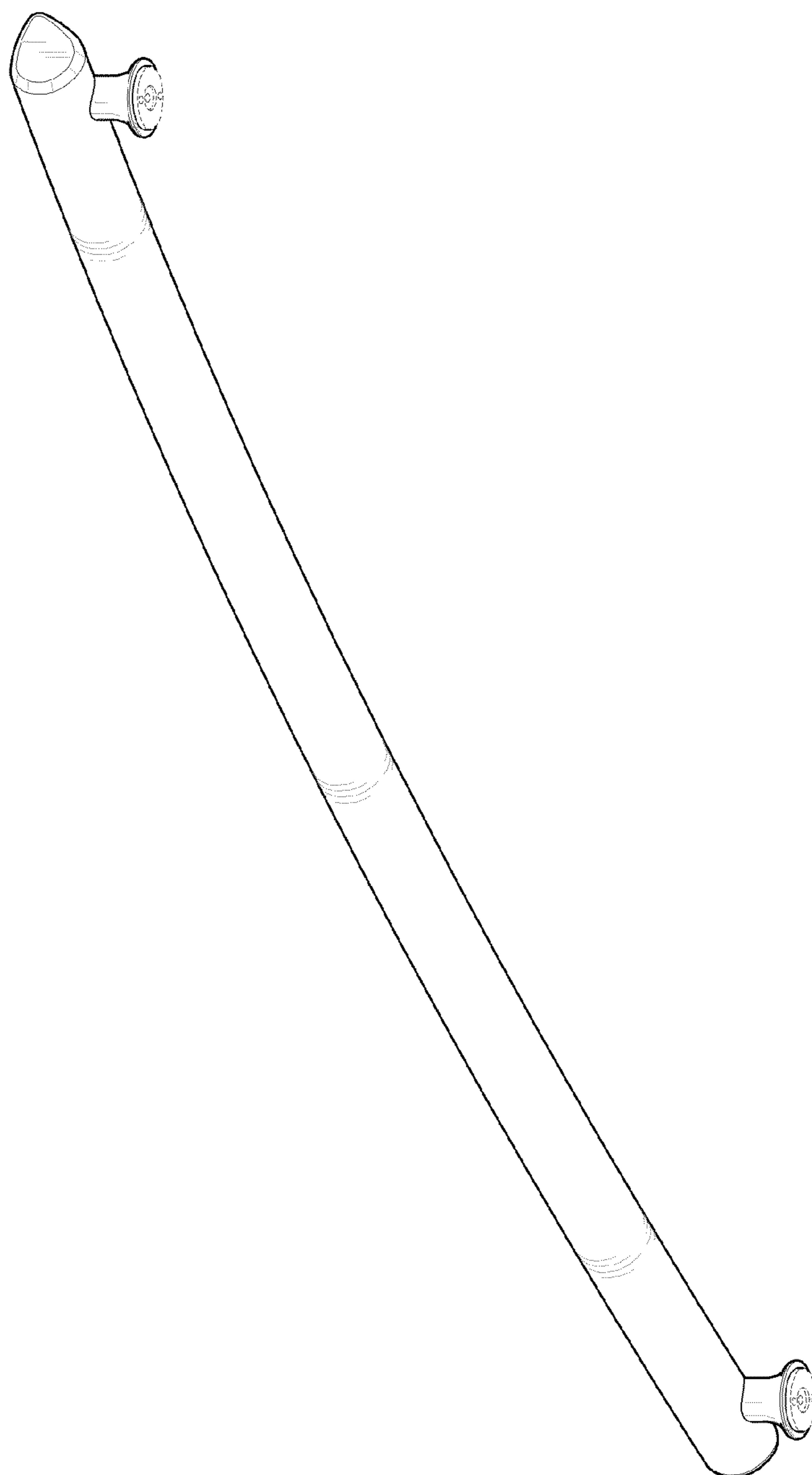

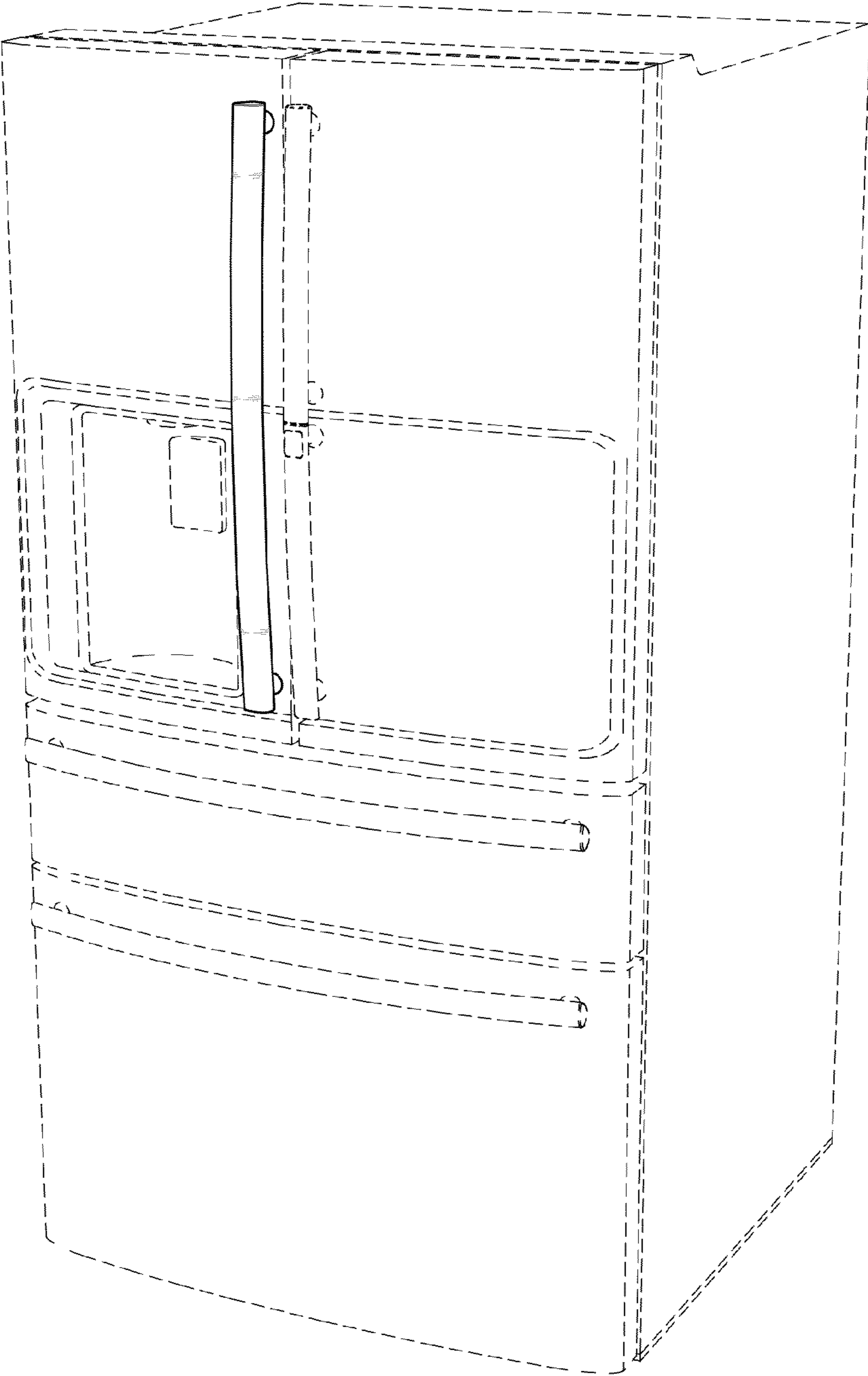
