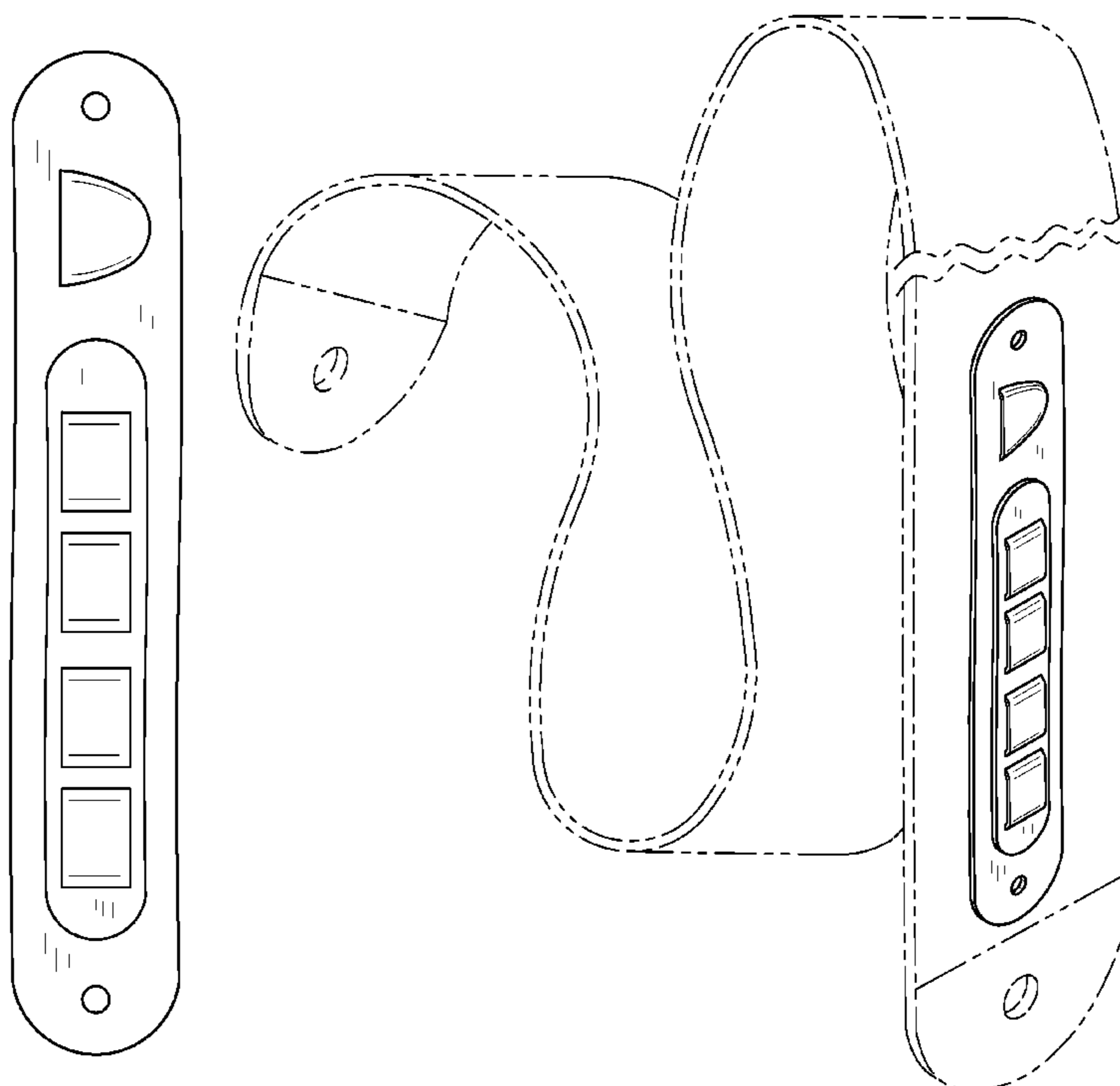
(57) **CLAIM**

I claim the ornamental design for the guitar strap rack, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the guitar strap rack.
FIG. 2 is a rear view of the claimed design.
FIG. 3 is a left side view of the claimed design.
FIG. 4 is a right side view of the claimed design.
FIG. 5 is a top view of the claimed design.
FIG. 6 is a bottom view of the claimed design; and,
FIG. 7 is a perspective view of the claimed design affixed to an outer surface of a guitar strap, which is depicted in broken lines as environmental matter forming no part of the claimed design.

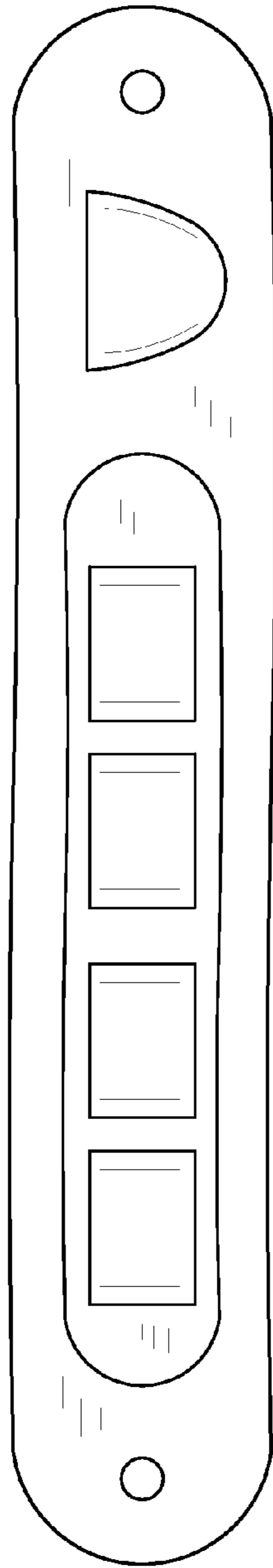

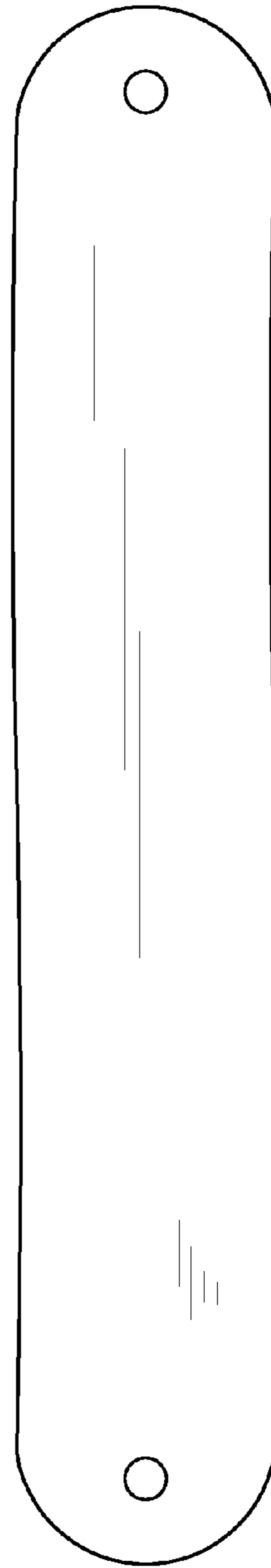

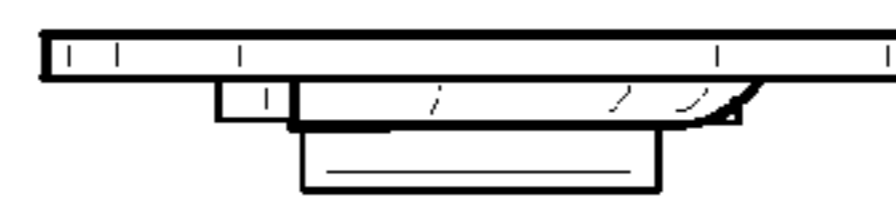

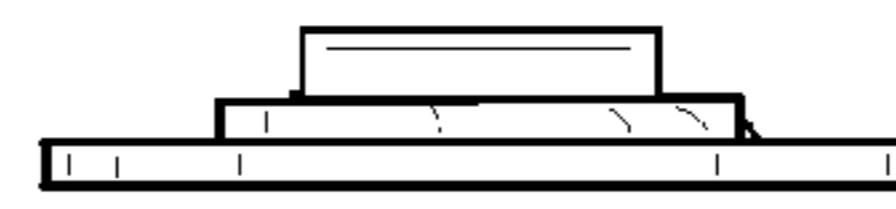

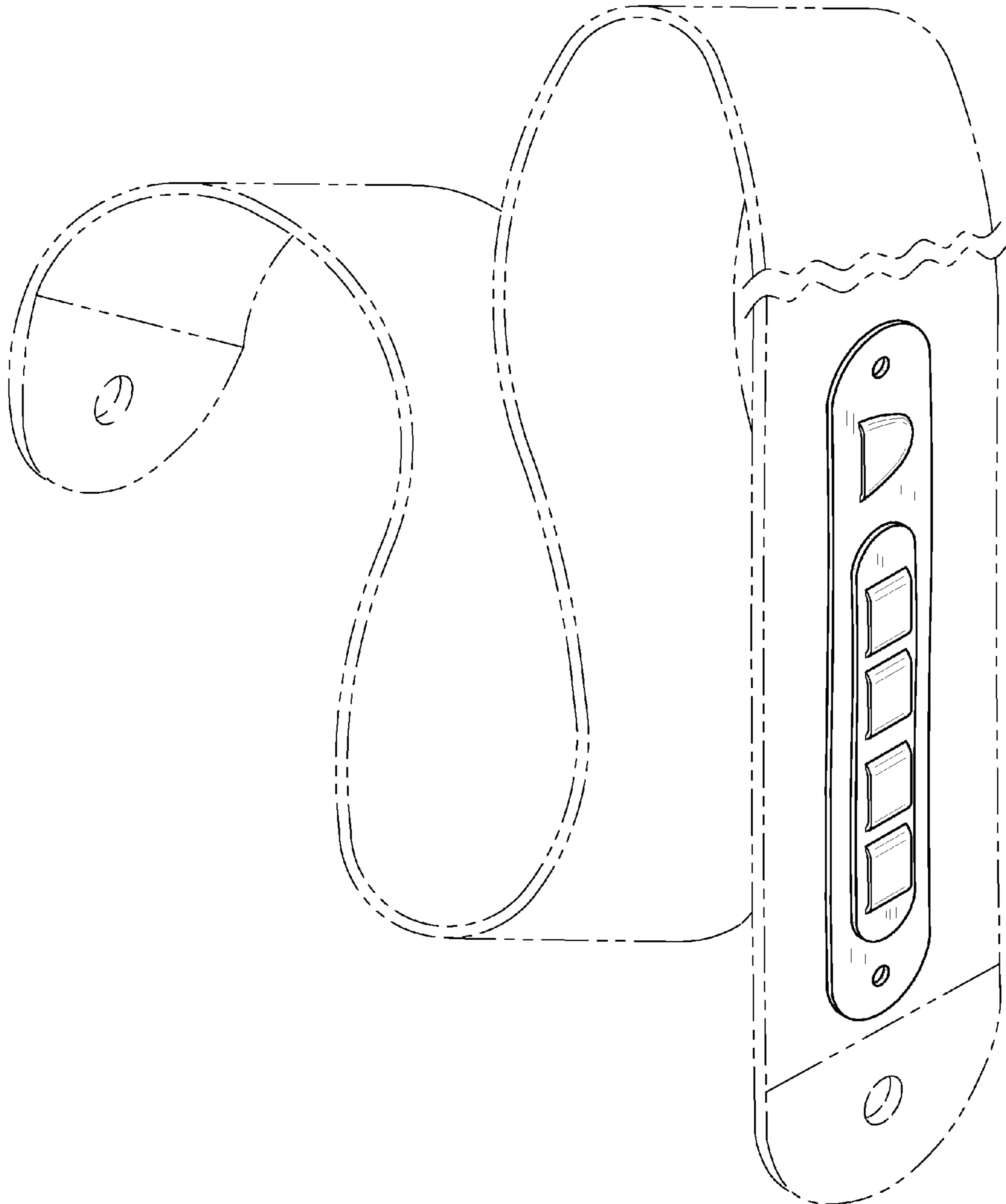
