FIG. 2 is a back view of FIG. 1;

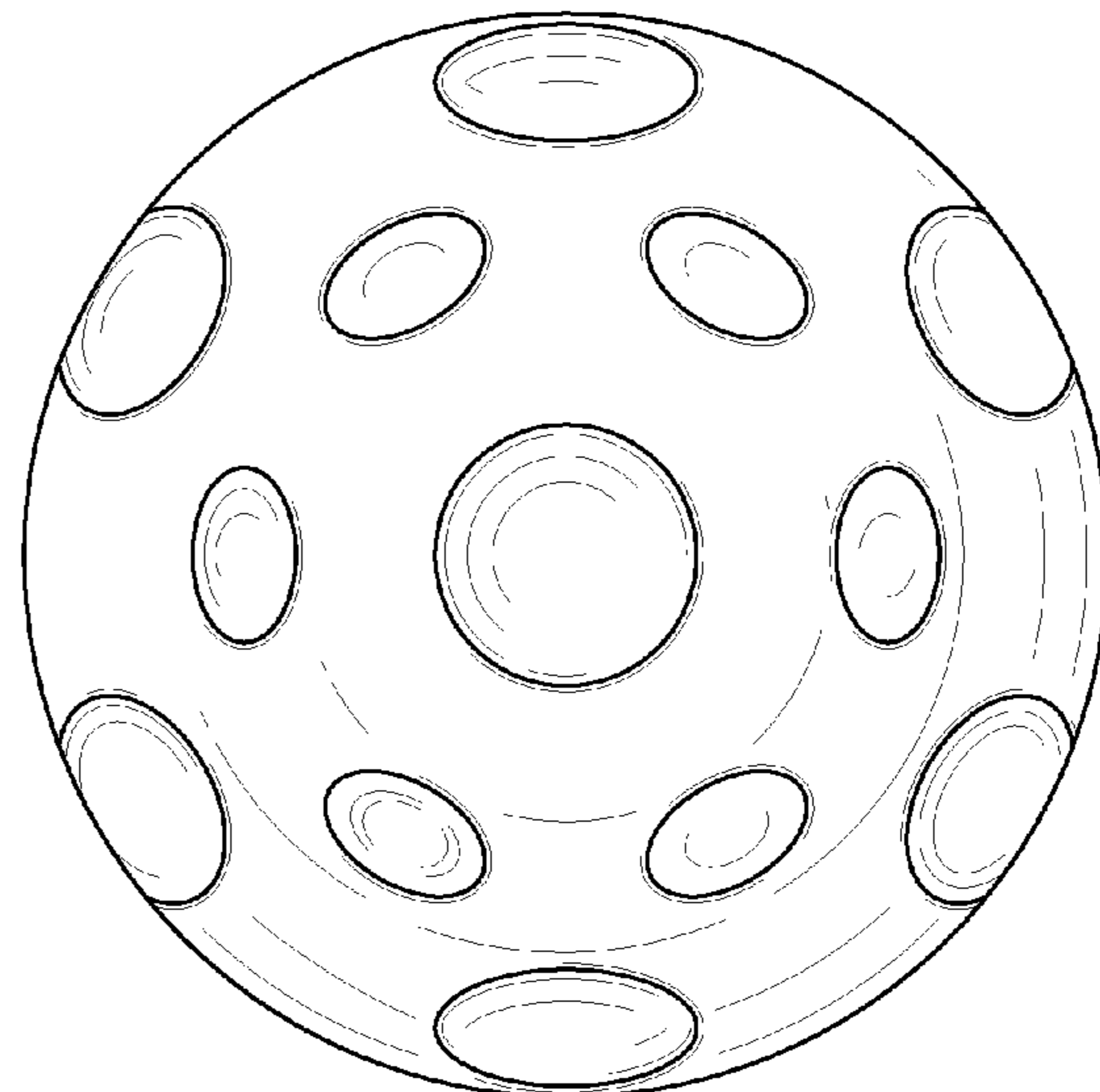
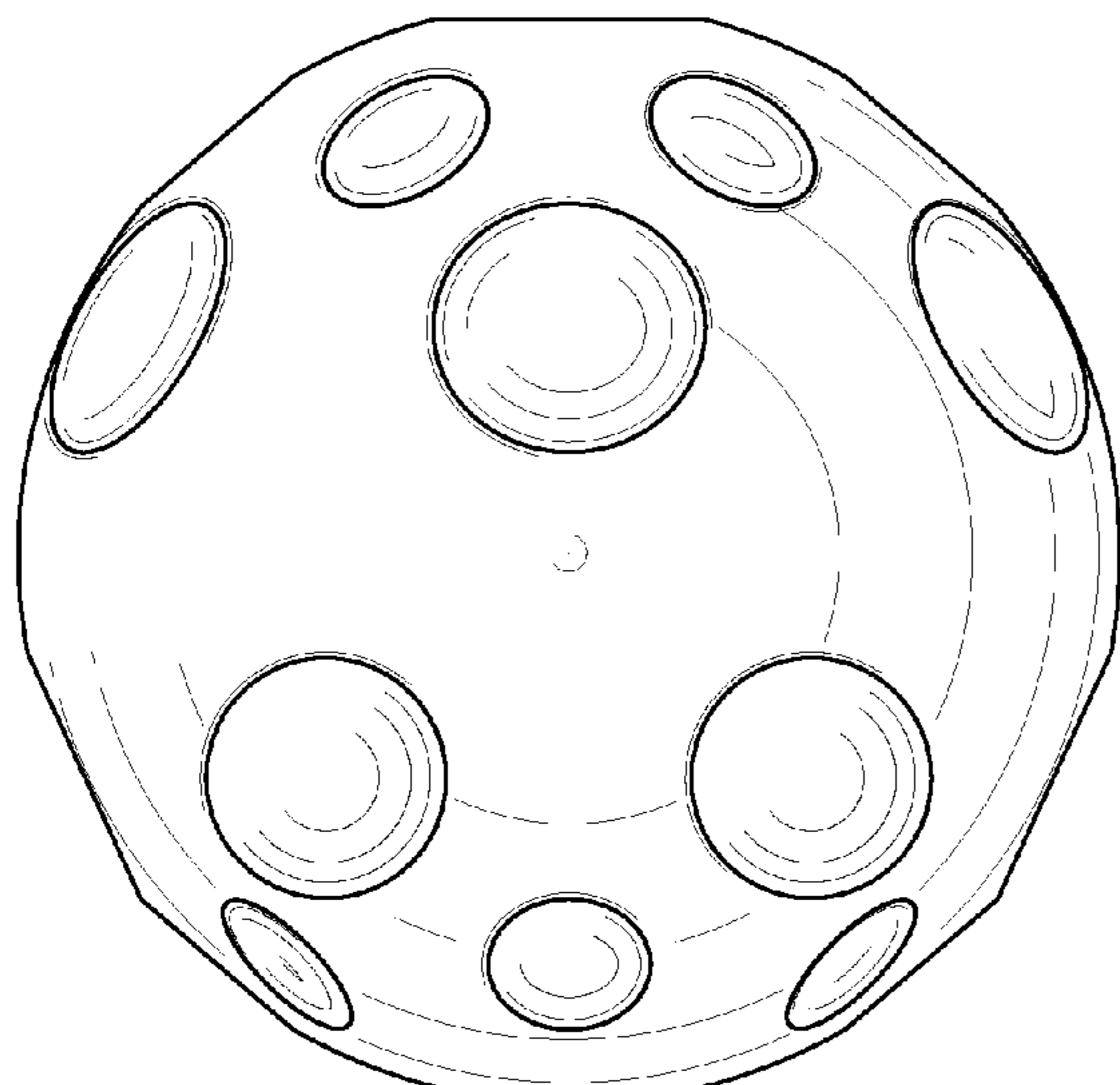
FIG. 3 is a right view of FIG. 1;

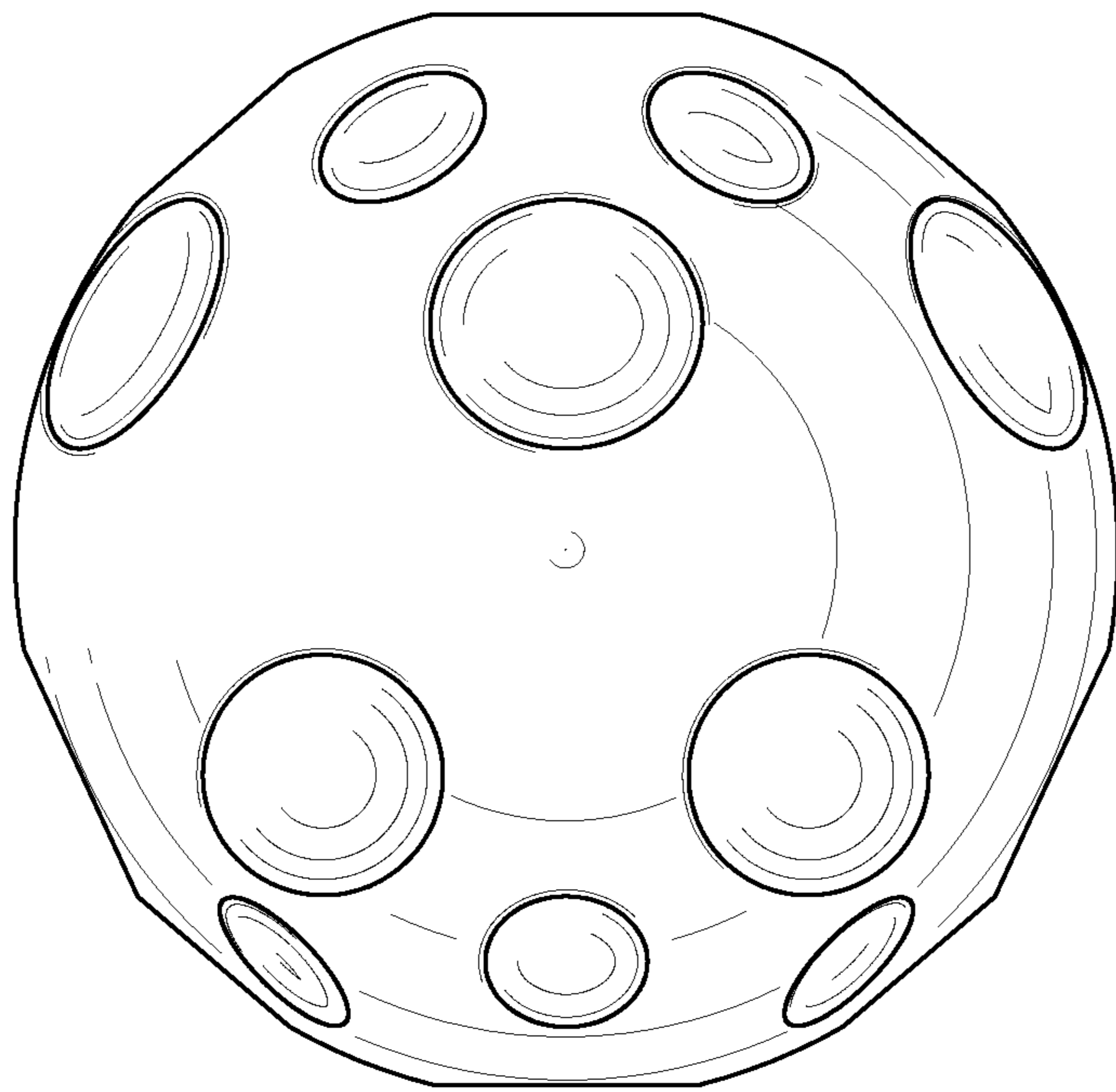

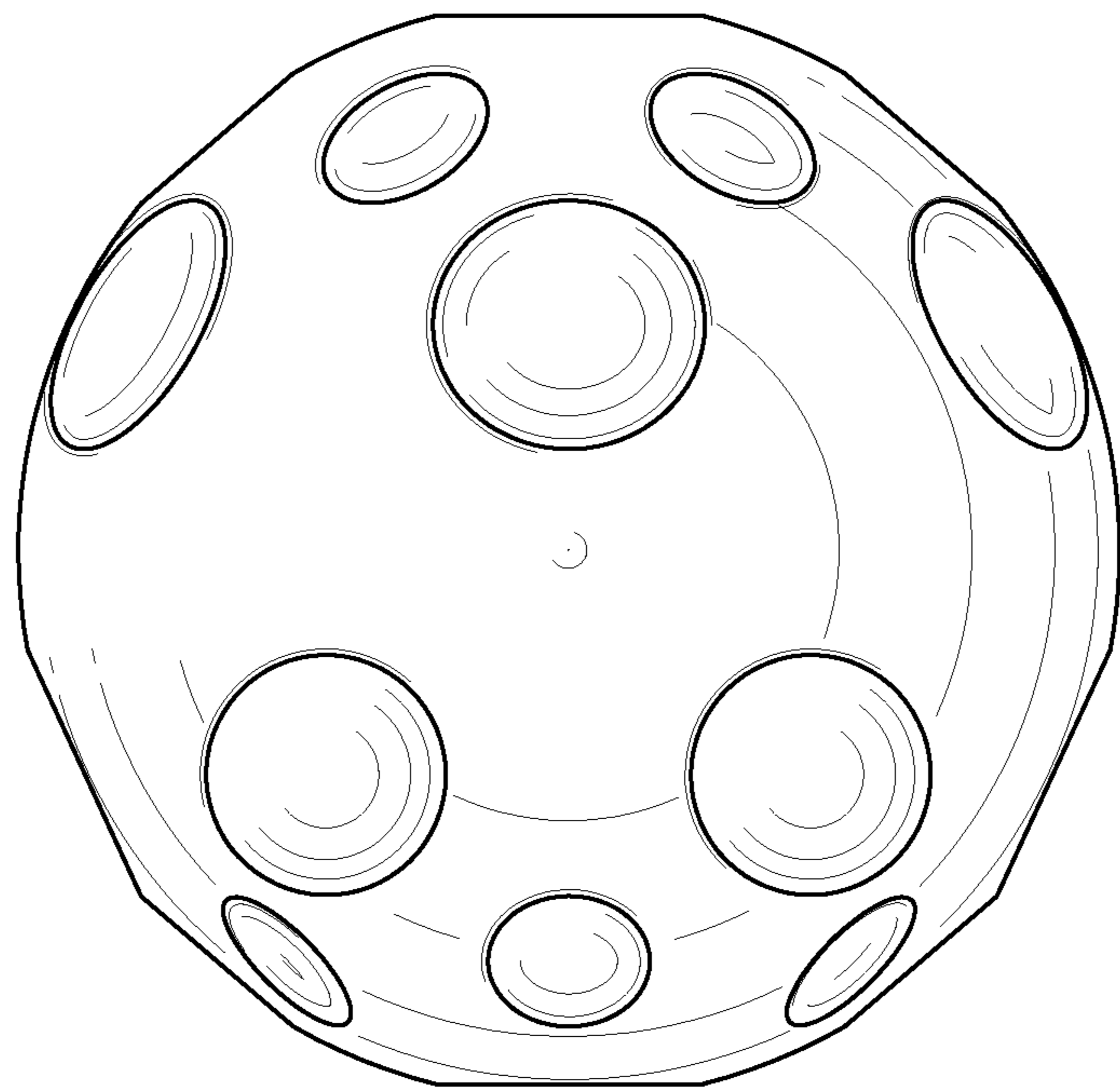

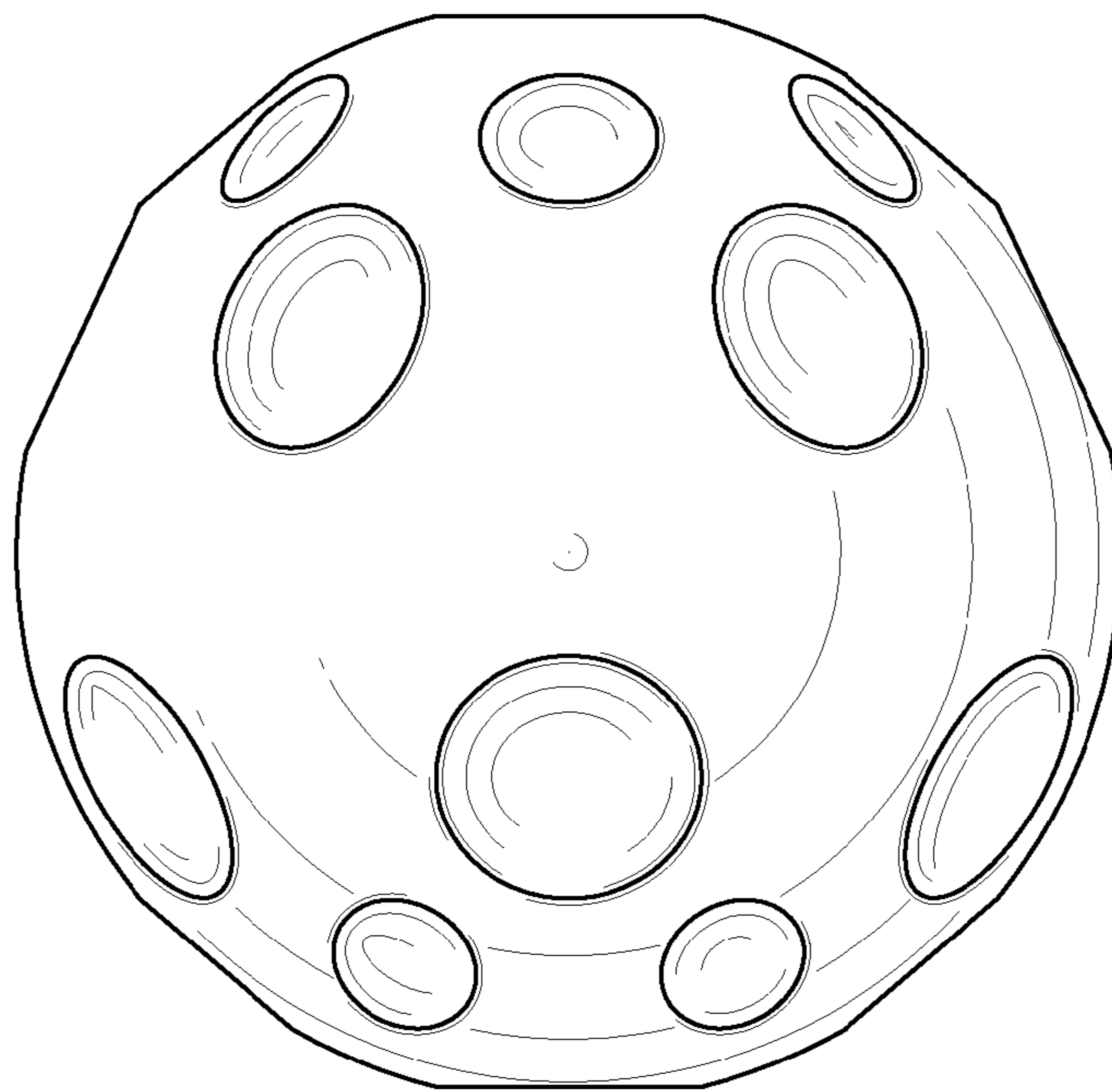

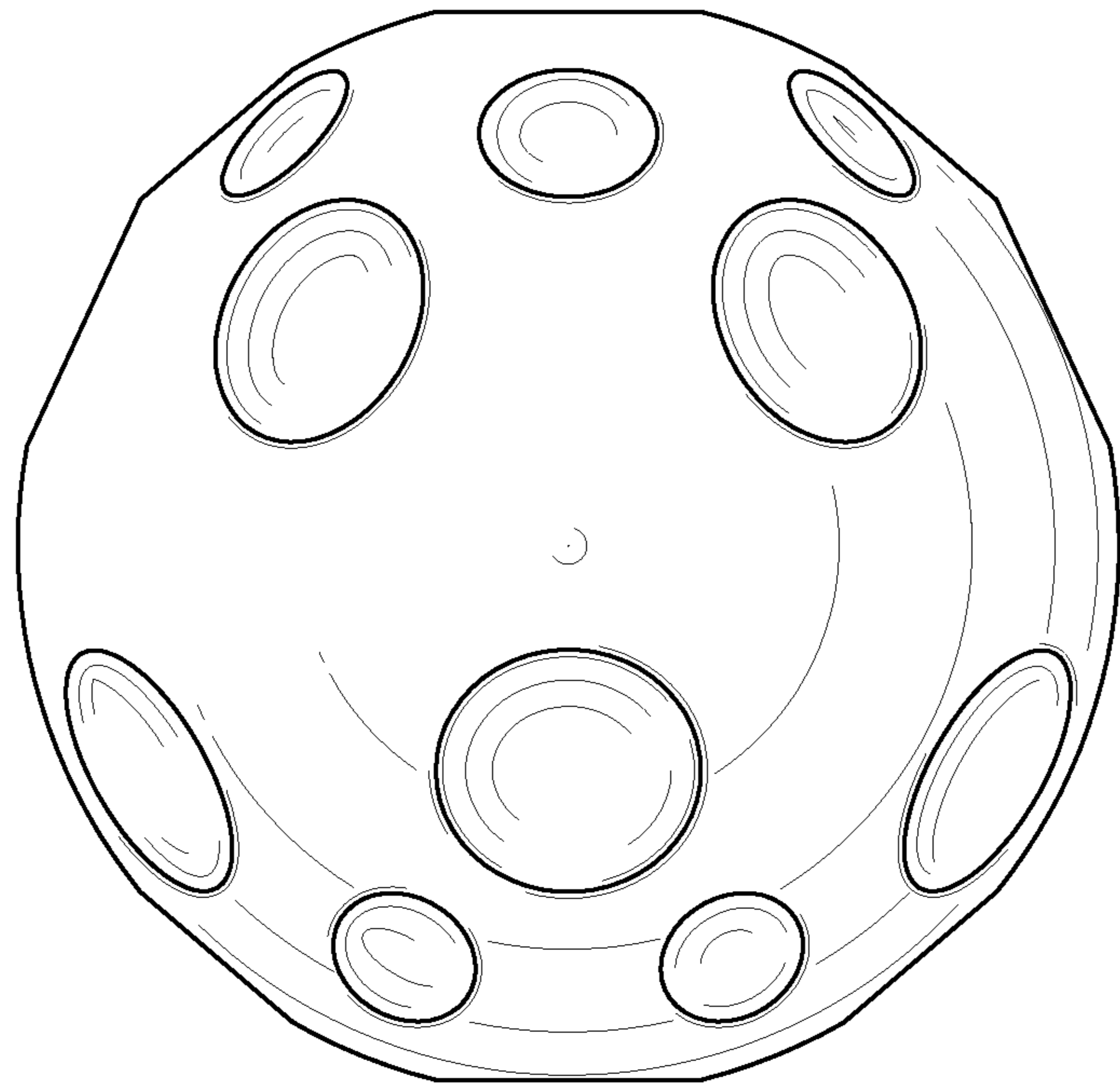

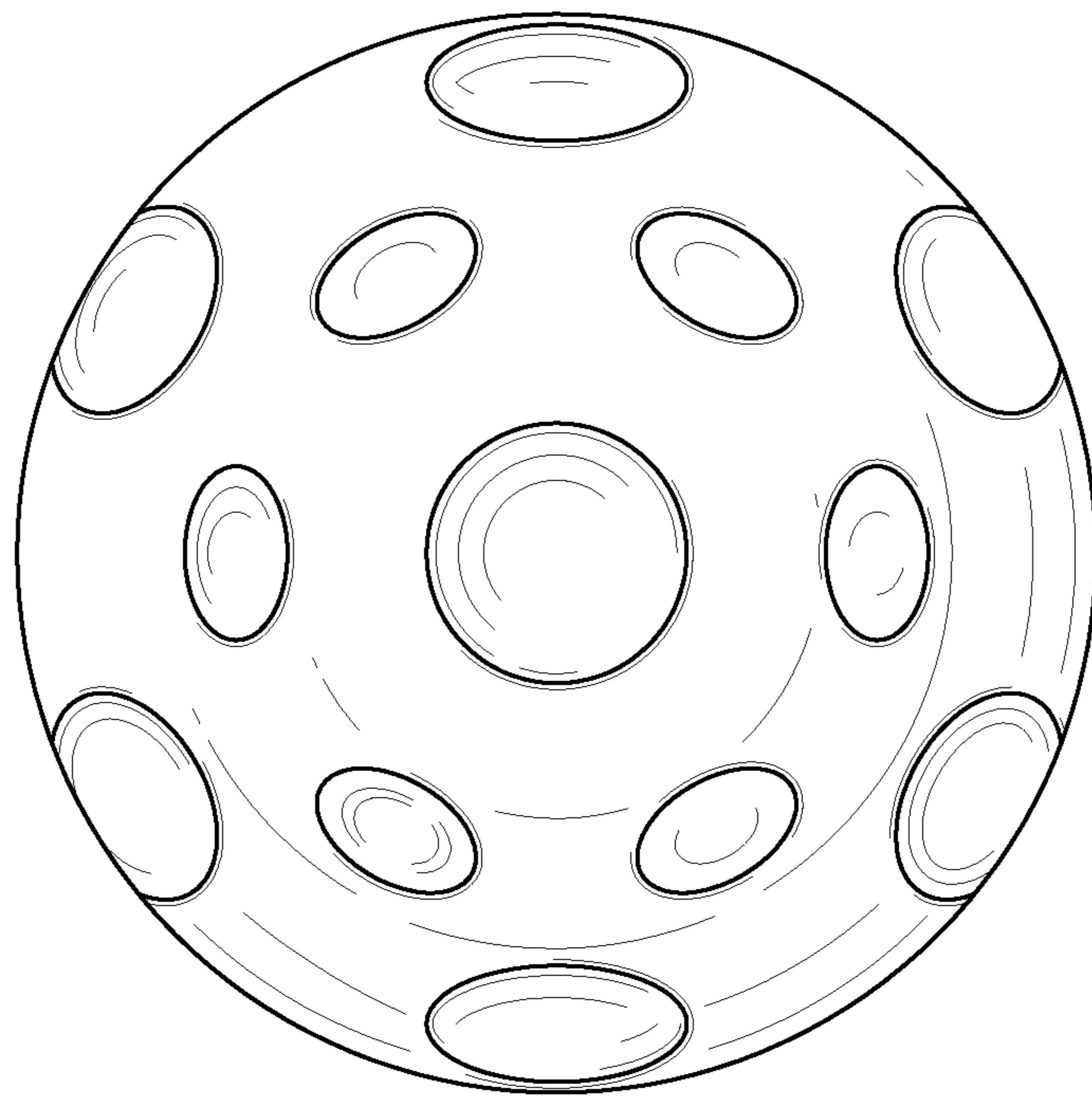

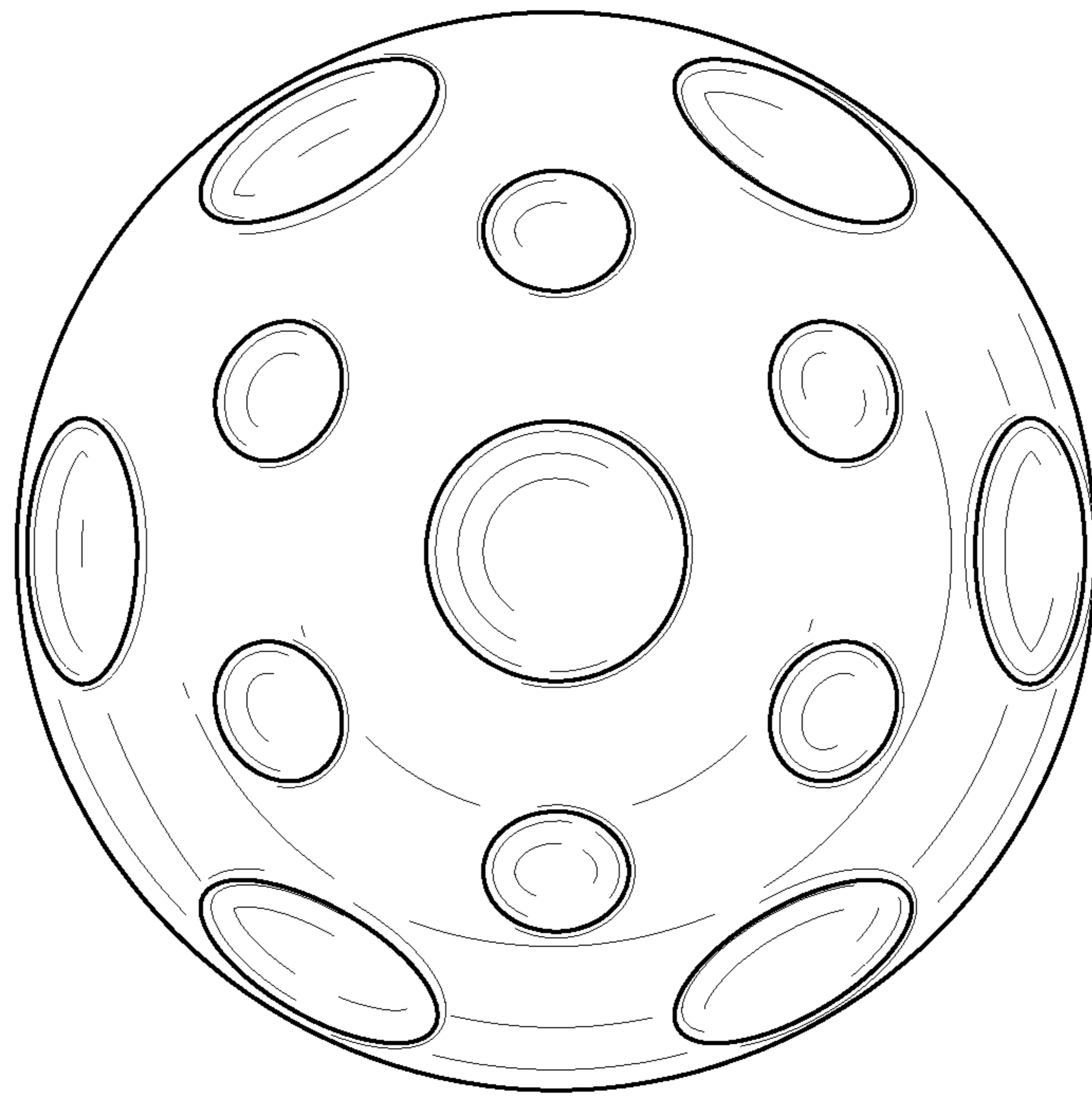
