**DESCRIPTION**

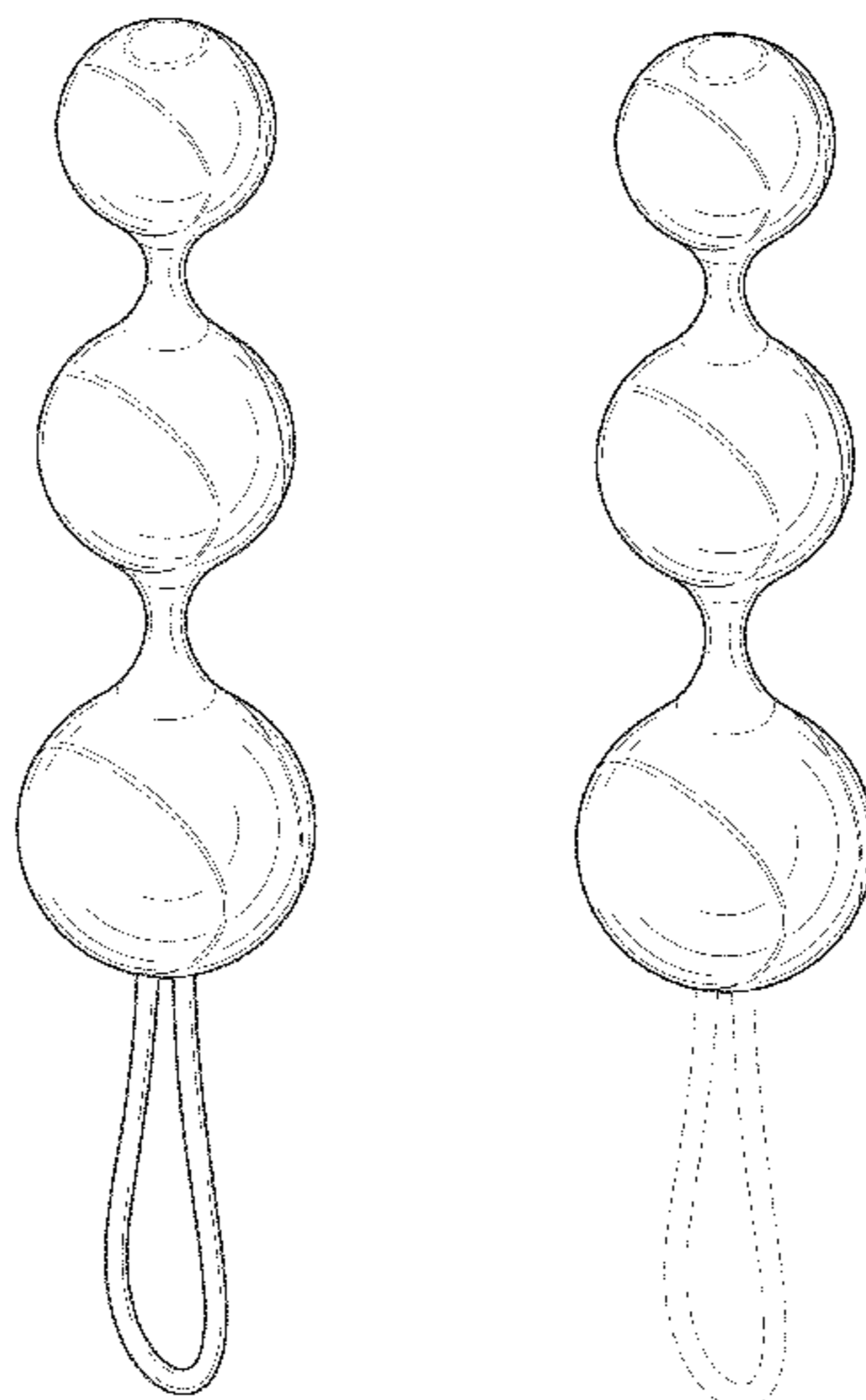

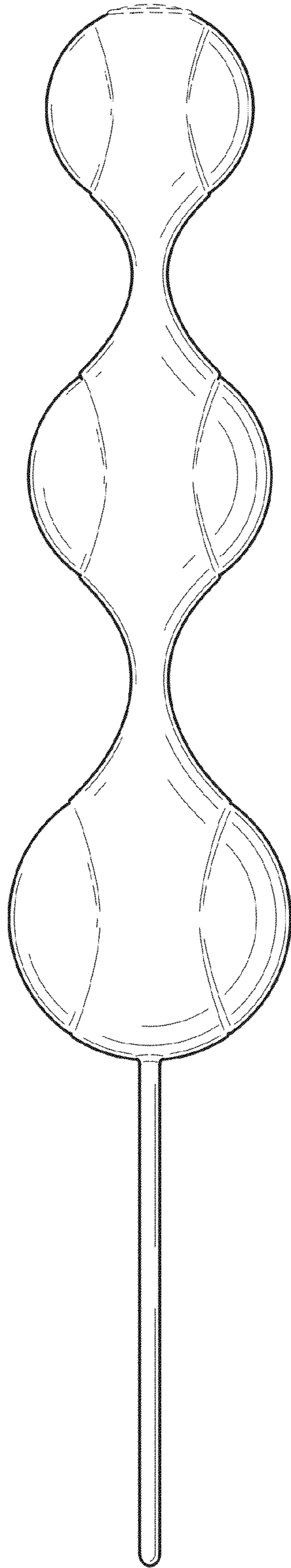

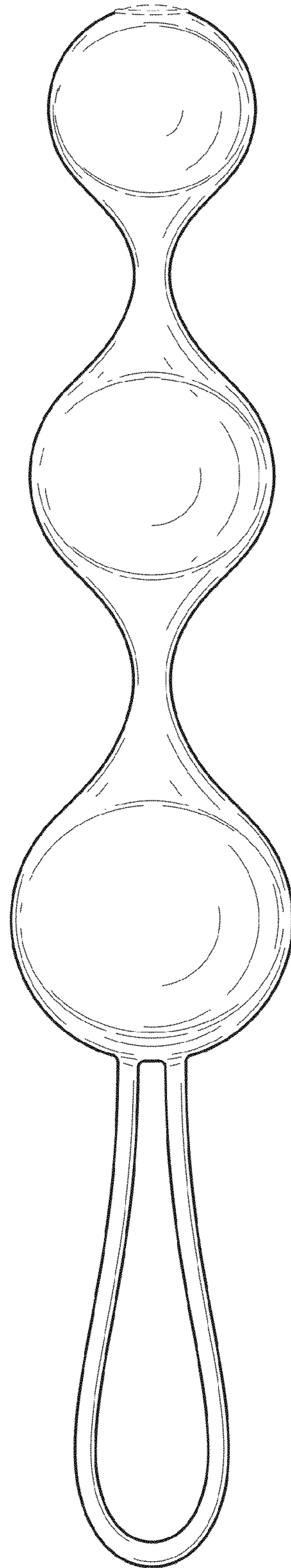

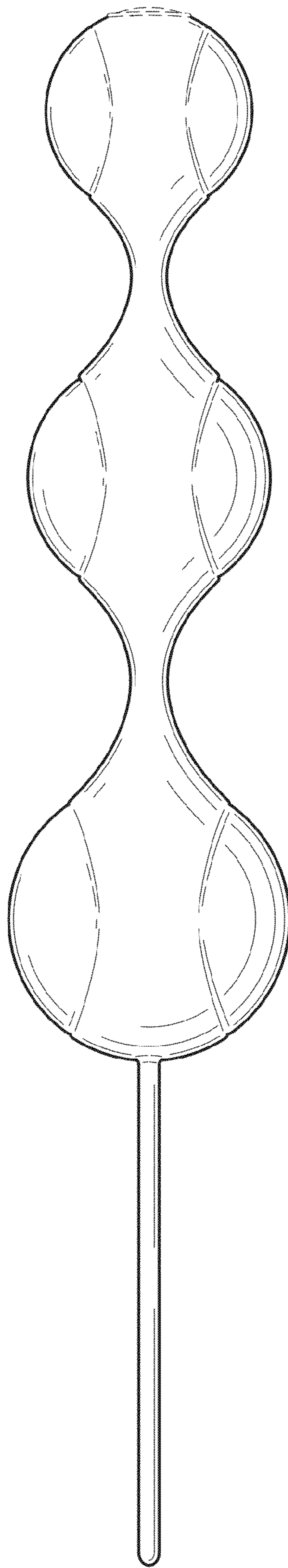

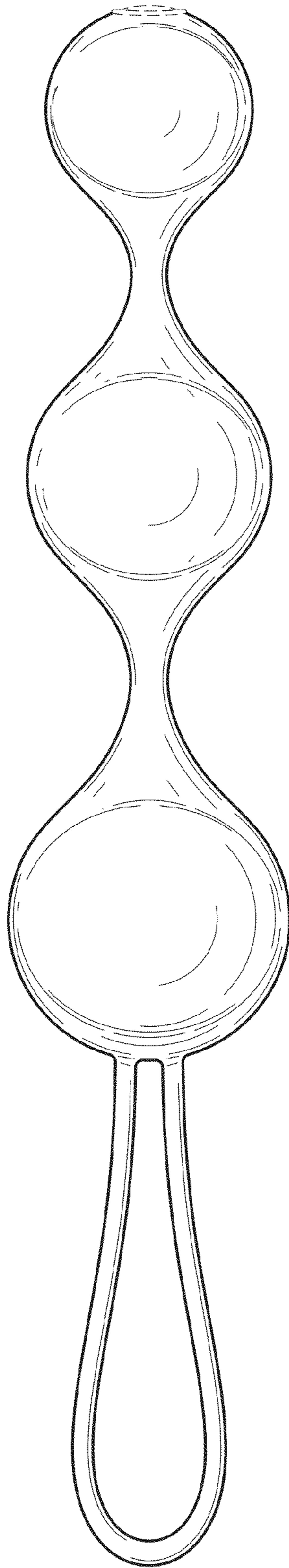

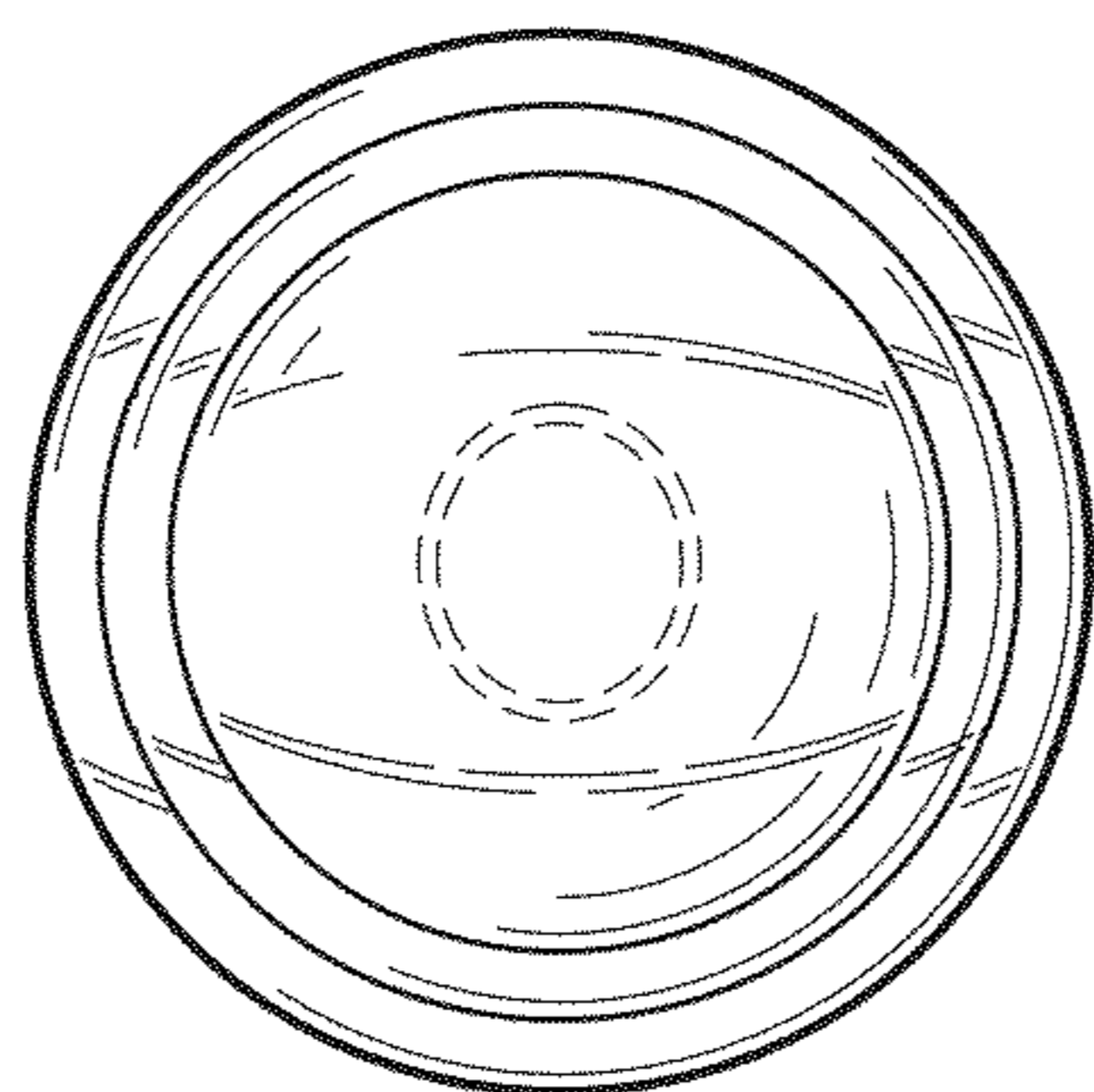

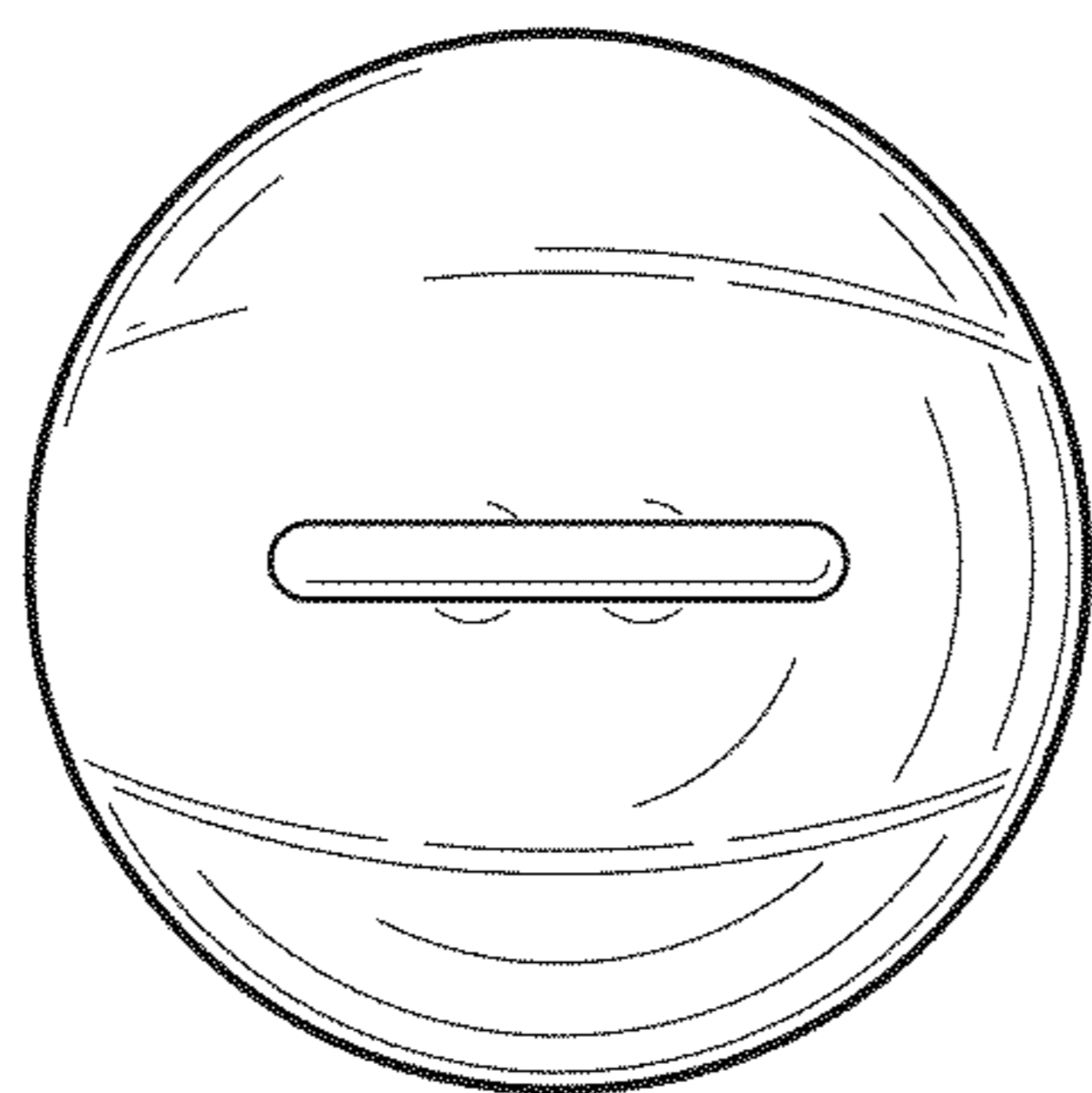

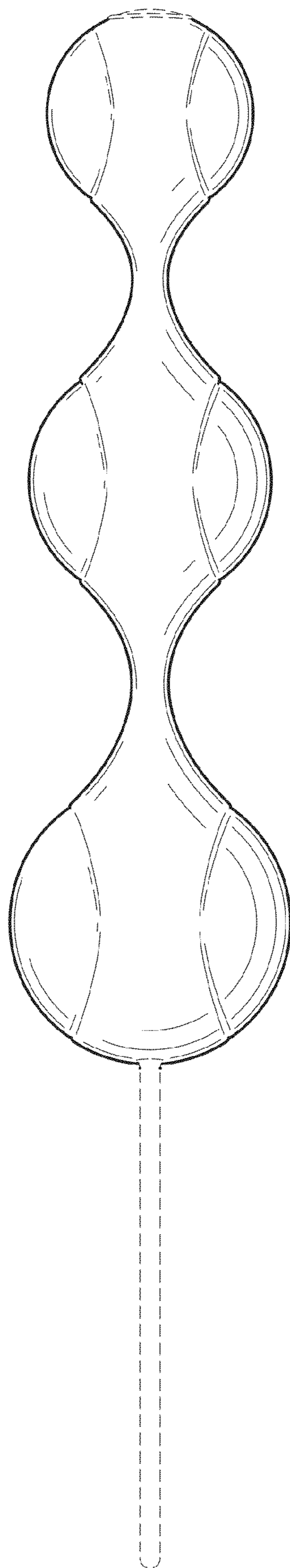

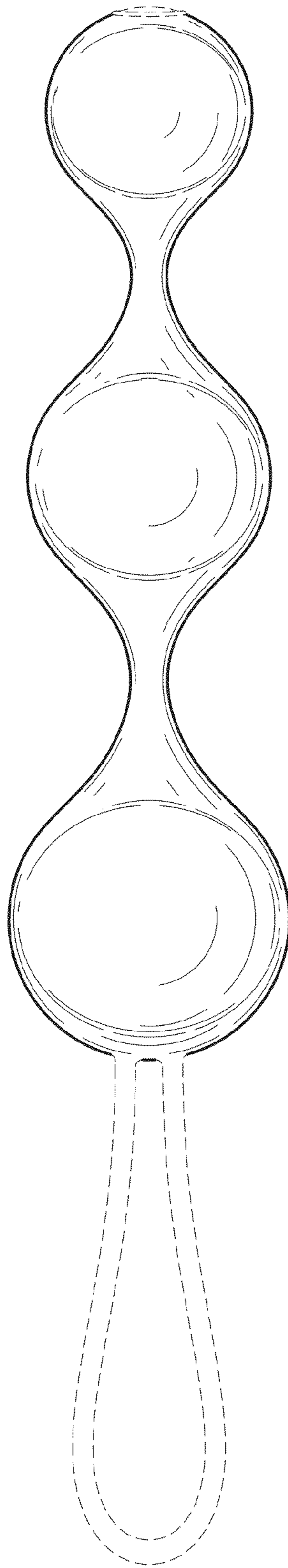

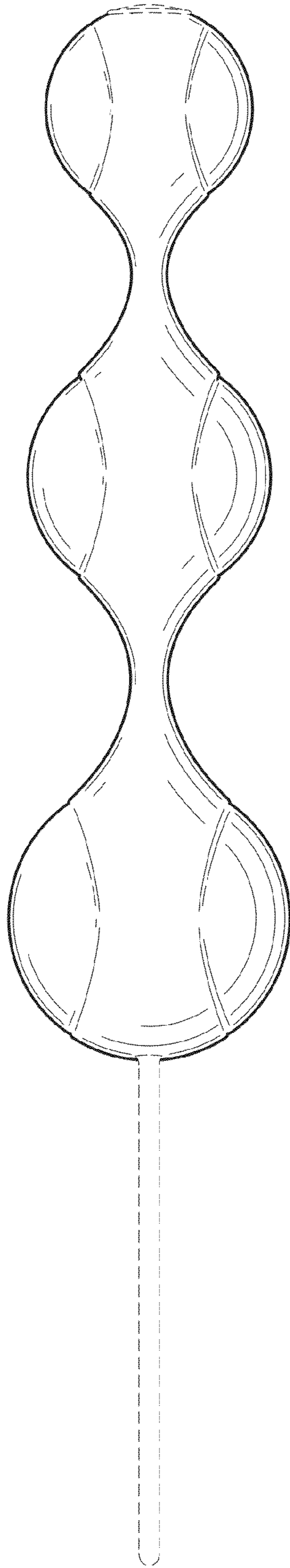

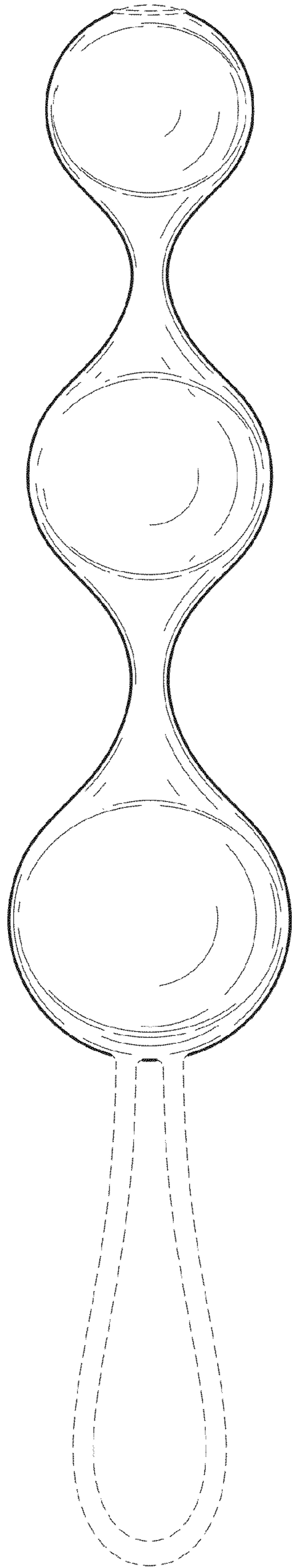

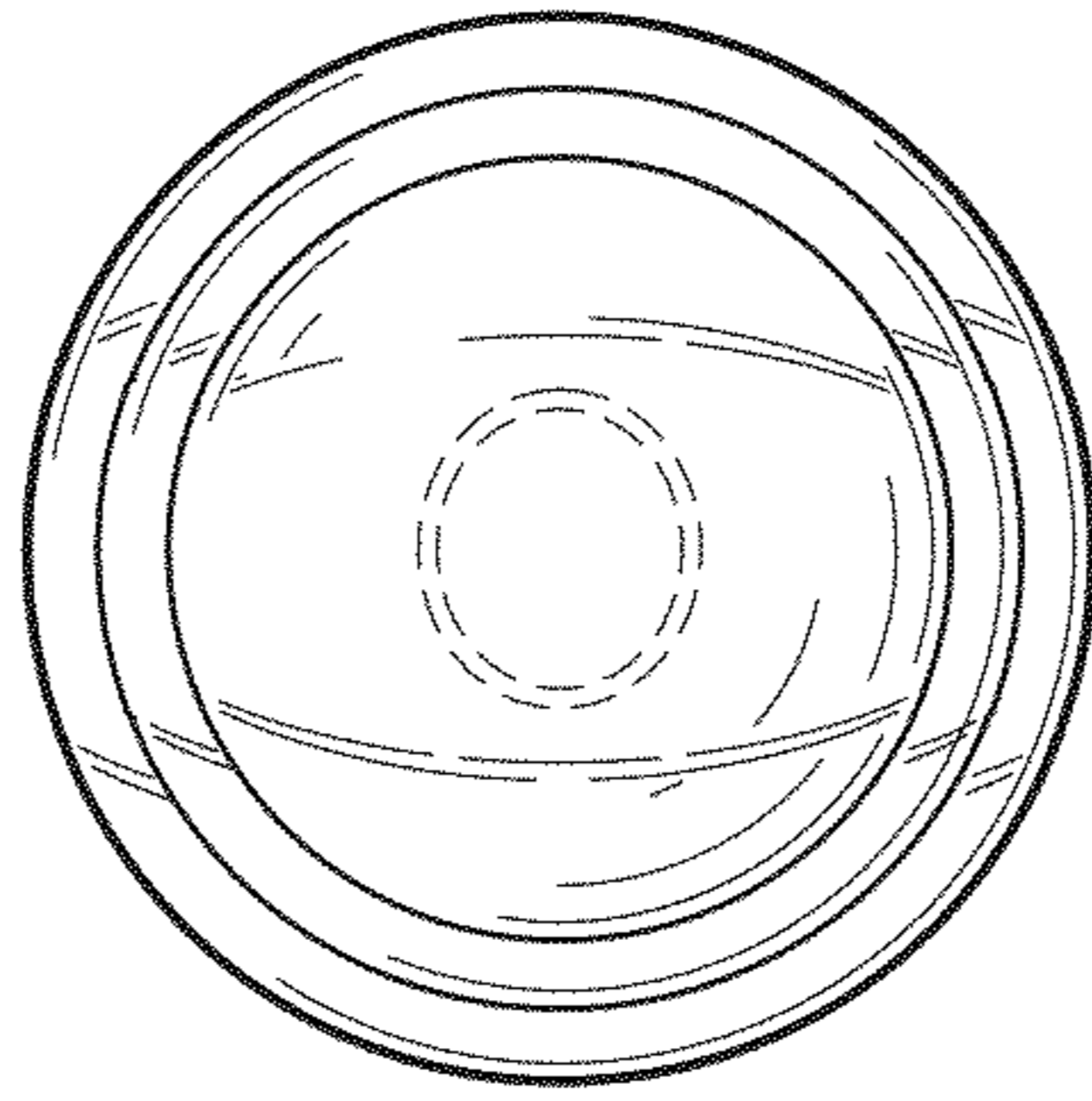

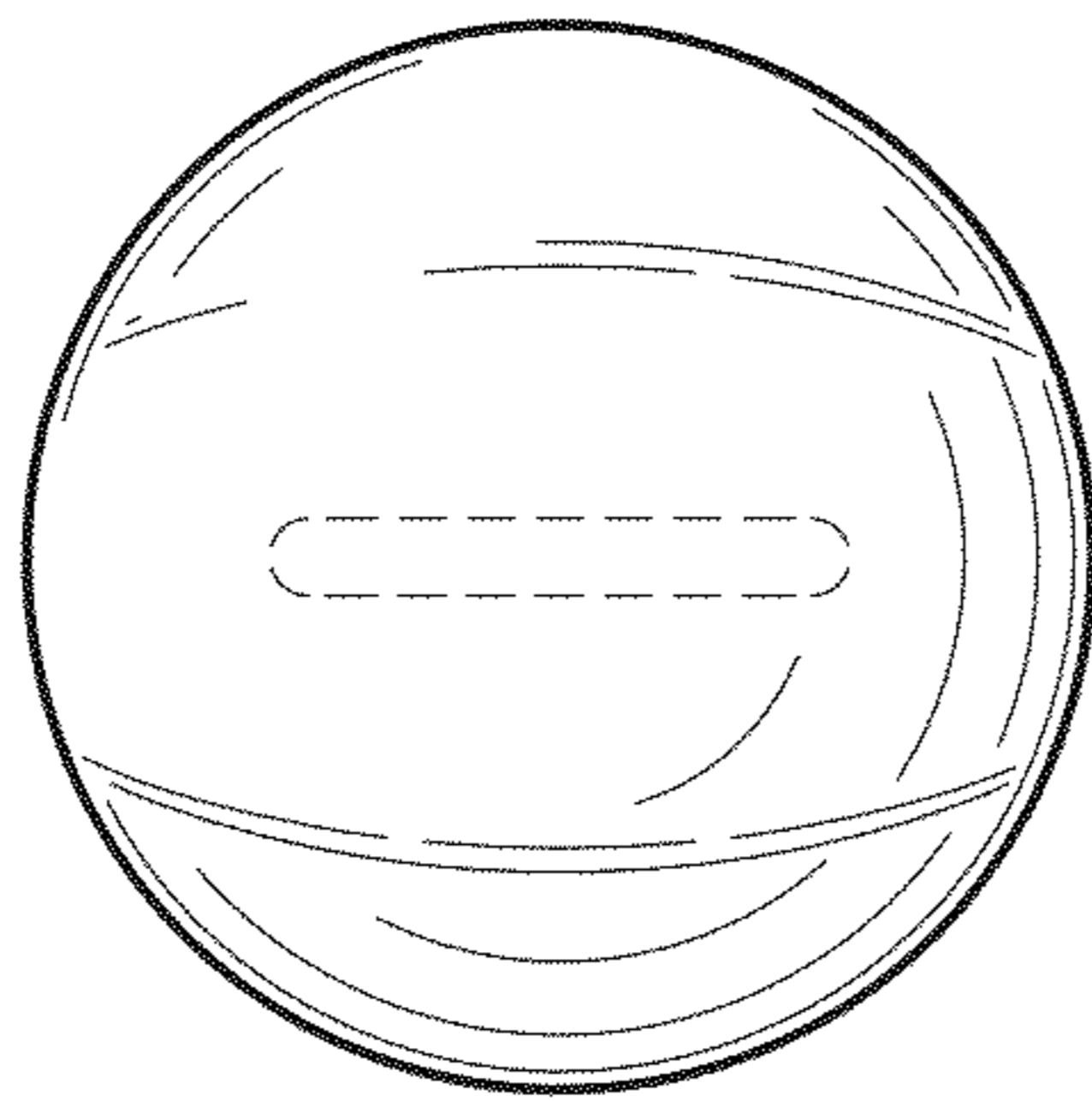
