FIG. 1 is a front view of a test tray showing our new design; FIG. 2 is a rear view thereof;

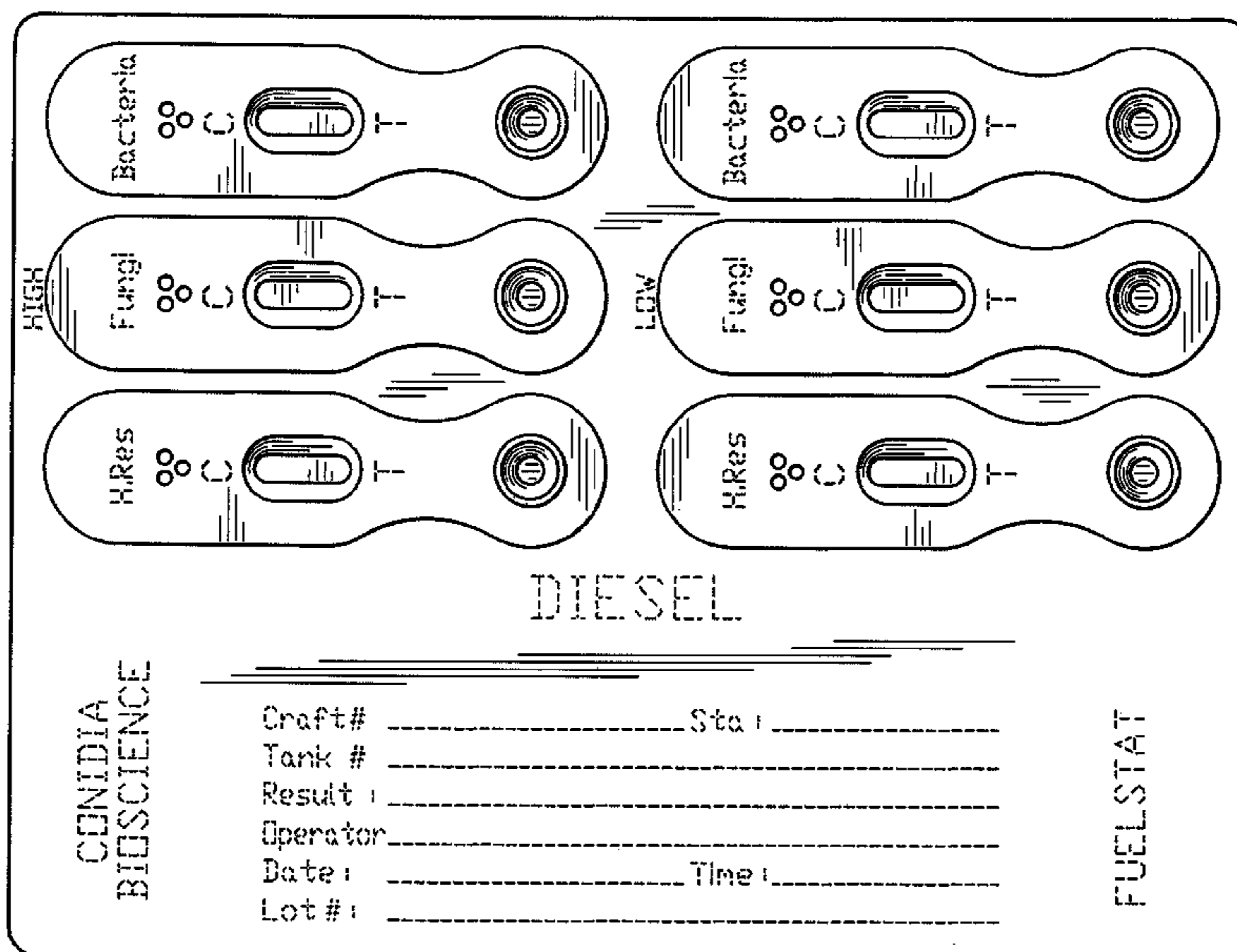
FIG. 3 is a left side view thereof, the right side being a mirror image thereof;

The broken line showing of features is included for the purpose of illustrating non-claimed features and forms no part of the claimed design.



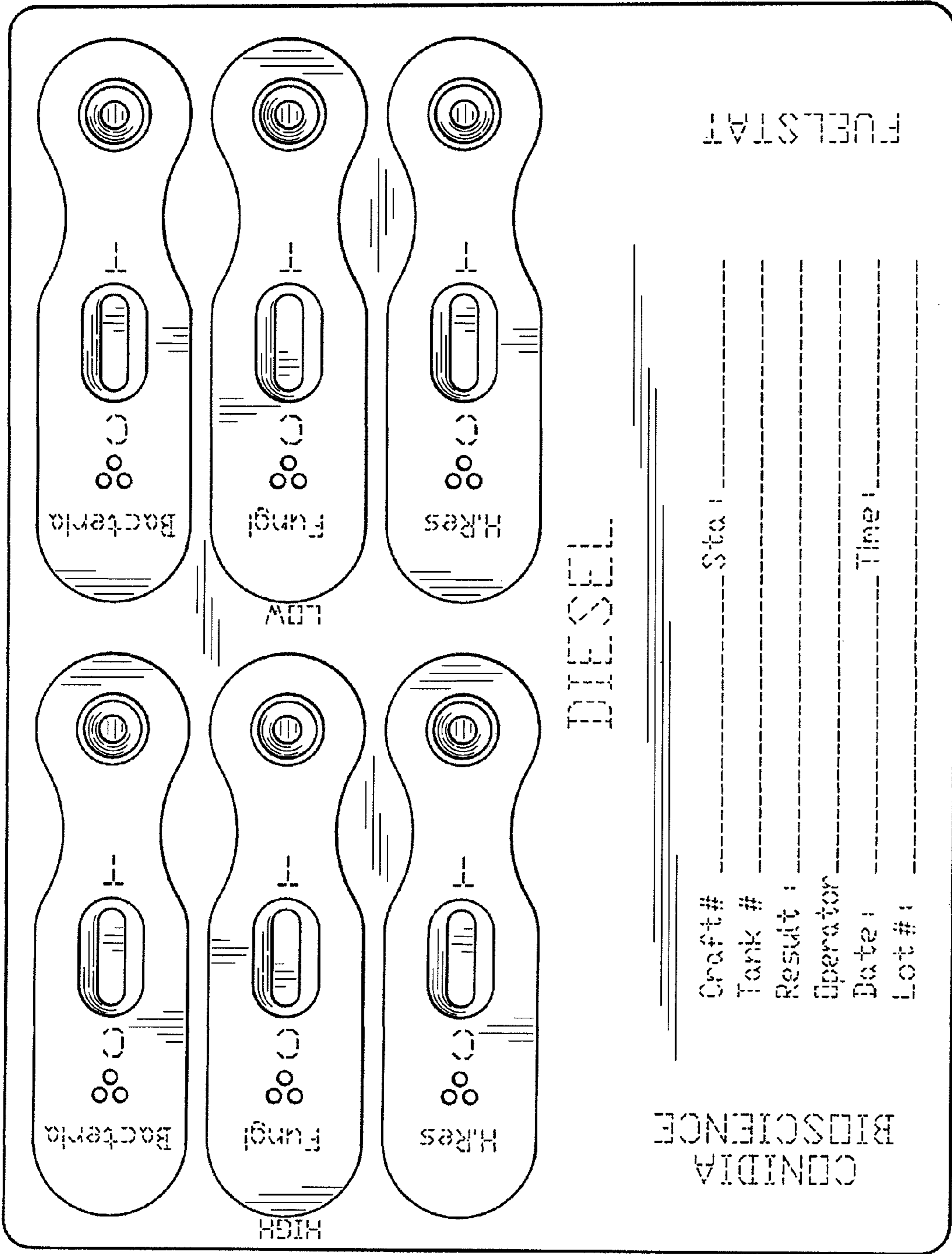

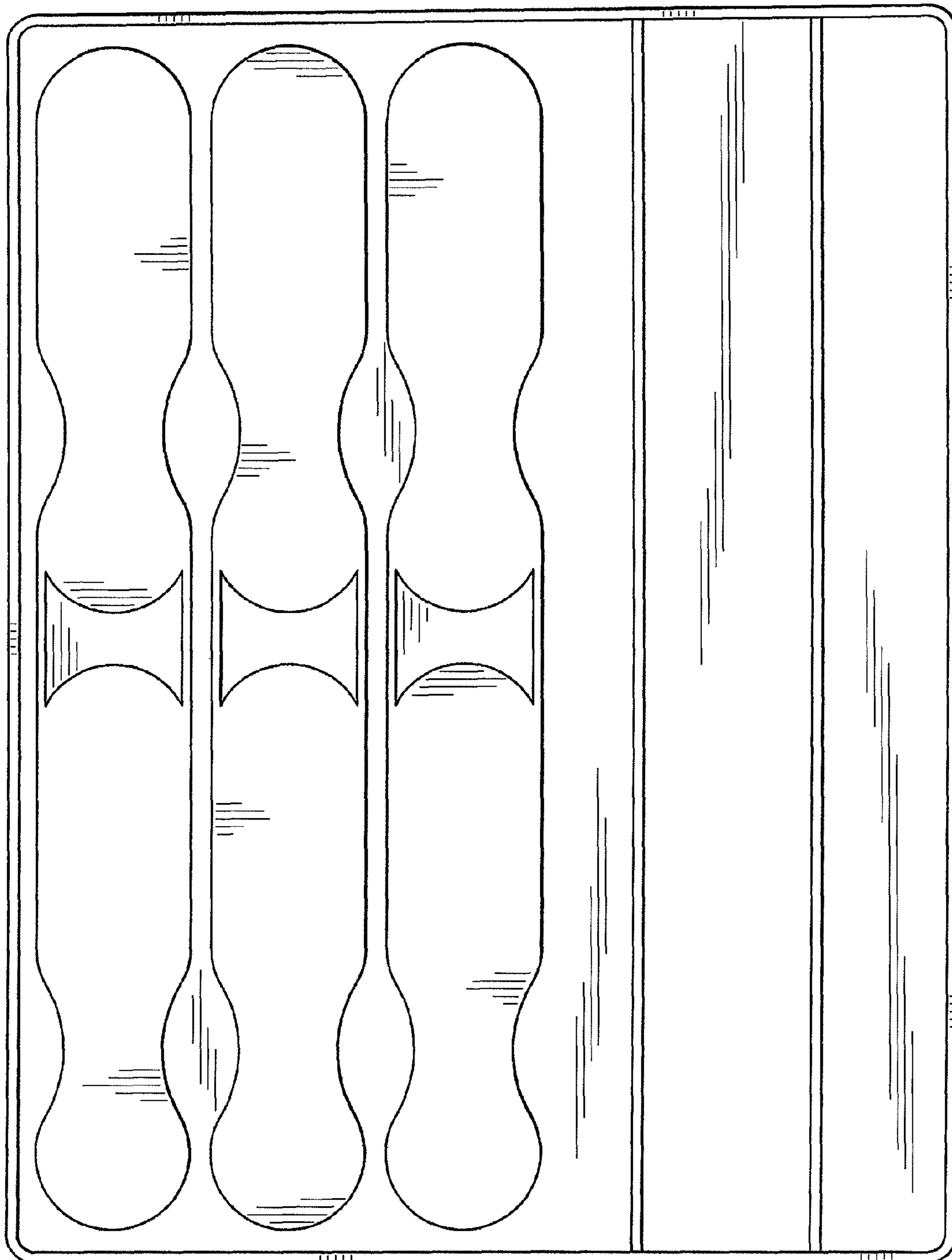

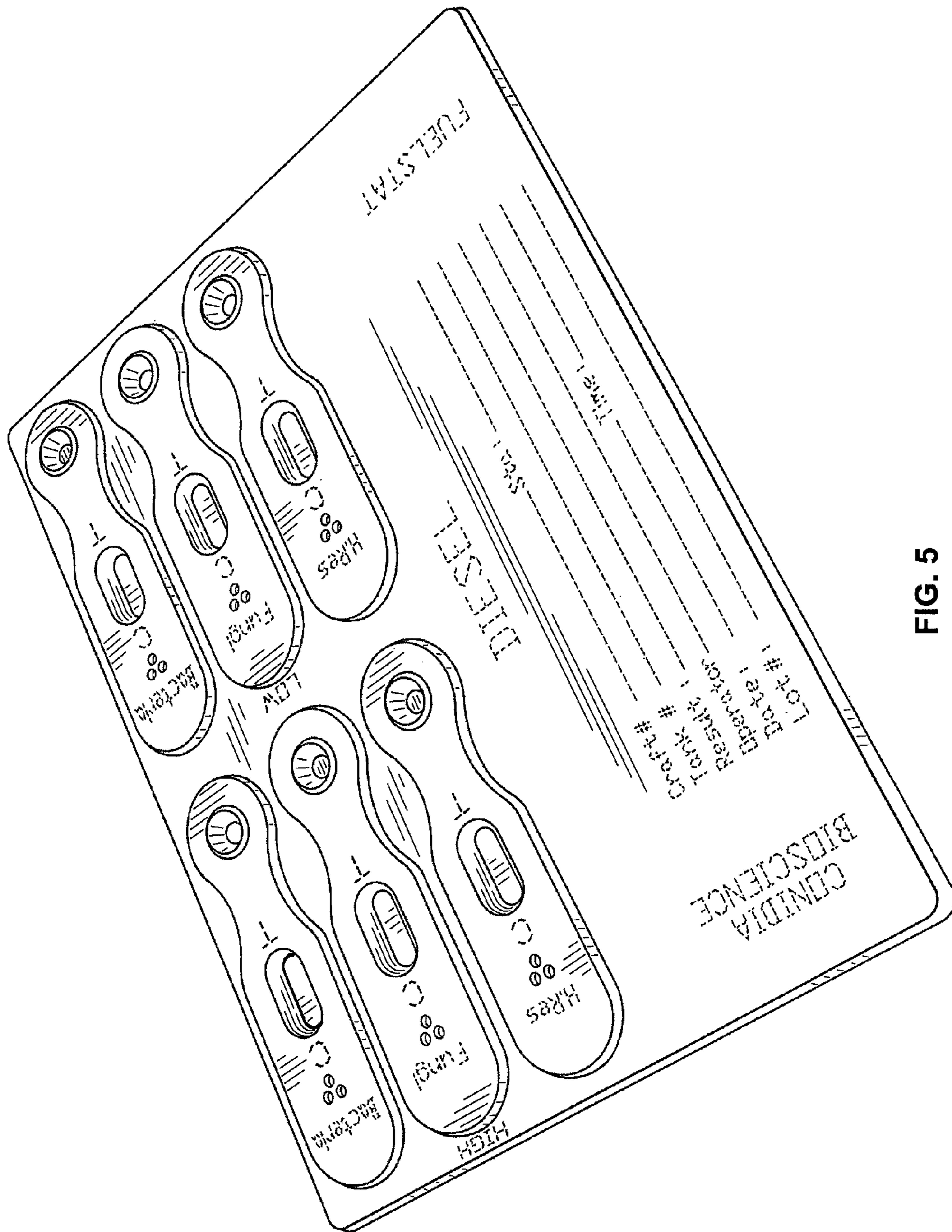

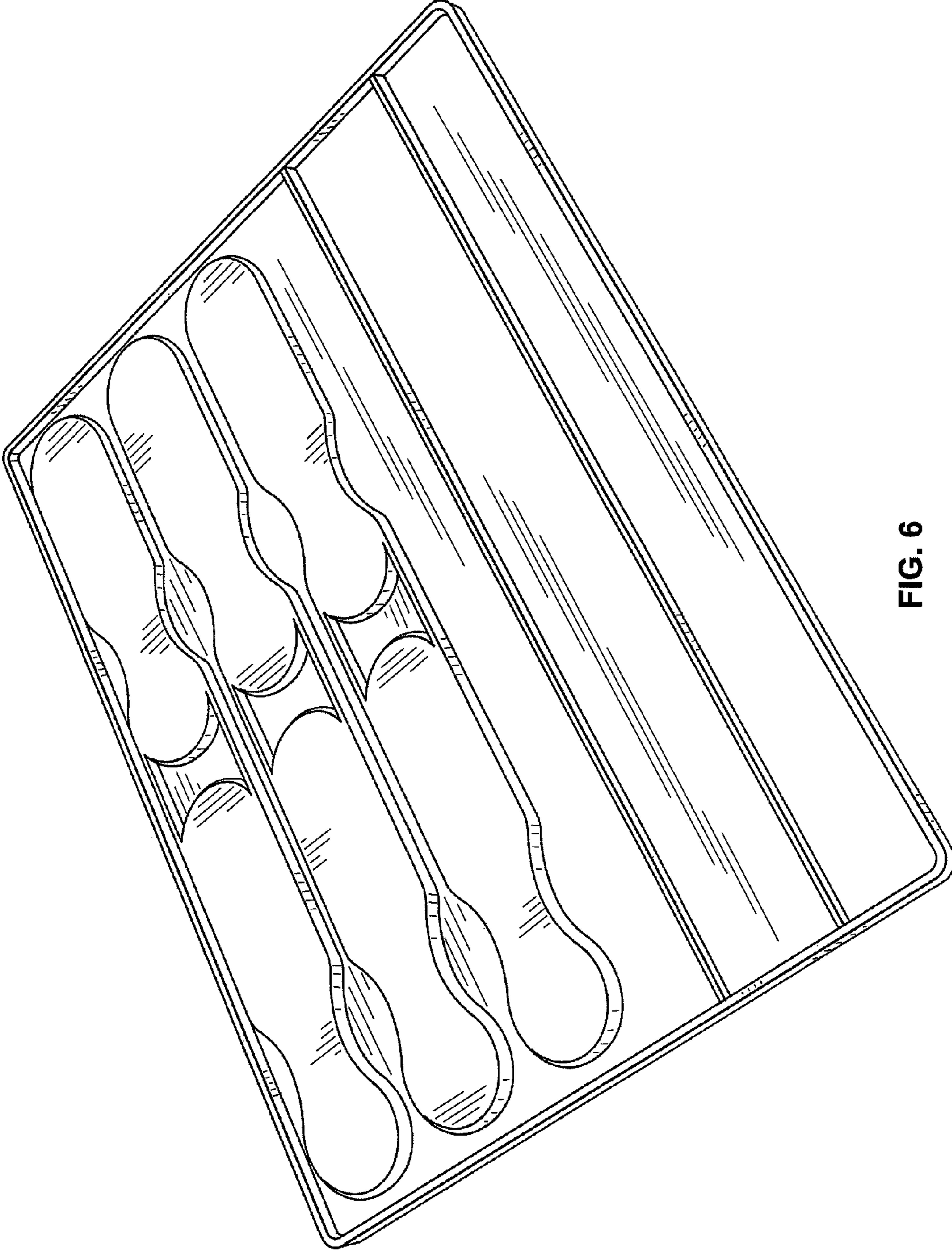
