FIG. 8 is a front, bottom and left side perspective view of FIG. 1 in an open position.

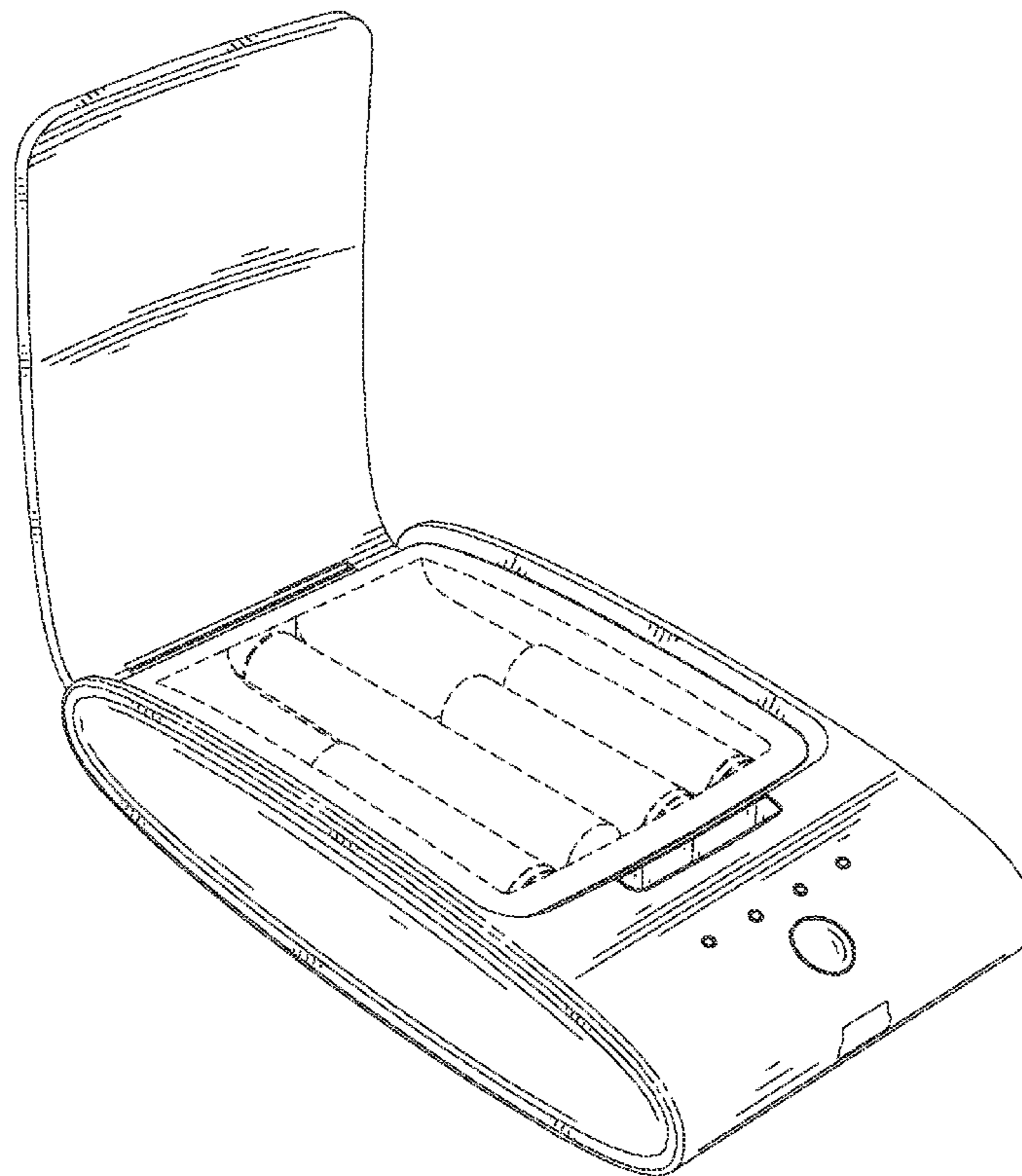

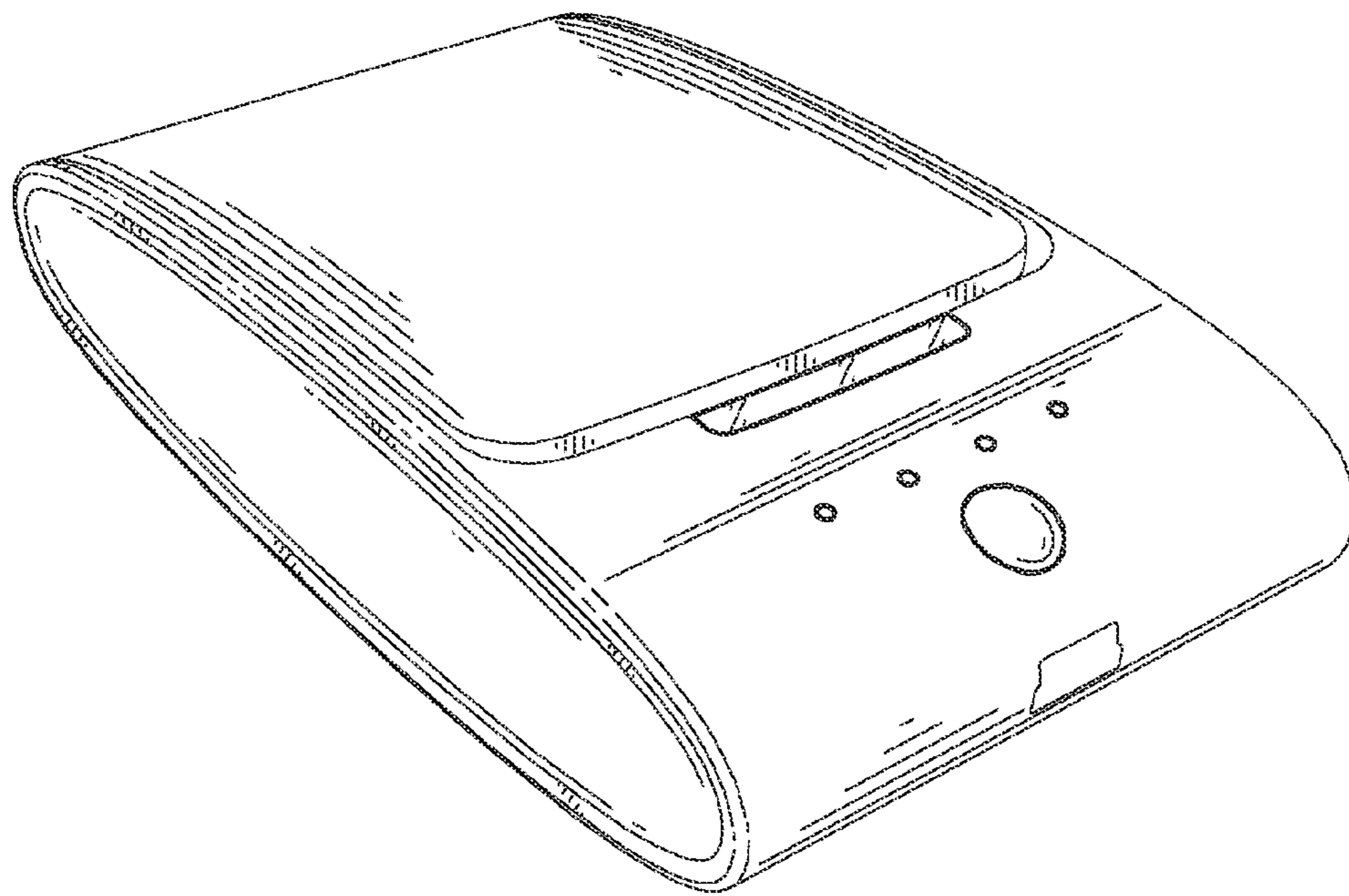

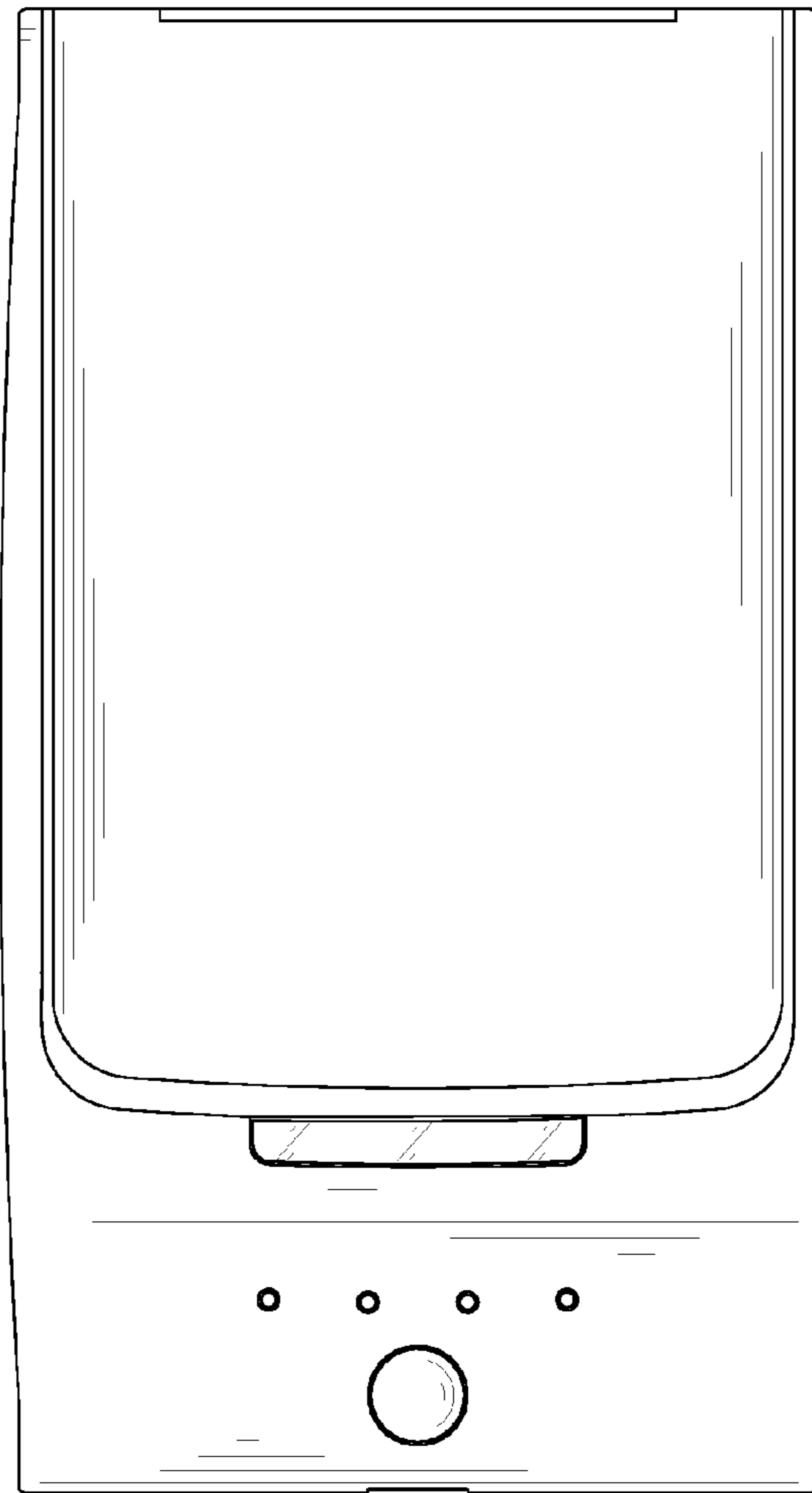

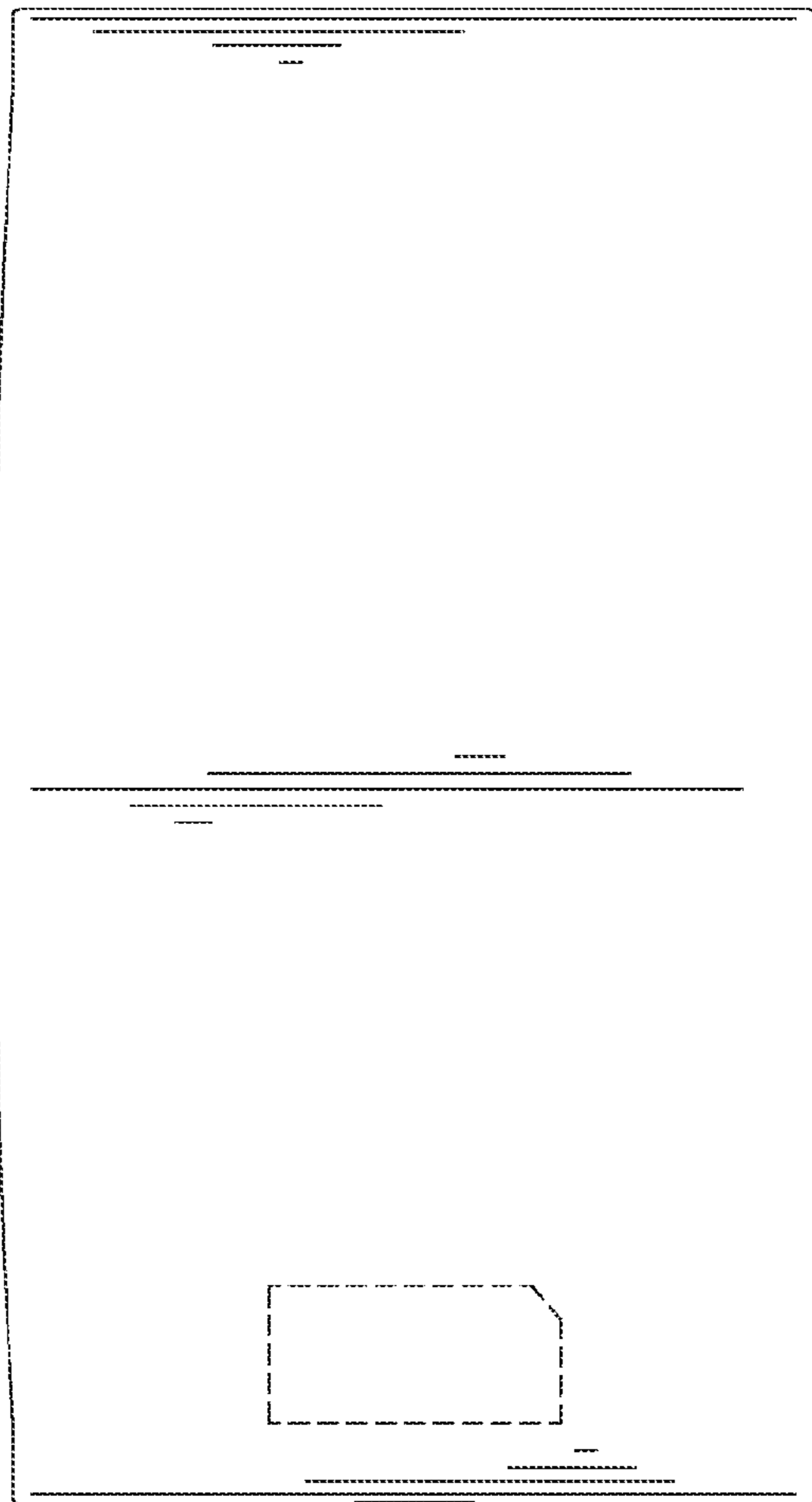

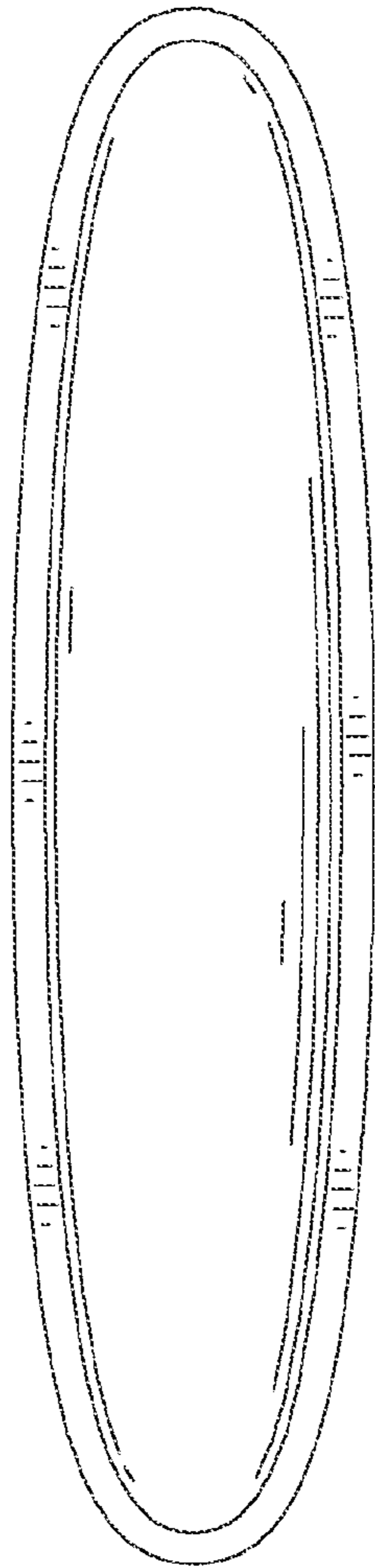

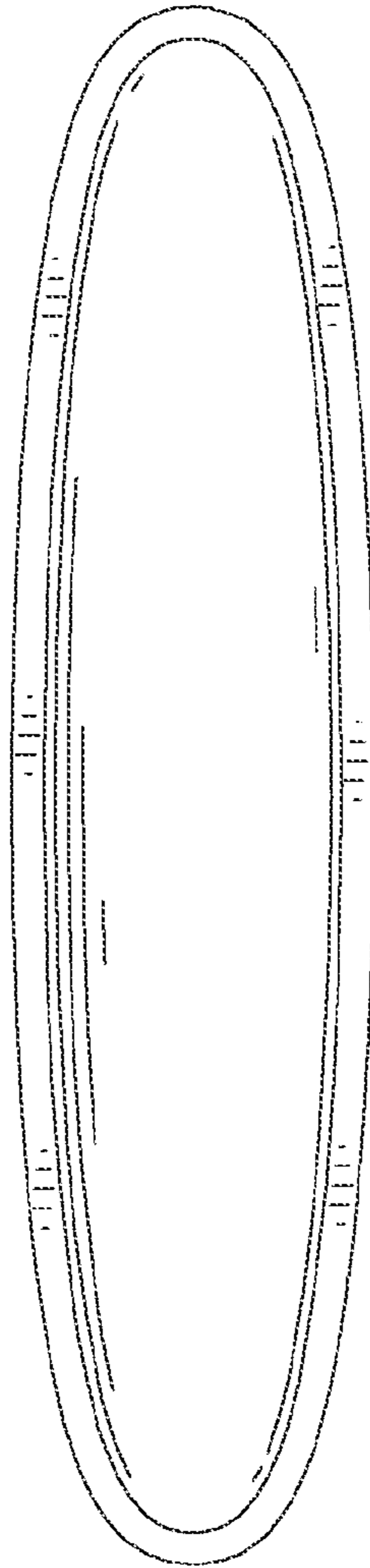

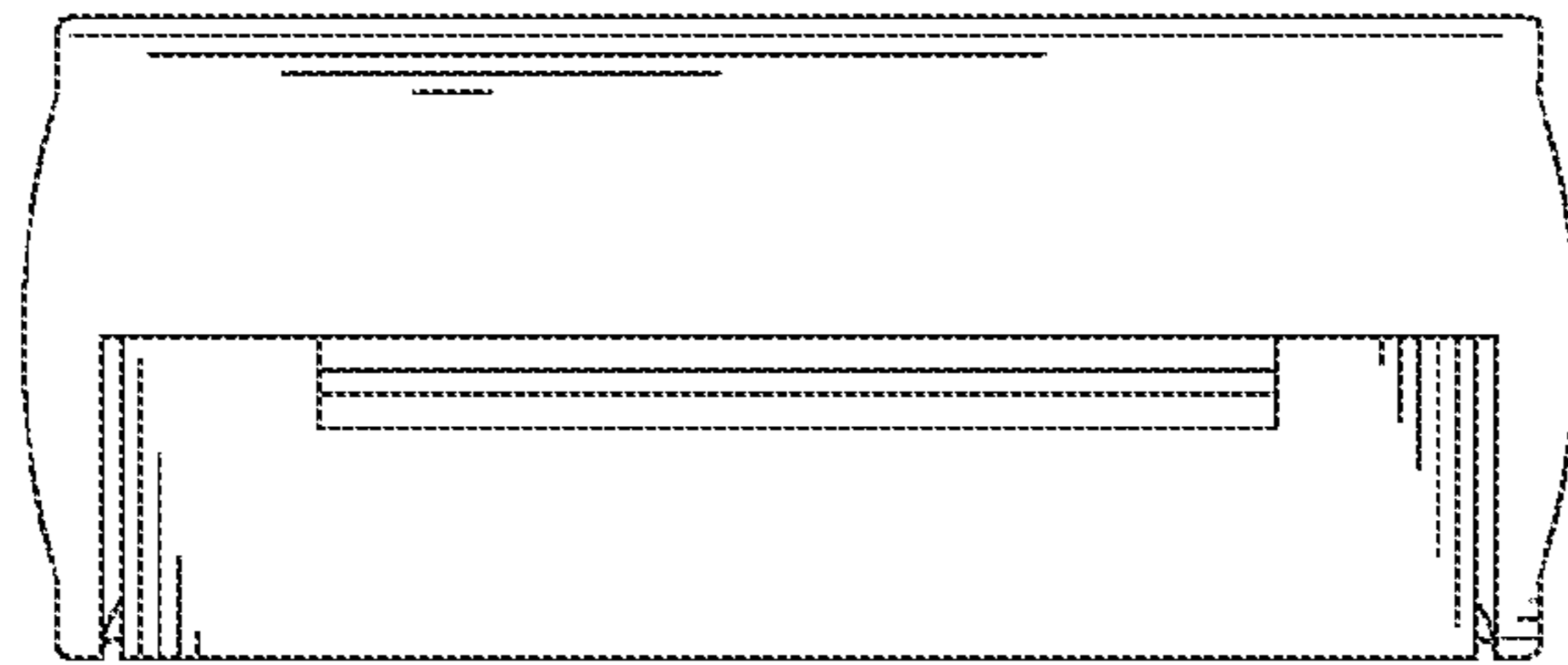

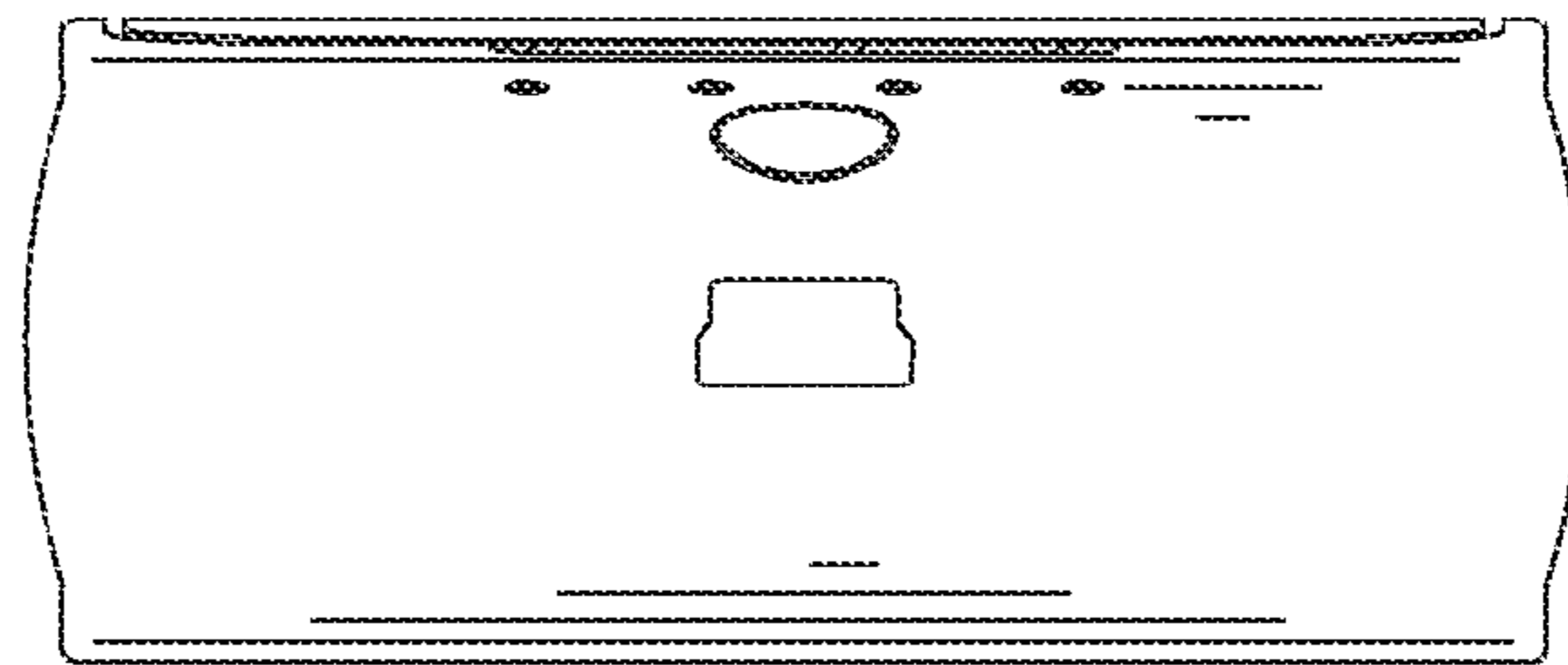

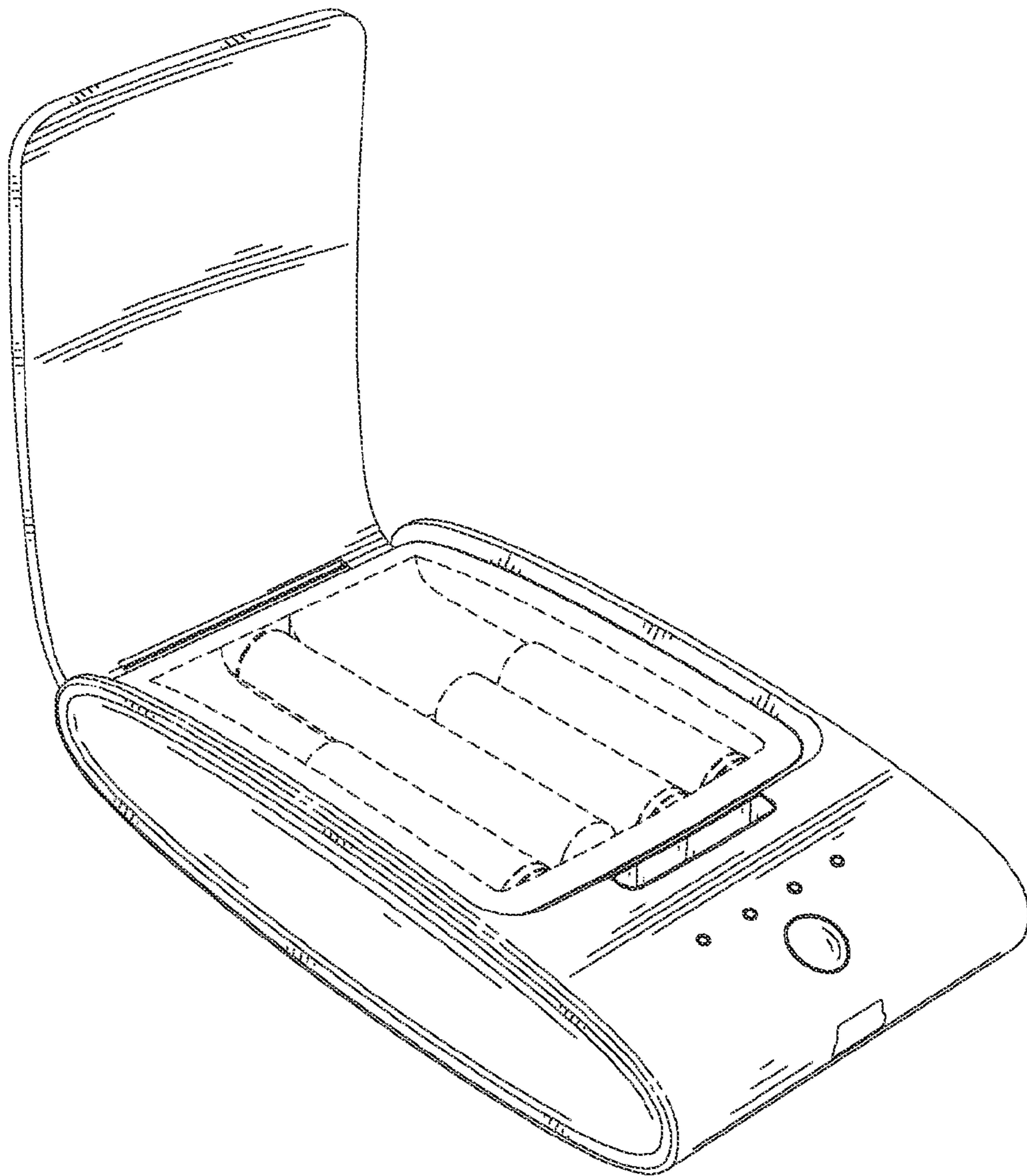
