(57) **CLAIM**

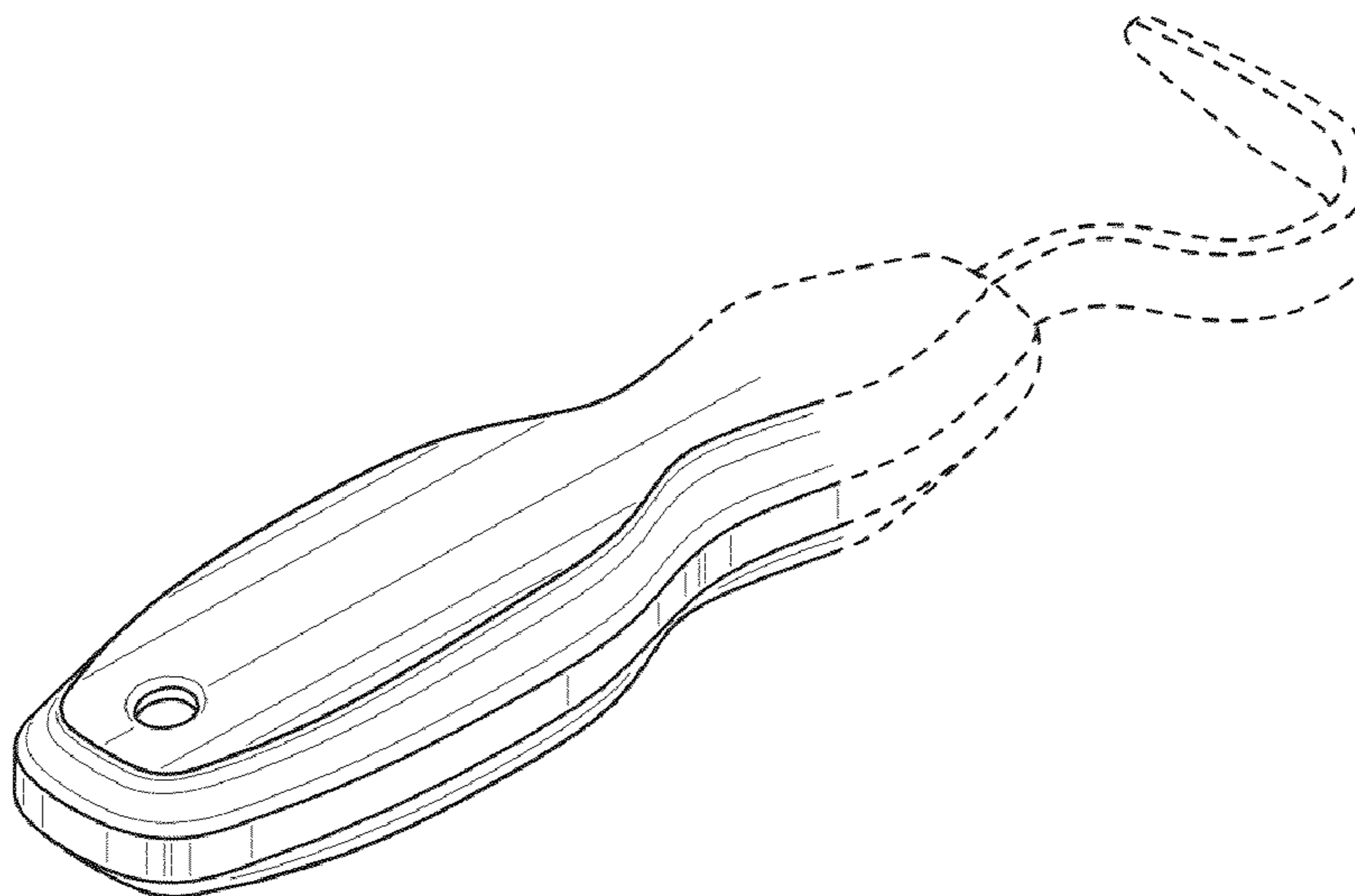
The ornamental design for a handle for equine tools, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a handle for equine tools showing our new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a bottom plan view thereof;  
 FIG. 4 is a right side view thereof;  
 FIG. 5 is a left side view thereof;  
 FIG. 6 is a front view thereof;

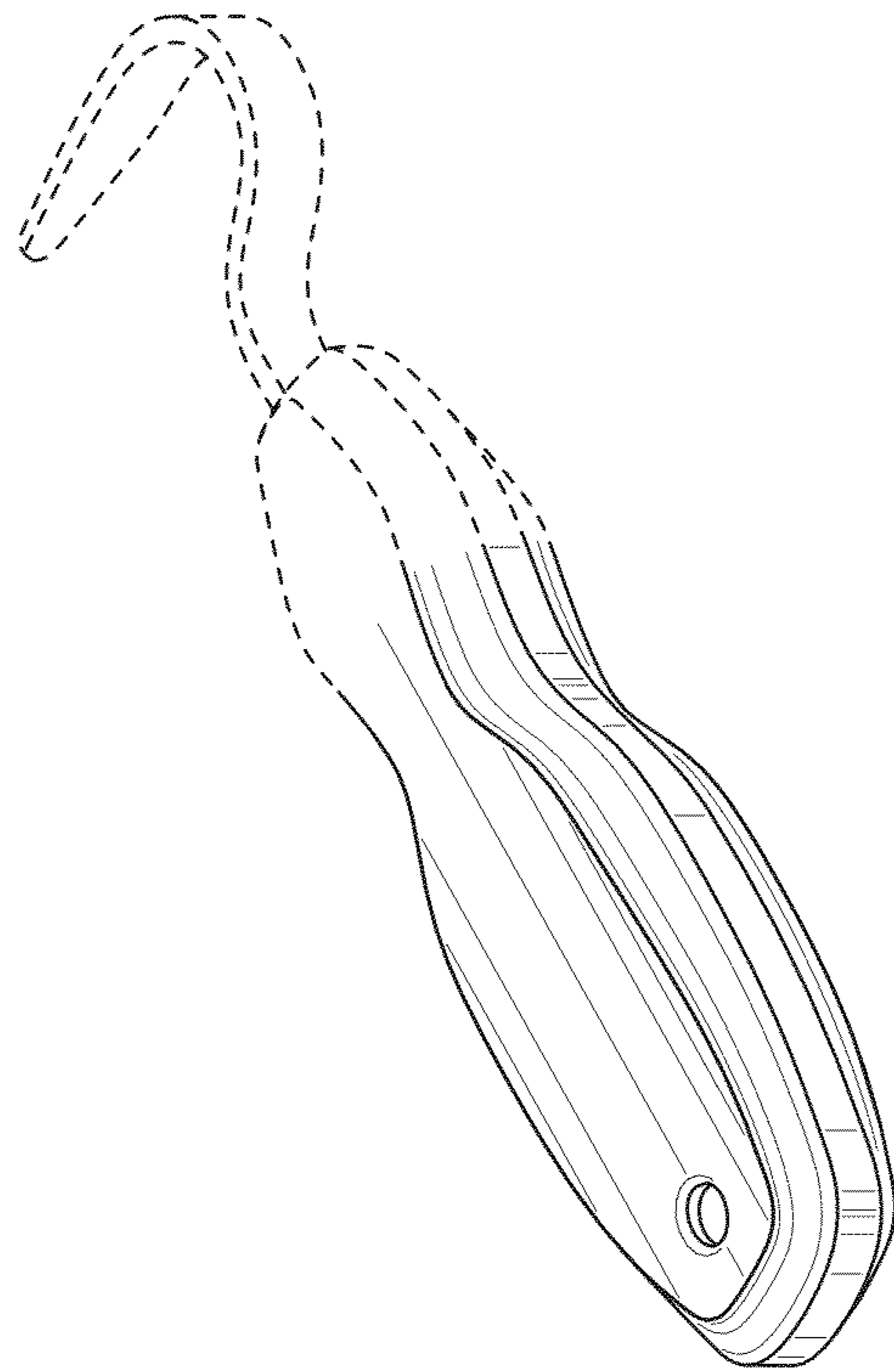

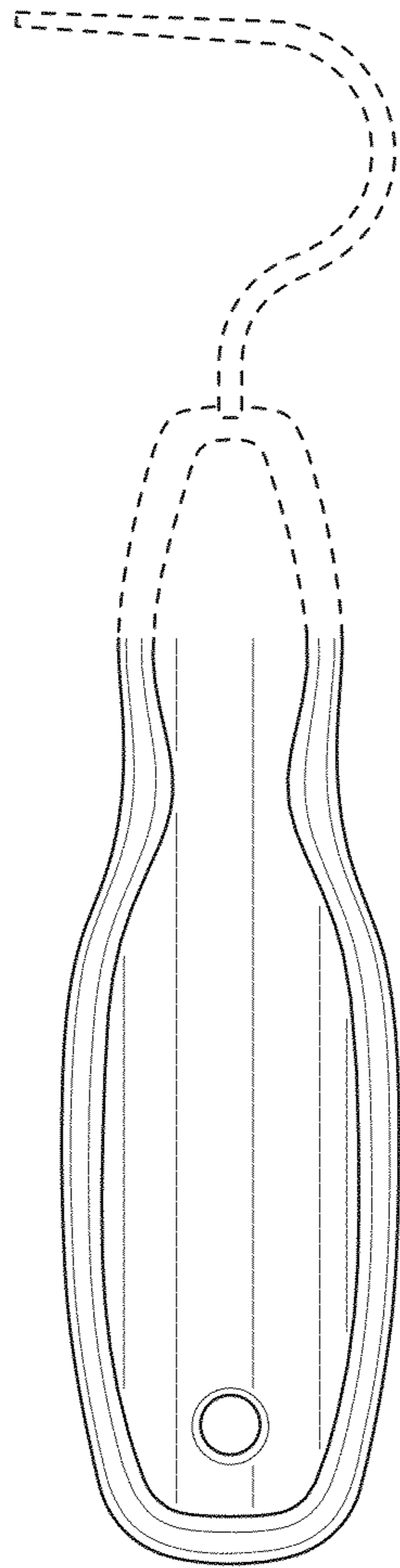

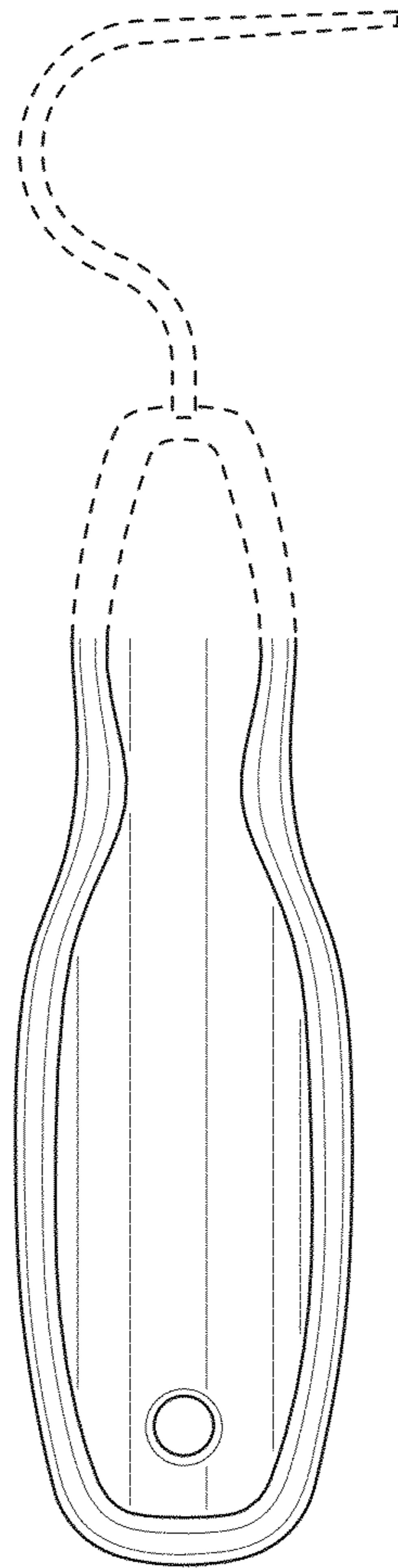

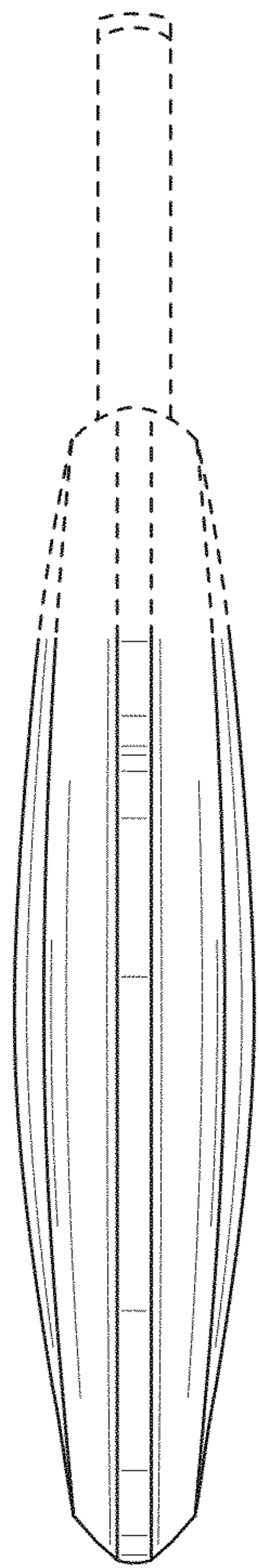

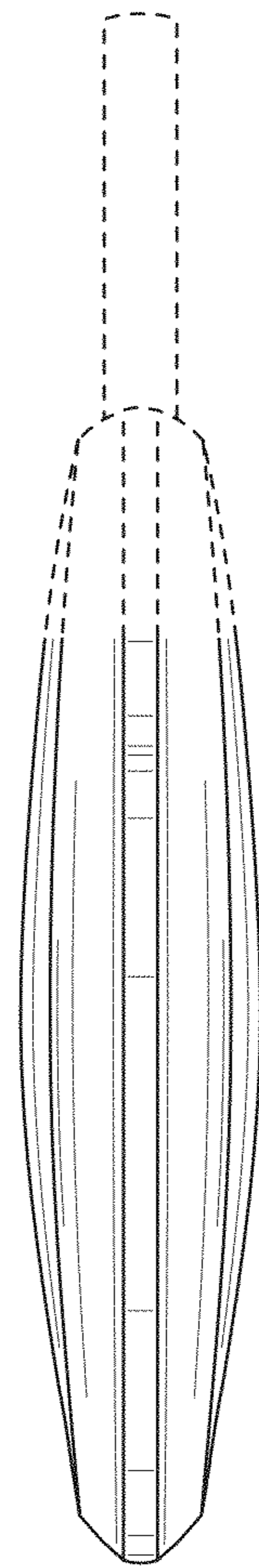

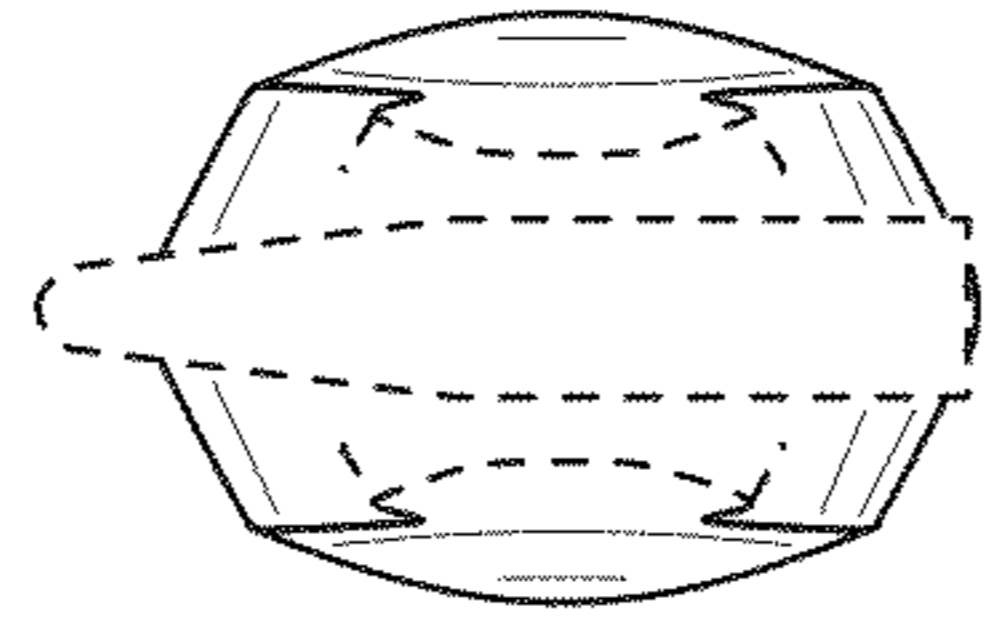

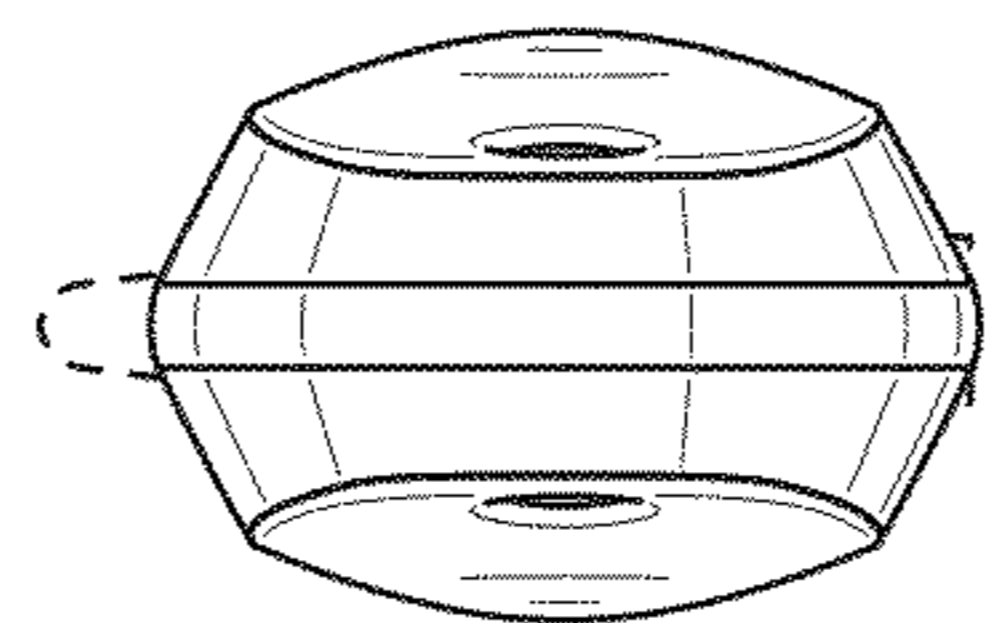

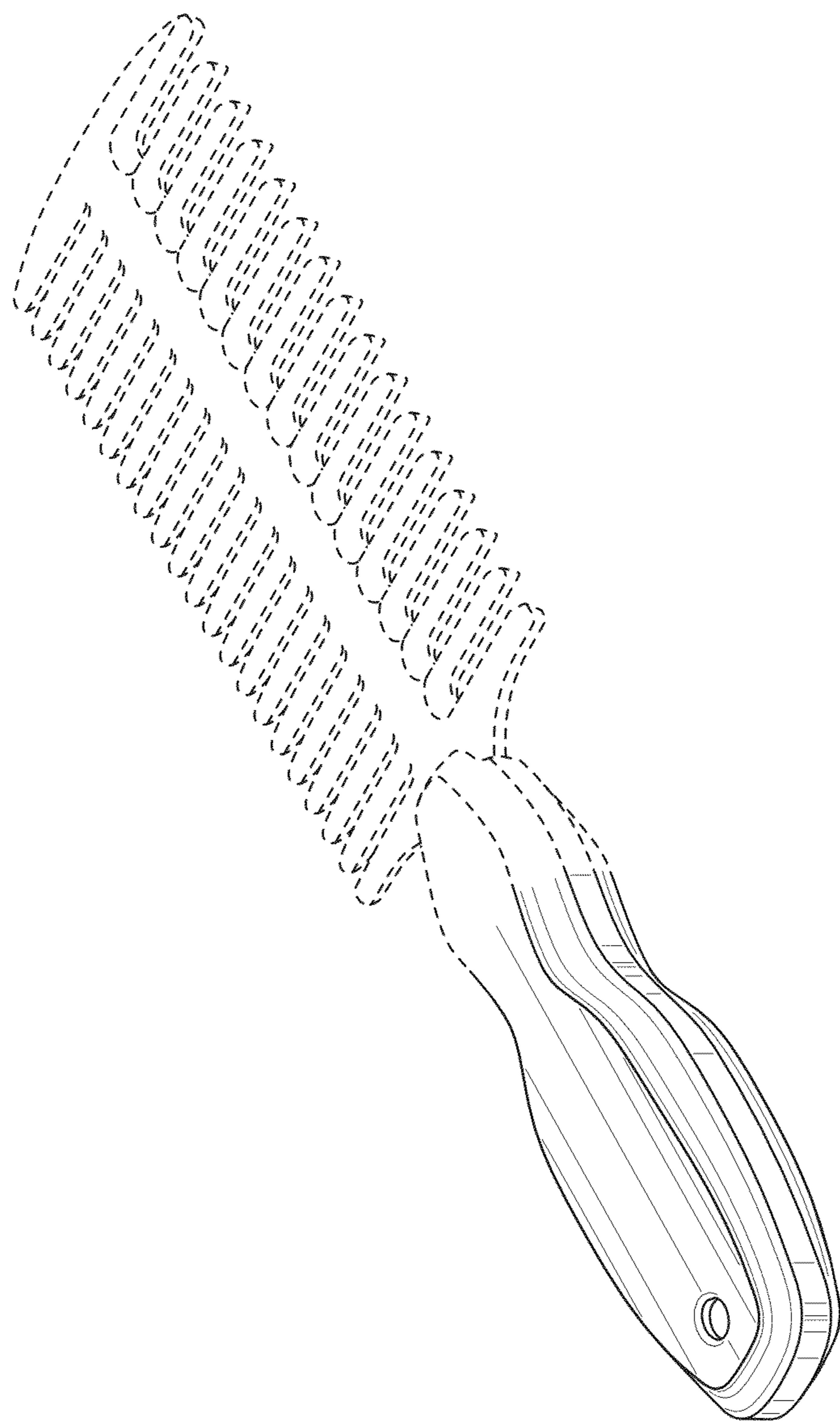

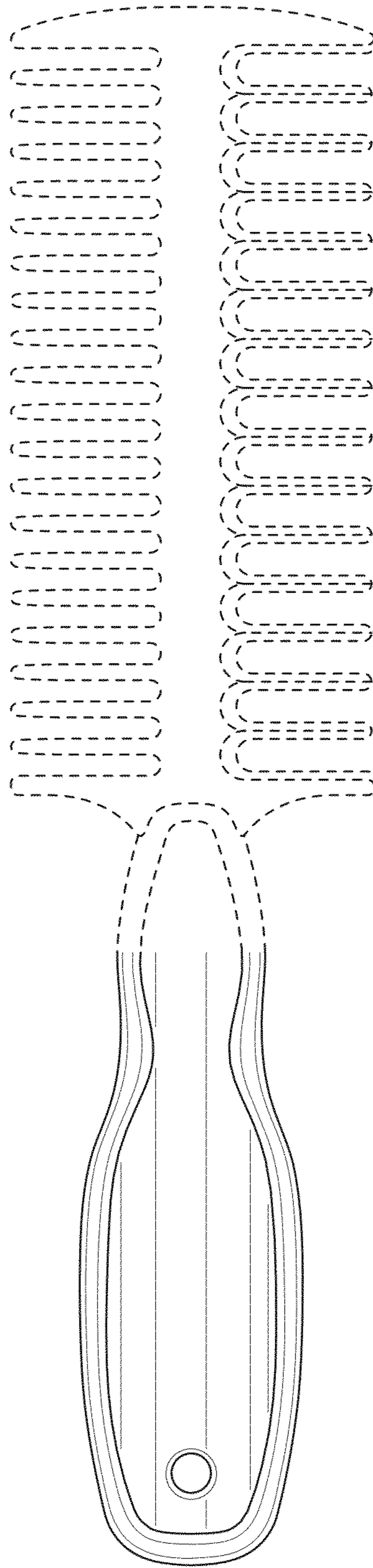

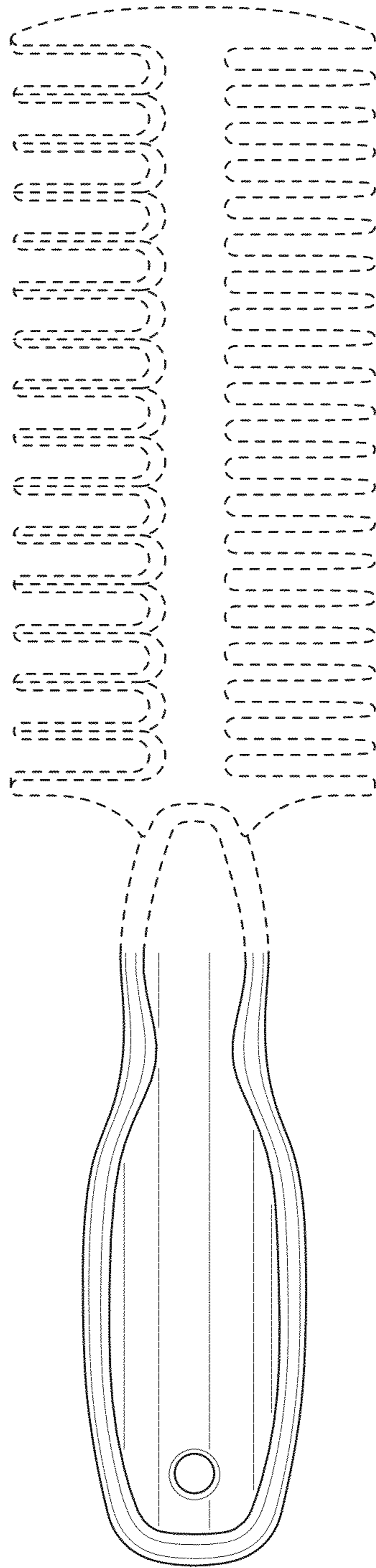

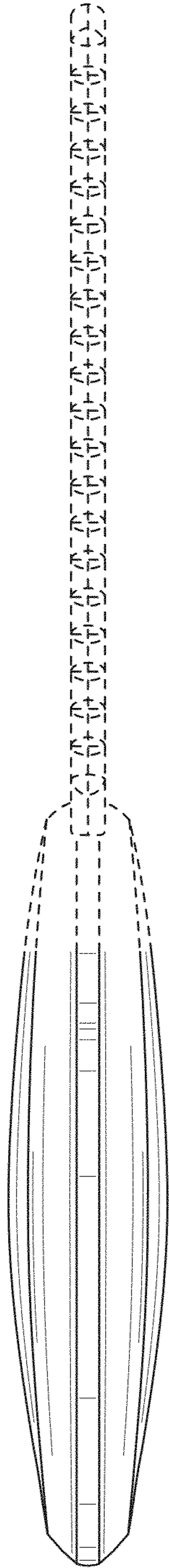

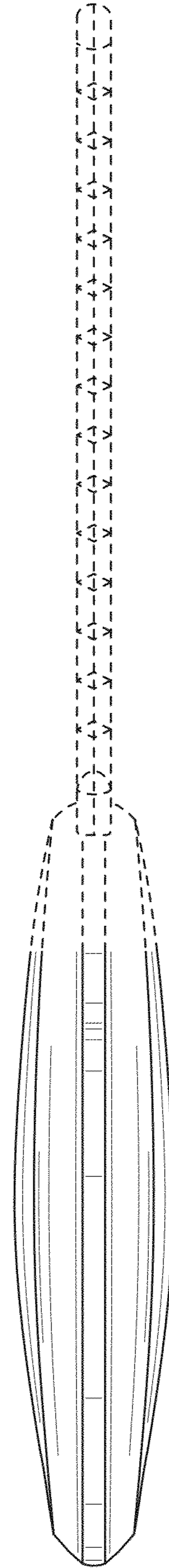

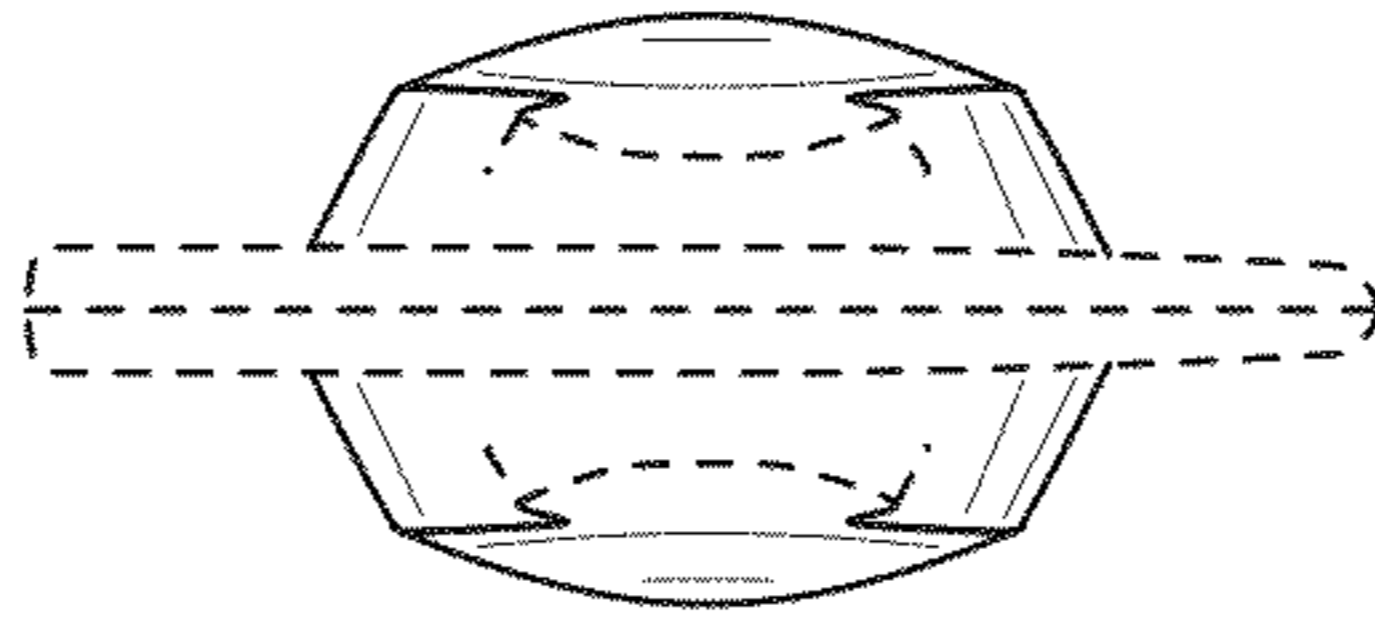

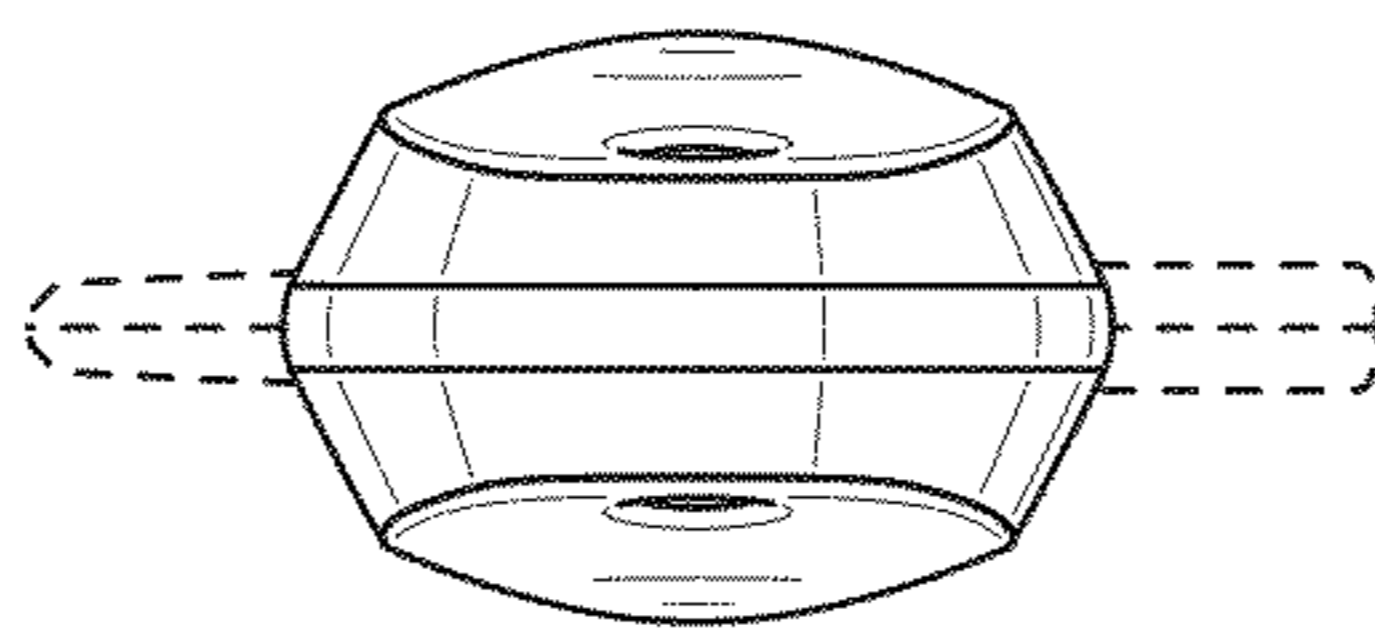
