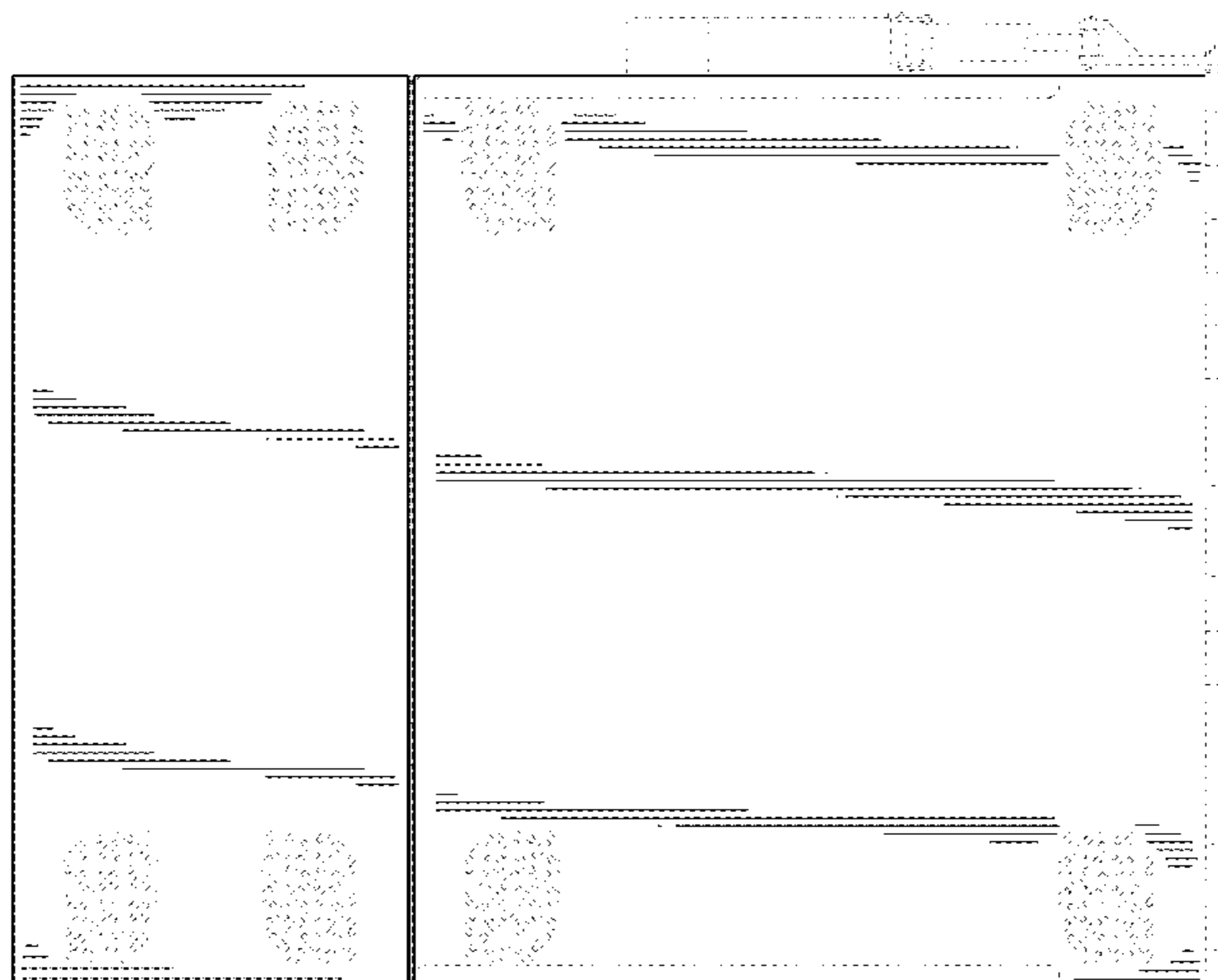
(57) **CLAIM**

The ornamental design for a low-profile lip extender unit for a dock ramp, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of a lip extender unit for a dock ramp; FIG. 2 is a side view of the lip extender unit for a dock ramp of FIG. 1 with the lip extender in the downward position; FIG. 3 is a side view of the lip extender unit for a dock ramp of FIG. 1 with the lip extender in the downward position; FIG. 4 is a side view of the lip extender unit for a dock ramp of FIG. 1 with the dock ramp in an elevated position and the lip extender in the extended position; FIG. 5 is a front view of the low-profile lip extender unit for a dock ramp of FIG. 1 illustrating the lip extender in the downward position; FIG. 6 is a back view of the low-profile lip extender unit for a dock ramp of FIG. 1; and, FIG. 7 is a bottom view of the low-profile lip extender unit for a dock ramp of FIG. 1. The dashed lines are provided for illustrative purposes only and form no part of the claimed design.

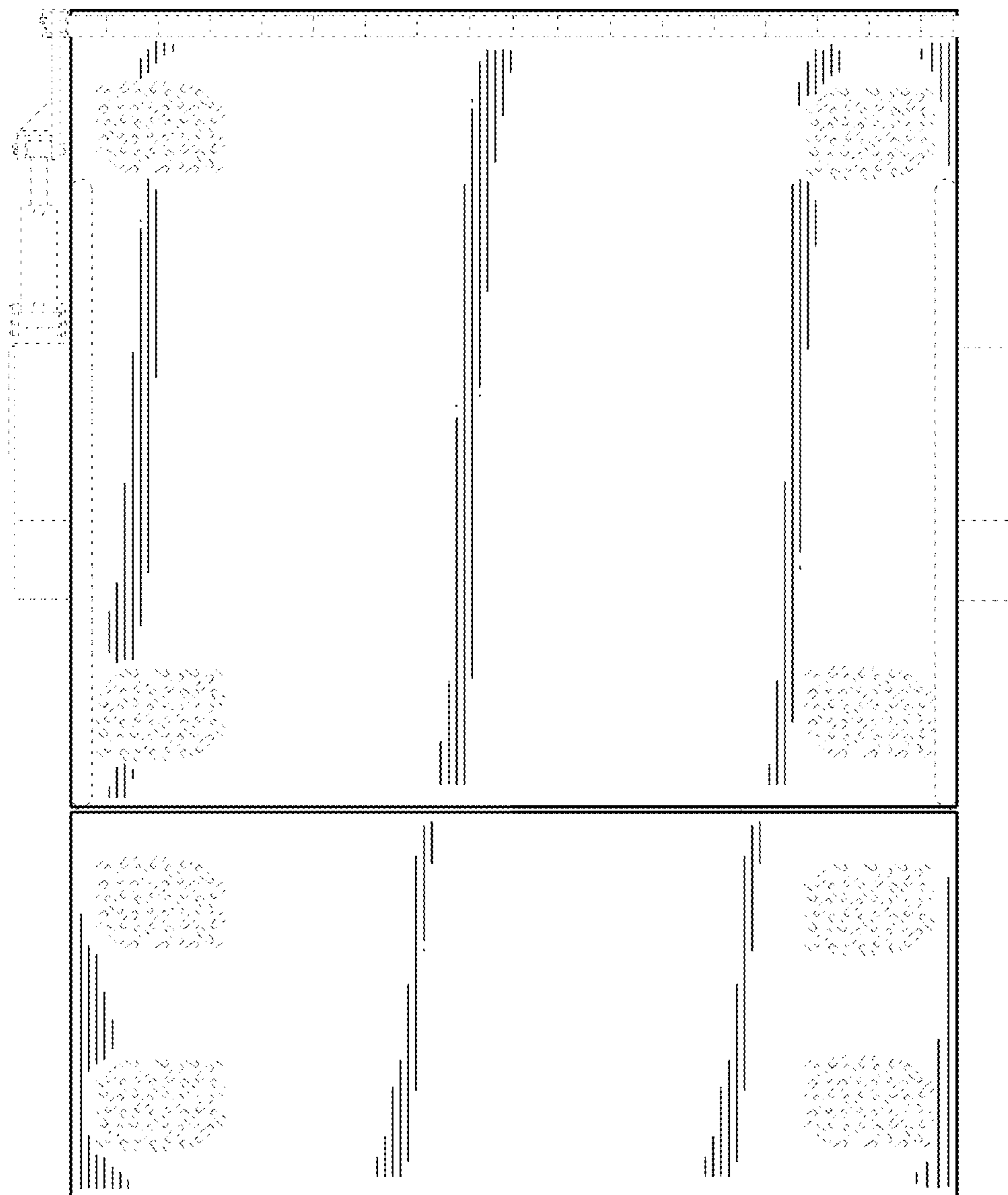

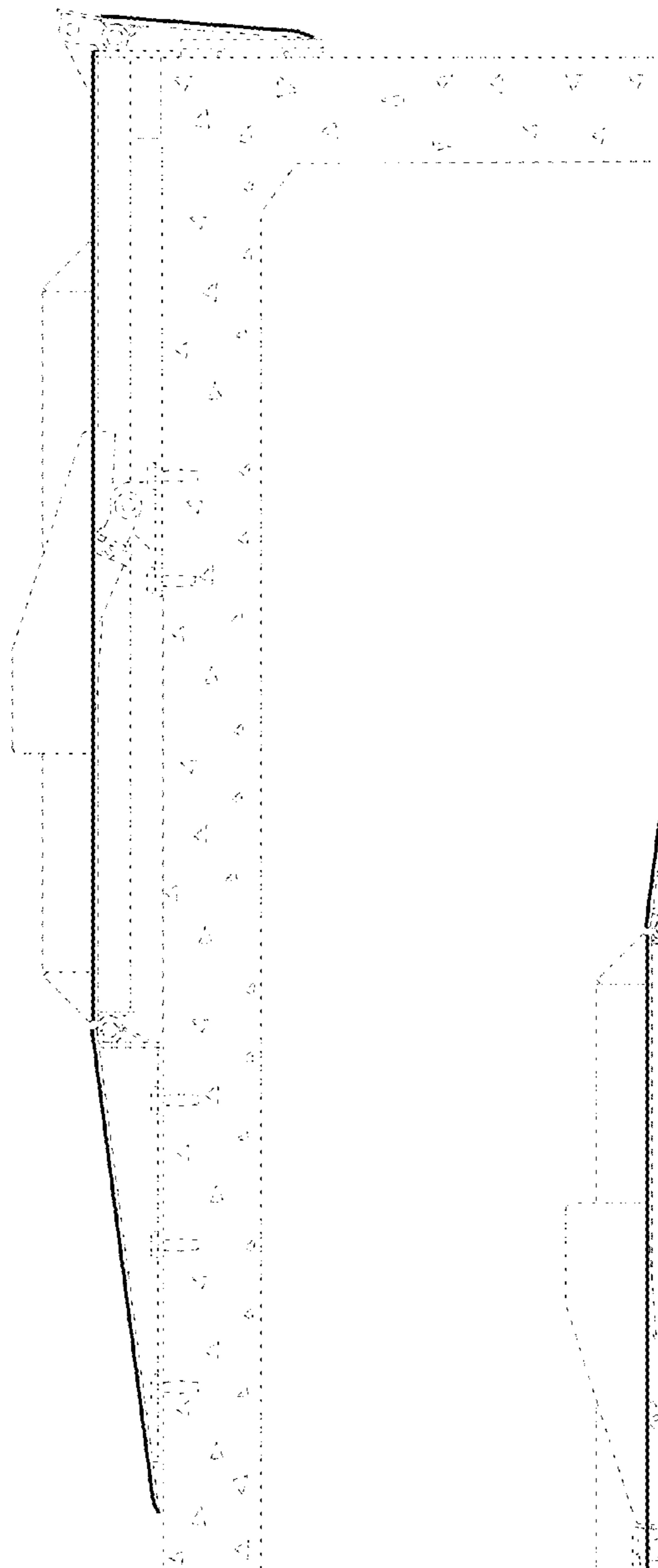

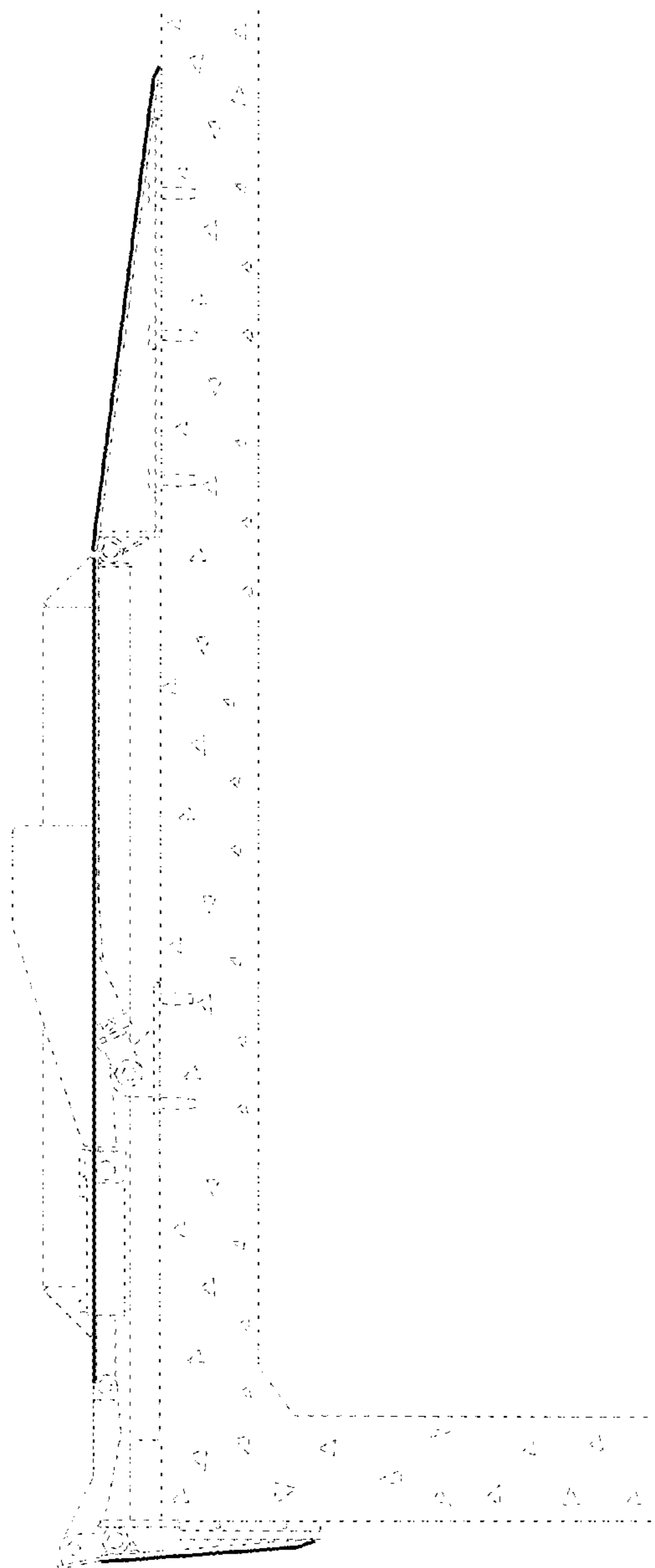
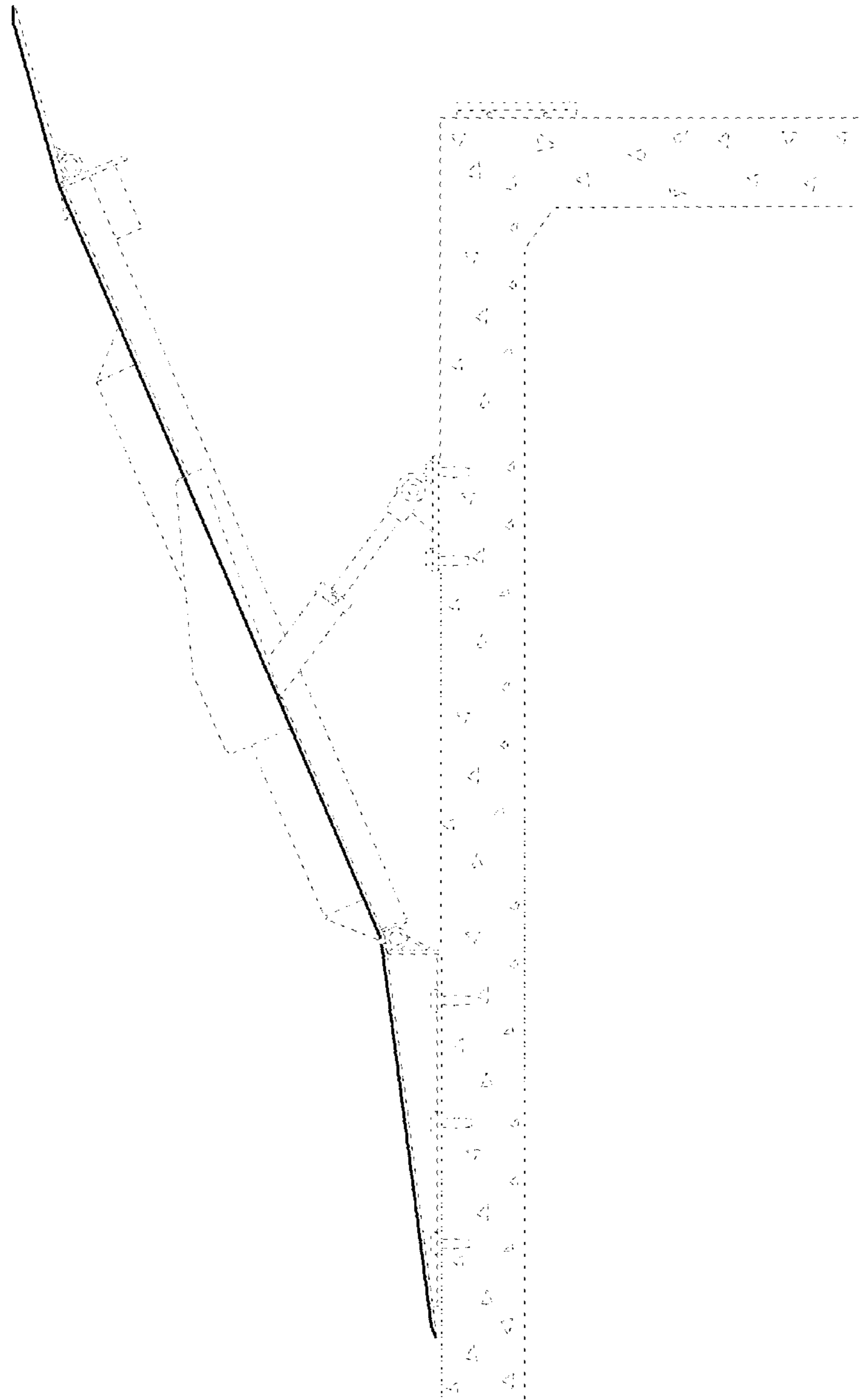

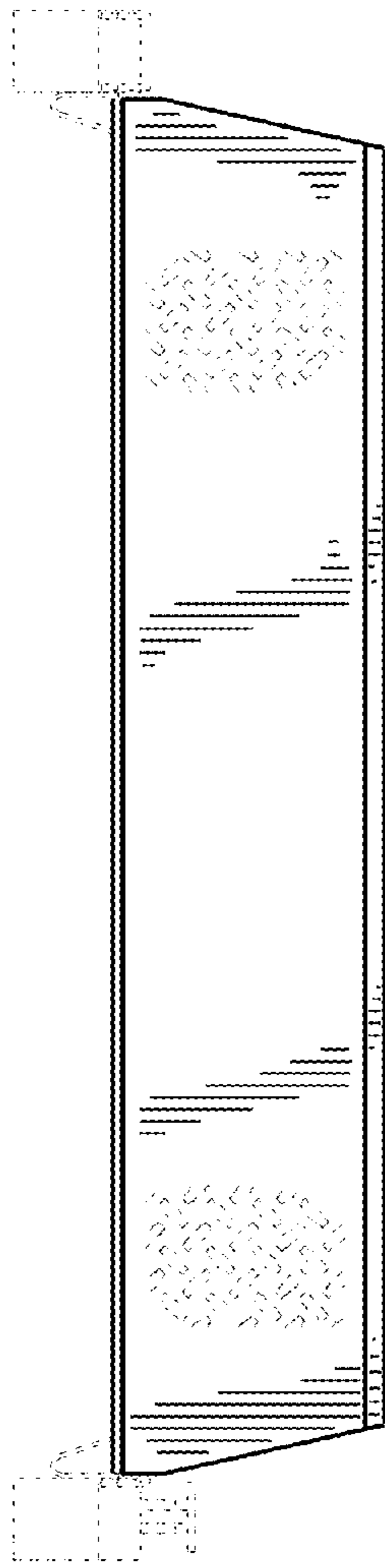

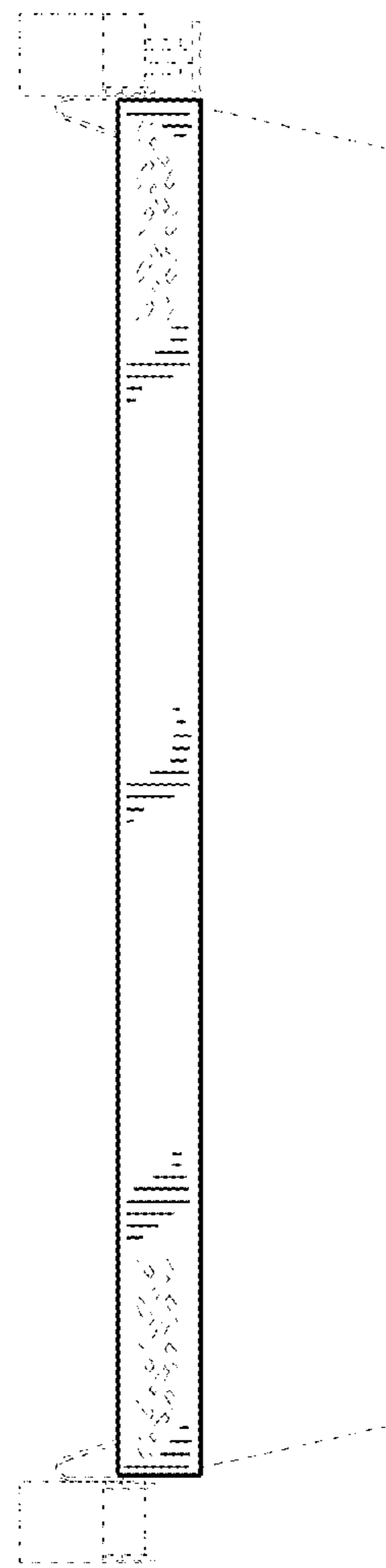

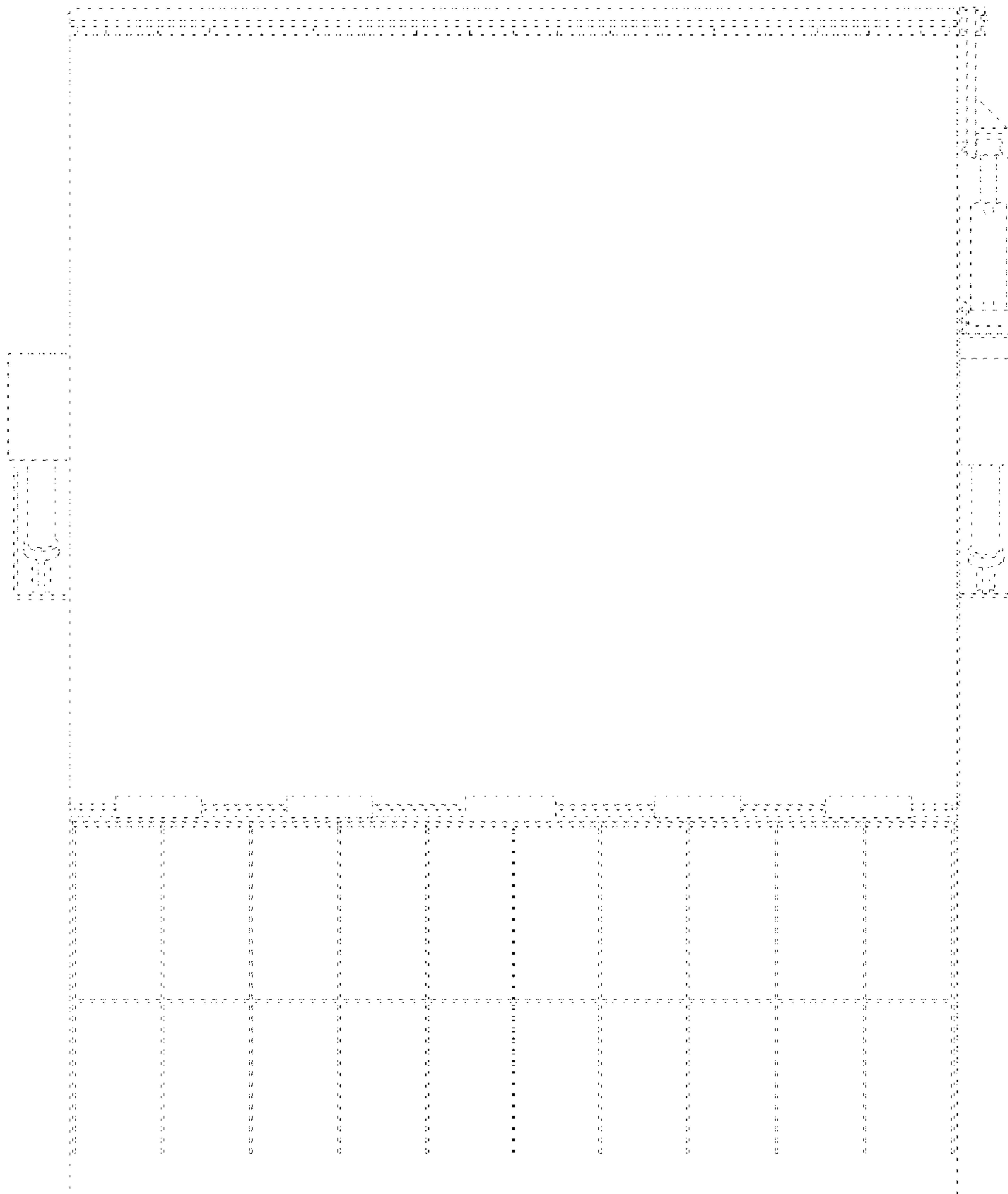
