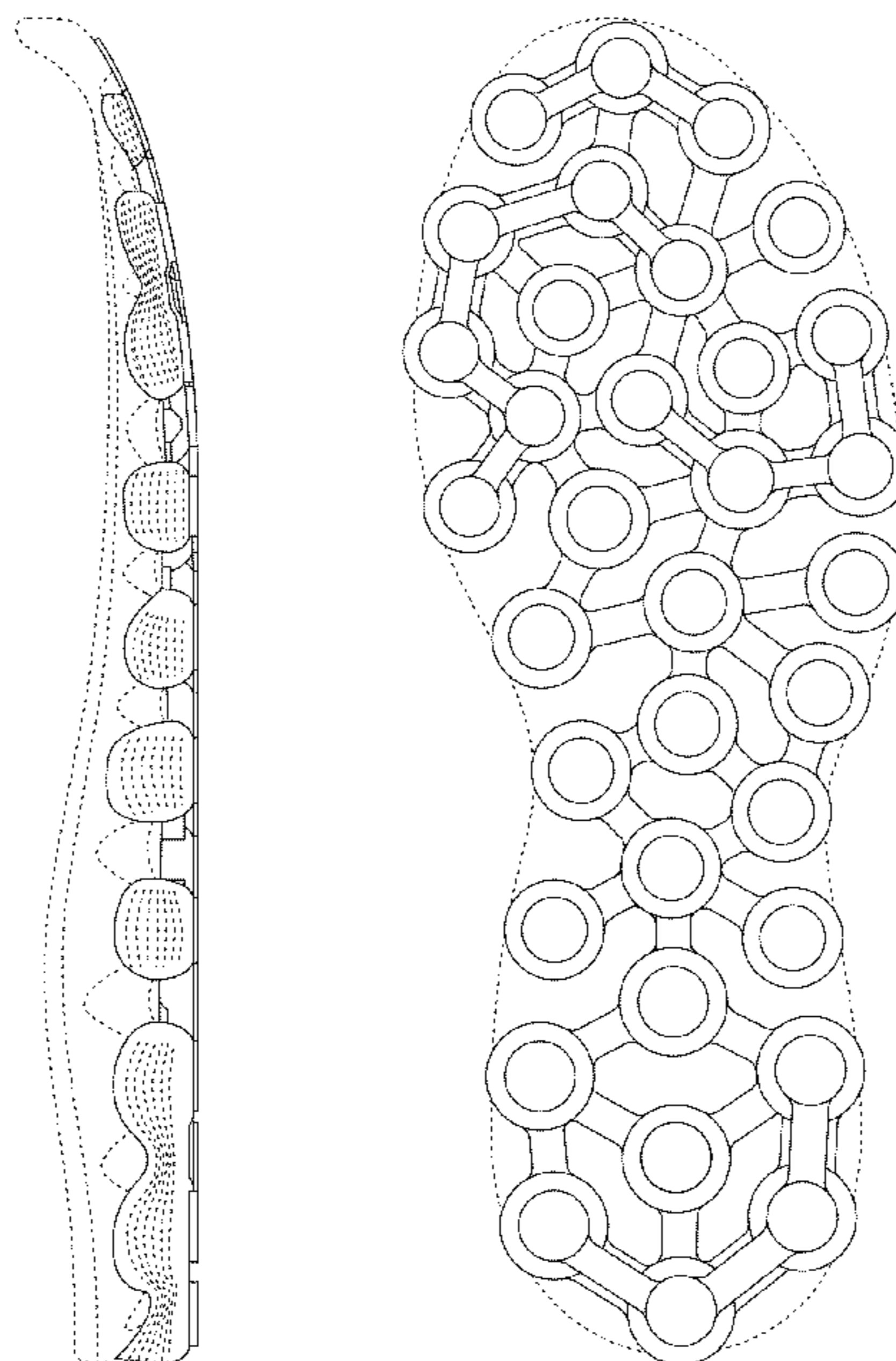

 FIG. 2 is a bottom view of the shoe sole;
 FIG. 3 is a lateral side view of the shoe sole;
 FIG. 4 is a top view of the shoe sole;
 FIG. 5 is a front view of the shoe sole;
 FIG. 6 is a rear view of the shoe sole; and,
 FIG. 7 is a perspective view of the shoe sole.
 A shoe sole is shown in FIGS. 1-7. Dashed lines have been included for illustrative purposes only, and form no part of the claimed design.

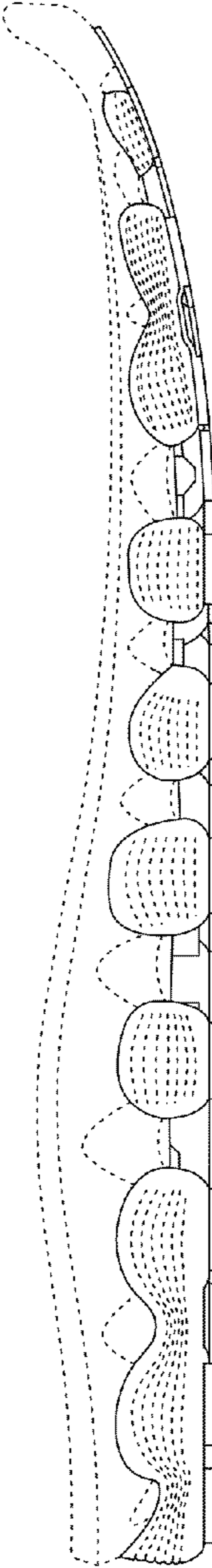

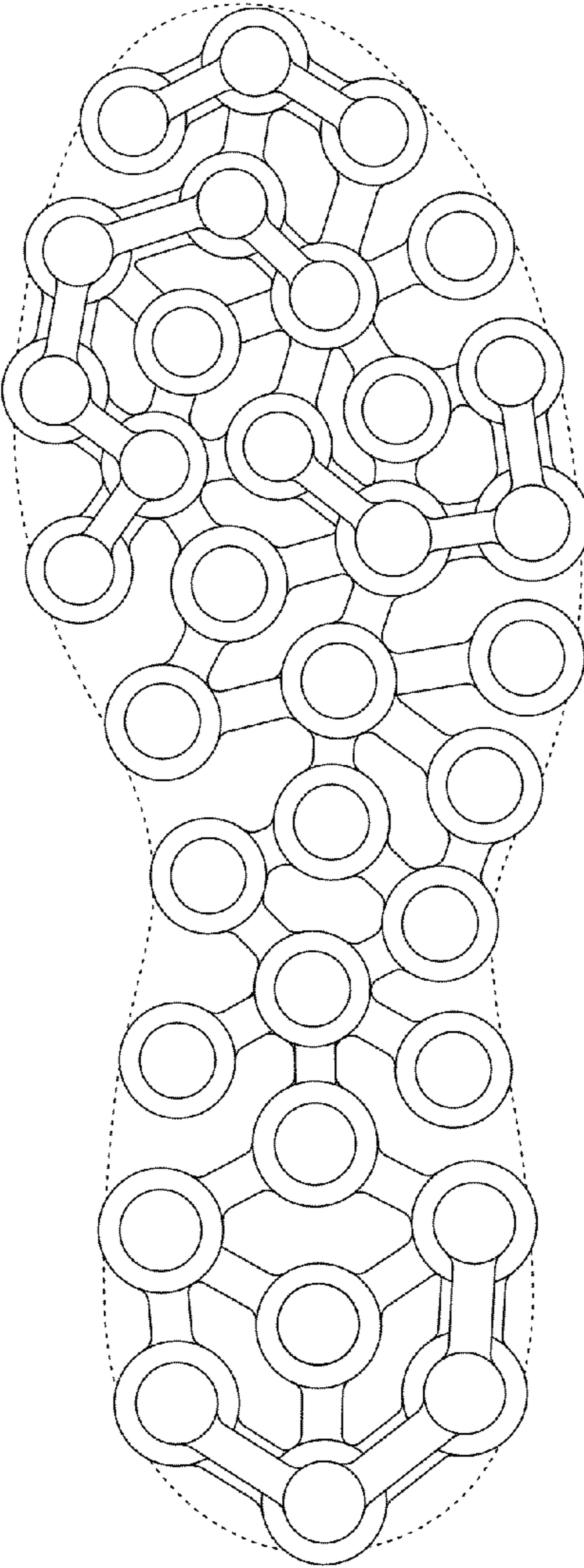

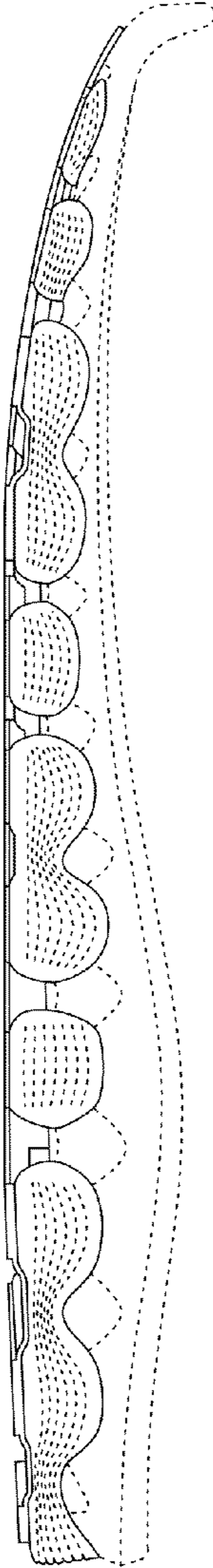

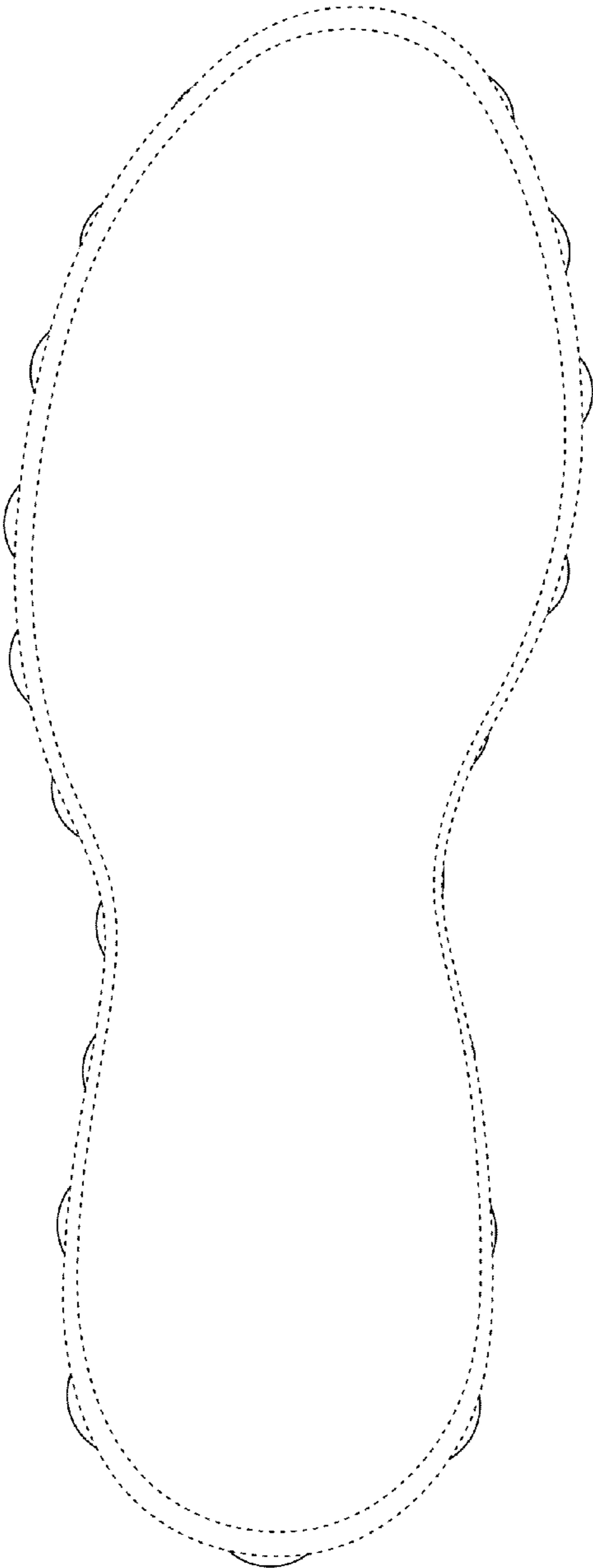

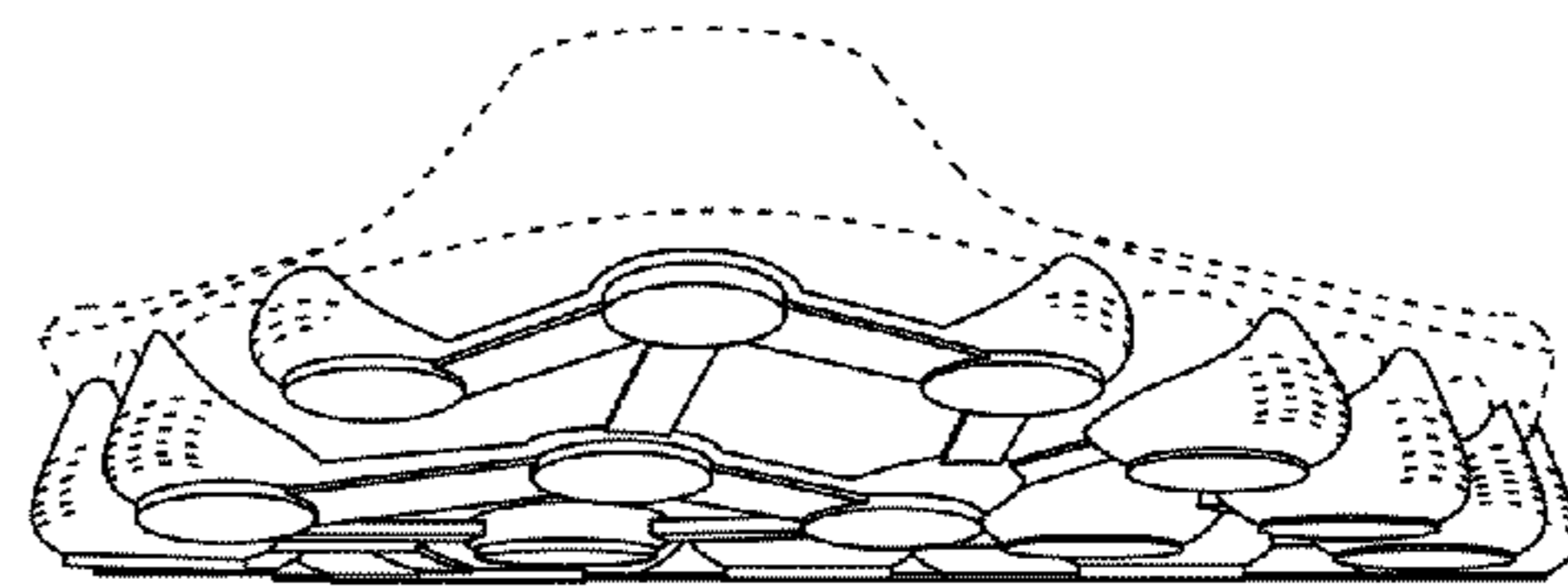

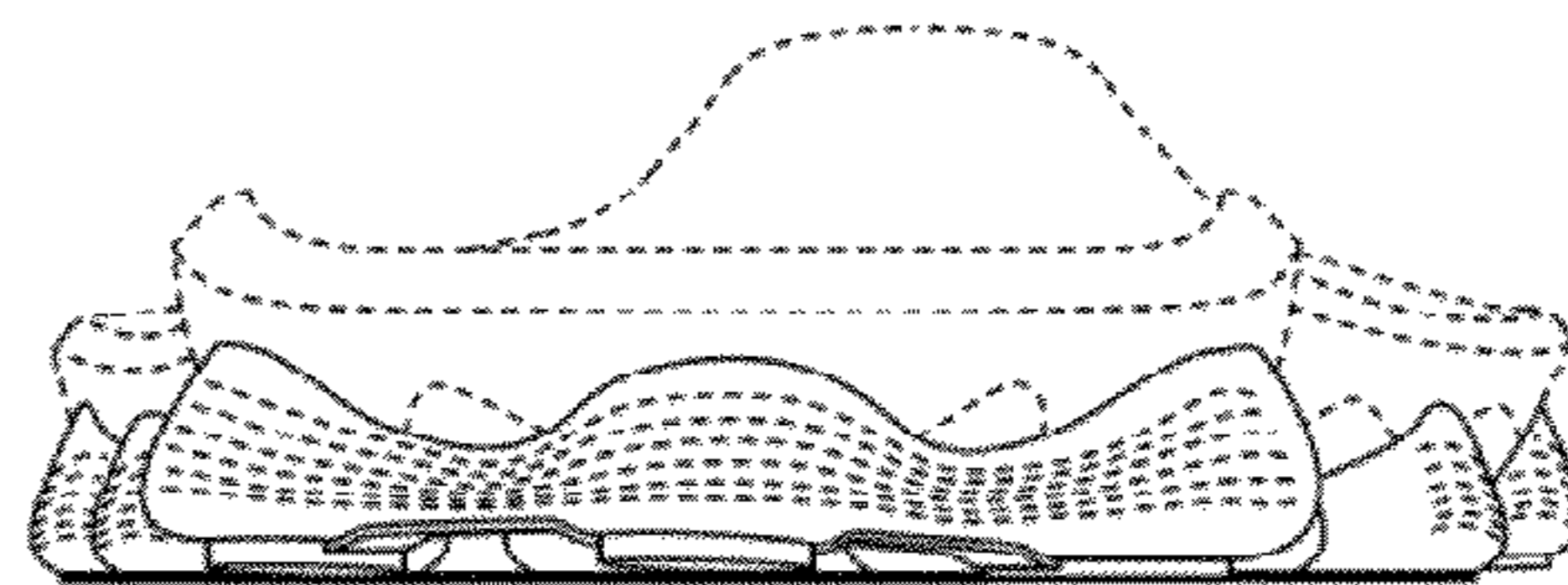

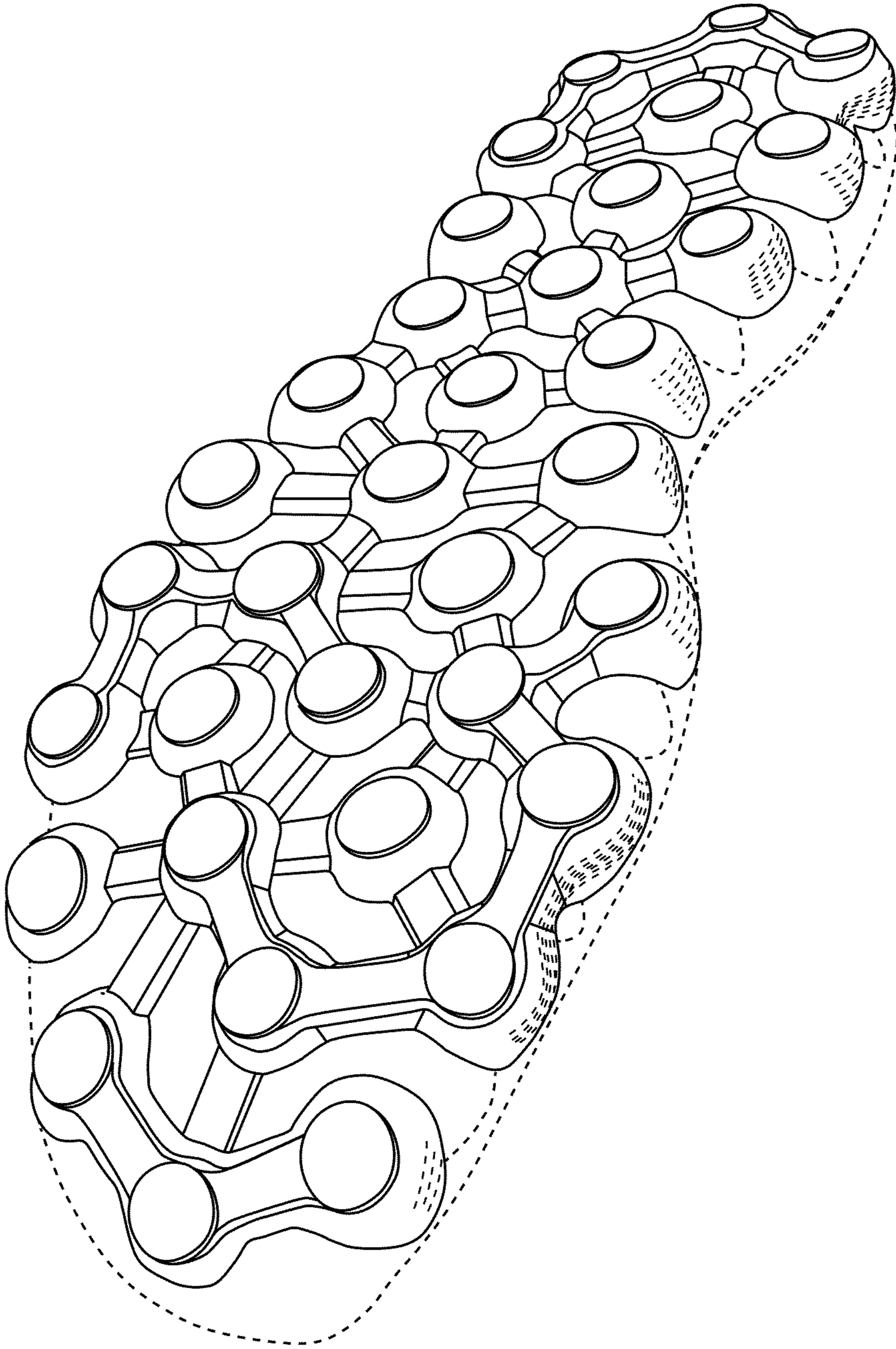
