**DESCRIPTION**

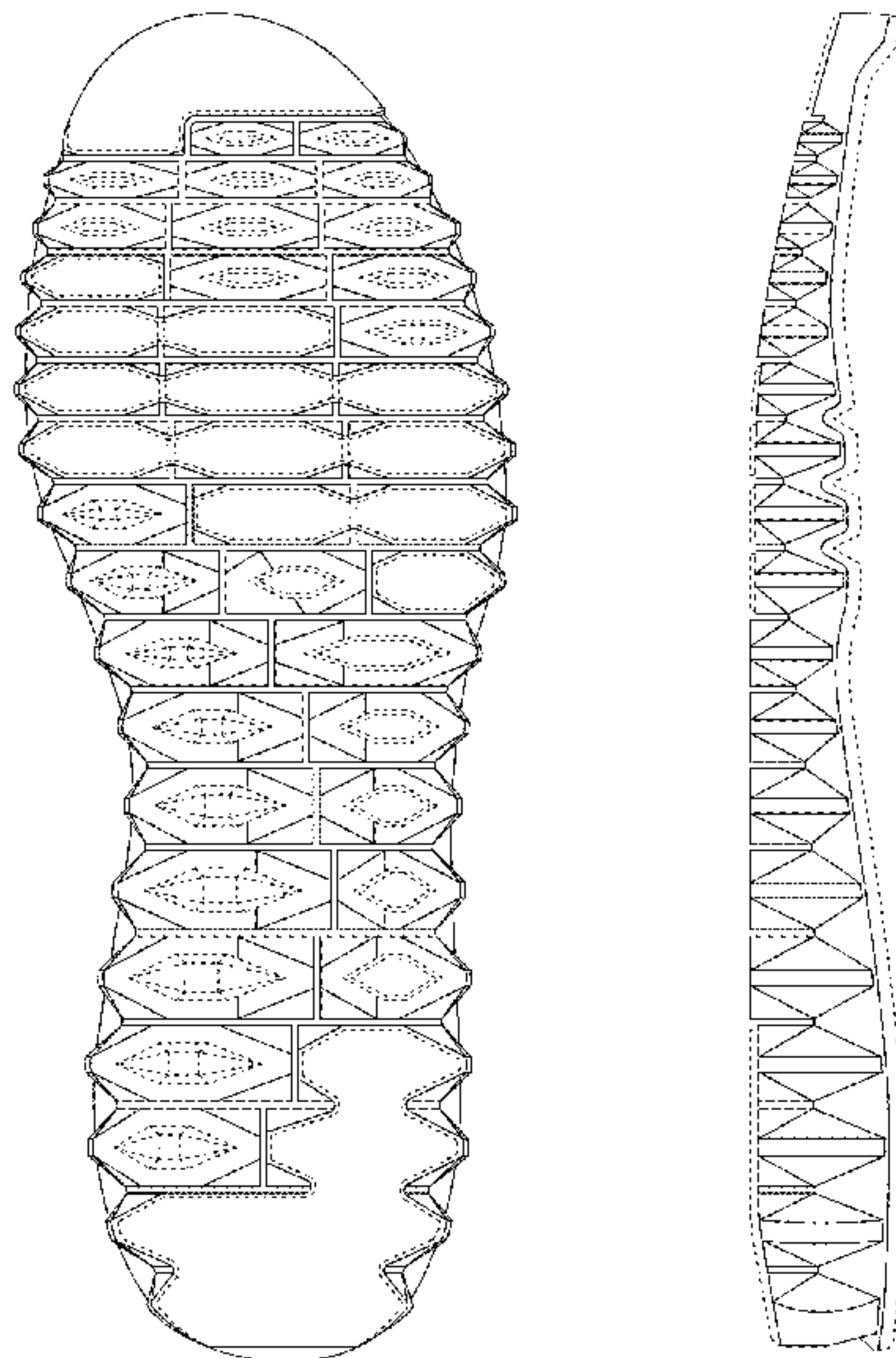
FIG. 1 is a medial side view of a shoe sole;

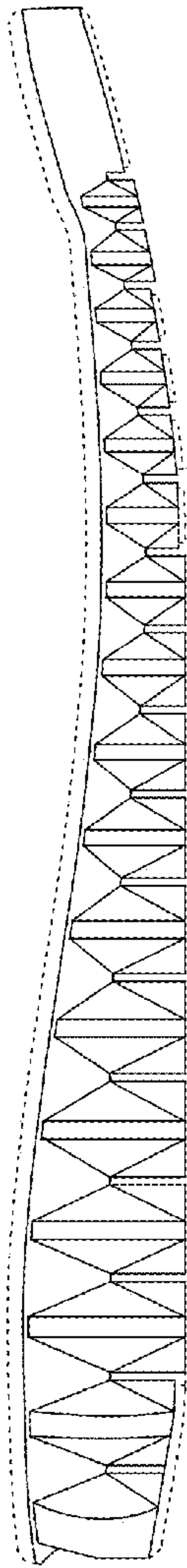

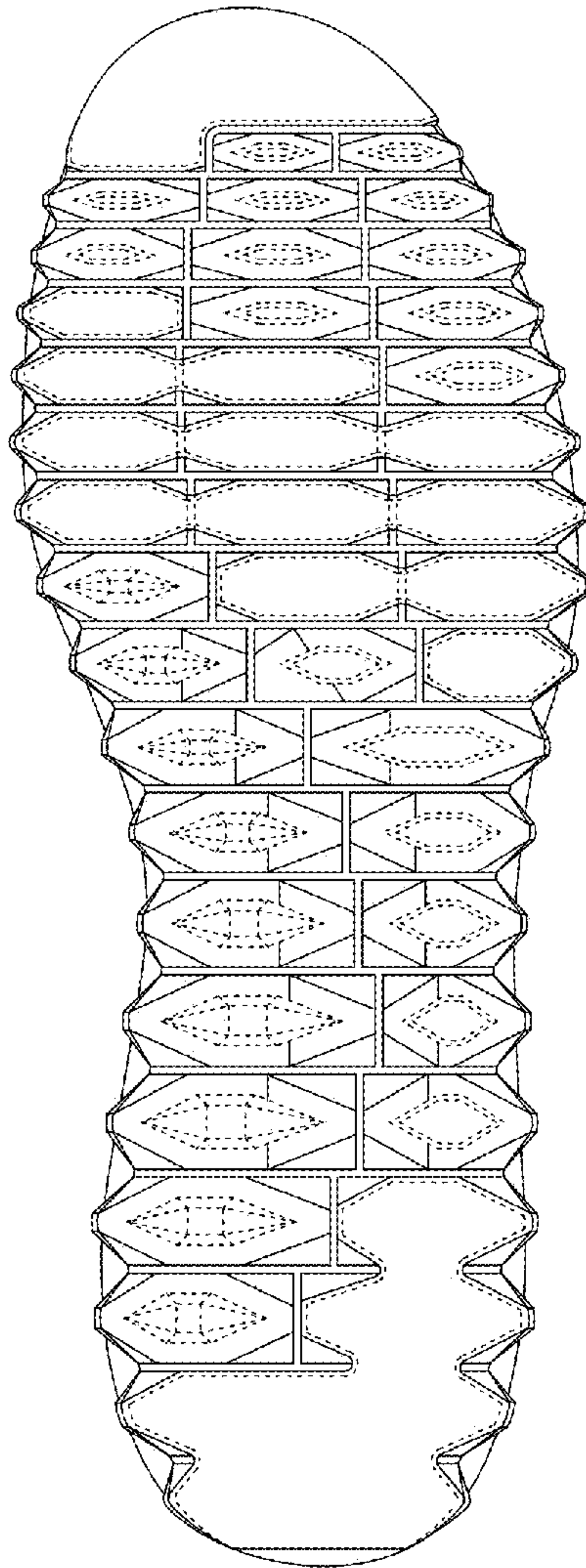

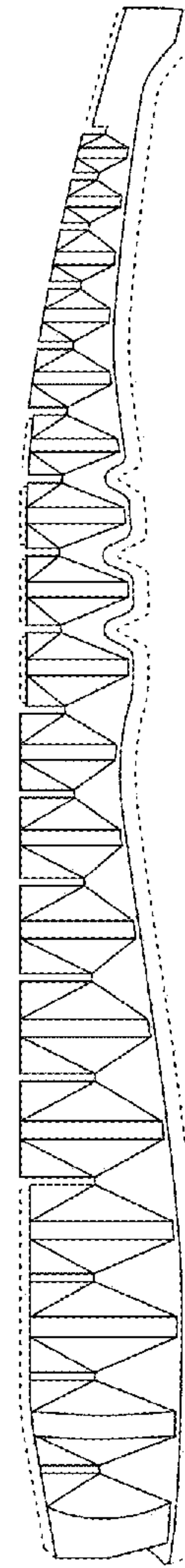

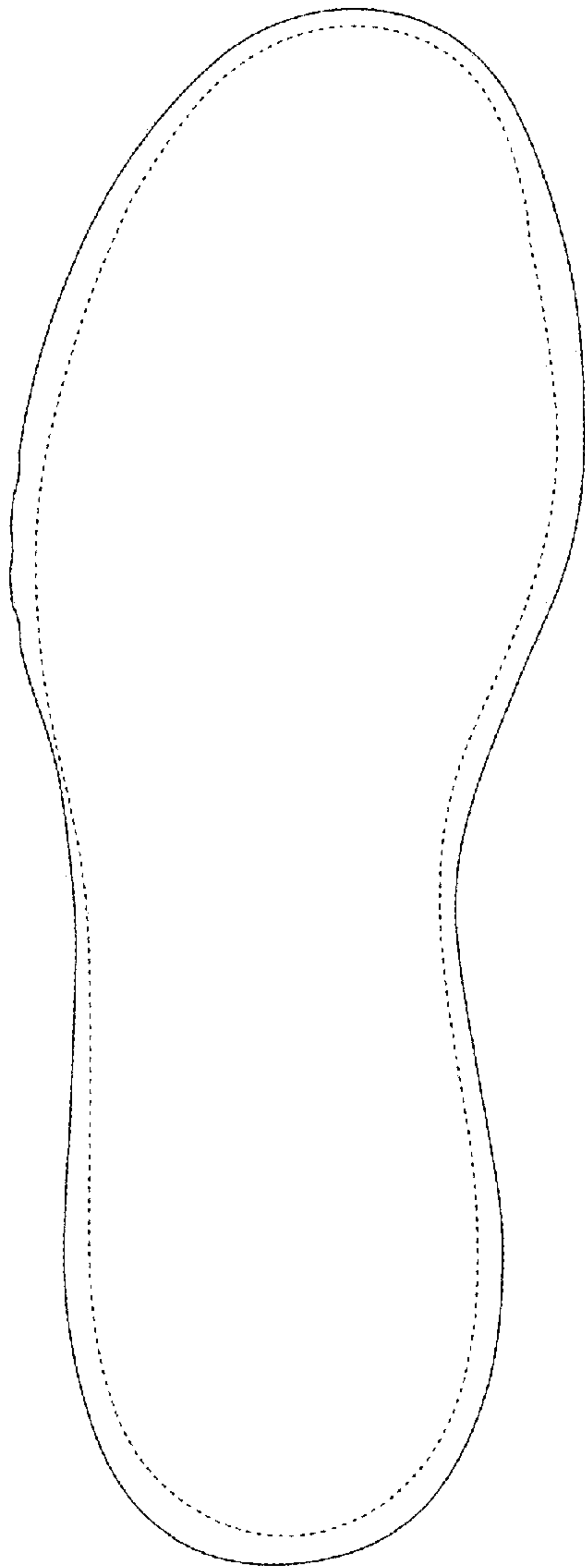

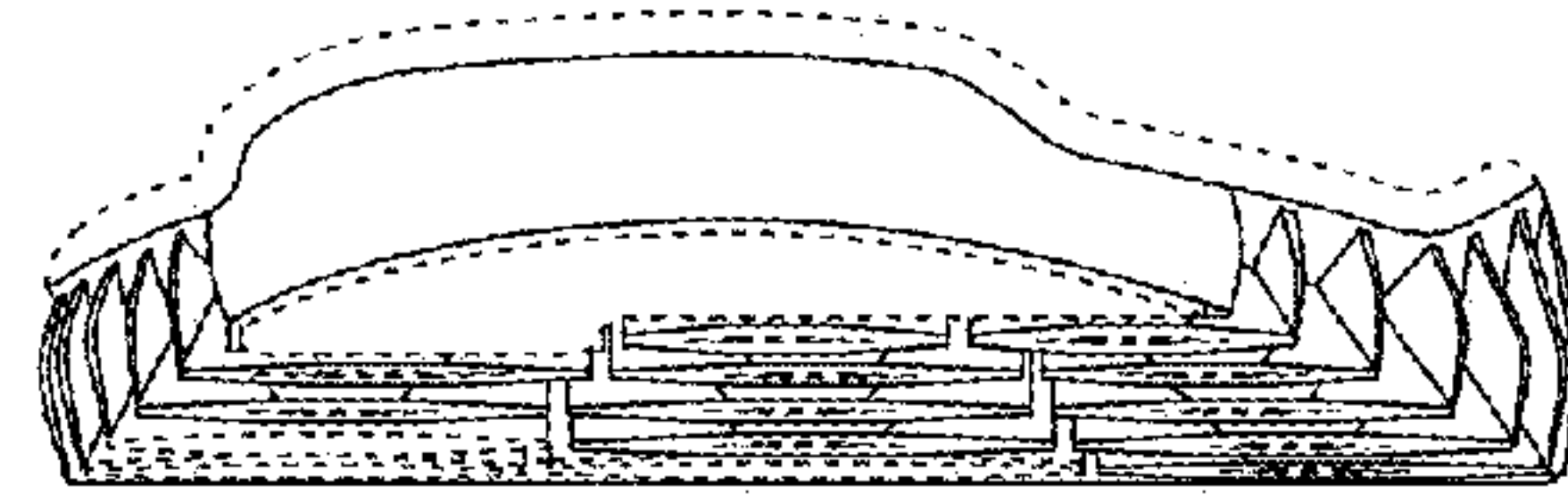

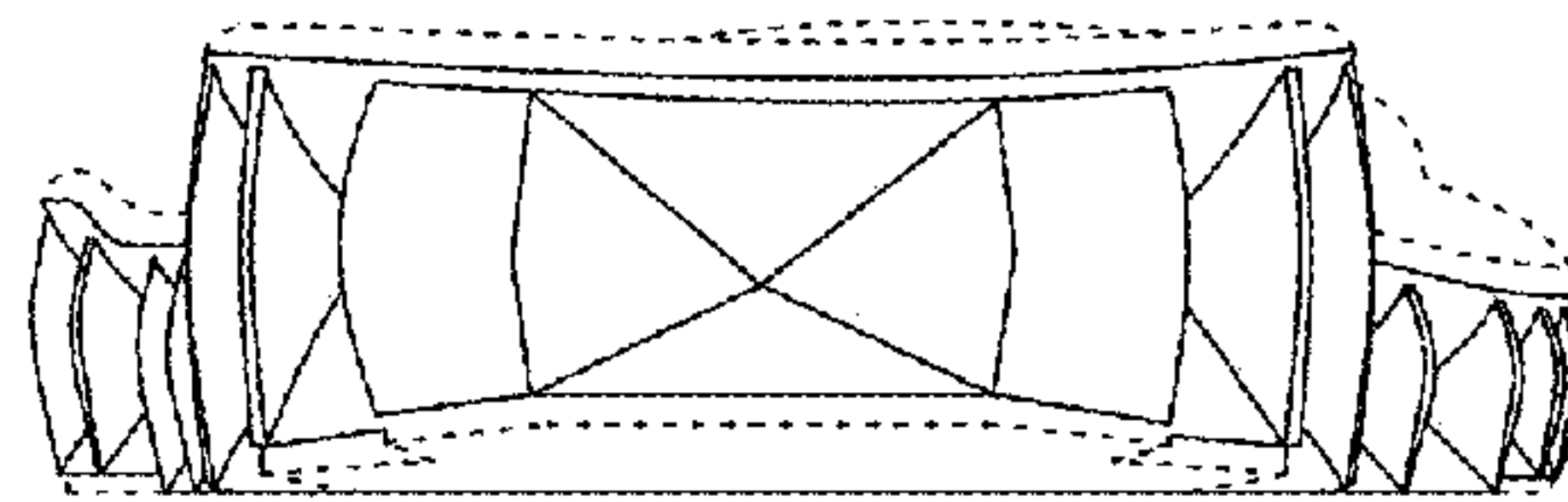

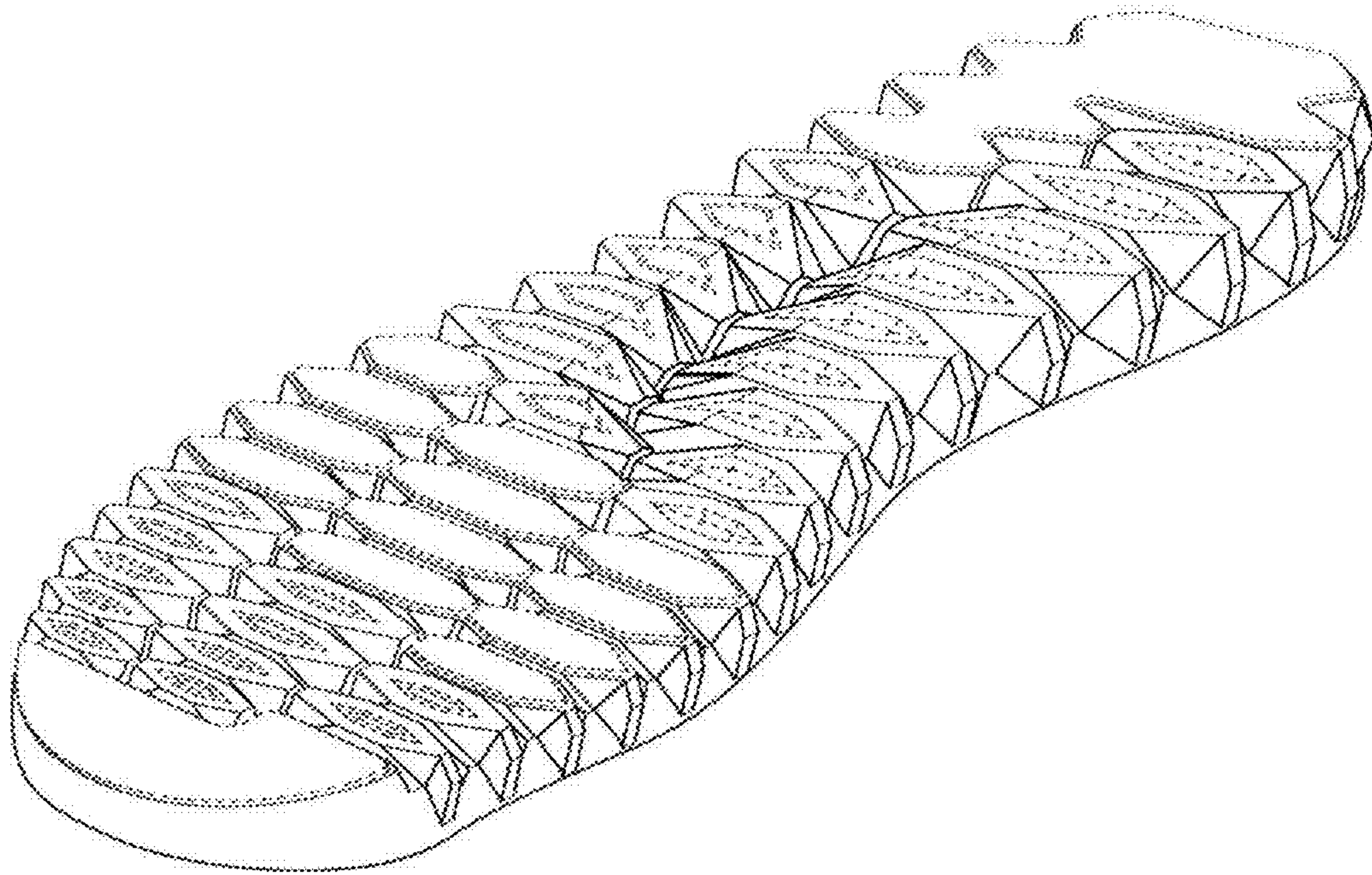
