The ornamental design for a headset carrying case, as shown and described.

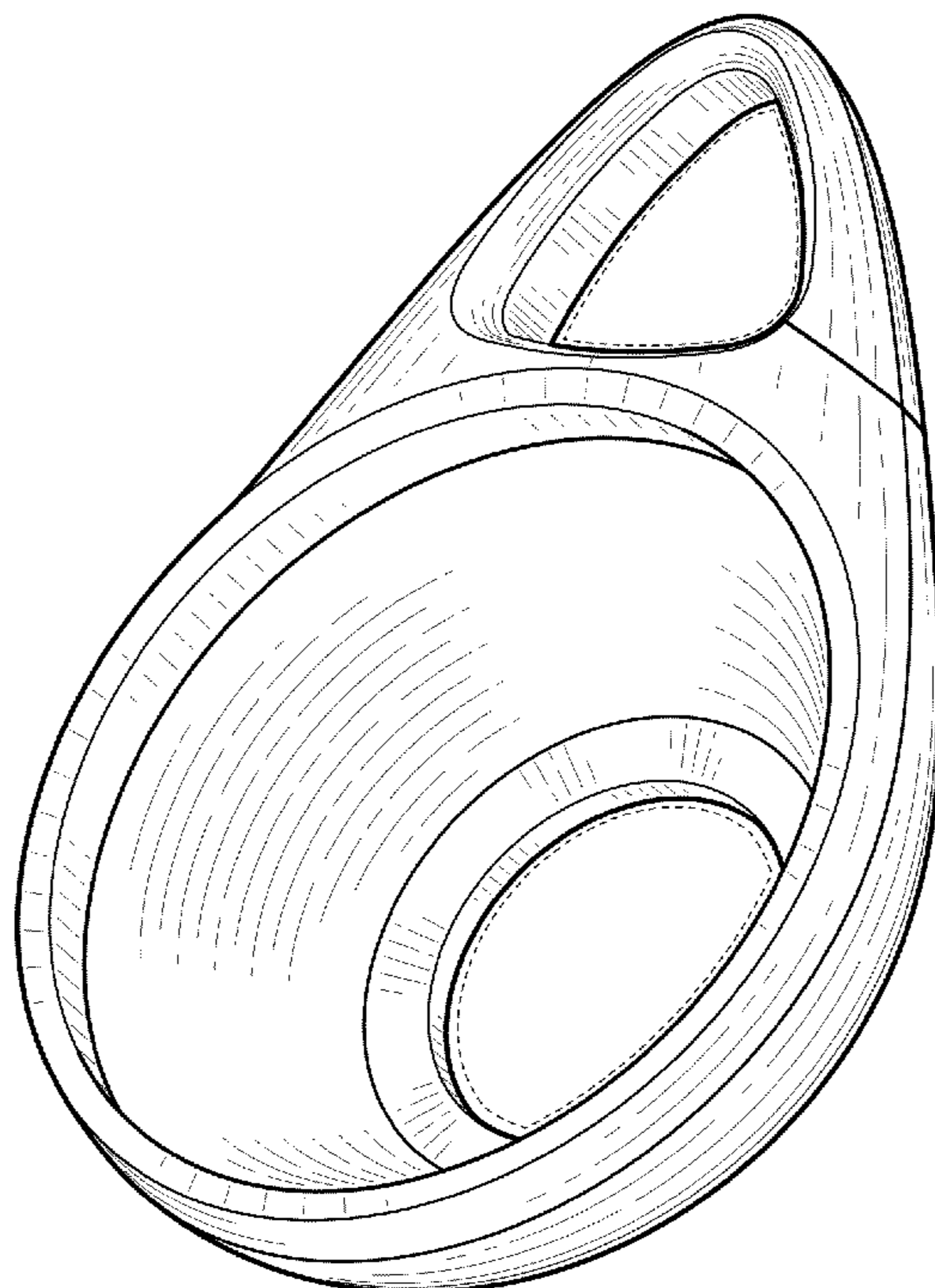
**DESCRIPTION**

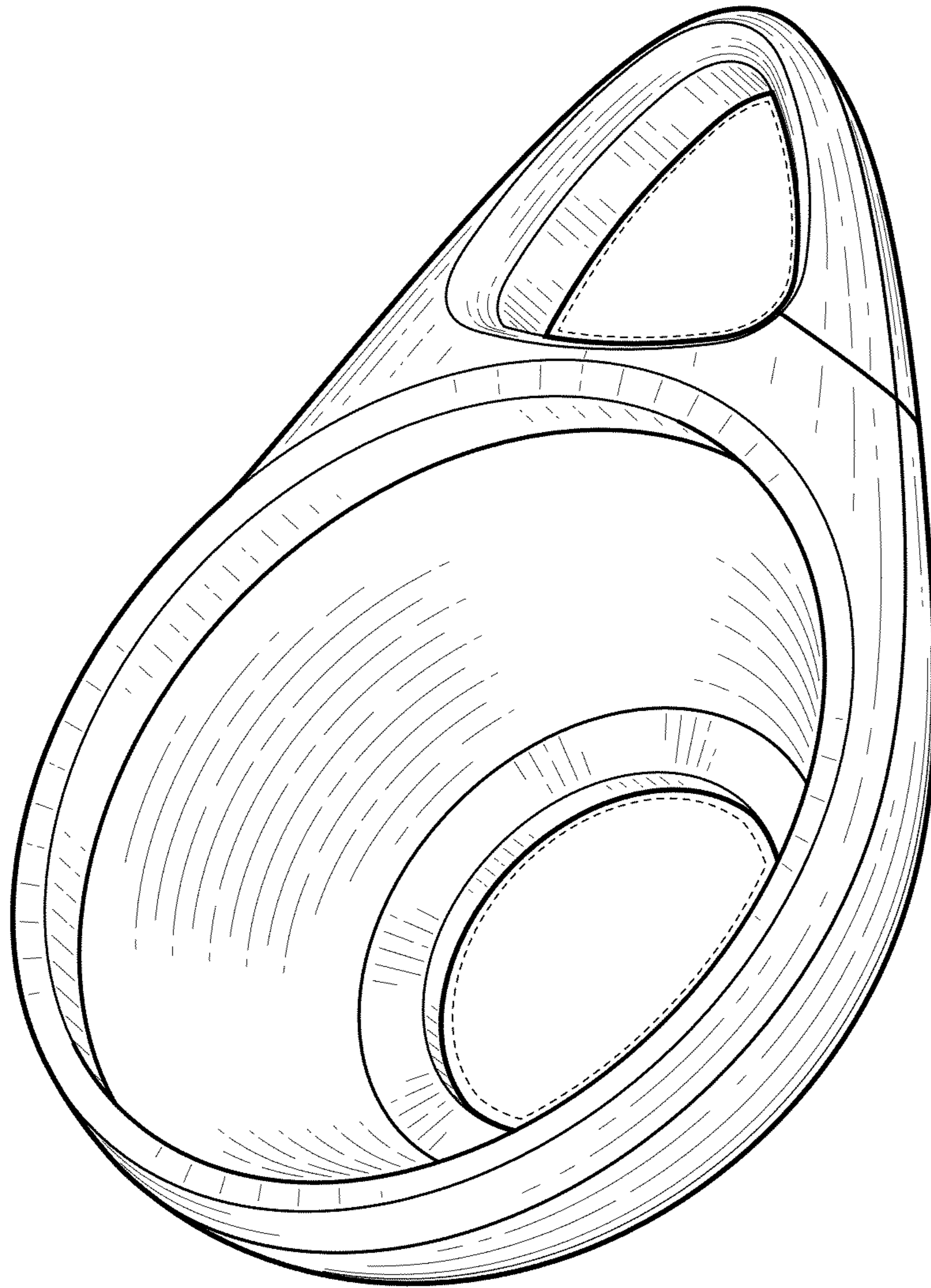

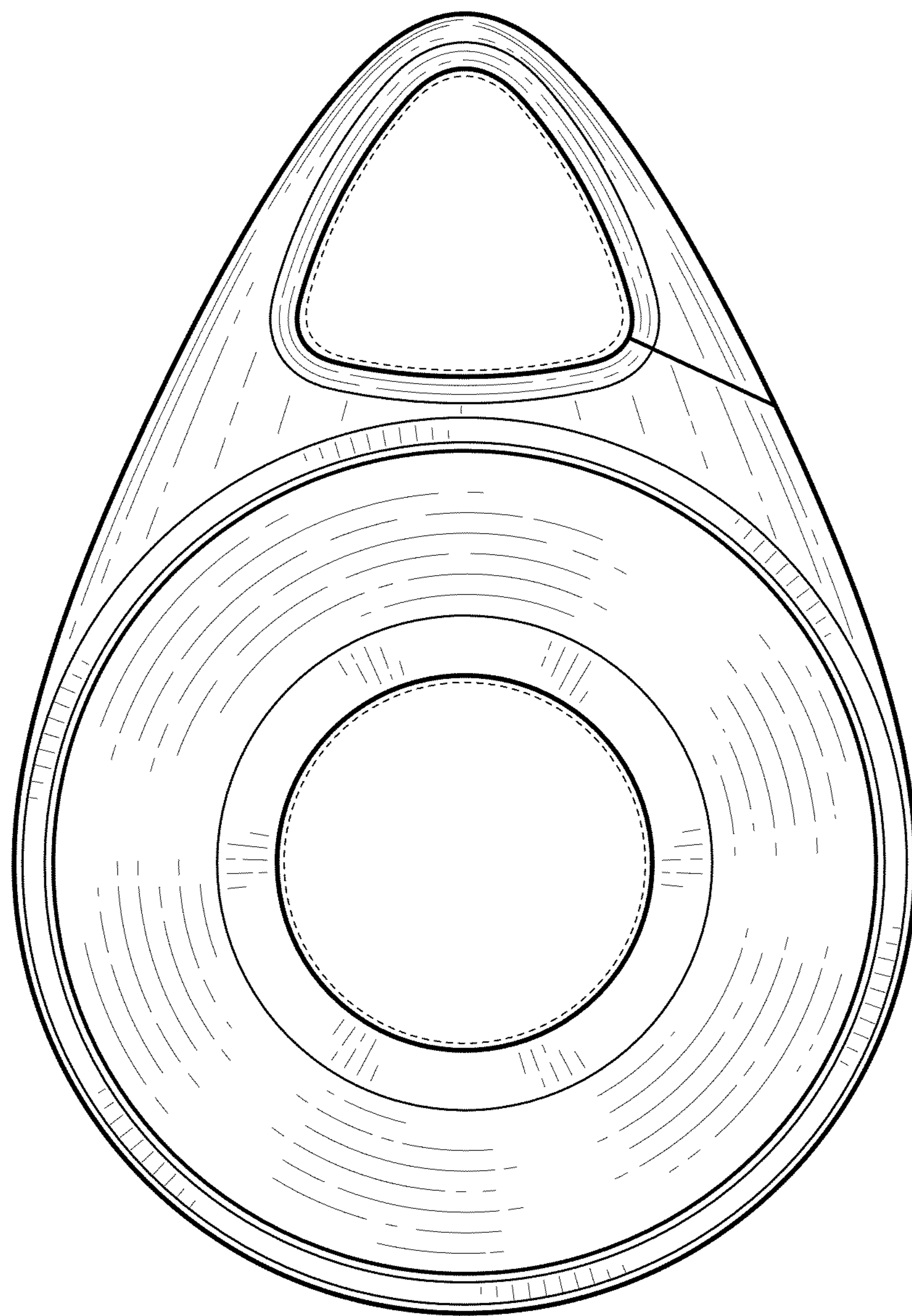

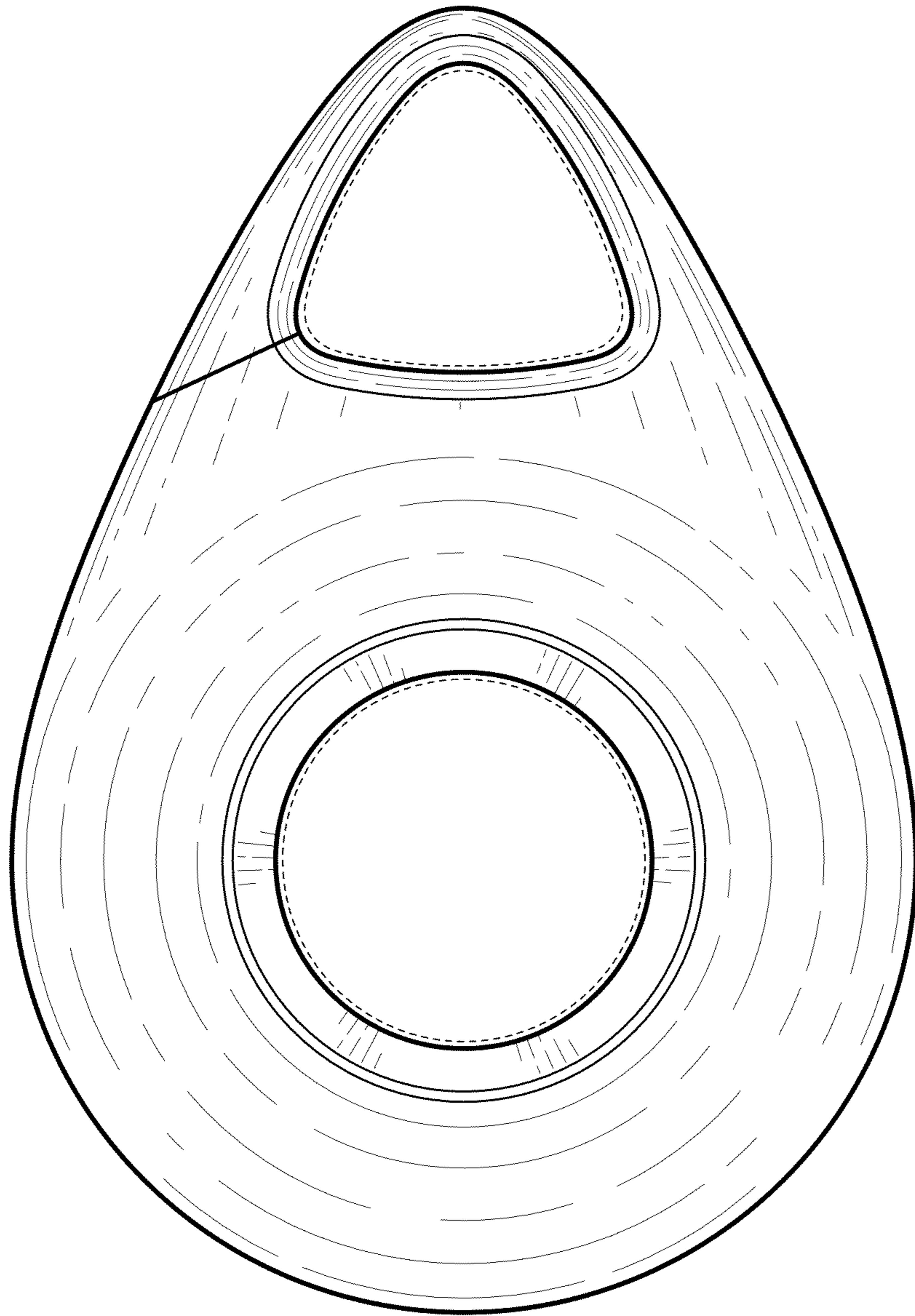

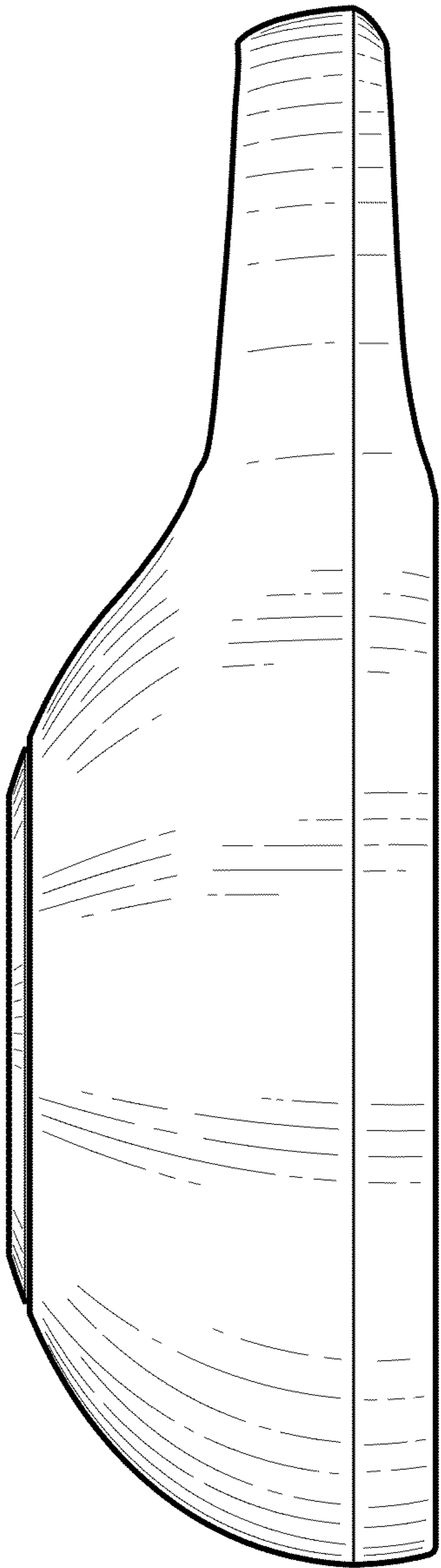

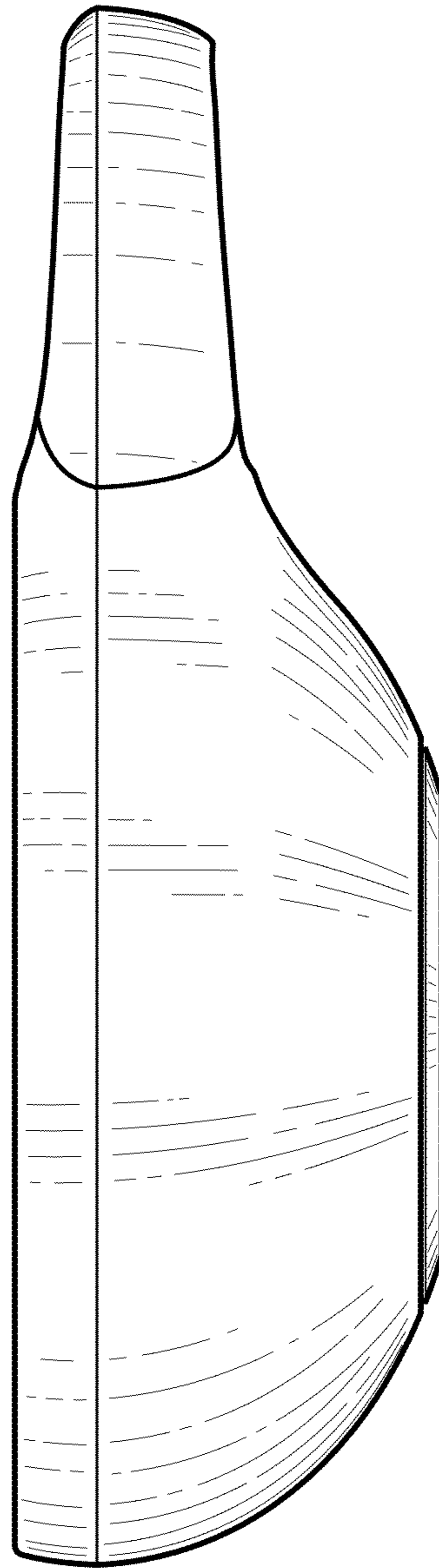

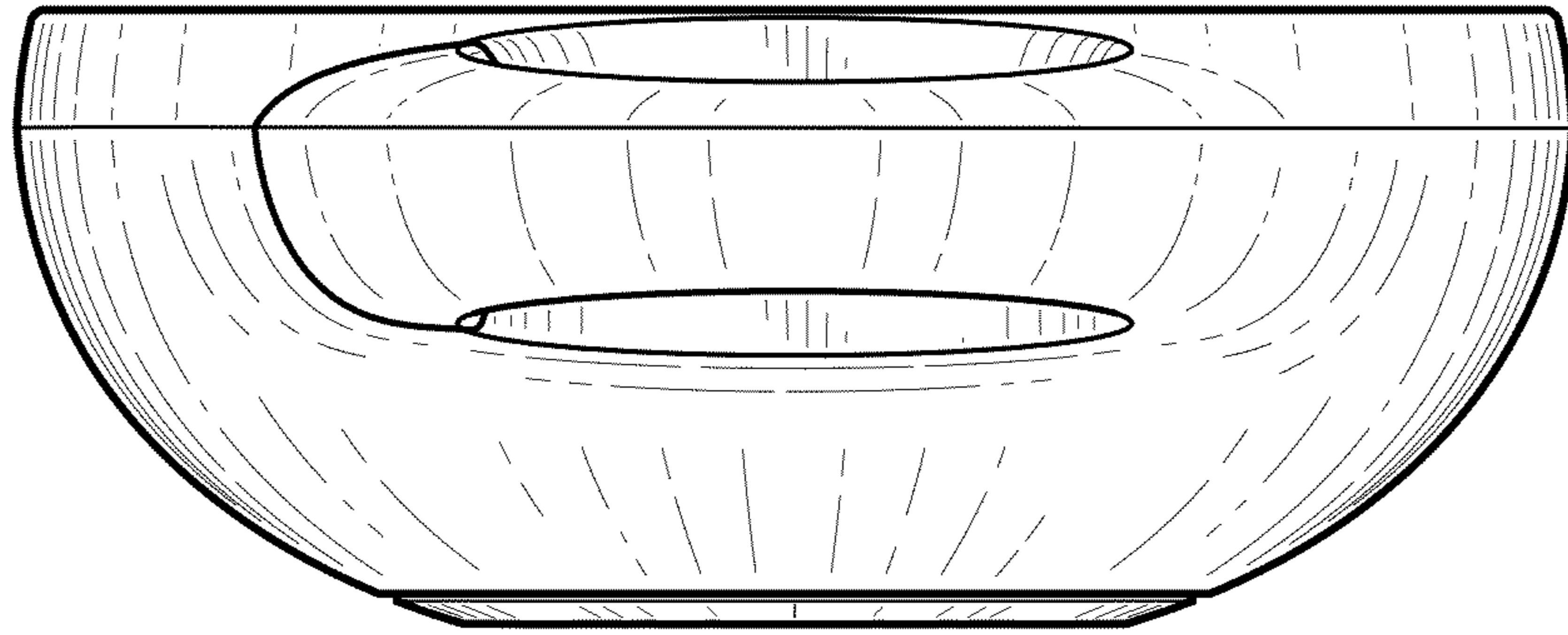

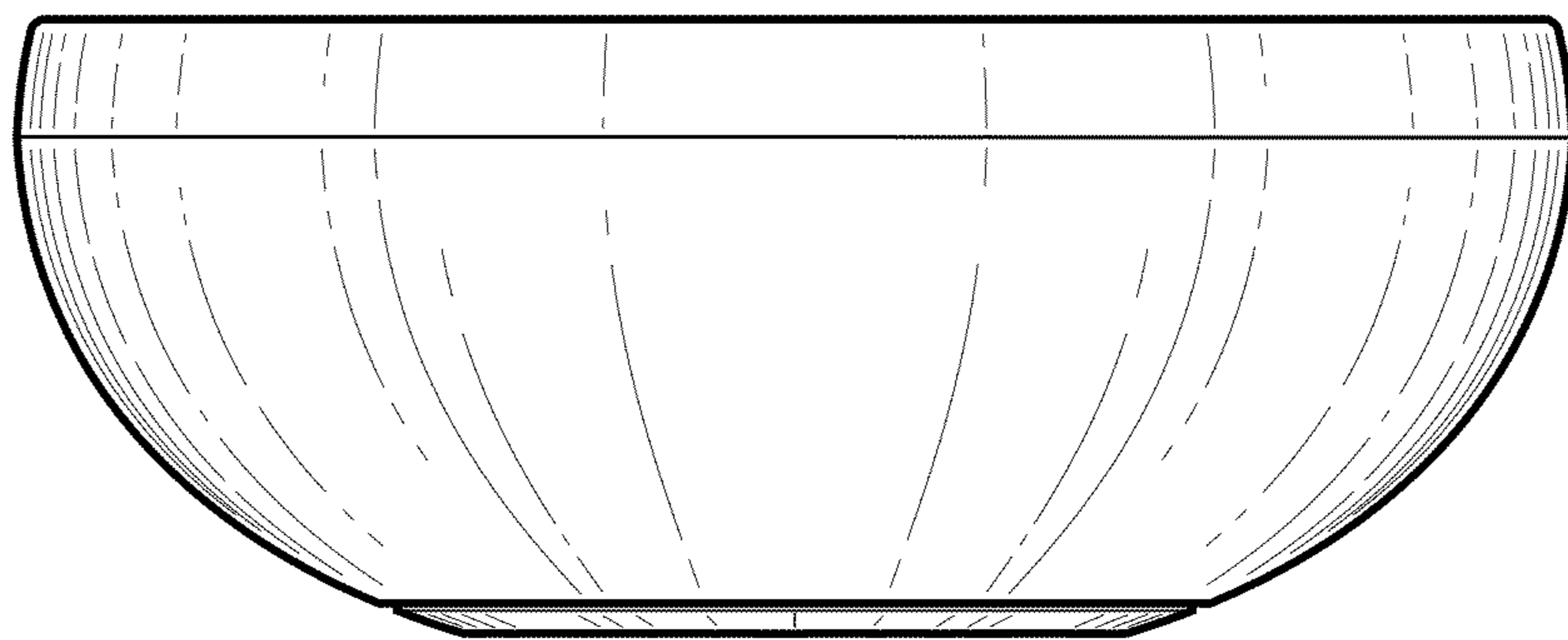
