(57) **CLAIM**

The ornamental design for a protective case, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a protective case according to a first embodiment of our design;
 FIG. 2 is a front elevation view of the protective case of FIG. 1 to which a rear elevation view is a mirror image thereof;
 FIG. 3 is a right elevation view of the protective case of FIG. 1;
 FIG. 4 is a left elevation view of the protective case of FIG. 1;
 FIG. 5 is a top elevation view of the protective case of FIG. 1;
 FIG. 6 is a bottom elevation view of the protective case of FIG. 1;
 FIG. 7 is a front perspective view of the protective case according to a second embodiment of our design shown in an open configuration thereof;
 FIG. 8 is a front elevation view of the protective case of FIG. 7 to which a rear elevation view is a mirror image thereof;
 FIG. 9 is a right side elevation view of the protective case of FIG. 7;
 FIG. 10 is a left side elevation view of the protective case of FIG. 7;

 FIG. 17 is a top elevation view of the protective case of FIG. 13;

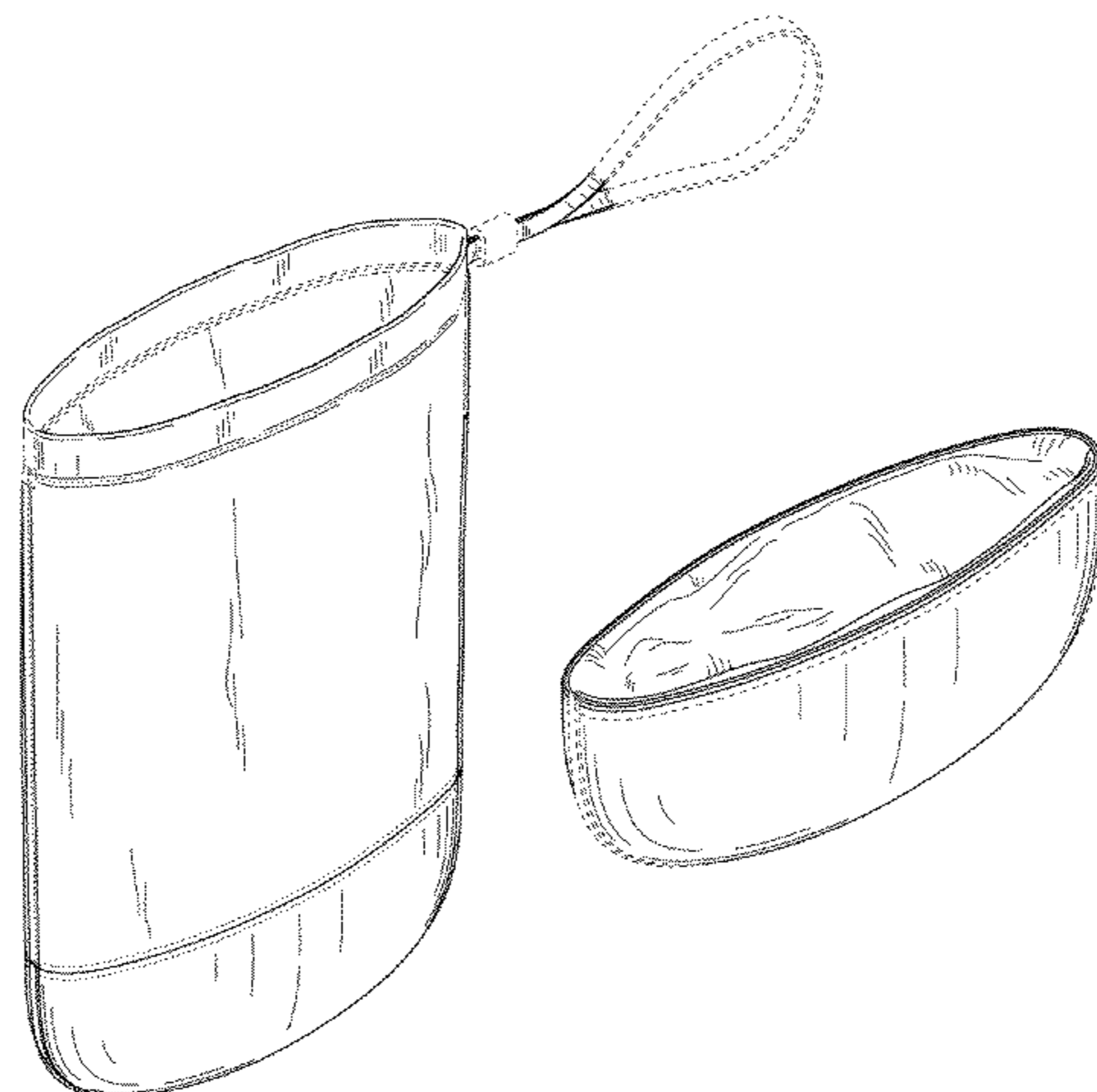


FIG. **18** is a bottom elevation view of the protective case of FIG. **13**;

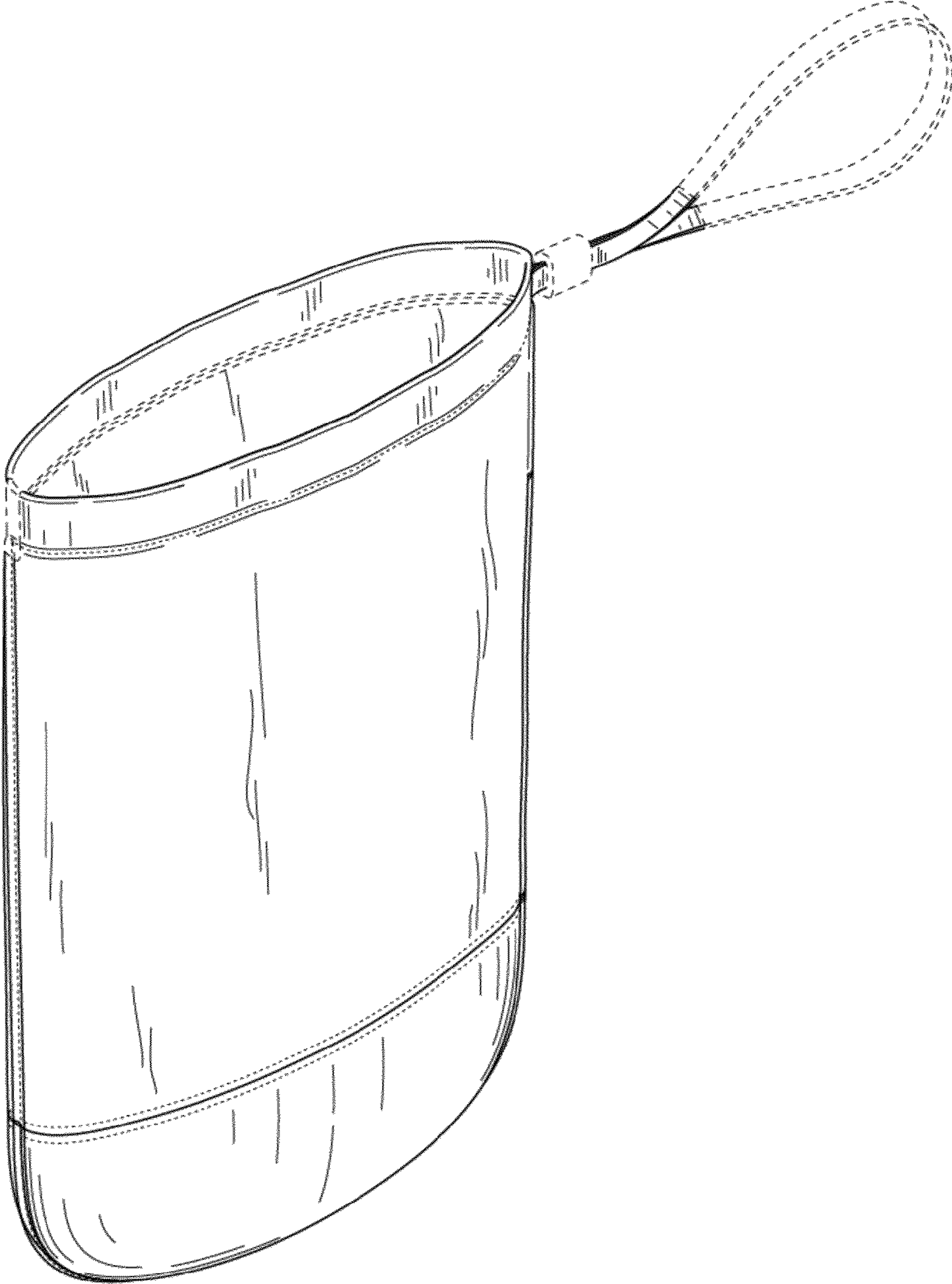

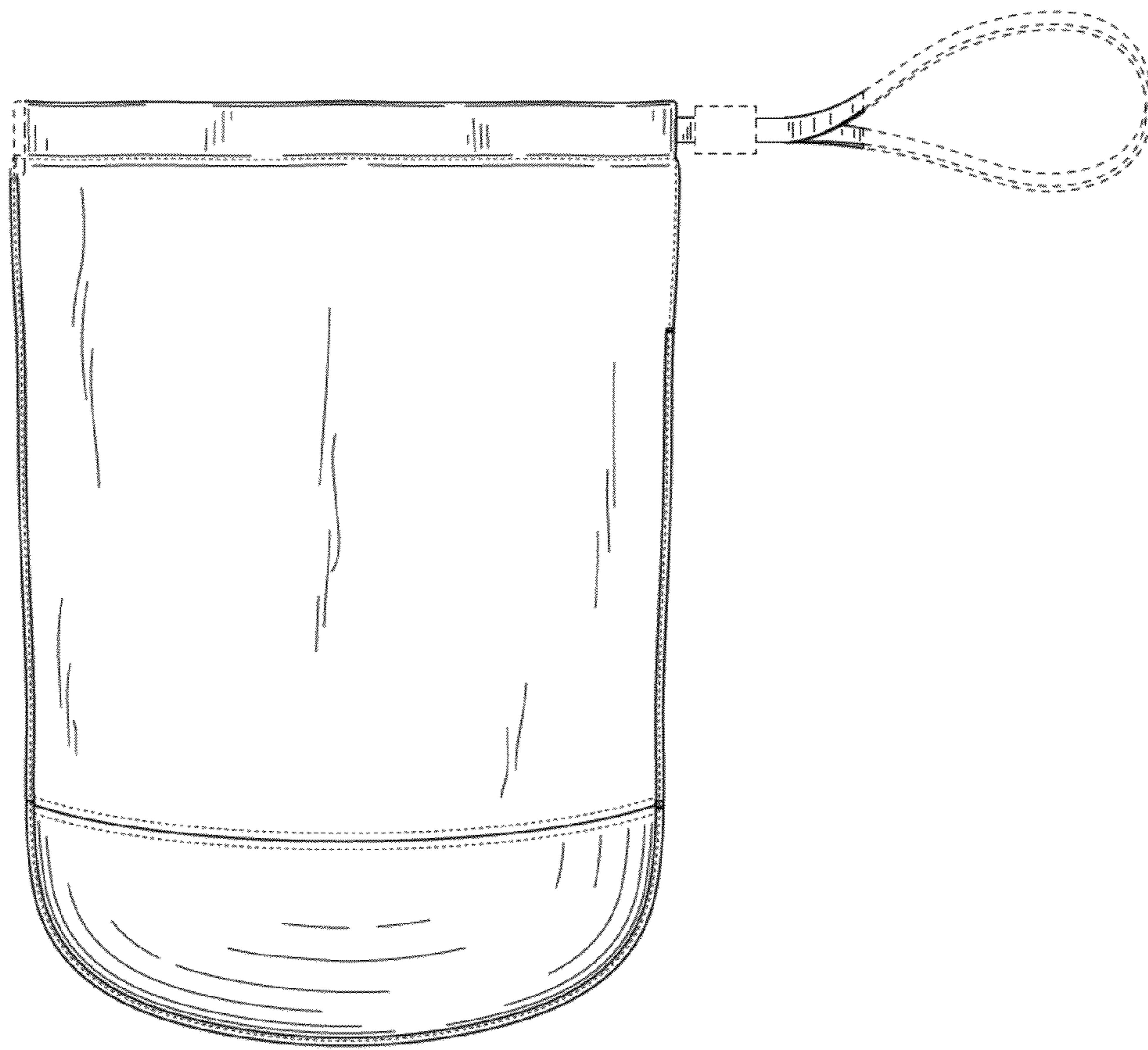

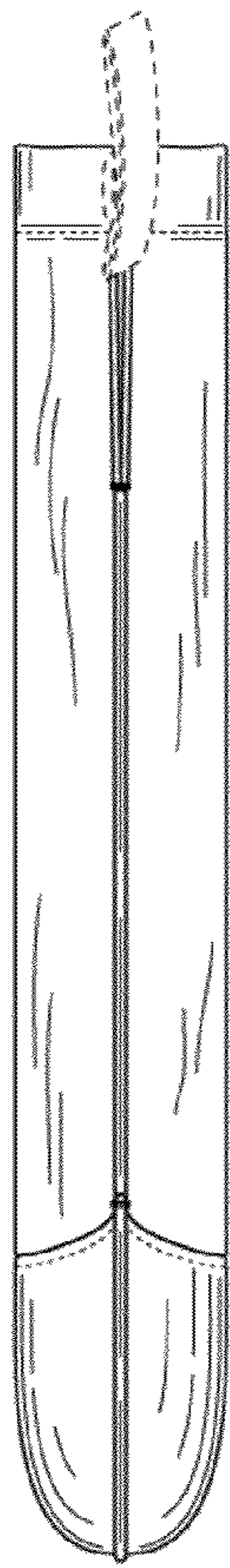

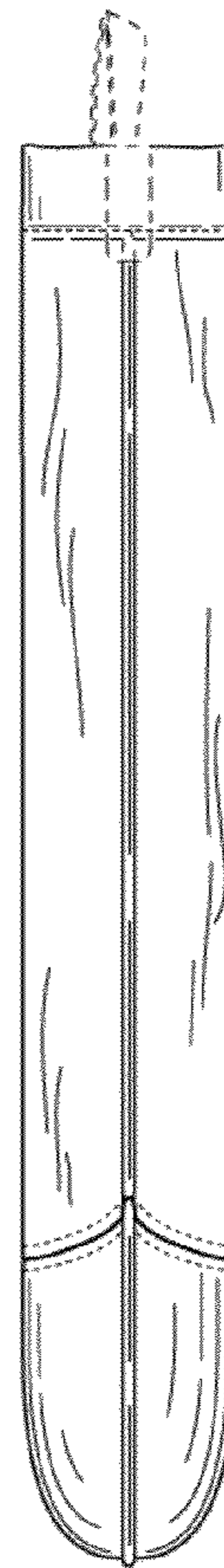

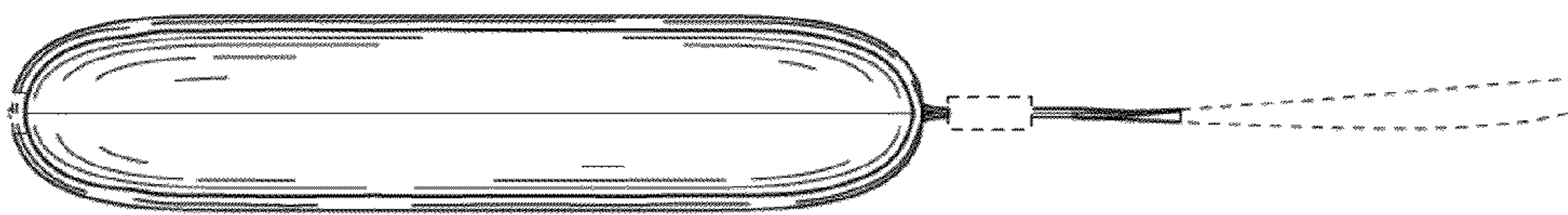

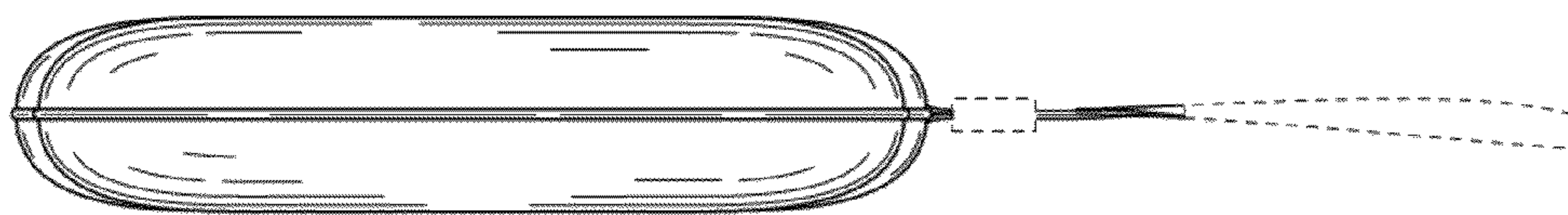

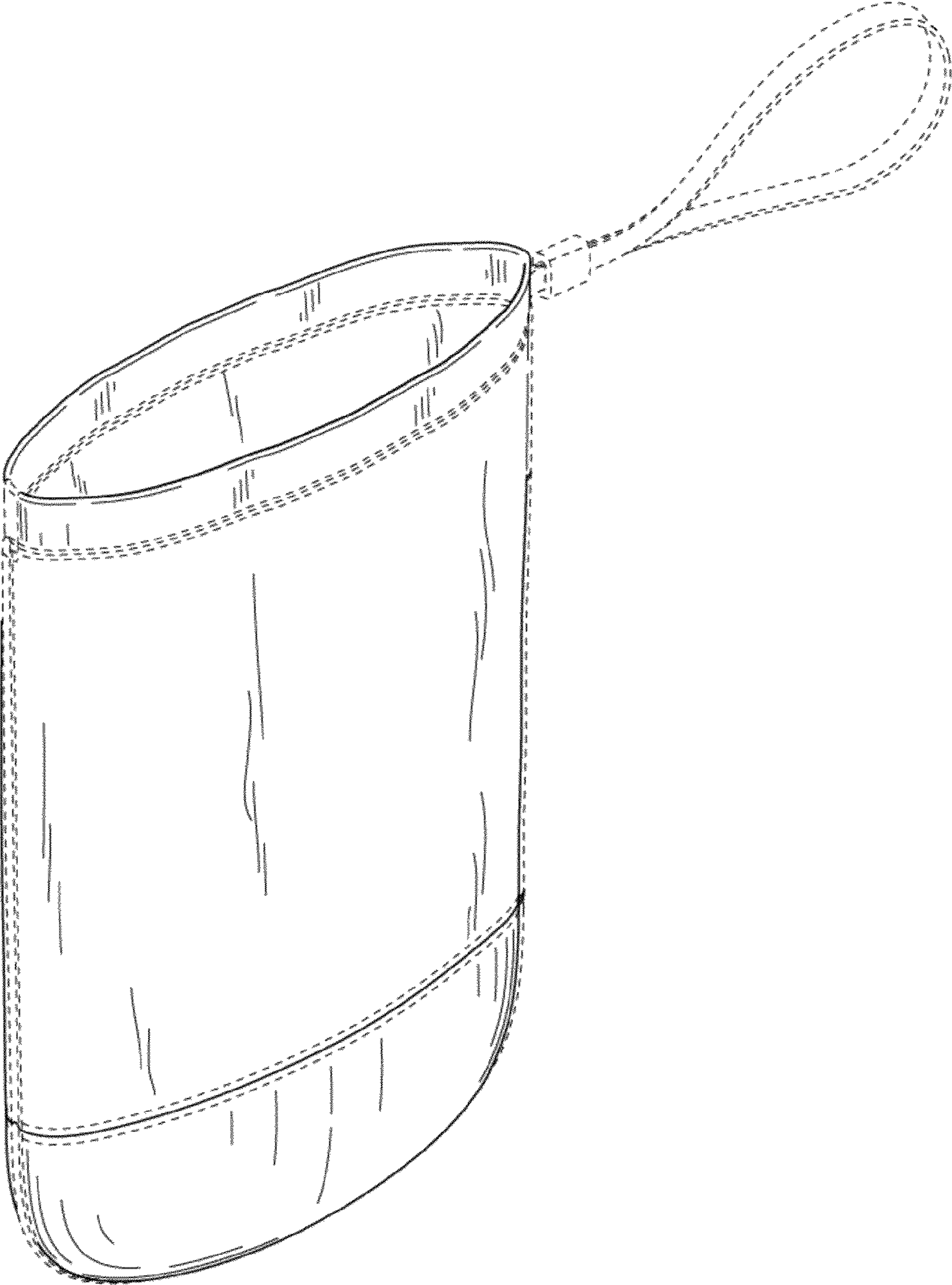

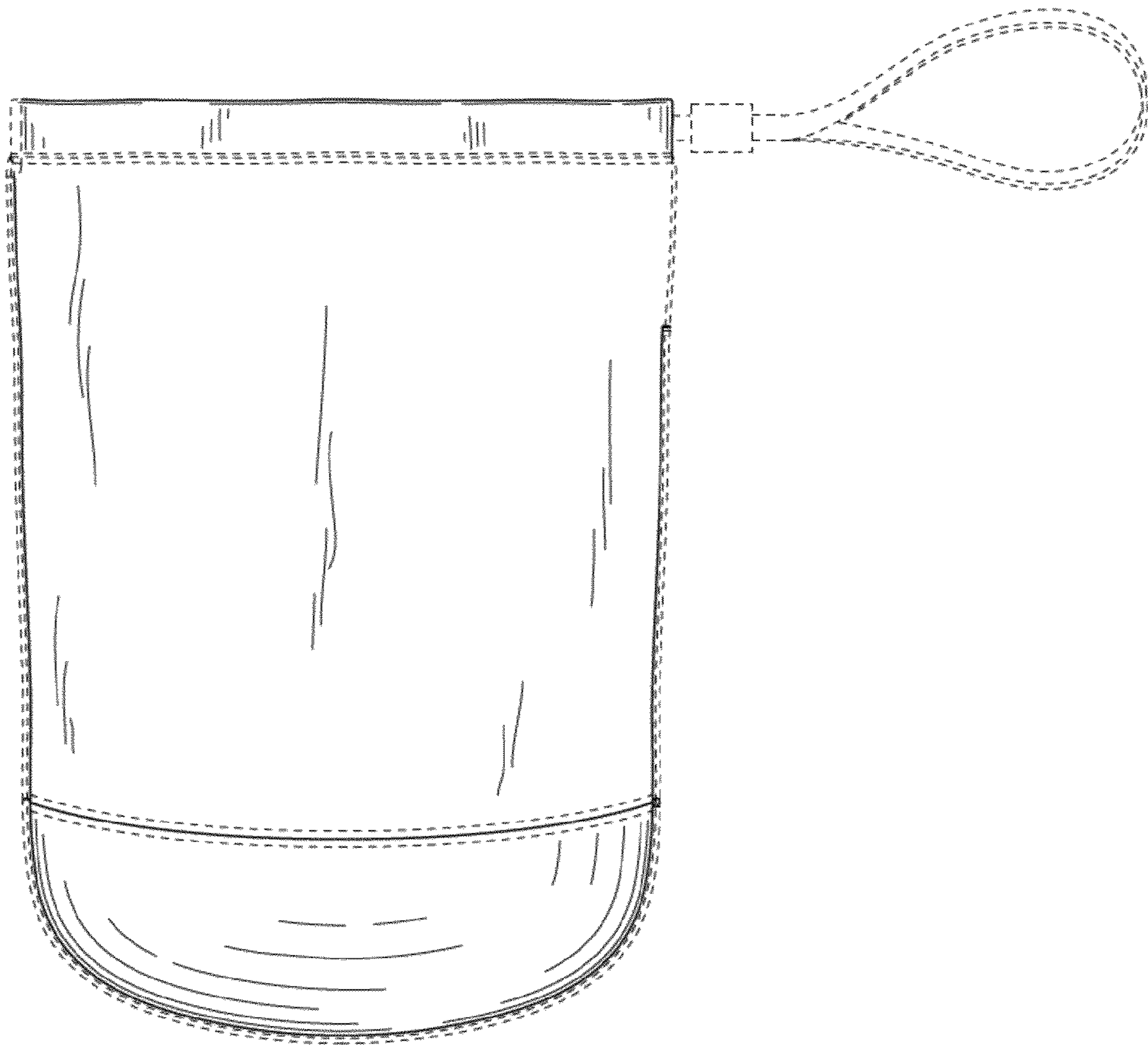

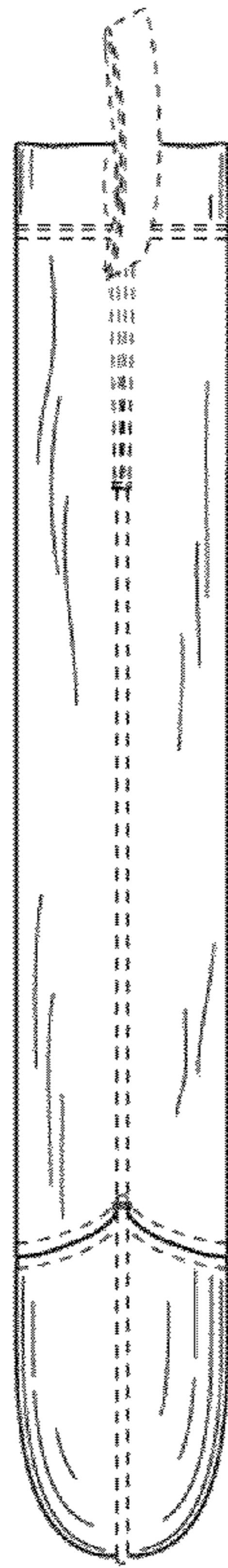

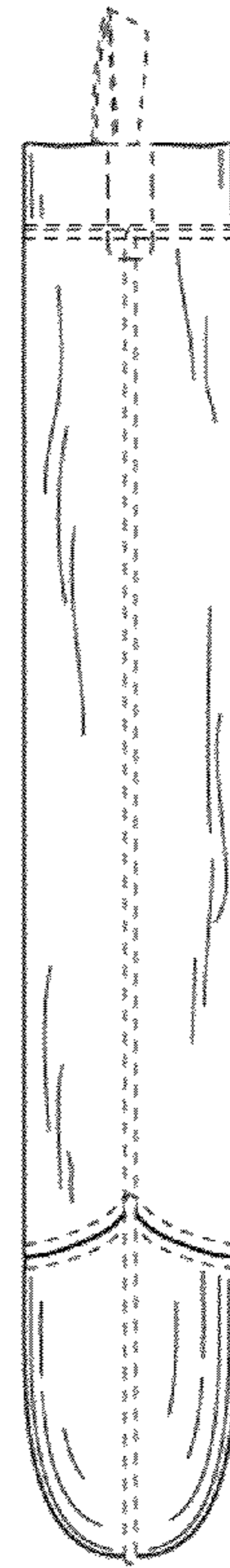

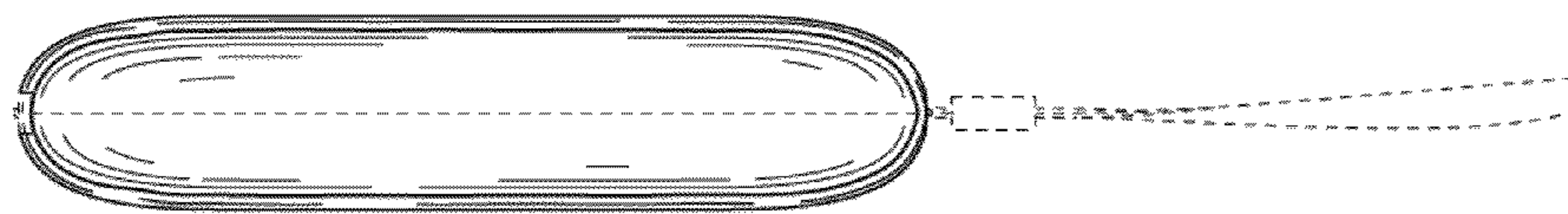

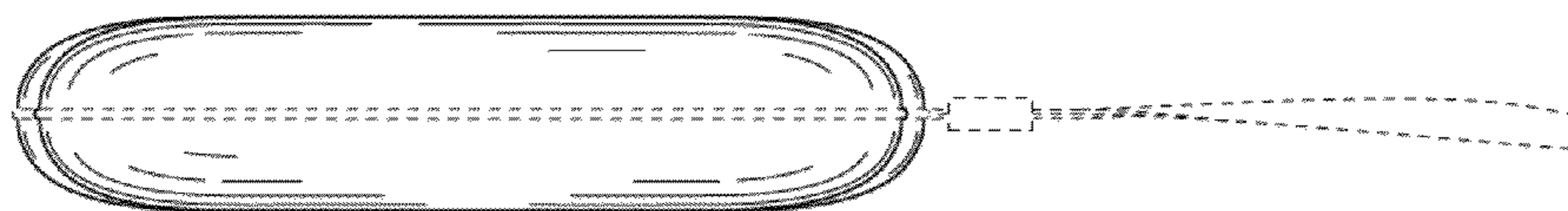

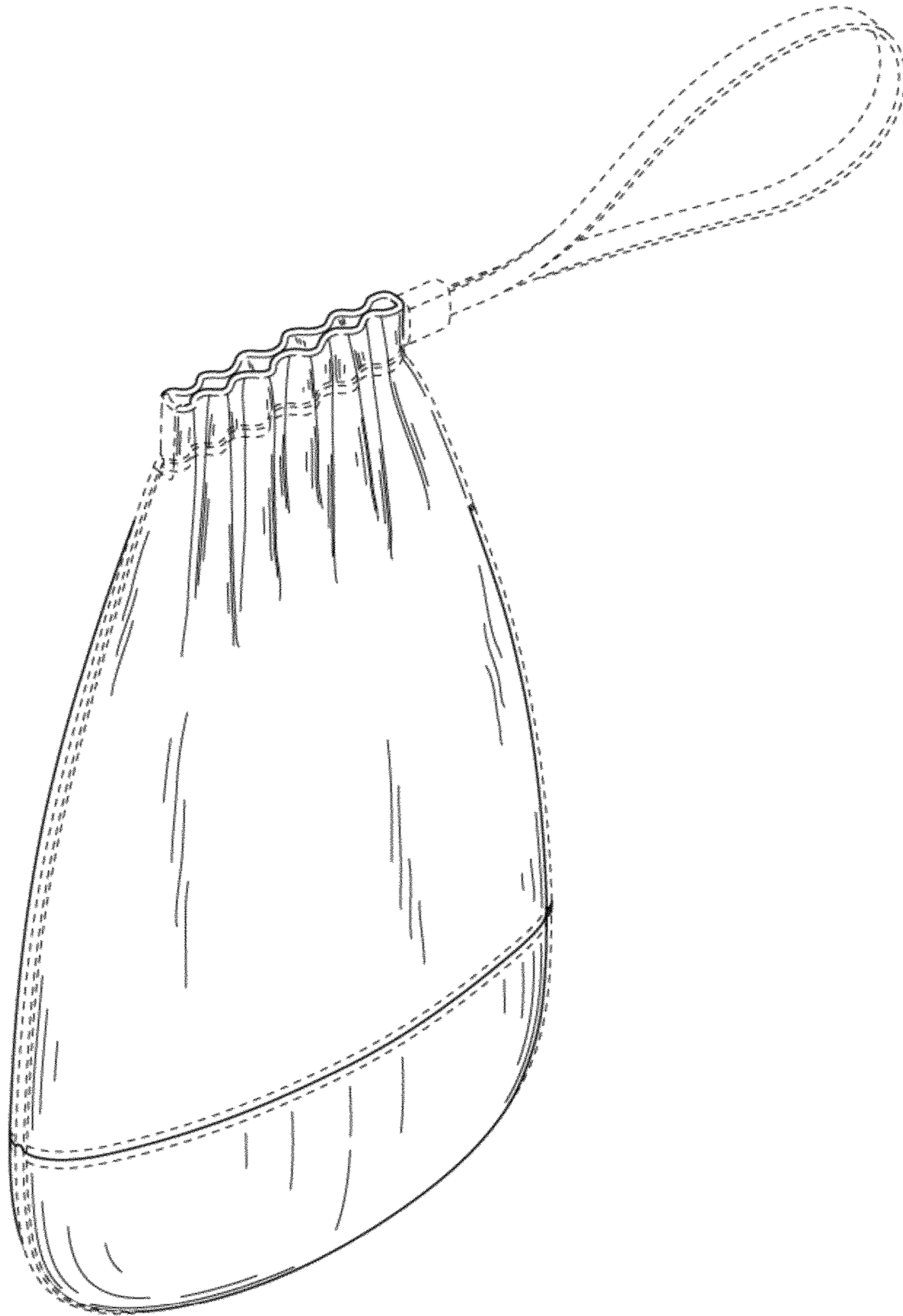

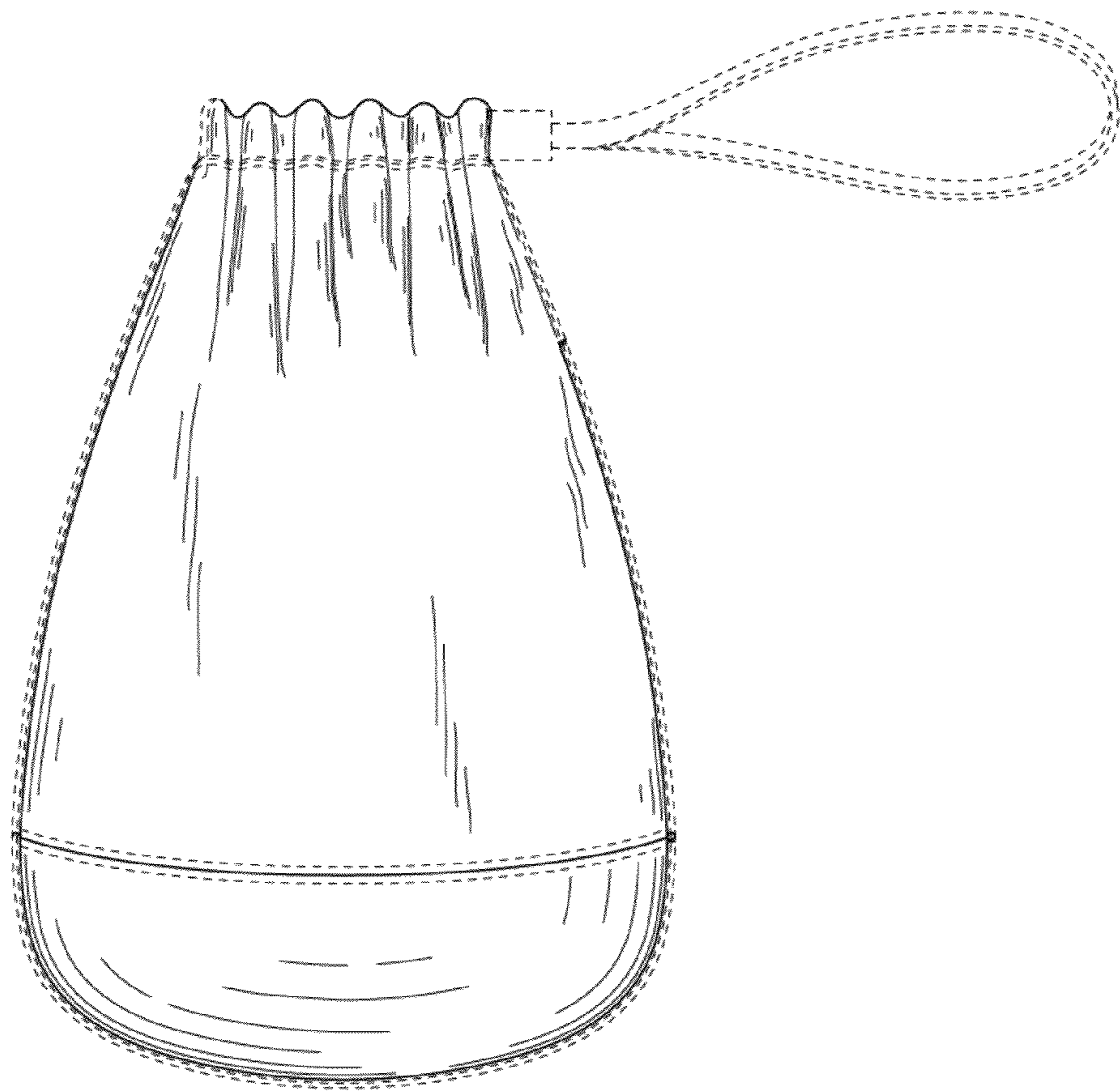

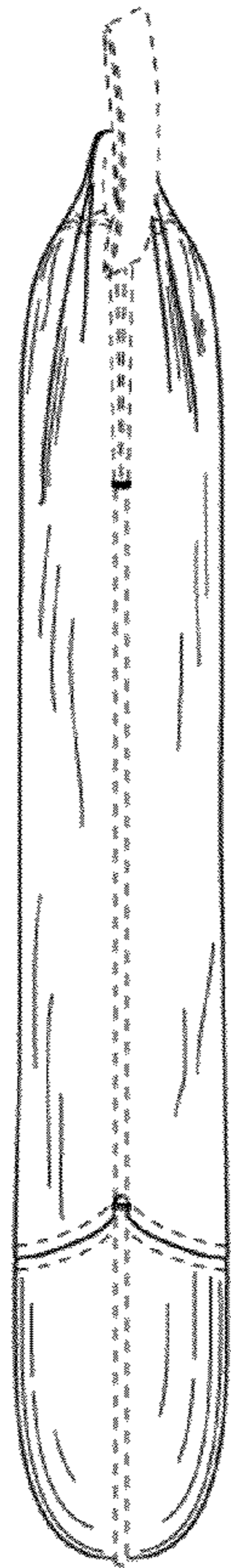

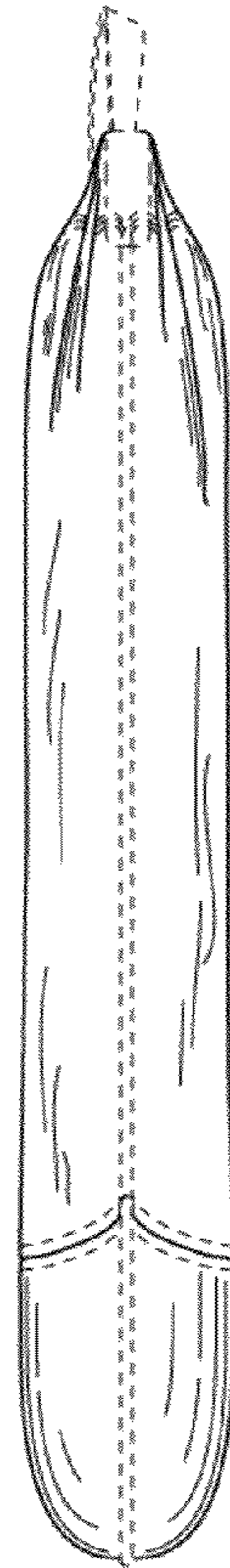

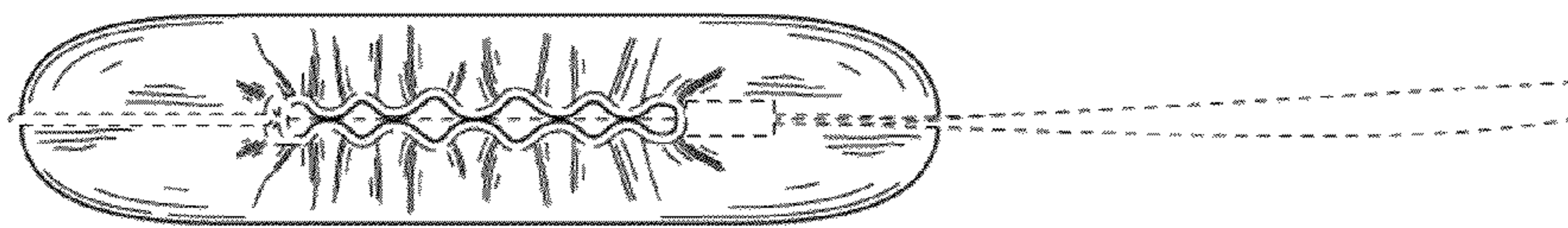

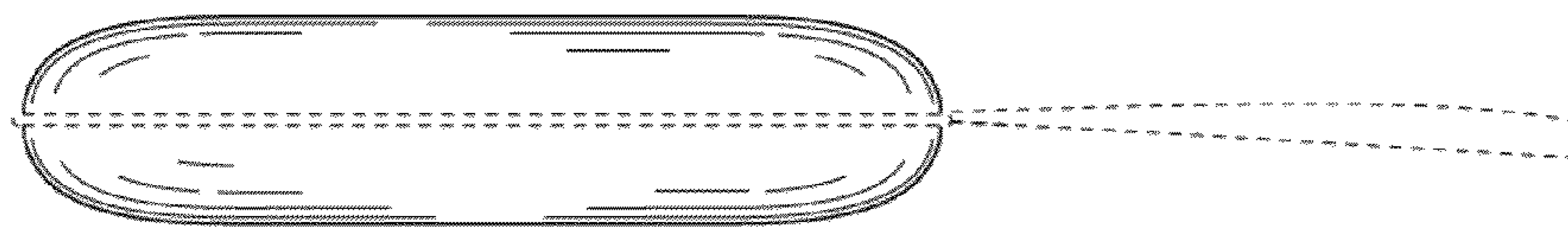

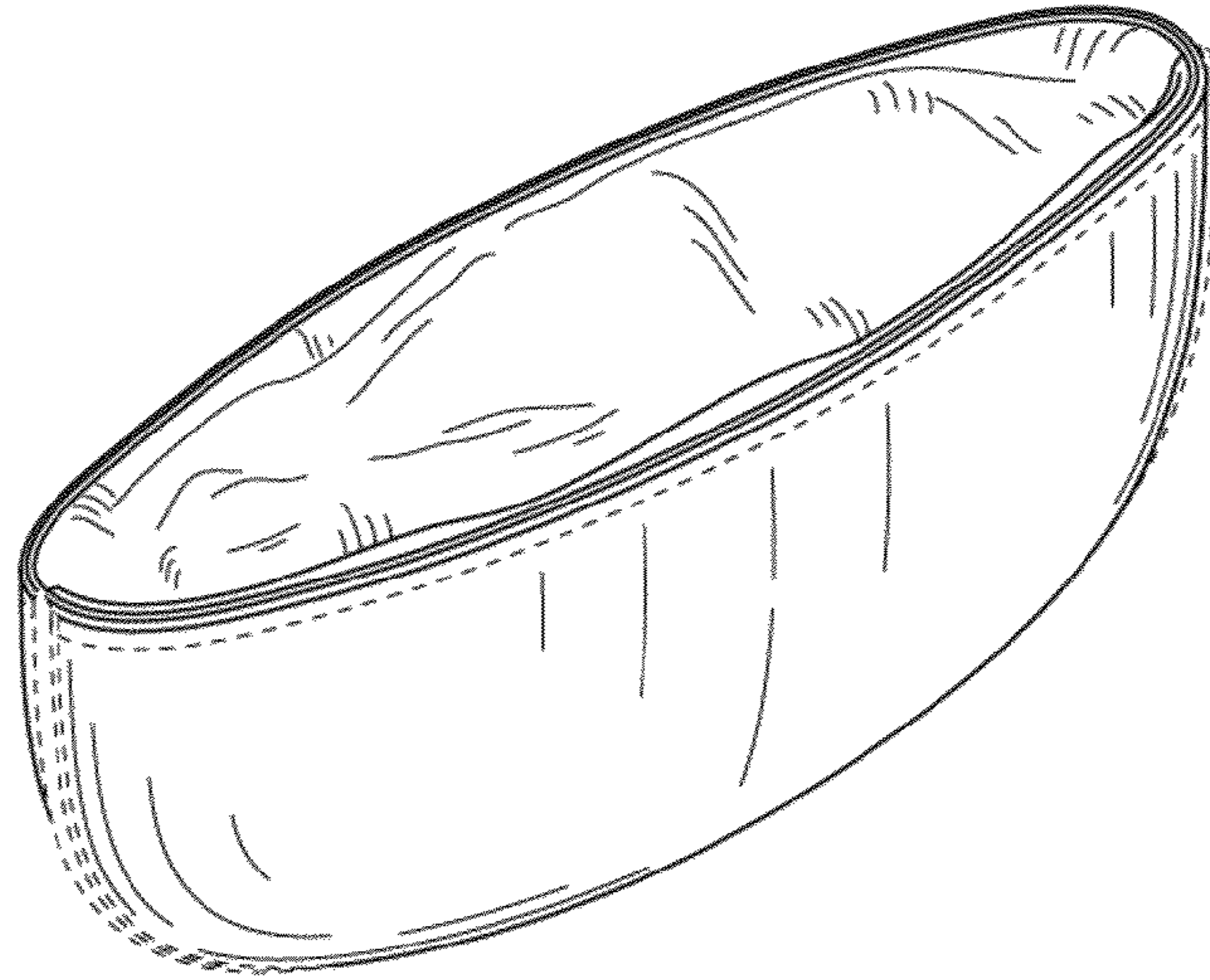

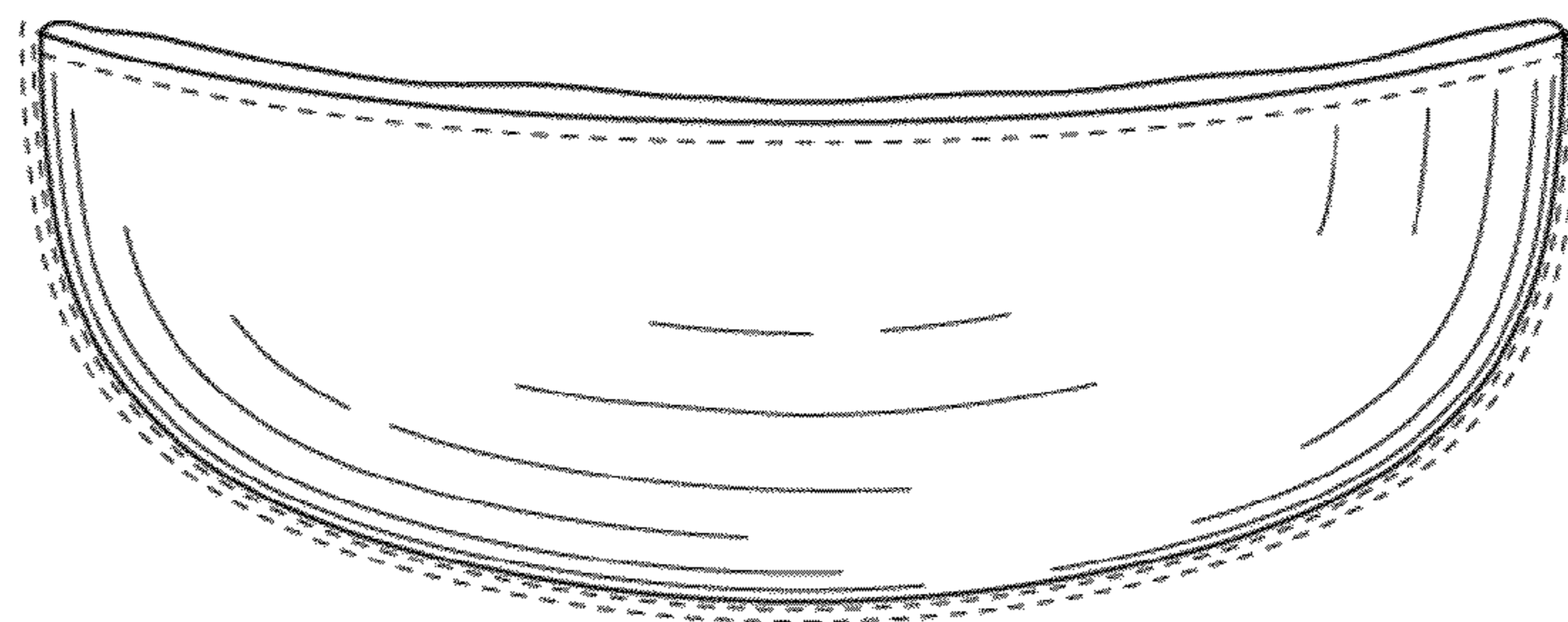

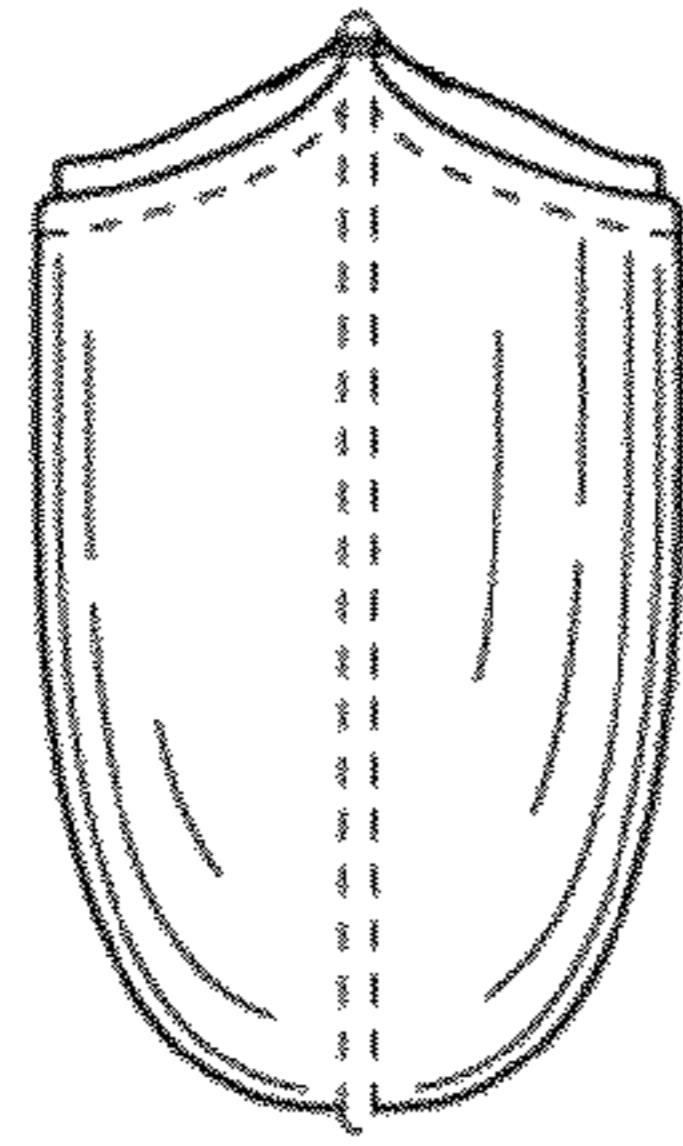

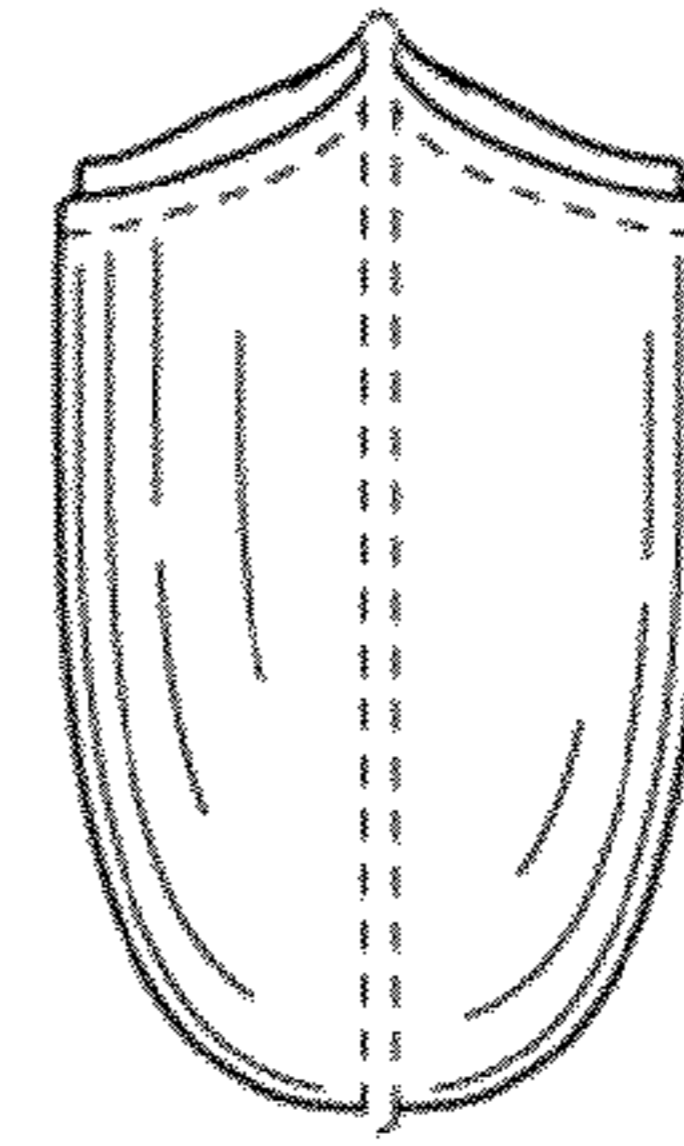

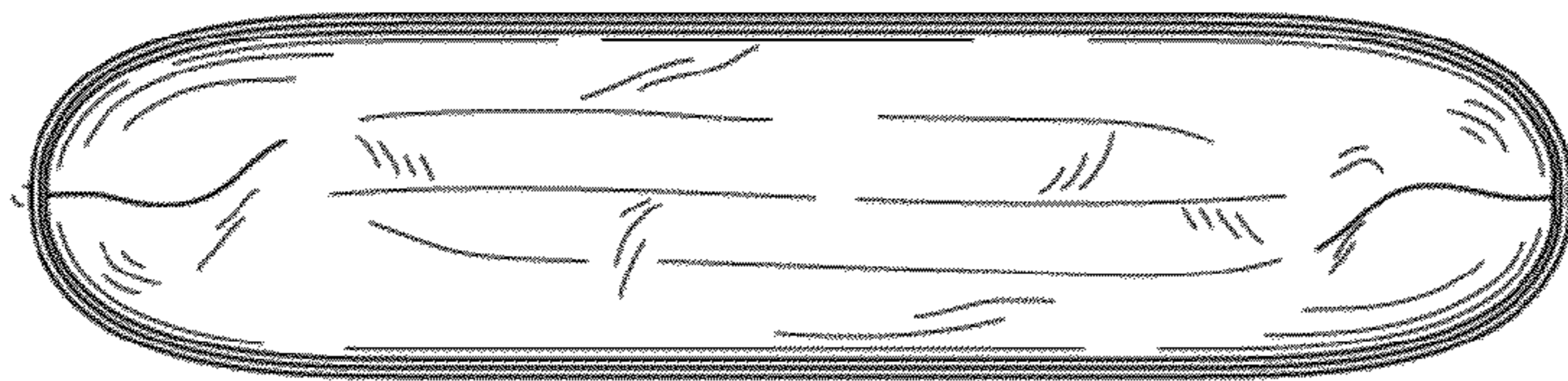

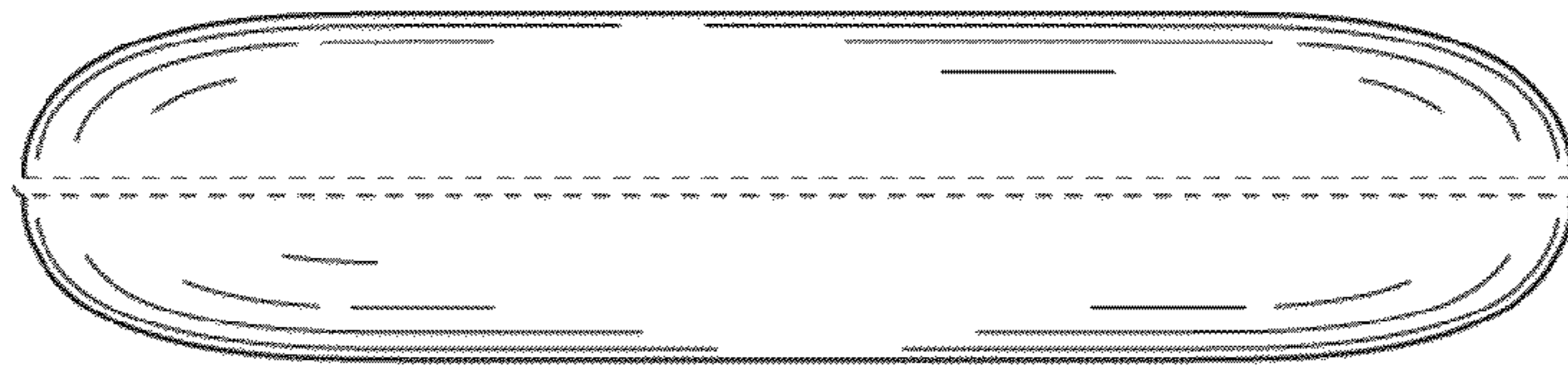
