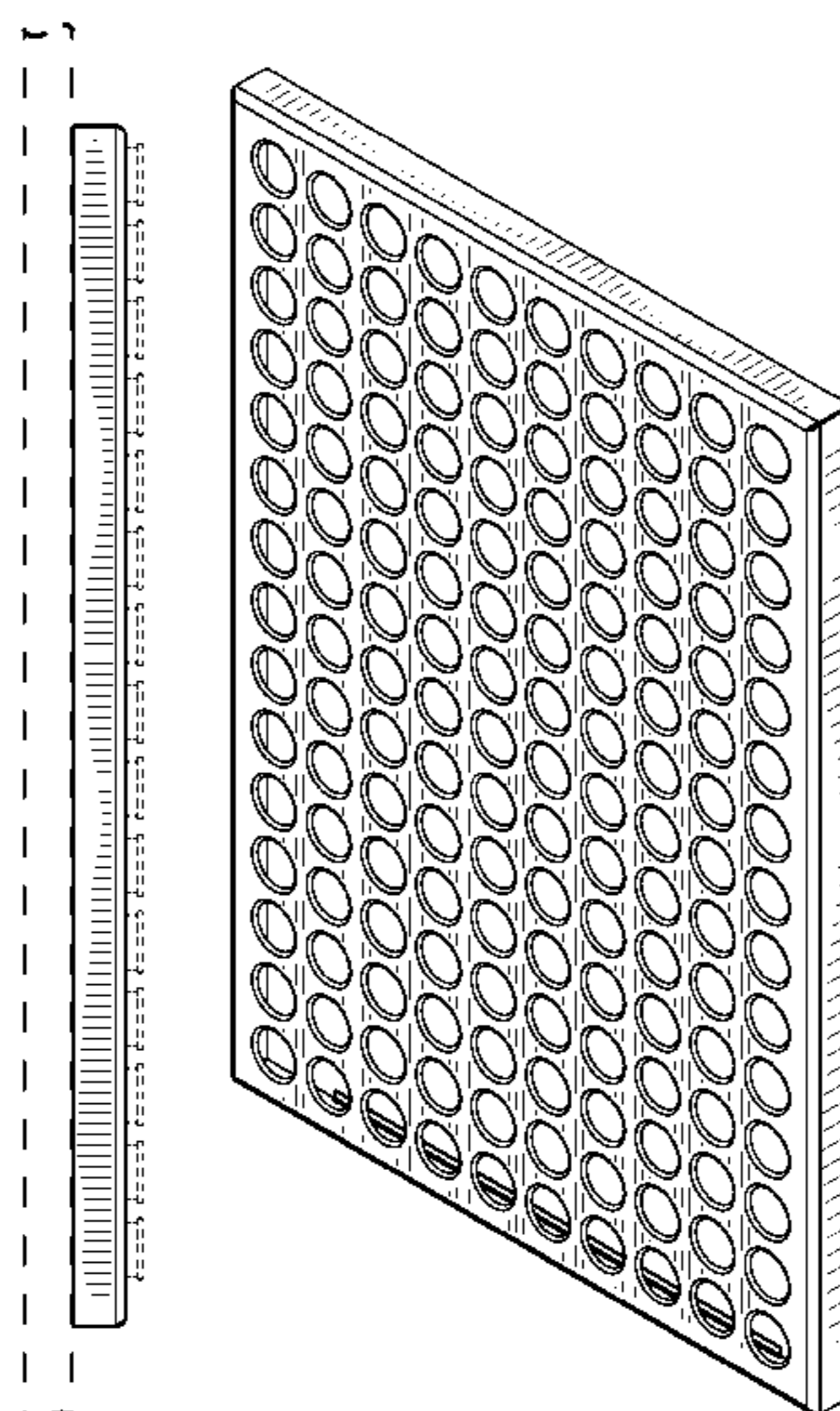
(57) **CLAIM**

We claim the ornamental design for a holder for coffee k-cup, as shown and described.

**DESCRIPTION**

FIG. 1 is a right-side elevational view of a holder for coffee k-cup showing our new design;  
FIG. 2 is a front perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a left-side elevational view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The broken lines in FIG. 1 showing a wall and coffee k-cups of the holder for coffee k-cup are for the purpose of illustrating environment, and form no part of the claimed design.

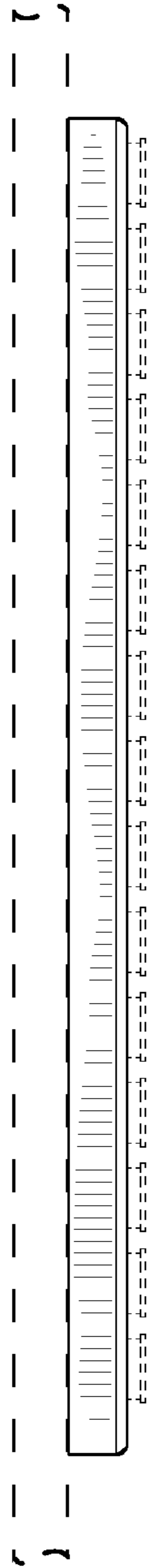

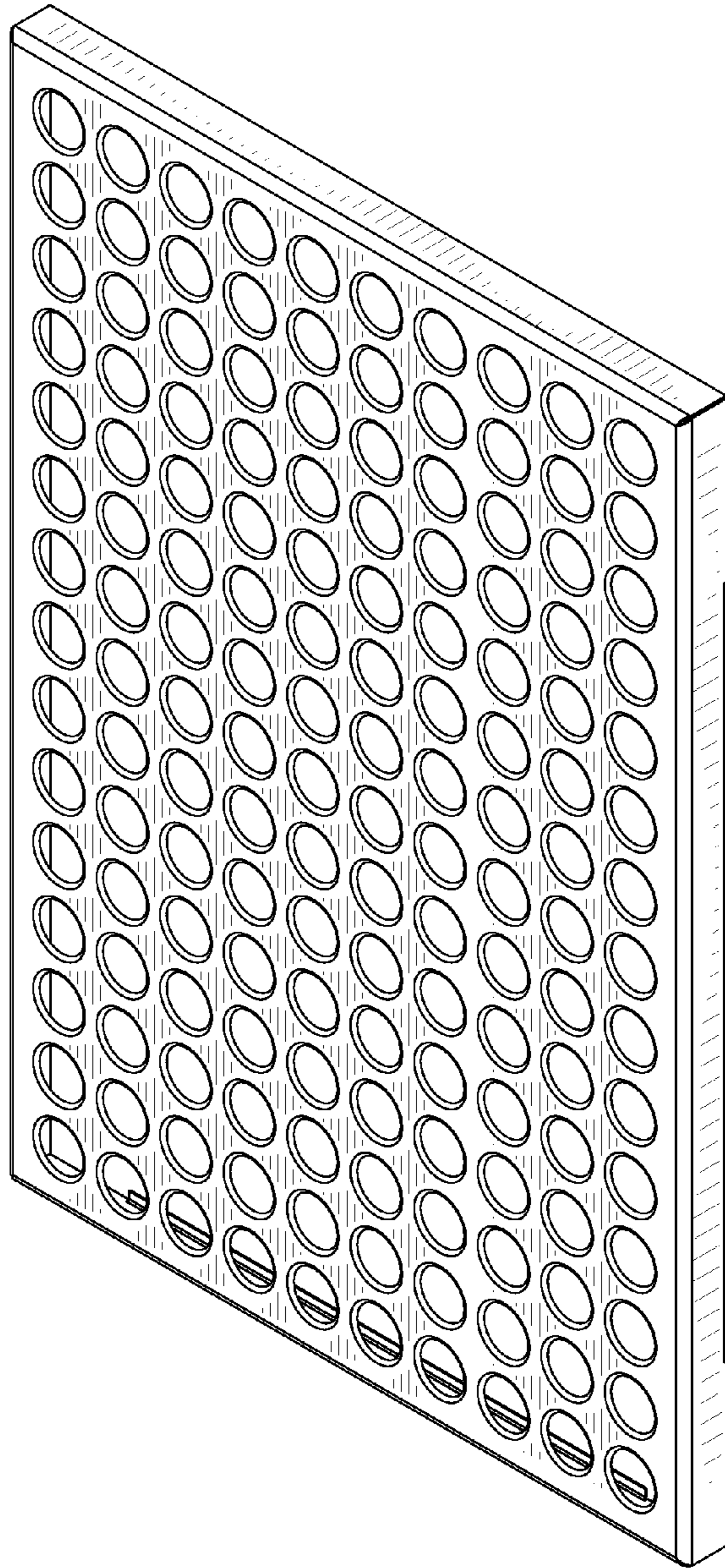

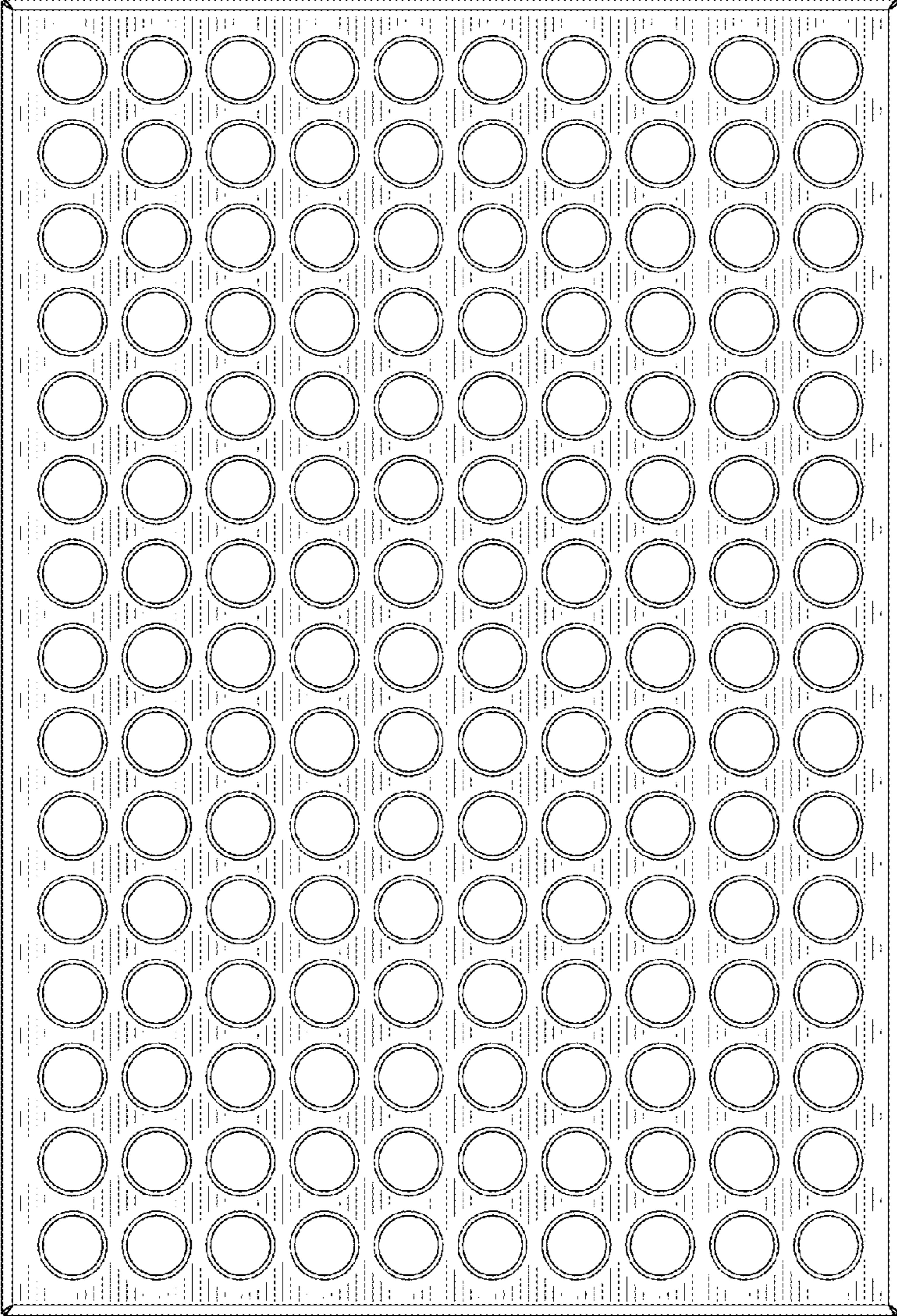

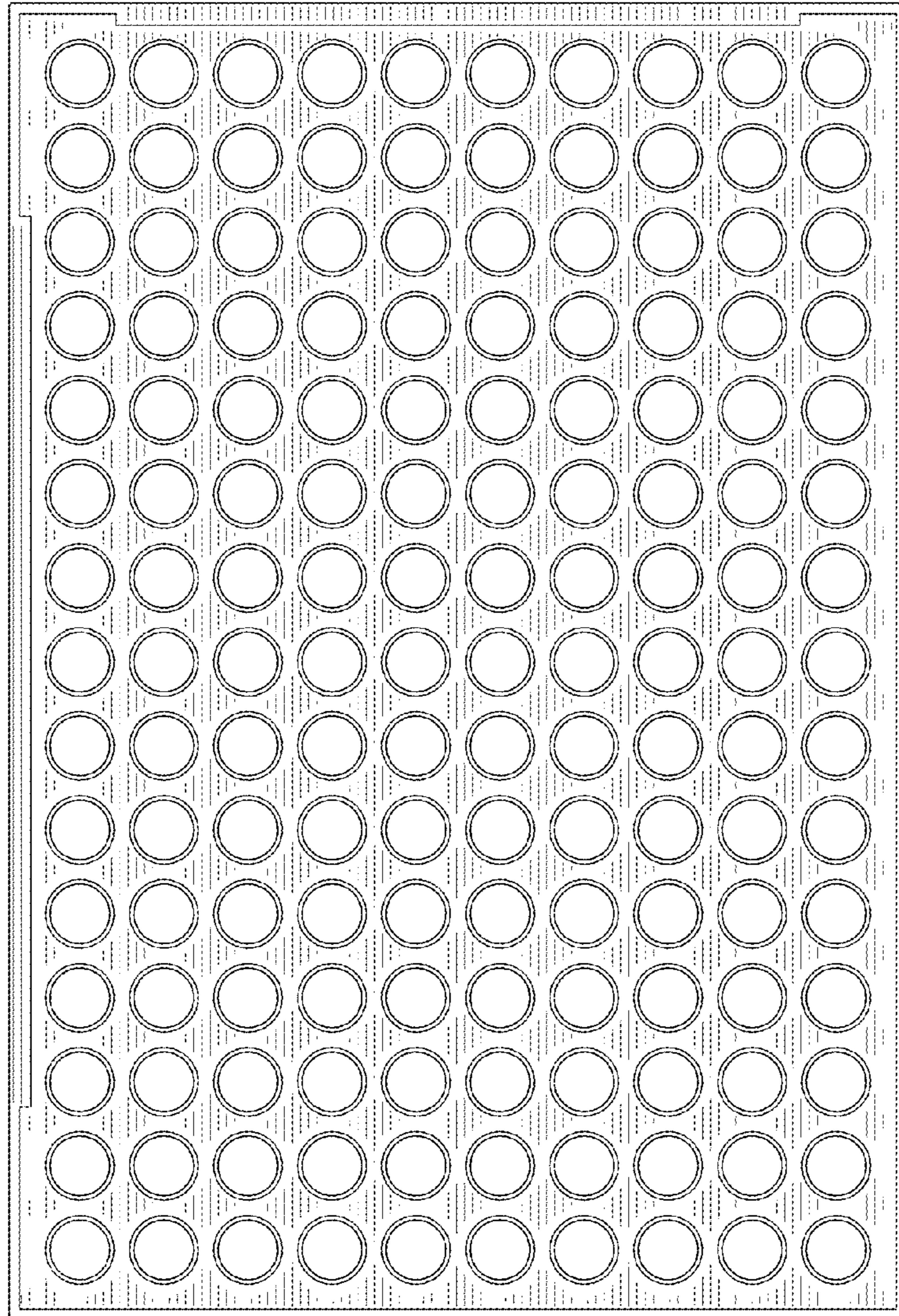

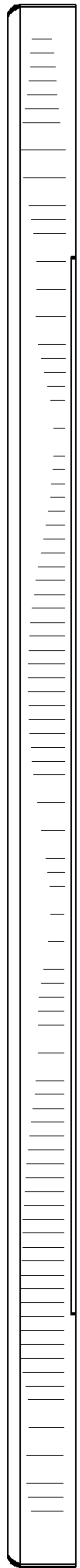

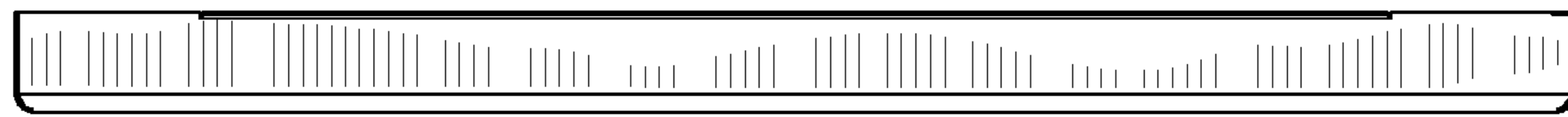

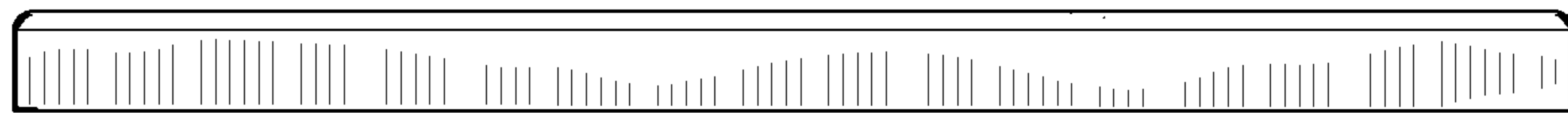
