FIG. 3 is a left side view of the packaging;

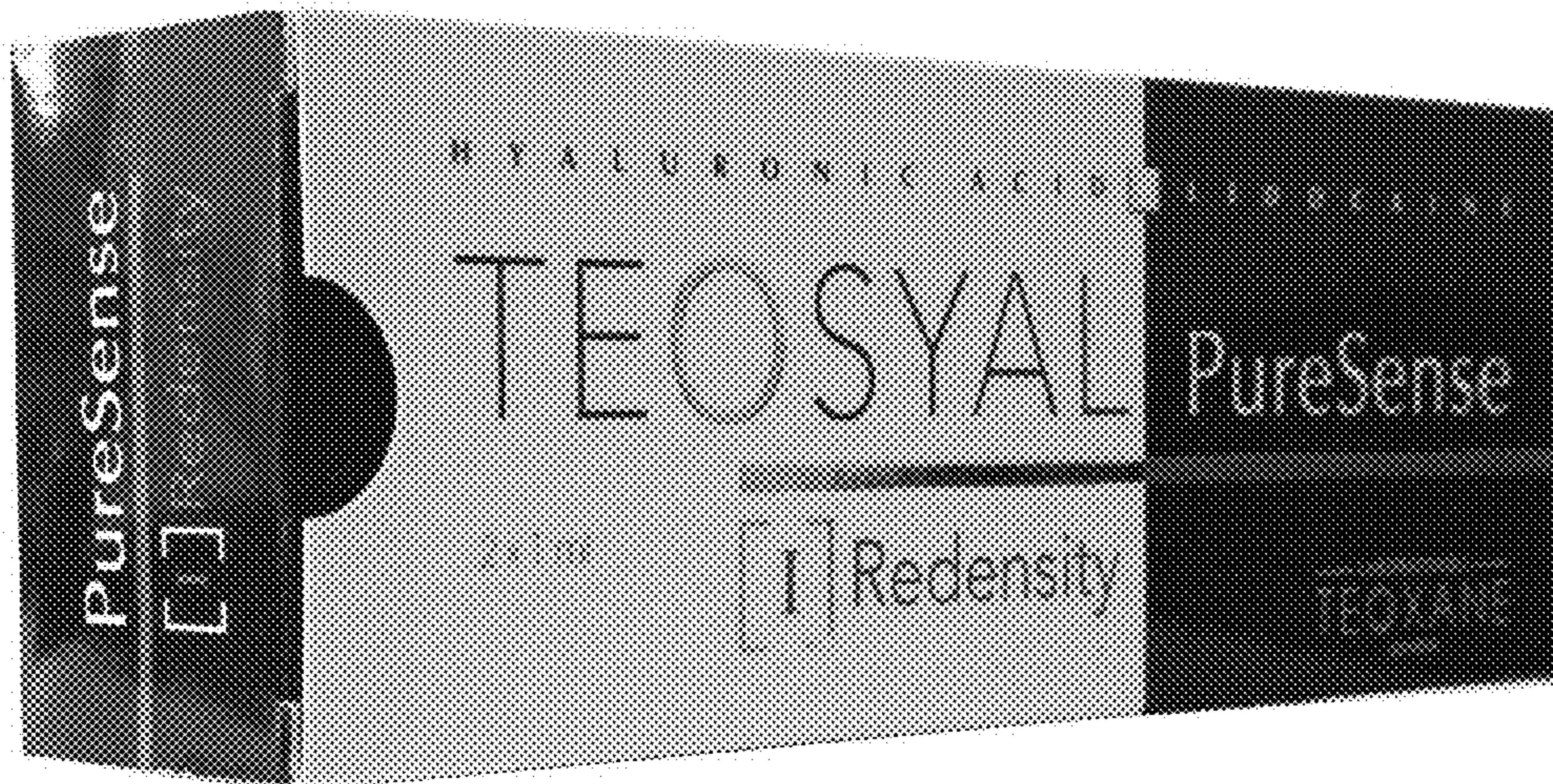
FIG. 4 is a right side view of the packaging;

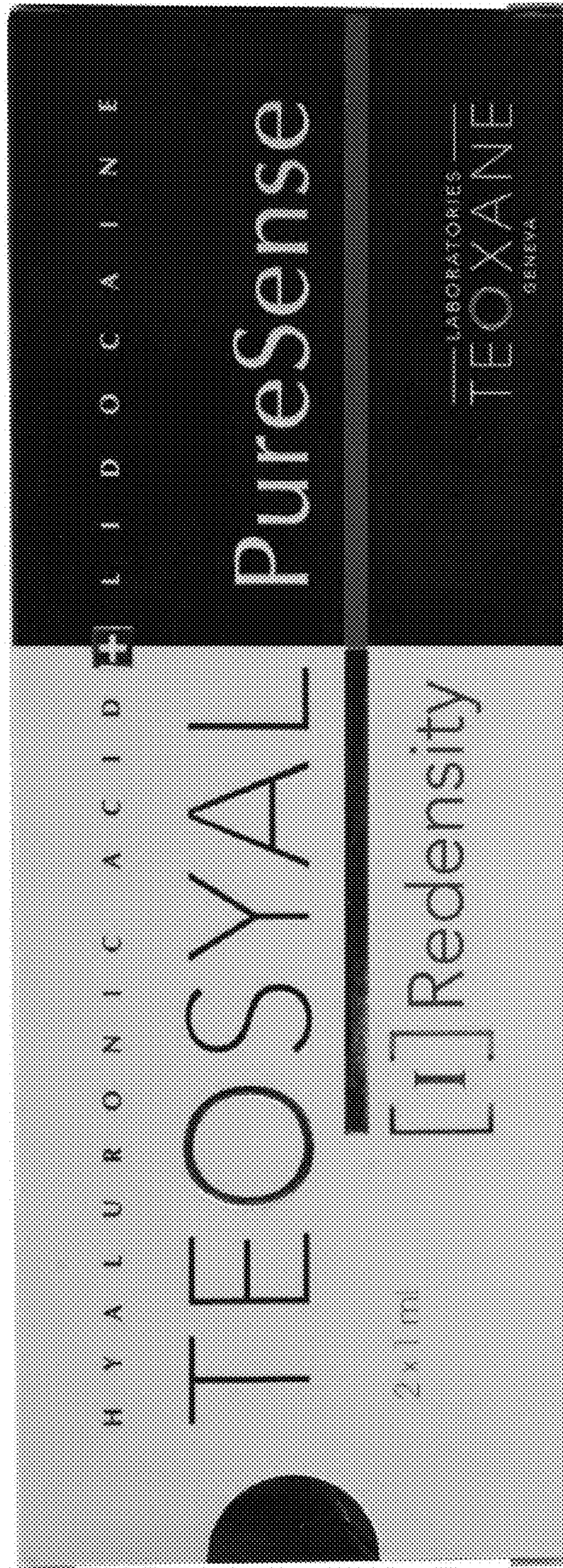

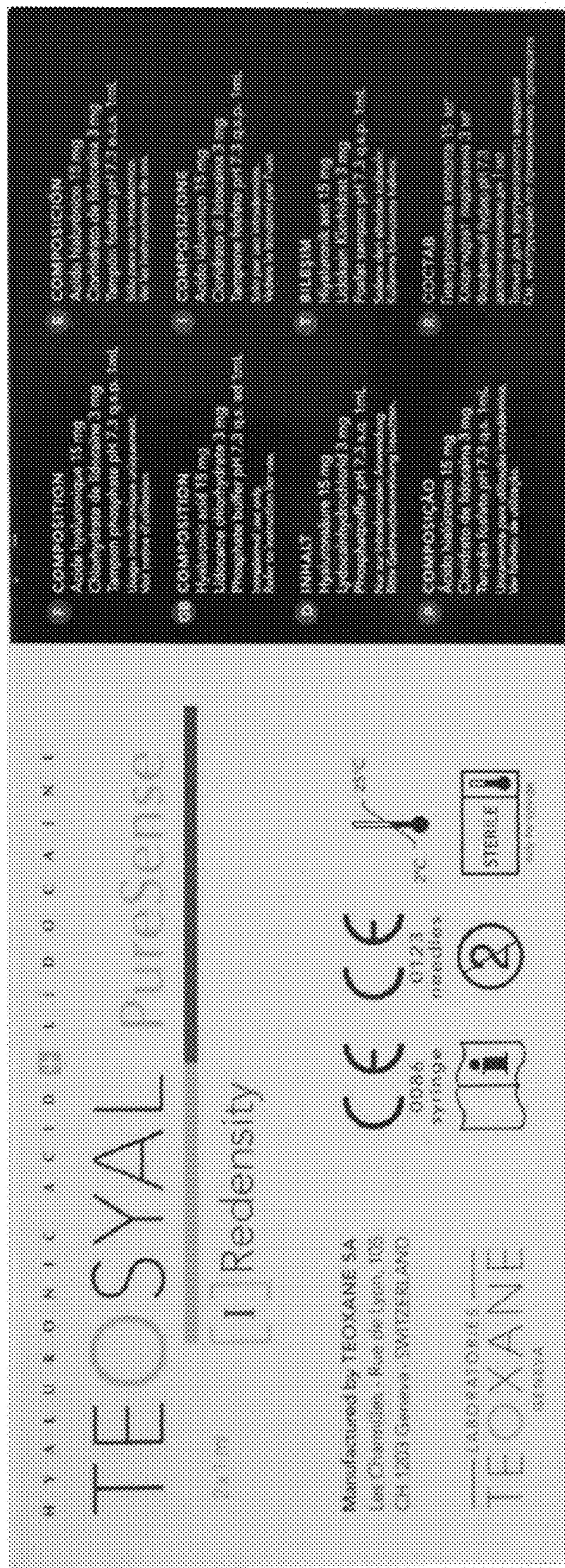

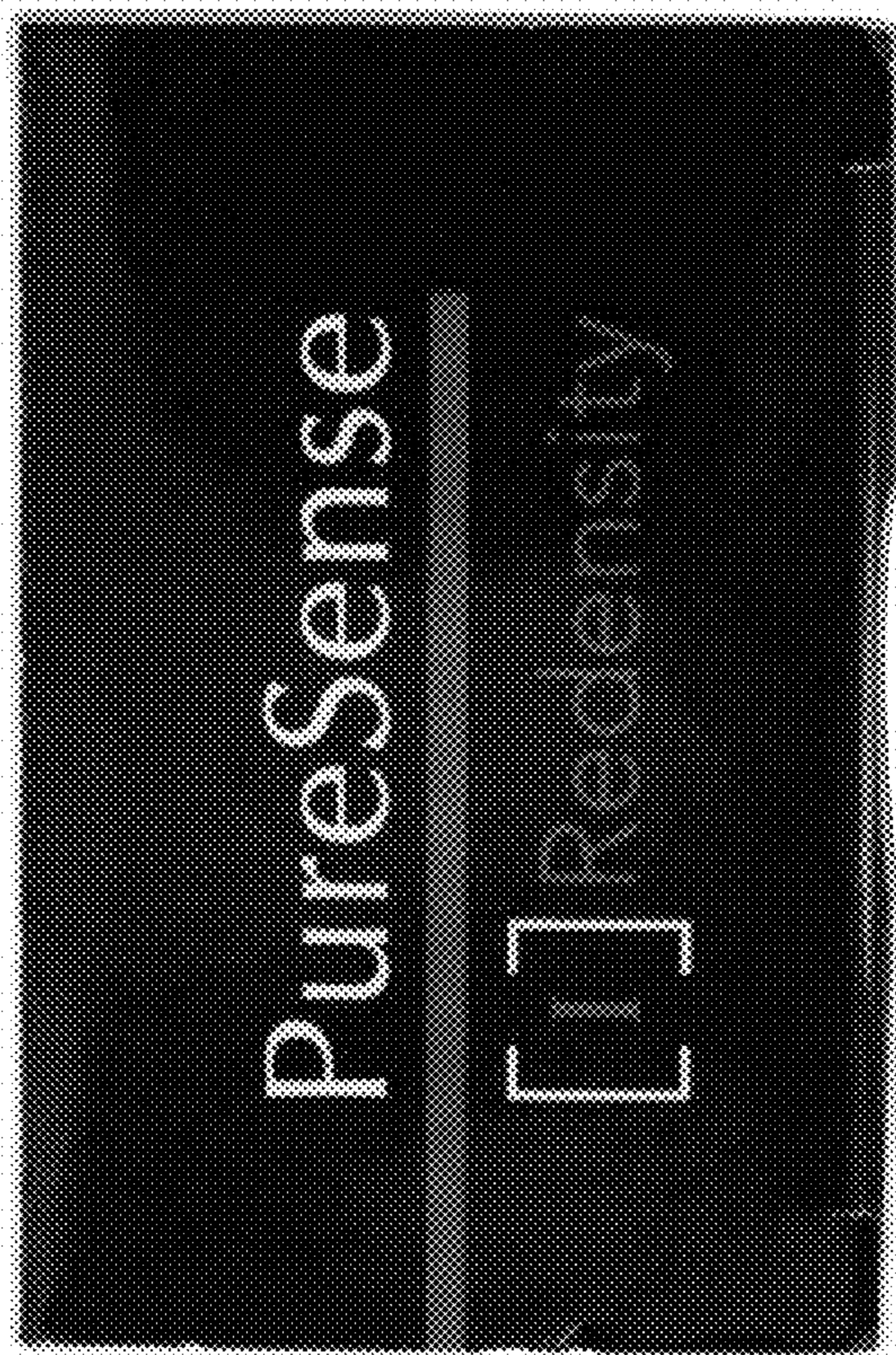

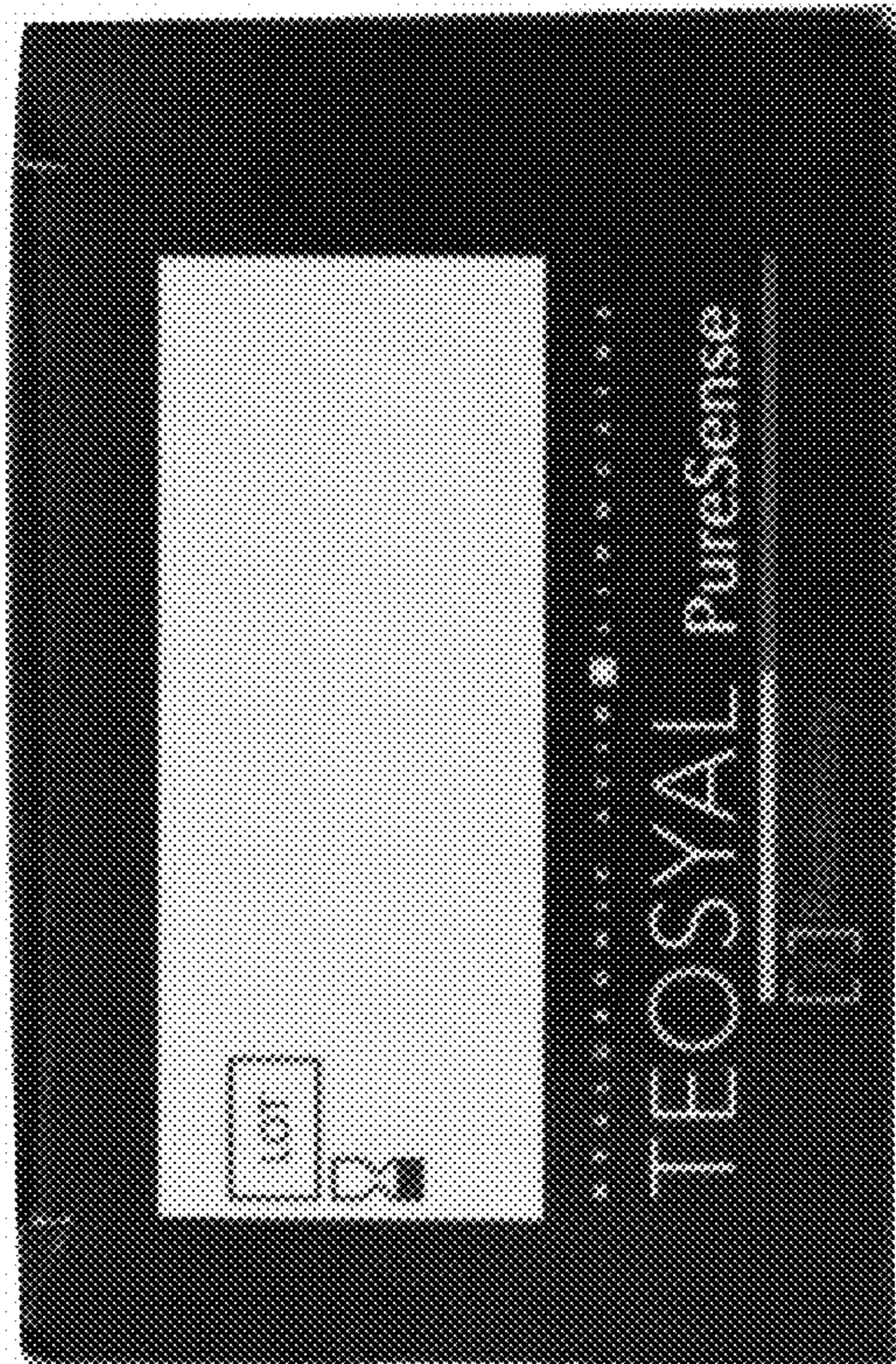

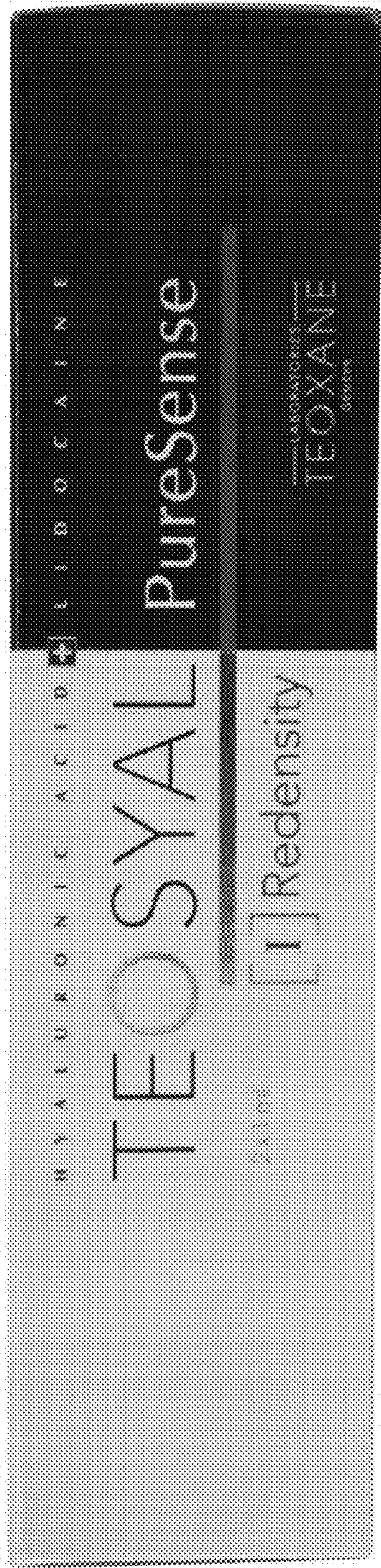

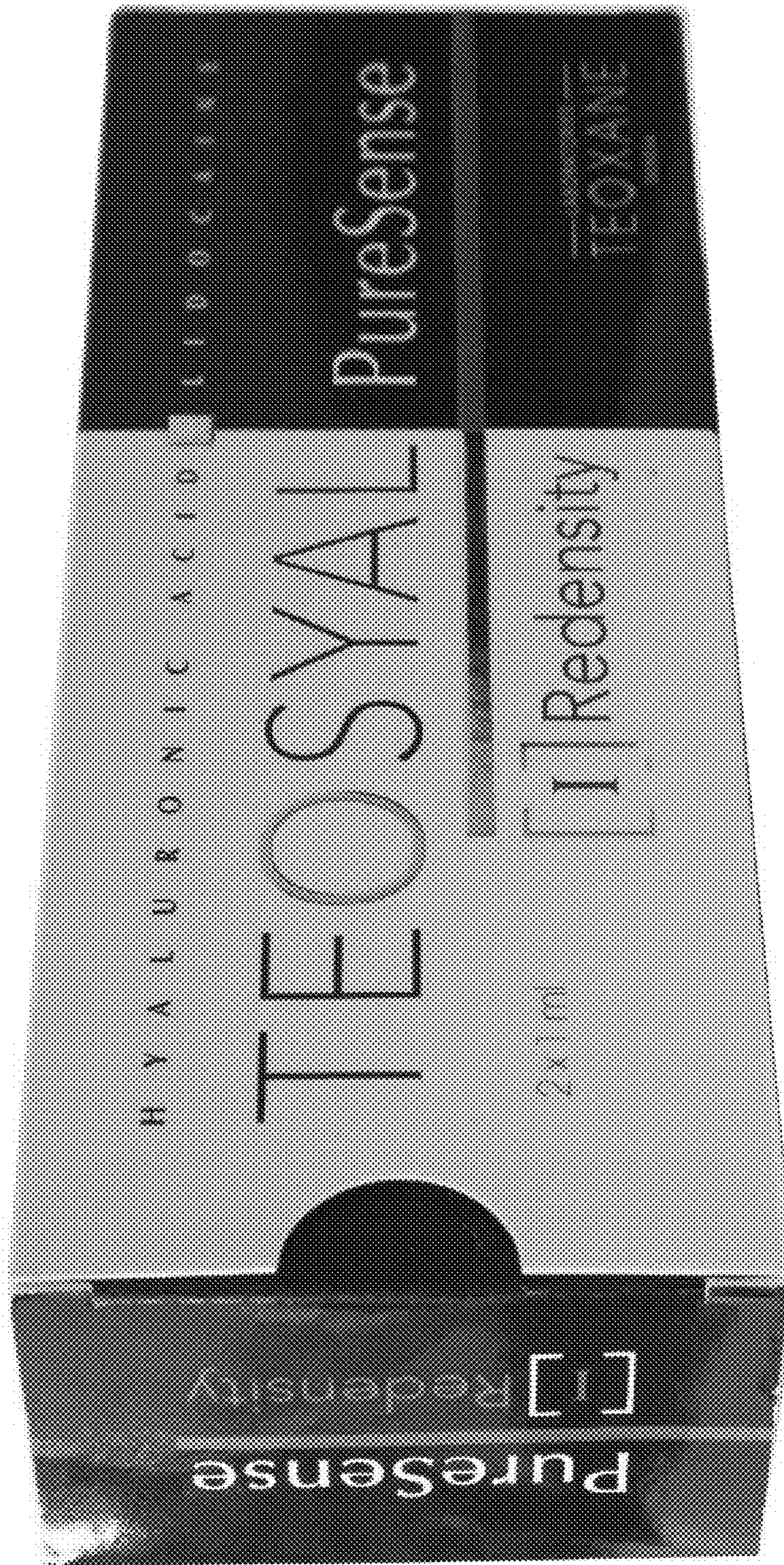
