(57) **CLAIM**

The ornamental design for an automobile, toy replica and/or other replicas, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the front left side of a first embodiment of an automobile, toy replica and/or other replicas.

FIG. 2 is a perspective view from the rear left side thereof.

FIG. 3 is a left side elevation view thereof.

FIG. 4 is a right side elevation view thereof.

FIG. 5 is a front elevation view thereof.

FIG. 6 is a rear elevation view thereof; and,

FIG. 7 is a top plan view thereof.

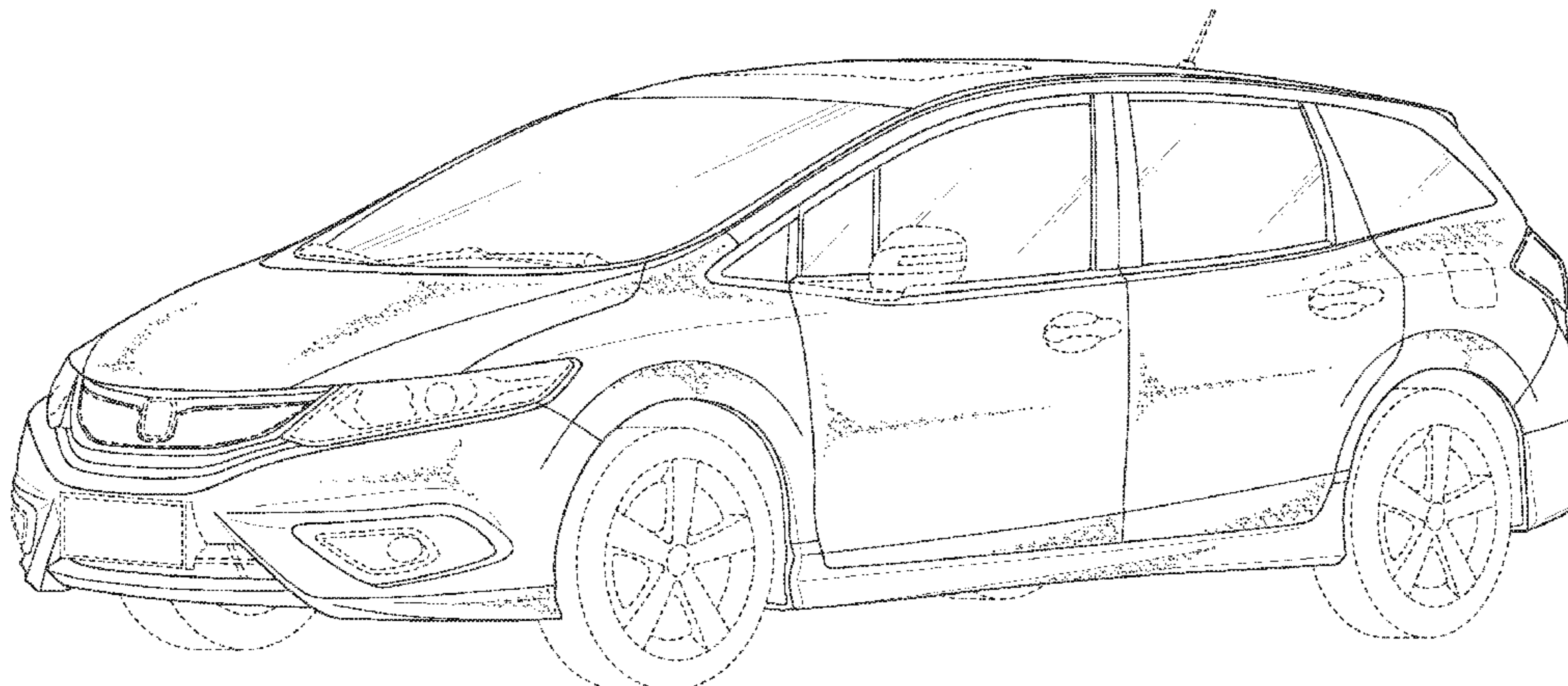

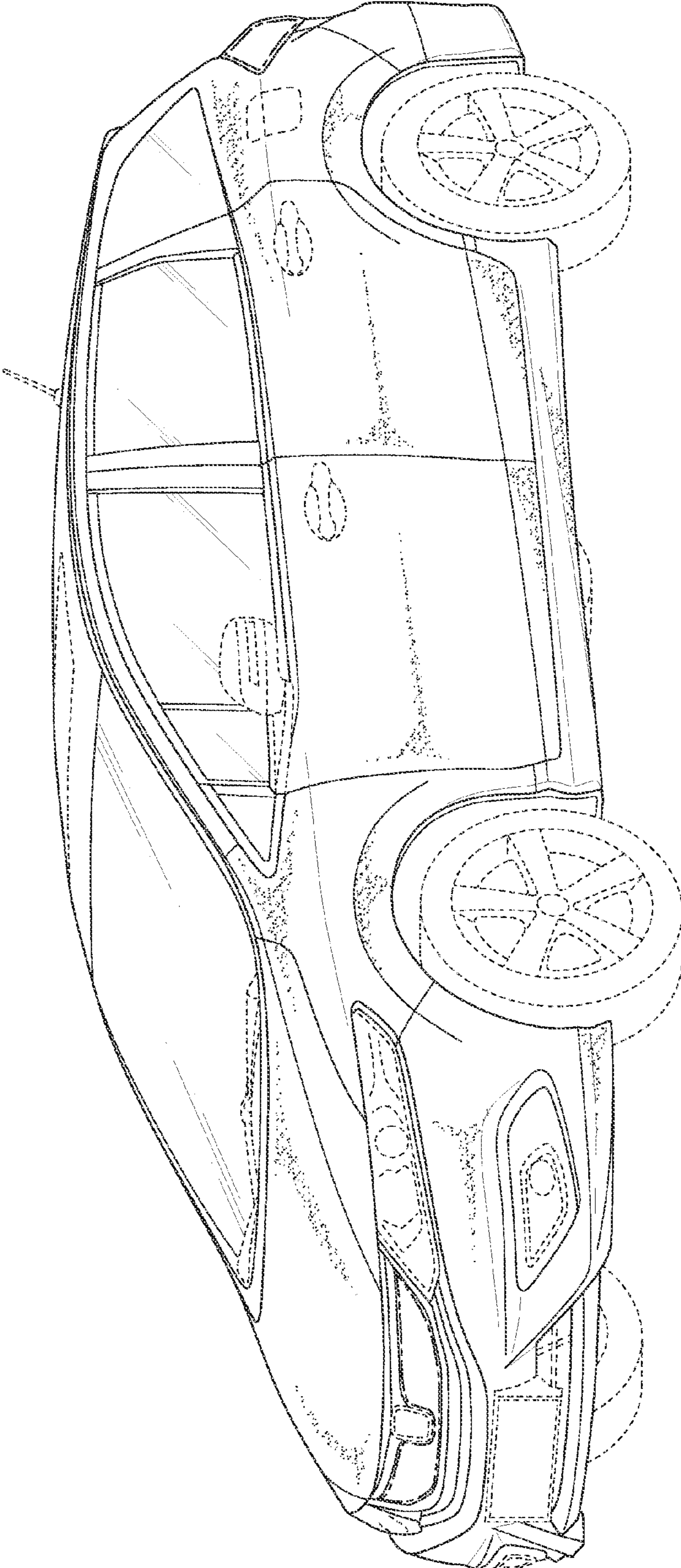

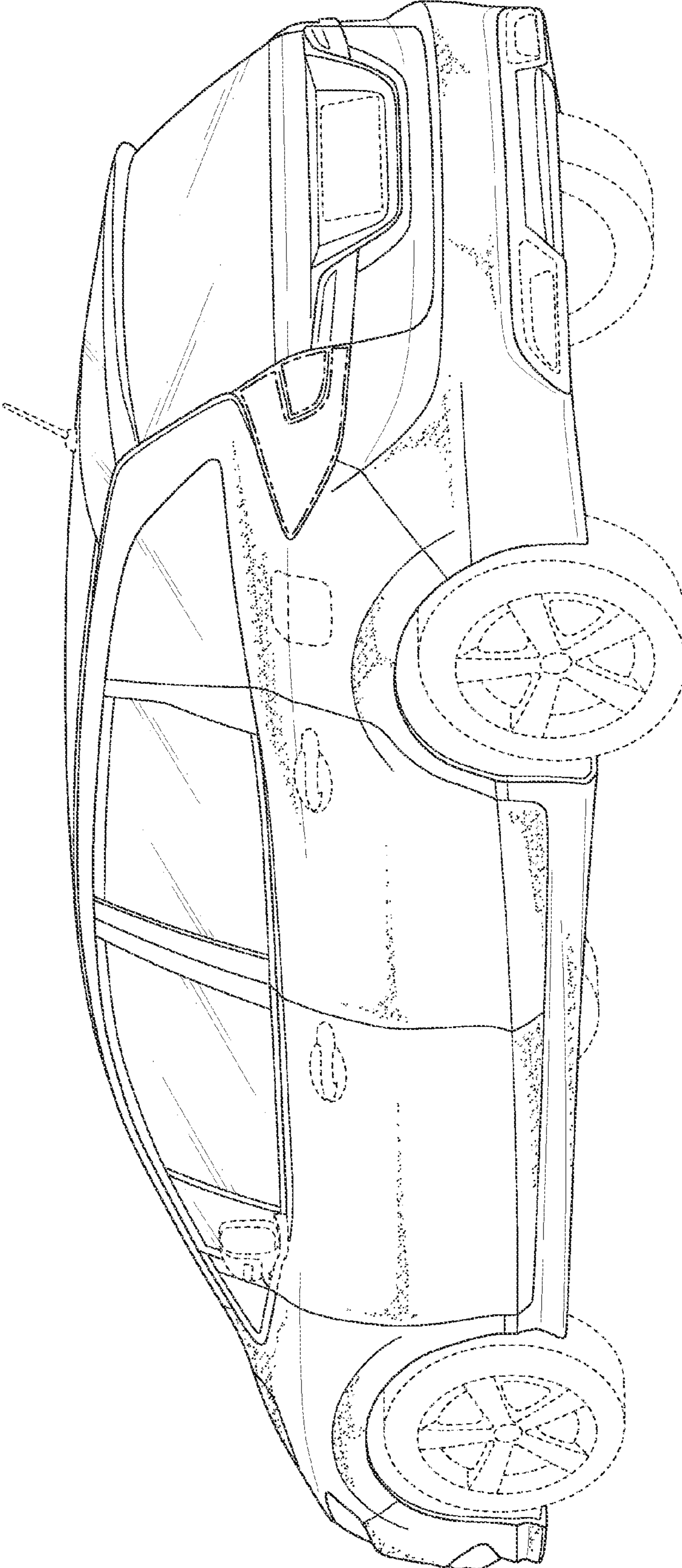

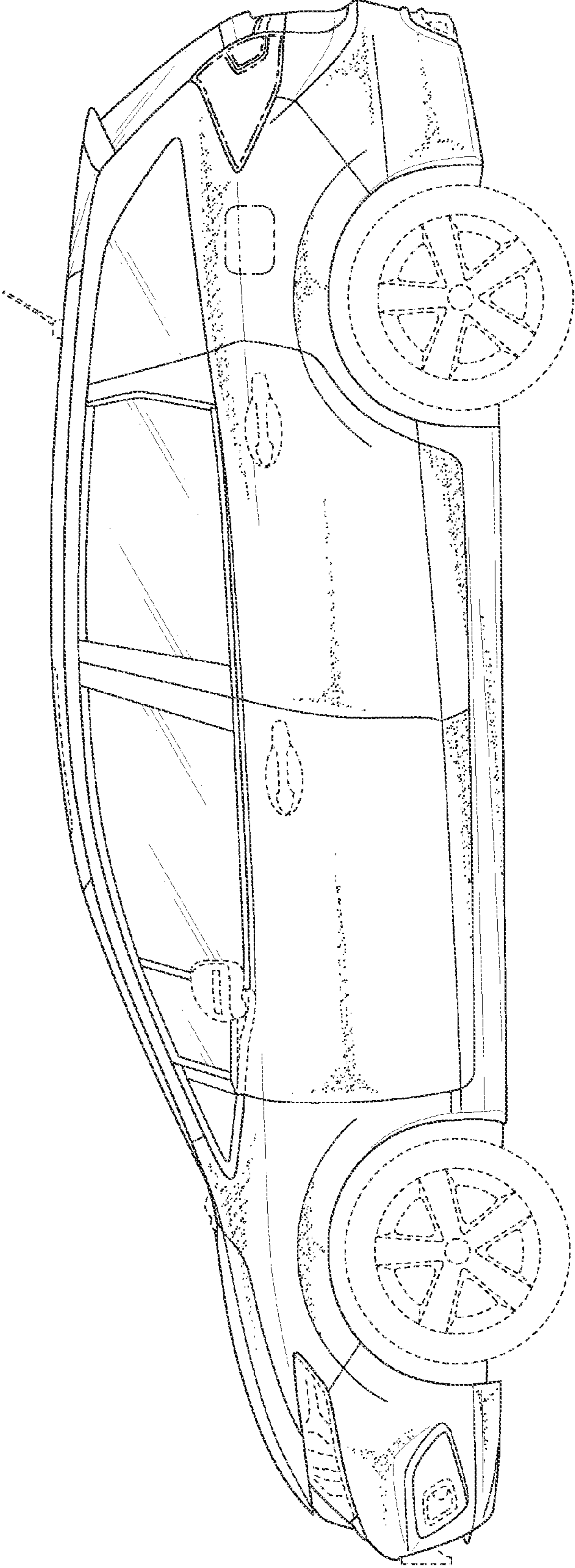

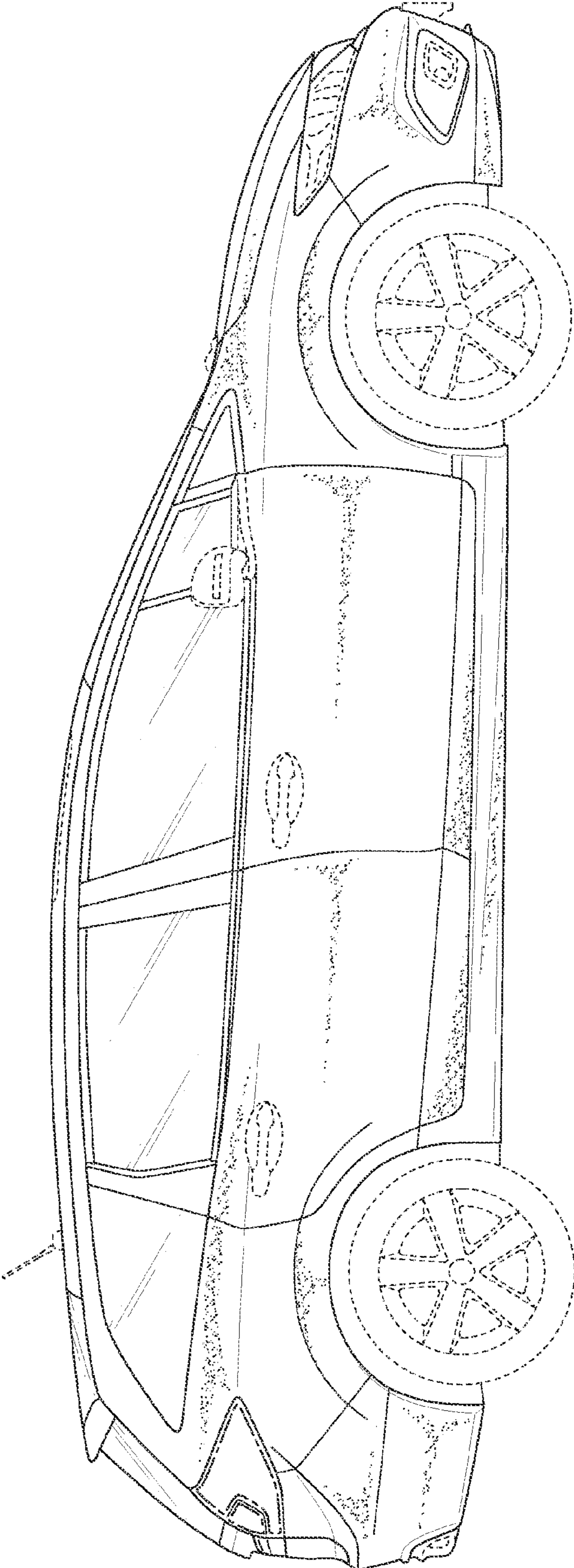

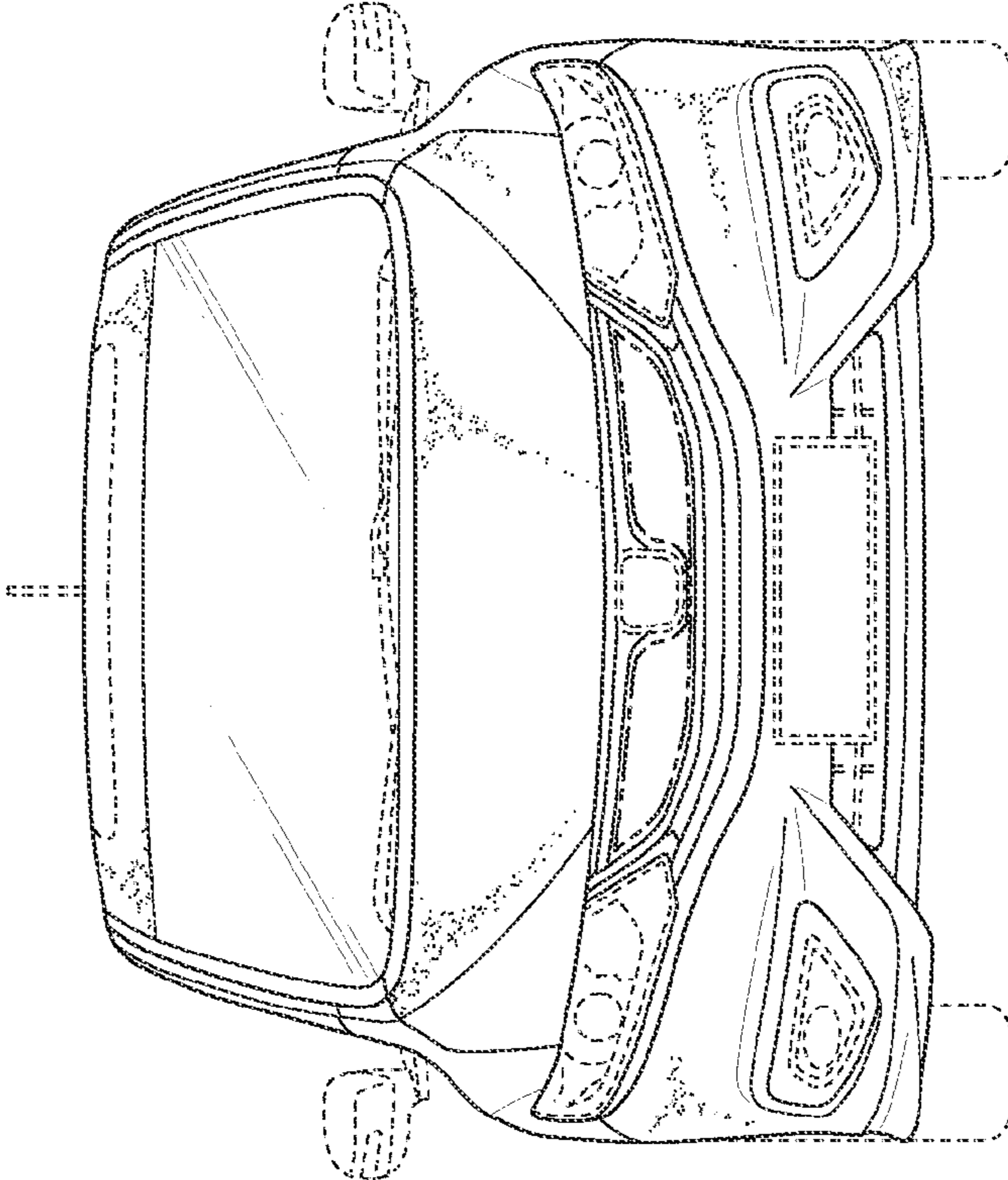

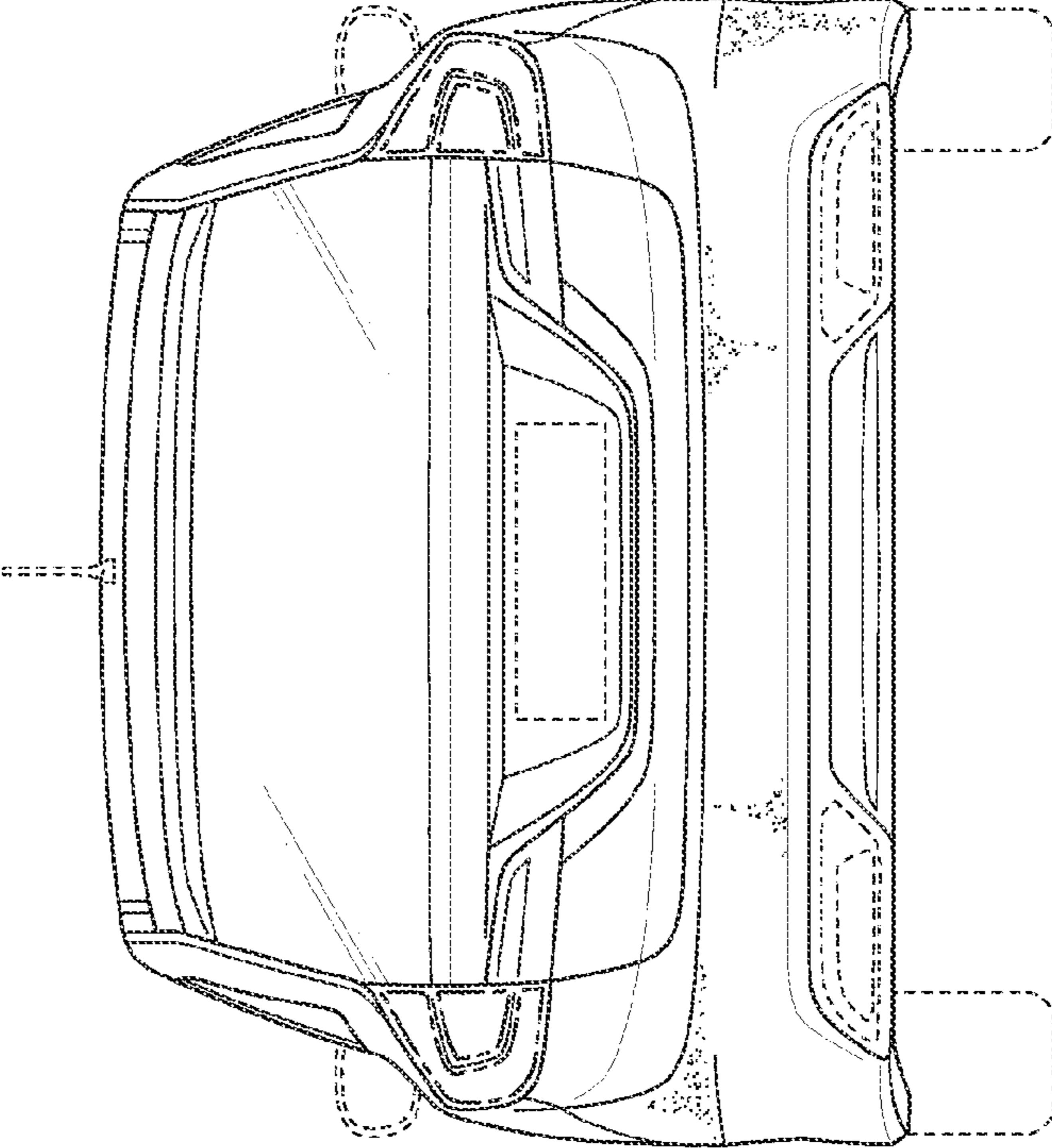
