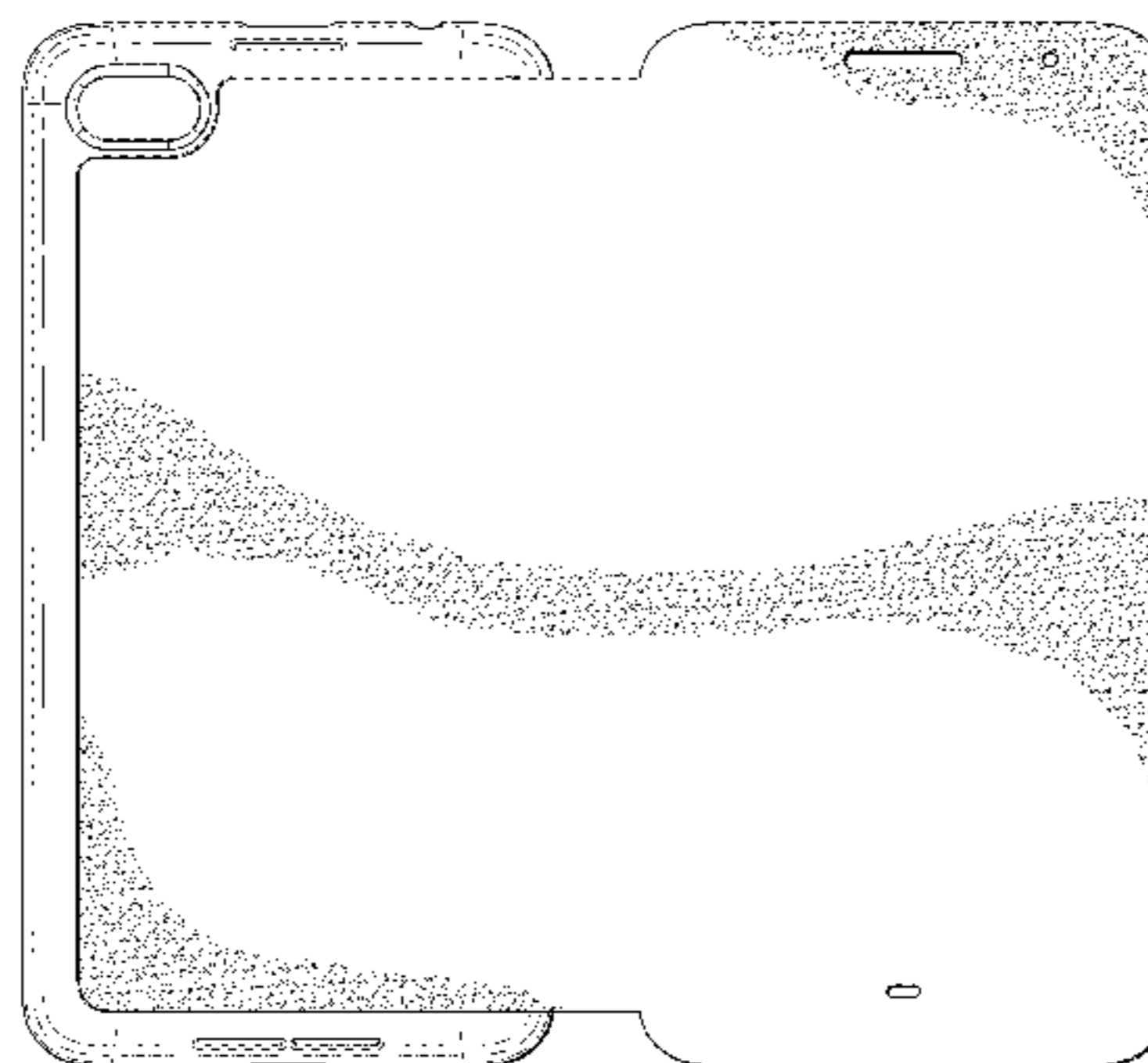
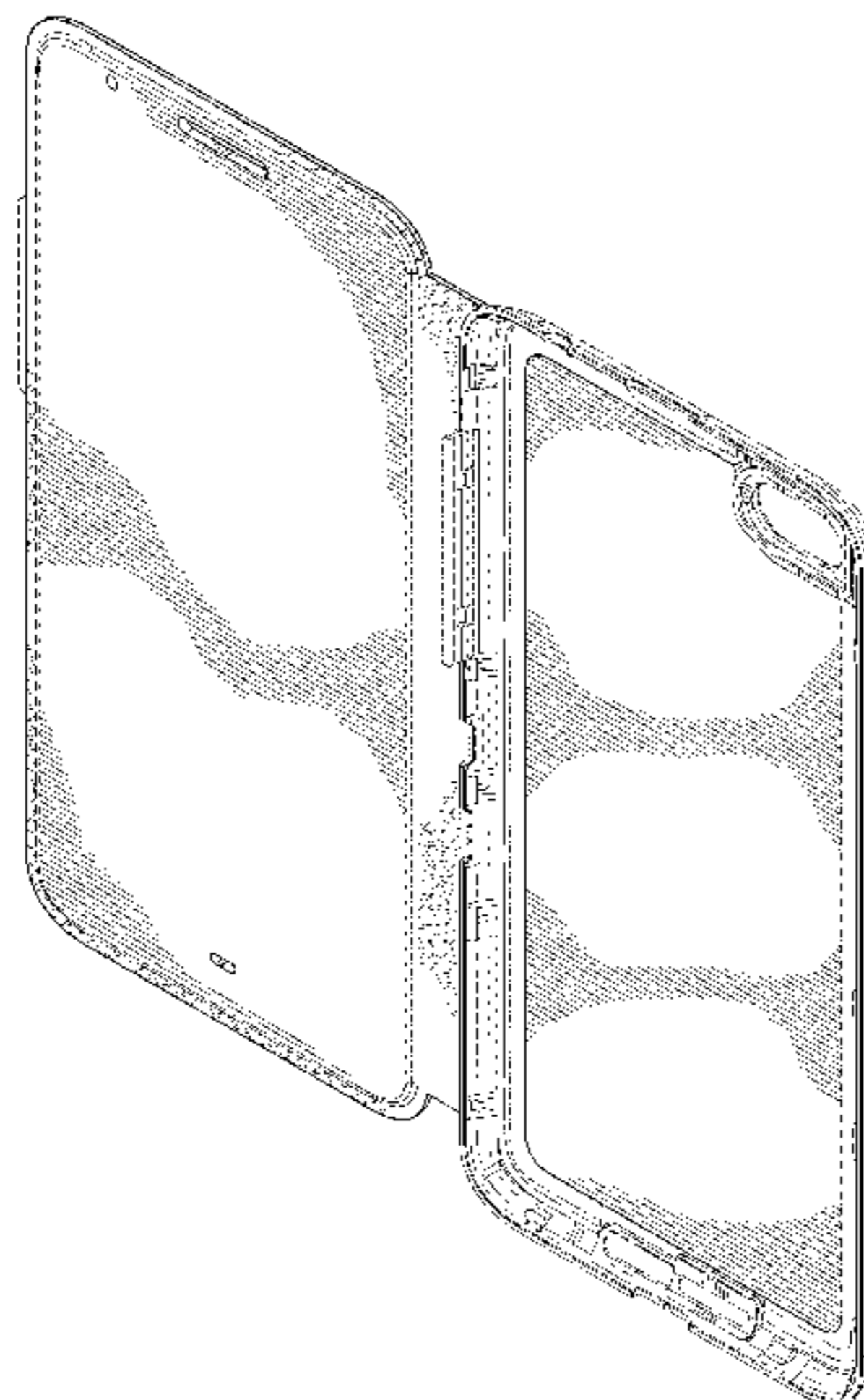
(57) **CLAIM**

The ornamental design for an electronic device case with flip cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an electronic device case with flip cover;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a right side elevation view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
Broken lines shown in the drawings illustrate environment that forms no part of the claimed design. The stippling and linear shading show contrast between surfaces.

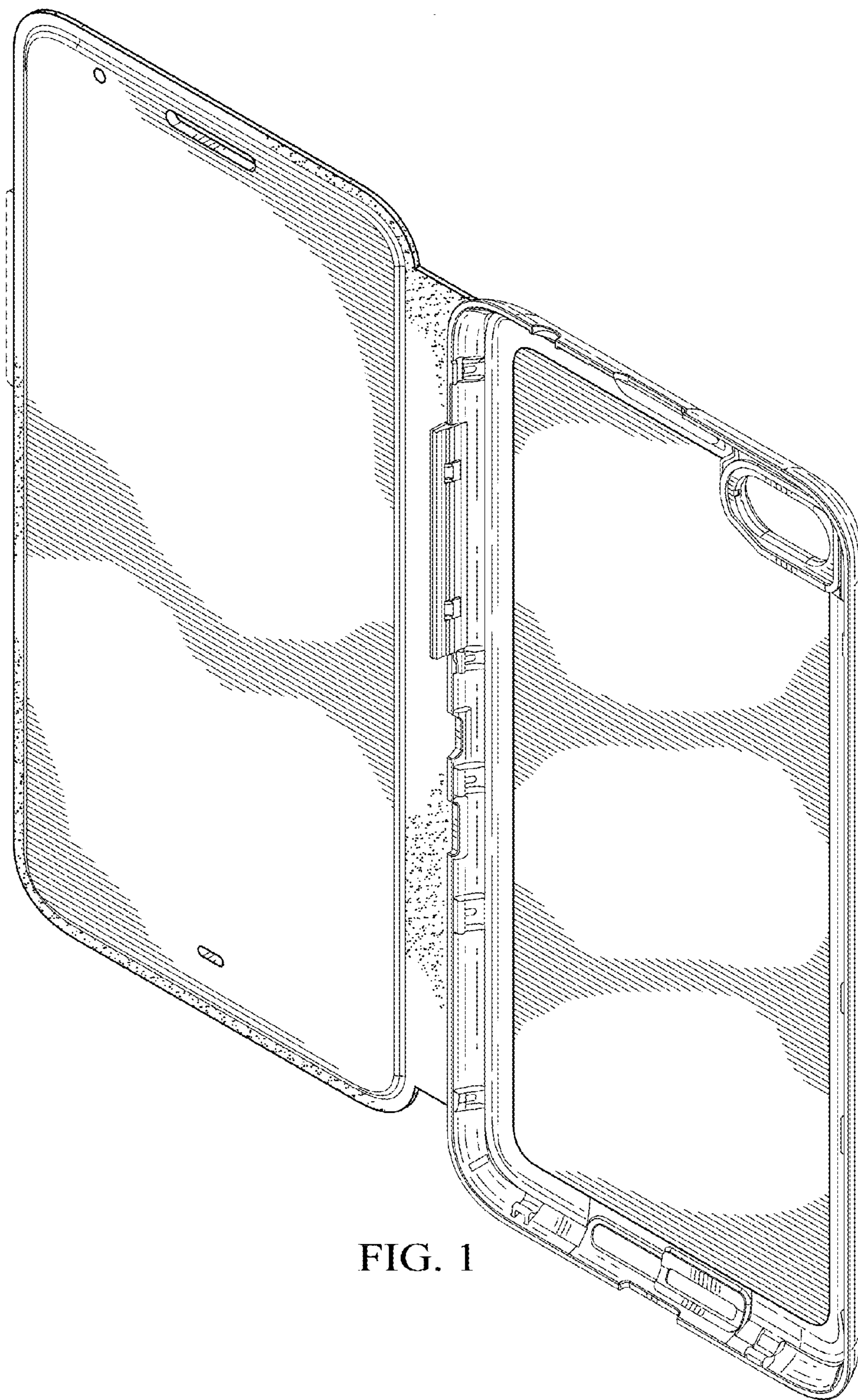

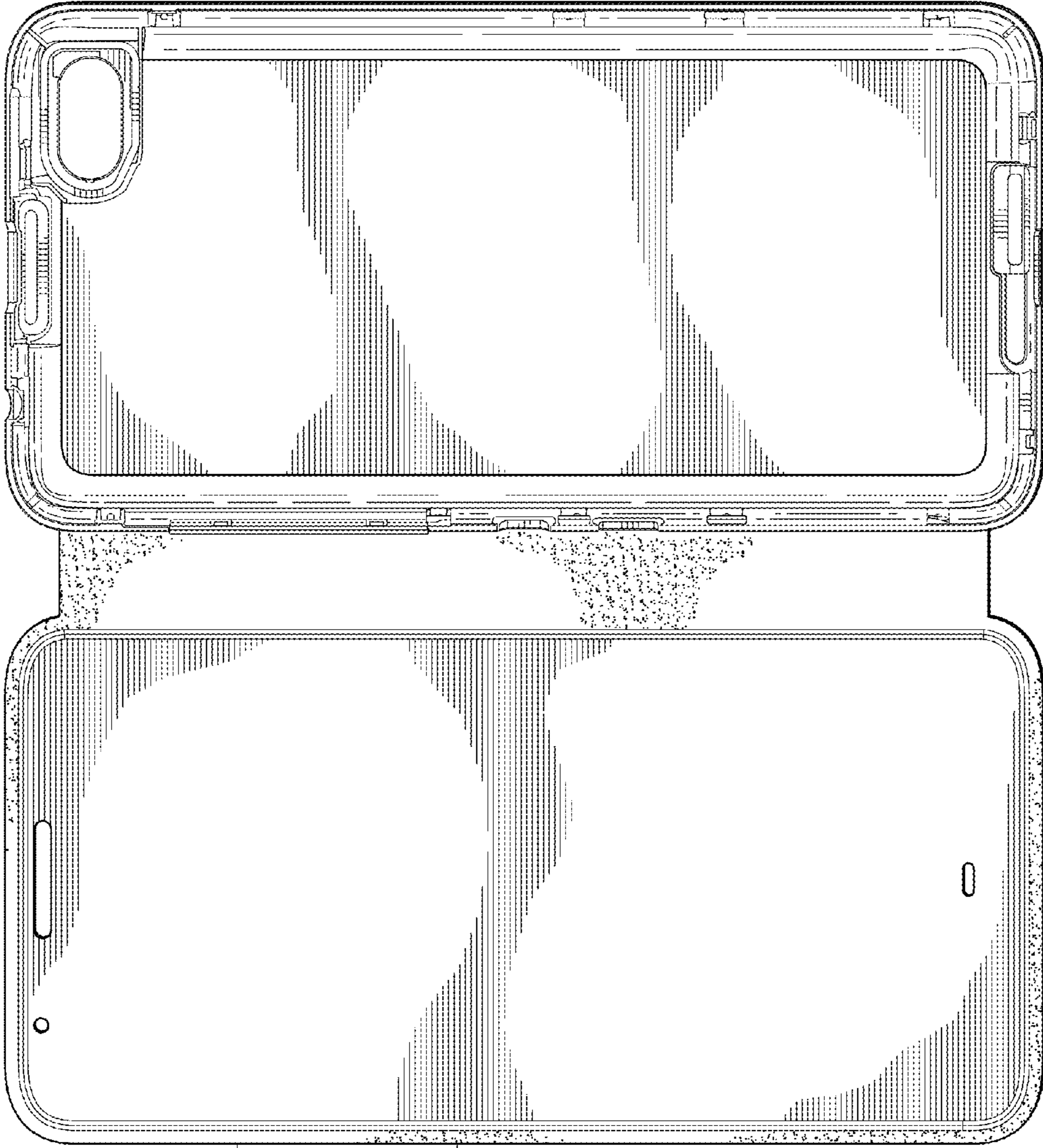

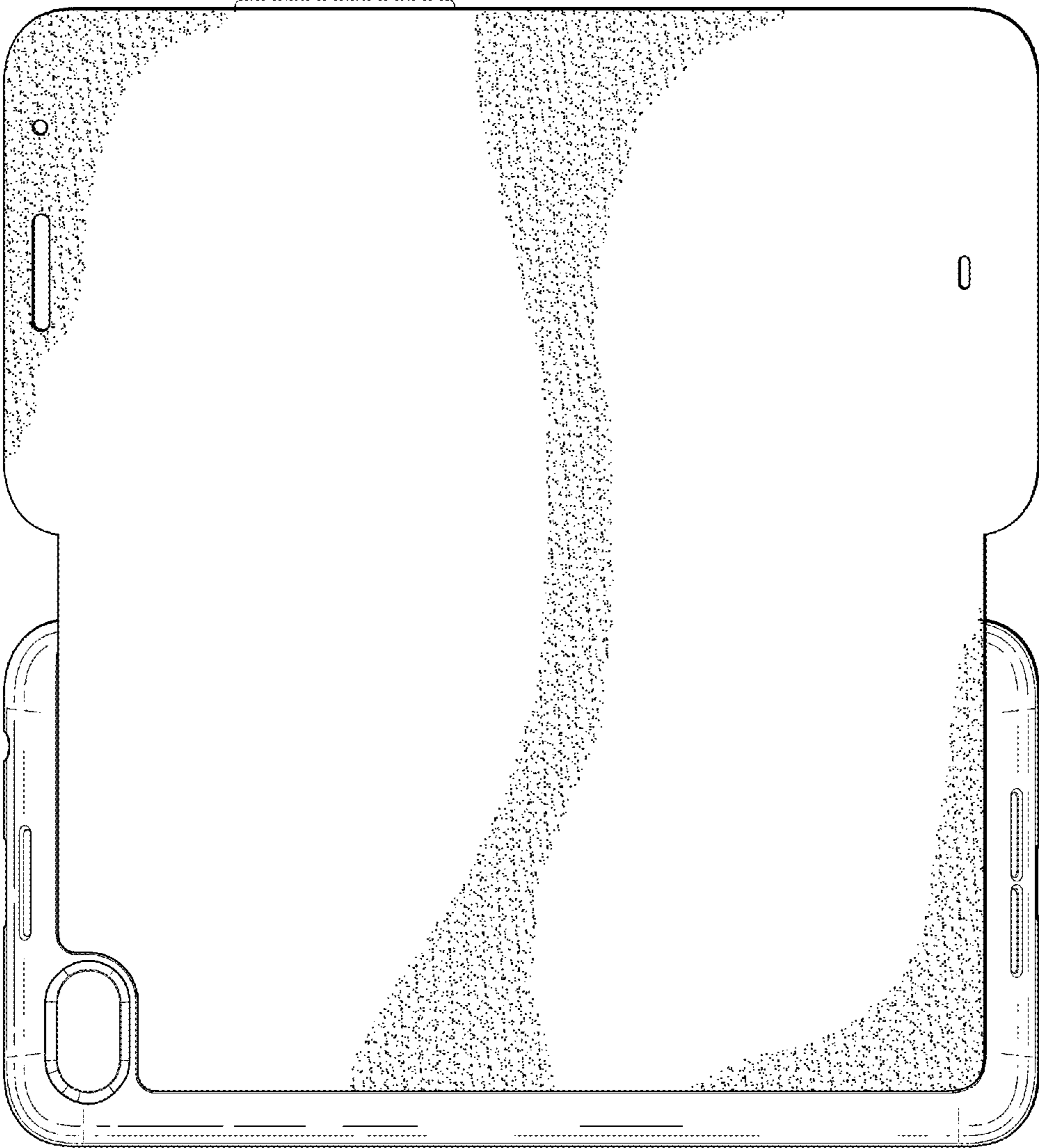

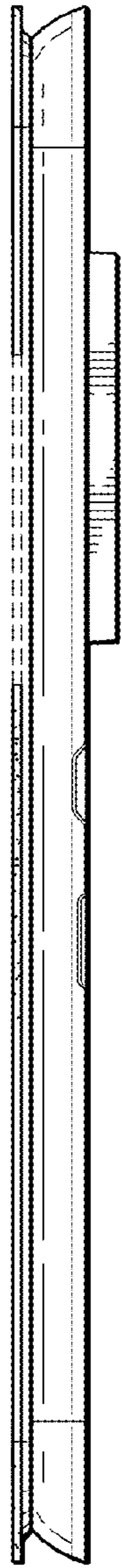

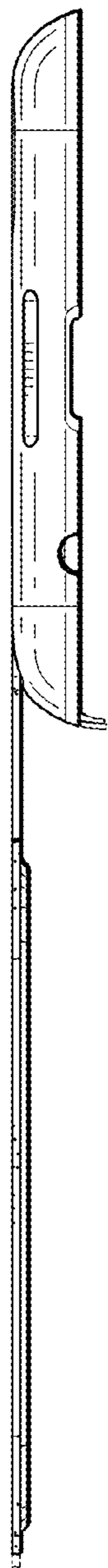
