**DESCRIPTION**

FIG. 1 is a front perspective view of a portable display showing the new design;

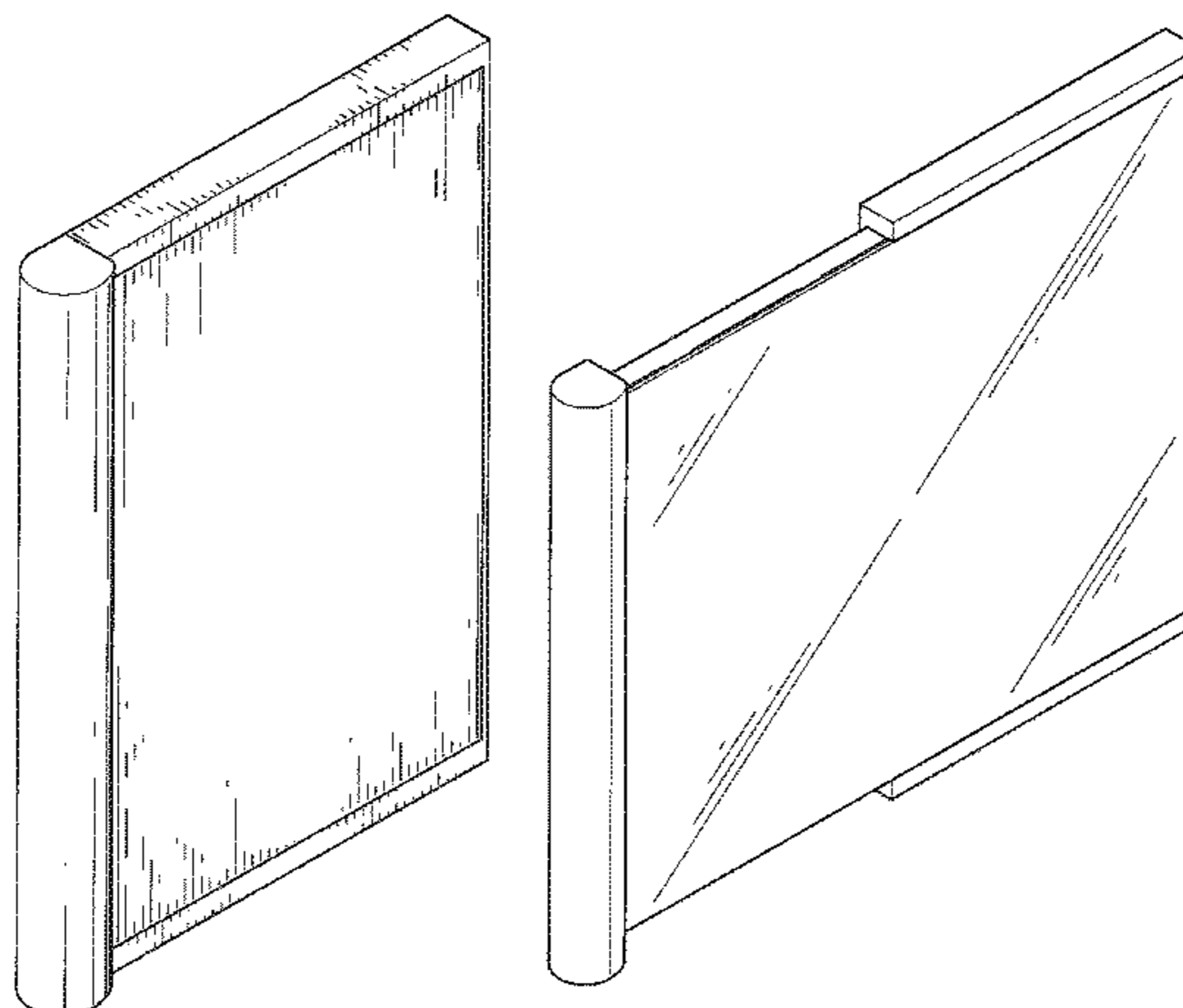

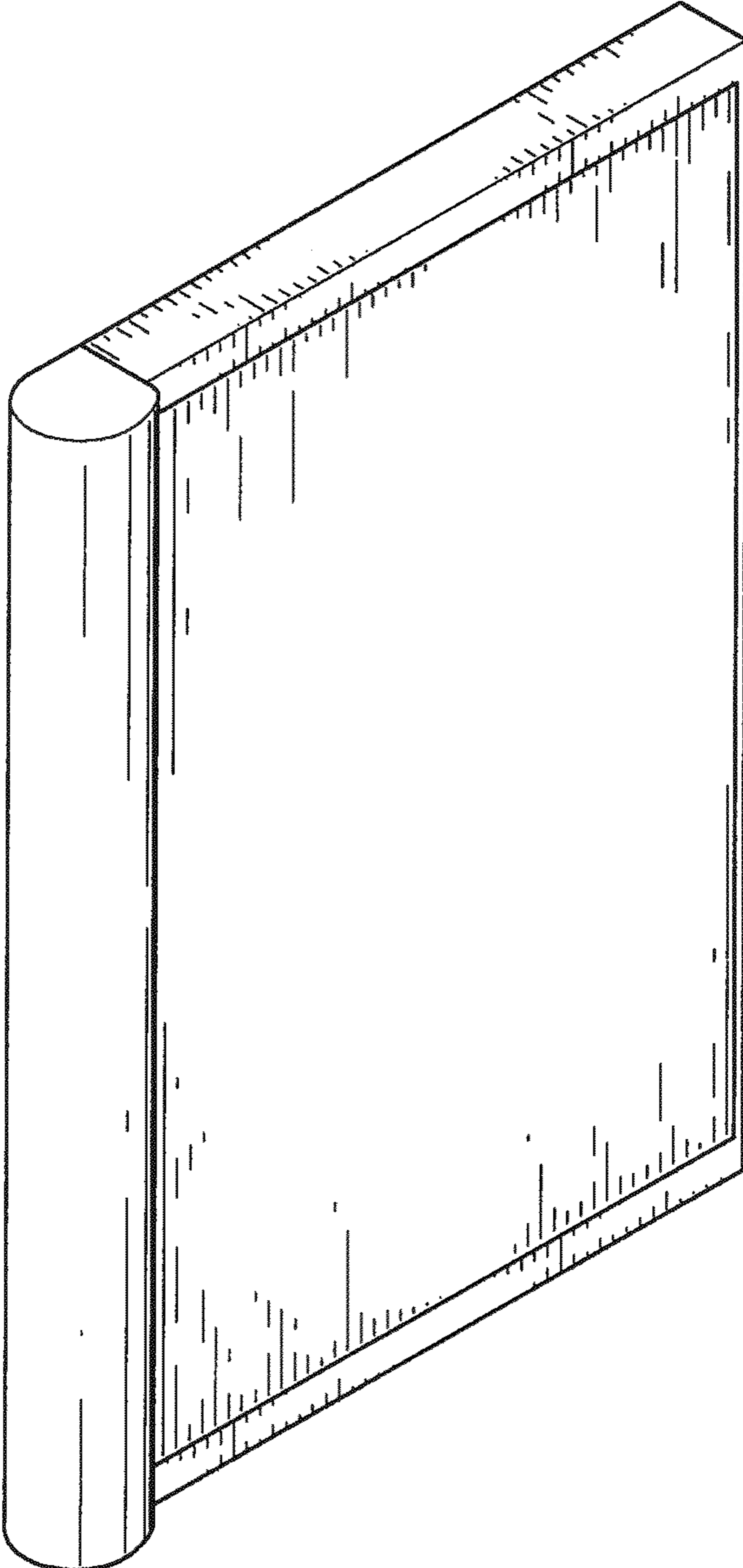

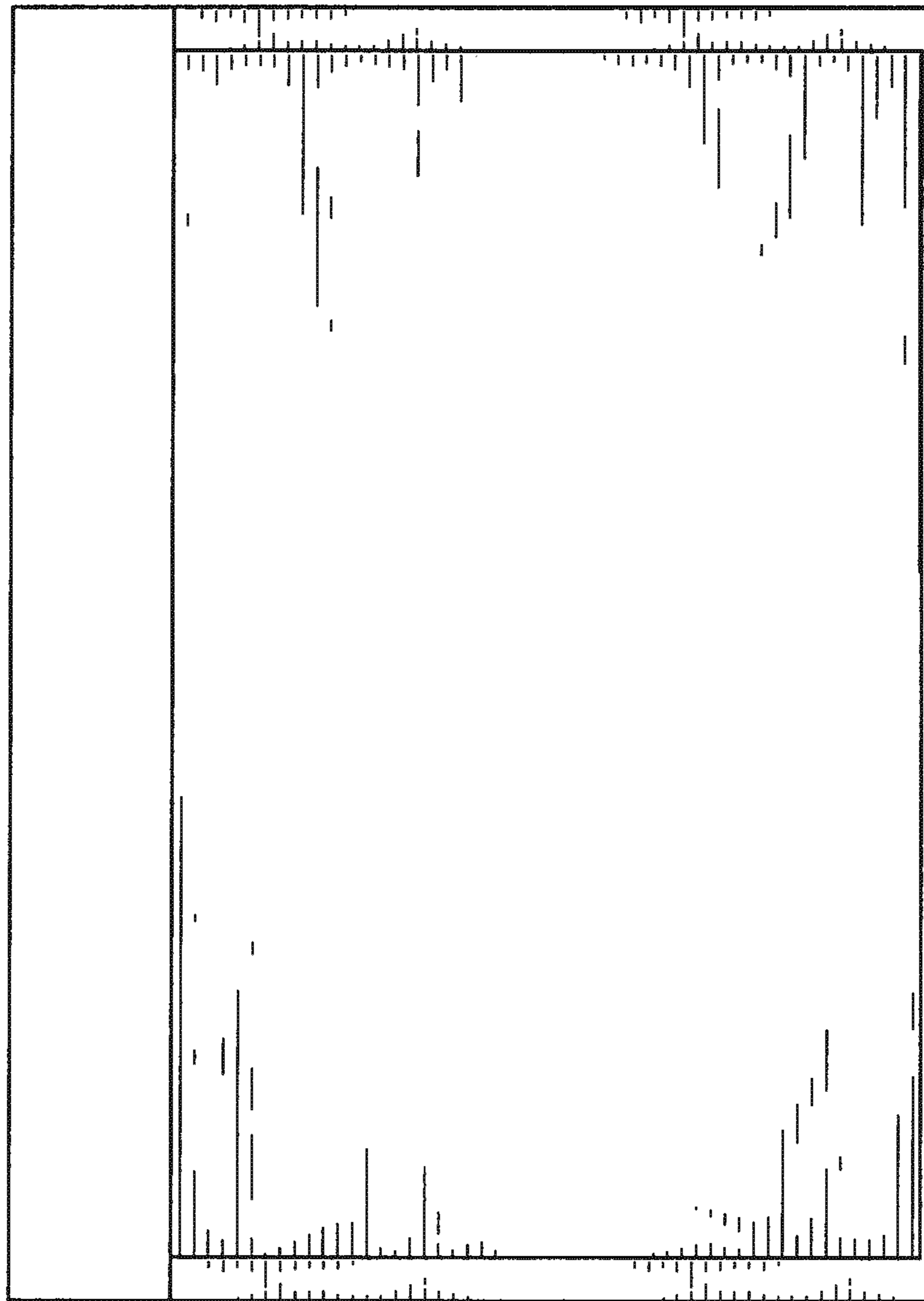

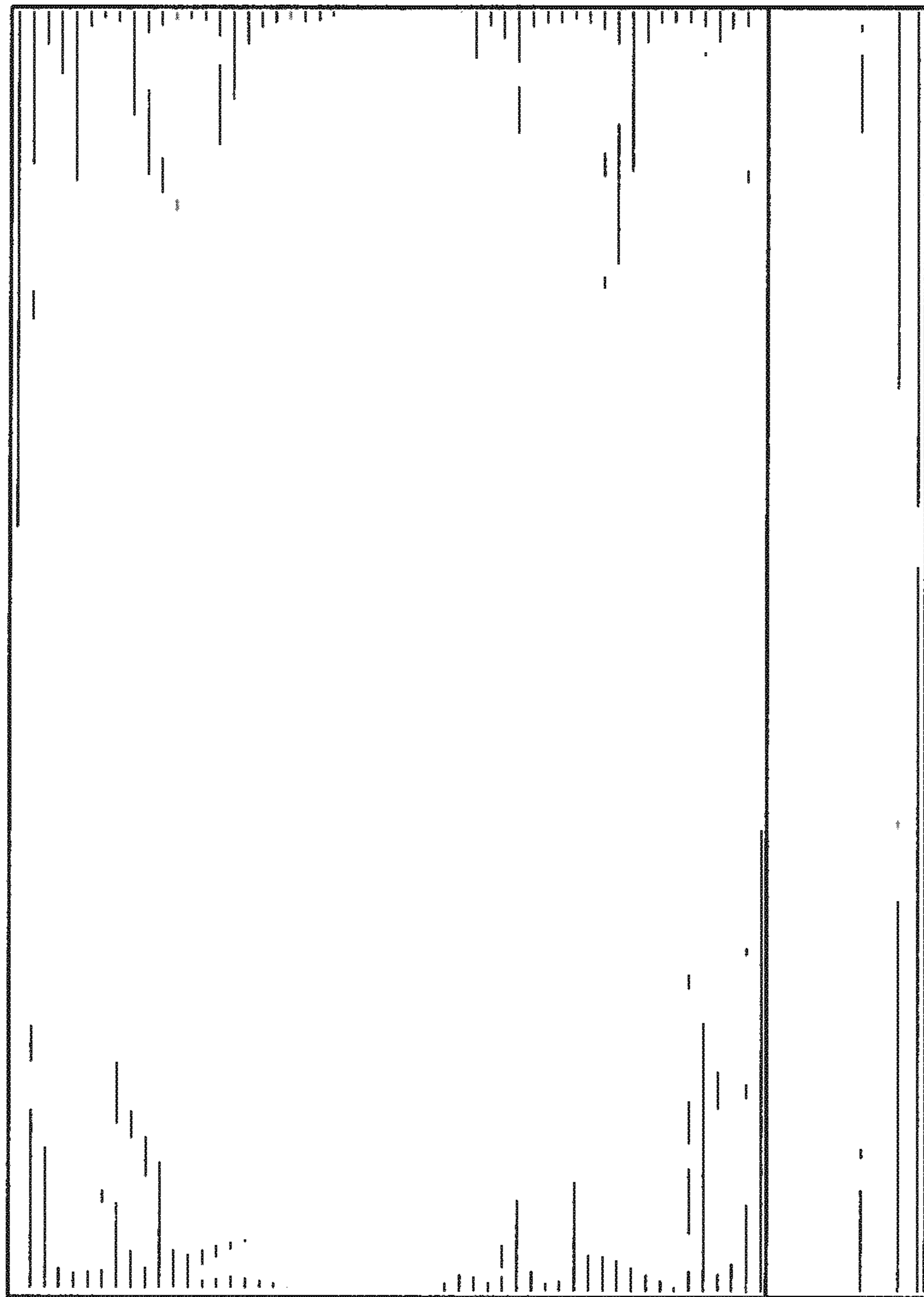

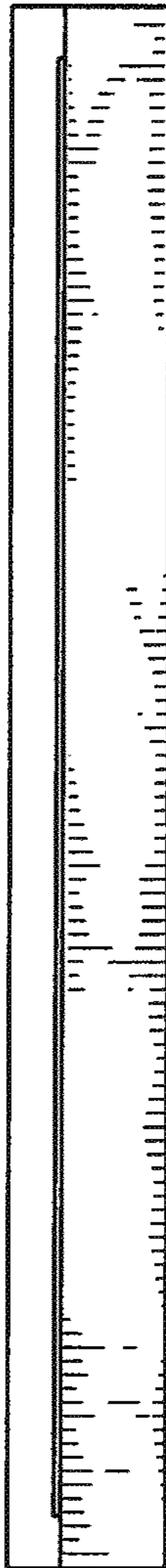

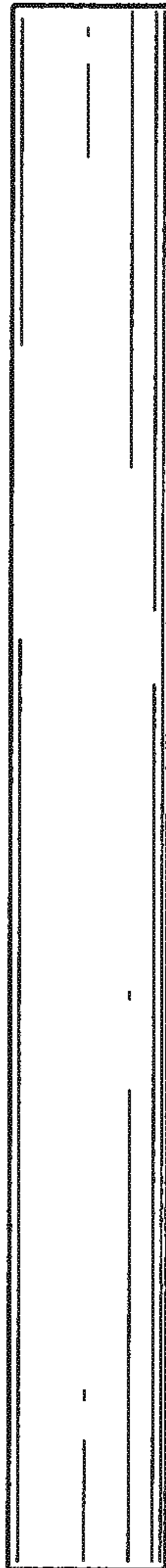

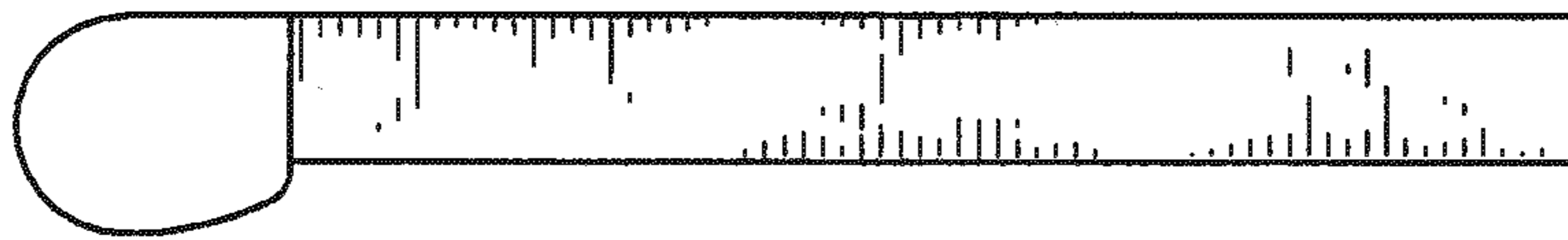

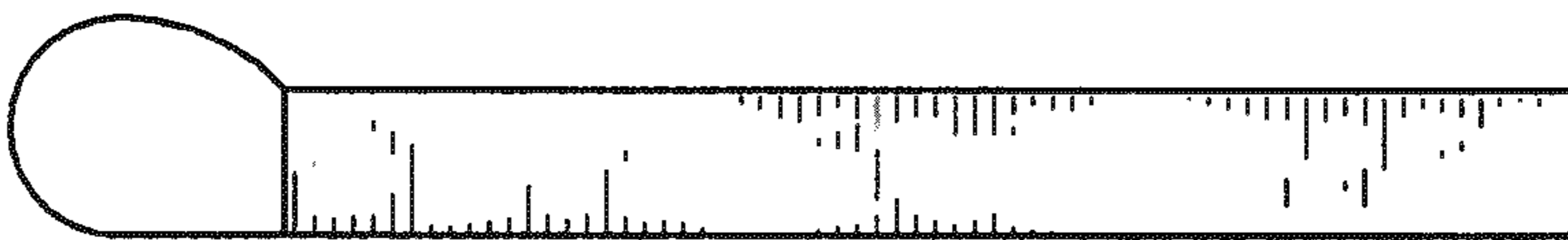
