(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing my new design; FIG. 2 is a front view of the graphical user interface of FIG. 1 in which a mobile terminal is provided in broken lines to illustrate an example environment; and, FIG. 3 is a front view of the graphical user interface of FIG. 1 in which, in addition to the mobile terminal in broken lines from FIG. 2, texts, numerals and/or images are additionally provided in broken lines to illustrate an example image generated. The display screen, mobile terminal, text, numerals and/or images shown in broken lines in FIGS. 1-3 form no part of the claimed design.

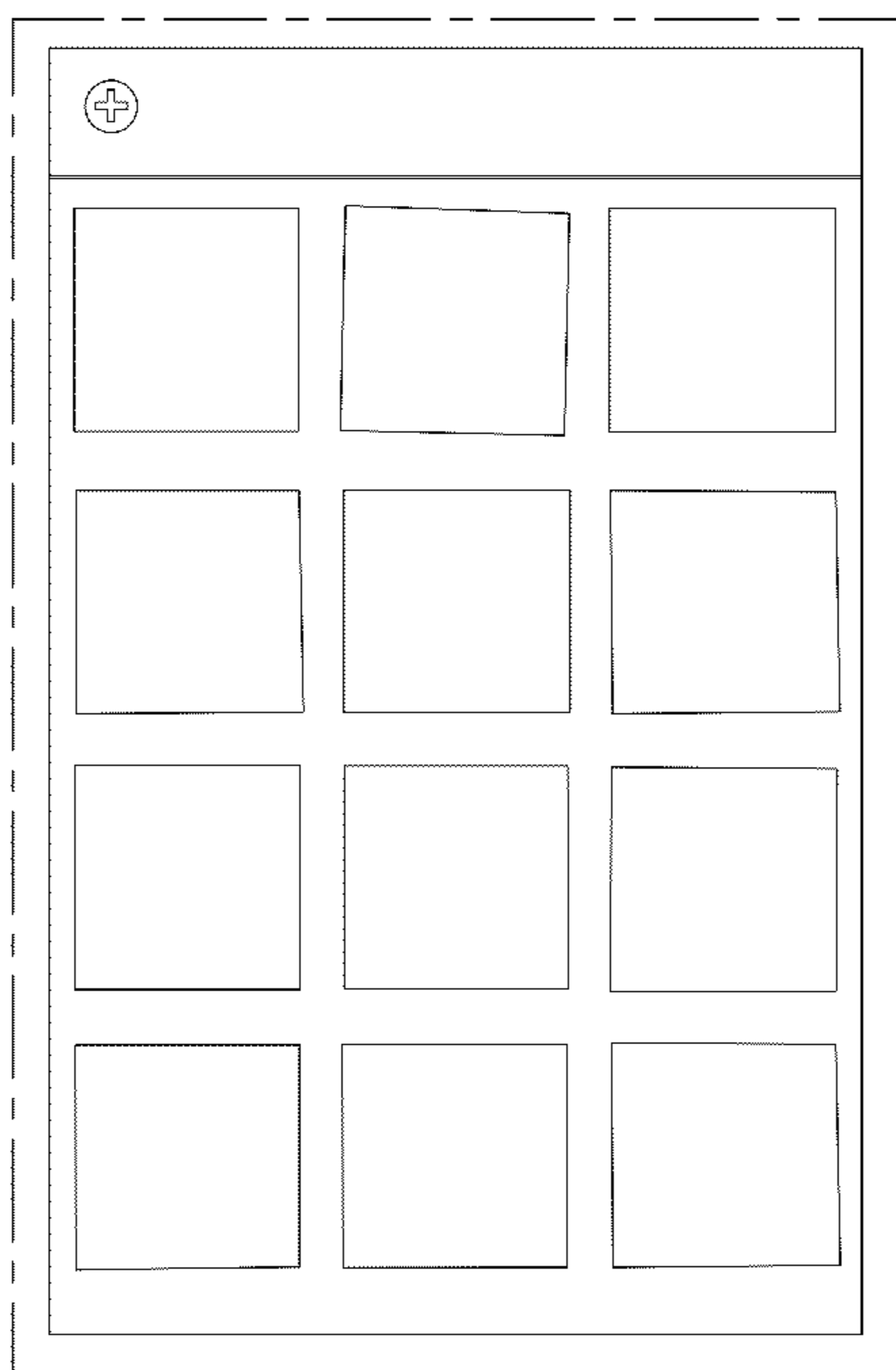

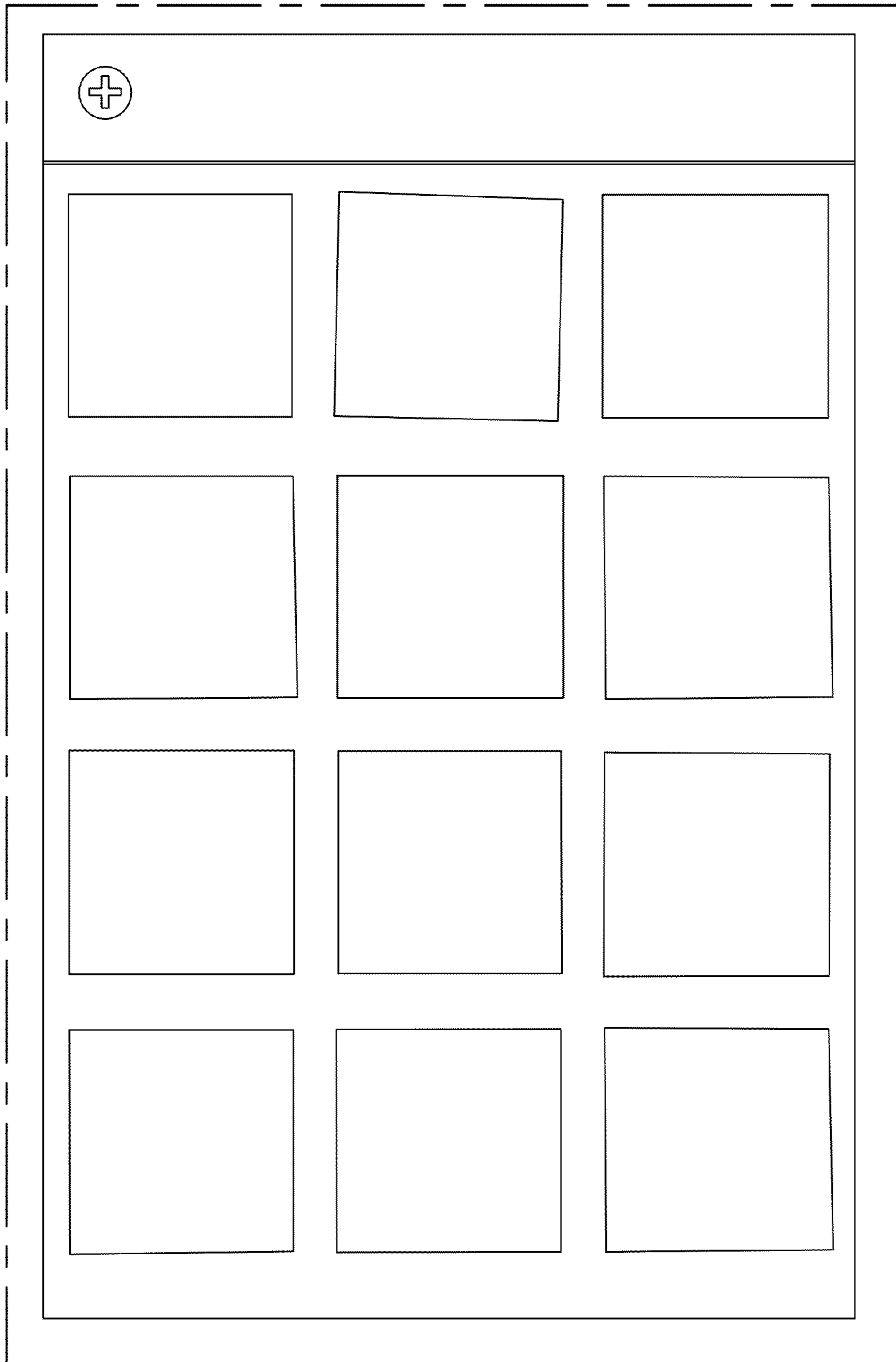

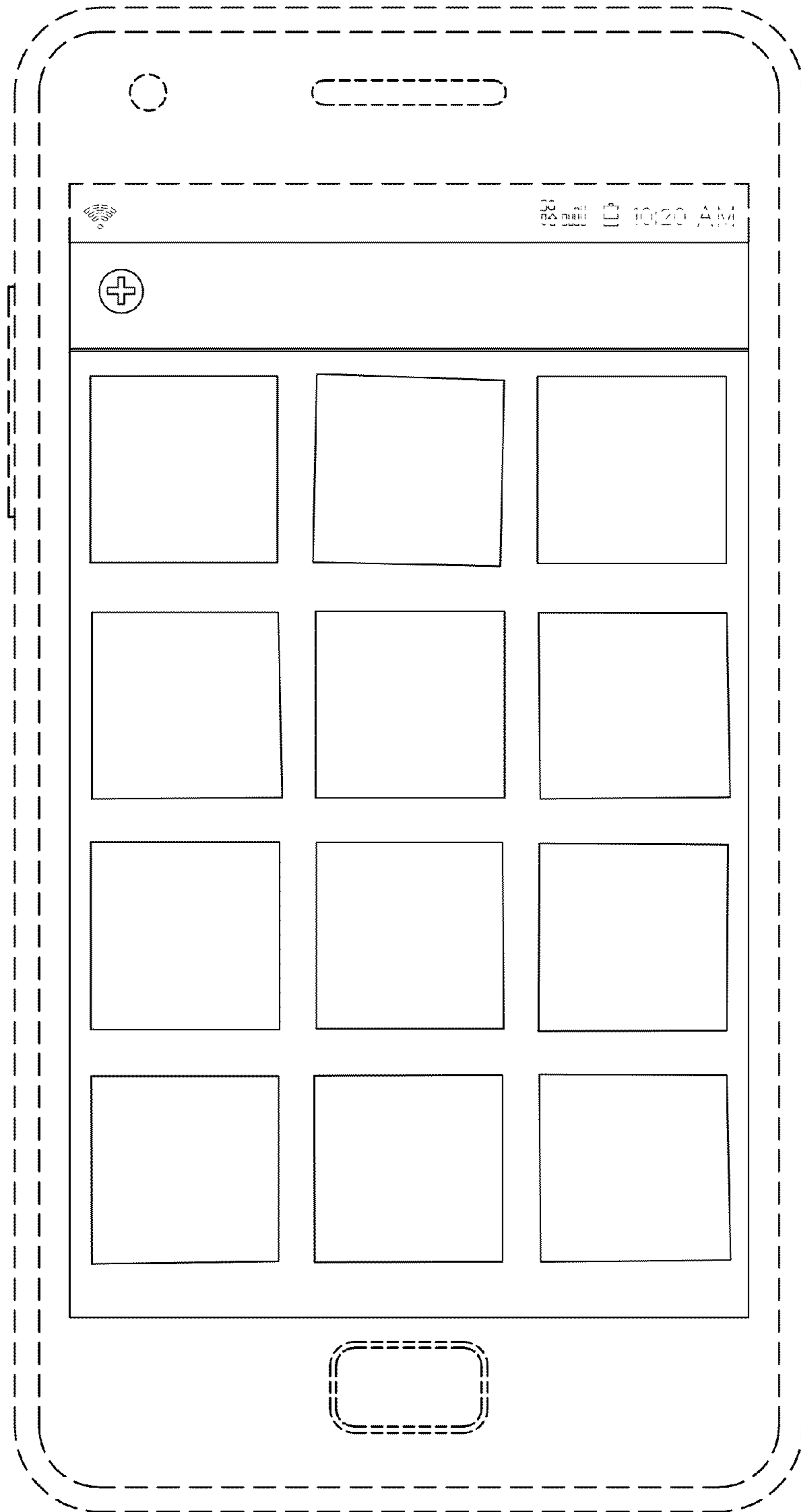
